Application for Amendment.

IN the matter of Letters Patent No. 932, dated eighteenth of June, A.D. 1896, granted to COURTENAY WILLIAM THOMPSON for an Invention for "*Improvements in the Reduction and Treatment of Ores.*"

Notice is hereby given that the above-mentioned COURTENAY WILLIAM THOMPSON, of Perth, Western Australia, Mining Engineer, has applied to amend the complete specification of his said invention, alleging his reasons for so doing—(1.) To limit the scope of and restrict the invention to the apparatus, by eliminating all reference to the process as set forth in the original specification; (2.) That the proposed amendment does not constitute an invention substantially different from or larger than the invention as claimed by the original specification.

The amendments proposed are as follows, viz.:—[Reference being had to amended Copy of Specification lodged in Patent Office, Perth.]

Page 1.

Strike out lines 17, 18, 19, 20, and 21.

Pages 2, 3, and 4.

Strike out the whole.

Page 5.

Strike out lines 1, 2, 3, 4, 5, 6, 7, 8, and 9.

Line 10.—Strike out the words "or suitable treatment."

Line 13—Alter the word "hereinbefore" to read "herein."

Page 6.

After line 7 insert—"The dies are placed in *two* rows, the *one* row 1 and 2 being parallel to the *other* row 3 and 4. The stamps are operated on to these parallel rows of dies by two parallel cam shafts as required. The feed of the rock on to the dies is into the centre at the 'feed,' as at A, whereby the rock has to pass over the dies to get to the screens. This desirable way of feeding the rock into the centre cannot be done in an ordinary battery."

Page 8.

Strike out "Claim 1."

Alter "Claim 2" to read "Claim 1," and insert the word "improved" before the words "method of construction."

Alter "Claim 3" to read "Claim 2."

Strike out "Claim 4."
