WHEREAS under the provisions of "The Constitution Act, 1889," it is made lawful for the Governor of Western Australia for the time being to fix the place and time for holding the first a very other Session of the Legislative Council and Legislative Assembly: NOW THEREFORE I, Sir ALEXANDER CAMPBELL ONSLOW, Knight, Chief Justice of the said Colony, Governor's Deputy, in exercise of the powers so vested in me, and of all other powers enabling me in that behalf, do, by this my Proclamation, announce and proclaim that the FOURTH SESSION OF THE THIRD PARLIAMENT OF WESTERN AUSTRALIA, to be holden under the provisions of the said Act, "The Constitution Act Amendment Act, 1893," and "The Constitution Act Amendment Act, 1896," shall be holden for the despatch of business on Wednesday, the 21st day of June next, at the hour of three of the clock p.m.; the Session of the Legislative Council to be holden in the Legislative Council Chamber, St. George's Terrace, in the CITY OF PERTH, in the said Colony; and the Session of the Legislative Assembly to be holden in the Legislative Assembly Chamber, in Hay Street, in the CITY OF PERTH, in the said Colony; and the Members of the Legislative Council and the Members of the Legislative Assembly are hereby required to give their attendance at the said time and places accordingly.

GREETING:

WHEREAS the President of the French Republic has decreed that an Universal International Exhibition of the Works of Industry and Agriculture, as well as of the Fine Arts, shall be held at Paris in the year One thousand nine hundred;

AND WHEREAS it is the wish of Her Most Gracious Majesty The Queen that such Exhibition shall afford full and suitable representation of the Industry, the Agriculture, and the Fine Arts of Her Majesty's United Kingdom of Great Britain and Ireland, Her Colonies and Dependencies in Europe, Asia, Africa, America, and Australasia, and that Her subjects shall take part in such Exhibition;

NOW KNOW YE THEREFORE that I, Lieutenant-Colonel Sir GERARD SMITH, K.C.M.G., Governor as aforesaid, reposing great trust and confidence in your zeal, integrity, knowledge and ability, have constituted and appointed, and do by these presents constitute and appoint you the said Josceline George Herbert Amherst, Henry Clay Callahan, Ephraim M. Clarke, Walter Le Geyt Daniell, Maurice Coleman Davies, William Robert Feldtmann, Frederick Daniel Good, John Winthrop Hackett, George William Hall, Richard Hamilton, Frederick Illingworth, Charles John Moran, Alfred Edward Morgans, Alexander Clark Munro, Lawrence Read, Revell Bodham Reade, Henry Teesdale Smith, George Throssell, Harry Whittall Venn, Ernest Williams, and Henry J. Yelverton, Commissioners to undertake the collection of the products of industry and agriculture in the Colony of Western Australia and the dispatch of the same to the said Exhibition;

AND my further will and pleasure is that you, or any three or more of you, when and so often as need or occasion shall require, so long as this my Commission shall continue in force, do report to me in writing, under your hands and seals respectively, all and every the several proceedings by yourselves had by virtue of these presents.

AND my further will and pleasure is that this Commission shall continue in full force and virtue until the close of the said Exhibition, and that you my said Commissioners, or any three or more of you, shall or may from time to time, and at any place or places, proceed in the execution thereof, and of every matter or thing therein contained, although the same be not continued from time to time by adjournment.

AND I appoint you the said HARRY WHITTALL VENN to be the President of this my Commission, with authority to appoint a Secretary.

IN TESTIMONY WHEREOF I have caused this Commission to be issued, and the Seal of Our Colony of Western Australia to be hereunto affixed.

WHEREAS under and by virtue of the provisions of "The Magisterial Districts Act, 1886," the Governor is empowered to alter the boundaries of Magisterial Districts, either by separating part of a Magisterial District from and declaring that it shall no longer form part of such Magisterial District, or by adding to a Magisterial District other land, whether theretofore included or not within the limits of a Magisterial District: Now THEREFORE I, the said Governor, with the advice of the Executive Council, do hereby declare that the tract of land comprised within the following boundaries, namely—

Bounded by lines starting from the intersection of the West side of the Donnybrook-Bridgetown Railway Reserve with the South boundary of Donnybrook Townsite, and extending in a Southerly direction along said side of Railway to a point due East of the South-East corner of Wellington Location 171, thence West about six and a-half miles, North to a point West of the South-West corner of Donnybrook Townsite aforesaid, and thence East to the starting point,

WHEREAS by "The Insect Pests Amendment Act, 1898," the Governor, by Order in Council gazetted, may, from time to time, make such Regulations as he deems necessary for prescribing the manner in which diseased plants or fruit and infected packages shall be treated, cleansed, or destroyed, or otherwise disposed of; providing for the registration of all orchards, vineyards, nurseries, and prescribing the matter in respect whereof fees shall be payable under this Act; fixing the amount of such fees; the mode of the payment, and the recovery thereof: AND WHEREAS it is deemed expedient that an additional Schedule should be made to Regulation 22 (published in the *Government Gazette* of the 3rd February, 1899) for the purposes of the said Act: Now, THEREFORE, His Excellency the Governor, by and with the advice and consent of the Executive Council, doth hereby make the following additional Schedule for the purposes aforesaid.

WHEREAS by "The Stock Diseases Act, 1895," the Governor is empowered, by Order in Council to be published in the *Government Gazette*, from time to time to prohibit the introduction or importation into the Colony, either by sea or land, of any stock from any country or place; or to permit such introduction by land to be made at such inland places, or their importation by sea at such parts of the sea coast in Western Australia, being "ports" within the meaning of the laws of the Customs for the time being, subject to such restrictions and regulations as he shall see fit: Now THEREFORE His Excellency the Governor of the said Colony does, with the advice of the Executive Council, hereby prohibit the introduction or importation of Dogs into Western Australia from beyond the limits of the Australasian Colonies and New Zealand, except in conformity with and subject to the following Regulations:—

REGULATIONS.

1. No dog imported from beyond the limits of the Australasian Colonies will be allowed to land in the Colony of Western Australia at any place other than within the Ports of Albany and Fremantle; and all such dogs shall perform quarantine at such places as may be approved by the Chief Inspector of Stock; and every owner of such dog shall pay or cause to be paid to an Inspector of Stock the sum of £15, before landing, to meet the expenses liable to be incurred in the quarantine and treatment of such dog.

2. No dog will be allowed in the quarantine ground except for the purpose of quarantine, and any dog found trespassing on the quarantine ground may be destroyed or subjected to quarantine by an Inspector.

3. All dogs imported into the ports of Albany or Fremantle, or any other port in the Colony of Western Australia, which the master of any vessel shall certify in the notice required by the Regulations issued under "The Stock Diseases Act, 1895," on August 28, 1897, as being only ship's dogs, or dogs in transit to other colonies not requiring to be landed, such dogs, if healthy, shall be detained on board such vessel, and shall be securely chained whilst within any port in the Colony, except as may be otherwise authorised by an Inspector.

4. Any master, or owner, or consignee who shall refuse or neglect to have any dog securely chained as directed by an Inspector, or who shall neglect to carry out any order or direction given by an Inspector for the care or security of any dog, shall be liable to a penalty of not less than £5 nor more than £50.

5. Any dog from the shore found or allowed to stray on board a ship on which an imported dog is detained may be destroyed or detained in quarantine at the expense of the owner, and any person taking or allowing a dog to be on board a ship where an imported dog is detained shall be liable to a penalty of not less than £5 nor more than £20. Any master, mate, or member of the crew of a ship who shall permit or suffer a dog to go on board their ship during the time any dog shall be detained on such ship shall be liable to a penalty of not less than £5 nor more than £20 for each breach of this regulation.

The Regulations published in the *Government Gazette* of the 19th March, 1897, are hereby cancelled.

NOTICE is hereby given that on and after May 15, 1899, a Red Light will be shown from Sunset to Sunrise from a steel mast, painted white, at Kovilam, on the Island of Karaitivu, North Coast of Ceylon, in latitude about 9 deg. 46 min. North, and longitude about 79 deg. 50 min. 20 sec. East.

The Light is a Fifth Order Dioptric Lantern, and will be hoisted to an elevation of 60 feet above sea level, and should be visible from all directions seaward at a distance of about 6 to 8 miles in clear weather.

THE Government of Western Australia gives notice that a patch of foul ground has been found in King George Sound, one mile and seven cables to the Westward of Michaelmas Island.

From the shoalest rock, having on it twenty-one feet (21ft.) at low water, where the Chart shows eight fathoms (8fms.):

- Gull Rock (centre) bears N. by E., magnetic.
- Breaksea Lighthouse bears E.S.E. magnetic
- Seal Island, highest part bears S.W. by S. Southerly, magnetic.
- King Point Lighthouse bears W. by N. $\frac{1}{4}$ N. magnetic.

An additional buoy, painted red, with staff and cage, has been placed a cable and a-half to the Westward of the rock above mentioned.

Vessels approaching Albany from the Eastward, and using the channel between Breaksea and Michaelmas Islands, are cautioned not to round the old buoy too closely, but are advised (while keeping

Rock Dunder open South of Michaelmas Island) to bring Gull Rock to bear N.N.E. magnetic before hauling up for King Point.

IT is hereby notified, for general information, that the Honourable the Attorney General has approved of the Regulations hereunder respecting Licenses to practise as a Surveyor under "The Transfer of Land Act, 1893" (56 Vict., No. 14):—

REGULATIONS.

1. Application for licenses, enclosing certificates and testimonials, must be addressed to the Commissioner of Titles.

2. Before an applicant is eligible for a license under this Act he—

(a.) Must obtain and hold a license under "The Licensed Surveyors' Act, 1895," and have held the same for a period of not less than twelve months;

(b.) Shall produce satisfactory evidence that he has had at least six months' field experience in surveying in Western Australia;

(c.) Shall produce evidence satisfactory to the Surveyor General that he is a person of good fame and character.

3. When the applicant has held for twelve months, and continues to hold a license in one of the other Australasian colonies under an Act similar to the Transfer of Land Act of Western Australia, he may apply for a license under this Act, after having held a license under "The Licensed Surveyors' Act, 1895," for six months, and had field experience in surveying in this Colony for not less than three months.

4. The applicant will be required to attend personally, at the office of the Surveyor General, to show that he is conversant with the Transfer of Land Act so far as it refers to surveys, with the Rules in force that have been made under that Act for the guidance of surveyors, and any other Acts that deal with surveys.

5. The Surveyor General shall have the right to subject an applicant to any examination, or to any other conditions he may consider necessary, and may refuse to grant a license to any applicant if he is of opinion that it would not be to the advantage of the Land Titles' Department to do so.

6. Any surveyor now or hereafter licensed to practise under this Act, who is absent from the Colony of Western Australia for a period exceeding twelve months, shall cease to be a licensed surveyor under this Act, and the Attorney General shall cause such absent surveyor's name to be removed from the list of surveyors licensed under this Act.

7. A person whose name has been removed from the list of licensed surveyors, in accordance with the provisions of Clause 6 of these Regulations, may, on returning to the Colony, apply for a license, and shall comply with all the foregoing conditions, except the one making field practice compulsory.
