WHEREAS by Section 219 of "The Municipal Institutions Act, 1900" (64 Vict., No. 8), it shall be lawful for the Governor, on request of the Council by notice in the *Government Gazette*, to declare any land reserved, used, or by purchase or exchange acquired for a street, or way, to be a public highway, and such land shall thereupon and thenceforth, from the date of such Proclamation, become and be absolutely dedicated to the public as a highway within the meaning of any law now or hereafter in force.

MUNICIPALITY OF BOULDER.

BY-LAW No. 77.

A By-law of the Municipality of Boulder, made under Section
 167 of "The Municipal Institutions Act, 1900," and
 numbered seventy-seven, for regulating the hawking of
 fruit, fish, meat, poultry, game, or vegetables, or any article
 of merchandise.

IN pursuance of the powers conferred by the said Act, the
 Mayor and Councillors of the Municipality of Boulder
 order as follows:—

1. By-law No. 10 of the Municipality, published in the
Government Gazette of 25th March, 1898, is hereby repealed.

2. No person shall hawk any fruit, fish, meat, poultry,
 game, or vegetables, or articles of merchandise within any
 part of the Municipality of Boulder without having first
 obtained a license from the Council.

3. Any person who travels and trades on foot, or with-
 out any vehicle or animal, or otherwise carrying to sell or
 expose or offer for sale within the limits aforesaid any of
 the articles or things aforesaid, shall be deemed to hawk
 the same.

4. No person shall keep, manage, or conduct any
 movable or temporarily fixed stall in or near any street for
 the sale of any meat, vegetables, drink, eatables, or articles
 of merchandise unless such person be licensed.

5. Every hawker, while hawking, shall produce his
 license upon being required by any constable or any officer
 of the Council, and shall at all times have affixed to some
 conspicuous part of his coat, barrow, basket, vehicle, or
 dray, a board or plate bearing his name and the words
 "Licensed Hawker" legibly painted thereon in letters not
 less than 1in. in length.

6. No licensed stall shall be placed or allowed to stand
 in any street or position other than that mentioned in the
 license, or between the hours of 8 p.m. and 2 a.m.

7. Ordinary licenses shall be issued for one month only,
 and the following license fees shall be paid, in advance, on
 the first Monday in the month:—

For every hawker with hand-basket or tray	2s. 6d. per month.
For every hawker with wheel- barrow or hand-cart	5s. "
For every hawker with vehicle drawn by a horse or other animal	10s. "
For every stall	£2 "

8. Every licensed hawker and every licensed stallholder
 shall at all times obey the lawful directions of the Traffic
 Inspector, or other authorised officer of the Council.

9. No person to whom a hawker's or stall-holder's license
 is granted shall lend, transfer, or assign the license granted
 to him, and no person shall borrow or make use of license
 granted to a person other than himself.

MUNICIPALITY OF BOULDER.

BY-LAW No. 78.

A By-law of the Municipality of Boulder, made under Section 167 of "The Municipal Institutions Act, 1900," and under Sections 23 and 25 of "The Weights and Measures Act, 1899," and numbered seventy-eight, for prescribing the fees to be charged for the examination and comparison and stamping of weights and measures, scales, balances, steel-yards, beams, and other weighing machines.

In pursuance of the powers conferred by the said Act, the Mayor and Councillors of Boulder order as follows:—

1. The following fees shall be charged, received, and taken by the Inspector of Weights and Measures for the Municipality of Boulder for examining and comparing with the authorised copies in the possession of the said Council, and stamping (if found correct) weights and measures, scales, balances, steelyards, beams and other weighing machines:—

2. The fees to be charged for any weights, measures, beams, scales, balances, steelyards, or other weighing machines compared and stamped by the Inspector outside of the Boulder Municipality shall be one-half more than

the fees hereinbefore mentioned, exclusive of any charge incurred in conveying the weights and measures from the Inspector's office to the place where such weights and measures are to be used.

3- All fees shall be paid to the Inspector before delivery of weights and measures, beams, scales, steelyards, or weighing machines to the owner.

WHEREAS by "The Health Act, 1898" (62 Vict., No. 24), the Local Board of Health has power to make By-laws: Now, therefore, in pursuance thereof, the following By-laws have been made, and shall come into operation from the date of publication in the *Government Gazette*.

INTERPRETATION.

In the construction and for the purposes of these By-laws, unless the context otherwise requires, the terms herein used shall have the meanings severally attached to them in Section 3 of the said Act.

BY-LAW No. 1.

Cesspools to be cleansed and filled up.

All existing cesspools within the area under the jurisdiction of the Local Board shall be cleansed and filled up to the satisfaction of the Inspector within a calendar month of notice to that effect being given to the owner or occupier.

BY-LAW No. 2.

Regulating the position and manner of construction of privies.

1. No person shall erect within the district of the Local Board any earth-closet, privy, or urinal, the walls of which are not of stone, wood, and iron, or brick, and every closet shall be equipped with the sealed pan adopted by the Local Board. The doors of every closet shall be properly fitted, and shall at all times be kept in a state of thorough repair. The trap-door shall be so constructed as to readily admit the pan, and shall be placed facing the right-of-way.

2. All closets, privies, or urinals shall be erected in such position and in such manner as shall be approved of by the Local Board; and all such closets, privies, and urinals shall be erected as near the right-of-way as conveniently can be, and every such structure shall be ventilated to the satisfaction of the Local Board.

3. Authority under Section 173, Subsection 3.—The occupier of every house or premises, whether public or private, shall cause to be kept in every closet or privy belonging thereto a box containing either ashes, dry earth, lime, sawdust, carbolic powder, or other disinfectant approved by the Local Board, and shall cause all nightsoil or other matter which may be deposited in such pan or receptacle in such closet or privy to be immediately deodorised or disinfected with a sufficient quantity of the disinfectant kept in such box.

BY-LAW No. 3.

Each closet shall be supplied with a sufficient number of receptacles for excrementitious matter which shall be interchangeable with others in the same district, and shall be of the following size, shape, style and materials, to be constructed out of 22 gauge iron, 14½ inches high, 13½ inches diameter, inside measurement, when completed. The ring around the top to be made out of 1 in. x ½ in bar iron, with four holes punched at equal distances apart, and rivetted to the body so as to fit same neatly and be level across the top. The seams of the body are to be folded and grooved, and sweated with solder. Two straps to be put across the bottom of pan, to be made of 20 gauge galvanised hoop iron, 1½ in., and swadged and rivetted to the bottom. The handles are to be made out of ½ in. round bar iron.

BY-LAW No. 4.

There shall be provided by the occupier two receptacles for every closet on the premises occupied by him.

BY-LAW No. 5.

Every nightman shall cause every receptacle for nightsoil, after the disposal of the contents, to be thoroughly cleansed and tarred.

BY-LAW No. 6.

Every contractor shall cause the nightsoil removed from any premises to be either rendered inoffensive or treated in a destructor, desiccator, or incinerator, or to be trenched or ploughed into the land.

BY-LAW No. 7.

That failing the use of a destructor, desiccator, or incinerator, the contractor be compelled to obtain a receipt from the occupier of the land whereon deposit is made, or from the manager of some approved dépôt for nightsoil for the number of pans there emptied or delivered.

BY-LAW No. 8.

The Local Board shall exercise stringent supervision over all such dépôts or places of deposit, and the Inspector shall inspect such dépôts or places regularly at such intervals as the Local Board may direct.

BY-LAW No. 9.

The mode of removal of each receptacle in each closet shall be as follows:—The nightman shall remove each receptacle and at once cover the same with a suitable tight-fitting lid, and upon every such removal shall carefully place a cleansed pan of the pattern approved by the Local Board in lieu of every pan so removed, and each pan shall be dealt with as prescribed in the next following clause hereof, that is to say:—

Each receptacle which shall have been removed from a closet and sealed with a lid as prescribed in the foregoing clause shall be then removed by the nightman in a cart or vehicle of a pattern to be approved by the Local Board, and the contents of all such receptacles shall be deposited in such place or places as shall from time to time be fixed by the Local Board.

Until otherwise directed, the nightman shall deposit the contents of all such receptacles in trenches, to be excavated at his own expense, in such place or places as shall be fixed by the Local Board, and treated with disinfectant, and covered with earth to such depth as the Local Board may from time to time direct.

The said receptacles shall be emptied once a week at the least, or so much more frequently as the Local Board may from time to time direct.

BY-LAW No. 10.

Fixing the charge, etc.

Every nightman shall be entitled to charge and to receive from the occupier of any premises from which any nightsoil, trade or house refuse shall have been removed, such sum or sums of money as are specified in Schedule "A" hereto, and no nightman shall ask, demand, or receive more than the moneys mentioned in the said Schedule.

BY-LAW No. 11.

Licenses to remove nightsoil.

1. No license shall be issued to any person not approved of by the Local Board.

2. No nightman shall remove nightsoil from any house or premises within the area under the jurisdiction of the Local Board, unless he shall have first obtained from the Local Board a license authorising him to do so.

3. The license shall be in the form of Schedule "B" hereto, and subject to the conditions contained in the license, and to the provisions of "The Health Act, 1898," and of these By-laws.

BY-LAW No. 12.

Imposing penalties on licensee for breach of conditions.

The following shall be the conditions upon which licenses to remove nightsoil shall be issued:—

The penalties for breach of any of the foregoing conditions shall be not more than the respective amounts set forth at the conclusion of each such condition.

BY-LAW No. 13.

For the mode of carriage of, and precautions, etc., to be observed—Meat, bread, fruit, etc.

1. No person or persons shall bring or cause to be brought or carried through any street or lane, in any cart or vehicle, any butcher's meat, bread, or fruit, unless such meat, bread, or fruit be protected from the sun, dust, and rain.
2. Every cart or other vehicle, and every construction or covering for carrying and protecting meat, bread, or fruit shall be kept in a clean and sanitary state.

BY-LAW No. 14.

For the registration annually of all persons carrying on the trade of cowkeepers, dairymen, or purveyors of milk.

All persons carrying on the trade of cowkeepers, dairymen, or purveyors of milk within the district of the Local Board shall register their names and addresses at the office of the Local Board, and shall pay a registration fee of £1 for such registration, and shall receive a certificate thereof in the form of Schedule "C."

BY-LAW No. 15.

For securing the cleanliness of bakeries.

1. No person shall carry on any bakery or bread or confectionery store unless and until the premises have been examined and passed as suitable by the Inspector.
2. All bakeries and bread and confectionery stores shall be at all reasonable times open to the inspection of any of the officers of the Local Board; and all troughs, tanks, and all utensils and appliances used in such premises shall be kept in a thoroughly clean condition, to the satisfaction of the Local Board's officers.

BY-LAW No. 16.

For prescribing the time of and the precautions to be taken on the removal of pigwash, etc.

1. No person shall remove any pigwash or other filthy matter unless such pigwash or filthy matter be carried in water-tight barrels or tanks, securely covered to prevent the escape of any of the contents thereof or any offensive smell therefrom.
2. Every tank or barrel and every receptacle used for the storage and reception of any pigwash or filthy matter, and every conveyance or vehicle used for the carriage or removal of any matter as above, shall be kept in a clean and sanitary condition.
3. No pigwash or filthy matter shall be removed from any place or premises between the hours of 10 o'clock in the morning and 6 o'clock in the evening, except by permission of the Local Board.

BY-LAW No. 17.

For the prevention of the sale of diseased fruit, etc.

No person shall sell or expose for sale in any market, warehouse, shop, or other place, any fruit which is diseased or unwholesome, and any fruit which, in the opinion of any officer appointed by the Local Board or Central Board, is diseased or unwholesome shall be destroyed, and all cases or packing material which surrounded such fruit shall also be destroyed as such officer may direct.

BY-LAW No. 18.

For the restriction of the storage and keeping of bonedust, etc.

No person shall store or keep any bonedust or artificial or other manure so as to be a nuisance or injurious to health.

BY-LAW No. 19.

Regulating and keeping of cattle or other animals.

1. Every occupier or owner of a building wherein or whereon any horses, cattle, swine, or other animals may be kept shall provide, in connection with such building or other premises, a suitable receptacle for dung, soil, filth, or other offensive or noxious matter which may be produced from time to time in the keeping of such animals.
2. Such receptacle shall be constructed in such a manner and of such material, and shall be maintained in such a manner so as to prevent the escape of any of the contents thereof or any leakage therefrom.
3. The owner or occupier of such premises shall at least once a week remove or cause to be removed all dung or other offensive matter from such receptacle, and shall convey or cause to be conveyed such dung or offensive matter to the depot or place set apart for that purpose by the Local Board.

BY-LAW No. 20.

Defining an area within which swine may not be kept, etc.

1. No person shall keep any swine within 100 feet of any house.
2. No person shall keep any swine in any part of the district under the control of the Local Board, unless and until such premises or places to be used as a piggery have been examined and approved by the Inspector and licensed by the Local Board.

BY-LAW No. 21.

For the prevention of danger to the public from manufactories or places for the storage of inflammable materials.

1. No person shall permit on any premises owned or occupied by him any accumulation of straw, paper, shavings, empty cases, or other inflammable material.
2. Any person who, after two hours' notice from the Inspector, shall neglect to remove such inflammable material shall be guilty of an offence against this By-law, and, on conviction, shall forfeit and pay for every such offence a sum not exceeding £5 for each day during which such breach shall be committed or continued.

BY-LAW No. 22.

For the disinfection of and the prevention of nuisance or injury to health from poultry yards, rags, or other materials used or stored in marine stores.

1. No person shall keep any premises as a poultry yard at a less distance than 25 feet from any dwelling.
2. Every poultry yard shall be kept in a clean condition and disinfected at least once a week with lime, ashes, or other suitable disinfectant.
3. No rags or other materials used or stored in marine stores, flock or bedding or furniture manufactories shall be kept so as to cause a nuisance or to be injurious to health.

BY-LAW No. 23.

For the regulation of noxious or offensive trades.

1. The owner or occupier of any place, building, or premises used for the purpose of carrying on any offensive or noxious trade, business or manufactory, as set forth in Section 146 of the Act, whether established before or after the passing of the said Act, shall register the same at the office of the Local Board during the first week in January in each year, and shall pay to the Local Board an annual registration fee, as set forth in Schedule "D" hereto, of the amount of which fee the Local Board shall give notice to such owner or occupier, and if such owner or occupier fails to comply he shall be liable to a penalty not exceeding £2 per day for each day during which such provisions shall not be complied with.
2. All premises or places so registered shall be kept in a clean and sanitary state, and shall be linewashed as often as may be required by the Local Board or its officers.

BY-LAW No. 24.

For the prevention of the use of steam whistles at factories, etc.

No person or owner of any factory or other establishment shall use, or caused to be used, any steam whistle so as to be a nuisance to any person.

BY-LAW No. 25.

Specifying the time which may elapse between the giving of a notice and the doing of a thing.

Unless otherwise provided for, the time which may elapse between the giving of a notice and the doing of a thing required to be done by any Inspector or officer shall be determined by the Local Board, according to the nature of the case.

BY-LAW No. 26.

For preventing offensive matter running out of premises.

1. It shall not be lawful for the owner, proprietor, or any employee of or in any manufactory, brewery, slaughterhouse, knacker's yard, butcher's or fishmonger's shops, laundry, or dunghill, to allow any offensive matter to escape and flow upon any street, lane, way, or thoroughfare, or land within the district of the Local Board.
2. All such offensive matter shall be placed in a suitable receptacle, and emptied as often as necessary, to the satisfaction of the Inspector.

BY-LAW No. 27.

Regulating the deposit of rubbish, etc.

1. The occupier of every house or premises shall, on written notice from the Inspector, and within the time specified in such notice, provide such and so many receptacles or boxes of the material and of the dimensions as may be required by the Local Board for the temporary deposit of house refuse.
2. The occupier of such house, or, if there be no occupier, then the owner, shall regularly collect all refuse or rubbish from such premises and place the same in the receptacles; and he shall not permit or suffer such receptacle to overflow or become offensive, and shall, when necessary or directed by the Inspector or officer of the Local Board, thoroughly disinfect the same forthwith.

3. Every receptacle as aforesaid shall be kept in such place or position as the Inspector may point out, and so as to be convenient for the removal of the contents thereof.

4. Every owner or occupier, or if there be no occupier, then the owner, of every house or premises to which a receptacle as aforesaid is attached or used, shall cause the same to be emptied at least once a week, or as often as the Inspector may direct.

5. The owner or occupier of such premises shall, after notice from the Inspector, and within the time limited in such notice, replace by a new and approved receptacle any receptacle that the Inspector may deem worn out or unfit for use.

BY-LAW No. 28.

Receptacles to be kept in an inoffensive condition.

All receptacles required by "The Health Act, 1898," or under these By-laws, shall be kept in an inoffensive condition by the householder or occupier.

BY-LAW No. 29.

Regulating the removal of offensive matter.

Every person who shall convey any dust, mud, ashes, rubbish, filth, blood, offal, manure, dung, or soil collected, placed, or found in or about any house, stable, cow-house, pigsty, lane, yard, street, or place whatsoever, through or along any street or lane, shall, previous to and during the whole time of such conveyance, cause such dust, mud, ashes, rubbish, filth, blood, offal, manure, dung, or soil collected to be covered with lime or suitable substance, or shall adopt such other precautions as respectively may be necessary to prevent the emission of noxious or offensive odour or effluvia therefrom; and the same shall not be deposited in any place within the district other than the place set apart by the Local Board for that purpose.

BY-LAW No. 30.

Regulating the disposal of the carcasses of dead animals.

In the event of death or any accident necessitating the slaughter of any horse, cattle, sheep, or other animal, the carcass of such animal shall be removed to a safe distance beyond the Municipality or Townsite, or to such place as the Local Board may direct, and there thoroughly burned and destroyed or buried to the satisfaction of the Inspector, by the owner or person in charge of such animal, as the case may be.

BY-LAW No. 31.

Regulating the burning of offal and other offensive matter.

No person shall burn any offal, rags, clippings or parings of leather, or any offensive matter so as to be offensive to any person or resident in the neighbourhood of such burning.

BY-LAW No. 32.

Regulating the removal of slops.

1. Any person who shall be ordered by the Local Board or its Inspectors shall provide and maintain proper water-tight vehicles or receptacles, fitted with close-fitting covers or lids, for the purpose of carting or receiving any slops or suds, house refuse, waste, or other matter or substance used in any laundry, which is likely to become a nuisance or offensive by reason of exposure.

2. All such vehicles or receptacles shall be kept in such convenient places so as to be readily removed as may be directed by the Inspector, so as not to be a nuisance to any person, and shall be kept in a thoroughly sanitary condition, and removed at least once a week and cleansed and disinfected both inside and out.

BY-LAW No. 33.

Regulating the deposit of offensive liquid, etc.

No foul or offensive water, or other offensive liquid, and no garbage, sweepings, or other offensive matter or thing, shall be pumped, emptied, swept, thrown, or otherwise discharged or deposited into or upon any street, lane, yard, vacant land, or other place, whether public or private, within the district, other than the place set apart by the Local Board for that purpose.

BY-LAW No. 34.

Restricting contracts.

No individual householder shall contract for the removal of nightsoil or any other refuse or offensive matter whatever, except with the person licensed by the Local Board, and in accordance with these By-laws.

BY-LAW No. 35.

Regulating the carrying off of storm or rain water.

Every owner shall cause all buildings to be provided with spoutings, downpipes, and drains sufficient to carry off all storm or rain water.

BY-LAW No. 36.

Hospitals.

1. Every private hospital within the district of the said Local Board shall be registered, and shall obtain a license.

2. Every license and registration so granted and obtained shall, subject to the powers of the said Local Board to revoke or cancel the same, be in force for 12 calendar months from the date thereof, and every application for registration and for a license shall state the name and address of the applicant and the qualifications held by him, the situation of the premises proposed to be licensed, the number of rooms contained therein, the maximum number of patients proposed to be treated therein at any one time, the sanitary arrangements in connection with the said premises, the minimum number of nurses to be constantly employed therein; and such application shall also be accompanied by a plan of the buildings and premises, and by a certificate signed by the Inspector of the said Local Board, stating that the sanitary arrangement and the drainage of such premises are satisfactory.

3. The said Local Board shall have the power at any time to cancel or revoke any such license and registration, if, in the opinion of the Local Board, such private hospital endangers health by reason of any drainage connected or adjacent thereto, or by reason of any default in the observance of any by-law or order for the time being in force in the said district, or hereafter to come into force, or if, in the opinion of the said Local Board, either the building or the conduct or management thereof is undesirable to the interest of the public health, or if any complaint is made against any such registered hospital.

4. Any building or premises licensed as by this By-law directed shall, at all times, be open to the inspection of the Inspector or other officer of the Board, who may make any order or direction for the destruction or removal of refuse, and as to the appliances to be used in connection therewith, and any other order or direction regarding the sanitation or the management of the premises, as he or they may think fit.

BY-LAW No. 37.

Penalties.

Any person guilty of any offence against any of these By-laws, not otherwise specially provided for, shall be liable for every such offence, besides any costs or expenses that may be incurred in the taking of proceedings against such person, as well as any costs and expenses which may be incurred in remedying such default, as provided for in "The Health Act, 1898" (Sections 35 and 242), or these By-laws, to a penalty not exceeding the sum of £10, and to a penalty not exceeding the sum of £5 for each day during which such offence shall be continued; and such penalty or penalties shall be recovered as provided in the said Act: Provided always, that no penalty imposed hereunder shall be less than 5s.

BY-LAW No. 10.

SCHEDULE "A."

BY-LAW OF THE YUNDAMINDERA LOCAL BOARD OF HEALTH.

No. 37.

No nightsoil or any human urine, whether mixed with other substances or not, or any solution of nightsoil, shall be removed from any place or depôt duly authorised for the reception, utilisation, or deposit of nightsoil or human urine, without having been first subjected to a heat of not less than 212° Fahrenheit for not less than 15 minutes.

BY-LAW OF THE COOLGARDIE LOCAL BOARD OF HEALTH.

No. 27.

SIR,

I am directed by the Commander-in-Chief to inform you that it has been brought to his notice that on the conclusion of the recent war in South Africa, a large number of Boer families found, on returning to their farms, that their family Bibles had disappeared.

It appears that the Boer inhabitants of the South African Colonies set great store by their family Bibles which often contain family records of some antiquity, and even, in some cases, are the only repository of such records, in consequence of the unavoidable destruction of church registers.

Lord Roberts feels sure that if any persons have in their possession any of these Bibles they will willingly return them, when they learn how they are valued by their former possessors, and he thinks it unnecessary to emphasise how much such a kindly act would be appreciated by our new fellow subjects.

He therefore wishes it to be known as widely as possible among all officers and soldiers who are now serving or have been retired, discharged, or relegated to the Reserve, whether they belong or belonged to the Regular Army, Auxiliary or Colonial Corps, and also among any of their friends, to whom they may have given them as relics, that Mr. W. H. Alexander, of 12 Bishopsgate Without, London, E.C., has kindly consented to receive and despatch to their owners any such Bibles which may have been taken from Boer farms.

He feels sure that the above facts, and the knowledge that it is his wish that all such relics should find their way back to their former owners, will be sufficient to ensure that their present owners, however much they value them, will readily part with them for this purpose.

CRUSHED AND TAILINGS TREATED AT THE STATE
BATTERIES AFTER 1ST JULY, 1903.

HIS Excellency the Governor in Executive Council, under the powers conferred upon him by Section 29 of "The Mining Development Act, 1902," has been pleased to make the following Regulations under which Stone will be crushed and Tailings treated at the State Batteries after 1st July, 1903.

H. GREGORY,
Minister for Mines.

1. All stone accepted for treatment at the State batteries shall be estimated at 21 cubic feet per ton, except where weighing machines are provided, when stone must pass over same to ascertain weight.

2. The manager of the battery may refuse any stone considered too poor to pay crushing charges, unless a deposit is paid in advance.

3. The charge for crushing, as determined from time to time by the Hon. the Minister for Mines, shall be posted up at each battery and strictly adhered to while in force.

4. A minimum charge will be made for all parcels of less tonnage than will return £5 on the rate charged per ton.

5. Payment for crushing shall be made to the manager on completion of treatment, or sufficient gold will be retained to pay for the amount due.

6. Where no cyanide plant has been erected at a battery, any person desirous of claiming tailings, the proceeds of his crushing, shall remove them from the battery site immediately the crushing is completed, otherwise they will be treated as abandoned tailings.

7. Where a cyanide plant has been erected at a battery, tailings resulting from stone crushed at that battery will be treated, but the manager may, in his discretion, refuse to treat any tailings should he consider them unsuitable for treatment by cyanide.

8. The number of tons of tailings suitable for cyanide treatment by the ordinary leaching vat plant installed at the battery shall be determined by the manager, whose decision shall be final; provided that in no case shall such tonnage exceed eighty per cent. of the number of tons milled. Where a slimes plant is working in conjunction with the ordinary vat system, the combined tonnage of sand and slimes shall not exceed 90 per cent. of the tons milled.

9. The manager shall take samples of the tailings as they pass through the battery, or from the pit into which the tailings may be deposited. The tailings collected shall be thoroughly mixed and divided into three samples, one for assay by the manager, one for the owner, and one sealed and kept by the manager for reference. The assay of the manager's sample will be available on application within fourteen days from the completion of any crushing, and should the owner dispute such assay, he shall within six weeks of the completion of the crushing notify the manager to that effect, in writing, and shall at the same time forward a certificate from a competent assayer. On receipt of such certificate the results of the two assays will be averaged, provided that the difference between them does not exceed six grains; but should the difference in the assay exceed six grains, and should the owner still refuse to accept the manager's assay, the manager shall forward the sealed sample previously referred to, to the Government assayer, Perth, and the result of the assay as furnished by him shall be considered as final. The cost of such assay (fifteen shillings) shall be borne by the party whose assay differs most widely from the referee assay.

10. A clean-up will be made about every two months, when the Department will make a *pro rata* distribution, based upon the original assay value of the tailings, the estimated extraction therefrom, and the actual extraction. After the deduction of ten shillings per ton for cost of treatment, the owners of tailings treated will receive the amount due to them within 14 days after the value of the bullion has been ascertained.

11. All tailings assaying less than 3dwts. 3grs. per ton shall become the property of the Government.

12. A charge of ten shillings per ton for treatment shall be the first charge on all tailings treated, and the gold contents of tailings will be paid for at the rate of Four pounds per ounce.

13. All tailings collected for treatment by the owner will be treated at the rate of 27 cubic feet per ton.

14. The Department reserves the right to suspend operations from any cause whatsoever, and will accept no responsibility for delays in treatment.

15. At every battery there will be kept a book in which shall be recorded the number of tons in each parcel lodged for treatment, the name, locality and number of the lease or holding from which it was obtained, and the name of the person for whom the stone is to be crushed.

A copy of the foregoing rules shall be inserted in the said book, and every person sending stone for treatment shall sign opposite the entry relating to the stone lodged by him, and such signature shall be sufficient evidence that he is cognisant of the foregoing rules, and agrees to be bound by them.

FREE ASSAYS AT THE SCHOOL OF MINES,
COOLGARDIE.

WITH the object of encouraging *bonâ fide* prospectors, *free assays* for gold, silver, copper, etc., and determinations of mineral samples and rocks will be made at the School of Mines, Coolgardie, under the following circumstances:—

- (a.) The sender must satisfy the Director that he is a *bonâ fide* prospector, or acting on behalf of such, and that the sample forwarded is one genuinely complying with the following conditions under which free assays will be made.

- (b.) The sample must have been obtained from land within the State not held under lease for mining purposes.
- (c.) The exact locality where the sample was found must be disclosed.

- (f.) Samples to be assayed for gold should weigh about 1 or 2lbs. Other samples should be as large as circumstances will permit, up to 2lbs.
- (g.) Each sample must be properly marked, and securely fastened in a separate bag, along with the name and address of the sender.

REPORT.

WESTERN AUSTRALIA.

To His Excellency Admiral Sir Frederick George Denham Bedford, Knight Grand Cross of the Most Honourable Order of the Bath, Governor in and over the State of Western Australia and its Dependencies, etc., etc., etc.

MAY IT PLEASE YOUR EXCELLENCY,—

In pursuance of your instructions, an inquiry, under Section six, Sub-section (c.), of the Roads Act, was held at the Public Works Office on Wednesday, the 15th July last, in regard to (1) the proposed boundaries, (2) the proposed wards, and (3) the proposed allocation of members to wards, of the proposed Cannington Roads Board District.

Six ratepayers attended in support of the petition which caused Your Excellency to order the inquiry, and five appeared to oppose it; all being ratepayers of the existing Canning Roads Board District. Everyone present stated his views.

I have the honour to report as follows:—

1. As regards the Boundaries of the District:

- (a.) The boundaries proposed and as gazetted are shown on plan marked "A" hereunder.
- (b.) Representations were made showing the desirability of including in the proposed District the portion of Canning Location 34, coloured blue on Plan "A." This I recommend, for the reason that its proximity to the Woodlupine Railway Station warrants it.

The Chairman of the Belmont Roads Board, in whose District this portion of Location 34 is at present included, and who was in attendance, stated that he considered the proposal reasonable, and further, that he anticipated no objection would be raised by the Board he represented.

- (c.) Representations have reached me through the Chairman of the Kelmscott Roads Board asking that the portion coloured green on Plan "A" should be transferred to the Kelmscott Roads Board District. This, having personally inspected the District, I recommend for the reason that, geographically, the area in question is naturally a portion of the Kelmscott Roads Board District owing to its proximity to the Government township of Kelmscott and the Kelmscott Railway Station.

2. As regards the Wards:

- (a.) The boundaries of the wards proposed and as gazetted are shown on Plan "B" hereunder.
- (b.) The only request put forward was that the boundaries of the North Ward be extended to include that portion of Canning Location 34 which I have already recommended should be included in the boundaries of the District as a whole. I see no objection, and therefore recommend it. The portion of Location 34 alluded to is coloured on Plan "B" in a slightly deeper tone than the North Ward, as gazetted.
- (c.) I also recommend that the boundaries of the South Ward should be extended to include the area of land lying between the main road and the Canning River, from the westerly boundary of Location 13 to the Canning Bridge, with a view of increasing the number of voters within the South Ward. I stated at the inquiry my inclination to do this and no objection was raised. The portion alluded to is coloured in a slightly deeper tone than the South Ward as gazetted.

3. As regards the allocation of Members to the Wards:

- (a.) The petitioners desire nine members instead of seven, to be allotted as follows:—

West Ward	3
North Ward	2
Central Ward	2
East Ward	1
South Ward	1

or, if this is not conceded, that the East Ward and South Ward be amalgamated and allotted one member, and the member thereby released be allotted to West Ward.

- (b.) I am of opinion that at present the proposed number of members, namely, seven, is sufficient to represent the district.
- (c.) I, however, recommend that the North Ward be allotted one member instead of two, and that the West Ward be allotted two members instead of one.
- (d.) I do not recommend that the South Ward and the East Ward should be amalgamated and allotted one member only, as I consider that, as the area of these two Wards is so large and forms the greater proportion of the District, it should have greater relative representation on the Board than it would have if only one member represented it.

- (e.) If my recommendations are adopted I consider the district around Woodlupine (North Ward) will be amply represented, especially in view of the fact that some portions of the adjoining Central and West Wards have, from their respective geographical positions, distinct Woodlupine (North Ward) tendencies.

EXACT BOUNDARIES.

The exact boundaries of the District and the Wards which I recommend are defined on Plan "C" hereunder.

Generally.

(a.) The following tabulated statement affords certain information:—

- (b). The district is an agricultural one, with distinct suburban tendencies in the North and West Wards and in the Westerly portion of the Central Ward. It is these conflicting interests that it is difficult to reconcile.
- (c.) Some of the petitioners contended that population should be the sole basis of representation, others that the intention of the Roads Act is against such contention. I have endeavoured, while giving due attention to the incident of population, to arrange that all parts of the district should have reasonable representation. If this is not equitably arranged, then the energetic suburban element in the North Ward, combined with the same element which exists along and within the boundaries in the West Ward and the Central Ward, would entirely dominate the position.

This month was exceptionally wintry throughout the South-West division, especially from the 1st to the 15th. The mean pressure and temperature throughout the State did not differ noticeably from the average for previous years, except in the extreme South-West, where the pressure was considerably lower than usual. The Interstate reports show that this was balanced by anti-cyclonic conditions in Eastern Australia, for the mean pressure at Melbourne and Sydney was above the normal.

Two violent storms visited the West and South-West districts—one on the 6th, bringing an exceptional downpour, and the other on the 14th, producing heavy gales. In connection with the former, rain commenced to fall in Perth at 5.40 p.m. on the 6th, and by 9 a.m. next day 27.9 points of rain were registered, two inches of this falling between 8.25 p.m. and 3.55 the following morning. This is the heaviest rainfall that has been registered at the Observatory, but before the establishment of this institution it was occasionally more severe. In connection with the second storm, the anemometer registered 508 miles between midnight and 4 p.m. on the 14th, the greatest velocity being between noon and 3 p.m., when the gale recorded 136 miles, an average of 45 miles per hour. At the Leeuwin the wind travelled 729 miles from 6 p.m. on the 13th to 6 p.m. on the 14th, and 739 miles for the following 24 hours, the greatest velocity recorded being 46 miles per hour at 8 a.m. on the 14th.

The total rainfall for the month was far in excess of the average for previous years on the West coast, and especially in the neighbourhood of Perth, but there is still a slight deficit in the amount to date since 1st January. On the goldfields there was about a normal quantity, and in the tropics, as usual at this time of the year, little or no rain fell.

During the latter part of the month the weather was mostly fine, and frosts were recorded in some instances. The following table shows the mean and absolute lowest readings of a minimum thermometer placed upon the surface of the ground:—

THE INDUSTRIAL CONCILIATION AND ARBITRATION ACT, 1902.

(1 & 2 Edwd. VII., No. 21.)

IT is hereby notified that His Excellency the Governor in Executive Council has been pleased to approve of the following amendments to the Regulations under the above-named Act.

AMENDED REGULATIONS. Section 49 of the Act.

REGULATION 38 is hereby cancelled, and the following is substituted in lieu thereof :—

38. On the receipt of any such application the Registrar shall notify the Clerk of Awards for the district in which the dispute arises, and direct that all further proceedings before the Board of Conciliation of such district in reference to such dispute be stayed until further order.

When such application shall have been granted or refused, a notification of the granting or refusal shall be sent by the Registrar to the said Clerk of Awards, who shall notify the parties thereof, and thereupon the dispute shall be dealt with by such Special Board or by the existing Board as the case may be.

Disputes shall be dealt with by Special Boards in a manner similar to that prescribed for Boards of Conciliation, and the Regulations shall be deemed to apply to Special Boards accordingly.

In Regulation 44, lines 5 and 6, omit the words "and the notice shall be posted within three days after the filing of the reference."

In Regulation 73 for "section 51" in the head note, read "section 53."

In the same Regulation, clauses (f), (g), and (h), strike out "3s. 0d." and insert in each case "a fee calculated as per the scale prescribed in clause (k) of this Regulation."

In the same Regulation, clause (g), strike out the words "(other than the first copy to each of the parties)."

In the same Regulation, clause (i), strike out the words "not chargeable with any other fee," and in lieu thereof insert "or other officer."

In Regulation 74 strike out, in the twelfth line, the words "the first copy of the award or order of the Court supplied to each of the parties interested."

Regulation 76 is hereby cancelled, and the following is substituted in lieu thereof:—

Section 112 (8) of Act.

76. The following shall be the scale of fees payable to the members of the Court of Arbitration, the Boards of Conciliation, and the Boards of Conciliators on and after the 1st October, 1903.

(1.) The Court of Arbitration:—

(a.) For each member of the Court (other than the President), £6 per week.

(b.) There shall be payable to each member of the Court (other than the President), in addition to the foregoing fees, for each day's absence from Perth:—

When the sitting is held within the Eastern or Western Industrial District, an allowance of 25s.

When the sitting is held elsewhere within the State beyond 25 miles from the General Post Office, Perth, an allowance of 20s.

(c.) The President shall receive travelling allowances as paid to Judges of the Supreme Court for the time being.

(d.) In addition to the foregoing fees, there shall be payable to each member the cost actually paid or incurred by him in respect of fare for passage within the State by rail, vessel, or coach to and from the town in which he resides.

(2) A Board of Conciliation or Special Board of Conciliators:—

(a.) For each day's actual sitting of the Board—
The Chairman and each member of the Board, £1 1s.

(b.) When a majority of the members of the Board, on a day when no sitting of the Board is held, meets in consultation for considering or settling an award, or meets in connection with a case which is before the Board for the purpose of inspecting any works, manufactory, or place where workers are employed, the time so occupied shall be deemed to be a sitting, provided that in every case the fact of the meeting is certified by the Chairman.

(c.) No more than one sitting during any one day shall be charged for or allowed.

(d.) In addition to the foregoing fees, there shall be payable to each member, for each hour or portion of an hour in excess of two hours, travelling within the State to and from the town in which he resides, for the purpose of attending the sitting of the Board, 2s. 6d.; but not exceeding one guinea in any one day.

(e.) In addition to the foregoing fees, there shall be payable to each member the cost actually paid or incurred by him in respect of fare for passage within the State by rail, vessel, or coach to and from the town in which he resides.

In the Schedule, in clause 3 of form 1, clause 4 of form 4, clause 3 of form 17, strike out the words "or industries."

In the Schedule, in form 40 insert as a footnote the following words:—"Should any party to an industrial dispute desire the matter to be heard before a Special Board of Conciliators, such party must apply therefor in Form 39 upon receipt hereof from the Clerk of Awards."
