WHEREAS by Section 219 of "The Municipal Institutions Act, 1900" (64 Vict., No. 8), it shall be lawful for the Governor, on request of the Council, by notice in the *Government Gazette*, to declare any land reserved, used, or by purchase or exchange acquired for a street or way, to be a public highway, and such land shall thereupon and thenceforth, from the date of such Proclamation, become and be absolutely dedicated to the public as a highway, within the meaning of any law now or hereafter in force: AND WHEREAS the Perth Municipal Council has requested that certain land, hereunder named and described, which has been used for a street or way within the Municipality of Perth, be declared a public highway: NOW THEREFORE I, the said Governor, by and with the advice and consent of the Executive Council, do by this my Proclamation declare the said land to be a public highway, and such land shall, from the date of this Proclamation, be absolutely dedicated to the public as a highway within the meaning of any law now or hereafter in force:—

WHEREAS it is by "The Inspection of Machinery Act, 1904," amongst other things enacted that the Governor in Council may from time to time make Regulations for the conduct of examinations and the granting of certificates to engine-drivers: NOW, THEREFORE, the Governor in Council does hereby make the following Regulations relating to the conduct of examinations, qualifications of applicants, and the granting of certificates to steam engine-drivers.

## REGULATIONS RELATING TO THE CONDUCT OF EXAMINATIONS, QUALIFICATIONS OF APPLICANTS, AND THE GRANTING OF CERTIFICATES TO STEAM ENGINE-DRIVERS.

## GENERAL PROVISIONS.

1. The Board of Examiners appointed under "The Inspection of Machinery Act, 1904" (hereinafter termed the Board"), shall examine or cause to be examined, on the subjects hereinafter specified, applicants for certificates of competency as engine-drivers under sections 53, 54, 55 of the said Act. At all meetings of the Board any two members shall be a quorum.

2. For the better conduct of examinations, the Minister may from time to time appoint for any district or districts one or more competent persons who shall act as supervisors, with such functions and powers as the Board thinks fit.

3. The Minister may, in a like manner, appoint any official person employed in the Inspection of Machinery Department to act as Secretary to the Board of Examiners, and such person shall act under the Board's direction.

4. Examinations will be conducted by the supervisors at such times and places as may from time to time be notified by the Secretary of the Board in the *Government Gazette* and in a newspaper or newspapers published or circulated in the locality, and candidates will be examined according to priority of receipt of notice, as required by Regulation 5.

5. Persons desirous of obtaining a Certificate of Competency must forward to the Chief Inspector of Machinery, Perth, notice, in writing, in the form of the First Schedule annexed hereto, of his intention to present himself for examination; such notice to be given not less than twenty-one days prior to the date of examination, and shall clearly state the class of certificate desired.

6. The notice must be accompanied by,—

- (1.) Cash, money order, or postal note to the amount or value of Ten shillings, which fee shall admit of one examination only. In the event of a candidate failing to pass the examination the fee shall be forfeited and paid into the consolidated revenue.
- (2.) The prescribed evidence as to sobriety, experience, and general good conduct, viz. :—
  - (a.) A statement of applicant's age and occupation, where and by whom employed during at least the last twelve months, and the nature of his employment, to which a statutory declaration shall be by him appended to the effect that all the statements contained in such declaration are true. Should any doubt exist as to an applicant's age, he will be required to produce a certificate of birth or baptism.
  - (b.) Testimonials from his employer, or two persons of good repute (whose addresses shall be given), and from a certificated engine-driver, as to his sobriety, experience, ability, and general good conduct. For a First Class Certificate of Competency, the testimonials shall be as herein-after specified under Clause 16, Subclause (d).
  - (c.) Medical certificate that the candidate is not wholly or partially deaf, nor has defective sight, nor is subject to fits, giddiness, or any other infirmity likely to interfere with the efficient discharge of his duties.

7. If in any case the Board does not deem the evidence of sobriety, experience, ability, and general good conduct so produced by the candidate, in compliance with the provisions of the preceding Regulation (No. 6), to be satisfactory, it may refuse to allow such candidate to present himself for examination.

8. If a candidate fail to pass the examination prescribed he shall not again present himself until a period of not less than three months shall have expired from the date of his last examination.

9. The Board, under Section 63 of the Act, may dispense with examination and grant any certificate mentioned in these regulations to any person of good repute who applies for same; who satisfies the Board that he is the holder of a corresponding certificate of equal status granted after examination by any duly constituted Board of Examiners outside this State; that he is still competent to practice as an engine-driver in the State or country wherein such certificate was granted; who pays the prescribed fees and who furnishes the certificate of a duly qualified medical practitioner (dated within one calendar month of the date of receipt of application) that neither his eyesight or hearing are defective, and that he is not subject to any mental or bodily infirmity likely to interfere with the efficient discharge of his duties.

10. Any person who obtains or attempts to obtain any certificate by means of fraud or false pretences, or any false document, shall be liable to disqualification for any period the Board may think fit; and shall not, during such period of disqualification, practice as an engine-driver or present himself for examination; and any certificate obtained by any such means shall be returned to the Board, and shall be cancelled.

11. No person under the age of eighteen years, nor any person who has not had practical experience with steam engines, boilers, and pumps, and is not a naturalised British subject shall be accepted as a candidate for any examination.

12. No application shall be considered, and no certificate shall be issued, unless full payment of the fees as prescribed by these Regulations shall have been made to the Chief Inspector of Machinery at Perth.

13. A candidate must, if possible, furnish testimonials of certificates signed by his employers; and such documents must specify clearly and distinctly the class of engines and diameter of their cylinders that he has driven or assisted to drive. In cases where a candidate is unable from any sufficient cause to produce testimonials from his employers of his having driven engines, the Board may accept a statutory declaration or other sufficient proof that such candidate has driven or assisted to drive a certain engine or engines at certain places for 12 months, within a period of three (3) years immediately prior to date of examination, as evidence of his having had the necessary experience to entitle him to be examined. The diameter of the cylinders of the engine, and the period employed therein, shall be stated in the testimonials as well as appearing on the application form.

14. No applicant for examination shall pay, give, or offer any gratuity or remuneration whatever to any member of the Board, or to any officer, messenger, or servant of the department; and any applicant or intending applicant who shall offer or give any remuneration shall be regarded as having failed in his examination, and shall be ineligible to present himself for a period of at least six (6) months; and any fees which may have been paid by the applicant shall be forfeited and paid into consolidated revenue.

#### CERTIFICATES OF COMPETENCY.

15. The Certificates of Competency to be issued by the Board of Examiners shall be of five (5) classes, namely, First, Second, and Third for Stationary Engine-drivers, Locomotive and Traction Engine-drivers' Certificates, and Marine Engine-drivers' Certificates.

- (a.) A First Class Certificate shall entitle the holder thereof to drive and have charge of any stationary steam engine used for mining, factory, or other purposes; but not to drive a locomotive, traction, or steam engine forming part of the propelling machinery on board of any local ship, vessel, or steamer employed in carrying goods or passengers for reward.
- (b.) A Second Class Certificate shall entitle the holder thereof to drive and have charge of any stationary steam engine used on or in connection with a mine, factory, or other place; but not to drive a winding engine by which men are raised or lowered, or used for hauling ore or other material from the main underlay shaft of any mine, or of any locomotive, or traction engine, or of a steam engine forming part of the propelling machinery on board any local ship, vessel, or steamer employed in carrying goods or passengers for reward.
- (c.) A Third Class Certificate shall entitle the holder thereof to drive and have charge of any stationary steam engine used on or in connection with a mine, factory, or other place, the cylinder of which does not exceed twelve (12) inches in diameter, or, if the engine has more than one cylinder, the combined area of the cylinders does not exceed that of a single cylinder, the diameter of which is twelve (12) inches. Provided that such engine is not a winding engine, a locomotive, traction engine, or a steam engine forming part of the propelling machinery on board any local ship, vessel, or steamer employed in carrying goods or passengers for reward.
- (d.) A Locomotive and Traction Engine-driver's Certificate, without any restriction expressed therein, shall entitle the holder thereof to drive and have charge of any locomotive or traction engine propelled or moved from place to place by its own motive power or machinery, and of any stationary steam engine used in connection with a mine, factory, or other place where it is lawful for the holder of a second class certificate to drive; but if any restriction is expressed therein such certificate shall only entitle the holder to the privileges of a third class certificate under the Act.
- (e.) A Marine Engine-driver's Certificate shall entitle the holder thereof to drive and have charge of any engine used in connection with and forming part of the propelling machinery of any local ship, vessel, or steamer which comes within the provisions of "The Inspection of Machinery Act, 1904," and is employed in carrying goods or passengers for reward. The certificate shall also entitle the holder to the same privileges as a second class certificate under the Act.

16. An applicant for a First Class Certificate of Competency must produce to the Board satisfactory evidence—

- (a.) Of his respectability of character.
- (b.) That he can read and write the English language, and is conversant with arithmetic up to the compound rules.
- (c.) That he has been the holder of a Second Class Certificate under "The Inspection of Machinery Act, 1904," or a certificate equivalent thereto in the opinion of the Board, for a period of not less than twelve (12) months; and that he has during six (6) months of that period been actually assisting to drive a winding engine under the supervision of a first-class certificated engine-driver for at least twelve (12) hours per week.
- (d.) Testimonials signed by his employer or engineer and by a first-class certificated engine-driver by whom the applicant has been taught, bearing on sobriety, experience, ability, and general good conduct. Such document shall be signed and declared by the said first-class certificated engine-driver before a justice of the peace, or a Commissioner for taking declarations and affidavits, to be true and correct in every particular.
- (e.) That he is, at the date of examination, not under the age of twenty-one (21) years nor over the age of fifty (50) years. A candidate who satisfies the Board that the necessary experience in driving winding engines had been gained prior to attaining the age of fifty (50) years may, in the discretion of the Board, be considered eligible for examination.
- (f.) That neither his eyesight nor his hearing is defective, and that he is not subject to any mental or bodily infirmity likely to interfere in the efficient discharge of his duties. For the purposes of this clause the certificate of a duly qualified medical practitioner, dated within one calendar month of the date of the receipt of application, must be furnished, which certificate shall be permanently retained by the Board.

The applicant must be able to pass a creditable examination as to the construction of various steam engines, pumps, and boilers in general use, and as to the details of different working parts, external and internal, be able to explain how to detect and correct defects, and what action is necessary in the ordinary emergencies which may arise in connection with winding and other engines, pumps, and boilers, and be able to work out certain arithmetical questions put to him by the examiners.

17. An applicant for a Second Class Certificate of Competency must produce to the Board satisfactory evidence—

- (a.) Of his respectability of character.
- (b.) That he can read and write the English language and is conversant with arithmetic up to compound rules.
- (c.) That he has been the holder of a Third Class Engine-driver's Certificate under "The Inspection of Machinery Act, 1904," or a certificate equivalent thereto in the opinion of the Board, for a period of not less than twelve (12) months; and has for at least twelve (12) hours per week during a period of not less than six (6) months been assisting to drive a steam engine, the cylinder of which is more than twelve (12) inches in diameter, or a double-cylinder engine, the cylinders of which have a combined area equal to that of a single cylinder of more than twelve (12) inches in diameter.
- (d.) That he is at the date of examination not under the age of nineteen (19) years, nor over the age of fifty (50) years. A candidate who satisfies the Board that necessary experience in driving stationary engines had been gained prior to attaining the age of fifty (50) years may, in the discretion of the Board, be considered eligible for examination.
- (e.) That neither his eyesight nor his hearing is defective, and that he is not subject to any mental or bodily infirmity likely to interfere with the efficient discharge of his duties. For the purposes of this clause the certificate of a duly qualified medical practitioner, dated within one (1) calendar month of the date of receipt of application, must be furnished, which cer-

tificate shall be permanently retained by the Board. The applicant must pass a creditable examination, and be conversant with the working parts of various stationary engines, pumps, and boilers in general use, the different parts and uses of the same, including the feeding of boilers, running of engines, and be able clearly to explain how he would overcome simple defects that might arise in the management and maintenance of boilers, pumps, and engines, and to work out certain arithmetical questions put to him by the examiners.

18. An applicant for a Third Class Certificate of Competency must produce to the Board satisfactory evidence—

- (a.) Of his respectability of character.
- (b.) That he is able to read and write the English language, and is conversant with the first four rules of arithmetic.
- (c.) That within a period of three (3) years immediately prior to the date of examination he has, during not less than twelve (12) months, and for not less than twelve (12) hours per week, been actually employed under a certificated engine-driver assisting to drive a steam engine with a boiler and accessories connected therewith, and used for mining, factory, or other purposes.
- (d.) That he is on the date of examination not under the age of eighteen (18) years, nor over the age of fifty (50) years. A candidate who satisfies the Board that necessary experience in driving engines had been gained prior to attaining the age of fifty (50) years, may, in the discretion of the Board, be considered eligible for examination.
- (e.) That neither his eyesight nor his hearing is defective and that he is not subject to any mental or bodily infirmity likely to interfere with the efficient discharge of his duties. For the purposes of this clause the certificate of a duly qualified medical practitioner, dated within one (1) calendar month of the date of receipt of application, must be furnished; which certificate shall be permanently retained by the Board.

The applicant must be able to pass a creditable examination as to the use of the principal parts of steam engines, pumps, and boilers in general use, and be able to describe the various fittings and working parts and their uses; also what action is necessary in the ordinary emergencies which may arise in connection with such engines, pumps, and boilers, and other minor matters dealing with safety and proper working of boilers.

19. An applicant for a Locomotive and Traction Engine-driver's Certificate must produce to the Board satisfactory evidence—

- (a.) Of his respectability of character.
- (b.) That he can read and write the English language, and is conversant with arithmetic up to compound rules.
- (c.) That he has been firing and assisting to drive a locomotive or traction engine moved from place to place by its own motive power or machinery for at least six (6) hours per day during a period of not less than twelve (12) months within three (3) years prior to the commencement of this Act. In the case of an applicant being the owner, a certificate from a Justice of the Peace, or two persons of good repute, that the applicant has been in charge of and has driven a locomotive or traction engine for a period of not less than six (6) months prior to the commencement of the Act, may be considered satisfactory evidence as to experience.
- (d.) That he is at the date of examination not under twenty-one (21) years of age, nor over the age of fifty (50). A candidate who satisfies the Board that necessary experience in driving locomotive and traction engines had been gained prior to attaining the age of fifty (50) years, may, in the discretion of the Board, be considered as eligible for examination.
- (e.) That he is conversant with the rules of the road and the conditions under which traction engines are allowed to travel on public roads and highways; and understands the meanings of all the different lights and signals used on the Government Railways in Western Australia.

- (f.) That he is free from colour-blindness, short-sightedness, or other defects of the eyes; that his hearing is not defective, and that he is not subject to any mental or bodily infirmity likely to interfere with the efficient discharge of his duties. For the purposes of this clause the certificate of a duly qualified medical practitioner, dated within one (1) calendar month of the date of receipt of application, must be furnished; which certificate shall be permanently retained by the Board.

The applicant must be able to pass a creditable examination as to the details of the different parts of locomotives and traction engines, and explain the use of each part, the use of the various cocks, gauges, valves, and connections on boilers, and state how temporary repairs could be effected in case of derangement to engine or boiler; he must understand the effect of impurities in water used in such boilers, and the methods adopted to keep them clean; and be able to work out certain arithmetical questions put to him by the examiners.

20. Provided that where an applicant is desirous of obtaining a certificate as a traction engine driver only, the Board may, upon being satisfied as to applicant's practical experience and general ability, grant to him a certificate, which shall be suitably endorsed—

“To drive traction engine only; also entitles the holder to the privileges of a Third Class Certificate.”

21. An applicant for a Marine Engine-driver's Certificate of Competency shall produce to the Board satisfactory evidence—

- (a.) As to good conduct and service.
- (b.) That he can read and write the English language, and is conversant with arithmetic up to the compound rules.
- (c.) That he has had at least two (2) years afloat as fireman or greaser, or has served not less than one year afloat as a fireman and not less than one year in a workshop in the making or repairing of engines as a skilled artisan; or such service as, in the opinion of the Board, is equal to the qualifying service first mentioned. Provided that not less than six (6) months of the qualifying service must have been service afloat in the engine-room.
- (d.) That he is, at the date of examination, not under the age of twenty-one (21) years, nor over the age of fifty (50). A candidate who satisfies the Board that necessary experience in driving marine engines had been gained prior to attaining the age of (50) years, may in the discretion of the Board, be considered as eligible for examination.
- (e.) That neither his eyesight nor his hearing is defective, and that he is not subject to any mental or bodily infirmity likely to interfere with the efficient discharge of his duties. For the purposes of this clause, the certificate of a duly qualified medical practitioner, dated within one (1) calendar month of the date of receipt of application, must be furnished; which certificate shall be permanently retained by the Board.

The applicant must be able to pass a creditable examination as to the position and use of principal parts of boilers and machinery used in simple, compound, and triple expansion engines; how the steam does its work in the engines in general use in steam vessels to which “The Inspection of Machinery Act, 1904,” applies; be able to explain the construction and use of the salinometer, thermometer, hydrometer, and the working of boilers with salt water; the use of all cocks and valves on boilers, and connections generally on ship's side and attached to engine; and the principle and construction of feed and auxiliary pumps; and to be able to work out certain arithmetical questions put to him by the Examiners.

#### EXAMINATIONS.

22. Applicants for Certificates of Competency shall have a knowledge of the provisions relating to engine-drivers in—

- (a.) “Inspection of Machinery Act, 1904.”
- (b.) “Mines Regulation Act, 1895,” and its amendments, and in any passed in substitution for the same and in force for the time being.
- (c.) “Coal Mines Regulation Act, 1902.”
- (d.) Or any other Act relating to engine-drivers' certificates, in force for the time being.

23. Applicants for Certificates of Competency, in addition to the aforesaid requirements, shall be examined in such parts of the following syllabus as may be applicable to their duties:—

- (a.) The various types of winding engines in use in Western Australia, and their component parts.
- (b.) The various types of boilers in use in Western Australia, and their component parts.
- (c.) The various types of condensers, air-pumps, and circulating pumps used in connection with steam-engines; the various methods of dealing with the exhaust steam from engines.
- (d.) The various types of hoisting arrangements in shafts and headgears.
- (e.) The various signalling arrangements used in connection with winding engines.
- (f.) The governor and steam-throttle arrangements of steam-engines, and regulating of the same.
- (g.) Auxiliary starting valves, bye-pass valves, and relief valves.
- (h.) Cylinders and pistons, dangerous defects relating thereto; also methods of attaching piston to rod.
- (i.) The various valve-gears applied to steam-engines, the action of them in starting, stopping, and reversing; how dangerous defects may be recognised and readily remedied in some cases.
- (j.) Lubrication and lubricators, and the effect on bearings and other working parts; of the stoppage of oil or grease supply.
- (k.) How the other parts of engines and the shafts and drums are connected up or geared.
- (l.) How ropes are attached to and coiled on drums; defects relating thereto.
- (m.) Various forms of brakes, how operated and how adjusted; the defects relating to their operation.
- (n.) The various types of depth indicators, and the working and adjusting of the same; with special reference to safety signals, changing levels, and usual safety appliances.
- (o.) The draining of stop valves and steam-pipes; how to connect boilers under steam.
- (p.) Boilers; feeding and firing arrangements; effect of high and low water; grease, deposit, scale, and how to act in cases of emergency.
- (q.) All boiler fittings; their names and uses.
- (r.) Dangerous defects relating to boilers, their fittings and settings; how observed and how dealt with.
- (s.) The handling of winding engines, and how to act in cases of emergency; and,
- (t.) Generally, the proper maintenance and economical working of steam machinery, including various engines, boilers, furnaces, pumping, propelling and winding gear.

24. The examination shall be partly conducted by means of written or printed papers, and partly *viva voce*, at the discretion of the Examiners, in order that candidates' acquirements may be tested, as far as possible, in one day's work.

25. The examinations shall be essentially of a practical character.

26. In the examination papers the possible number of marks obtainable for each answer shall be stated.

27. The envelopes containing examination questions shall be opened by the Supervisor in the presence of the candidates.

28. Candidates shall write out their answers to the questions in the presence of the Supervisor, and in accordance with the following instructions:—

- (a.) Examinations shall commence at 9:30 a.m. on the advertised dates. Candidates shall be in their places five minutes before the time fixed for the paper. After this time no candidate shall be admitted, unless under very exceptional circumstances, and by express permission of the person or persons supervising the Examinations. Provided, always, that no person who has seen the paper shall have previously left the room. No candidate who shall have entered the room, and may desire to abandon the examination, shall, under any circumstances whatever, be permitted to leave before the expiration of one half-hour from the time of the paper being given out. No writing paper, blotting-paper, books, or manuscripts are allowed to be brought into the examination room.

- (b.) Any candidates who arrive at the examination room with books, papers, or manuscripts in his possession, whether referring to the subject of examination or not, must give them up at the door of the examination room before taking his place.
- (c.) Perfect silence shall be maintained, and no communication, by word or otherwise, between candidates will be allowed during the examination; if any candidate wishes to communicate with the Supervisor he must stand up in his place.
- (d.) Any candidate violating any of these regulations, or behaving in a disorderly manner in or about the examination room, will have to immediately leave the building, and the Board, on the recommendation of the Supervisor, may subsequently cancel his paper.
- (e.) The candidate is to write on one side only of his paper, and must lay each sheet, when finished, face downwards, close beside him, and must take care that no other candidate shall have any opportunity of copying from his paper. Candidates will be held responsible if their written papers are exposed in such a manner that they may be copied by their neighbours. If a Supervisor is convinced that copying or collusion has taken place between two candidates, both candidates are liable to be disqualified.
- (f.) On the first page of each paper a candidate must write the date and place of examination. He must also place on every sheet his name in full. When he has completed his written answers he is to fasten them together at the left-hand top corner and seal them in an envelope which will be supplied to him for the purpose. He shall then hand the envelope to the Supervisor. Any breach of the rules in this paragraph will at least cause delay, and may cause the omission of a successful candidate's name from the published list.
- (g.) In answer to arithmetical questions, the details of the work must be given; no credit will be allowed for answers only to such question.
- (h.) Warning will be given ten (10) minutes before the time fixed for giving up papers. When the papers are called for, everyone is to cease work immediately.
- (i.) Candidates should so arrange their papers that on being opened by the Board the answer to the first question may face it, and other answers must be attached in proper sequence.
- (j.) Places will be allotted to the candidates so that they may be seated about 5ft. apart from centre to centre, where practicable. All writing materials and paper fasteners for connecting the written papers will be provided by the department.
29. Candidates will be allowed in the time allotted for their examination to cancel any part of their work, and additional paper will be supplied by the Supervisor when required; but candidates will not be allowed to work out any problem on waste-paper.
30. The envelopes containing the worked papers shall be initialled by the Supervisor or an authorised officer of the department, as they are received from each candidate, as a guarantee that each paper has been worked by the person whose name it bears.
31. Directly after each examination the envelopes containing the worked papers must be securely packed and sealed by the Supervisor, who shall immediately forward them to the Secretary of the Board, at Perth. Before they are sealed, no person (not being a Supervisor or authorised officer of the Department) shall be allowed to enter the room, except by permission of the Chairman of the Board.
32. The members of the Board shall have equal jurisdiction as to the questions set, and shall be equally responsible for those set.
33. No person shall be eligible to act as a Supervisor of any examination who shall have acted as a coach to, or instructor of, pupils at any time during the six (6) months immediately preceding such examination, unless by special permission of the Minister.
34. The minimum marks to qualify for a pass shall be fixed by the Board of Examiners, and shall be stated in each set of examination questions.

35. After each examination the Supervisor or Supervisors shall furnish a report to the Board, which shall contain a statement of the names of the persons examined, and the efficiency of each candidate in the *viva voce* examination.

#### CERTIFICATES OF SERVICE.

36. Certificates of Service will be granted by the Board without examination to any person of good repute who, not later than the twenty-eighth (28th) day of February, nineteen hundred and seven (1907), applies for the same by filling up the application in the form of the First Schedule annexed hereto, pays the prescribed fee of ten shillings, and complies with the following conditions:—

- (a.) For a First Class Certificate of Service an applicant must furnish the Board with satisfactory evidence that, for a period of twelve (12) months within three (3) years immediately prior to the twelfth (12th) day of October, one thousand eight hundred and ninety-five (1895), he has been in charge of and efficiently managed, upon a mine, machinery worked by steam consisting of winding, pumping, and crushing engines with boilers and appendages. Provided that a similar Certificate of Competency or Service has not been refused by a Board of Examiners appointed under "The Mines Regulation Act, 1895," and its amendments, or "The Coal Mines Regulation Act, 1902." He must also furnish the certificate of a duly qualified medical practitioner, dated within one (1) calendar month of the date of receipt of application, that neither his eyesight nor his hearing is defective, and that he is not subject to any mental or bodily infirmity likely to interfere with the efficient discharge of his duties.
- (b.) For a Second Class Certificate of Service an applicant must furnish the Board with satisfactory evidence that for a period of not less than twelve (12) months within a period of three (3) years immediately prior to the commencement of "The Inspection of Machinery Act, 1904," he has been in charge of and efficiently managed and driven a steam-engine, the cylinder of which exceeds twelve (12) inches in diameter, or if the engine has more than one cylinder, the combined area of the cylinders exceeds that of a single cylinder twelve (12) inches in diameter, including boilers and appendages; and that he has not previously been refused a certificate of competency by a Board of Examiners appointed under "The Mines Regulation Act, 1895," and its amendments, or "The Coal Mines Regulation Act, 1902;" and also furnishes the certificate of a duly qualified medical practitioner, dated within one (1) calendar month of the date of receipt of application, that neither his eyesight nor his hearing is defective, and that he is not subject to any mental or bodily infirmity likely to interfere with the efficient discharge of his duties, which certificate shall be permanently retained by the Board.

37. An applicant for a Third Class Certificate of Service must produce documentary evidence and satisfy the Board that he has been in charge of and efficiently managed and driven a steam-engine (including boilers and appendages) for a period of not less than twelve (12) months within three (3) years immediately prior to the first day of March, one thousand nine hundred and five (1905); and must furnish the certificate of a duly qualified medical practitioner, dated within one (1) month of the date of receipt of application, that his eyesight and hearing are not defective, and that he is not subject to any mental or bodily infirmity likely to interfere with the efficient discharge of his duties; which certificate shall be permanently retained by the Board.

38. An applicant for a Locomotive and Traction Engine-driver's Certificate of Service must produce documentary evidence and satisfy the Board that he has been in charge of and efficiently managed and driven a locomotive and traction engine, or either of them, for not less than twelve months within a period of three (3) years immediately prior to the first day of March, one thousand nine hundred and five (1905); and must furnish the certificate of a duly qualified medical practitioner, dated within one (1) calendar month of the date of receipt of application, that his eyesight and hearing are not defective, and that he is not subject to any mental or bodily infirmity likely to interfere with the efficient discharge of his duties, which certificate shall be permanently retained by the Board.



Should an applicant's service have been confined to a traction engine only, the Board may grant him a certificate under this clause, which shall be suitably endorsed:

"To drive traction engine only; also entitles the holder to the privileges of a third class certificate."

In the event of an applicant being an owner, a certificate from a Justice of the Peace, or two persons of good repute, that the applicant has been in charge of and has driven a locomotive or traction engine for the period and during the time prescribed in this clause, may be accepted as satisfactory evidence of service.

39. Certificates of Service, granted in accordance with these Regulations, shall entitle the holder thereof to the same privileges as a Certificate of Competency of the same class.

#### INTERIM CERTIFICATE.

40. The Board, or any member thereof, may grant an Interim Certificate to an engine-driver who has not had an opportunity of presenting himself for examination, either of Competency or Service, and who applies for the same by filling up the prescribed form (Second Schedule hereto), pays the prescribed fee of five shillings, and complies, to the satisfaction of the member, with the following conditions:—

- (a.) That he is the holder of a certificate which is equivalent to an Engine-driver's Certificate under "The Inspection of Machinery Act, 1904," and which has been granted by any duly constituted and recognised authority outside the State.
- (b.) That at the date of applying for the Interim Certificate he is still competent to practice as an engine-driver in the State or Country wherein the original certificate had been granted to him.
- (c.) That the original certificate belonging to the applicant shall be forwarded to the Chief Inspector of Machinery, Perth, who shall retain it until the expiry of term of the Interim Certificate, when it shall be restored to its owner.
- (d.) That he furnishes to the Board the certificate of a duly qualified medical practitioner, dated within one (1) calendar month of the date of application, that his eyesight and hearing are not defective, and that he is not subject to any mental or bodily infirmity likely to interfere with the efficient discharge of his duties, which certificate shall be permanently retained by the Board. Such medical certificate may, at the discretion of the Board, be considered good for a period not exceeding six (6) months from the date appearing on the face thereof.

#### COPIES OF CERTIFICATES.

41. Whenever an engine-driver proves to the satisfaction of the Board that he has, without fault on his part, lost or been deprived of any certificate previously granted to him under the provisions of "The Inspection of Machinery Act, 1904," "Mines Regulation Act, 1895," and its amendments, "Coal Mines Regulation Act, 1902," or "The Boat Licensing Act, 1878," and who applies for a copy of the same by filling up the prescribed form (Third Schedule hereto), the Board shall, upon payment by the engine-driver of the prescribed fee of Five shillings, cause a copy to be made of the certificate to which the applicant appears to be entitled, which copy shall be suitably indorsed and certified to by the Chairman or Secretary of the Board and delivered to the applicant. Any such copy so made out, indorsed, and certified as aforesaid, shall have the effect of the original certificate, provided that the applicant shall also prove to the satisfaction of the Board that he has made reasonable efforts to recover his lost certificate.

#### MISCELLANEOUS.

42. Every Certificate of Competency or Service issued under "The Inspection of Machinery Act, 1904," shall specify the name, place, and date of birth of the person to whom such certificate is issued.

43. Every holder of a second or third class certificate granted under these regulations shall deliver such certificate to the Board prior to his being examined for a higher certificate; and in the event of a higher certificate being granted, his former certificate shall be surrendered to the Board and cancelled.

44. Should the holder of any certificate from the Board of examiners mutilate, efface, add to, or erase in any manner the certificate issued, the Board may, in its dis-

cretion, recommend to the Minister the cancellation of such certificate, and he shall not be allowed to apply for its renewal until a period of not less than twelve months has elapsed from the date of the *Government Gazette* containing the Governor's approval of such cancellation. If it shall be proved to the satisfaction of the Board that such mutilation, defacement, addition, or erasure is due to malice on the part of some person other than the registered holder, the Board may, in its discretion, recommend to the Minister the reduction of the period hereinbefore mentioned.

#### COMPLAINTS.

45. If an owner, or any responsible person under him, or any inspector appointed under the Acts mentioned in these Regulations, represents at any time in writing to the Board that any engine-driver holding a Certificate of Competency or Service, or an Interim Certificate, is by reason of incompetency or gross negligence unfit to discharge his duties, or that he has been convicted of any offence against the "Inspection of Machinery Act, 1904," "Mines Regulation Act, 1895," and its amendments, "Coal Mines Regulation Act, 1902," or the "Boat Licensing Act, 1878," or any other Act relating to engine-drivers' certificates in force for the time being, or that he has been guilty of misconduct likely to be detrimental to the proper or efficient discharge of his duties, or that he has developed any symptoms of epilepsy or other serious complaint which would render him unfit to efficiently perform his duties as an engine-driver, the Board may call upon the engine-driver to appear before such persons as may be appointed by the Minister (one of whom shall be a police or resident magistrate, or a justice of the peace), to show cause why he should not be disqualified from acting as an engine-driver. The persons appointed as aforesaid to conduct such inquiry may call such evidence as is deemed necessary, and such evidence shall be on oath or affirmation, which any person appointed as aforesaid may administer. The Board shall be furnished with depositions taken at such inquiry, together with a report thereon, by the persons so appointed; and if it appears to the Board that the engine-driver has failed to show good cause why he should not be disqualified as a certificated engine-driver, the Board may report to the Minister accordingly. The Minister may thereupon, by notice in the *Government Gazette*, disqualify him for such period as he thinks fit, and during the period of disqualification he shall not take charge of any machinery where a certificated engine-driver is by law required; or the Minister may, by notice in the *Government Gazette*, alter, suspend, or cancel any certificate granted to such person.

46. With respect to any inquiry held under Regulation 45, the following provisions shall have effect:—

- (a.) The inquiry shall be held at such time and place as the Board may appoint, and the engine-driver shall have the right to engage counsel to defend him at such inquiry. He shall receive 14 days' notice of the Board's intention to authorise the holding of an inquiry; and if the engine-driver intends to employ counsel he shall give seven days' notice of such intention to the Chairman of the Board.
- (b.) Any person shall, upon the receipt of such notice, deliver into the charge of the Inspector of Machinery for the District, or to the Chief Inspector of Machinery at Perth, his Certificate of Competency or Service as the case may be. The certificate shall be returned to him should the complaint or charge not be sustained.
- (c.) The Board shall furnish to the engine-driver, not less than fourteen (14) days before the commencement of the inquiry, a statement of the case upon which the inquiry is instituted.
- (d.) The engine-driver shall, at his own expense, attend such inquiry, and may produce such evidence as he may consider necessary.
- (e.) An engine-driver may, in addition to his disqualification, suspension, or reduction, be required to defray all or part of the expenses of any inquiry which may be held under the provisions of this Regulation.

47. No person in charge of any steam engine used for mining, factory, or other purposes shall, under any pretext whatever, unless relieved by a competent person holding the required certificate for that purpose, absent himself or cease to have continual supervision of such steam engine during the time it is at work. Any person so offending shall be deemed guilty of a breach of these Regulations.

#### CUE AND DAY DAWN WATER BOARD.

##### SECTION 1.—BY-LAWS FOR PROTECTING THE GROUNDS, WATER, WORKS, ETC., FROM TRESPASS AND INJURY.

1. No person shall trespass within the fenced-off ground adjacent to the pumping station near Jack's Well.

2. No person shall bathe or wash clothes or other articles in any reservoir or other waterworks within the water area, or wash, throw, or cause to enter therein any dog or other animal; or throw or convey, or permit to be conveyed or thrown therein any rubbish, dirt, filth, dead animal, or other noisome thing.

3. Picnic parties or other persons shall not camp or light fires in the vicinity of the pumping station on land fenced off, without special permission.

4. No person shall drive or conduct any vehicle or animal across the main conduit between Pumping Station Nallan and Cue Service Reservoir, except at the crossing-places provided, and the owner of any animal or live stock shall not allow the same to cross such conduit except at such crossing-places.

5. No person shall, without first obtaining a license, cut or remove timber from any land within the water area, or from any reserves or other properties in possession of the Board.

6. No person shall without proper authority enter any machinery-house, valve-house, or other portion of the works in the vicinity of the reserve not open to the public.

7. Any person committing a breach of any of the foregoing By-laws shall be liable to a penalty not exceeding £20 (Twenty pounds).

##### SECTION 2.—BY-LAWS FOR THE LICENSING OF PLUMBERS.

8. In these By-laws the terms used are to be interpreted by the meanings given by Section 3 of "The Water Boards Act, 1904." "Chairman" shall mean Chairman of the Board, and "Officer" shall mean an officer who has been appointed, in writing, by the Chairman for purposes of these By-laws, and whose appointment has been notified in the *Government Gazette*.

9. No person shall affix, alter, or repair any service pipe or fitting to be used in connection with any main or other pipe belonging to the waterworks, or interfere in any way therewith, unless licensed as a plumber or holding an operative plumber's certificate under these By-laws.

10. An application for a plumber's license or an operative plumber's certificate shall be in writing, signed by the applicant, and addressed to the Chairman.

11. Every applicant for a plumber's license or an operative certificate shall satisfy the Chairman that he is a competent plumber, and may be required to submit to an examination in the theory and practice of plumbing work.

12. Every license or certificate shall be granted by the Board; and the granting and cancellation of any license or certificate shall be in the absolute discretion of the Board.

13. Every license or certificate shall be annual, expiring on the 10th day of January next following the granting thereof, and may be in the Form A or Form B in the Schedule hereto.

14. A fee of One pound shall be payable for every license or certificate, except when a license or certificate is granted after the 10th day of July in any year, in which case the fee shall be Ten shillings.

15. Every applicant for a plumber's license shall, before receiving a license, deposit with the Board the sum of Five pounds, to be held by the Board during the currency of the license as security for the proper performance of all work undertaken by the licensee.

16. The Board may deduct from such deposit the expense of making good any bad work of the licensed plumber or his workmen (notwithstanding that such workmen are holders of operative plumbers' certificates), and as often as any expense is so deducted the licensed plumber shall make good the deposit to the sum of Five pounds, and in default his license will be cancelled.

17. Every licensed plumber shall, within forty-eight hours of any change in his address, give notice in writing thereof to the Board.

18. The mains shall be tapped only by the workmen of the Board.

19. No licensed plumber or operative plumber shall interfere with any pipe or fitting belonging to the waterworks without the permission, in writing, of an officer appointed by the Board under these By-laws first obtained.

20. No ground shall be opened, nor shall any work be undertaken for the purpose of laying and fixing a new service or fittings, or in the extension or alteration of an existing service or fittings, until notice shall have been given by the responsible plumber to an officer appointed by the Board under these regulations. Such notice shall be in writing, in the Form C in the Schedule, and shall describe the nature and extent of proposed work, and shall be given forty eight hours at least before the work is intended to be commenced, unless the officer expressly accepts shorter notice.

21. On the completion or extension of any service the responsible plumber shall report the work as ready for inspection.

22. In no case shall the ground be filled in or water be turned on to any land until the work executed by the responsible plumber has been examined and passed by an officer and a certificate in writing has been given by such officer to that effect.

23. Any person committing a breach of any of the foregoing By-laws shall, upon conviction, be liable to a penalty not exceeding Twenty pounds.

#### SECTION 3.—BY-LAWS FOR GENERAL PURPOSES.

24. Within the Cue and Day Dawn Water Area the water rate shall be at the rate of One shilling and fourpence in the £ per annum upon the net annual value of all rateable land.

25. Within the Water District, water services to non-rated premises will be given on the terms and conditions as set forth hereunder; provided that, in accordance with the provisions of "The Water Boards Act, 1904," other terms and conditions may be agreed upon as occasion may arise:—

26. The minimum sum payable as rates shall be one pound per annum.

27. Rates shall become due and payable half-yearly, in advance, on the first day of January and the first day of July: Provided that in all cases where a water rate is made after the first day of January or the first day of July in any year, the notice of the order for the making and levying of such rate, published in the *Government Gazette* and a newspaper, as provided by section 94 of the said Act, shall specify the minimum sum payable as rate as aforesaid, and the date or dates when the rate shall be due and payable, and such rate shall be and become due and payable in accordance with the terms of such notice.

28. Within the Cue and Day Dawn Water District every ratepaying consumer will be entitled to a supply of water at the rate of 10s. per thousand gallons in return for the amount of rates paid by him. Provided that such water shall be taken during the period for which the rate is struck, and that the maximum quantity to be taken in consideration of the rate during any one half of a year shall not exceed one half of the quantity to which the consumer is entitled in respect of an annual rate. Any consumer taking water in excess of the quantity to which he is entitled in respect of a rate will be charged at the rates and on the conditions set forth in By-law No. 25.

29. Every half-year shall end on the 30th June or 31st December in every year.

30. Where water is supplied by measure to the owner or occupier of land not rated under the Act, payment for the same shall be made at such times and in such manner as may be agreed upon between the Board and the consumer.

31. Any person or persons requiring a water service to town or suburban premises in respect of which for the time being a water rate may not be made, may be supplied on payment of a minimum charge, which shall be fixed by the Board in each case. The minimum charge shall then take the place of a water rate, and the general provisions of these By-laws, as applying to rate-paying consumers, shall apply to minimum charge paying consumers.

32. Application for services shall be made on the printed form, procurable at the Board's office, and shall be lodged not less than three days before the service is required.

33. Applications will not be entertained unless full information, as indicated on the printed form, is supplied, and the full amount of rates due on the premises to which a service is required is paid.

34. The Board may, by notice to a consumer, from time to time restrict the quantity of water that may be supplied to him in any one week.

35. The Board may from time to time, when necessary for the purpose of tapping or repairing the main or otherwise, cut off the supply of water from any part or parts of the water area.

36. It shall be at the discretion of the Board as to whether or not a meter shall be affixed to any service, and the Board will also determine the size and class of meter in each case.

37. Meters will be supplied by the Board, and rent for same shall be payable half-yearly in advance, on the following scale:—

38. The quantity registered by the meter at any date between ten days before the end of the half-year, and ten days after the end of the half-year, may be taken by the Board as the reading of the meter at the end of such half-year.

39. During the time any meter is undergoing any repairs, or should it cease to properly register the consumption of water, the Board may, at its option, estimate the quantity of water consumed by taking an average of the quantity used during the previous month or quarter, or during the corresponding period of the previous year, and shall charge for the consumption so ascertained.

40. If the consumer shall at any time be dissatisfied with any particular reading of a meter, and shall be desirous of having same tested, he shall give written notice thereof to the Board within seven days of such reading, and thereupon the said meter shall be tested by passing through it a predetermined quantity of water; and if upon such testing it shall appear to the satisfaction of the Board that the said meter registered above five per cent. more than was actually passed through it at such testing, then the said Board will bear the expense of and incidental to such testing, and will also adjust the charge to the said consumer; but if the said meter upon such testing shall not register above five per cent. more than the quantity that shall actually have passed through it, then the said consumer shall pay to the said Board all the expenses of and incidental to such testing; provided that the amount representing the expense of each and every test shall be fixed by the Board, and shall in no case exceed the sum of Forty shillings: Provided, also, that the said consumer shall not be at liberty to avail himself of the right to test the registration of the said meter for any period other than one month next preceding the date of reading in respect of which he shall have given notice as aforesaid.

41. In every case in which the supply of water shall have been cut off by reason of non-payment of rates or other charges, or by reason of a defective service, a reconnection fee of Five shillings shall be charged and shall be payable by the consumer on demand.

42. No person to whom water is supplied by the Board shall, without written permission, sell or supply water to any person who may not reside on the premises of which he is the occupier.

43. The occupier of any premises to which the water has been laid on, or, in the event of there being no occupier, the owner, shall cause proper means to be taken, by locks or otherwise, subject to the approval of the Board, to prevent the use of the water from the main by persons not connected with the premises supplied.

44. The owner or occupier of any allotment of land within the water area who shall erect or make, or cause to be erected or made, any building or addition to an existing building on such land shall, within one calendar month thereafter, give notice in writing thereof to the Board.

45. Officers or workmen employed by the Board shall not solicit or receive from the public any fee, gratuity, or reward.

46. Any person committing a breach of, or failing to observe any one of the foregoing By-laws, shall be liable to a penalty not exceeding £20.

#### APPENDIX TO BY-LAWS FOR GENERAL PURPOSES.

Attention is invited to the following provisions of "The Water Boards Act, 1904":—

#### PART IV.—THE SUPPLY AND DISTRIBUTION OF WATER.

Water may be cut off from unoccupied premises, etc.

60. The Water Board may turn or cut off the water supply—

- (1.) If the land to which water is supplied is unoccupied; or
- (2.) When any rates or moneys due for water supplied, or agreed to be supplied, or any rent or charges for any meter or other fittings remain unpaid for seven days after they become due; or
- (3.) If the occupier refuses to permit a meter to be attached to any pipe on his land; or
- (4.) If the occupier commits or permits any breach of any of the provisions of this Act or the by-laws thereunder.

Turning or cutting off the water shall be a cumulative remedy for enforcing payment of water rates or other moneys due, and shall not relieve the owner or occupier from liability in respect thereof.

Supply of water not compulsory.

65. It shall not be compulsory on the Water Board to supply or continue to supply water to any person; and the Water Board shall not be liable to any penalty or damages for not supplying or continuing to supply water.

#### PART V.—THE PROTECTION OF WORKS AND FITTINGS AND THE PREVENTION OF WASTE.

Duty to keep fittings in repair.

66. Every person supplied with water under this Act shall keep the service or communication pipe and all prescribed fittings within or attached to his land in good repair so as to effectually prevent the water from running to waste.

Fittings not to be connected or disconnected without notice.

67. No person shall—

- (1.) Connect a meter, pipe, or other fitting through which water is, or is intended to be supplied; or
- (2.) Disconnect a meter, pipe, or other fitting from any other meter, pipe, or other fitting through which water is, or is intended to be supplied,

unless he has given the prescribed notice of his intention so to do, and has received the consent, in writing, of the Water Board or of an authorised officer in that behalf.

Power to enter and examine whether water is wasted, etc.

68. (1.) Any officer of the Water Board may, at all reasonable times, enter upon any land to which water is supplied under this Act, and may examine and ascertain—

What quantity of water has been consumed there;

Whether there has been or is any waste, misuse, fouling, or contamination of the water; and

Whether all fittings, with the materials and mode of arrangement thereof, used or intended to be used are in accordance with the by-laws, and in proper order and repair.

(2.) When a fitting is not in accordance with the by-laws, or is out of proper order and repair, the officer of the Water Board may repair or remove it, and if necessary substitute others in its stead, or may alter the mode of arrangement, as the case requires.

Any expense incurred by the Water Board in that behalf shall, on demand, be repaid by the owner or occupier of the land, and if not repaid on demand may be recovered by the Water Board in the same manner in which water-rates may be recovered.

Protection of fittings.

69. No person shall remove, alter, repair, renew, or uncover any pipe or other fitting which is the property of the Water Board until the prescribed notice has been given to the Water Board, and the consent of the Water Board, in writing, obtained.

No such pipe or fitting shall be subject or liable to be seized or taken in execution by process of law, or under distress for rent

Power to enter on land and fix fittings.

70. Any person authorised by the Water Board may at all reasonable times enter upon any land to which water is or is intended to be supplied under this Act, and may place and fix thereon and attach thereto, wherever the Water Board thinks proper, such fittings as the Water Board may think expedient, and may there do all other acts and execute all other works which the Water Board may think fit.

Any person so authorised may at all reasonable time enter upon such lands and examine, remove, repair, alter, or replace all or any of such fittings.

Penalty for using unauthorised fittings.

71. If any person supplied with water by the Water Board does any of the following things for the purpose of taking water in a manner not authorised by this Act, that is to say—

- (1.) Uses in, places upon, or attaches to the land, or permits to be so used, placed, or fitted, any fitting, instrument, or thing not authorised by the Water Board; or
- (2.) Alters, misuses, injures, or removes any authorised fitting, except for the purpose of necessary repair,

he shall forfeit and pay to the Water Board a sum not exceeding fifty pounds, and shall, in addition, be liable to pay to the Water Board any damages sustained by the Water Board in respect of any injury done to their property, and the value of any water wasted, misused, or unduly consumed.

Penalty for not repairing fittings.

72. If any person supplied with water by the Water Board causes or suffers any pipe, receptacle, fitting, or other apparatus used in connection with water supplied to him by the Water Board to be out of repair without repairing it within a reasonable time, or to be so used or contrived that the water supplied to him by the Water Authority is, or is likely to be wasted, misused, unduly consumed, or con-

taminated, or so as to allow the return of foul air or any noisome or impure matter into a pipe belonging to the Water Board, or connected with any such pipe, he shall forfeit and pay to the Water Board a sum not exceeding ten pounds.

Penalty for destroying valves, etc.

73. If any person, not being authorised by the Water Board --

- (1.) Wilfully or carelessly breaks, injures, opens or shuts, or wilfully permits to be broken, injured or opened or shut, any lock, sluice, cock, valve, pipe, or other authorised fitting, or any work belonging to the Water Board;
- (2.) Flushes or draws off the water from any reservoir or other work of the Water Board; or
- (3.) Does any other wilful act, or wilfully permits to be done any act whereby such water is wasted,

he shall forfeit and pay to the Water Board a sum not exceeding Fifty pounds, and shall, in addition, be liable to pay to the Water Board any damage sustained in respect thereof, as well for the value of the water wasted as in repairing the fittings or other parts of the works; and the amount of such damage shall be ascertained, determined, and recovered in the same manner as such forfeited sum.

Penalty for taking, etc., water in contravention of this Act.

74. If any person uses, or consumes or permits to be used or consumed, any water belong to the Water Board, contrary to the provisions of this Act and the by-laws thereunder, he shall forfeit and pay to the Water Board a sum not exceeding Fifty pounds.

Fraudulent taking of water.

75. Any person who fraudulently takes, or procures to be taken, any water belonging to the Water Board from a reservoir main or pipe belonging to the Water Board, or from any pipe leading to or from any such reservoir main or pipe, is guilty of a misdemeanour, and liable to imprisonment, with or without hard labour, for any term not exceeding two years.

Other consequences of contravening this Act or the by-laws.

76. If any person supplied with water by the Water Board--

- (1.) Does, or causes or permits to be done, anything in contravention of the provisions of this Act or of the by-laws; or
- (2.) Omits to do so, or prevents being done, anything which under any of those provisions ought to be done for the prevention of the waste, misuse, or undue consumption of the water of the Water Board,

the Water Board may (without prejudice to any other remedy against him) cut off any of the pipes by or through which water is supplied by the Water Board to him or for his use, and may discontinue the supply of water to him so long as the cause of injury remains or is not remedied; but such cutting off shall not effect or take away his liability to payment of rates.

#### PART VI.—WATER RATES AND PAYMENT FOR WATER.

*The Rate Book.*

Recovery of rates by distress.

100. If any person liable to pay money due for rates or for water supplied by measure under the provisions of this Act fails to pay the same for the space of fourteen days after demand thereof made, in writing, by the clerk or secretary, or any authorised collector, the chairman may issue his warrant for levying the amount with costs, by distress and sale of the goods and chattels found on the land in respect of which the money is due, in accordance with the law for the time being relating to distress for rent.

A warrant of distress may be in the form or to the effect of the Fifth Schedule.

The chairman may include in any one warrant any number of persons liable to pay rates.

The fees prescribed in the Sixth Schedule shall be payable on every distress.

Recovery by action or complaint.

102. Instead of proceeding by distress and sale, or in case no sufficient distress can be found on the premises, the Water Board may, fourteen days after demand thereof, in writing, by the clerk or secretary, or any authorised collector, and notwithstanding any change of occupation or

ownership, recover any money due for rates or for water supplied by measure from the occupier or owner for the time being of the land in respect of which the money is due, by complaint before two Justices of the Peace, or by action in any court of competent jurisdiction.

Recovery of rates paid by owner from occupier.

106. (1.) When the owner of any land has paid any money due for rates or water supplied, which, as between the owner and occupier, should have been paid by the occupier, the owner may recover the sum so paid, on demand, from the occupier as arrears of rent could be recovered from the occupier by the owner.

Recovery of rates paid by occupier from owner.

(2.) When the occupier of land has paid any money due for rates or water supplied, which, as between such occupier and the owner should have been paid by the owner, the occupier may deduct the amount paid from any rent due or to become due to the owner, or may recover the amount from the owner in any Court of competent jurisdiction.

Apportionment of rates between successive owners or occupiers.

107. When an occupier or owner ceases to be the occupier or owner of the land in respect of which a rate is made, before the end of the period in respect of which such rate was made, such occupier or owner shall, as between himself and the succeeding occupier or owner, be liable to pay a portion only of the rate payable for the whole of such period proportionate to the time during which he continued to be the occupier or owner.

Any person who is the occupier or owner of the land during the remainder of the period shall, as between himself and the preceding occupier or owner, be liable to pay a portion of such rate in proportion to the time during which he is such occupier or owner.

But any rate made in respect of such property, and any money due for water supplied, shall continue in force, and may be recovered by the Water Board from the owner or occupier for the time being, without regard to any change in the occupation or ownership.

Notices and demands, how served.

145. (1.) Any notice or demand required by this Act to be given to or made upon any person may be served--

- (a.) By delivering the same to such person;
- (b.) By leaving the same at his usual or last known place of abode;
- (c.) By forwarding the same by post in a prepaid letter addressed to such person at his usual or last known place of abode.

When deemed to have been given.

(2.) A notice or demand forwarded by post shall be deemed to have been given or made and to have been received at the time when, by ordinary course of post, the letter would be delivered.

When name of owner or occupier unknown.

(3.) When a notice or demand under this Act is required to be given or made to any owner or occupier whose name or address is unknown to the Water Board, it shall not be necessary to name such owner or occupier, and such notice or demand may be served by placing it on some conspicuous part of the land of such owner or occupier, and by publishing it three times, at intervals of not less than a week between any two publications, in a newspaper usually circulating in the district.

Service on corporations.

(4.) A notice or demand may be served on a corporation, or incorporated company, or the members of a partnership, by being delivered, left, or posted in a prepaid letter; the notice or demand being addressed in each case to the corporation, company, or partnership at the principal office or place of business thereof in the State.

Recovery of value of water misused, etc.

150. When any water supplied under this Act has been wasted, misused, or unduly consumed, the Water Board may recover the value thereof, as a debt due to them by the person who wasted, misused, or unduly consumed the same, and the remedy given by this section shall be additional to any other remedy which the Water Board may possess, and to the liability to any penalty which such person has incurred.

Obstructing Water Board or officers in performance of duty.

151. Every person who obstructs the Water Board or any member thereof, or any person employed by the Water Board, in the performance of any act or thing which they are respectively authorised or required to do in the execution of this Act or any by-law made thereunder, shall be liable to a penalty not exceeding Twenty pounds.

## CONDITIONS.

The material and workmanship to be of the best description and subject to the approval of the Officer of Police in charge of the Station.

The work to be performed on the requisition of the Officer in Charge, and in the event of the Contractor failing to attend to the order the work will be otherwise performed, and any extra expense charged to the Contractor.

A set of shoes to last at least one month. If required oftener, or shoes slipped, they are to be replaced at the Contractor's expense.

Payments of accounts to be made monthly.

This Contract to be terminable upon one month's notice from either party, but it may be cancelled without notice from the Commissioner of Police for bad workmanship.

## INSTRUCTIONS.

The following instructions are to be observed by all Farriers shoeing Police Horses:—

The shoes for the fore feet should be of an uniform width from toe to heel, averaging from seven-eighths to one inch, and of an uniform thickness from toe to heel of about three-eighths of an inch, but in the case of horses which travel exclusively on bush roads the shoe may be made narrower and thicker in proportion. The heel of the shoe should on no account be thicker than any other portion of it. There should be seven nails in each shoe—four on the outside and three on the inside, and the last nail on the inside should not be further back or nearer to the heel than about midway between the toe and the heel of the shoe.

The heel of the hind shoe may be a little thicker than any other portion of the shoe, but in other respects the same remarks apply as to the fore shoes.

Calkins are never to be allowed on the fore shoes except where the horse has to travel over mountainous districts and cannot do without them, as they are inconvenient for the horse to travel in, and by the undue pressure they cause on the heels of the feet they produce bruises and corns, and frequently in a very short time render the animal quite useless.

The shoe, when fitted to the foot, should present, from toe to heel, a perfectly plane or flat surface on that part which rests on the crust or wall of the foot, and should in every instance follow the natural shape of the foot, more especially from the quarters to the heels.

The feet should be prepared by carefully removing the dead or shelly portions with the rasp and knife, but on no account should the sole of the foot be pared to admit of its being sprung by the thumb of the smith, as is too frequently the case, for the sensitive foot, when thus denuded of its horny cover, is very liable to become bruised by the animal's treading on a stone or some other hard substance.

The heels should not be cut open, as it is termed, nor should the bars, which act as buttresses to prevent the heels contracting, be removed. The wall or crust should be levelled from heel to toe to receive the shoe. The heel of the fore foot, for about half an inch from the extreme point, may be about one-sixteenth part of an inch lower than the quarters, so that when the shoe is on a thin knife may be passed between it and the foot at the heel.

Unless in exceptional cases, which will seldom occur, the frog should not be pared, but should be left to itself. Nature will remove the superfluous horn, and the rags can do no harm, and if left alone will soon disappear altogether.

The foot should never be rasped above the clinches of the nails, as it only weakens the foot, and leaves less horn to nail to when it grows down.

## MONTHLY NOTES FOR MAY, 1905.

The weather for the month was very stormy and interesting. It generally happens that a definite date can be assigned for the commencement of winter, and in the present case the season broke on 1st May.

There were three main disturbances affecting the weather, and it is considered worth while to study these a little in detail, for it seems not unreasonable to suppose that the manner in which a season announces itself will in time afford a clue to the character of the weather for the remainder of the season. At the beginning of the month barometers were falling and a depression was evidently approaching the Leeuwin. On the morning of the 2nd the winds were West and South-West thence to Esperance, East of which they were North and North-East. On the 3rd they had backed, being North-West in the extreme South-West, elsewhere North and North-East in South Australia. On the 4th, North-West at Leeuwin, thence West and South-West as far as Eucla, and still North to North-East in South Australia. On the 5th, they had backed to North-West and North all along our coast. On each occasion the barometer fell as the wind backed from West or South-West towards the North, with tendency to finer weather, and rose as the wind came round again, with heavy squalls of rain.

## THE CLIMATE—continued.

The above must be compared with the pressure in the South-East portions of Australia where a "high" was established over Tasmania on the 1st, and this was gradually squeezed Northwards towards New South Wales and Queensland.

When the anticyclone was definitely established there, the "low" South of our coast managed to pass along towards Tasmania, and was followed by a "high" over our Southern districts, with finer weather.

This "high," which came in from the Indian Ocean on the 7th, passed slowly Eastward, reaching Adelaide on the 12th, and Melbourne on the 15th.

On the 11th, another "low" approached our West coast, the isobar of 30.0 running right round the Western coast line. On the 12th (just when the "high" had reached Adelaide), the wind had veered to West-North-West at Leeuwin, but was Northerly thence to Eucla. On the 13th heavy rain was recorded in all Western districts, as far North as Onslow. On the 14th (Sunday) reports were somewhat incomplete, but Westerly winds had only reached Albany. On the 15th, it had backed to North-West at Leeuwin and Albany. The "high" was now at Melbourne. On the 16th, the wind remained North-West, but the barometers had risen, the "low" apparently going Southwards. The high was now beginning to work up the East coast. On the 17th, winds had reached South-West at Leeuwin and Albany, thence Eastwards, West to North-West, and North to North-East in South Australia. The "high" was now off the Eastern coast near Sydney. By the 18th, a rapid movement Eastwards had taken place, the "low" being South of Victoria, and a "high" passing over our South districts. Next day (19th) the "high" reached Adelaide, then progressed slowly Eastward. On the 20th, the third disturbance of the month approached our West coast, rain being reported at Carnarvon and Winning Pool, and barometers fell rapidly. On the morning of the 21st the centre was near Bunbury, certainly North of the Leeuwin. This point is important, in view of the theory I have advocated as to the direction whence these storms approach our coast. At 8 a.m. on the 21st, the barometer was reading 29.55 at Cape Leeuwin, wind East; 29.52 at Cape Naturaliste, wind East; 29.46 at Bunbury, wind North-North-West; 29.60 at Perth, wind North-West; and 29.71 at Geraldton, wind South-West. The "low" then worked down the coast and round the Leeuwin (the wind veering, not backing, at this place); and on the morning of the 22nd the wind was West-South-West at Leeuwin, North-West at Albany, thence North to North-East to Adelaide. On the 23rd, it was Westerly as far as Eyre, North-West at Eucla, and thence North and North-East in South Australia. So far, the "low" had gone straight ahead, but the winds now began to back again, and on the 24th they were North-West and North all along our South coast, but still North and North-East in South Australia. On the 25th, winds were Westerly from Leeuwin to Esperance, thence North-West to Eucla, and thence North. On the 26th they had backed again, being North-West at Leeuwin and Albany, thence North. During the last few days the "high," which had reached Adelaide on the 19th, was moving slowly Eastwards, and eventually, on the 26th, seems to have passed Northwards up the East coast to the neighbourhood of Brisbane. After this our "low" moved rapidly towards Tasmania, and the weather moderated.

We see, therefore, that the three disturbances which ushered in the present winter season and produced such abundant rain throughout our State were similar in character. They each possessed a feature which required careful study, as it is due to this particular characteristic that the downpour was so heavy. As a general rule, any winter "low" which arrives at the Leeuwin has a tendency to pass Eastwards or East-South-East towards Tasmania, giving heavy coastal rain at it passes, with winds in the North-West quadrant. Under normal conditions the wind gradually veers West, South-West, and South, and the weather moderates. But in the present case each of the three "lows" found itself unable to proceed on account of the presence of a very slowly-moving "high" in South-East Australia or Tasmania, and seemed to rebound two or three times. Thus, as the "low" moved Eastward, winds would veer to the West, then as the "low" rebounded from the "high" they would back again to North-West and North, and the squally weather would start all over again as the "low" made another attempt to move Eastwards.

When the "high" was finally removed, in each case travelling Northward, the "low" rushed forward rapidly, bringing heavy rains to South Australia as it passed, but with clearing weather following almost immediately. The result of the whole movement was that we had a rainfall far in the excess of the average; whereas in South Australia, though there were two or three good downpours, the general character of the weather was that of an unduly prolonged summer—warm, dry, and dusty.

It will be seen from the above what an important part the Tasmanian observations play in even the daily forecasting for this State, as from them may come the first intimation of the movement of the "high" pressure. Unfortunately, under present arrangements, these observations are not always received in time to be utilised.

On the whole, the pressure was unusually low, ranging from .04 inch below normal in the extreme North to over a quarter of an inch in defect in Southern districts. The temperature was generally above the average in the interior and Northern portions of the State. In West and South coastal districts it was below in the day and above at night, having considerably less diurnal range than usual.

Frosts have not yet started, the lowest reading of a terrestrial thermometer being 31.0, at Southern Cross.
