WHEREAS by "The Stock Diseases Act, 1895," it is provided that it shall be lawful for the Governor to acquire and set apart, by proclamation in the *Government Gazette*, such ground as may be required for one or more Quarantine Stations, on which the necessary sheds and appurtenances may be erected for the purpose of the said Act: AND WHEREAS it is deemed expedient by me, the said Governor, to set apart temporary stations: NOW THEREFORE I, the said Governor, in exercise of the powers vested in me as aforesaid, with the advice of the Executive Council, do hereby set apart as a 'Temporary Quarantine Station for pigs the premises known as "Water Hall," situated at Guildford, the property of Jas. Morrison, Esq., for a period of 30 days as from the 15th November, 1905.

WHEREAS by a Regulation made under "The Stock Diseases Act, 1895," and published in the *Government Gazette* on the 18th day of September, 1903, it was provided, *inter alia*, that no cattle should leave the East Kimberley Quarantine Area except at the Port of Wyndham: AND WHEREAS by the said Act it is provided that the Governor may, from time to time, by Order in Council, exempt such stock as he may think fit from the operations of any of the provisions thereof, either by generic or particular description: AND WHEREAS it is deemed expedient to permit the removal of certain stock from within the boundaries of the East Kimberley Quarantine Area, *via* Derby: NOW THEREFORE I, the said Governor, with the advice of the Executive Council, do hereby exempt from the operation of the said Regulation under the said Act, three hundred and five head of cattle from the Margaret River Station, the property of Messrs. Copley & Co.

With reference to my Circular Despatch of the 1st September, 1904, I have the honour to transmit to you, for the information of your Government, copies of a notice issued by the Nobel Committee of the Norwegian Parliament with regard to the nomination of candidates for the Nobel Peace Prize of 1906.

I have to request that your Government will take such action with reference to this document as may seem calculated to make the conditions of the Prize known to those bodies and persons who are qualified to nominate candidates.

It will be noted that names of candidates should be received by the Committee before the 1st of February next.

### NOBEL PEACE PRIZE.

All proposals of candidates for the Nobel Peace Prize, which is to be distributed December 10, 1906, must, in order to be taken into consideration, be laid before the Nobel Committee of the Norwegian Parliament by a duly qualified person before the first of February of the same year.

Any one of the following persons is held to be duly qualified: (a) Members, acting and former, of the Nobel Committee of the Norwegian Parliament, as well as the advisers appointed at the Norwegian Nobel Institute; (b) Members of Parliament and Members of Government of the different States, as well as Members of the Interparliamentary Union; (c) Members of the International Arbitration Court at the Hague; (d) Members of the Commission of the International Peace Bureau; (e) Members of the Institute of International Law; (f) University professors of Political Science and of Law, of History and of Philosophy; and (g) Persons who have received the Nobel Peace Prize.

The Nobel Peace Prize may also be accorded to institutions or associations.

According to the Code of Statutes, § 8, the grounds upon which any proposal is made must be stated, and handed in along with such papers as may therein be referred to.

According to § 3, every written work, to qualify for a prize, must have appeared in print.

For particulars qualified persons are requested to apply to the office of the Nobel Committee of the Norwegian Parliament, Drammensvei 19, Kristiania.
