WHEREAS by Section 20 of "The Goldfields Water Supply Act, 1902," it is provided that the Governor may, by Order in Council, constitute and define the boundaries of a Water Area, for the purposes of the said Act, and may divide the area into districts, and define the boundaries of the districts: NOW, THEREFORE, His Excellency the Governor, by and with the advice of the Executive Council, and under the powers of the said Act, doth hereby revoke and cancel the Order in Council dated 30th May, 1906, and in lieu thereof doth order that, as and from this date, the said area shall be divided into the districts specified in the

Schedule hereto, with the several boundaries therein respectively defined:—

THE SCHEDULE.

THE MIDLAND WATER DISTRICT.

All that portion of the Water Area outside of and to the Westward of Reserve numbered 8059 on Plan 1c/40 in the Lands Department, except the land embraced in the North Midland Water District.

THE NORTH MIDLAND WATER DISTRICT.

All that portion of the Water Area bounded by lines starting from the South-Western corner of Lot 79, Swan Location 14A, extending due North to the South bank of the Swan River; thence along the said river to the North-Western corner of Swan Location 13; thence along the Northern boundary of the said Location 13 to the Midland Railway; thence in a Southerly direction and along the Midland Railway to the intersection with the township boundary; thence along the township boundary to the starting point.

THE MUNDARING WATER DISTRICT.

All that portion of the Water Area West of a line drawn at right angles to the pipe line at a point two miles West of Northam Town Hall, such line being extended to the boundaries of the Water Area on both sides of the pipe line, but excluding therefrom that portion of the Water Area comprised within the Midland Water District and North Midland Water District.

THE NORTHAM WATER DISTRICT.

All that portion of the Water Area bounded by a circle having as its centre the Northam Town Hall, and the radius of which shall be two miles.

THE CENTRAL WATER DISTRICT.

All that portion of the Water Area between the Eastern boundary of the Mundaring Water District and the Western boundary of the Coolgardie Water District, but excluding therefrom that portion of the Water Area comprised within the Northam Water District and the Southern Cross Water District.

THE SOUTHERN CROSS WATER DISTRICT.

All that portion of the Water Area comprised within a circle, the centre line of which shall be at the Southern Cross Railway Station, and the radius of which shall be seven miles in length.

THE COOLGARDIE WATER DISTRICT.

All that portion of the Water Area situated outside of and to the Eastward of the Southern Cross Water District and West of a line drawn at right angles to the pipe line at Mungari Railway Station, and extended to the boundaries of the Water Area on both sides of the pipe line.

THE KALGOORLIE WATER DISTRICT.

All that portion of the Water Area East of a line drawn at right angles to the pipe line at Mungari Railway Station, and extending to the boundaries of the area on both sides of the pipe line, but excluding therefrom those portions of the Water Area comprised within the Boulder, Kanowna, and Bulong Water Districts.

THE BOULDER WATER DISTRICT.

All that portion of the Water Area bounded by a line starting at a point on the boundary of Water Area due South of Lakeside Railway Station, and passing thence due North to Lakeside Railway Station; thence North-Westerly along railway to the intersection of railway with the boundary of Boulder Townsite, between Gold Mining Leases 16E and 31E; thence following the said boundary Northerly, North-Westerly, and by irregular line South-Westerly to most Westerly point of Boulder Townsite; thence by straight line to most Southerly point of Somerville Suburban Area; thence due South to boundary of Water Area; thence along last-mentioned boundary to the starting point, but excluding therefrom those portions of the Water Area comprised within all gold mining leases that are or may be supplied with water from the Kalgoorlie and Boulder Mines Water Trust.

THE KANOWNA WATER DISTRICT.

All that portion of the Water Area bounded by a circle having as its centre the Railway Station at Kanowna, and the radius of which shall be five miles in length.

THE BULONG WATER DISTRICT.

All that portion of the Water Area having as its centre the Post Office at Bulong, and the radius of which shall be nine miles in length.

DUTIES OF SECRETARY.

1. Duties of Secretary.

- (a.) To attend all Board meetings.
- (b.) To attend committees when considered necessary.
- (c.) To take notes of all minutes of any meeting of the Board or a committee, and prepare reports of committees.
- (d.) To conduct all correspondence, and to give the other officers instructions as directed by the minutes.
- (e.) To answer all the questions on the Board's business.
- (f.) To prepare the rate book and all rate notices, and attend all appeals at Court.
- (g.) To summon the members and Board to committee meetings other than the regular meetings.
- (h.) The Secretary shall keep the cash-book, as well as any and all other books issued in accordance with instructions inserted therein, and those required to show the receipts and expenditure made by the Board. The said books shall be written up every fortnight ready for inspection by the Board, or any member of the Board who may, at any time during office hours, desire to see them. He shall check all accounts sent into the Board, and see that all accounts for works (exceeding five pounds in amount) have stated on them the authority under which such works have been done, and shall keep all returns made by the collectors or other of the Board's officers, and shall see that with all returns made the heels of the receipt books accompany the returns; he shall supervise and attend to the due payment of all money coming through the hands of the Board's officers and payable to the credit of the Board; he shall report to the Board, at their next meeting, any officer neglecting to make his returns as provided, with the necessary vouchers attached thereto.
- (i.) He shall pay into the bank, as soon as possible after the receipt, to the credit of the Board, any sum or sums of money that may be received by him on behalf of the Board.
- (j.) He shall have the cash-book and bank pass-book made up in readiness for the meetings of the Board, and shall produce them at each meeting thereof. Should any member of the Board desire to see them at any time during office hours, the Secretary shall produce them for his inspection. No money shall be paid into the bank to the credit of the Board by any officer of the Board except by or through the Secretary. The Secretary shall give all receipts on printed forms. The Secretary shall readily and cheerfully obey all lawful commands or orders of the Board, and shall attend to all other matters affecting the finances of the Board and not therein specified.
- (k.) - (o.) To report to the Board at every meeting the business he has transacted for the Board, the amount of money collected, and, if necessary, the Board may appoint a sub-collector.

MEETINGS AND PROCEEDINGS.

2. (a.) The Board shall meet for ordinary meetings on the third Saturday in each month, at 8 p.m.
- (b.) The Chairman, if present, shall preside at all meetings of ratepayers and of the Board, and in his absence, or if after being present he shall retire, one of the members of the Board, chosen by the ratepayers or members present (as the case may be), shall preside for remainder of meeting.
- (c.) At all meetings of the Board, when there is no quorum present, or when the Board is counted out, which counting out shall take place whenever there shall be less than a quorum present, such circumstances, together with the names of the members then present, shall be recorded in the minute-book.

ORDER OF BUSINESS.

3. The ordinary business at all ordinary meetings shall be as follows, that is to say:—
 - (a.) Reading and confirmation of minutes of last ordinary and special meetings (if any).
 - (b.) Consideration of business arising out of minutes.
 - (c.) Consideration of correspondence (received and despatched) and taking such immediate action as may be deemed expedient in regard thereto.
 - (d.) Passing of accounts for payment.
 - (e.) Presentation of petitions or memorials and committee reports, and consideration thereof.
 - (f.) Consideration of tenders and ratification of contracts.
 - (g.) General business of Board.
 - (h.) No discussion shall take place upon the minutes except as to their accuracy, or for the rectifying of any clerical error.
 - (i.) After confirmation of minutes, the Chairman may make any communication to the Board which he may deem advisable to bring under their notice, and it shall be competent for any member of the Board to ask a question or questions, but he shall confine himself to the question simply, and no debate shall ensue thereon at the time.

TENDERS.

4. Tenders for any work shall be opened and dealt with when the subject matter of tenders comes on to be considered at meeting of Board, and the Board may require deposits on tenders up to 10 per cent. on amount of contract.

POLLUTION OF WATER.

5. No animal shall be watered at the supply windmill well, or well on allotment 68, controlled by Board, nor shall any person camp within a radius of two chains of these wells. No person shall wash himself, his garments or chattels, at or near these wells. No person shall allow any matter or object to fall into any well within the water area, nor shall he in any way impair the purity of water in works within the area.

MANAGEMENT OF WATER.

6. All persons having the water laid on to premises shall keep all meters, pipes, and fittings in repair, and should any person neglect to keep the pipes, meters, or fittings in repair the Board may enter upon the premises and make the necessary repairs at cost of owner or occupier of such premises; and all expenses incurred by Board on that behalf shall be, on demand, repaid by owner or occupier, or, if not repaid on demand, may be recovered in the same manner by Board as water rates are recovered.

LICENSING OF PLUMBERS.

- 6a. No person shall affix, alter, or repair any service pipe or fitting to be used in connection with any main or other pipe belonging to the waterworks, or interfere in any way therewith, unless licensed as a plumber or holding an operative plumber's certificate under these By-laws.
7. An application for a plumber's license or an operative plumber's certificate shall be in writing, signed by the applicant, and addressed to the Chairman.

8. Every applicant for a plumber's license or an operative's certificate shall satisfy the Chairman that he is a competent plumber, and may be required to submit to an examination in the theory and practice of plumbing work.

9. Every license or certificate shall be granted by the Board; and the granting and cancellation of any license or certificate shall be in the absolute discretion of the Board.

10. Every license or certificate shall be annual, expiring on the 10th day of January next following the granting thereof, and may be in the form A or form B in the Schedule hereto.

11. A fee of Ten shillings shall be payable for every license or certificate.

12. Every applicant for a plumber's license shall, before receiving a license, deposit with the Board the sum of Two pounds ten shillings, to be held by the Board during the currency of the license as security for the proper performance of all work undertaken by the licensee.

13. The Board may deduct from such deposit the expense of making good any bad work of the licensed plumber or his workmen (notwithstanding that such workmen are holders of operative plumbers' certificates), and as often as any expense is so deducted the licensed plumber shall make good the deposit to the sum of £2 10s., and in default his license will be cancelled.

14. Every licensed plumber shall, within forty-eight hours of any change in his address, give notice, in writing, thereof to the Board.

15. The mains shall be tapped only by the workmen of the Board.

16. No licensed plumber or operative plumber shall interfere with any pipe or fitting belonging to the water-works without the permission, in writing, of an officer appointed by the Board under these By-laws first obtained.

17. No ground shall be opened, nor shall any work be undertaken for the purpose of laying and fixing a new service or fittings, or in the extension or alteration of an existing service or fittings, until notice shall have been given by the responsible licensed plumber to Secretary. Such notice shall be in writing, and shall describe the nature and extent of the proposed work, and shall be given forty-eight hours at least before the work is intended to be commenced, unless the officer expressly accepts shorter notice.

18. On the completion or extension of any service the responsible plumber shall report the work to an officer as ready for inspection.

19. In no case shall the ground be filled in, or water be turned on to any land, until the work executed by the responsible plumber has been examined and passed by an officer, and a certificate in writing has been given by such officer to that effect.

GENERAL PROVISIONS.

20. The Board may, by notice to a consumer, from time to time restrict the quantity of water that may be supplied to him in any one week.

21. The Board may, from time to time, when necessary for the purpose of tapping or repairing the main, or otherwise, cut off the supply of water from any part or parts of the water area.

22. The quantity registered by the meter at any date between ten days before the end of the half-year and ten days after the end of the half-year may be taken by the Board as the reading of the meter at the end of such half-year.

23. During the time any meter is undergoing repairs, or should it cease to properly register the consumption of water, the Board may, at its option, estimate the quantity of water consumed by taking an average of the quantity used during the previous month or quarter, or during the corresponding period of the previous year, and shall charge for the consumption so ascertained.

24. If the consumer shall at any time be dissatisfied with any particular reading of a meter, and shall be desirous of having same tested, he shall give written notice thereof to the Board within seven days of such reading, and thereupon the said meter shall be tested by passing through it a predetermined quantity of water; and if, upon such testing, it shall appear to the satisfaction of the Board that the said meter registered above five per cent. more than was actually passed through it at such testing, then the said Board will bear the expense of and incidental to such testing, and will also adjust the charge to the said consumer; but if the said meter, upon such testing, shall not register above five per cent. more than the quantity that shall actually have passed through it, then the said consumer shall pay to the said Board all the expenses of and incidental to such testing; providing that the amount representing the expense of each and every test shall be fixed by the Board, and shall in no case exceed the sum of Forty Shillings: Provided also, that the said consumer shall not be at liberty to avail himself of the right to test the registration of the said meter for any period other than one month next preceding the date of reading in respect of which he shall have given notice as aforesaid.

25. In every case in which the supply of water shall have been cut off by reason of non-payment of rates or other charges, or by reason of a defective service, a re-connection fee of Five shillings shall be charged, and shall be payable by the consumer on demand.

26. No person to whom water is supplied by the Board shall, without written permission, sell or supply water to any person who may not reside on the premises of which he is the occupier.

27. The occupier of any premises to which the water has been laid on or, in the event of there being no occupier, the owner shall cause proper means to be taken, by locks or otherwise, subject to the approval of the Board, to prevent the use of the water from the main by persons not connected with the premises supplied.

28. The owner or occupier of any allotment of land within the water area who shall erect or make, or cause to be erected or made, any building or addition to an existing building on such land shall, within one calendar month thereafter, give notice in writing thereof to the Board.

29. Officers or workmen employed by the Board shall not solicit or receive from the public any fee, gratuity, or reward.

30. Every half-year shall end on 30th June and 31st December in each year.

31. Any person committing a breach of or failing to observe any of the foregoing By-laws shall be liable to a penalty not exceeding £20.

HIS Excellency the Governor in Executive Council, in pursuance of the powers vested in him by Section 22 of "The Elementary Education Act, 1871, Amendment Act, 1893," has been pleased to approve of the following amendment to Regulations:—

Regulation 98.

With the permission of the Department, children over 16 years may be retained in the school. In each such case a fee of 6d. per week must be paid to the teacher, which may be retained by him. A statement should be forwarded with the Quarterly Summary showing the amounts so received. The attendance of these children should be noted on the Registers, but entered apart from the ordinary scholars, and not included in the totals.

And the substitution of the following words:—

After a scholar has reached the age of fourteen years, the following fees shall be paid, unless an application has been made for the child to be placed upon the free list and such application has received the approval of the Minister.

A fee of one shilling per week must be paid by all children over fourteen and under fifteen years of age in attendance at school. Children over fifteen must pay two shillings per week. The Head Teacher must collect these fees and forward them to the Department

each month with the salary sheet. To facilitate the checking of the lists, the teacher of any class containing over-age children should enter on his register first the names of children over fifteen, next the names of those over fourteen, and next the names of those who will attain the age of fourteen during the quarter.

Also the cancellation of the following words in Regulation 227:—

The Department has no objection, if the parents wish their children to be instructed when they are between the ages of three and six, to have them placed on the roll and taught in the ordinary way. No child under three can be admitted. Where there is no separate Infants' School it would not be desirable to admit children below the age of four years. Children over fourteen, but below sixteen, might remain in the school if of good behaviour and unless their influence on the younger children is likely to be bad. Children over sixteen can only remain in the school on payment of a fee of sixpence per week, which should be retained by the teacher but accounted for to the Department.

And the substitution of the following words:—

No child under the age of four years can be admitted to a Government School. Children over fourteen may remain in the school until the age of sixteen, if they are of good behaviour and not likely to have a bad influence over the younger children, subject to the payment of the prescribed fees. In special cases where, owing to isolation, it has been impossible for a child to attend school at the usual age, the Minister may permit his retention in a school after he has reached the age of sixteen years.

These alterations shall come into effect from 1st November, 1906.

NOTES ON THE CLIMATE FOR AUGUST, 1906.

The principal feature of the weather during the month was the unusually heavy general rainfall in the early part, the finest general downpour ever recorded in the State. On Thursday morning (2nd) a "high" which had been traversing the Southern parts of this State was well on its way to South Australia, and there were vague indications of a "low" approaching our Western coast from the Indian Ocean. On Saturday morning (4th) the barometer at Geraldton (29.72) was the lowest in Australia, and rain had commenced to fall on the N.W. and W. coast. The "low" then passed down the coast and round the Leeuwin, where the barometer fell to 29.10 next morning; but the rain extended right through the Murchison and Coolgardie Fields, as well as in the S.W. districts. In fact, the heaviest fall was between the Murchison and N.W. coast, where from 3 to nearly 5 inches were generally recorded; elsewhere from 1 to 2½ inches fell. Special attention is called to this disturbance, because the indications point so unmistakably to the fact that it first approached the N.W. coast from the Indian Ocean and did not come up from the Antarctic "low." Three times again during the month did unsettled weather visit the interior, but under different conditions. In all these cases a "high" barometer was slowly passing Eastward across the Southern parts of the State, with strong Easterly winds; but in the upper atmosphere a disturbance seems to have passed from the N.W. coast across the interior in a more or less South-Easterly direction towards South Australia. On the 13th and 14th, moderate to heavy rain fell on the N.W. coast and passed South-Eastwards, just missing the Goldfields, but bringing general rains throughout South Australia all South of Alice Springs and as far West as Eucla. The rain was recorded on the South-West coast of South Australia on the morning of the 16th, and next morning it was general. The third of these disturbances brought rain on the N.W. coast on the night of the 18th, and throughout the Coolgardie Fields next night.

THE CLIMATE OF WESTERN AUSTRALIA DURING AUGUST, 1906—continued.

During the latter part of the month a “high” of great intensity passed slowly across Southern districts from West to East, giving a spell of fine dry weather, with strong unpleasant Easterly winds. This was followed by a “low,” which brought moderate to heavy rain in South-West districts on the 30th.

On the whole the pressure was about normal in the Northern half of the State, but higher than usual in the Southern, especially in the South-East, where the excess amounted to one-tenth of an inch and upwards.

Temperature was generally below the normal, especially on the Eastern Goldfields, where the defect amounted to 4° or 5° for the mean daily maximum.

Rainfall was rather less than usual in the extreme South-West coastal section South of latitude 30°, but elsewhere, except in the extreme North and North-East, it was very heavy, and far in excess of the average for previous years.

Frosts were occasionally experienced in Southern portions of the State, but they do not appear to have been very severe. The following table shows the mean and absolute readings of a minimum thermometer placed on the surface of the ground and read daily:—

CENTRAL BOARD OF HEALTH.

Regulations made under Section 154 of "The Health Act, 1898," by the Central Board of Health for the prevention of overcrowding and obstruction in gangways, passages, and aisles in any public building, and for the prevention of fires in such public buildings, and generally for securing the public safety and convenience therein.

All Regulations made under the said section by the said Board prior to the date of the adoption of these Regulations are hereby rescinded.

The owner or occupier of any public building, or the manager or trustee of any public building, or the company or corporation using or occupying any public building, or the person by whose authority or sanction any public building is used, shall comply with the following conditions and regulations:—

PART I.

GANGWAYS, ETC.

1. Gangways of sufficient number and width shall be reserved, to the satisfaction of the Board, in convenient lines, to facilitate the passage of persons to and from their seats. No gangway shall be approved that is less than three feet wide.

2. All gangways, aisles, passages, corridors, lobbies, and ways forming part of any public building, and whether inside or outside of any such building, shall at all times be kept entirely free from chairs, flapseats, or other obstruction, whether permanent or temporary.

3. No person shall, whilst any such building is open or occupied by the public, obstruct any gangway, aisle, passage, corridor, lobby, or way as aforesaid by sitting, standing, or remaining therein or thereon; and every owner, occupier, trustee, door-keeper, or other person in charge of, or having the control, care, or management of any such building shall take all necessary steps in his power to prevent any such obstruction as aforesaid.

EXITS, DOORS, ETC.

4. All doors used as exits by the public in any public building hereafter erected shall be at least 4ft. 6in. wide in the clear, with doors hung in two folds made to open outwards towards the thoroughfare or way.

5. No door of any public building shall open immediately upon a flight of steps, but a square landing at least the width of the doorway shall be provided between such steps and such doorway.

6. All internal doors shall be so hung as not to obstruct, when open, any gangway, passage, staircase, or landing.

7. The united widths of the exits from any apartment of a public building shall not be less than at the rate of one foot to every thirty persons that may be accommodated therein.

8. All exits and any other doors of any public building shall, when so ordered by the Board, be indicated by approved six-inch letters where and as directed.

9. All exit doors having fastenings shall, if so required by the Board, be fastened with approved automatic bolts only; and all fastenings fitted to such doors shall be of an approved description.

10. All exit or escape doors of a public building must be fully opened directly the audience is about to leave such building.

11. Any door of a public building shall, when so directed by the Board, be made to open both ways, and also, if so required, be made to lock back against a wall in such a manner as to require a key to release it.

12. All barriers or gates shall be made to open outwards, and no gates or barriers shall be fitted or secured with other than approved fastenings. Provided, that if this is not possible, such gates or barriers shall, when open, be so fastened back against the wall that they can only be released by a key.

TICKET OR CHECK BOXES.

13. No ticket or check-takers' boxes shall be placed in any passage, or so as to offer obstruction to any exit.

SEATING.

14. The area to be assigned for the accommodation of each person in any public building shall not be less than 24 inches by 16 inches in a gallery, and not less than 28 inches by 18 inches in all other parts of any such building or premises.

(a.) Chairs, and all seats less than nine feet in length, shall be securely fixed to the floor, or together in lengths of not less than nine feet, and shall be placed in regular rows, convenient for ingress and egress.

STAIR CARPETS, ETC.

15. All stair carpets and floor coverings shall be so secured and kept as to prevent possibility of accident.

HANDRAILS.

16. A continuous handrail shall be securely fixed on both sides of all steps and landings, at a vertical height of 34 inches above the nosings of the treads or floors of the landings.

(a.) Such handrails shall, if so required by the Board, be chased into the walls.

(b.) A central handrail shall be fixed on all stairways and entrance steps exceeding eight feet in width.

SKYLIGHTS, ETC.

17. All skylights and the sloping or vertical sides of lantern lights shall, if required by the Board, be protected by approved guards.

DECORATIONS, ETC.

18. All decorations, or wall and ceiling linings of permanent structures, shall be constructed of fire-resisting materials.

LIGHTING.

19. When the electric light is installed, or about to be installed in any public building, it shall be on condition that a competent electrical engineer, to be approved by the Board, do first certify, in writing, to the satisfaction of the Board, and then thereafter once in every six months, or oftener if so required, that the system is in proper working order, and is in all its parts in accordance with the requirements of Part II. of these regulations.

(a.) Any other systems of lighting that may be installed in any public building shall be subject to the approval and control of the Board, who may at any time, and from time to time, require by notice, in writing, an examination of any such lighting installation to be made by an approved and competent person, within a time to be stated within the said notice; and the said person shall furnish without delay a true report to the Board of the state and nature of such installation.

20. Any inflammable material, if within four feet vertically or three feet horizontally of any gas or oil light, shall be properly and sufficiently protected.

21. All gas-pipes shall be made of iron, brass, or other approved metal, and all gas brackets shall be fixed without joints.

22. All pendant or bracket lights that are fitted with glass shall be provided with suitable wire-netting underneath.

23. All lights shall be placed so as to be out of reach of the public.

24. Additional means of lighting for use in the event of the gas, electric, or other lights being extinguished, shall, if required by the Board be provided, by lamps, to be approved by the Board, and properly secured to an unflammable base, placed out of the reach of the public, at such points as may be directed.

FIRE EXTINGUISHING APPLIANCES.

25. Such number of buckets as may be ordered by the Board, painted red, and labelled "fire," in proper stands, located where directed, shall be provided and kept full of water, and—

(a.) A number of woollen blankets, if so ordered, shall also be provided and placed where directed in metal trays; and during any time an audience is occupying the building such blankets shall be kept thoroughly saturated with water; and

(b.) Such number and description of fire hydrants, with approved hoses and nozzles, as may from time to time be ordered by the Board, shall be provided, and the hydrants connected with an approved source of water supply, and the whole maintained in an efficient state; and

(c.) The Board may from time to time order that a certain number of approved skilled persons shall be employed and be in attendance in any public building during the whole time such building is occupied by the public; and such persons shall perform such duties and take such precautions as the Board may, in writing, direct.

26. Storage of any but absolutely necessary materials of an inflammable nature in any public building is hereby prohibited.

27. Every public building shall, if so required by the Board, be placed in direct telephone communication with a fire brigade station.

28. Printed copies of this part of these regulations shall, when ordered by the Board, be posted in any public building in such places as may be directed, and such posted copies shall be maintained in good order.

SMOKING.

29. No smoking shall be permitted on or under the stage, or in any part of a public building behind the proscenium wall.

PART II.

DIVISION I.—WIRING FOR THE UTILISATION OF ELECTRICAL ENERGY.

30. These regulations embody the requirements and precautions framed to secure satisfactory results with supply at a pressure not exceeding 500 volts if continuous, or 250 volts if alternating. They are intended to include only such requirements and precautions as are generally necessary, but they are neither intended to take the place of a detailed specification, nor to instruct untrained persons.

31. Notice of the proposed introduction, or of any alteration of wiring must in all cases be given to the Board. Any departure from these rules may be authorised only by the written consent of the Board, and such departure shall only be regarded as holding good in the particular case for which permission was granted. In special cases, temporary installations, or any work or condition for which provision is not made in these rules, such precautions must be taken as are required by the Inspector.

GENERAL ARRANGEMENT.

32. All wires within buildings, unless special permission is obtained previous to the commencement of the work, must be enclosed in substantial tubing or well-seasoned hardwood casing, which shall be approved by the Inspector. Where conductors are not enclosed they must be attached at frequent intervals to glass or porcelain insulators of approved pattern and run taut without unnecessary strain. Metal staples will not be permitted under any circumstances for the attachment of wires. Conductors must radiate from distributing centres, and in large systems from those centres to sub-centres, so that no sub-circuit carries more than 5 amperes up to 125 volts, or more than 3 amperes from 125 to 250 volts, for incandescent lighting. When conductors are attached to the exterior of a building, insulators of approved pattern must be used in addition to the water-proof insulation round the wires. Permission must be obtained for the running of wires over, or in close proximity to buildings; and in all such cases special provision must be made to prevent short-circuiting, either by their own falling or being fallen upon by other conductors.

33. When protected from mechanical injury by hard metal tubes or conduits, conductors even of opposite polarity may be "bunched," and when carrying small currents from sub-centres, as in regulation 32, they may, if without joints, be "bunched" even when the protecting tubing or casing is non-metallic. If the supply is alternating and the protection metallic, conductors must be bunched so that the sum of the currents passing is zero.

34. When one of the main conductors of a system of supply is earthed, no interruption of the current by any mechanical device is permitted in a conductor connected to the earthed main that does not also, and simultaneously, break circuit on the non-earthed conductor. Hence, to insure the current being interrupted simultaneously on both the earth and non-earthed wires, no switch that is not linked to another switch on the non-earthed conductor may be inserted in any conductor connected to an earthed main.

35. No fuse may be placed in the neutral conductor of a "three-wire" system. This does not prevent the use of a disconnecting link in the neutral for testing purposes, but fuses must be placed on both conductors of two-wire circuits branching therefrom.

36. Every system must be controlled by linked main switches, which must be placed as near to the entry of supply to a building as circumstances permit, and which must be easily accessible. Subject to regulation 35, the system must also be protected by main fuses.

37. Every sub-circuit must be protected on both poles by a fuse; and no single-pole switch may be inserted in the earthed side of a system.

38. When the wiring is such that one conductor is uninsulated at all points—such as a bare return to a concentric system—no switch or fuse may be placed in that conductor, and the said conductor must be efficiently earthed.

39. When the supply is from all three conductors of a three-phase system, each conductor must be protected by a fuse and the whole controlled by three linked switches.

40. When the pressure between outer conductors of a three-wire main exceeds 250 volts, the circuits connected to opposite sides of the neutral conductor must be so disposed that a person cannot simultaneously touch two points respectively in contact with the outer conductors.

41. Conductors conveying currents at pressures exceeding 250 volts must be completely enclosed in strong metallic sheathing or tubing efficiently connected to earth, and such sheathing or tubing must be electrically continuous throughout its length. Conductors conveying currents at pressures not exceeding 250 volts must be completely enclosed in strong metallic sheathing or tubing, and such sheathing or tubing must be electrically and mechanically continuous throughout its length.

Wood casing must also be continuous throughout its length.

Combinations of metal tubing and wood casing are prohibited.

42. No switch, cut-out, connector, or other electrical appliance, may be mounted directly upon any surface of a condensing or humid nature, such as masonry, brickwork, cement or plaster—but must, in addition to its own mount, be fixed upon a base block rendered impervious to moisture.

43. Branch fuses must be grouped together in accessible positions in sight, and should be symmetrically placed and labelled for each circuit.

44. Contact between insulated conductors and gas-pipe, or metals in contact therewith, must be prevented by non-conducting incombustible distance pieces.

45. Gas-pipes must never be used to obtain an earth connection.

46. Switches and fuses not in an engine-room or compartment specially arranged for the purpose must be covered.

CONDUCTORS—CONDUCTIVITY AND SIZE.

47. The sectional area of conductors must be greater than that determined by the heating effect of the current required for the maximum number of lamps, or other current-using apparatus, that can be used simultaneously on the circuit.

48. The size of conductors within a building will, subject to regulation 47, be determined by the permissible drop in volts, which should not exceed two per cent. on lighting circuits.

49. Copper conductors should be of soft copper, and should have a conductivity not less than 100 per cent. as compared with Matthiessen's standard; and where sulphur compounds are present in any part of the installation the copper in contact with the insulation must be protected therefrom by tinning or otherwise.

50. The sectional area of a copper conductor must not be less than that of No. 18 S.W.G. wire, with the exception of the case of flexible cord conductors and wires for fittings, when the sectional area must not be less than that of a No. 20 S.W.G. wire. All insulated copper conductors having a greater area than that of a No. 14 S.W.G. wire must be stranded.

51. The sizes of copper conductors which will safely carry currents up to 740 amperes, and the length in yards of single conductor in circuit for each volt of fall of potential when the maximum current is in use shall be approved by the Board.

CONDUCTORS—INSULATION.

52. Conductors must be specially insulated with material which does not deteriorate at the highest temperature to which it will be subjected; for instance, rubber must not be allowed to exceed 130° F., or paper—or fibre—insulation 170° F. In specially hot places the conductors should be so large that the electric heating is almost nil.

53. The insulation on any conductor other than a flexible cord must be throughout either—

- (a.) A dielectric which is impervious to moisture and only needs mechanical protection. ("Dielectric" does not include braiding or taping); or
- (b.) A dielectric which must be kept perfectly dry, and therefore needs to be encased in a waterproof sheath, generally of soft metal, such as lead, drawn closely over the dielectric.

54. The radial thickness of vulcanised rubber must be not less than 30 mils plus one-tenth of the diameter of the conductor. The dielectric must not soften sufficiently to allow decentralisation at a lower temperature than 170° Fahr. No conductor shall be insulated with pure rubber as sole dielectric. If the dielectric around any conductor consist of vulcanised india-rubber, the conductor must be protected in an approved manner from the action of the vulcanisation.

55. The dielectric of Class (a.) must be thoroughly damp-proof, and that of Class (b.) must be enclosed in a sheath of ductile material entirely impervious to moisture, which, if metallic, must be electrically continuous throughout and connected to earth.

56. The dielectric must be such that when a test-piece of the insulated conductor has been immersed in water for twenty-four hours it will, while still immersed, withstand 2,000 volts for ten minutes between the conductor and the water. Prior to immersion the test-piece must have been bent six times (three times in one direction and three times in the opposite direction) round a smooth cylindrical surface not more than twelve times the diameter of the finished cable.

57. The minimum insulation resistance shall in each case be approved by the Board.

58. Conductors insulated as in Class (a.) may be protected by braid or taping, prepared so as to resist moisture. Unless fixed in sight and out of reach of injury, all conductors must, further, be protected by a strong covering; and this, in damp situations, must consist of water-tight, incombustible tubes, which, if of metal, must be electrically continuous throughout and connected to earth. Means must be provided to prevent the accumulation within the tubing of water arising from condensation or other sources. Sharp bends or elbows must be avoided, corners being turned by smooth-bore round bends or suitable boxes.

59. The exposed ends of conductors, with dielectrics of Class (b.), where they enter the terminals of switches, fuses, and other appliances, must be protected from moisture which might creep along the insulating material within the waterproof sheath.

60. Concentric conductors should in all respects conform to the requirements herein laid down for single conductors; the insulation resistance of the dielectric separating the two conductors must be that given in the Table for single conductors having the same diameter as the inner conductor. The insulation resistance of the dielectric on the outer conductor where insulated must be that given in the Table for single conductors of the same outside diameter.

61. When the mains are earthed at one point, the outer conductor of the concentric system is the conductor to be connected to the earthed main.

62. In applying the bending test to concentric conductors, the diameter of the cylinder used should be not more than twelve times the diameter of the finished cable.

63. Flexible conductors, i.e., those made up of a number of wires not larger than No. 35 S.W.G., which are then insulated, may only be used for attachment to portable appliances, or pendants or for sub-circuits when visible throughout their length and spaced from walls by porcelain insulators. Where twin flexible cord conductors are in a position where they are likely to receive mechanical injury or are specially exposed to the action of flies or other insects, they must have additional protection to the satisfaction of the Inspector. For the wiring of fittings a strand composed of three wires of No. 25 S.W.G. may be used. The insulating material used as the dielectric must be either pure rubber or vulcanised rubber of the best quality. If pure rubber be used, it should be laid on in two layers, care being taken that these break joint. The radial thickness of the dielectric must not be less than 16 mils for pressures up to 125

volts, or 20 mils for pressures from 125 to 250 volts. The covering must be such that a test-piece not less than one yard in length cut from the conductor will withstand a pressure of 1,000 volts alternating at a frequency of from 40 to 100 periods per second applied for ten minutes between the test-piece and a similar test-piece twisted together with it, the pieces being subjected during the test to the vapour arising from a pan of boiling water placed ten minutes before the commencement of the test at a distance not exceeding three feet immediately below it.

CONDUCTORS—JOINTS.

64. Joints in conductors are prohibited except on small wires protected by fuses, viz., 5-ampere fuses on circuits up to 125 volts, and 3-ampere fuses on circuits from 125 to 250 volts. Junction-boxes must be used to connect lengths of larger conductors, and be so constructed that—

- (a.) The conductors cannot be readily short-circuited;
- (b.) The insulation between opposite poles will not readily break or chip;
- (c.) The connections do not heat.

If used in damp places, special precautions must be adopted to exclude moisture.

65. Joints must be mechanically and electrically perfect to prevent heat being generated. All joints must be soldered. Soldering fluids must not be used. The insulation of all joints in insulated conductors must be most carefully attended to.

66. In jointing conductors the braiding, tape, or lead must be carefully removed without damage to the dielectric for a sufficient length to insure a thorough union between the dielectric and the material used to insulate the joint. If the insulating material is not waterproof, it must be covered with an impervious sleeve or box, which must make a water-tight joint on each side of the junction. Care must be taken to exclude moisture during the operation.

67. Joints between flexible conductors and permanent wires under flooring or in wood-casing are prohibited.

Joints constitute a source of weakness, and they must, therefore, be accessible, and it is recommended that their positions be indicated by a conspicuous mark.

BURIED CONDUCTORS IN BUILDINGS.

68. Conductors must be provided with protection of sufficient strength to resist a nail.

69. Conductors passing through walls or fire-resisting floors must be provided with additional protection, such as a porcelain or other incombustible tube, which must be filled up with some chemically inert incombustible material, so as to prevent the spread of fire through these openings. When the end is outside the building it should be bell-mouthed and turned downwards. Unless under exceptional circumstances, and with the approval of the Inspector, no conductors will be allowed to pass through party walls separating two buildings.

CONDUCTORS—WOOD CASING FOR.

70. Wood-casing must not be—

- (a.) Buried in plaster or cement, nor exposed to moisture;
- (b.) Used in damp places;
- (c.) Run immediately below water pipes unless efficiently protected from drip.

CONDUCTORS—PRECAUTIONS AT POINTS OF CONNECTION.

71. Where conductors are connected to switches, fuses, junction-boxes, or other appliances, the whole of the separate wires forming the stranded or flexible conductor must make contact with the terminal so that no loose wire or strand can project. The dielectric must not be bared back further than to allow the conductor to enter the terminals properly, and the ends of the insulation Class (b.) should be sealed.

72. The braiding, lead, or other covering to the dielectric must be cut back from the end of the insulating material, and waterproofed. In damp places the strands of conductors, Class (b.), should be soldered to prevent moisture creeping along the copper beneath the insulation.

73. Conductors of larger section than 7/18 must be soldered to proper lugs for connection. Where there is any possibility of strain on the lugs they must be mechanically attached in addition to the soldering.

SWITCHES.

74. Every switch, whether fixed separately or combined with lampholders or fittings, must, except as provided in regulation 46, be encased, and comply with the following requirements:—

- (a.) Over-heating must not take place at the point of contact or elsewhere, when the full current flows continuously.
- (b.) When being switched off it must not be possible to form a permanent arc. Switches should be tested at pressure and current 50 per cent. in excess of that which will be used on the circuits for which they are intended.
- (c.) It must be incapable of remaining in partial contact.
- (d.) The base must be of incombustible non-conducting and moisture-proof material.
- (e.) The cover must be of incombustible material, and must be either non-conducting, or of rigid metal, and clear of all internal mechanism.

- (f.) Where the pressure exceeds 250 volts, covers must be of metal and must be earthed.
- (g.) Handles must be insulated and so arranged that the hand cannot touch live metal.
- (h.) It must not contain a fuse.
- (i.) In all damp or other situations where contact between switches and earth can be easily made, no lighting switches will be allowed in which any part of the cover or handle is of metal, unless such metal cover or handle is efficiently and permanently connected to earth.

FUSES.

75. Every fuse must be encased, except as provided in regulation 46, and comply with the following requirements:—

- (a.) That no overheating can take place in any part when the full current flows continuously.
- (b.) That it shall effectually interrupt the current when a short-circuit occurs, and also when the current through it exceeds the working rate by 100 per cent., the current flowing under the normal pressure in both cases.
- (c.) The base of the fuse must be of incombustible, non-conducting, and moisture-proof material.
- (d.) The cover must be of incombustible material, and must be either non-conducting or of rigid metal lined with insulating incombustible material. It must be kept clear of all the internal mechanism. When the fuses are of the open type and grouped together, the case of the distribution board will be a sufficient protection provided the distance from cover to fuse exceeds two inches.
- (e.) Fuses must not be placed in wall-sockets, ceiling roses, lampholders, or switch covers.
- (f.) The fusible metal must be of such size that no conductor protected by it can possibly exceed the temperature specified in regulation 52.

76. Separate single fuses, and not "double-pole" fuses, must be used on circuits on which the pressure exceeds 125 volts.

77. Fuses may be considered too large if they are not warm to the touch on full load, and too small if they hiss when moistened.

CONNECTORS: WALL AND FLOOR-PLUGS, ETC.

78. All connectors must be capable of withstanding a test at a pressure and current 50 per cent. in excess of that for which they are intended. In damp places special water-tight connectors must be used. In cases where the fixed part of the connector is attached to a floor it must be so arranged that no dust or water can accumulate in the cavity, and that all contacts are well below the floor-level, or covered to prevent any possibility of danger from contact with carpets.

79. No connector may contain a fuse.

80. Connectors must be constructed so that they cannot be readily short-circuited. Clearances must be such that an arc cannot be started if the connector is pulled out at the time that the current is flowing. The insulation used between opposite poles should be such that it will not readily break or chip.

81. Flexible cord conductors for portable fittings must end in a connector.

82. Every portable current-consuming device must be independently controlled by a switch on the live side of the connector.

CEILING ROSES.

83. Every ceiling rose must comply with the following requirements:—

- (a.) The base must be of incombustible, non-conducting, and moisture-proof material;
- (b.) The cover must be of incombustible material, and must be either non-conducting or of rigid metal; and clear of all internal mechanism;
- (c.) Unless it, or its base, form part of the sheathing as in regulation 42, it must not be attached directly to a plastered surface, but must be mounted on a prepared block;
- (d.) Its terminals must be relieved of the direct pull of the attached conductor and fitting, and be so arranged that no short-circuit can take place;
- (e.) It must not contain a fuse.

SWITCH AND DISTRIBUTION BOARDS.

84. Main and distribution switch-and-fuse boards must be made of incombustible insulating material insulated, where hygroscopic, by bushes from the supporting framework, and fixed in a dry situation, and be so placed that a fire thereon cannot spread to combustible material.

85. Live metal must be fixed at such a distance from all metal not at the same potential, or be so separated by insulating partitions, that an arc cannot be formed between the metal surfaces.

86. Connections at the back of boards must be made easily accessible, but, unless protected from acid fumes, must not project into battery rooms. Circuits should be labelled for identification.

87. The cases of instruments, if metallic, must be insulated from the circuits, or, if connected to one pole, they should be protected from the possibility of contact with the other.

88. Every voltmeter with its connecting wires must be protected by a fuse on each pole.

FITTINGS FOR SUPPORTING LAMPS.

89. Wherever brackets, electroliers, or standards, require to have the conductors threaded through tubes or channels formed in the metal work, these must be of ample size and have no sharp angles or projecting edges, which would be liable to damage the insulating material. In cases where lamps or fittings are suspended by means of flexible conductors, suitable cord grips must be used, which will take all weight off the terminals of the fitting, and which at the same time will not tend to chafe the insulation of the conductor, or to press the cores of the conductor into contact with one another through the insulation.

90. Where possible, the conductors should be carried without joints through the fittings to the lamps; but where connections at the fitting are unavoidable, special care must be taken to make the joints equal in conductivity and insulation to the rest of the work.

91. Combined gas and electric fittings must not be used.

92. When disused gas-fittings are adapted for electric light, they must be entirely disconnected from the gas-pipes.

LAMP HOLDERS.

93. Lampholders must—

- (a.) Be entirely incombustible;
- (b.) Be insulated from any continuously earthed conduit or sheath not forming part of the circuit;
- (c.) Be specially designed if for currents above $1\frac{1}{2}$ amperes;
- (d.) Not be hung from flexible cord conductors where exposed to the weather, but be rigidly supported.

94. Switch lampholders should be controlled in groups of ten, or fewer, by a separate fixed wall-switch.

ARC LAMPS.

95. Arc lamps must—

- (a.) Be guarded by lanterns or globes, which must be arranged to intercept falling particles of carbon;
- (b.) Be insulated from their support;
- (c.) Be fixed so that their cases cannot come into contact with any metallic object;
- (d.) Have their leading-in wires protected from rain;
- (e.) Be controlled by linked switches and protected by fuses (see "General Arrangement");
- (f.) Not be used in places where inflammable vapours or explosive mixtures of dust or gas are liable to be present;
- (g.) Arc lamps must be suspended to pulleys and lowered for the purpose of carboning, cleaning, etc., stranded conductors must be used for the leads if such leads go direct to the lamp.

INCANDESCENT LAMPS.

96. Incandescent lamps and their holders—

- (a.) Must not be placed in close proximity to inflammable materials; shades made of such materials must be kept free from contact with the lamps by suitable guards; celluloid and other highly inflammable material must not be used for shades;
- (b.) If placed in positions where they are exposed to inflammable vapour or gas, should be enclosed in air-tight fittings of thick glass and have no flexible cord connections.

97. Incandescent lamps of the Nernst type must comply with regulation 95 (a), (b), (c), (d), (f), and 96 (a).

DYNAMOS AND MOTORS.

98. Any dynamo or motor rated at more than one-third of a horse-power must—

- (a.) Be protected from damp, dust, and mechanical injury;
- (b.) Be so placed that no unprotected woodwork or combustible material is within a distance of twelve inches from it measured horizontally, or within four feet measured vertically above it, unless it is of an enclosed type;
- (c.) If supplied at 250 volts or upwards, have its frame efficiently connected to earth;
- (d.) If employed in positions exposed to highly inflammable dust or flyings, or where highly inflammable materials are manipulated or stored, be of the enclosed type, without belting or gearing penetrating the casing, with ventilating openings, if any, only in the vertical portions of their casings, protected by two thicknesses of fine-mesh wire gauze set at least a quarter of an inch apart and substantially attached to the casing;
- (e.) Be controlled by linked switches and protected by fuses or circuit-breakers on both conductors;
- (f.) If a motor have, in addition to the above, starting gear consisting of a regulating switch and series resistance, the regulating switch being fitted with a magnetic release that will automatically open the circuit should the current be interrupted.

RESISTANCES.

99. Resistances, whether used in connection with arc lamps, dynamos, or motors, or for any other purpose, must be—

- (a.) Carried on frames or supports and enclosed in cases, the frames, supports, and cases to be of incombustible material efficiently insulated from the resistances;
- (b.) Amply ventilated by means of apertures protected by fine-mesh wire gauze where there is danger of inflammable material entering them;
- (c.) So proportioned that they cannot rise in temperature more than 240° F., nor the cases containing them more than 130° F., above the temperature of the surrounding air;
- (d.) So fixed that no unprotected inflammable material is within six inches of the cases containing them, or within twenty-four inches measured vertically above them.

CHOKING COILS.

100. Choking coils must comply with the regulations for Resistances (99, (a), (b), and (d), and 104).

ACCUMULATORS AND OTHER BATTERIES.

101. The room in which accumulators or primary batteries are placed must be well ventilated.

102. Accumulators and batteries must be well insulated from earth, and protected by fuses at all points of connection between the circuit and the regulating cells, unless special precautions are taken to keep the conductors permanently apart by incombustible and non-conducting material.

TRANSFORMERS.

103. If high-pressure transformers are brought into a building they must—

- (a.) Together with their switches and fuse-boxes, be contained in fire-and-water-proof structures, and be accessible only to authorised persons;
- (b.) Be so protected by suitable apparatus that a leak between the primary and secondary coils shall cut the transformer out of circuit;
- (c.) Not under normal full load exceed a temperature of 170° F.

104. Low-pressure alternating transformers or choking coils must conform with regulation 99 (a), (b), and (d), and their temperature must not exceed 170° F.

ELECTRIC RADIATORS AND HEATERS.

105. These appliances must be—

- (a.) So constructed and mounted that heat cannot be conveyed to their supports and connections, precautions being taken with regard to their surroundings as in the case of non-electrical heating appliances;
- (b.) Protected by a fuse and switch in both conductors, subject to regulation 34, connectors being so arranged that the live end of the coupling is not exposed to accidental short-circuiting or injury.

TESTING.

106. The insulation resistance to earth of the whole or any part of the wiring must, if tested previously to the erection of fittings and electroliers, be measured with a pressure not less than twice the intended working pressure, and must not be less in megohms than 30 divided by the number of "points" under test. For this purpose the "points" are to be counted as the number of pairs of terminal wires from which it is proposed to take the current, either directly, or by flexibles, to lamps or other appliances.

107. Current must not be switched on until the following test has been applied to finished work:—

The whole of the lamps having been connected to the conductors and all switches and fuses being on, a pressure equal to twice the working pressure must be applied, and the insulation resistance of the whole or any part of the installation must not be less in megohms than 25 divided by the number of 30-watt lamps. When all lamps and appliances have been removed from the circuit, the insulation resistance between conductors must not be less than 25 megohms divided by the number of 30-watt lamps. For the purpose of this test, every arc light shall be considered as equivalent to 15 lamps, and every motor or heater shall be rated at one lamp per ampere, provided that no motor, heater, or other appliance may be connected to the supply of electrical energy unless the insulation of the part carrying the current measured, as above, is greater than 500,000 ohms from the frame or case.

108. The value of systematically inspecting and testing apparatus and circuits cannot be too strongly urged as a precaution against fire. Records should be kept of all tests, so that any gradual deterioration of the system may be detected. Cleanliness of all parts of the apparatus and fittings is essential. In testing, the negative pole should be connected with the conductor under test. All dead or disused wires and fittings which do not conform to these rules must be removed from a building.

109. No repairs or alterations may be made when the pressure is "on."

DEFINITION OF CERTAIN TERMS USED IN FOREGOING REGULATIONS.

110. *Bunching of Conductors.*—Conductors are said to be bunched when more than one is contained within a single duct or groove.

Dielectric.—A dielectric is any material which by its nature or the method of its application to a conductor permanently offers high resistance to the passage of current and of disruptive discharge through itself.

Earthed Conductor.—A conductor is said to be earthed when it is metallically connected at one or more points to the general mass of the earth.

Linked Switches.—Linked switches are single-pole switches fixed on conductors of different polarity linked together mechanically so as to operate simultaneously.

Neutral Conductor.—The neutral conductor of a three-wire system is the conductor which is at a potential intermediate between the potentials of the outer conductors, and is common to all consuming devices.

Outer Conductor.—The outer conductors of a three-wire system are those between which there is the greatest difference of potential.

NOTE.—This specialised use of the word "outer" must not be confused with the non-technical use of the word when applied to the conductor of a concentric main which physically surrounds the other conductor or conductors of such main.

Single-pole Switches.—Single-pole switches are switches interrupting one conductor only of a circuit.

Three-wire System.—A three-wire system is one in which three conductors are maintained at different potentials, the conductor at a potential intermediate between the highest and lowest being common to all lamps or other consuming devices supplied from the system.

Uninsulated Conductor.—A conductor is said to be uninsulated when, although not metallically connected to earth, no provision is made by the interposition of a dielectric or otherwise for its insulation from earth.

DIVISION II.—ELECTRIC LIGHTING.

SANCTION OF THE BOARD TO BE OBTAINED TO ALL WORK.

111. Before the installation of the electric light, or any electrical work or apparatus, and before any alterations or additions to the electric installation are commenced, the sanction of the Board shall be obtained to what is proposed to be done. For this purpose plans showing the approximate positions of the lights, and specifications, together with full particulars of the work it is proposed to carry out, and drawings of proposed switch-boards, shall be forwarded to the Secretary, to whom also complete drawings shall be sent on the completion of the work.

TESTS.

112. Where the electric light is permitted in such premises, tests shall be made as ordered by the Board from time to time.

MAIN CIRCUITS.

113. All such premises, when lighted by electric light, shall have at least three separate and distinct main circuits—

- (a.) For the stage;
- (b) and (c) for the auditorium, corridors, exits, and all parts of the house open to the public.

The circuits "B" and "C" shall be so arranged that approximately half the lights in each division of the auditorium and half those in each corridor, exit, etc., shall be on "B," and the other half on "C" circuit.

As far as practicable the lights on the two circuits shall be placed alternately.

In no case shall the two circuits be combined in one fitting, nor shall the wires or leads for one circuit be placed in the same box, tube, or casing, etc., as those of another circuit.

SUPPLY BY PUBLIC LIGHTING COMPANY.

114. When the current is supplied by a public lighting company or corporation, these circuits shall be separately taken from the street mains, each circuit being taken from a separate box, and, where practicable, from a separate pair of mains. Where transformers are installed on the premises, separate transformers with switches, fuses, and other apparatus shall be used for each of the three circuits, and the transformers, etc., for circuits "B" and "C" shall be placed in separate rooms or in detached strong iron cases placed well apart and the primary and secondary mains properly protected, or shall be divided by a fireproof partition.

SUB-CIRCUITS—THREE-WIRE SYSTEM.

115. Where supply is given on the three-wire system, circuits "A" and "B" or "A" and "C" may be supplied from the two sides of that system, but the other circuit "C" or "B" shall be taken from a separate connection with the street mains.

The main leads, etc., for circuit "A" shall, where possible, be kept entirely on the stage side of the proscenial wall, and those for "B" and "C" entirely on the auditorium side of that wall. If it be desired to control a portion of the lights in the auditorium from the stage board (circuit "A"), this will be permitted if a sufficient number of lights, for safety purposes, be maintained on circuits "B" and "C" in each portion of the auditorium, entirely independent of the stage. The number and position of such lights shall be subject to the approval of the Board.

INDEPENDENT COMPANIES.

116. The supply for the three main circuits may be taken from the mains of independent companies, but in such case special precautions must be taken to prevent accidental connection.

CHANGE-OVER SWITCHES.

117. Change-over switches may also be used if approved by the Board.

METALLIC CIRCUITS.

118. In all circumstances complete metallic circuits shall be employed.

Gas and water-pipes shall never form part of any circuit.

SUB-CIRCUITS.

119. The main circuits "A" "B" and "C" shall be subdivided as may be necessary.

The number of lamps shall be so sub-divided that no sub-circuit other than a distributing board feeder shall carry more than three amperes, and each sub-circuit shall start from a distributing board. No distributing board feeder circuit shall carry more than 10 amperes.

The same sub-circuit shall not be used for arc lamps and incandescent lamps.

Lights outside buildings shall be on sub-circuits entirely independent of inside lights. These outside sub-circuits may carry any current not exceeding 10 amperes.

Circuits for power or heating purposes shall be kept distinct and separate from lighting circuits.

CONDUCTORS, FIXING AND PROTECTION.

120. All conductors shall be efficiently protected from mechanical injury.

In special cases, or where necessary for protection from the depredations of rats, mice, or other vermin, armoured cables may be used.

These need receive no further mechanical protection, but the armouring shall be efficiently earthed.

Lead-covered cables shall not be used unless protected by external armour of iron or steel, or enclosed in substantial iron pipes or tubes.

Metal fastenings for fixing conductors shall be avoided as far as possible. Where unavoidable, some additional covering shall be used to protect the conductor, unless armoured from mechanical injury at the points of support.

If casing be used, it shall be of hard wood and each conductor shall be laid in a separate groove, unless previous permission be obtained from the Board to vary this condition. In no circumstances shall wires be laid in the same groove belonging to different circuits "A" "B" and "C." The cover shall be secured with screws at the outer edges.

Casings shall as far as possible be placed in sight, and the conductors shall always be accessible.

Casing shall not be used where it is liable to injury from weather or leakage of water, nor shall it be recessed into plaster.

No soft or fusible metal tubing shall be used to contain conductors, nor shall any tubing which is not water-tight be embedded in walls of plaster or floors.

Where iron pipe or tube is used as a mechanical protection, it shall be bushed where necessary, and proper joint-boxes shall be used.

STAGE LIGHTING.

121. Where there is a stage, it shall, except by special permission of the Board, be lighted by electric light only. Special care shall be taken that all works in connection with the lighting of the stage are carried out in as substantial a manner as possible.

STAGE SWITCH-BOARD.

122. A switch-board, containing all the necessary switches, cut-outs, and other fittings for the control and regulation of the stage lighting, shall be fixed in some convenient position, preferably overlooking the stage.

This board shall be inaccessible to all but the persons employed at such premises to work it.

If the connections are made at the back of the board, there shall be a space of not less than three feet between the wall and the back of the board, or such larger space as may be necessary to insure the thimbles and connections being at all times easily accessible, or, as an alternative, provision shall be made by hinging the board or placing it on rollers for rendering the back of the board accessible without breaking the connections or dismounting the board.

No metal work in connection with the circuits shall be exposed or so fixed or constructed as to be liable to cause a short circuit.

FOOTLIGHTS, ETC.

123. Lamps on battens, footlights, etc., shall be protected by stiff wire-guards, so arranged that no scenery or other inflammable material can come in contact with the lamp.

No readily combustible material shall be used in connection with any lamps in such a manner that it might come in contact with the lamps.

No soft or readily inflammable wood shall be used in connection with the lamps, and all wood shall be protected by unflammable material from the possibility of ignition by an arc between any two parts of the two conductors, or by heated particles from any conductor or part of a conductor which may connect together the two main conductors.

STAGE SOCKETS.

124. The sockets for the stage shall be of approved hard wood, vulcanite, or slate, with metal guards, care being taken to avoid risk of ignition, and they shall be of specially substantial construction.

Where a number of lights, as in the footlights, battens, etc., are supplied under control of one switch, and protected by one double pole cut-out, the conductors shall be maintained throughout of such a section that they will be effectually protected by the cut-outs against heating.

BATTENS.

125. The leads to the battens shall be specially guarded, particularly at the points where they join on to the battens, and a sufficient length shall be allowed to prevent the leads receiving any injury through any movement of the battens, and this part of the leads shall be protected by leather or stout waterproof canvas hose, properly fixed.

The battens shall be suspended by at least three wire ropes attached to insulators on battens.

On no account shall the same battens be adapted for both gas and electric light.

ARC LAMPS.

126. Arc lamps shall not be used inside such premises without special permission from the Board.

When they are used, special precautions shall be taken to guard against danger from falling glass or incandescent particles of carbon.

All parts of the lamps, lanterns, and fittings which are liable to be handled (except by the persons employed to trim them) shall be insulated from the frame-work.

In no case shall arc lamps be suspended by the conductors.

CUT-OUTS.

127. All circuits shall be efficiently protected by cut-outs, placed in positions easily accessible to the staff but inaccessible to the public.

All cut-outs shall be of approved pattern and be fixed in such a position as to admit of quick replacement.

All cut-outs shall be so constructed that fused metal cannot cause a short-circuit or an ignition.

All cut-outs shall be so marked as to show what circuit or lamps they control.

SWITCHES, CUT-OUTS, ETC.

128. All exposed metal work, such as fittings, switch and fuse covers, etc., shall be efficiently insulated from the circuits.

All switches, cut-outs, ceiling roses, wall and floor sockets, and lampholders shall have unflammable bases and covers.

All lampholders shall be of bayonet socket form, and shall be fitted with porcelain bridges or some equivalent separation between poles.

All fittings shall be suspended in an approved manner, and special care taken to avoid risk of suspension failing from any cause.

All switch and fuse-boards which are not fitted with front connections shall be so mounted as to give instant and easy access to the connections at the back of the board, and shall be provided with dividing strips between poles, both at back and in front, and proper lock-up cases with glass fronts, the glass (unless plate of adequate thickness) shall be protected with a wire guard, or boxes with lids and sides rendered fireproof by asbestos sheeting, or some equivalent method may be used.

RESISTANCES.

129. Resistances for regulating the power of the lights or motors or for other purposes, shall be mounted on incombustible bases, and shall be so protected and placed at such a distance from any combustible material that no part of the resistance, if broken, can fall on such material, or *vice versa*.

Principal metallic resistances shall be placed in a fire-proof room reserved for the purpose. Liquid resistances shall be provided with proper trays and stands.

GENERATING PLANT.

130. Where the supply of current is derived from special plant on the premises or under the control of the licensee, such plant shall in all cases be approved by the Board. The switch-board and its fittings shall be to the satisfaction of the Board.

Boilers, steam-engines, gas-engines, and dynamos, when used for the supply of electricity to such premises, shall be placed in such positions as shall be sanctioned by the Board.

All necessary provision shall be made for keeping the temperature of the engine-rooms within proper limits.

GAS ENGINES.

131. Gas engines shall be placed in rooms so adequately and continuously ventilated that no explosive mixture of gas can accumulate by any leakage through the engine in the event of any of the gas-cocks being left turned on.

A hood connected with a pipe carried into the external air shall be fixed over the ignition tube when this is used.

BATTERIES.

132. Primary or secondary batteries shall be placed in rooms so adequately ventilated to the outside air that no fan shall be necessary. These rooms shall be of fire-proof construction, with iron doors.

The batteries shall be well insulated.

TRANSFORMERS.

133. Transformers used to transform either direct or alternating currents, together with the switches and cut-outs connected therewith, shall be placed in a fireproof and moisture-proof structure adequately ventilated to the outside air, and accessible to the management.

Where the primary current is of high potential, such structure shall be outside the building.

No part of such apparatus shall be accessible except to the persons in charge of its maintenance.

The outer cases of all transformers shall be efficiently connected to earth.

Proper labels, indicating the circuit controlled, shall be affixed to all transformers, main switches, fuses, etc.

No transformer which, under normal conditions of load, heats above 130 degrees Fahr., shall be used.

Transformer circuits shall be so arranged that in no circumstances shall a contact between the primary and the secondary coils lead an electro-motive force of high pressure into the building.

HIGH PRESSURE.

134. The term high pressure means in all cases throughout these regulations pressure above 240 volts.

INSULATION RESISTANCE.

135. The insulation resistance of a system of distribution shall be such that the greatest leakage from any conductor to earth, when all branches are switched on, shall not exceed one-sixty-thousandth part of the total current intended for the supply of the said lamps and motors; the test being made at the usual electro-motive force; Provided that this rule shall not be held to justify a lower insulation resistance than 10,000 ohms.

SUPERVISION.

136. The generating plant and switching gear shall be in the hands of thoroughly competent manipulators, and the engine-room, if any, shall be inaccessible to the public, and shall, where possible, have an independent entrance.

MOTORS, ETC.

137. Motors or electrical heating apparatus shall, if permitted, be subject to special conditions, but electric fans and similar motors not taking more than 300 watts may be used if separately wired from fuses on a proper distributing board.

A plan of the wiring shall always be kept in a prominent position in the office of the manager of such premises.

TEMPORARY LIGHTING.

138. In all cases in which it is desired to instal temporary lighting, sufficient notice in writing shall be given to the Secretary of the Board before the work is commenced.

Wires and cables shall be adequately and firmly fixed, and shall be similar to the wires already specified in these regulations, and in all cases where the wires are within reach of the public they shall be cased.

All joints shall be soldered and taped if used for more than one week, and if used less than a week the wire shall be soldered if larger than 7/20 S.W.G. or its equivalent. In either case the joints shall be taped.

The circuits shall be subdivided as much as possible, no sub-circuit exceeding three amperes.

All temporary work shall be immediately removed when no longer required for the purpose for which it was installed.

In the case of temporary work on the stage, all connections to the permanent installation shall be removed immediately after each performance in which they are used, unless permission be obtained to the contrary.

Such special conditions as may be requisite in each case will be attached to the consent of the Board to the use of temporary electrical work.

DIVISION III.—EXHIBITIONS OF ANIMATED PICTURES, ETC.

139. Lanterns must be constructed of metal or lined with metal and asbestos.

140. An alum or water bath must be used between the condenser and film.

141. The apparatus must be fitted with a drop shutter, available in case of emergency.

142. If the film does not wind upon a reel or spool immediately after passing through the machine, a metal receptacle, with a slot in the metal lid, must be provided for receiving it.

143. If electric arcs be used, the installation must be in accordance with the regulations, and the choking coils and switch must be securely fixed on incombustible bases, preferably on a brick wall, and double-pole safety fuses must be fitted.

144. If oxy-hydrogen gas be used, storage must be in metal cylinders only, placed where directed by the Board.

145. The use of an ether saturator (except a saturator approved by the Board) is prohibited.

146. Generators must not be placed under the stage and only in an incombustible chamber fitted, situated, and maintained as approved by the Board.
