WHEREAS by Section 219 of "The Municipal Institutions Act, 1900" (64 Vict., No. 8), it shall be lawful for the Governor, on request of the Council, by notice in the *Government Gazette*, to declare any land reserved, used, or by purchase or exchange acquired for a street or way to be a public highway, and such land shall thereupon and thenceforth, from the date of such Proclamation, become and be absolutely dedicated to the public as a highway within the meaning of any law now or hereafter in force:

AND WHEREAS the Subiaco Municipal Council has requested that certain lands named and described in the Schedule hereunder, which have been used for streets or ways within the Municipality of Subiaco, be declared public highways: NOW THEREFORE I, the said Governor, by and with the advice and consent of the Executive Council, do by this my Proclamation declare the said lands to be public highways, and such lands shall, from the date of this Proclamation, be absolutely dedicated to the public as highways within the meaning of any law now or hereafter in force.

WHEREAS by "The Fisheries Act, 1905," it is provided that the Governor may, by Proclamation declare, *inter alia*, that any Western Australian waters shall be closed against the taking of any prescribed species of fish by any means whatever, or against fishing generally by any method of capture, during any specified time in any year: AND WHEREAS it is desirable that the waters in the vicinity of the Fish Rock, situate in Geographe Bay, should be declared closed as hereinafter provided: NOW THEREFORE I, the said Governor, by and with the advice and consent of the Executive Council, do hereby declare as follows:—

That all that portion of Western Australian waters extending half a mile North-West of a point locally known as the Fish Rock, in Geographe Bay, and half-a-mile South-East of the said point, and a quarter of a mile to seaward shall be closed against fishing generally, and by every method of capture (except by means of fishing lines) from the 1st day of October, 1906, to the 31st day of March, 1907, both days inclusive.

CARNARVON JETTY.

HARBOUR AND LIGHT DEPARTMENT.

JETTY REGULATIONS, WHARFAGE RATES, AND BERTHAGE DUES.

From and after 1st October, 1906, the following Regulations shall come into force:—

BERTHING DUES, ETC.

1. All vessels using the jetty shall pay berthing dues at the following rates, namely:—

For vessels exceeding 200 tons register, 1d. per ton on all cargo landed or shipped; minimum, 10s.

All vessels not exceeding 200 tons register, 1d. per ton on all cargo landed or shipped; minimum, 2s. 6d.

All lighters, 1d. per ton on all cargo landed or shipped; minimum, 2s. 6d.

COMPUTATION OF BERTHING DUES.

2. In the computation of berthing dues for cargo-carrying vessels, the Wharfinger shall have the option of proceeding on a weight basis of 2,000 or 2,240 lbs. to the ton (according to trade

usage), or a measurement basis of 40 cubic feet to the ton, for the cargo in respect of which such dues are levied, except as follows:—

Hardwood timber at 33cwt. per load of 50 cubic feet.	
1 bullock, cow, steer, heifer, or such-like animals, 1 ton.	
3 calves or foals, 1 ton.	
15 sheep, pigs, goats, or such-like, 1 ton.	
Caneware—Chairs	8 to the ton.
Tables	8 "
Lounges	4 "
Articles N.O.E.	8 "
Hides (Raw), loose	24 "
" " in bags	8 bags to the ton.
Skins in bales	5 bales to the ton.
" in bundles	10 bundles to the ton.

Vessels after having discharged or taken in their cargo shall remove to any berth or anchorage pointed out by the Harbour Master or Officer-in-charge.

All vessels lying alongside the jetty and transshipping cargo to or from lighters or other vessels shall pay the like berthing dues in respect thereof as if the said cargo had been landed on or taken off the jetties in place of being taken from or placed in such lighters or vessels as aforesaid.

Goods for transshipment not trucked to be charged Jetty rates one way, those trucked full rates. Wharfinger not responsible for goods stacked on Jetty.

All wharfage dues and handling or other charges incurred, payable in respect of cargo discharged or shipped, shall become payable to the Wharfinger on the discharge or shipment of the said cargo, and shall be paid to the Wharfinger on demand, and each bill of lading as shown on the manifest must be cleared by one payment. No inward cargo shall be delivered to the consignee or owner thereof, nor outward cargo to the vessel in which it is intended the same shall be shipped, until the written receipt of the Wharfinger shall have been presented to the consignee or owner, or to the shipper or master, of the vessel respectively, for the payment of all wharfage dues and charges as aforesaid in respect of such cargo; provided always, that it shall be competent, but not compulsory (in the case of outward cargo), for the Wharfinger to accept from the agent or the master a guarantee, in writing, that such dues shall be paid to him within 24 hours of the clearance of the vessel. Cargo passed overside into lighters and taken delivery of direct from ship or *vice versa*, where the Wharfinger does not receive, handle, or deliver same (always at Wharfinger's option), half schedule rates.

INWARD MANIFESTS TO BE SUPPLIED AND CERTIFIED TO.

5. The master of every vessel arriving shall deliver at the office of the Wharfinger, prior to commencing to discharge cargo, a true, legible, and complete copy of the manifest of the said vessel, certified to by himself as being true and complete, and

shall also furnish, within 48 hours, a certified statement of all alterations (if any) which may be made in such manifest by reason of remeasurement of goods included therein or otherwise.

OUTWARD MANIFESTS, ETC.

6. The master of every vessel shall deliver at the office of the Wharfinger, prior to the clearance of the ship in which outward cargo is shipped, a certified copy of manifest giving true, legible, and complete particulars of such goods as will enable the amount of outward wharfage dues payable thereon to be readily computed.

7. No person shall enter on any wharf with goods for shipment without first delivering to the Wharfinger an outward cargo advice note as required by the Department, containing full and true account, with gross measurements or weights of such goods then under his immediate control.

8. All outward cargo must be delivered into the shed at least not less than four working hours prior to ship's advertised time of sailing.

9. No goods shall be landed or placed on any jetties without the written authority of the Wharfinger or Officer-in-Charge. Cargo discharged without such authority having been first obtained shall not be deemed to be in the custody of the Department, nor shall the Department be held responsible for any loss or damage that may accrue to any such cargo from any cause whatsoever.

10. If it appear that goods are being landed and cannot, in the opinion of the Wharfinger or Officer-in-charge, be removed in time to prevent a "block," the Wharfinger or Officer-in-charge may give notice, in writing, to the masters or persons in charge of vessels or lighters from which goods are being discharged to stop discharging cargo, and upon such notice being given, no further cargo shall be discharged until such time as the Wharfinger or Officer-in-charge may direct.

RECEIPTS, ETC., FOR INWARD CARGO.

11. If during the progress of discharge of cargo doubt shall be expressed by the Wharfinger as to the condition of any package or packages, such package or packages shall be placed in a situation apart from other cargo, pending examination, and the Department's tally and receipt for such package or packages shall be that of a doubtful or damaged package, as circumstances or appearances dictate. Such packages shall be opened and examined by the consignee, but only in the presence of the Wharfinger and ship's agent, as soon as is possible after being landed. The Department will, under no pretence whatsoever, be held responsible for the safe custody or the condition of such package or packages, or of it or their contents.

12. In the event of the ship, by its agent, refusing to accept a receipt as indicated for such cargo, such cargo must be immediately returned on board by the ship, and shall not be again landed until it has been examined by the consignee, who shall take delivery direct from the ship.

RESPONSIBILITY OF THE DEPARTMENT.

13. No goods for which receipts have not been given by the Department shall be deemed, for any purpose, to be in the custody of the Department as Wharfingers, nor shall the Department be responsible for the safe custody, or for any loss or damage that may accrue to same, in any manner whatsoever.

GOODS TO BE CHECKED BEFORE DELIVERY.

14. No person shall remove any goods or luggage from any wharf or shed without first satisfying the Wharfinger or Officer-in-charge of his right to do so; and shall, before removing same, sign for such goods or luggage to the Wharfinger or Officer-in-charge.

DELAY IN DELIVERY OF GOODS.

15. The Department will not be responsible for any claim arising from delay in the delivery of goods from any cause whatsoever.

WRONG DELIVERY.

16. The Department will not be responsible for the wrong or non-delivery of the goods which are erroneously or deficiently marked, or which have numerous old or imperfectly erased marks thereon.

GOODS NOT TO BE MOVED.

17. No person shall remove from one vessel to another, or from any part of the wharf to any other part thereof, any goods or luggage without the authority of the Wharfinger first had and obtained.

GOODS NOT TO BE HANDLED IN WET WEATHER.

18. No goods shall be landed or shipped in wet weather without the permission, in writing, of the Wharfinger at the request of the master or agent of the discharging or loading vessel; but the giving of such permission shall not throw on the Department any liability for damage to such goods caused by being so landed or shipped or handled in wet weather. The determination of the Wharfinger that the weather is wet shall be conclusive.

RESPONSIBILITY IN CASE OF FIRE, ETC.

19. The Department shall not be responsible for loss or damage to goods while in their custody, by fire, water used in extinguishing fire, or vermin.

EXTRA CHARGES.

20. The Wharfinger may make extra charges for handling packages over one ton in weight, or of an exceptional shape, or where extra labour is required or unusual risk is involved.

CARGO DEPOSITED ON WHARF.

21. No ballast, stone, coal, coke, timber, sand, or other goods or other materials in bulk shall be deposited on any wharf or jetty without special permission, in writing, of the Wharfinger or Officer-in-charge.

DEPARTMENT NOT BOUND TO FIND STORAGE ACCOMMODATION.

22. The Department shall not be bound to find storage room for any goods, either in any shed or on any wharf. After notification to the owners, shippers, or consignees of any goods, or to the vessel's agent, that room is not available for the storage of such goods within a shed, or that such goods are, owing to their character, not permitted by some authority other than the Department to be stored in a shed, the Department shall not be held responsible for any loss or damage that may accrue to the goods, by the elements or otherwise, during the time they remain on the Department's premises.

GOODS TO BE REMOVED OR MAY BE SOLD.

23. All goods landed on any wharf shall be removed therefrom or placed in a shed within seven days after being landed. The Wharfinger is empowered to take charge of and store cargo and goods if not removed from any wharf or shed by the consignee within the time or respective times limited for that purpose, or to cause the same to be conveyed to King's Warehouse or delivered to the consignee at his expense and risk, or to remove the same to any of the premises of the Department or other convenient place, or to keep the same until payment to the Department of the expenses of such removal and of the keeping of the goods, and of all other charges due to the Department thereupon: and, in default of payment, on behalf of the Department to sue for same.

STORAGE RATES FOR GOODS.

24. Should any goods be not removed from any wharf or jetty or sheds thereon within the time specified in these regulations, there shall (subject to as hereinafter mentioned) be payable to the Wharfinger, as and by way of storage rent in respect thereof, the sum of one shilling (1s.) per ton for the first week, and for every subsequent week the sum of threepence (3d.) per ton additional to the amount per ton payable by each immediate preceding week, i.e., one shilling and threepence (1s. 3d.) per ton for the second week, and one shilling and sixpence (1s. 6d.) per ton for the third week, and so on. For the purpose of this regulation a fraction of a ton shall be deemed to be a ton, and a part of a week shall be reckoned as one week. Nothing herein contained shall prevent the Wharfinger from removing or ordering the removal, as provided for in these Regulations, of any such goods at any time after the time hereinbefore appointed for their removal.

LIMIT OF STORAGE.

25. No goods shall be allowed to remain in any shed or upon any wharf for a longer period than four weeks. If any goods so remain without the consent of the Department, the Wharfinger may remove same to King's Warehouse (in the case of goods liable for Customs duty) or to any of the premises of the Department or other convenient place, and retain the same. The charge to be made for such removal only to any premises of the Department shall be two shillings (2s.) per ton, and the charge for storage on such goods after removal shall continue to be at the same rate as applies to goods left in wharf sheds beyond the specified free storage period.

CLAIMS IN RESPECT OF CARGO.

26. No claim will be entertained by the Department in respect of goods landed, or alleged to be landed, unless claim has been received by the Wharfinger, in writing, before the vessel (in case of sailing vessels) leaves the Harbour, or in case of steamers, within four days of the steamer leaving the port, nor in respect of outward goods unless received by the Wharfinger within twenty-four (24) hours after the vessel in which it was intended to ship such goods leaves the port. Each claim must be rendered on the form recognised by the Department, which form will be supplied on application.

WORKING HOURS.

27. The working hours of the Port shall be and include the hours from 8 a.m. till 12 noon, and from 1 p.m. till 5 p.m. on week days other than Saturdays, and on Saturdays the hours from 8 a.m. till 1 p.m.

28. The cost over and above the ordinary cost of day work, or all labour and supervision, etc., employed during any hours not being working hours as above defined, or on holidays, shall be paid for by the vessel in addition to the usual charges. The extra cost of lighting shed or berth to enable the vessel to work during any hours not being working hours, or on holidays as aforesaid, shall also be paid by the vessel.

29. A vessel desiring to work any hours, not being working hours as defined above, shall give to the Wharfinger or Officer-in-charge two hours' notice, and on holidays twelve hours' notice of her desire to do so.

PENALTIES.

30. When any person or persons, by the foregoing Regulations, or any of them, are required to do or perform any act or thing, and such act or thing remains undone, the Harbour Master or his representative may cause the same to be performed, and charge the cost and expense against such person or persons, and the amount thereof may be recovered summarily.

31. Every person who does, permits, or suffers any act or thing contrary to any of these Regulations shall, on conviction, for every offence, breach, or neglect, be liable to a penalty not exceeding (except when otherwise provided) the sum of £20 (42 Vict., No. 18).

A COMPETITIVE Entrance Examination to the Clerical Division under the Public Service Act will be held at the beginning of November, 1906.

It is estimated that during the year 1907 there will be from 20 to 30 vacancies in Class "G," 4th Grade, of the Clerical Division.

Candidates must, on the day of the examination, be not less than sixteen nor more than twenty-five years of age at their last birthday.

Message boys already in the Service are notified that the terms of their employment are governed by Regulation 284, and that if they are to remain in the Service after they have attained the age of 18 years, they must obtain a position in the Clerical Division by competitive examination.

Officers already included in Class "G" should present themselves for examination, as unless they pass this examination now they will be required to pass it before promotion to Class "F," and as promotion to this class will also be governed by an examination in connection with clerical duties and attainments, it would be wise to get through the educational test examination without delay.

Officers in Class "G" who have passed in any of the following examinations will be exempted from this examination:—

Matriculation of any University.

Senior or Junior of the Adelaide University.

Ex-Seventh of the State School.

Those officers in Class "G" who failed to qualify in the last examination, but who obtained not less than 40 per cent. of the aggregate marks for the compulsory subjects, will be exempted from the necessity of entering again in this examination for those subjects in which they passed, provided that exemption certificates, which are obtainable on application to the Commissioner, are sent in on or before 1st October, 1906.

Candidates must notify the Public Service Commissioner, in writing, on or before the 1st October, 1906, of their intention to present themselves for examination.

The standard required in the subjects prescribed will be about equivalent to that required in the Ex-Seventh Standard of the State Schools and in the Junior Examination of the Adelaide University.

IT is hereby notified, for general information, that His Excellency the Governor in Council has been pleased to approve of the following By-laws of the Port Hedland Road Board, under Section 117 of the Roads Act (2 Edw. VII., No. 48).

WHEREAS by virtue of the provisions of "The Roads Act, 1902" (2 Edward VII., No. 48), the Road Board of every district is empowered to make, publish, alter, modify, amend, or repeal by-laws for any of the purposes of the said Act mentioned: It is therefore ordered by the Port Hedland Road Board that from and after the publication thereof in the *Government Gazette* the following Special By-laws relating to the registration of camels, licensing of camel-drivers and bicycles, tricycles, motor cars, etc., shall come into force.

PORT HEDLAND ROAD DISTRICT.

SPECIAL BY-LAWS FOR THE REGISTRATION OF CAMELS AND THE LICENSING OF CAMEL-DRIVERS, AND FOR THE LICENSING OF BICYCLES, TRICYCLES, AND MOTOR CARS, AND REGULATING THE USE THEREOF.

THE Port Hedland Road Board in exercise of the powers conferred by "The Roads Act, 1902," and of every other authority enabling it in that behalf, doth hereby make the following By-laws:—

Camels to be registered.

1. No person shall own, keep, or use within the Port Hedland Road District (hereinafter referred to as "the District") any camel unless such camel is registered for the time being at the office of the Road Board of the said District. Provided that no person shall be required to register a camel under this By-law during such time as the camel is duly registered in the office of some other Road District.

Application for registration.

2. Application for registration shall be made to the Secretary to the Board by writing in the Form "A" in the Schedule, and shall contain the particulars indicated thereby, and shall be signed by the applicant or his agent.

Registration Fees.

3. The following fees shall be payable on registration of camels plying for hire:—

In respect of every bull camel over three years of age	10s. per annum.
In respect of every camel used for packing—	
For every bull camel under three years of age	10s. per annum.
For every cow or gelding	5s. per annum.
In respect of every camel used for draught only (except bull camels over three years of age)	5s. per annum.

Provided that no registration fee shall be payable in respect of camels used solely by prospectors for prospecting purposes.

Certificate of registration.

4. A certificate of registration shall be issued by the Secretary to the Board to the applicant in the Form "B" in the Schedule.

Duration.

5. Every registration shall expire on the thirty-first day of December in the year for which such registration is effected.

Registration Discs.

6. On the annual registration of every camel the Board will issue to the applicant a registration disc inscribed with the name of the district and the registration number.

Every person in charge for the time being of such camel shall keep the disc attached to the neck of the camel.

Camel-driver's licenses.

7. No person shall drive any camel or camels within the district unless he is the holder of a camel-driver's license in force for the time being issued by the Board of the said district, or unless he is the holder of a license in force for the time being issued by the Board of some other road district.

Form of license.

8. A camel-driver's license shall be in the Form "C" in the schedule, and the licensee shall be required to sign his name in the margin thereof before the license is issued to him.

License fee.

9. The fee payable for a camel-driver's license shall be five shillings per annum.

Duration of license.

10. Every camel-driver's license shall expire on the thirty-first day of December in the year for which it was granted.

Transfer.

11. A camel-driver's license shall be transferable by indorsement at the office of the Board on payment of a fee of one shilling, the transferee to sign his name in margin thereof.

License and registration certificate to be produced.

12. Every camel-driver shall produce his camel-driver's license and the certificate of registration for each and every camel in his charge whenever called upon so to do by any constable or officer of police, or any member or officer of the Road Board.

Limit of number of camels to be driven.

13. No person shall at the same time drive or take the charge of more than eleven camels, whether draught or pack camels, or partly draught and partly pack camels.

Camels to give place to horses, etc.

14. Every camel-driver or other person driving or having the charge of any camel or camels on any road or track, or at any well or watering place, shall, at the request of any person in charge of any horse or mule, forthwith remove any camel or camels which he is driving, or of which he is in charge, to a distance of not less than a quarter of a mile from such road, track, well, or watering place.

Unregistered camels may be destroyed.

15. Any unregistered camel found straying in any part of the Board's district may be seized and either sold or destroyed, after such camel has been advertised for three weeks in some paper circulated in the district; the owner shall be liable to pay to the Board the cost and expense incurred, in addition to registration fees.

Penalty for suffering camels to stray.

16. If any camel is suffered to stray, the owner thereof and any person who having been in charge thereof has suffered it to stray shall be guilty of an offence against these By-laws.

Penalty for driving diseased camels.

17. If any person drives or rides any camel suffering from any infectious or contagious disease on any road within the district he shall be guilty of an offence against these By-laws.

Public watering places not to be used by diseased camels.

18. No camel suffering from any infectious or contagious disease shall be allowed to water at any public watering place.

Any person who having, as owner, driver, or otherwise, the custody of any camel suffering from any infectious or contagious disease, permits such camel to water at any public watering place shall be guilty of an offence against these By-laws.

Diseased camels may be destroyed.

19. It shall be lawful for any member of the Board or any person acting with the authority of the Board or of any officer of the Board to slaughter and destroy any camels found suffering from any infectious or contagious disease on any road.

Cycles and motor cars to be licensed.

20. No person shall use any bicycle, tricycle, or motor car in the district unless such bicycle, tricycle, or motor car is licensed.

Provided that if a license is taken out for a bicycle, tricycle, or motor car by any person in the district in which he resides he shall not be required to take out a license in any other district.

Form of license.

21. A bicycle, tricycle, or motor car license shall be in the Form "D" in the schedule, and application for the same shall be made to the Secretary to the Road Board at the office of the Board.

Fee.

The fee for every bicycle, tricycle, and motor car license shall be five shillings per annum.

Duration.

22. Every license for a bicycle, tricycle, or motor car shall expire on the thirty-first day of December in the year for which it was issued.

Number to be affixed.

23. Every licensee of a bicycle, tricycle, or motor car shall affix and keep affixed the license number on some conspicuous part of the bicycle, tricycle, or motor car.

Riding on footpaths prohibited.

24. No person shall ride or impel a bicycle, tricycle, or motor car of any kind upon any footpath within the district.

Lamp to be carried.

25. No person shall, between the hours of sunset and sunrise, ride a bicycle, tricycle, or motor car along any road unless there is attached thereto a lamp which shall exhibit a white light in the direction in which he is proceeding, and at all times to be kept lighted.

Bell to be used.

26. Every bicycle, tricycle, or motor car shall carry a bell or other instrument suitable for giving warning of approach, which shall be used as a signal whenever any person on foot or horseback or vehicle is being approached or passed.

Roads and footpaths not to be obstructed.

27. No person shall leave any bicycle, tricycle, or motor car in or on any road or footway so as to become an obstruction, and every person shall remove his bicycle, tricycle, or motor car immediately upon being requested to do so by any police officer or constable or member or officer of the Board.

Speed.

28. No person riding on a bicycle, tricycle, or motor car shall pass at a speed exceeding eight miles an hour, any person who shall be riding or driving any horse or other animal.

To dismount on meeting restive horse.

29. When a cyclist or motorist meets a horse or other animal, and such horse or other animal becomes restive, or appears likely to get beyond the control of the person in charge thereof, such cyclist or motorist shall dismount, and remain dismounted till such horse or other animal has been passed.

Speed on turning corners.

30. No person shall ride any cycle, bicycle, tricycle, or motor car round the corner formed by the junction of any roads in the district, or across the intersection of any of the said roads, at a pace exceeding six miles an hour.

Penalties.

31. Every person who does, permits, or suffers any act, matter, or thing contrary to any of the foregoing By-laws, or commits, or permits any breach or neglect thereof, shall be deemed guilty of an offence against these By-laws, and any person guilty of an offence against these By-laws, shall be liable to a penalty not exceeding £20 for every such offence.

HIS Excellency the Governor in Executive Council, in pursuance of the powers vested in him by Section 22 of "The Elementary Education Act, 1871, Amendment Act, 1893," has been pleased to approve of the following amendments to Regulations:—

The cancellation of the following words in Regulation 98:—

With the permission of the Department, children over 16 years may be retained in the school. In each such case a fee of 6d. per week must be paid to the teacher, which may be retained by him. A statement should be forwarded with the Quarterly Summary showing the amounts so received. The attendance of these children should be noted on the Registers, but entered apart from the ordinary scholars, and not included in the totals.

And the substitution of the following words:—

After a scholar has reached the age of fourteen years, the following fees shall be paid, unless an application has been made for the child to be placed upon the free list and such application has received the approval of the Minister.

A fee of one shilling per week must be paid by all children over fourteen and under fifteen years of age in attendance at school. Children over fifteen must pay two shillings per week. The Head Teacher must collect these fees and forward them to the Department each month with the salary sheet. To facilitate the checking of the lists, the teacher of any class containing over-age children should enter on his register first, the names of children over fifteen, next the names of those over fourteen, and next the names of those who will attain the age of fourteen during the quarter.

Also the cancellation of the following words in Regulation 227:—

The Department has no objection, if the parents wish their children to be instructed when they are between the ages of three and six, to have them placed on the roll and taught in the ordinary way. No child under three can be admitted. Where there is no separate Infants' School it would not be desirable to admit children below the age of four years. Children over fourteen, but below sixteen, might remain in the school if of good behaviour and unless their influence on the younger children is likely to be bad. Children over sixteen can only remain in the school on payment of a fee of sixpence per week, which should be retained by the teacher but accounted for to the Department.

And the substitution of the following words:—

No child under the age of four years can be admitted to a Government School. Children over fourteen may remain in the school until the age of sixteen, if they are of good behaviour and not likely to have a bad influence over the younger children, subject to the payment of the prescribed fees. In special cases where, owing to isolation, it has been impossible for a child to attend school at the usual age, the Minister may permit his retention in a school after he has reached the age of sixteen years.

These alterations shall come into effect from 1st November, 1906.

The above cancels the notice dated 6th September, 1906, appearing in the *Government Gazette* of 7th September, 1906.

THE ROADS ACT, 1902.

BY-LAWS OF THE WOODANILLING ROAD BOARD.

THE Woodanilling Road Board, in pursuance of the powers vested in the said Board, under and by virtue of the said Act, doth hereby make and publish the following By-laws:—WHEREAS by "The Roads Act, 1902," the Board of any District is empowered to make By-laws for all or any purposes in the said Act mentioned, it is hereby resolved by the Board of the Woodanilling District, by and with the approval of His Excellency the Governor in Council, that the following By-laws shall be in force within the said District from the date of the publication thereof in the *Government Gazette*:—

INTERPRETATION.

In these By-laws the following terms shall, unless the context otherwise indicates, bear the meanings set against them respectively, that is to say:—

"The Act," the Roads Act of 1902 and all amendments thereto considered necessary which may come into force hereafter as far as the Act allows.

"District," the Woodanilling Road Board District.

"Board" the Woodanilling Road Board.

"Committee," a committee appointed for any purpose by the Board under Section 87 of the Act.

"Secretary," the Secretary of the Board.

"Road" or "Reserve," a public road or reserve, as the case may be, under the control of the Board.

"Footpath" or "Footway" shall include any part of a street set apart for the sole use of foot passengers, and whether the same be made or kerbed or otherwise.

"Cycle," a bicycle, tricycle, velocipede, motor-cycle, or motor-car.

"Cyclist," a person riding, impelling, or otherwise using or having the management or control of any cycle.

"Person" shall include the plural and also the body corporate.

"Permission of the Board," the consent of the Board given in writing.

"Vehicle," any cart, dray, carriage, van, omnibus, trap, or other conveyance (not being a hand-cart), with or without springs.

Other interpretations are as defined in Section 4 of "The Roads Act, 1902."

APPOINTMENTS.

1. No permanent appointment shall be made to an office under the Board until an advertisement has been published in one or more newspapers (local) calling for applications from persons competent to fill such an appointment. All appointments shall be made by resolution passed by the Board.

DUTIES OF SECRETARY.

2. Duties of Secretary—

- (a.) To attend all Board meetings.
- (b.) To attend committees when considered necessary.
- (c.) To take notes of all minutes of any meeting of the Board or a committee, and prepare reports of committees.
- (d.) To conduct all correspondence, and to give the other officers instructions as directed by the minutes.
- (e.) To answer all the questions on the Board's business.
- (f.) To supervise the preparation of the rate books and Board's electoral lists, examine proofs of latter, and arrange for the distribution of copies prior to elections, and, if necessary, to compile separate valuations for each event; also to attend all Courts of Revision or Appeal, making the necessary arrangements for the elections, and preparing papers, etc., for the clerks.
- (g.) To summon the members to Board and committee meetings other than the regular meetings.
- (h.) The Secretary shall keep the cash-book, as well as any and all other books issued by the Minister for Works in accordance with instructions inserted therein, and those required to show the receipts and expenditure made by the Board. The said Books shall be written up every fortnight ready for inspection of the Board, or any member of the Board who may, at any time during office hours, desire to see them. He shall check all accounts sent in to the Board, and see that all accounts for works (exceeding five pounds in amount) have stated on them the authority under which such works have been done, and shall keep all returns made by the collectors or other of the Board's officers, and shall see that, with all returns made, the heels of the receipt books accompany the returns; he shall supervise and attend to the due payment of all money coming through the hands of the Board's officers and payable to the credit of the Board; he shall report to the Board, at their next meeting, any officer neglecting to make his returns as provided, with the necessary vouchers attached thereto.
- (i.) He shall pay into the bank as soon as possible after the receipt, to the credit of the Board, any sum or sums of money that may be received by him on behalf of the Board, as provided by Section 171 of the Act.
- (j.) He shall have the cash-book and bank pass-book made up in readiness for the meetings of the Board, and shall produce them at each meeting thereof; should any member of the Board desire to see them at any time during office hours, the Secretary shall produce them for his inspection. No money shall be paid into the bank to the credit of the Board by any officer of the Board except by or through the Secretary. The Secretary shall give all receipts on printed forms. The Secretary shall readily and cheerfully obey all lawful commands or orders of the Board, and shall attend to all other matters affecting the finances of the Board and not herein specified.
- (k.) The Secretary shall prepare, and at each ordinary meeting of the Board produce, an approximate balance-sheet, showing as near as possible the position of the Board as regards payments already made, its present assets and liabilities, which latter shall specify and include moneys voted for special purposes which have not yet been undertaken or contracted for; and no further expenditure of any nature shall be incurred unless the balance-sheet shall be then produced.
- (l.) To see that all tender notices are properly advertised, and notices posted where directed by the Board.

DUTIES OF COLLECTOR.

3. To send out all rate notices.

To collect all moneys due to the Board for rates and licenses.

To report to the Board at every meeting the business he has transacted for the Board, the amount of money collected and paid over to the Secretary; and, if necessary, the Board may appoint a sub-collector.

MEETINGS AND PROCEEDINGS.

4. The Board shall meet on the fourth Saturday in each month, at the hour of half-past two o'clock in the afternoon. The Chairman, if present, shall preside at all meetings of ratepayers and of the Board, and in his absence, or if after being present he shall retire, one of the members of the Board chosen by the ratepayers or members present (as the case may be) shall preside for remainder of meeting.

At any meeting of the Board it shall rest with the majority of the members of the Board present to exclude the public from such meeting when, in their opinion, it is expedient so to do.

At all meetings of the Board when there is no quorum present, or when the Board is counted out, which counting out shall take place whenever there shall be less than a quorum present, such circumstances, together with the names of the members then present, shall be recorded in the minute book.

ORDER OF BUSINESS.

5. The ordinary business at all ordinary meetings shall be as follows, that is to say:—

- (a.) Reading and confirmation of minutes of last ordinary and special meetings, if any.
- (b.) Consideration of business arising out of minutes:
- (c.) Consideration of correspondence (received and despatched) and taking such immediate action as may be deemed expedient in regard thereto.
- (d.) Passing of accounts for payment.
- (e.) Presentation of petitions or memorials and committee reports, and consideration thereof.
- (f.) Consideration of tenders and ratification of contracts.
- (g.) General business of the Board.
- (h.) No discussion shall take place upon the minutes except as to their accuracy, or for the ratification of any clerical error.
- (i.) Immediately after the confirmation of the minutes the Chairman may make any communication to the Board which he may deem advisable, or bring under consideration any business he may think necessary; and it shall be competent for any member of the Board to ask a question or questions, but he shall confine himself to the question simply, and no debate shall ensue thereon at the time.

PETITIONS.

6. Every petition or memorial must be couched in respectful and temperate language, and shall be presented by a member only; such member shall affix his signature thereto.

TENDERS.

7. Tenders for work shall be opened and dealt with when the subject matter of the tenders comes on to be considered at the meeting of the Board, or by a committee appointed for that purpose, and the Board may require deposits on tenders amounting up to £20 at the rate of 10 per cent., and over £20 5 per cent., or approved sureties.

CONDUCT OF MEETING.

8. (a.) Every member speaking at a meeting must stand and address himself to the Chairman.
- (b.) A member having audience shall not digress from the subject of debate, and speak for more than ten minutes, unless by consent of the majority of the members of the Board then present.
- (c.) A motion once moved at a meeting cannot be withdrawn unless by the consent of the majority of the members of the Board then present.
- (d.) One or more amendments may be proposed on a motion before the Board.
- (e.) When more than one amendment is moved, the question shall first be put on the last amendment, then on the next in succession, and then on the original motion, in the reverse order in which they are moved.

- (f.) A motion of amendment not seconded cannot be discussed by any member except the mover, nor put by the Chairman.

- (g.) In submitting a motion or amendment, the Chairman must put the question first in the affirmative and then in the negative.

- (h.) When an amendment is carried the motion as amended thereby becomes a substantive motion, upon which further amendment may be moved before it is finally dealt with.

- (i.) All notices of motion shall, if required, be in writing.

COMMITTEE.

9. No committee shall incur any financial liability, or in any way commit the Board to any responsibility whatever, without express and specific authority conferred by the By-laws or by a resolution of the Board.

FINANCE ACCOUNTS.

10. All accounts, bills, and vouchers shall be submitted to the Board by the Chairman at the ordinary meetings on the prescribed form, and after being certified correct shall be so initialled by him and paid by cheque.

11. The Chairman and one member, or, in the absence of the Chairman, any two members, may, in case of urgency, authorise the expenditure of a sum not exceeding five pounds, but shall in every case report the same at the next meeting of the Board.

UNAUTHORISED EXPENDITURE.

12. Every item of expenditure and every item incurred by any committee or member of the Board otherwise than under the authority of the Act or of these By-laws, shall be deemed unlawful expenditure and a breach of this By-law by such person.

OFFENCES, OMISSIONS, OR NEGLECTS.

13. Any person guilty of the following offences, omissions, or neglects shall, on conviction, pay a penalty not exceeding £10:—

- (a.) Riding or driving a horse, cattle, or other animals, or wheeling any barrow or driving any carriage upon or along any footpath.
- (b.) Placing any timber, bricks, or any other building material upon any footpath, channel, surface drain, or road without the permission of the Board having first been obtained.
- (c.) Placing an advertisement board or placard on property under the control of the Board without first having obtained the permission of the Board.
- (d.) Opening any drain or sewer, or removing the surface of any road or carriage road without the permission of the Board having first been obtained.
- (e.) Rolling any cask, breaking in any horse, flying any kite, using any bows and arrows, football, catapult, air-gun, or firearms, or playing at any game to the annoyance or damage of any person, or obstructing any road, whether by allowing any cart or animal to remain across such road or by placing goods thereon or otherwise.
- (f.) Having any awning, verandah, or blind on any road not being of the full width of nine feet and eight feet clear above the footway, or hanging any goods on or under such awning, verandah or blind over the road, or erecting any sign-board, sign-awning, blind, overhanging-lamp, or other thing over or near any road without first having obtained permission of the Board.
- (g.) Furiously or negligently riding or driving on any road.
- (h.) Blasting any rock, stone, or timber in or near any public road without permission of the Board, and not attending to any directions in regard thereto given by such Board.
- (i.) Making a cellar door or any other opening from any road without the consent of the Board.

GENERAL REGULATION OF TRAFFIC.

14. Every person having the care or conduct of any vehicle shall keep the same on the left or near side of the road, except in case of actual necessity or other sufficient reason for deviation, and shall not interrupt or interfere with any person or vehicle passing or attempting to pass his vehicle.

DUTIES OF SUPERVISOR.

15. The duties of the Supervisor shall be—

- (a.) To promptly attend to all instructions received through the Secretary or Chairman.
- (b.) To prepare proper plans and specifications for all works and improvements as regards streets, roads, bridges, buildings, or premises under control of the Board situate within the bounds of the Board's district; examine all materials to be employed in such works, and see the same faithfully and properly executed and performed; lay out such works as to height, lines, levels, and dimensions, and watch the progress and formation lest such height, lines, etc., should be altered; measure all metal before being used on any works, and measure and make returns to the Board through the Secretary for payment for all works and materials; submit all specifications and plans to the Board before tenders are called.
- (c.) To see that the work for cleansing and repairing all public streets, roads, and footways is properly carried out.
- (d.) To engage labourers and forthwith report such engagement to the chairman.
- (e.) To see that no labourers are engaged but those who are able-bodied and sober, and to immediately discharge any labourer guilty of disobedience, insubordination, or if found incapable of performing the duties allotted to him.
- (f.) To see that the time of the men engaged is personally recorded, and have the pay-sheet made out accordingly.
- (g.) To give the necessary lines and levels to persons building next to public ways, and see that there is no encroachment on public property.
- (h.) To see that all sewers, drains, culverts, and bridges are maintained in a state of efficiency.
- (i.) To see that the laws with regard to buildings within the Board's district are not infringed, and take action in the case of "dangerous buildings."
- (j.) To see that all officers under his control carry out their duties efficiently, and to report any departure therefrom.
- (k.) To attend all meetings of the Board.
- (l.) To render the Secretary, when required, reports and accounts of all matters coming under his control; to supply monthly or oftener, if required, to the Board returns of work completed or in progress, and the names of all men employed by him, with remarks thereon.
- (m.) To define from time to time duties of labourers engaged, and see that they are kept constantly at work; to see that all drains and culverts are kept clear, and, where necessary, to make provision for turning off stormwaters from roads; to see that all wells, tanks, enclosures, windmills, pumps, windlasses, buckets, ropes, troughs, etc., are kept in good working order.

REGULATION OF VEHICULAR TRAFFIC.

16. No person between sunset and the following sunrise shall, in, upon, or along any of the public roads within the district, drive any vehicle without having a lamp or lantern, securely fixed and lighted, on the off side of the front of such vehicle.

OBSTRUCTION OF ROADS.

17. (a.) Nothing of any kind whatever may be allowed to remain on any part of any road within the district after sunset, nor in any case longer than is absolutely necessary, without the permission of the Board.
- (b.) No person will be permitted to plough a firebreak within twenty feet of the centre of any road or track.
- (c.) Every person who damages the road under the Board's control by digging or otherwise removing the earth from around the bogged wheels of any vehicle shall replace the same earth.
- (d.) Any person who falls any timber on any road or track shall be liable to a penalty not exceeding £5.

PRESERVATION OF TREES, ETC.

18. No person shall injure, cut, break, deface, pull up, pick, remove, or destroy any tree, shrub, plant, etc., growing on any reserve, road, or street. In case of any offence such person, on conviction, shall forfeit the sum of £10.

THROWING DANGEROUS SUBSTANCES.

19. Any person who shall throw vegetable substances or any offensive, noxious, or dangerous substances upon any road or reserve shall be liable to remove same at own cost, and to a fine not exceeding £2 in addition to amount of any damages that may be caused thereby.

RESERVES AND RECREATION GROUNDS.

20. (a.) All reserves and recreation grounds under the control of the Board shall be open to the public daily for recreation purposes.
- (b.) Exclusive right to use and occupy any such recreation reserve for holding public sports or amusements by any responsible person or persons may be granted by the Board upon such terms and conditions, and subject to such restrictions, as the Board may impose.

PENALTIES.

21. (a.) Where any person or persons by the foregoing By-laws or any of them are required to do or perform any act or thing remains undone, the Board may cause the same to be performed, and charge the costs and expenses against such person or persons, and the amount thereof may be recovered summarily.
- (b.) Every person who does, permits, or suffers any act or thing contrary to any of these By-laws shall, on conviction, for every offence, breach, or neglect be liable to a penalty not exceeding (except when otherwise provided) the sum of £20, in addition to the amount of any damage caused by such neglect or breach of these By-laws.
- (c.) No person shall damage or destroy by means of horse, team, wagon, dray, or any other means, any road or portion of road under construction or repair.
- (d.) All penalties and other sums recovered under the provisions of these By-laws shall, unless otherwise provided, be paid to the Board, and shall become the property of and form part of the income of the District, except so much as may be payable to any informer.

LICENSE FEES.

22. All license fees due under the Act shall be paid to the Secretary not later than the last day in March in each year.
