WHEREAS by Section 23 of "The Stamp Act, 1882," as amended by Section 3 of "The Stamp Act Amendment Act, 1906," the Governor may by Regulation prescribe the fees to be paid in connection with the replacement of Duty Stamps under the 23rd Section of "The Stamp Act, 1882": AND WHEREAS it is desired to make such Regulation fixing such Fees: Now, THEREFORE, His Excellency the Governor's Deputy, by and with the advice of the Executive Council, does hereby make the following Regulations accordingly:—

1. Upon delivery of all stamped Promissory Notes or Bills of Exchange which have become damaged, spoilt, or rendered unfit for use or unnecessary, the Colonial Treasurer shall supply the applicant with a similar number of Promissory Notes or Bills of Exchange impressed with a like amount of duty, and charge therefor a fee of 1d. each, provided the said Promissory Notes or Bills of Exchange are presented at the Treasury within two months of the period when they have become damaged, spoilt, or rendered unfit for use or unnecessary.

2. Upon delivery of all stamped Cheque forms which have become damaged, spoilt, or rendered unfit for use or unnecessary, the Colonial Treasurer shall impress for the applicant a similar number of Cheque forms with the duty of 1d. each, and charge therefor 10 per cent. on the value thereof, provided the said Cheque forms are presented at the Treasury within two months of the period when they have become damaged, spoilt, or rendered unfit for use, or unnecessary.

3. Upon delivery of any other document or instrument which has become damaged, spoilt, or rendered unfit for use or unnecessary, the Colonial Treasurer shall supply the applicant with an adhesive or impressed stamp of like amount, provided the said document or instrument is presented at the Treasury within two months of the period when it has become damaged, spoilt, or rendered unfit for use, or unnecessary, and charge therefor a fee of sixpence.

REGULATIONS MADE BY THE CENTRAL BOARD OF HEALTH.

Under Subsection 111, Section 9, of "The Health Act Amendment Act, 1902."

1. The occupier of any house, premises, or place wherein there is any infectious or contagious disease shall notify forthwith the presence of such disease to the secretary of the Local Board of Health of the district, and if there be no local Board of Health, then to the secretary of the Central Board of Health, and the legally qualified medical practitioner in attendance on any case of bubonic plague or smallpox shall immediately notify such case to the Central and Local Board.

2. The medical officer of, and such inspectors or other officers as may be authorised by, any local board or by the Central Board may, for the purpose of carrying out these Regulations, at all times enter all houses, buildings, and premises and make such investigations or inquiries as may be necessary for the purpose of ascertaining the presence therein or the source of any infectious or contagious disease.

3. All streets and public ways and places shall be day by day, or as the Central Board may otherwise direct, kept effectually cleansed by those entrusted by law with the care and arrangement thereof, or by the owners or occupiers of the houses and tenements adjoining thereto.

4. For the purpose of cleansing, purifying, ventilating, and disinfecting houses, schools, churches, buildings, and places of assembly or entertainment, and other buildings and premises, the owner, occupier, or person having the care or ordering thereof shall comply with all orders made by the Local Board of the District, or by the Central Board, or of one of its officers, and if such owner, occupier, or person as aforesaid shall neglect or refuse to carry out any such order within the time limited therein, then the Medical Officer or other officer of such Board, or of the Central Board, may so cleanse, purify, ventilate, and disinfect such buildings, places and premises, at the expense of the owner, occupier, or the person having the care and ordering thereof, and such expenses shall be recoverable by each Local Board, or the Central Board, from such owner, occupier, or person in any Court of competent jurisdiction, and such owner, occupier, or person making default as aforesaid shall be prosecuted for contravening this Regulation.

5. All goods and chattels deemed to be infected, and all nightsoil and all faecal or other discharges of persons suffering from any infectious or contagious disease, shall (when ordered by the Central Board) be destroyed, and if not so ordered to be destroyed shall be completely and thoroughly disinfected, and for this purpose every Inspector of the Central Board, or of any Local Board, shall carry out such directions for such disinfection or destruction as may from time to time be made by the Central Board.

6. A daily house-to-house visitation and inspection shall be made by the Local Board of Health or its officers of all houses, warehouses, granaries, stores, stables, and other buildings and premises in any district or part of a district which the Central Board may deem expedient.

7. All persons suffering from bubonic plague or smallpox shall, unless otherwise directed by the Central Board, be removed immediately to a special isolated place set apart for that purpose and approved by the Central Board, and shall be kept in such place until they are free from all infection and contagion.

8. No person shall quit or enter any house, premises, place, town, or district, which may be declared by the Central Board to be infected; and any person attempting to quit or enter such house, premises, place, town, or district without the permission of the Central Board shall be prosecuted for so doing.

9. For the prevention of the spread of bubonic plague and smallpox, the Central Board may, from time to time, declare any house, premises, town or district, to be infected.

10. The body of any person who shall die of bubonic plague shall not be buried in any cemetery, but shall be cremated as soon as possible after death, under the direction of an officer appointed for the purpose by the Central Board, and after such cremation the ashes of the body may be buried in the usual way.

11. No room in any common or other lodging house, workroom, factory, or other such building shall be occupied or suffered or permitted to be occupied by any person, unless such room is ventilated to the satisfaction of the Central Board, or unless such room contains the proportion of at least 500 cubic feet of air space, and not less than 50 square feet of floor area for each person in such occupation.

12. (a.) The Central Board may from time to time, by notice in writing, require the owners or occupiers of any house or premises within a district or part of a district declared to be infected, to provide in connection with any such house or premises, and within a time to be stated in the said notice, such privies as may be considered necessary, located, constructed, fitted, and equipped in accordance with the directions accompanying such notice.

(b.) And may also, by notice in writing, and within the time specified therein, require such owners or occupiers as aforesaid to alter the position of, refit, equip, or cleanse any existing privy appurtenant to any such house or premises, in such manner as may in each case be directed in the said notice.

(c.) The Central Board may also, by notice in writing, direct the Local Board of any district or part of a district declared to be infected to provide public latrines, located, constructed, fitted, and equipped in such manner as may be directed, and within the time limited by the said notice.

13. In the event of any nuisance existing in or on any house or land, any officer of the Central or Local Board may notify, in writing, the owners or occupiers thereof to abate such nuisance forthwith, and to execute such works and do such things as may be deemed necessary to prevent a recurrence of such nuisance within the time and in the manner stated in such notice.

14. For the purpose of preventing the breaking out or spread of bubonic plague, the owners and occupiers of all houses and premises shall deposit all refuse in metal bins of approved construction or other approved receptacles, and shall keep all such receptacles covered and secured with approved tight-fitting metal covers so as not to admit of rats or flies having access to the contents, and shall maintain all such receptacles in a cleanly condition.

15. (a.) The owners and occupiers of all houses, warehouses, granaries, produce or other stores, shops, factories, breweries, stables, byres, and other buildings and premises shall destroy all rats or mice therein, and such methods for such destruction shall be used as may from time to time be directed or approved by any inspector of the Central Board.

(b.) The owners and occupiers as aforesaid wherein or whereon any rat or mouse infected with bubonic plague is found shall take every precaution against the spreading of such disease, and for this purpose shall, when so ordered by any officer of the Central Board, cleanse, purify, ventilate, and disinfect such premises as aforesaid in such manner as shall be directed by such officer, and shall destroy all rats and mice therein. If such order be not carried out within the time limited to the satisfaction of the Central Board, then the said Board may declare the premises to be infected.

16. The owners or occupiers of any such premises as aforesaid, which is in such a condition as to permit the access of rats thereto, or the harbourage of rats therein, and whether such condition be in the structure, or in the openings, or in the doors or ways of entrance thereto, or in its floors, skirtings, ceilings, partitions, or internal fittings, shall, if so required by notice in writing of the Central Board, cause such building within the time limited by the said notice to be so repaired or altered as to prevent, as far as practicable, access of rats to or harbourage of rats in it.

17. The owner or occupier of any stable, cow-byre, cattle shed or stockyard, or shoeing forge shall provide an approved impervious bin for the reception of all dung or refuse arising in such premises, and shall cause such stable, cow-byre, cattle shed or stockyard, or shoeing forge to be cleansed daily, and all dung or other refuse deposited upon such premises to be collected daily, or as may be directed by an inspector, and placed in the said bin, and he shall not allow the said bin to remain uncovered or to be overfilled.

18. (a.) The owner or occupier of any premises shall cause all underground drains therein to be made and maintained in a thoroughly rat-proof condition, and to be cleansed and disinfected, from time to time, or whenever so required by any inspector of the Local or of the Central Board.

(b.) The occupier of any such premises as aforesaid shall, upon production of the notice served upon the owners as aforesaid, allow the owner and his workman free access to such premises, for the purpose of enabling compliance with any notice or order so made.

19. The owner or occupier of any such premises as aforesaid whereof the floors or any other portion of any structure forming part of such premises, are of such materials, or so constructed, or in such a state, as to permit the harbouring of rats in or about such premises, shall after service upon him of an order signed by the Secretary of the Central Board and within the time limited by such an order, cause such floors, or such other portions of any structure as aforesaid to be reconstructed of such materials and in such a manner as the said order may direct.

20. The owner or occupier of any stable, cowbyre, cattle-shed or stockyard, shall cause the same to be paved and drained with such materials, and in such a manner, and within such time, as the Central Board may, by notice in writing, direct.

21. All owners or occupiers of premises licensed under "The Wines, Beer and Spirits Sale Act" and of all boarding houses, restaurants, dining rooms, tea rooms, bakeries, butchers' shops, fruit shops, confectioners' shops, oyster saloon and other premises, and of theatres, music halls or other public buildings, shall cause such premises to be daily cleansed, and shall also employ such methods, and adopt such measures for the extermination of vermin, as the Central Board may from time to time, by notice in writing, direct.

22. Any Local Board having jurisdiction over any area or premises declared to be infected shall, if the Central Board so directs, establish within such areas or for such premises, special night-soil removal or rubbish removal services, of such frequency, and in such manner as the Central Board may from time to time direct.

23. For the purpose of preventing the spread of bubonic plague or smallpox, all persons occupying, using, or employed in the same house, shop, factory, warehouse, premises, or place as any person suffering from or having suffered from bubonic plague or smallpox, and all other persons deemed by the Central Board, or the Medical Officer thereof, or the Officer of Health, to have been liable to infection therefrom, or from any other cause whatever, unless decided to be unnecessary by the Central Board, shall be removed to an isolated place approved by the Central Board for that purpose, and shall remain in quarantine for such period as the Central Board may direct.

24. Complete precautions shall be taken to prevent rats coming ashore from all ships in any port of Western Australia, coming from or having touched at any port where bubonic plague is known or is suspected to exist, for which purpose the following shall be carried out:—

- (a.) Every rope by which every such vessel shall be made fast to any wharf or pier shall be provided with two metal funnels of approved pattern and dimensions, one being fixed at the shore end, and the other at the ship end of such rope.
- (b.) There shall be suspended at night over the side along the wharf or pier four sets, or more if required, of electric or other suitable lights, so distributed as to furnish complete illumination fore and aft along the whole length of the side of the vessel, when so ordered by an inspector.
- (c.) The owner, agent, or master of every such vessel shall take all practicable measures to prevent the passage of rats between the ship and the wharf or pier.
- (d.) All pipes, ports, and other holes in the side of the vessel next to the wharf or pier shall be completely closed, and kept closed so long as the vessel is alongside, in order to prevent ingress or egress of rats.

(e.) No lighter shall be allowed alongside any such vessel unless special permission is given by an inspector or other authorised officer of the Central Board.

25. The bodies of all rats taken alive or dead shall be destroyed by fire.

26. The master of every ship arriving at any port in Western Australia from any place or country where bubonic plague is known, or suspected to exist, or having touched at or received cargo from such place or country, shall destroy the rats in such ship, and shall use such methods for this purpose as may be directed from time to time by the Central Board.

27. All cargo from all ships mentioned in the last preceding Regulation shall be disinfected or dealt with at such port in such manner as the Medical Officer may deem necessary, and all cargo consigned to Perth shall be dealt with at Fremantle in the same manner as cargo consigned to that Port: Provided always, that all packages suspected to be infected or liable to harbour rats or carry infection shall be opened, and, if deemed necessary, disinfected or destroyed.

28. No vessel or ship conveying goods of any description from the Port of Fremantle shall be allowed to come alongside of any wharf or landing at or adjacent to the City of Perth, or discharge any goods or cargo from such vessel or ship unless permission is given by the Inspector or other authorised officer of the Central Board of Health.

29. Before removing cargo from such vessels or ships mentioned in Regulations 24, 25, and 26—

- (a.) Every package shall be separately examined and passed by an Inspector or other authorised officer of the Central Board before being slung.
- (b.) Every package not passed on such inspection shall be dealt with in such manner as the Inspector or other authorised officer (subject to the instructions of the Central Board) may direct.
- (c.) No package whatsoever shall be landed from such ship or vessel without the consent of the Inspector or other authorised Officer, nor until so inspected, and passed or otherwise dealt with.
- (d.) Paragraphs (a) and (b) of this Regulation shall, when so directed by the Central Board, also apply to articles leaving any port or place in which Bubonic Plague exists in man or animals.

30. No cargo shall be discharged from any ship or vessel before 7 a.m. or after 6 p.m., except by permission of the Central Board.

31. All ships arriving at any port in Western Australia coming from or having touched at any port where bubonic plague is known or is suspected to exist, are subject to the provisions contained in these Regulations, and the owners, agents, and masters thereof are hereby held responsible for the whole of the Regulations being strictly carried out, and such owners, agents, and masters shall be subject to all penalties for default under "The Health Act, 1898."

32. The following articles are deemed by the Central Board liable to be infected, and shall not be landed at any port in Western Australia from any place where bubonic plague is known or suspected to exist, or from any ship which may have touched at or received cargo from such place; that is to say:—

Green hides, untanned skins, fresh skins, and bones, whether whole, crushed, or in the form of bonedust, except such bones or bonedust as have been prepared and treated in the manner approved by the Central Board, and disinfected in such manner as may be prescribed in each case by the Central Board.

33. The introduction of raw bones, bonedust, or bonemeal from all places where anthrax is known or suspected to exist, is hereby prohibited, except such raw bones, bonedust, or bonemeal are accompanied by a certificate from the Government of the State or country from which they are imported declaring that they have been subjected to an indicated steam pressure of 20lbs. to the square inch for a period of not less than two hours.

The Central Board hereby authorises, requires, and directs all Local Boards and their officers to superintend and see to the execution of these Regulations.
