## THE JETTIES REGULATION ACT, 1878.

5309/09.

HIS Excellency the Governor in Council has been pleased to approve the following Regulations and Schedule of Wharfage Rates, Berthage Dues, and Handling and Haulage Charges for Point Sampson and Cossack Jetties, in connection with Roebourne Tramway; to come into force on the 15th day of December, 1909.

Under Secretary.*Berthing Dues, etc.*

1. All vessels using the Jetty shall pay berthing dues at the following rates, namely:—

For vessels exceeding 200 tons register, 1d. per ton on all cargo landed or shipped; minimum, 10s.

All vessels not exceeding 200 tons register, 1d. per ton on all cargo landed or shipped; minimum, 2s. 6d.

All lighters, 1d. per ton on all cargo landed or shipped; minimum 2s. 6d.

*Computation of Berthing Dues.*

2. In the computation of berthing dues for cargo-carrying vessels, the Wharfinger shall have the option of proceeding on a weight basis of 2,000 or 2,240lb. to the ton (according to trade usage), or a measurement basis of 40 cubic feet to the ton, for the cargo in respect of which such dues are levied, except as follows:—

Hardwood timber, at 33cwt. per load of 50 cubic feet.

1 bullock, cow, steer, heifer, or such-like animals, 1 ton.

3 calves or foals, 1 ton.

15 sheep, pigs, goats, or such-like, 1 ton.

Caneware—Chairs, 8 to the ton.

Tables, 8 to the ton.

Lounges, 4 to the ton.

Articles, n.o.c., 8 to the ton.

Hides (Raw), loose, 24 to the ton.

Hides (Raw), in bags, 8 bags to the ton.

Skins, in bales, 5 bales to the ton.

Skins, in bundles, 10 bundles to the ton.

Vessels after having discharged or taken in their cargo shall remove to any berth or anchorage pointed out by the Wharfinger or Officer-in-charge.

All vessels lying alongside the jetty and transshipping cargo to or from lighters or other vessels shall pay the like berthing dues in respect thereof as if the said cargo had been landed on or taken off the jetties in place of being taken from or placed in such lighters or vessels as aforesaid.

Goods for transshipment not trucked to be charged jetty rates one way, those trucked full rates. Wharfinger not responsible for goods stacked on jetty.

*Payment of Wharfage Dues, etc.*

3. All wharfage dues and handling or other charges incurred, payable in respect of cargo discharged or shipped, shall become payable to the Wharfinger on the discharge or shipment of the said cargo, and shall be paid to the Wharfinger on demand, and each bill of lading as shown on the manifest must be cleared by one payment. No inward cargo shall be delivered to the consignee or owner thereof, nor outward cargo to the vessel in which it is intended that same shall be shipped, until the written receipt of the Wharfinger shall have been presented to the consignee or owner, or to the shipper or master, of the vessel respectively, for the payment of all wharfage dues and charges as aforesaid in respect of such cargo; provided always, that it shall be competent, but not compulsory (in the case of outward cargo), for the Wharfinger to accept from the agent or the master a guarantee, in writing, that such dues shall be paid to him within 24 hours of the clearance of the vessel. Cargo passed overside into lighters and taken delivery of direct from ship or *vice versa*, where the Wharfinger does not receive, handle, or deliver same (always at Wharfinger's option), half schedule rates.

*Schedule of Wharfage Dues, Handling and Haulage Charges.*

4. All goods landed from or shipped into any ship shall pay wharfage dues and handling and haulage charges as under (excepting goods on which full inward wharfage dues have once been paid at any other port within the State, which goods shall pay handling and haulage charges only). Such wharfage dues, handling and haulage charges, except where otherwise provided, shall be levied on ship's measurement or weight, at the option of the Wharfinger or Officer-in-charge:—

Haulage on all goods to Customs Bond Store, Cossack, at 2s. per ton; minimum 6d.

*Roebourne or Point Sampson to Cossack Tramway.*

Passenger fares to or from Roebourne or Point Sampson to Cossack—Single, 2s. 6d.; return, 4s. Children under 12 free at discretion of Manager of Tramway.

*Notes.*—Cargo transhipped from one vessel to another for conveyance to destination or temporarily shall pay wharfage 1s. per ton. Live stock landed on beach, and not handled by Wharfinger, shall pay wharfage dues only.

*Definition of "Haulage Charges."*—Haulage charges on inwards cargo shall, except where otherwise specifically provided, include receiving from ship's slings, tallying (which tallying shall be done in conjunction with and in the presence of any tallying which may be done by the ship), and delivering to the tail or side of vehicle, but not loading the vehicle. Inwards cargo shall not, for any purpose whatever, be deemed to be in the custody of the Wharfinger until the sling is released from the ship's crane or hoisting hook, or deposited on the wharf or conveyance provided by the Wharfinger to receive the same.

Outwards cargo shall be deemed to be in the custody of the ship when the ship's crane or hoisting hook is inserted in the sling.

*Inwards Manifests to be supplied and certified to.*

5. The master of every vessel arriving shall deliver at the office of the Wharfinger, prior to commencing to discharge cargo, a true, legible, and complete copy of the manifest of the said vessel, certified to by himself as being true and complete, and shall also furnish, within 48 hours, a certified statement of all alterations (if any) which may be made in such manifest by reason of measurement of goods included therein or otherwise.

*Outward Manifests, etc.*

6. The master of every vessel shall deliver at the office of the Wharfinger prior to the clearance of the ship in which outward cargo is shipped, a certified copy of manifest giving true, legible, and complete particulars of such goods as will enable the amount of outward wharfage dues payable thereon to be readily computed.

7. No person shall enter on any wharf with goods for shipment without first delivering to the Wharfinger an outward cargo advice note as required by the Department, containing a full and true account, with gross measurements or weights of such goods then under his immediate control.

8. All outward cargo must be delivered into the shed at least not less than four working hours prior to ship's advertised time of sailing.

9. No goods shall be landed or placed on any jetties without the written authority of the Wharfinger or Officer-in-charge. Cargo discharged without such authority having been first obtained shall not be deemed to be in the custody of the Department, nor shall the Department be held responsible for any loss or damage that may accrue to any such cargo from any cause whatever.

10. If it appear that goods are being landed and cannot, in the opinion of the Wharfinger or the Officer-in-charge, be removed in time to prevent a "block," the Wharfinger or Officer-in-charge may give notice, in writing, to the masters or persons in charge of vessels or lighters from which goods are being discharged to stop discharging cargo, and upon such notice being given, no further cargo shall be discharged until such time as the Wharfinger or Officer-in-charge may direct.

*Receipts, etc., for Inward Cargo.*

11. If during the progress of discharge of cargo doubt shall be expressed by the Wharfinger as to the condition of any package or packages, such package or packages shall be placed in a situation apart from other cargo, pending examination, and the Department's tally and receipt for such package or packages shall be that of a doubtful or damaged package, as circumstances or appearances dictate. Such packages shall be opened and examined by the consignee, but only in the presence of the Wharfinger and ship's agent, as soon as is possible after being landed. The Department will, under no pretence whatsoever, be held responsible for the safe custody or the condition of such package or packages, or of it or their contents.

12. In the event of the ship, by its agent, refusing to accept a receipt as indicated for such cargo, such cargo must immediately be returned on board by the ship, and shall not be again landed until it has been examined by the consignee, who shall take delivery direct from the ship.

*Responsibility of the Department.*

13. No goods for which receipts have not been given by the Department shall be deemed, for any purpose, to be in the custody of the Department as Wharfingers, nor shall the Department be responsible for the safe custody, or for any loss or damage that may accrue to same, in any manner whatsoever.

*Goods to be checked before Delivery.*

14. No person shall remove any goods or luggage from any wharf or shed without first satisfying the Wharfinger or Officer-in-charge of his right to do so; and shall, before removing same, sign for such goods or luggage to the Wharfinger or Officer-in-charge.

*Delay in Delivery of Goods.*

15. The Department will not be responsible for any claim arising from the delay in the delivery or goods from any cause whatsoever.

*Wrong Delivery.*

16. The Department will not be responsible for the wrong or non-delivery of the goods which are erroneously or deficiently marked, or which have numerous old or imperfectly erased marks thereon.

*Goods not to be removed.*

17. No person shall remove from one vessel to another, or from any part of the wharf to any other part thereof, any goods or luggage without the authority of the Wharfinger first had and obtained.

*Goods not to be Handled in Wet Weather.*

18. No goods shall be landed or shipped in wet weather without the permission, in writing, of the Wharfinger at the request of the master or agent of the discharging or loading vessel; but the giving of such permission shall not throw on the Department any liability for damage to such goods caused by being so landed or shipped or handled in wet weather. The determination of the Wharfinger that the weather is wet shall be conclusive.

*Responsibility in case of Fire, etc.*

19. The Department shall not be responsible for loss or damage to goods while in their custody, by fire, water used in extinguishing fire, or vermin.

*Extra Charges.*

20. The Wharfinger may make extra charges for handling packages over one ton in weight, or of an exceptional shape, or where extra labour is required or unusual risk is involved.

*Cargo Deposited on Wharf.*

21. No ballast, stone, coal, coke, timber, sand, or other goods or material in bulk shall be deposited on any wharf or jetty without special permission, in writing, of the Wharfinger or Officer-in-charge.

*Department not bound to find storage accommodation.*

22. The Department shall not be bound to find storage room for any goods, either in any shed or on any wharf. After notification to the owners, shippers, or consignees of any goods, or to the vessel's agent, that room is not available for the storage of such goods within a shed, or that such goods are, owing to their character, not permitted by some other authority other than the Department to be stored in a shed, the Department shall not be held responsible for any loss or damage that may accrue to the goods, by the elements or otherwise, during the time they remain on the Department's premises.

*Goods to be removed or may be sold.*

23. All goods landed on any wharf shall be removed therefrom or placed in a shed within seven days after being landed. The Wharfinger is empowered to take charge of and store cargo and goods if not removed from any wharf or shed by the consignee within the time or respective times limited for that purpose, or to cause the same to be conveyed to King's Warehouse or delivered to the consignee at his expense and risk, or to remove the same to any of the premises of the Department or other convenient place, or to keep the same until payment to the Department of the expenses of such removal and of the keeping of the goods, and of all other charges due to the Department thereupon; and, in default of payment, on behalf of the Department to sue for same.

*Storage Rates for Goods.*

24. Should any goods be not removed from any wharf or jetty or sheds thereon within seven days, there shall (subject to as hereinafter mentioned) be payable to the Wharfinger, as and by way of storage rent in respect thereof, the sum of one shilling (1s.) per ton for the first week, and for every subsequent week the sum of threepence (3d.) per ton additional to the amount per ton payable for each immediately preceding week, *i.e.*, one shilling and threepence (1s. 3d.) per ton for the second week, and one shilling and sixpence (1s. 6d.) per ton for the third week, and so on. For the purpose of this regulation a fraction of a ton shall be deemed to be a ton, and a part of a week shall be reckoned as one week. Nothing herein contained shall prevent the Wharfinger from removing or ordering the removal, as provided for in these Regulations, of any such goods at any time after the time hereinbefore appointed for their removal.

*Limit of Storage.*

25. No goods shall be allowed to remain in any shed or upon any wharf for a longer period than four weeks. If any goods so remain without the consent of the Department, the Wharfinger may remove same to King's Warehouse (in the case of goods liable for Customs duty) or to any of the premises of the Department or other convenient place, and retain the same. The charge to be made for such removal only to any premises of the Department shall be two shillings (2s.) per ton, and the charge for storage on such goods after removal shall continue to be at the same rate as applies to goods left in wharf sheds beyond the specified free storage period.

*Claims in respect of Cargo.*

26. No claim will be entertained by the Department in respect of goods landed, or alleged to be landed, unless claim has been received by the Wharfinger, in writing, before the vessel (in case of sailing vessels) leaves the Harbour, or in case of steamers, within four days of the steamer leaving the port, nor in respect of outward goods unless received by the Wharfinger within twenty-four (24) hours after the vessel in which it was intended to ship such goods leaves the port. Each claim must be rendered on the form recognised by the Department, which form will be supplied on application.

*Working Hours.*

27. The working hours of the port shall be and include the hours from 8 a.m. till 12 noon, and from 1 p.m. till 5 p.m. on week days other than Saturdays, and on Saturdays the hours from 8 a.m. till 1 p.m.

28. The cost over and above the ordinary cost of day work, or all labour and supervision, *etc.*, employed during any hours not being working hours as above defined, or on holidays, shall be paid for by the vessel in addition to the usual charges. The extra cost of lighting shed or berth to enable a vessel to work during any hours not being working hours, or on holidays as aforesaid, shall also be paid by the vessel.

29. A vessel desiring to work any hours not being working hours as defined above, shall give to the Wharfinger or Officer-in-charge two hours' notice, and on holidays twelve hours' notice of her desire to do so.

*Penalties.*

30. When any person or persons, by the foregoing Regulations, or any of them, are required to do or perform any act or thing, and such act or thing remains undone, the Harbour Master or his representative may cause the same to be performed, and charge the cost and expense against such person or persons, and the amount thereof may be recovered summarily.

31. Every person who does, permits, or suffers any act or thing contrary to any of these Regulations shall, on conviction, for every offence, breach, or neglect, be liable to a penalty not exceeding (except where otherwise provided) the sum of £20 (42 Viet., No. 18).

## GUILDFORD MUNICIPALITY.

*Building By-laws.*

To regulate Buildings, Alterations, Additions, *etc.*, within the Guildford Municipality.

IN pursuance of the powers in that behalf contained in "The Municipal Corporations Act, 1906," the Council of the Guildford Municipality doth hereby make the following By-laws:—

*Repeal.*

1. All By-laws heretofore made by the Council of the Guildford Municipality, with reference to the matters hereinafter contained, are hereby repealed.

*Interpretation Clause.**Interpretation.*

2. The several words mentioned in the interpretation sections of "The Municipal Corporations Act, 1906," shall, where used in these By-laws, have the same meaning as is attached to such words by the said sections.

*Building.*

(a.) The expression "building" shall mean any structure which in enclosed, having door or window, roofed and floored.

*External Walls.*

(b.) The expression "external walls" shall mean the outer walls when under main roof, or the outside wall of a habitable room, or the outer wall of the main building.

*Floor area.*

(c.) The expression "floor area" applied to a building shall mean the aggregate superficial areas of so many horizontal sections thereof as there are floors in the said building. The horizontal section of each floor shall be made at the point of its greatest surface dimensions, inclusive of external walls and of such portions of the party walls as belong to the building, and also of all verandah and balcony floors, covered ways, and light courts.

*Squares.*

(d.) The expression "square" applied to the measurement of the area of a building shall mean the space of one (100) hundred superficial feet.

*Domestic buildings.*

(e.) The expression "domestic buildings" includes a dwelling house, suite of offices, and any other building not being public building or building of the warehouse class, or a building the property of or occupied by or under the control or management of His Majesty's Government or any department thereof.

*Inhabited rooms.*

(f.) The expression "inhabited" applied to a room shall mean a room in which some person passes the night, or which is used as a living room, including a room with respect to which there is a probable presumption (until the contrary is shown) that some person passes the night therein, or that it is used as a living room.

*Application for building license.*

3. Every person intending to commence to build, take down, alter, add to, or repair any building, whether partially destroyed by fire or otherwise, or to do any act whereby any public street may be obstructed or rendered dangerous or inconvenient to persons passing over or near thereto, shall give three clear days' notice, in writing, to the Building Committee of his intention so to do, and shall deposit with such notice complete drawings and specifications of the proposed works, and also a plan of the locality showing the position of such buildings, and their relative positions to each other.

Such notice shall be delivered at the Council office, and shall contain particulars of the site and nature of the intended building, work, or other act.

*Tracings.*

A plan or a tracing of the ground plan of all buildings, showing the size of all rooms, and the covered floor area of such buildings, and the relative positions of all outbuildings shall be deposited with the Town Clerk to remain permanently in his custody.

The Building Committee, provided the license fee and the deposit as hereafter provided have been paid to it, shall forthwith grant a license in the Form "A" of the Schedule hereto, and also give such directions as it shall think fit for the erection of hoardings or fences, and platforms and handrail, for the protection of passengers; and such directions shall be complied with to the satisfaction of the Building Committee before the commencement of such building, work, or act. In the event of the plans being incomplete or incorrect, they must be re-submitted for approval, after the alterations have been properly effected.

Every breach of this By-law shall subject the person guilty of such breach to a fine or penalty of not exceeding £5, and a further penalty of not exceeding £1 for each day the same continues, recoverable in a summary manner before Justices.

*Deposit of materials in streets.*

4. Every person wishing to deposit any stone, brick, lime, rubbish, timber, iron, or other materials on any public street, or to make any excavation on any land abutting on, or adjoining, or contiguous to any public street, shall first make application for and obtain from the Town Clerk a license so to do.

Such license shall be given in the Form "A" in the Schedule hereto, specifying the time for which the same, when so erected and set up, may be continued; also the conditions to be observed by licensee, and giving such other directions as the Town Clerk may think necessary.

Any infringement of this By-law shall subject the person guilty of such infringement to a fine of £5 for every day such infringement continues, to be recovered in a summary manner before Justices.

*Hoardings.*

5. Every person who shall be required to erect any hoarding, fence, platform, or handrail under the last two preceding clauses, shall keep the same in good and sufficient repair to the satisfaction of the Building Committee, so long as it shall, in its opinion, be necessary for the public safety; and every such person shall, immediately upon receipt of notice from the Town Clerk that such hoarding, fence, platform, or handrail is out of

repair, and requiring him to repair the same, forthwith repair the same to the satisfaction of the Building Committee, and shall be liable to a penalty of £1 for every day the same shall continue in disrepair after the receipt by him of such notice.

Every person erecting such hoarding, fence, platform, or handrail, or obstruction of any kind in any public street, or any excavation as aforesaid, shall cause the same to be well and sufficiently lighted at night, all in accordance with the direction and to the satisfaction of every the Inspector, and shall be liable to a penalty of £1 for every night or part of a night on which the same is not so lighted.

*Power to enforce preceding By-laws.*

6. It shall be lawful for the Building Committee, without reference to the Council, to take immediate steps to enforce any of the preceding regulations, and it may cause any such hoarding or other obstruction that has been erected without a license, or which has been erected or continued in breach of the conditions of any such license, to be removed, or any such excavations to be filled in, or injuries to the public street repaired, at the cost and expense of the person erecting or making the same; and such costs and expenses shall be recoverable from the person so making the same, as well as the penalties hereinbefore imposed, before Justices.

*External walls.*

7. With regard to the component materials of any external walls within 15ft. of any street, every such wall must be built of brick or stone, or artificial stone together laid in, and with mortar or cement in such manner as to produce solid work, unless the special permission of the Building Committee shall be first had and obtained.

*Materials in repairs.*

8. If any external wall or enclosure be at any time hereafter taken down or otherwise demolished, for the height of one storey or for a space equal to one-fourth of the whole surface of such external wall, then every part thereof not built in the manner of the several materials by these regulations directed for external walls must be taken down; and the same must be re-built in such manner and of such materials for and in all respects as by this By-law directed for external walls hereinafter to be built according to the class and rate of the building to which such external walls or enclosure shall belong.

*Mutual or party walls.*

9. Mutual or party walls.—In reference to the component material thereof, every part of all such walls must be built of sound bricks, or stone, or artificial stone, or such bricks, or stone, or artificial stone laid in together, and with mortar or cement, and in such a manner as to produce solid work, and as to the woodwork which it may be desired to connect with the party walls of any building, the bearing ends of wooden beams, bresssummers, girders, trimming joists, and the ends of partitions, heads and sills, and the bearing ends of the main timbers of any roof, and the wood bricks may be laid into any substance of a party wall; but no such beams, bresssummers, girders, partitions, head or sill, nor any part of a roof being wood, nor any wood bricks, must be laid or placed within two inches of the centre of any party wall; and no other woodwork of any kind must be laid into, placed upon, or be run or driven into any part of the substance of any party wall; but if the ends of the timber be carried in iron shoes or stone corbels, then such iron shoes or stone corbels must be built into the wall at least one-half the thickness of such wall; and the top of every such party wall must be carried to a height of at least one foot three inches above where the party wall and the roof adjoin with sound, hard bricks, or stone, set in good mortar or cement, and finished with a suitable coping.

*Damp courses.*

10. All brick or stone walls of buildings to have a damp course composed of materials impervious to moisture, extending throughout the whole thickness at the level of the lowest floor above ground level.

*Roofs.*

11. With regard to the roof, flat, and gutter of any building and any projection therefrom, and also balconies, verandahs, and shop fronts, they must be so arranged and constructed and so supplied with gutters and pipes as to prevent the water therefrom dripping on to or running over any public way, and all such rain pipe, eaves, and gutters are to be made of metal.

All iron pipes shall lead if so required from the front of the building under the footpath into the street-side channel; provided always that the pipe laid across the footway shall be at least six inches below the surface and be of jarrah, cast or wrought iron piping, of four inches diameter, or in glazed earthenware, securely bedded, all as directed by the Building Committee.

*Drains.*

12. With regard to the drains of buildings of any class, and of every addition thereto, before the several walls of any such buildings shall have been built to a height of ten feet from their foundation, the drains therefor must have been properly built and made good—that is to say, if there be within 100 feet from any front of the building a common sewer into which it is lawful and practicable to drain, then into such common sewer, and if there be not in such situation and within such distance any such common sewer, then to the best outlet that can be obtained, so as to render in either case drains available for the drainage of the lowest floor of such building or addition thereto, and also of its areas, privies, and offices; and every such drain must be laid to a sufficient fall or current, so as that the whole of every such drain within the walls of such building shall be wholly carried over under the lowest floor, independently thereof, and every such drain within the walls of such building must be constructed of sound laid bricks of the best quality, laid wholly in cement mortar, or of the best quality of glazed stoneware drain-pipes, jointed in cement, and not less than four inches internal diameter, so as to render the drain air-tight; all drains to be laid and built to the approval of the Building Committee.

Proper plans of such proposed drainage shall be submitted for the approval of the Building Committee; such plans showing the sizes of pipes, gradients, ventilating pipes, inspection chambers, etc., and the same must in every case be approved of in writing by the Building Committee before the work or any part of the same is proceeded with.

Drains passing through or under any dwelling, shop, or other tenement must be constructed in heavy cast iron u.g. pipes or earthenware pipes enclosed in concrete, and all drains must be disconnected from the sewer or other outlet:

*Covering footpaths, scaffoldings, etc.*

13. In the case of any building being erected abutting on the footpath of a public street, or of any plastering operations being intended to be performed above the first storey of any building, the builder or other person having charge of such buildings, or the plasterer, shall, before proceeding to build further than the first storey of such building so being erected, or with any plastering as aforesaid, give notice thereof, in writing, to the Town Clerk, who shall thereupon give directions to such builder, person, or plasterer, for the covering of such footpath as he shall think fit, and any builder, person, or plasterer who shall fail to give such notice, or shall proceed with such building or plastering without having complied in all respects with the directions of the Building Committee, or without keeping such scaffolding, covering, or other erection directed by him in efficient state of repair to the satisfaction of the Building Committee, shall incur a penalty of £5 for each day in which such default shall occur or continue.

If, in the Building Committee's opinion, any scaffolding is unsafe or insufficient, it may direct that the same shall be strengthened, altered, and made secure to its entire satisfaction.

*Back yards.*

14. With regard to back yards or open spaces attached to dwelling houses, every house hereafter built or re-built must have an enclosed back yard or open space, exclusive of any building thereon, unless all the rooms of such house can be lighted and ventilated from the street.

*Privies.*

15. Every privy hereafter to be built must have a door and be properly enclosed, screened, and fenced from public view, and every house or other building hereafter to be erected shall have attached to it a privy of the following construction to the satisfaction of the Building Committee:—The size above the floor internally not to be less than 3ft. 9in. by 4ft. 6in., and not less than 6ft. 6in. high, in clear height on the lowest side. It must also be sufficiently ventilated; the walls to be constructed of 4½in. brickwork, lime-washed or plastered, jarrah or galvanised corrugated iron, and not to be erected closer than 3ft. to the boundary of the adjoining allotment nor nearer than 20ft. to any business place or dwelling, unless with the express permission of the Building Committee, and all must have proper supervision for the removal and replacing of pans. The pan must be the regulation pattern, and a metal tray at least two inches deep, with sufficient flushing apertures, must be fitted behind the riser for its reception, or it may be composed of concrete, slate, or some non-absorbent material, having a proper fall towards the door.

*Height of rooms.*

16. With regard to rooms in other parts of the buildings, in reference to the height thereof, every room used or intended to be used for the purpose of habitation must be at the least 10ft., and lean-to roofs to average at least 9ft., from floor to ceiling, and no sleeping room shall have a cubical area of less than 500ft. for each person.

*Ventilation.*

17. Every room used for the purpose of habitation, or for the assemblage of people for any purpose whatever, shall be well and properly ventilated, to the satisfaction of the Building Committee, by the insertion of airbricks below the floor, and by openings in the sleeper walls, also by ventilators in the ceilings or at the top of the walls thereof, according to the size of such rooms.

*Verandahs.*

18. Awnings or verandahs to be erected over footpaths are to be in accordance with drawings and specifications approved by the Building Committee. There must be at least 8ft. clear headway under all parts of the superstructure, and the posts must not be less than 5in. by 5in. if in jarrah, with a minimum of 3½in. if in cast iron. The verandah to be painted and kept in repair to the satisfaction of the Building Committee, who shall have power to order such repairs to the verandahs generally as it may deem necessary. In the event of neglect, or of the Building Committee observing the necessity of removal or repair, such must be commenced within seven days of the receipt of notice from the Town Clerk, and must be completed within fourteen days from such notice, or otherwise the verandahs will be removed as nuisances; the cost of such removal to be borne by the owner or occupier, and to be recoverable from him in a summary manner before Justices.

*Signboards, signs, etc.*

19. No person shall erect, put up, or place any signboard, sign, awning, blind, overhanging lamp, or other thing, over or near any footway or roadway without first having obtained the written consent of the Council therefor. Permission to erect a signboard shall only be given where there is a verandah to which to affix such signboard, and every person who shall have obtained permission to erect a signboard shall cause the same to be securely fastened to such verandah at a height in the clear of not less than 8ft. from the footpath.

*Bressummers.*

20. All bressummers to be either of iron or approved wood, and to be loaded to one-third only of the breaking weight.

*Fire places.*

21. Every fireplace constructed of iron shall be lined with brick or stone, built up to a height of 3ft from the level of the fire rest, not less than four and a-half inches thick, and the hearth of every such fireplace or chimney must be laid and bedded wholly on brick, or stone, or must be laid and bedded wholly on brick, or stone, or of a slab or slabs of brick, tile, stone, slate, iron, or other proper and sufficient substance at least 12in. longer than the opening of the chimney when finished, and at least 14in. in front of the arch over the same.

*Dangerous buildings.*

22. When any building shall, in the opinion of the Building Committee, be ruinous or dangerous, or unfit for human use or habitation, through defects in its construction or surroundings, the Town Clerk shall give notice to the owner thereof to remove or renovate the same, and every such owner shall forthwith comply with such order, under a penalty of not more than £20 for non-compliance.

*Temporary buildings.*

23. With regard to the granting of permission for the erection of temporary buildings, special permission may be granted by the Building Committee, for a period to be stated, for the erection of temporary buildings, all the walls of which may be of wood or iron.

*Prohibiting for human habitation.*

24. No building, or any part thereof, not originally built as and for a dwelling house within the limits of the Municipality, whether built before or after the adoption of this By-law, shall be converted into or used as a dwelling house without the previous consent of the Council, who may grant such consent upon and subject to such conditions as they may see fit, or in their discretion may refuse the same.

*Man in charge.*

25. Any builder or any other person erecting any building under these By-laws shall at all times during working hours, during the progress of such work, be himself or keep a responsible man on the scene of such work to take any orders from the Building Surveyor, or Inspector, or Chairman of the Building Committee relative to such building, and the plans and specifications of such building shall at all times be thereon in the custody of such person for production to the Building Committee, and any infringement of this By-law shall subject the person guilty to a penalty of £5 for every such offence.

*Culverts.*

26. When it shall be necessary to make any crossing over a watertable in any street into any private premises, such crossing place shall be made by the Council, and shall be properly laid and channelled with wood, stone sets, or other suitable material as the Council may deem fitting, and half the cost of such making shall be borne by the owner of such premises, and shall be paid by him, and in case of any repairs being necessary to such crossing the same shall be made by the Council, and the cost of same shall be borne and paid by such owner.

*Spikes, barbed wire, etc.*

27. Iron spikes or other projections, broken glass, or barbed wire shall not be placed or fixed on any premises abutting upon a street.

*Wood and iron buildings.*

28. Wood and iron buildings, where allowed, to be not less than 5ft. from the boundary, except by express permission of the Building Committee or the Council.

*Contractor's sheds.*

29. Nothing in these By-laws shall prevent any contractor's and builder's temporary office, sheds, and workshops from being erected of wood or iron, on any building site, during building operations, provided that special application be made to, and permission be granted by, the Building Committee.

*Compulsory fencing.*

30. The Council may at any time order any part of any street boundary not already built upon to be fenced or walled as they may see fit, within three months from such notice. In such cases the fence must be constructed of iron or wood to a plan that must be submitted to and obtain the approval of the Building Committee. If walled, the construction thereof must be in accordance with the provisions of By-laws, and should the owner or occupier neglect or refuse to comply, the Council may proceed with the work after one month's written notice, subject to the provisions contained in By-laws.

*Chimneys.*

31. Every chimney shaft or flue hereafter built, raised, or repaired must be carried up in brick or stone work all around at least 4in. thick to a height of not less than 3ft. above the highest part of such portion

of the roof, flat, or gutter adjoining thereto, measured at the point of junction; and as to any chimney shaft (except that of a steam engine, brewery, distillery, or manufactory), the brick or stonework of such shaft or flue must not be built higher than 8ft. above the slope, flat, or gutter of the roof which it adjoins, measured from the highest point of junction, unless such chimney shaft shall be built of increased thickness, or be built with and bonded to another chimney shaft, or be otherwise rendered secure. And as to the chimney shaft for the boiler, furnace of any steam engine, or for any brewery, distillery, or manufactory, such shaft may be erected of any height so that it be built in such a manner and of such strength and dimensions as shall be satisfactory to the Building Committee, upon special application in each case.

And be it enacted that every owner or user of any chimney shaft of any mill, manufactory, or other similar building shall, if the Building Committee deem it necessary, construct the fireplace or furnace to such chimney shaft in such manner as effectually to consume the carbonaceous matters or gases arising from the fuel used therein, or shall affix proper and suitable apparatus to such fireplace or furnace so as to cause the same to consume such carbonaceous matters or gases as aforesaid; and any such owner or user who shall neglect or refuse to construct such fireplace or furnace in the manner hereinbefore prescribed, or who, being thereto required in writing by the Town Clerk, shall after the lapse of 10 days neglect or refuse to affix such proper and suitable apparatus to such fireplace or furnace as aforesaid, shall, on conviction thereof before any Justice of the Peace, forfeit and pay a penalty of not less than £5.

And be it enacted that if any such owner or occupier, or any fire-stoker or other person in charge of such fire-place or furnace, shall not well and properly use such fire-place or furnace or any apparatus put up or affixed to such fire-place or furnace for the purpose of causing such carbonaceous matter or gases to be consumed, or shall use the same or any of them negligently so as to permit or suffer such carbonaceous matter or gases of an opaque colour (ordinarily called smoke) to issue therefrom except for the period of 30 minutes after the commencement of lighting such fires on any day, every person so offending shall, on conviction thereof before any Justice of the Peace, be liable to a penalty of not exceeding £20.

*Chimney-pots.*

32. As to earthen or metal chimney-pots, tubes, funnels, or cowls of any description whatsoever.—If such pot, tube, funnel, or cowl be higher than 4ft. above the brick or stone work of the flue upon which the same shall be placed, then it must be fixed 2ft. at least into the brick or stone work of the flue on which it shall be placed, or otherwise fixed to the satisfaction of the Building Committee.

*Power of Building Committee to enter and remove.*

33. Generally, where anything shall have been done, or omitted to be done, in contravention to these regulations, it shall be lawful for the Building Committee, at its discretion, to enter on the premises and remove, or cause to be removed, any buildings, or other things which have been erected in contravention thereof, or to do, or cause to be done, any act or thing which should have been done in pursuance thereof, and the cost of so doing shall be borne and paid by such owner or other person, in addition to any penalties to which he may be liable in respect thereof under these regulations.

*Alignment.*

34. The building line in any street within the Municipality shall be fixed by the Building Committee, and all buildings hereafter to be erected shall be built to this line and be kept parallel thereto, and to the alignment of the street and within curtilage of the allotment.

*Building level.*

35. The level of the ground floor of any building shall not be less than 3in. above the level of the foot-path, at the boundary line, without the permission of the Building Committee.

*Bench marks, etc.*

36. All survey levels, bench marks, or other marks denoting the same shall be carefully preserved, and any person removing, obliterating, or causing or permitting the same to be removed or obliterated shall be liable to a penalty of £10, and to pay all costs incurred in replacing same.

*Mutual or parapet walls.*

37. All walls erected on the boundary of allotment must have parapet or mutual walls with copings, the walls in every case being carried up as per clause No. 9 of these By-laws.

*Cornices, etc.*

38. No cornice or other ornament shall project beyond the alignment of the street more than 18in., and must not be lower than 15ft. above the level of the pavement.

*Cellars.*

39. No cellar will be allowed under the pavement of a street, and authority for affixing prismatic or other lights on the pavements must be obtained in writing from the Building Committee before being fixed.

*Balconies.*

40. No balcony supported wholly from cantilevers, or corbelled out from the wall, will be permitted, unless specially authorised in writing by the Council.

*Bake-house floors.*

The floors of every bake-house shall be constructed of concrete, wood blocks, bricks, asphalt, or other impervious matter authorised and approved by the Building Committee.

*Thickness of walls.*

41. Conditions for determining thickness of walls:—  
For one storey work (stone), all exterior walls not less than 16in. thick.

For one storey work (brick), all exterior walls not less than 9in. thick, or 11in. hollow.

Partition walls (stone), not less than 12in. thick.

Partition walls (brick), not less than 4½in. thick.

Cellar walls for house of one storey, not less than 18in. thick.

Cellar walls for house of two storeys, not less than 27in. thick.

First storey walls (stone), not less than 14in. thick.

First storey walls (brick), not less than 9in. thick.

Ground floor carrying one upper storey (stone), not less than 18in. thick.

Ground floor carrying one upper storey (brick), not less than 9in. thick, or 11in. hollow.

Party walls, not less than 9in. thick.

Mutual walls, not less than 14in. thick, or 16in. hollow.

Piers must never be less than 18in. on the face, and 13½in. deep.

The same thickness of walls for third storey as provided for second storey.

The footings of walls must in all cases be at least 4in. thicker on each side than the upper walls, and the foundations of piers must in no case be less than 2ft. 6in. by 2ft. 6in.

*Disputes.*

42. If any dispute shall arise between the Building Committee and any person or persons respecting the meaning or operation of any of the conditions of these By-laws, the question shall be referred by the Building Committee to the Council for their adjudication.

*Fees and penalties.*

43. All fees, penalties, and other sums recovered under the provisions of these By-laws or any of them shall, unless otherwise provided, be paid to the Council, and shall become the property of and part of the ordinary income of the Municipality.

Obstructions.—The gangway and water channel shall at all times be kept clear throughout.

Sanitary.—Before commencing to build, a privy shall be erected for the use of the workmen, and all the requirements of the sanitary authorities strictly complied with.

Re-instatement.—At the expiration of the period for which this license is granted, or sooner if possible, the hoarding shall be cleared away and the footpath, kerbing, channelling, and roadway made good to the satisfaction of the Building Committee.

Deposit.—As additional security for the satisfactory performance of the last-named condition, the licensee shall deposit a sum not exceeding £5 at the discretion of the Building Committee, with the Town Clerk.

THE SHARKS BAY PEARL SHELL FISHERY ACT, 1892.

5307/09. Colonial Secretary's Office, Perth, 24th December, 1909.

HIS Excellency the Governor in Council has been pleased to approve the following Regulations under the above Act for the control and management of the Sharks Bay Pearl Shell Fishery, in substitution for the Regulations approved on the 11th May, 1898.

Regulations for the Control and Management of the Pearl Shell Fishery at Sharks Bay.

HIS Excellency the Governor in Council, under the powers conferred upon him by the Sharks Bay Pearl Shell Fishery Act (55 Viet., No. 9), has been pleased to repeal the Regulations approved of on the 11th day

of May, 1898, and to make the following Regulation for the control and management of the Sharks Bay Pearl Shell Fishery in lieu thereof:—

1. The rent of a General License shall be at the rate of £4 per annum per boat, payable in advance on the date of application, and the term shall be for any period not less than three months and not exceeding one year. All licenses shall expire on the 31st December.

2. The rent of an Exclusive License shall be at the rate of not less than 1s. per acre per annum, minimum rent £1, and shall be payable half-yearly in advance on the 1st day of January and the 1st day of July in each year. Provided that in respect of Exclusive Licenses over any blocks now surveyed and set apart for such licenses, the rent shall be fixed by the Governor in Council.

3. The term of an Exclusive License shall be computed from the first day of January preceding the date of the approval of the application, and shall be for any period not exceeding fourteen years.

4. Licenses applied for during the year will be charged rent proportionate, calculated from the 1st day of January or July last immediately preceding the date of approval of the application, as the case may be.

5. Applications for general licenses shall be made to the Inspector, as the authorised agent of the Minister, and the applicant shall give the name of the owner and the name of the boat, provided that the Inspector may, in any case in which any boat is disabled or unable to work, allow another boat to be substituted for the boat so disabled or unable to work.

6. No person shall destroy or preventably permit to perish any immature pearl shell, nor shall collect, remove, or have in his possession such immature pearl shell, excepting under the conditions covered by Clause 12; and no person shall open any pearl shells except at such places as shall have been approved of by the Inspector.

7. The holder of a general license shall only be entitled to have two men at work in each boat; but if more are required, the permission of the Inspector in writing shall be necessary; and, if obtained, an additional fee of 5s. per month for each additional man so employed in such boat shall be paid in advance.

8. All boats licensed shall have a distinguishing number painted on the bow, above the water-line, and the licensee shall maintain such figures in a clear and legible manner during the currency of the license.

9. The owner or the agent of the owner of any licensed boat, before proceeding to work on any of the waters of Sharks Bay, shall bring the crew of such boat before the Inspector, who shall explain to such crew the regulations under which they are to work.

10. The Inspector may, in his discretion, prohibit the use of a dredge on any portion of Sharks Bay, whether held under exclusive license or not, and this prohibition shall be absolute and continuous on all shallow and so-called "pick-up banks."

11. It shall be lawful for the Inspector at any time to absolutely prohibit the obtaining of pearls and pearl shells, either by dredging, collecting by hand, or otherwise, from any portion of Sharks Bay, whether held under exclusive license or not, when in his opinion the working is likely to detrimentally exhaust the ground.

12. No person shall retain any young or immature shell, and shall at once return them to the water, unless they are required for planting areas held under exclusive licenses; in which case they shall be so dealt with as not to be allowed to perish.

13. The Inspector or other officer may seize and remove any young or immature shell found in possession of any person.

14. No person shall have or carry on board any boat or use a dredge without the permission of the Inspector, and the Inspector or other officer may seize and remove any dredge found on board any boat, or used contrary to this regulation:

15. The Minister may set apart any portions of Sharks Bay as reserves for the growth and breeding of the pearl or other oyster; and no person shall dredge or otherwise obtain shell from any such reserve. The Inspector may seize and remove any shell so obtained, and any other shell that may be found in possession of any person who may be found collecting shell by dredging or otherwise from any Government Reserve, and any person so found shall be liable to a penalty not exceeding £50.

16. No person shall trespass, or sail over or anchor on any Government Reserve, or other locality set apart by the Minister for the growth and breeding of any oyster; and no person, except the Inspector or licensee, shall trespass, sail over, or anchor upon any sections held under exclusive license.

17. Applications for exclusive licenses shall be made to the Inspector, as the authorised agent of the Minister, of areas of from 10 acres upwards, but not exceeding two square miles. Each application shall be accompanied by an accurate description of the area applied for, and an application fee of £1.

In all applications for exclusive licenses, the length of the licensed area shall not exceed twice its width.

In those parts of Sharks Bay which have been surveyed into blocks, each application must comprise one complete block as surveyed. All applications for exclusive licenses shall take priority according to the order of their being lodged with the Inspector. In the event of two or more simultaneous applications for the same area, the priority shall be determined by lot, by the Minister.

18. The Inspector shall give notice, by affixing a notice on the notice board of his tent or office for seven days, that an application has been made, and shall hear and report all objections that may be raised to the granting of such exclusive license in open court. Provided that such notice shall not be necessary in the case of applications for surveyed areas.

19. The Minister shall not be bound to entertain any application, and he may invite tenders for any license or licenses, but shall not be bound to accept the highest or any tender. The Inspector may, in open court, refuse to recommend the granting of an exclusive license over the area applied for.

20. All holders of exclusive licenses shall cultivate the areas held by them in a *bona fide* manner, to the satisfaction of the Inspector, by planting and protecting the oysters on the area; and the holders of exclusive licenses shall be subject to the Regulations in the same manner as the holders of general licenses.

21. The holder of an exclusive license neglecting or offending against these Regulations shall, upon conviction, in addition to the penalties provided by these Regulations, render his license liable to forfeiture by the Governor in Council.

22. The Inspector may visit, inspect, and report on all portions of Sharks Bay, whether reserved, held under exclusive license, or otherwise.

23. It shall be lawful for any person, who thinks himself aggrieved by any act or decision of the Inspector, to appeal against such act or decision to the Minister, whose decision in all cases shall be final.

#### Penalties.

24. Any person offending against the provisions of these Regulations shall be liable, on conviction, to a penalty not exceeding the sum of £50.

The light will illuminate the whole horizon, showing one flash every 15 seconds, but for an arc of 52deg. of the horizon from N. 42deg. W. to S. 86deg. W., it may be obscured by the land if the vessel comes within two nautical miles from the Lighthouse. The bearings are magnetic and from seaward.

The light will have a power of 864,000 candles. It will be 480 feet high above high water, and visible in clear weather at a distance of 30 nautical miles.

The Lightkeepers at this station on hearing fog-signals, during thick and foggy weather, will fire two guns with an interval of two minutes between them, and, if the vessel's fog-signal is still heard, will repeat the firing after a space of five minutes.
