WHEREAS by Section 43 of "The Land Act, 1898," it is made lawful for the Governor, by Order in Council, without issuing any deed of grant to place any Reserve under the control of any Municipality, Roads Board, or other person or persons, as a Board of Management, and to empower such Board to make, repeal, and alter by-laws for the control and management of such Reserves, and prescribe fees for depasturing thereon, and for other purposes, such by-laws to be approved by the Governor and published in the *Government Gazette*: And whereas it is deemed expedient that Reserves 833, 1244, 2026, 2027, 2363, 6316, 6672, 6743, 8486, and 12210 should be placed under the control of the Beverley Road Board, for the respective purposes for which they are set apart, as a Board of Management: Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, doth hereby place the before-mentioned Reserves under the control of the Beverley Road Board as aforesaid, as a Board of Management, and doth empower such Board to make, repeal, or alter by-laws for the control and management of the said Reserves, for prescribing fees for depasturing thereon, for directing the manner in which such fees shall be imposed, paid, collected, and disposed of, and to impose penalties not exceeding in any case £5 for any breach thereof, and £2 a day for a continuing breach, but not more than £20 in the aggregate.

THE PUBLIC SERVICE ACT, 1904.

Additional Regulations.

Office of Public Service Commissioner,
Perth, 9th January, 1913.

HIS Excellency the Governor in Executive Council, acting under the powers conferred by Section 84 of "The Public Service Act, 1904," has been pleased to approve of the following Regulations:—

1. In these Regulations, subject to the context,—
"Appeal Board," or "Board," means the Appeal Board constituted under the Chairmanship of the President of the Arbitration Court, for the hearing of Appeals from proposals of the Commissioner, or of the Commissioner acting in conjunction with Assistant Commissioners relating to the Classification or re-classification of offices.
"Chairman" means the chairman of the Appeal Board.
"Clerk" means the person for the time being appointed by the Governor to be Clerk of the Appeal Board.

2. The Clerk shall be charged with the duty of keeping a record of all appeals from the proposals of the Public Service Commissioner and Assistant Commissioners relating to the re-classification of offices and published in the *Government Gazette* on the 29th day of March, 1912, and the 10th day of May, 1912.

3. The Commissioner shall from time to time forward to the Clerk such appeals as shall have been received by the Commissioner, together with a statement indicating the order in which it would be most convenient to have the appeals heard, having regard to the exigencies of the service.

4. After receipt of any such appeals and statement the Clerk shall, under the direction of the Chairman, give to the Commissioner and to the appellant not less than seven days' notice of the time and place at which each appeal will be heard.

5. The Board shall decline to proceed with any appeal that is not from a proposal relating to classification or re-classification.

6. Upon receiving notice of the date fixed for the hearing of an appeal under these Regulations, the Commissioner and the appellant shall arrange for the attendance of their respective witnesses and for the production of all necessary documents.

An appellant shall, within four days of the receipt of notice of the date fixed for the hearing, supply the Commissioner with a list of witnesses he proposes to call, and the Commissioner shall forthwith supply the Clerk with a complete list of all witnesses.

The appellant shall be supplied with the names of the witnesses intended to be called by the Commissioner, on application at the Commissioner's Office:

Provided that nothing in this Regulation shall prevent additional witnesses being called at the hearing by leave or at the instance of the Board.

7. No appeal shall be entertained by the Board unless the appeal has been duly lodged within the time prescribed by Regulation 113, published in the *Government Gazette* on September 16th, 1910.

8. The Board may in its discretion adjourn the hearing of any appeal from time to time where the appellant is ill or absent from the State, or for any other good and sufficient reason.

9. The decision of the Board in each case shall be in writing signed by the Chairman and shall be recorded by the Clerk and shall be forthwith forwarded to the Governor.

The Clerk shall furnish the Commissioner and the appellant with a certified copy of each decision.

10. The Board may at any time allow an appellant to amend the statement of his grounds of appeal on such terms (if any) as to the Board shall appear just.

11. The Board may itself call upon any person to give evidence or produce any document, and may hear evidence and examine documents tendered or produced on behalf of the appellant or of any person lawfully represented before the Board. The Board shall not be bound by any rules of evidence but may admit and receive as evidence such testimony, documents, or other information as shall appear to the Board likely to be of assistance in arriving at an equitable decision.

12. Regulations 181, 185, 186, 187, 188, 189, and 190 do not apply to appeals to the Appeal Board.

13. Subject as hereinbefore provided, the other Regulations made under "The Public Service Act, 1904" (including any amendment thereof) relating to the Appeal and the Appeal Board mentioned in such Regulations, shall, so far as applicable, and not inconsistent with these Regulations, apply to and in respect of the Board and appeals mentioned in these Regulations.

PARKS AND RESERVES ACT, 1895.

Amendments to King's Park By-laws.

HIS Excellency the Governor in Executive Council has been pleased to approve, under Sections 8 and 9 of "The Parks and Reserves Act, 1895," of the following amendments to the By-laws for the control and management of King's Park (Reserve 1720):—

By-law No. 2.—Add the following paragraph:—"Nor shall any person ride upon or over any cultivated ground or any pathway in the said Park."

By-law No. 4.—Add:—"or cut or remove any dead-wood or timber lying in the Park unless with the permission in writing of the Board first obtained."

By-law No. 6.—Insert the word "disorderly" after "riotous" in the second line, and add the following:—"Neither shall any person obstruct or interfere with any officer in the employ of the Board in the performance of his duty in the said Park."

By-law No. 9.—Insert the following after "fire" in the fourth line:—"or use any explosive substance whatever."

By-law No. 11.—Add the following paragraph:—"Nor shall any person be permitted to use any portion of the said Park for the purpose of training any horse or other animal thereon."

By-law No. 16.—Add the following:—"and shall also have attached to any such motor car a lighted lamp so fixed as to exhibit a light from the rear of such motor car."

By-law No. 19.—Add the following:—"Nor shall any person ride on any roadway or over any portion of the said Park at a rate or speed or in a manner dangerous to the public."

Damaging Roads.

1. No person shall damage or destroy by means of horse, team, wagon, dray, or other means, any road or portion of a road, under construction or repair, and any person found guilty of such damage or destruction shall be liable to a penalty not exceeding £20.

2. Any person who:—

- (a.) Cuts or removes, without the consent in writing of the Chairman of the Board, timber, earth, sand, gravel, stone, or other materials from a road; or
- (b.) Erects any building or structure whatsoever, without the consent aforesaid, upon a road, so as to encroach thereon; or
- (c.) Draws, without the consent aforesaid, across the waterside of a road, except over a properly constructed approach or culvert, a dray or other wheeled vehicle; or
- (d.) Draws upon a road timber, stone, or other material otherwise than on a wheeled vehicle, or suffers such material when carried principally or in part upon a wheeled vehicle to drag or trail upon a road, or draws upon a road a whim or timber carriage any portion of which, or any portion of chains attached thereto, or any portion of any other attachment trails or drags upon a road, shall be deemed guilty of an offence against these By-laws, and shall be liable to a penalty not exceeding £5 for every such offence.

Heavy Traffic.

3. A yearly license fee of £2 per pair of wheels shall be paid for every jinker or whim used within the District, and no person shall use, on any declared road within the District, any jinker or whim for which a current license shall not have been issued.

No single or two-wheeled jinker or whim shall be allowed on any declared road within the District.

4. The owner of every traction engine which, together with its load, shall weigh more than five tons, shall travel the roads, bridges, and culverts, at his own risk, and shall be liable to pay for any damage done.

HIS Excellency the Governor in Executive Council has been pleased to approve of the following Regulations for the Scholarships, Bursaries, and Exhibitions offered by the Education Department.

SEECIL ANDREWS,

SCHOLARSHIPS, BURSARIES, AND EXHIBITIONS.

I.—Primary School Scholarships.

When an Inspector finds an exceptionally promising child in a small country school, and considers that he would greatly benefit by obtaining the advantages of a large school, he should take steps to ascertain whether the parents would be willing to allow the child to attend the nearest suitable large school, if an allowance of £25 per annum were made by the Department. The number of such Scholarships to be awarded in any one calendar year shall not exceed twelve. As a rule they will be given to children under eleven years of age, but at the discretion of the Minister they may be given to older children. Such Scholarships will be tenable until the holders have completed the Primary School Course, or have gained Scholarships to a Secondary School, provided that their progress and diligence are satisfactory.

II.—Secondary School Scholarships.

1. Scholarships, not exceeding fifty in each year, are annually offered for boys and girls attending Government or other efficient primary schools. Ten of these Scholarships will be of the value of £20 per annum. The remainder will entitle the holders to receive a grant to defray necessary expenses incurred in the provision of books, provided that no such grant shall exceed £3 per annum. Scholarship-holders living at home may also receive a grant to defray their necessary travelling expenses, provided that their homes are at a greater distance than two miles from the school. The winners of these Scholarships must attend Secondary Schools approved by the Department. If the winner of a Scholarship resides at such a distance from an approved school that it is necessary for him to become a boarder or to live away from home, an additional allowance of £30 per annum will be given.
2. The Scholarships will be tenable for four years.
3. A candidate for these Scholarships must—
 - (a.) Be over twelve and not more than thirteen and a-half years old on the last day of the year on which the examination for the Scholarship is held.
 - (b.) Have attended one or more of the Government or other efficient primary schools of the State continuously for at least two years immediately preceding the day mentioned in (a), and have made not less than three hundred half-day attendances (unless prevented by illness) in such school or schools during his last year.
 - (c.) Produce a certificate of industry and good conduct from the Head Teacher of the school last attended.
4. The Scholarships are awarded upon a competitive examination conducted by the Education Department.
5. A number of Scholarships, not exceeding one-fifth of the total number offered, will be reserved for pupils from country schools, provided that candidates of sufficient merit present themselves. A school with an average attendance of over 200 shall not be deemed a country school for the purposes of this section.
6. The conditions upon which the Scholarships are tenable are:—
 - (a.) That the successful scholar shall, at the commencement of the first term following the award of the Scholarship, become a pupil at a Secondary School approved by the Minister. The Minister may require that the school be inspected.
 - (b.) That he shall continue to attend such school, and at the end of each term obtain from the authorities of the school, and forward to the Education Department, a certificate stating that his conduct and attendance have been satisfactory. Full particulars of attendance, of success in study, and of promotion, if any, must be given. If an unfavourable report is received, or if at any time his conduct be disorderly or immoral, the Scholarship may, at

the discretion of the Minister, be forthwith cancelled.

7. The Secondary Schools at which these Scholarships are tenable cannot themselves send any candidates for the Scholarships, which are, as stated above, offered for scholars attending primary schools.

8. The subjects of examination will be:—

English, 300 marks.
Arithmetic, 200 marks.
History, 100 marks.
Geography, 100 marks.

9. The examination will be on the course laid down for Standard VI. in the Curriculum of the Government Primary Schools.

10. The examination will be held in such centres as shall be fixed annually by the Department.

III.—Primary School Bursaries.

1. Bursaries of the value of Ten pounds each, tenable for one year only, will be annually offered to boys and girls attending the Government or other efficient Schools of the State, provided that the average fee laid down for the school does not exceed One shilling per week.
 2. Candidates for these Bursaries must—
 - (a.) Have attended one or more of the Government or other efficient schools continuously for at least two years immediately preceding, and have made not less than three hundred half-day attendances in such schools during their last year.
 - (b.) Procure a Certificate of Industry and Good Conduct from the Head Teacher of the last school attended.
 - (c.) Be not less than thirteen nor more than fifteen years of age on the day of examination.
 3. The Bursaries are awarded upon a competitive examination.
 4. No candidate is eligible for a Bursary who fails to obtain $\frac{2}{3}$ (two-thirds) of the maximum number of marks.
 5. An examination of candidates will be held once a year. The examination will be held in Perth, and should it be found expedient, for the convenience of candidates residing in the distant parts of the State, the Minister may arrange for examinations being also held in "local centres."
 6. Application for admission to the Bursary Examination must reach the Department by such date as may be notified in the *Government Gazette* or *Education Circular*.
 7. Half the payment will be made at the expiry of six months after the examination, and the remainder on the completion of a year, if the following conditions have been fulfilled:—
 - (a.) That the holder of the Bursary shall have attended a Government or other efficient school regularly, making at least three-quarters of the possible attendances for the six months in question.
 - (b.) That he shall produce a certificate of good conduct from the teacher.
- Note.—The parents of the successful candidates shall have the right to choose the Government or other efficient school in which their children shall be educated during the 12 months of holding the Bursary.
8. The examination will be on the full course as laid down in the curriculum for primary schools for Standard VII. in the following subjects:—
- English (excepting Literature), 300.
Writing, 50.
Mathematics (including Arithmetic, Geometry, Algebra, and Mensuration), 300.
History (a full course of British History), 200.
Geography, 200.

Note.—Girls taking the Domestic Course will have a special paper on Household Management—including Arithmetic—instead of Mathematics.

9. A limited number of Bursaries will, at the discretion of the Minister, be reserved for candidates from small schools, provided that they obtain at least $\frac{2}{3}$ (two-thirds) of the maximum number of marks, although they may not be among the highest on the list.

Where a candidate attends an efficient school other than a Government one, the Department may require an Inspector to report upon, and, if necessary, examine such children as are stated to have passed the Sixth Standard or an equivalent examination.

IV.—Senior and Junior Government Exhibitions.

Regulations for 1913.

1. The exhibitions will be divided into Senior and Junior Classes. Seven Senior Exhibitions of the value of £25 each, tenable for one year, will be offered for candidates of either sex, who have not reached the age of 17; and twelve Junior Exhibitions of the value of £20 each per annum, tenable for two years, will be offered for candidates of either sex who have not reached the age of 16 years.

2. The courses of examination for Seniors and Juniors respectively will be those laid down for the Senior and Junior Adelaide University Examinations.

3. Only seven subjects will be taken into consideration in allotting the exhibitions. The following subjects are compulsory for the Senior Exhibitions:—English Literature, Arithmetic, and Algebra and one Foreign Language. The following subjects are compulsory for the Junior Exhibitions:—English Literature, Arithmetic, one Foreign Language, and History or Geography or a second Foreign Language. The remaining four subjects in the Senior Examination and the remaining three subjects in the Junior Examination may be any of those prescribed for the respective examinations by the University. If a candidate for the Senior Exhibitions sits for more than four optional subjects, only the four in which he obtains the best results will be counted. If a candidate for the Junior Exhibitions sits for more than three optional subjects, only the three in which he obtains the best results will be counted.

4. The scale of marks as allotted by the Adelaide University will be adopted, with the following exceptions:—In the Senior Examination 300 marks will be allotted to each of the following subjects:—Latin, Greek, Physics, Chemistry. In the Junior Examination 300 marks will be allotted to each of the following subjects: Latin, Greek, Geography, Arithmetic, Physics, Chemistry.

5. Candidates for Junior Exhibitions must not be more than 16 years of age, and candidates for Senior Exhibitions not more than 17, on the 1st day of December of the year in which the examination is held. All candidates must have resided in the State for two years on the first day of the month in which the examination is held.

6. (a.) The fees of candidates who have previously passed the Adelaide Junior Examination will be paid by the Department.

(b.) The ten candidates highest on the list in the Junior Examination, and the six candidates highest on the list in the Senior Examination of those who have not had their fees paid by the Department, will have their fees refunded after the results are known.

7. Candidates who qualify will be required to produce birth certificates, or satisfactory proof of age, before the exhibition or certificate is issued.

8. Applications for admission to the examinations must be made on the prescribed forms, which may be obtained from the Education Department. Applications will not be received after the 1st September.

9. Payment for the Exhibitions shall be made in two moieties each year, the first payment to be made on the expiry of six months from the date of the award, as notified in the *Government Gazette*, and subsequent payments at intervals of six months after the first payment, such payment to be subject to the provisions:—

(a.) That the holder of the Exhibition shall have been in regular attendance at school, and shall produce a certificate from his or her head teacher testifying to such regular attendance. Regular attendance implies that the holder of the Exhibition shall have made at least three-quarters of the possible attendances.

(b.) That the holder must produce a certificate of good conduct from his or her head master.

V.—Government University Exhibitions.

1. Ten exhibitions to be held at the University of Western Australia shall be open for competition to any boy or girl under the age of 19 years on the first day of December in the year in which the examination is held, whose parents or either of them shall be *bona fide* residents in the State of Western Australia, and who himself shall have been a resident therein for a period of three years at least previous to the holding of the examination provided for by these rules.

2. The said exhibitions shall be tenable for a period of three years, and shall each be of the value of £50 for each of the said three years.

3. All competitors for the said exhibitions shall pass an examination, to be held at such place and by such examiner or examiners as may be appointed by the Education Department.

4. (a.) The said examination shall be held and the said exhibitions awarded annually. In 1913 the exhibitions will be awarded on the results of the Higher Public Examination of the Adelaide University.

(b.) The scale of marks as prescribed by Adelaide University will be adopted. If candidates of sufficient merit are forthcoming, four of the exhibitions will be given to those who take either two mathematical subjects and one science, or two sciences and one mathematical subject; any two of the other subjects may be taken as well. For the remaining six exhibitions there is no restriction as to the subjects taken.

(c.) The Minister reserves to himself the right to withhold all or any of the above exhibitions in the event of candidates not showing sufficient merit.

5. Every competitor shall give to the Education Department not less than eight weeks' notice of his intention to compete at such examination, such notice to be computed from the date of the examination as may be fixed from time to time and notified in the *Government Gazette*, and, together with such notice, shall forward to the Education Department (a) a certificate of birth, and (b) two certificates attesting the good character and repute of such competitor. Of these two latter, one shall be given and signed by the head master of such competitor's school, and the other by the clergyman, priest or minister of the religious denomination to which such competitor shall belong and of the district in which such competitor shall be residing, or by the Resident Magistrate of that district.

6. The Exhibitions shall be held subject to the following conditions, namely:—

(a.) A successful candidate shall, as soon as the Regulations of the University will allow, become enrolled as an undergraduate of the University.

(b.) An exhibitioner shall enter at once upon a full course of study leading to a Degree.

(c.) He shall begin residence at the University to which he may have been admitted as soon after such admission as the Regulations of such University shall allow.

7. The holder of an Exhibition shall be entitled to receive the said sum of £50 by three equal instalments, payable at any time when he has furnished proof that he has satisfactorily completed his term, subject to the production of such certificates or other evidence as the Education Department may from time to time direct.

8. The Education Department may from time to time, with the approval of the Governor, revoke, add to, or amend these rules.

UNIVERSITY OF WESTERN AUSTRALIA.

THE following draft of a Statute proposed to be made by the Senate is published in accordance with Section 31 (6) of "The University of Western Australia Act, 1911."

STATUTE.

No. 9.—*Professorial Board.*

1. The Professorial Board shall consist of the following members:—

- (a.) The Vice-Chancellor (when appointed).
- (b.) The Professors of the University.
- (c.) Such Lecturers of the University as may be approved by the Senate on the recommendation of the Professorial Board.

2. The Vice-Chancellor, or, in his absence, one of the Professors of the University elected by the Professorial Board, shall preside at its meetings.

3. The Board shall submit to the Senate recommendations regarding the various courses of study.

4. The Board shall make, after report from the Faculty or Faculties, if any, concerned, all arrangements for giving effect to the Statutes and Regulations relating to courses of study in the University, and, in particular, shall determine the days and hours of lectures, the duration of courses, and the dates and general conduct of examinations.

5. The Board shall recommend Examiners, whether members of the University staff or not, for appointment by the Senate after report from the Faculty or Faculties, if any, concerned.

6. The Board shall nominate for appointment by the Senate, a Board of Examiners to conduct the Matriculation Examination, and any Examinations of a standard lower than Matriculation which the Senate may decide upon.

7. The Board shall make such rules for the discipline of the students of the University as it may deem necessary, and shall appoint a Committee of Discipline consisting of such of their members as they may determine. This Committee shall control the discipline of the students of the University and have power to suspend, fine, or otherwise punish any student when necessary for the maintenance of discipline, subject to an appeal to the Professorial Board. The Committee may also recommend to the Professorial Board the expulsion of any student.

8. The Board shall report to the Senate upon all proposals for the creation or suppression of Professorships, Lectureships, or Faculties, all proposals for the foundation or abolition of Fellowships, Studentships, Scholarships, Exhibitions, Prizes, or other awards, all proposals for new buildings or equipment, and all applications from departments for grants for study or research.

9. The Board may make recommendations to the Senate as to regulations governing the order to be observed at academic ceremonies.

10. The Board may make representations to the Senate as to the removal of any Professor, Lecturer, or other member of the teaching staff.

11. The Board shall fix, subject to any conditions made by the Founders and accepted by the Senate, the time and mode and conditions of awarding Fellowships, Studentships, Scholarships, Exhibitions, Prizes, or other awards, and award the same.

12. The Board shall receive and consider communications from the Guild of Undergraduates and forward with or without comment such as are intended for communication to the Senate.

13. The Board shall discuss and report to the Senate on any matters referred to it by the Senate.

14. All questions which shall come before the Professorial Board shall be decided by the majority of the members present, and the Chairman shall have a vote, and in the case of an equality of votes a casting vote, and no questions shall be decided at any meeting of such Board unless at least one-half of the members thereof be present.

15. Subject to the provisions of these Statutes and to the Regulations made by the Senate, the Professorial

Board shall have power to regulate its own procedure, appoint its own Secretary, and fix the times and places of its meetings, and to do such other acts and things as the Senate shall authorise or prescribe.

16. A *précis* of the proceedings of the Board shall be laid upon the table of the Senate once in each term, or forthwith in matters of special importance, and the Senate shall have power of its own motion to review any decision of the said Board.
