WHEREAS by "The Water Boards Act, 1904," the Governor is empowered by Order in Council to constitute the district of a Local Authority or two or more Local Authorities on any part or parts of such District or Districts a Water Area under such name as may be directed: And whereas under the provisions of the said Act the Governor may authorise the Minister of Water Supply, Sewerage, and Drainage to exercise within a Water Area all or any of the functions of a Water Board: Now, therefore, His Excellency the Governor, by and with the advice of the Executive Council, doth hereby constitute an Area having the boundaries described in the Schedule hereunder a Water Area for the purpose of the said Act under the name of the Geraldton Water Area, and does hereby appoint the Minister of Water Supply, Sewerage, and Drainage to exercise any or all of the functions of a Water Board under the said Act in such Area.

This Order in Council shall take effect on the 21st day of June, 1913.

WHEREAS by "The Metropolitan Water Supply, Sewerage, and Drainage Act, 1909," it is provided in Section 20 that the Governor may exempt such reticulation works as in his discretion he may think fit from the operation of certain sections in this Act: Now, therefore, His Excellency the Governor, with the advice of the Executive Council, does hereby exempt the reticulation works as hereinafter described from the operations of Subsections (a) and (b) of Section 20, and Sections 21, 22, and 23 of the said Act.

Description of said Reticulation.

A 6-inch stoneware pipe sewer, with all apparatus relating thereto, being a portion of Areas 2 and 3, Fremantle, commencing at Manhole 173 and proceeding North along Solomon Street to Martha Street, and thence East along Martha Street to King Street; a total distance of 353 feet.

MUNICIPALITY OF BOULDER.

By-Law No. 93.

A By-law of the Municipality of Boulder made under Section 179 of "The Municipal Corporations Act, 1906," and numbered 93.

IN pursuance of the powers conferred by the said Act, the Mayor and Councillors of the Municipality of Boulder order as follows:—

1. No person shall permit any goods, wares, or merchandise or any articles or effects to remain on any part of any footpath or street.

2. No person shall pack or unpack or cause to be packed or unpacked any goods, wares, or merchandise, or any articles or effects, on any part of any street or footpath.

3. No person shall place, hang up, or otherwise expose for sale any goods, wares, or merchandise upon or over any footpath.
