WHEREAS by Section 7 of "The Metropolitan Water Supply, Sewerage, and Drainage Act, 1909," it is provided that the Governor may, by Order in Council, alter or extend the boundaries of the Metropolitan Water, Sewerage, and Drainage Area or any district thereof, and re-define the boundaries of districts: And whereas it is desirable that the boundaries of the Guildford District should be altered: Now therefore I, the said Governor, by and with the advice of the Executive Council, do hereby alter the boundaries of the Guildford District of the said Area and re-define the boundaries of the said District by substituting the boundaries set out in the schedule hereto for the boundaries defined in the Second Schedule to the said Act.

THE SCHEDULE.

The Metropolitan Water, Sewerage, and Drainage Area. Guildford Water District.

All that portion of the Water Area comprised within the boundaries hereunder described:—

Starting at the South-West corner of Reserve 5342 near Helena Weir; thence in a Westerly direction to the South-East corner of Helena Location 20a; thence along Southern boundary of said location to Road 1135; thence South-West to North-East boundary of Swan Location 28; thence along the North-East boundary of said location to the Swan River; thence South-Westerly along centre of Swan River to the South-East corner of Location T; thence along the North-East boundary of said Location T to the North-East corner of said Location T; thence Easterly along the Southern boundary of Swan Location 1299; thence Northerly along the Eastern boundary of said location; thence along the Northern boundary of said location to intersection of Swan Road Board boundary; thence Northerly and along the Swan Road Board boundary to the North boundary of Swan Location G; thence due East along North boundary of said location for a distance of about 9½ miles to the North-East corner of Swan Location 1328; thence South and along the Eastern boundary to the South-East corner of said location; thence Easterly and along a 50-link road to intersection of Government Road No. 1890; thence South and along said road to intersection with Newcastle Road; thence due South to the Northern boundary of Reserve 3304; thence in a South-Westerly direction to the North-East corner of Reserve 6955; thence South along Eastern boundary to South-East corner of said Reserve; thence East to the North-East corner of Swan Location 1775; thence South to North-West corner of Swan View Sub-Lot 31; thence East to North-East corner of Swan View Lot 23; thence in a Southerly direction and along the Eastern Railway to the North-West corner of Lot 70, Black Boy Hill Estate; thence South to the North-West corner of Lot 58; thence South-West to the North-West corner of Lot 52; thence along Western boundary of said Lot 52 to the York Road; thence South to the Northern boundary of Helena Location 20b; thence East to South-East corner of Lot 63, Greenmount; thence North for about 7 chains; thence East to the South-East corner of Lot 61, Greenmount; thence Southerly and along road crossing Darlington Railway Station to South boundary of Location 1242; thence East to South-East corner of Location 1246; thence North to South-West corner of Location 1268; thence East and along road to South-East corner of Greenmount Sub-Lot 133; thence in a South-Easterly direction to the North-West corner of Swan Location 1421; thence in a Southerly direction to point of commencement.

WHEREAS it is provided by "The Water Boards Act, 1904," that for preventing the pollution of water within a catchment area, every Water Board shall, within such area, have all the power and authority of a Local Board of Health, including the power to make and enforce By-laws under any Act relating to Public Health: And whereas it is desirable that the lands described in the schedule hereto should be declared the catchment area for the Geraldton Water Supply: Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, doth hereby order and declare the lands described in the schedule hereto to be a catchment area for the Geraldton Water Supply.

WHEREAS by the provisions of "The Cemeteries Act, 1897," and amending Acts, it is made lawful, in case it should appear to the Governor that burials in any cemetery under any law relating to cemeteries or other burial ground, or place of burial whatsoever, should be wholly discontinued or discontinued subject to any exception or qualification for the Governor by Order, to be published in the *Government Gazette*, to direct that after a time mentioned in such Order, not being less than three months from the date thereof, burials in such cemetery or burial place, ground, or place of burial, shall be discontinued wholly or subject to any exception or qualification mentioned in the same or any subsequent Order: And whereas it has been made to appear to the said Governor that it is advisable that, excepting in vaults at present owned by private persons, all burials should be discontinued in the old Cemetery at Meckering, being Reserve No. 5687, Sub-lot 20: Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, doth hereby direct that from and after the first day of October, 1913, burials within the limits of the said Meckering Cemetery shall be wholly discontinued, except in cases where the special permission of the Minister for Lands be first obtained.

1. The Superintendent of any Institution may direct any inebriate detained therein to do such work as such Superintendent may from time to time consider likely to be beneficial to the health and assist in the cure of such inebriate.

2. If any inebriate shall refuse or neglect to do any work which he has been lawfully directed to do by any Superintendent he shall be liable, on conviction, to a penalty not exceeding five pounds.

3. The Superintendent of any institution and all persons acting under his authority may use such force as may be necessary to prevent any inebriate, lawfully ordered to be placed therein for any period, from escaping from the institution before the expiry of the period.

4. The Superintendent of any institution may grant to any inebriate detained therein leave of absence by license in writing under his hand, for a certain period, to be specified therein and may, in such license, specify any conditions subject to which the inebriate is to be allowed to remain out of the institution, and the inebriate shall be released in accordance with the terms of such license.

5. If any inebriate released as aforesaid shall break any of the conditions specified in such license, or if he shall neglect or refuse to return to the institution on the expiry of the period specified in the license, he may be apprehended by virtue of an order made by any Justice of the Peace, and re-delivered to the Superintendent to be detained for the remainder of the period mentioned in the order of detention, unless such order of detention shall have been previously lawfully rescinded.

6. If any inebriate lawfully detained in an institution shall escape or attempt to escape therefrom he shall be liable to a penalty not exceeding Fifty pounds.

*Regulations.**General.*

1. Every licensee shall produce, on demand by any Guardian appointed under "The Game Act, 1912," or any Police Officer or Constable, or any person authorised by the Minister, his license, and in default shall be liable to a penalty not exceeding £10, and his license shall be liable to forfeiture.

License to take and kill Native Game for Sale or Barter.

1. Application for a license to take and kill native game for sale or barter under Section 10 of "The Game Act, 1912," may be made to the Chief Inspector of Fisheries, Perth, or to the Resident Magistrate of any Magisterial District. The license shall be in accordance with Form A. in the Schedule to these Regulations or to the effect thereof.

2. The fee to be paid for any such license shall be £3 per annum, provided that if a license is taken out after the 30th day of June the fee shall be £1 10s.

3. Every such license shall expire on the 31st day of December next following the issue thereof.

4. The above license, issued under Section 10 of "The Game Act, 1912," and the Regulations made thereunder, does not authorise the killing, taking, or destroying of native game or any particular kind of native game from or on any reserve for native game or from or on a reserve for that particular kind of native game.

Licenses to sell Native Game.

1. An application for a license under Section 10 of "The Game Act, 1912," to sell native game may be made to the Chief Inspector of Fisheries, Perth. The license shall be in accordance with Form B. in the Schedule to these Regulations or to the effect thereof.

2. The fee to be paid for any such license shall be £1 per annum.

3. Every such license shall expire on the 31st day of December next following the date of issue thereof.

4. Any person selling native game not being the holder of a license granted under "The Game Act, 1912," shall be liable to a penalty not exceeding £20.
