WHEREAS by power conferred by Section 8 of "The Roads Act, 1911," the Governor may alter the boundaries of any District: And whereas it is desirable to alter the boundaries of the Mount Malcolm, Mount Margaret, and Kookynie Road Districts: Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, doth hereby alter the boundaries of the Mount Malcolm, Mount Margaret, and Kookynie Road Districts, by transferring portion of the Mount Margaret Road District territory to Mount Malcolm Road District, as described in Schedule "A" hereunder; by transferring from the Kookynie Road District to the Mt. Malcolm Road District portion of the former's territory, as described in Schedule "B"; by transferring from the Kookynie Road District to the Mt. WHEREAS by virtue of the power conferred by Section 8 of "The Roads Act, 1911," the Governor may by Order in Council re-divide any District into Wards: And whereas it is desirable to re-divide the Armadale-Kelmscott Road District into seven Wards, and allocate His Excellency the Governor, by and with the advice and the number of members for each Ward: Now, therefore, consent of the Executive Council, doth hereby re-divide the Armadale-Kelmscott Road District into seven Wards, with the names and boundaries and the number of members allotted to each Ward as described in Schedule hereunder:—

SCHEDULE.

Kelmscott Ward.

Bounded on the North by part of the North boundary of Road District, from the North-West corner of same to the North-East corner of Location 516.

Bounded on the East by a line starting from the North-East corner of Location 516, and extending Southward along the East boundary of Locations 516, 515, 404, and 330, and its prolongation South to the South bank of the Canning River; thence Eastward along the South bank of said river to its intersection with a West boundary of Canning Location 32; thence South along the West boundary of Canning Location 32 to the North corner of Lease 48/2077.
