Applications should be addressed to the “Commonwealth Public Service Inspector” of the State in which the vacancy exists, and in the case of officers of the Commonwealth Service be forwarded through the chief officer of the department to which the applicant belongs.

Minimum and maximum salaries where shown indicate the limits of the class or grade in which the position is classified. Subject to the provisions of the Public Service Act, appointments may be made at any salary within those limits. Successful appointees must comply with the life assurance provisions of the Public Service Act and Regulations.

# WESTERN AUSTRALIAN GOVERNMENT TRAMWAYS.

## BY-LAW No. 32.

The Rules and Regulations for the guidance of the officers and men employed on the Government Tramways of Western Australia shall be those set forth in the Schedule hereto.

## SCHEDULE TO BY-LAW No. 32.

### GENERAL RULES.

1. In these Rules and Regulations, unless there be something in the subject or context repugnant to such construction—

#### *Employee.*

- (a.) "Employee" shall mean any person whomsoever employed by the Commissioner who has been supplied with a copy of these Rules and Regulations, whether employed in a permanent office or as a supernumerary.

#### *Depôt Master.*

- (b.) "Depôt Master" shall mean the Depôt Master, or person in charge of the Depôt for the time being.

#### *Car.*

- (c.) "Car" shall mean any Tramway vehicle propelled by electricity, or other means, and with or without trail-cars attached.

### *Conditions of Service.*

2. All persons employed by the Commissioner must devote themselves exclusively to his service, and conform to all the Rules and Regulations of the Commissioner; they must reside at whatever place may be appointed, attend at such hours as may be required, and pay prompt obedience to all persons placed in authority over them.

### *Names and Addresses of Employees.*

3. The name and address of each person employed in the working of the Tramways must be registered at the station or depôt to which he is

attached, or at which he is paid, so that if required in case of emergency the employee may be readily found. Any change of address must be at once notified, in order that the record may be kept perfect.

### *Absence from and Exchange of Duty. Illness, Medical Certificate, etc.*

4. No employee is allowed to absent himself from duty, to alter his appointed hours of attendance, or to exchange duty with any other employee, without the special permission of his superior officer. In case of illness or accident he must immediately report the circumstance to his superior officer to admit of a substitute being provided, and should his absence extend over more than one day a Medical Certificate must be furnished if required. Employees absent from any cause must give notice before 4 p.m. on the day previous to resuming duty of their intention to do so.

### *Uniform—Wearing and Care of.*

5. Every employee must come on duty clean and neat in his person and dress; if provided with uniform he must appear in it, with the number and badge clearly visible and in perfect order; and if any article provided by the Commissioner be damaged by improper use it must be made good by the employee using it.

### *Conduct of Employees.*

6. Employees must be prompt, civil, and obliging. They must afford every proper facility for the business to be performed; be careful to give correct information, and when asked, give their names and numbers without hesitation. Employees shall not use improper language or enter into an altercation with the public or their fellow employees, whatever provocation may be given.

### *Safety of Public and Maintenance of Traffic of first importance.*

7. The safety of the public shall be the first and most important duty of every employee; to this, together with the maintenance and regularity of the traffic and comfort of passengers, all work must be entirely subservient.

### *Book of Regulations—To whom supplied.*

8. (a.) Every employee connected with the working of the Tramways must be supplied by his superior officer with, and have with him when on duty and produce when required, a copy of these Regulations.

### *Working Orders, etc.—To whom supplied.*

(b.) Every Depôt Master, Inspector, Clerk, Foreman, Ticket Examiner, Starter, Shunter, Motor-man, Conductor, Pointsman, Flagman, Switch-board Attendant and Ganger, connected with the working of the Tramways must be supplied with, and have with him when on duty, a copy of the working orders, also the current time-table and Weekly Notice.

### *Lost Copies of Regulations to be replaced.*

9. If any employee loses his copy of the Rules and Regulations, Time-Table, Working Orders, or other document necessary for the performance of his duty, he must immediately report the loss in writing and obtain another copy from his superior officer.



*All Employees must assist in carrying out Regulations, etc.*

10. (a.) Every employee must assist in carrying out the Regulations, By-laws, and Working Orders, and immediately report to his superior officer any infringement thereof, or any occurrence which may come under his notice affecting the safe and proper working of the traffic.

*Applications for Instructions in case of doubt.*

(b.) In any case where an employee does not understand his duty, or is in doubt as to his duty, he must apply without delay to his immediate superior for instructions.

*Giving Security.*

11. Employees holding situations of trust will be required to find security for their fidelity of such kind and in such manner as the Commissioner may determine, and the officer responsible must see that security is given by those members of the staff who are entrusted with the handling of cash.

*Intoxication.*

12. (a.) If any employee in charge shall consider at any time that any employee under his direction or supervision is unfit to perform his duties properly by reason of being under the influence of intoxicants, he shall relieve him from duty and immediately report the matter to the Head of the Branch by or through his immediate superior.

*Taking or obtaining intoxicants forbidden.*

(b.) Employees are forbidden to take intoxicating liquor or to have it in their possession while on duty.

*Gambling.*

(c.) Gambling on Tramway vehicles or premises is strictly forbidden.

*Fees or Gratuities must not be accepted.*

13. No gratuity is allowed to be taken from passengers or other persons by any employee.

*Trading forbidden.*

14. No employee shall trade, either directly or indirectly, for himself or others.

*Presentations.*

15. No employee shall accept a presentation without the consent of the Commissioner.

*Patents for Tramway Appliances not to be applied for without permission.*

16. No employee shall take out a patent for appliances previously tested or used on the Tramways.

*Misconduct punishable.*

17. (a.) The Commissioner may at any time, without notice, dismiss, or his officers may suspend from duty, any employee for intoxication, disobedience of orders, negligence, or misconduct, or for being absent from duty without leave, and no wages or salary from the date of his suspension can be claimed from the Commissioner by any employee after dismissal, or during the period of his suspension from duty, or during his absence from duty from any cause.

*Fines.*

(b.) The Commissioner or his officers may impose fines not exceeding five pounds in respect of disobedience of orders, neglect of duty or any other omissions, and deduct from the wages or salaries of employees such sums as are deemed advisable.

*Right of Appeal.*

(c.) i. Should any employee think himself aggrieved at any time, he may appeal to the Head of his Branch, and finally to the Commissioner, but in such case the Appeal must be sent through the Head of his Branch.

ii. Any permanent employee, who has been continuously employed for one year, and who has been fined, or reduced to a lower class or grade, or dismissed, may appeal to the Appeal Board in the manner laid down in the Appeal Board Regulations.

*Not to leave the Service without giving the required Notice.*

18. (a.) No employee, unless temporarily employed, will be allowed to leave the Service without giving the following notice in writing of his intention to do so, under pain of forfeiting any salary or wages which may be due:—

Officers paid by yearly salary—One (1) month.

Employees paid by daily wages—Fourteen (14) days.

*Leaving without Notice.*

(b.) Any employee will also be held liable for any loss, damage, inconvenience or expense which may be occasioned by his leaving without giving such notice, unless permission to leave the service has been obtained from the Head of his Branch.

*Articles supplied to be taken care of and returned on leaving the Service.*

19. When an employee leaves the Service, he must immediately deliver up his uniform and all other articles belonging to the Commissioner. Any money that may be due for wages to any employee leaving the Service will not be paid until the clothing, book of rules, bag, lamps, flags, tools, detonators, and all other articles the property of the Commissioner which may have been supplied to him, shall have been delivered up or satisfactorily accounted for in accordance with these Rules. If not delivered up, or if any article be missing, or be damaged by improper use, the cost of such article, or of the repair of such damage, shall be a debt due from the employee to the Commissioner, and may be deducted from any pay then due, or, if such pay be found insufficient to meet the claim, will become a debt recoverable at law.

*Property of the Commissioner not to be converted to Employee's use.*

20. Every employee shall be held responsible for the careful use and preservation of all articles belonging to the Commissioner in his custody or care, and no employee will be allowed to convert to his own use any such article.

*Rent.*

21. The Commissioner may deduct from the salary or pay of any employee, who is a tenant of any premises vested in the Commissioner, any sums that may be due by him for rent in respect of such premises.



*Travelling without Pass or Ticket forbidden.*

22. No person not specially authorised by the Tramway Traffic Superintendent will be allowed to travel on the tramways unless provided with a proper ticket or free pass.

*Unnecessary conversation forbidden.*

23. Employees are forbidden to converse with passengers or with each other to the neglect of their duty.

*Lost Property.*

24. Unclaimed or lost luggage, money, or other property, found on the Tramway line, vehicles, or premises, must be immediately delivered to the proper officer, and dealt with by him in accordance with the instructions upon the subject.

*Getting between vehicles to couple or un-couple them, etc.*

25. (a.) Every employee shall exercise proper care in getting between vehicles for the purpose of coupling or uncoupling them, and in the performance of any other duty which necessarily exposes such employee to danger or risk of personal injury.

*Reckless exposure to danger to be prevented.*

(b.) Every employee must prevent, as far as possible, reckless exposure to danger on the part of any other employee.

*Trespassing.*

26. (a.) Persons, other than employees or those having business with the Department, must not be allowed to enter any Dépôt, Power House, or Workshops without the permission of the Officer-in-Charge.

*Removal of Trespassers.*

(b.) Unless instructions are issued to the contrary, any person trespassing must be requested to leave the premises, and, on complying, must be warned not to go or pass thereon again. If such person refuse to quit, he must be requested to give his name and address, which must be handed to the Dépôt Master, or other superior officer, with a report of the circumstances. In the event of the offender refusing his name and address he must be detained and given in charge of the police.

*Disorderly Passengers.*

27. (a.) In the event of any passenger being disorderly and annoying other passengers, the Conductor or other authorised employee must use all reasonable means to stop the annoyance; these failing, he must, for the safety and comfort of all, remove or cause to be removed such person from the car.

*Intoxicated Passengers.*

(b.) No person in a state of intoxication will be allowed to enter or remain on a car.

*Legal proceedings not to be taken without authority. Communications to persons not entitled thereto forbidden.*

28. (i.) No employee shall undertake any legal proceedings on behalf of the Commissioner, or on behalf of any other employee.

(ii.) Except in the course of official duty, no information concerning public business or any matter of which an employee has knowledge officially shall

be given, directly or indirectly, by an employee without the express direction or permission of the Commissioner.

An employee shall not—

(a.) Publicly comment upon the administration of any Department of the State; or

(b.) Use, for any purpose other than the discharge of his official duties, information gained by or conveyed to him through his connection with the Department.

*Responsible Officers to see that proper Books and Accounts are kept.*

29. (a.) Every officer is responsible for each person under his control keeping the proper record, books, and accounts applicable to his duty. Any employee failing to report an irregularity which may come to his knowledge will incur the same responsibility as if he were the person in fault.

*Responsibility of Officer-in-Charge.*

(b.) Every officer in charge of a district or dépôt is answerable for the security and protection of the offices and buildings, and of the property of the Department under his supervision. He is also responsible for the faithful and efficient discharge of the duties devolving upon all employees under his charge, either permanently or temporarily employed in the district or at the dépôt, and such employees are subject to his authority and directions in the working of the line. He is also responsible for the general working of the district or dépôt being carried out in strict accordance with the regulations.

*Notices to be exhibited.*

(c.) The Dépôt Master must see that a copy of every notice connected with the duties of the employees under his supervision is posted in a place accessible to them. He must also see that copies of the notices, such as list of fares, charges, By-laws, and penalties, are fixed in a conspicuous place at the Dépôt or Offices, and employees responsible must always be prepared to prove that such notices are properly exhibited.

*Employees to forward communications only through their superior officers; not solicit outside influence.*

30. Employees must not address communications in connection with their public duties or positions in the Service other than through their immediate superior officers, or use or obtain outside influence either directly or indirectly to represent their requirements.

*Age of employees engaged in safe working.*

31. Employees under 21 years of age must not be engaged in any of the following positions:—Inspectors, Foremen, Motormen, Gangers, and Pilot-men.

*Reports against employees to be made within seven days.*

32. Any employee who has cause to complain of, or make a report against, any other employee shall make the complaint through his immediate superior to the Head of his Branch within seven (7) days of the occurrence.

*Employees not to leave duty until relieved.*

33. (a) In any case in which one employee is appointed to relieve another, the person about to be relieved shall not, under any pretext, leave duty until the employee appointed to relieve him arrives.

*Full information must be given when employees change duty.*

(b.) On the change of duty between employees, all circumstances which may have occurred out of the ordinary course of working must be communicated to the employee coming on duty before he takes charge.

*Sobriety of person relieving.*

(c.) No person employed in any capacity shall give up charge to any other person, whose duty it may be to relieve him, unless the person being relieved shall be satisfied of the sobriety of the person whose duty it may be to relieve him.

*Employees not to borrow money from other employees.*

34. Employees are strictly forbidden to borrow money from, or to place themselves under any pecuniary obligation to, other employees.

*Employees not to smoke on duty.*

35. Employees in uniform are strictly forbidden to smoke while on duty, except at such times and places as may be authorised by the Tramway Traffic Superintendent.

*Witnesses in Court cases.*

36. Any employee attending in his official character under a subpoena or order to give evidence, or to produce papers in any Court, shall attend such Court in performance of and as part of his official duty. He must as early as possible after the receipt of such subpoena acquaint his superior officer with the fact, and obtain his permission for absenting himself. He shall remit or cause to be remitted to the Head of the Branch, or other employee authorised to receive such, all fees received by him for the performance of such duty, together with a statement of account and vouchers of the necessary expenses (if any) incurred by him in the performance of such duty.

*Violence not to be used.*

37. In the case of violation of the Government Tramways Act or of the By-laws of the Commissioner, not affecting the safety of the public or their property, and it becomes necessary, and is justifiable to use force, it must only be done when all other means fail, and then only such force or compulsion must be used as may be absolutely necessary.

*No person to be detained whose name and address are known.*

38. As a general rule, great caution is to be observed in detaining or giving any person, more particularly a passenger, into custody, and as the detaining or giving anyone into custody is only for the purpose of insuring his appearance to answer any charge that may be preferred against him, no one should be detained whose name and residence are known either to the Conductor or other officer, or to any respectable person with whom such officer may be acquainted, or who may give an address and produce sufficient evidence that it is genuine.

*Removal of offenders.*

39. If, after being warned to desist, it becomes necessary to remove any passenger from a car for smoking, or other cause where the foundation of the charge appears to be doubtful, he should be first requested to leave; and if he refuse, care should be taken not to use unnecessary force in removing him, and it is desirable that the Conductor or other employee, on warning him to desist, shall first state to him that he is liable, if he persist in smoking or otherwise offending, to incur a penalty, and to be removed.

*Offences to be investigated.*

40. Before anyone is removed from a car, the Conductor in charge must carefully ascertain the nature of the offence, and obtain the names and addresses of the offender, the persons complaining, and of witnesses to the occurrence.

*Police to be called when practicable.*

41. Where the aid of Police can be obtained it is desirable to call a Constable to take any charge which it may be necessary to prefer.

*Persons to be warned against violating Act or By-laws.*

42. (a.) Employees, who may have reason to believe that any person is about to commit any offence against the provisions of the Government Tramways Act or the By-laws of the Commissioner, may respectfully warn such person against the committing of such offence.

*Violation of Act or By-laws—Witnesses.*

(b.) Should any such offence be committed, any employee observing the same must use every endeavour to obtain the correct names and addresses of offenders and as many witnesses as can be procured, and report the occurrence with all particulars to his superior officer without delay.

*In case of detention, immediate report to be made.*

43. (a.) Whenever any person is detained or taken into custody a telegraph or telephone message, stating his name, address, and occupation, and the nature of the charge, is to be forwarded to the Head of the Branch instantly, and a written report is also to be sent by the next car, or as soon after as possible, stating, with the particulars of the case, when and where the charge is to be heard.

*Person detained to be taken before a Magistrate.*

(b.) Any person taken into custody should be taken before a Magistrate as soon as practicable.

*Uniform time to be kept.*

44. Employees whose duties require them to carry watches must regulate the same daily by the standard clock of the district in which they are employed.

*Employees to render assistance when required.*

45. (a.) All employees, whether on or off duty, must render assistance when called upon by an officer or by the Conductor in charge of a car, who must report the occurrence.

*Employees to perform such other duties as may be required.*

(b.) All employees will be expected to perform such other duties in addition to, or in place of, their regular duties, as their superior officers may direct.



*Accidents or wilful obstruction—Reports.*

46. (a.) Should an accident occur, or the track be wilfully obstructed, the Conductor or other authorised employee must obtain the names and addresses of those concerned and also of two or more witnesses if possible, and full and complete information as to the facts must be reported in writing as soon as possible. In the case of a serious accident, the Motorman and Conductor should ask to be relieved in order to make such report.

(b.) All employees who are witnesses of such an occurrence, also the Motorman and Conductor of car concerned, must furnish reports in a similar manner.

*Discretion required in performance of duty.*

47. In all matters not fully covered by these regulations, employees are expected to use judgment and discretion in performing their duties, and in dealing with passengers and any others with whom they may come in contact.

**SIGNALS.***Fixed Bell Signals.*

48. STOP—One ring.  
ALL CLEAR, PROCEED—Two short rings.

*Hand Signals.*

49. Hand signals will be made by hand or flags by day, and with lamps by night or in foggy weather.

*Danger, Stop—*

- (a.) A red flag or red light.
- (b.) One or both arms held above the head.
- (c.) In the absence of a Red Light any light waved violently.
- (d.) Any unusual or imperfect signal, or the arm waved violently.

*Caution, proceed slowly—*

- (a.) A green flag or green light.
- (b.) One arm waved slowly up and down.

*Move away from person Signalling—*

One arm, or white light, waved slowly up and down towards the driver.

*Move towards person signalling—*

One arm, or a white light, waved across the body.

*Permanent Way Signals.*

50. (a.) A green flag or green light, fixed near the track, or exhibited by trackmen or flagmen, indicates that cars must reduce speed to walking pace, or to such speed as may be prescribed by special instructions, over the portion of the line protected by such signal.

(b.) A red flag or red light indicates danger, and will be used when it is necessary to stop a car.

*Overhead Line Signals.*

51. Wire obstructed, pull down trolley and coast past defect—

Red flag or red light attached to overhead line.

Wire under repair, proceed slowly and watch trolley—

Green flag or light attached to overhead line.

A Motorman approaching either of the above signals must signal to his Conductor and see that he is attending to trolley before he passes under the defect.

*Car Signals—Conductor to Motorman.*

52. Car Signals: Conductor to Motorman—

Stop at stopping places only—1 bell.

Go ahead—2 bells.

Stop as early as possible within reasonable distance—2 slow bells (when car is in motion).

Stop, Danger—3 bells.

Full load, close front gate, stop only at stopping places—4 bells.

*Car Signals—Motorman to Conductor.*

53. Car Signals—Motorman to Conductor—

Apply rear brake—1 bell.

Let off rear brake—2 bells.

Come forward—3 bells.

Attend to trolley—4 bells.

Before starting from a terminus or stopping place, before passing standing cars, before entering sharp curves or cuttings, when approaching side and cross streets, to warn persons to clear the track, and in all cases not otherwise specified—2 sounds of gong.

**WORKING OF CARS.***Employees to examine Notices.*

54. Before starting and after concluding his day's work, each Motorman and Conductor must examine the notices and rosters affixed to the notice boards at the depôt, in order to ascertain if there is anything requiring his special attention.

*Authorised Drivers.*

55. (a.) The only person authorised to drive any car are employees who have been duly passed as competent to take charge of same; or men who are learning the duties of Motormen in accordance with the instructions dealing with such training, but in such cases the Motorman will be held responsible for safe-working of car.

*Unauthorised employees not to move Motors.*

(b.) Unauthorised employees are not on any account to move cars, whether inside or outside of sheds.

*Motormen's position while running.*

56. The position of the Motorman while car is in motion will be one hand on the controller or regulator handle and the other on the brake, and he will only leave this position when absolutely necessary.

*Employees to be with Car.*

57. (a.) Each Motorman and Conductor must be with his appointed vehicle for such time previous to leaving and after returning to the depôt as may be ordered.

*Motormen responsible for condition and equipment of Car.*

(b.) The Motorman will be responsible for having his vehicle in running order, and properly equipped with such tools, stores, and appliances as may be required before leaving the depôt and during the time the car is on traffic.

*Motormen to obey Conductor's Signals.*

58. The Motorman will receive his orders from the Conductor in charge or other authorised traffic employee in all matters affecting the starting, stopping, or movements of the car.



*Car to be in good order and defects reported.*

59. The Motorman will be held responsible for the safe condition and running of his car, and must, if any repairs are required, report the same immediately to his Foreman, and on arrival at the depôt enter in a book kept for that purpose the defect requiring attention, also the condition of each car.

*Conductors to examine Car for defects.*

60. Conductors when taking charge must carefully examine the cars, and especially the windows, lamps, hose, and other couplings, and should they find damage of any kind, report same in writing to their Depôt Master at once. Conductors in charge will be held responsible for all defects of the kind found on the car and not reported.

*Care of Rolling Stock.—Violent application of brakes.*

61. Every care must be taken to avoid damage to rolling stock or equipment. Brakes must not be applied violently or motors reversed while running, except in case of emergency.

*Power Brake—Working of.*

62. Motormen must carefully watch the working of the power brake, where provided, and see that it is maintained in proper working order; they must test the brake by making an application immediately after taking a car out of a depôt, also each time a car is attached or detached.

*Power Brake—Defective.*

63. Should the power brake be defective, the Conductor must be informed at once, and the car controlled by means of hand brake.

*Interference with equipment.*

64. Unauthorised persons must not be allowed to interfere with couplings or the brake taps or connections, or to handle the driving apparatus or other equipment of cars.

*Cars not to be left unattended.*

65. The Motorman when on duty must not leave his car unless it is absolutely necessary, and in such case he must take his controller handles with him, and the Conductor or other competent employee must first be placed in charge.

*Motorman to secure Car before leaving.*

66. (a.) When a car is left standing at a terminus or loop it must be properly secured by hand brakes or sprags, and the Motorman must open the main switch and carry the controller and reversing handle with him.

*Vehicles in Siding to be secured.*

(b.) Every vehicle, when standing in a siding, must be properly secured, by hand brakes or sprags, to prevent it from moving and fouling other lines.

*Power Brake not to be used to secure vehicles.*

(c.) The power brake is not to be used to secure unattended vehicles.

*Cars left in Depôts.*

67. When a car is left standing in a Depôt the Motorman must see that the controller and reversing handles are removed, and placed on end of car nearest entrance, and the main and brake switches, also air drain cock, opened. The Motorman must remove the trolley from the wire, reverse and properly secure it.

*Stores, Economy of.*

68. The strictest economy must be observed in the use of all stores, and each employee will be held responsible for the stores, tools, etc., issued by him.

*Avoid stopping on Curves or Reversing Motors.*

69. A car should not be stopped on a sharp curve, except in case of emergency, nor motors reversed while in motion, except to avoid accident, and then it must be done carefully. The power must be cut off before reversing the motors. Every case of reversal must be reported.

*Reversal of Motors.*

70. Should it be necessary to reverse the motors, the power must be applied very gradually, as a little will usually stop the car quickly, while a sudden application of the power may cause skidding of the wheels or damage to the machinery. The reversed power must be cut off immediately the car stops.

*Current to be cut off at Frogs, etc.*

71. (a) Motormen must cut off the current when passing overhead frogs, except when necessary to negotiate the grade or crossings, open section insulators, fittings at car-shed doors, "cut-off" signs, or a break in the wires.

*Reduced Speed at Points, Curves, etc.*

(b.) Motormen must pass over points, crossings, curves, overhead frogs, and rough or disturbed track at reduced speed and signal Conductor to attend to trolley when necessary.

*Defective Motors to be cut out.*

72. Should a motor be found to be defective, it should be cut out, but this must not be done unless the main or automatic switch is open.

*Fuses and Electric Lamps.*

73. Only the authorised fuse or lamp is to be used in any electric circuit.

*Cleanliness of Cars.*

74. Conductors must keep the cars under their charge clean and free from dust, and in every respect in good order.

*Responsibility of Motormen.*

75. (a.) The Motorman is held responsible for the safe running of his Car, for the proper operation of its mechanism, and for the maintenance of the Timetable.

*Responsibility of Conductor.*

(b.) The Conductor is in charge of the passengers, and is held responsible for the safety and convenience of the passengers and intending passengers, and for the collection of and proper accounting for the fares and charges.

*Motorman and Conductor to work in harmony.*

(c.) It is essential that the Conductor and Motorman should work in complete harmony. Assistant Conductors will be under the control of the Conductor in charge, who will be responsible that their duties are properly performed.

*To start with care and run on proper Line.*

76. The Motorman must start and stop his car carefully and without a jerk, and pass along the proper line, which, in the case of an ordinary double line, is the left-hand line in the direction in which the car is travelling.



*Stopping of Cars.*

77. Motormen must be careful not to overrun or stop short of stopping-places; the gradient, state of the weather, and conditions of the rails, as well as the weight and length of the car, must be considered in determining when to shut off power and apply the brakes.

*Approaching Standing Cars and Side Streets.*

78. (a.) Motormen must observe the utmost caution when approaching cars standing on the opposite line, side streets, junctions, or line intersections, and when running through crowded thoroughfares.

*Warning Signal to be Sounded.*

(b.) Warning signal must be sounded on approaching all side and cross streets.

*To Regulate Speed.*

79. The Motorman must regulate the running of his car as accurately as practicable, according to the time-table, so as to avoid extreme speed or loss of time.

*Empty Cars.*

80. Motormen must not exceed the ordinary speed when running cars not carrying passengers; they must exercise the same care as when working a passenger car, and avoid unnecessary ringing.

*White Headlight to be Shown.*

81. A white light must be displayed on the front of each car when on any part of the running lines between sunset and sunrise or in foggy weather.

*Churches, Passing during Service.*

82. Motormen must pass all churches and other places where Divine Service is held, slowly and quietly during the hours of service on Sundays, Christmas Day, and Good Friday, and avoid ringing as much as possible.

*To look both ways before starting.*

83. After the Conductor has given the signal to start, Motormen must look both ways and satisfy themselves that all is clear before the car is moved.

*Conductor to see All Clear.*

84. (a.) Assistant Conductors must notify the Conductor in charge when all is clear on the car.

*Assistant Conductor not to give Starting Signal.*

(b.) Assistant Conductors must never give a signal to the Motorman to start a car, but always leave that duty to the Conductor in charge.

*Care when approaching Persons on Track or Foot-boards.*

85. When approaching employees at work on the track or overhead wires, or cars with persons improperly standing on inner side footboards, the Motorman must sound the gong, and be prepared to stop instantly if required.

*Not to stop where Roadway Disturbed.*

86. Cars must not be stopped to pick up or set down passengers where the track or roadway is broken or disturbed, or where any obstruction is near the track, except by direction of an officer.

*Motormen to watch facing points.*

87. (a.) Motormen must satisfy themselves that facing points are in proper position before passing over them.

*Watchfulness required.*

(b.) Motormen and Conductors must at all times keep a sharp look-out, and exercise the greatest watchfulness in order to prevent accidents or injury to the public.

*Restive horses.*

88. (a.) Motormen must be careful to slow down on overtaking or meeting a restive horse, and pass it cautiously; if necessary, they must at once bring the car to a stand.

*Warning when approaching persons, etc.*

(b.) A Motorman noticing any person, horse, or vehicle on or close to the track, must, if time permits, sound his gong.

*Reversal of motor to avoid accident.*

(c.) If he perceives no notice taken of his warning, he must shut off power and apply his brake, and may, if necessary, reverse his motor to stop in the shortest possible time.

*Not to take risk of accident.*

(d.) When Motormen have sounded a warning signal, they must not trust to persons, horses, or vehicles moving immediately out of their way, but must be prepared to stop at once and make certain of the road being clear before proceeding, even at the risk of delay.

*Disabled car to be assisted.*

89. (a.) In the event of a car coming to a stand, and being unable to proceed, the Conductor must apply the car hand-brakes, and arrange (after consulting the Motorman) for the following car to assist his car forward.

*Starting of assisted cars.*

(b.) Before starting cars with an assistant car or cars attached, the Motorman of the rear car must sound the gong. This must be repeated by the Motorman of each succeeding car; and as soon as the Motorman of the leading car repeats the signal all Motormen must apply power simultaneously.

*Motormen to obey leading Motorman's signals.*

(c.) The Motorman of each assistant car must carefully watch for and promptly obey the signals of the Motorman of the disabled car.

*Space between cars.*

90. Motormen, while running, should not approach within one hundred (100) feet of a preceding car, except at reduced speed. Care must be taken not to draw nearer than five (5) feet to any obstruction on, or fouling the track. A side street, entry, or vehicular crossing must not be blocked by running up to a standing car or street vehicle.

*Approaching stopping places where car is standing.*

91. (a.) When approaching any stopping place where a car is already at a stand in front, the speed of the approaching car should be so regulated as to enable it to arrive at the stopping place as the car in front moves away.



*Car not to be moved without signal.*

(b.) Once the car comes to a stand, whether at a recognised stopping place or not, Motormen must not move until they receive a signal from the Conductor or a Traffic Officer to do so.

*To stop on near side of street.*

92. When stopping places occur at the intersection of streets, Motormen must come to a stand before crossing the street, except where otherwise directed by stop-marks or special notice.

*Stopping places.*

93. Conductors must see that cars in traffic, not otherwise directed, or as provided in Regulation 95, are stopped at all "regular" stopping places, whether they have passengers aboard or not, and when there are passengers to pick up or set down must give Drivers the proper signal before arriving at "conditional" stopping places. Cars are only to be stopped for passengers at the authorised stopping places, except as provided in Regulation 86.

*"Through" cars approaching stops, etc.*

94. Motormen of "through" cars approaching cross-streets, stopping places, or places where other cars may be taking up or setting down passengers must exercise the greatest caution, and come to a stop if necessary; they must also proceed cautiously if there is a pick-up car close in front, so as to be able, in case of need, to stop short of the preceding car.

*Loaded cars running through.*

95. (a.) If the cars are fully loaded so as to be unable to accommodate more passengers, the Conductor in charge may instruct the Motorman to pass certain stopping places, but care must be exercised that passengers are not over-carried.

*Spacing cars.*

(b.) Inspectors and Starters may give similar instructions when it becomes necessary to space the cars.

*Running through stopping places.—Caution.*

(c.) Should such instruction be given, the Motorman must in every case sound the gong prior to passing any stopping place, and must use every precaution to prevent accident.

*Speed when approaching junctions, etc.*

96. (a.) Motormen must approach junctions, line intersections, termini, and such other places as may be indicated by special notice, at such speed as will enable them, should necessity arise, to stop at the proper place by means of the hand-brakes only.

*Conductor to apply hand-brake when signalled.*

(b.) The Conductor must be signalled to apply the rear handbrake when necessary (1 bell).

*Vehicles not to stand foul of running lines.*

97. Cars must not be allowed to stand foul of any running line, and where the clearance is doubtful, or any obstruction is near the line, Motormen must satisfy themselves that there is room before passing.

*Protection of shunting operations.*

98. No vehicle is permitted to be shunted or moved from one Main line to the other, or cross, enter, or leave the Main line until properly protected

by Hand Signals in one or both directions, as may be required, and care must be taken, when the Main line is about to be obstructed, to allow sufficient time to elapse for any approaching car (which may be near) to be brought to a stand before the obstruction is allowed. When a Conductor is on the car he must see that this is done; in his absence the Motorman will be held responsible.

*Passengers not to stand on front platform.*

99. (a.) Passengers must not be allowed to stand on the front platform of cars.

*Passengers not to hang on to or jump off cars.*

(b.) Passengers or other persons must not be allowed to hang on to the cars, nor are they permitted to run about on or jump on or off the cars while car is in motion.

*Power to be off before Brakes applied.*

100. (a.) When making a stop, Motormen must take care that the power is quite off before applying the brakes.

*Brakes to be applied gradually.*

(b.) The brakes should be applied gradually, except in cases of emergency, so as not to cause the wheels to skid or discomfort to passengers.

*Control Cars on descending grades.*

101. Perfect control must be kept of the car, and the trolley cars kept in contact with the wire, when descending grades.

*Trolley to be run trailing.*

102. The trolley must be run trailing, except for a short distance on a straight wire where some obstruction prevents reversal of trolley, in which case trolley must be held by Conductor and car moved slowly.

*Trolley off Wire.*

103. Should the trolley leave the wire, the Conductor must immediately signal the Motorman, and pull the trolley down. The Motorman must always turn the controller to "Off" and the car must be stopped. On no account should the trolley be replaced unless the controller is "Off." Cases of trolley leaving the wire must be reported and particulars of any damage done.

*Speed when replacing trolley.*

104. (a.) After running with the trolley off the wire at crossing-loops or other places, the car must be slowed down to four miles per hour during daylight, and brought to a stand after dark, whilst the trolley is being replaced.

*Running with trolley off wire forbidden.*

(b.) Running with the trolley off the wire, except at authorised places, is strictly forbidden.

*Failure of electric power.*

105. (a.) Should the current from the power station be cut off, Motormen must throw the controller handle to "Off," stop the car, switch on the lamp circuit, and watch for the light to appear.

*Starting after electric power failure.*

(b.) When the power is fully on, as indicated by the lights burning brightly, up cars must start away gradually, each Motorman waiting till he sees the car ahead well in motion, but Down cars must wait a full minute before they also start in same manner.



(c.) Motormen must not go into parallel for three (3) minutes after starting, and must report place, time, and duration of all power failures.

*Punctuality of Cars.*

106. Cars must not be started from any place before the time stated in the time tables. Every effort must be used for ensuring the despatch of cars at the appointed time, and the punctuality of the traffic.

*Passengers to be safely on or off before Conductor starts car.*

107. Great care must be exercised by Conductors in satisfying themselves that all persons have safely alighted from or entered the cars before they give the signal for the Motorman to start.

*Announcing names of stops, etc.*

108. Conductors must distinctly call out the name of each stopping-place and also, where necessary, the destination of the car.

*Look-out for Passengers.*

109. Motormen and Conductors must keep a sharp look-out for intending passengers. Before passing a conditional stopping-place they must satisfy themselves that no persons wish to enter or alight.

*Destination signs to be exhibited.*

110. Motormen and Conductors must see that the destination signs are correctly exhibited on their cars.

*Conductors of "Through" cars to announce next stop.*

111. Conductors' working cars known as "Through" cars, which do not stop at all stopping-places, must call out the names of the streets at which the next stoppage will be made, when any of the usual stopping places are to be passed.

*Unusual stop. Passengers to keep seats.*

112. When any unusual stop during a trip is made, the Motorman and Conductor must request passengers to keep their seats.

*Fares—Collection of.*

113. (a.) As soon as possible after passengers have entered the car Conductors must politely request their fares, and tickets representing the fares received must be issued immediately, together with the proper change, while facing the passenger.

*Examination of Tickets.*

(b.) At the commencement of each fare section, or at any time when in doubt as to passengers having paid their proper fares, Conductors must politely request the production of tickets.

*Cash to be carried in proper bag.*

(c.) All moneys, the property of the Commissioner, but no other, must be carried in the bags provided for the purpose.

*Car lighting.*

114. Conductors are responsible for the lighting of the car lamps when required, and all lamps must be extinguished when cars are out of service each night.

*Backing a Car.*

115. (a.) Should it be necessary to move a car backwards it must be done slowly and carefully, the

Conductor standing in such a position as to command a clear view of the line in the direction in which the car is moving, and he must be ready to signal the Motorman to stop instantly.

*Backing over Points.*

(b.) Conductors must see that points which become facing are properly set before signalling their car over them.

*Shunting, control of vehicles.*

(c.) When shunting cars the person in charge must so control the vehicles as to stop clear of any obstruction.

*Assist Passengers to find seats, and when alighting.*

116. Conductors must assist passengers to find seats when the cars are nearly full, and must also render assistance to elderly or infirm persons, or ladies accompanied by children, when entering or alighting.

*Position of Conductor in Charge.*

117. During a journey, when not engaged elsewhere, the Conductor in charge must stand within reach of the trolley cord at the rear of his car, so as to command a view of the whole of it.

*Conductor to pay attention to Motorman's signals.*

118. Whenever a Motorman gives a danger signal the Conductor must pay immediate attention, and do all he can to avert accident, and he must also be in a position to give full particulars should an accident occur.

*Motormen and Conductors to report irregularities.*

119. Motormen and Conductors must report as soon as possible any instance of travelling too quickly through points or over crossings, or faster than permitted by special instructions; any indication of defect in the track or overhead wires; any instance of cars derailed, or receiving any strain or injury; any defective brakes or couplings; any instance of cars shunted violently or running unsteadily; any accident, delay, neglect, or other irregularity or deviation from the requirements of the Regulations, By-laws, or Working Orders.

*Defects in Permanent Way and Wires—reporting.*

120. Motormen and Conductors must at once inform the first officer met with and the employee in charge at the terminus, and report in writing on arrival at the Depot, any defect in or about the track or overhead wires which they may have observed, and which requires immediate attention. Notice must also be given to any employees who may be met near the spot, who must at once proceed to the defective point and protect it if it is not in their power to effect repairs.

*Ballast or Work Cars not to interfere with Traffic.*

121. Water ballast or work cars must be regulated so as not to interfere with passenger traffic.

*Loads of Ballast or Work Cars.*

122. Men in charge of ballast or work cars must see that their loads are properly and safely stowed, and that no portion projects in such a manner as to be likely to cause injury to persons, vehicles, or structures.



**PERMANENT WAY—OVERHEAD LINE AND WORKS.***Trackmen to have Gauge and Signals.*

123. Each gang of Trackmen must be supplied with a Permanent Way Gauge, two sets of Flags, and two hand Signal Lamps. Each Ganger will be held responsible for having his signals constantly in order and ready for use.

*Inspectors responsible for observance of Regulations.*

124. Inspectors of Permanent Way and Works must take care that all Regulations affecting Permanent Way are observed, and report any departure from these to the Engineer.

*Addresses of men to be kept by Inspector.*

125. Each Inspector must have a register of the names and places of residence of all men employed in his district so that, in case of accident, he may be enabled to summon them immediately.

*Obstruction of Double Line, Danger Signal to be exhibited.*

126. When it is necessary to change or turn a rail; or if from any cause the line is unsafe, or previous to any Trackmen's trolley or other obstruction being placed upon the line, or in the event of any ballast or other work car being obliged to remain stationary on the line, or to move so slowly as to be in danger of being overtaken, a danger signal must be plainly exhibited, at a sufficient distance from the point where such obstruction or danger exists, in the direction of any coming car (even if no car is expected) by the Ganger, or by a competent man appointed by him, who must continue to exhibit the signal until he receives orders from the Ganger to withdraw the signal; such order, however, must not be given until the obstruction is completely removed.

*Obstruction of Single Line, Danger Signal to be exhibited.*

(b.) If the obstruction occurs on a single line of Tramway, the Ganger must arrange for danger signals to be exhibited at a sufficient distance in both directions.

*Employees to keep clear of Cars.*

127. (a.) When a car is approaching, employees at work on the Permanent Way must not remain on any running lines, nor between them, but must at once move clear of all lines, unless they can distinctly see that they are in a position of safety, and in no danger from another car approaching them unobserved; the employees must stop in the positions they have taken up till the car has cleared a sufficient distance to enable them to see that no car is approaching on the other lines before they recross the rails.

*Protection of Working Parties.*

(b.) Where the approach of a car cannot be observed or heard in time for the employees to get out of the way, a Flagman or other competent employee must be appointed by the Ganger to give the necessary warning. On single lines the working party must be protected in both directions.

*No Blasting without Authority.*

128. Blasting or excavations which will be likely to interfere with the stability of the line must not be allowed on or near the Tramways without the authority of the Engineer.

*Time for effecting Repairs.*

129. (a.) The times for effecting repairs which involve the stopping of cars must, as far as practicable, be so selected as to interfere as little as possible with the passage of the traffic.

*Removal of Rail—New Rail to be in readiness.*

(b.) In all cases before taking out a rail the Trackmen must have, at the spot, a perfect rail in readiness to replace it.

*Rails not to be displaced in Foggy Weather, unless absolutely necessary.*

(c.) Unless absolutely necessary, a rail must not be displaced, nor must any other work be performed, during a fog by which an obstruction may be caused to the passage of the Cars.

*New Works or Alterations.*

130. (a.) New works or alterations must be carried out in such a way as not to interfere with the safety of the line.

*Roadway under Repairs, protection of Traffic.*

(b.) When it is necessary to disturb the surface of the roadway all material must be kept clear of the car foot-boards. Proper signals must be exhibited to warn vehicular and foot traffic, necessary crossing places provided, and every effort made to ensure the safety and convenience of the public.

*Repairs to Rail Bonds.*

131. When repairs or alterations to the Permanent Way affect the Rail Bonds, due notice of the occurrence is to be given to the Traffic Inspector.

*Trucks or Trackmen's Trolleys to be run in proper direction and to be protected.*

132. When a Truck or Trackmen's Trolley is run empty, or used for conveying materials or men along the line, if the line is double, it must be taken in the same direction as the cars run and be suitably protected by the ordinary signals.

*Unauthorised Persons not to carry out Repairs.*

133. No person other than a duly authorised person is to be allowed to carry out any work whatsoever, on, over, or under the tram lines without the written authority of the Engineer.

*Defects in Overhead Line to be reported.*

134. In event of any defect in or damage to the overhead wires, the proper officer must be informed, and, if necessary, the damaged part must be protected until repaired.



*Fallen Overhead Line.*

135. If a trolley or feeder wire should break or fall to the ground, employees must endeavour to draw the wire from contact with the rails and secure it, and must warn all foot-passengers or persons in charge of vehicles to keep clear of the wire until the section is cut out. The wire must be held by trolley tongs or a dry coat, hat, rope, or other non-conductive material to avoid shocks.

*Points to be Examined and Adjusted.*

136. (a.) All points and crossings and Scotch blocks must be carefully examined, points cleaned daily, and, if necessary, adjusted.

*Oiling of Points.*

(b.) Gangers must oil and keep clean the working parts of points, unless the duty is otherwise provided for.

*Guys and Scaffolding to be kept clear.*

137. Every care must be exercised to see that ladders, guys, scaffolding, and trestles are kept at proper clearance from the line during the erection or repair of buildings, etc.

*Cant of Curves.*

138. It is very important that a proper cant be kept on the outer rails of all curves, the particulars of which will be given by the Engineer.

*Floods and Heavy Rain—Precaution during.*

139. (a.) Each Ganger is required, in the event of very heavy and continuous rain likely to cause flood, to examine carefully the action of the water through the streets, culverts, and bridges on his length, and not to allow the grooves to silt up; and should he have any reason to apprehend danger to the works, he must immediately exhibit the proper signals for the cars to proceed cautiously or to stop, as necessity may require, and at once inform the Inspector thereof by telephone or other means, and until the Inspector arrives he must take all precautionary measures for securing the stability of the line.

*Dust Storms—Precautions during.*

(b.) During dust storms the Ganger must use every endeavour to keep the grooves and rails clear of sand.

*Defective Material to be taken out.*

140. (a.) Gangers must see that all broken rails, check rails, sleepers, or other defective materials are removed from the line with the least possible delay, and that sound materials are substituted.

*Broken Rails.*

(b.) All cases of broken rails must be specially reported to the Inspector.

*Rails to be Flush with Street.*

(c.) Gangers must see that the rails or guards are not allowed to stand above the macadam or surface of the roadway.

*Surface between rails to clear Cars.*

(d.) The surface of the track between the rails, or immediately outside them, must not be raised so high as to interfere with the mechanism of the cars.

*Security and Care of Materials.*

141. (a.) Each Inspector of Permanent Way will be held responsible for the security of all Permanent Way materials in his district, and for their being kept clear of both lines, and properly stacked.

*Material not to be sold without authority.*

(b.) Old sleepers, timber, and material of all descriptions are not to be sold or disposed of in any way without the authority of the Commissioner.

*Parts of car equipment to be forwarded to Depot.*

(c.) Portions of car equipment found on the line must be forwarded to nearest Car Depot.

*Security and care of tools, etc.*

142. All tools and implements required for repairs must, when not in use, be kept locked up in a building, or in boxes, for the security of which each Foreman or Ganger on his own length of line is responsible.

*Accidents.—Permanent Way men to obtain information and report.*

143. (a.) When accidents occur or a failure of any part of the works, which affects the safety of the line, takes place, a report either by telephone or other means, must be at once sent to the Traffic Superintendent, Electrical Superintendent, Inspector and Engineer stating as fully as possible the extent and nature of accident. The Ganger or Foreman should obtain all the information possible and report in writing to the Inspector.

*Permanent Way repairs to await Inspector's directions.*

(b.) No repairs are to be effected until the Engineer or his Inspector has viewed the place, except where repairs are absolutely necessary for the safe working of the traffic, a man being stationed to warn the public of the danger, until the Engineer or Inspector has directed repairs to be made.

*Drains and rails to be kept clear.*

144. Gangers must see that the drains, rails, and rail grooves are kept perfectly clean and free from all obstructions.

*Section and Feeder Switches—Interference with.*

145. No employees, other than those who have been specially authorised, are permitted to open, close, or otherwise interfere with any Section or Feeder Switch.

*Fire to be used with care.*

146. Employees must exercise great care in the use of fire and inflammable materials.

## PERTH CITY COUNCIL.

## By-law No. 36.

*Baths.*

A BY-LAW of the Municipality of Perth, made under Section 179, Subsection 4, of "The Municipal Corporations Act, 1906," and numbered 36, for the general management of the Municipal Baths at Mounts Bay Road, Crawley; the conduct of the visitors thereat, and for fixing the charge to be made for the use thereof.

In pursuance of the powers conferred by the said Act, the Mayor and Councillors of the City of Perth order as follows:—

1.—*Hours of Admission.*

(a.) From 1st November to 30th April the Baths shall be open daily from 6 a.m. to 10 p.m., and from 1st May to 31st October they shall be open daily from 7 a.m. to 9 p.m. On Sundays the Baths will be closed at 7 p.m.

(b.) School children under the charge of a teacher shall be admitted to the Baths free of charge, on such days and between such hours as the Council may from time to time appoint, and subject to such special restrictions as the Council may impose.

2.—*Costume.*

Every person using the Baths shall at all times whilst bathing wear a neck-to-knee bathing costume, and in the case of persons apparently above the age of 12 years such costume shall consist of drawers and a tunic covering the same to below the middle.

3.—*Admission and Entrance Tickets.*

(a.) No person shall enter the Baths save through the gates or turnstiles set apart for entrance purposes.

(b.) No person (save the officers or workmen of the Council, and school children and teachers admitted under the provisions of Clause 1, Sec. b) shall enter the Baths except upon payment of the charge herein prescribed, or upon the production of an appropriate season ticket.

(c.) No person to whom any season ticket has been issued shall lend, give, or sell, or otherwise dispose of the same to any other person.

(d.) Every person to whom a season ticket has been issued shall, at any time when required by the caretaker so to do, produce and show the same to him, and no person shall enter or attempt to enter the Baths on any expired ticket or on any ticket belonging to any other person.

4.—*Charges for Admission.*

The following shall be the sums to be paid for admission to and the use of the Baths and the requisites supplied therein:—

Cash charges for admission are payable at the entrance to the Baths. Tickets may be obtained either from the Town Clerk, or from the caretaker.

A season ticket shall admit the holder at all times when the Baths are open, except during the times when carnivals are in progress, or upon any other days specially set apart by the Council.

5.—*Control of Premises.*

(a.) Every person using the Baths shall obey all reasonable directions of the caretaker with regard to such use.

(b.) No person shall obstruct, interfere with, or hinder the caretaker in the performance of any duty in the Baths.

6.—*Costumes, Towels, etc.*

(a.) No person shall injure or destroy any costume, towel, or other article supplied to him by the caretaker.

(b.) Any person who shall fail to return or shall injure or destroy any article supplied to him by the

caretaker shall, before leaving the Baths, pay to the caretaker such reasonable sum as he shall assess as being the value of such article or as representing the damage done to the same, as the case may be.

7.—*Offences.*

(a.) No person shall enter the Baths while in an intoxicated condition.

(b.) No person shall at any time, while suffering from any cutaneous, infectious, or contagious disease, enter or use the Baths or any part of the Baths premises.

(c.) No person in charge of any dog shall allow such dog to enter any part of the Baths premises.

(d.) No person shall smoke in any part of the Baths Buildings.

(e.) No person shall behave in a disorderly or riotous manner, swear, nor use any indecent, obscene, or abusive language, nor gamble, nor misconduct himself, in any part of the Baths premises.

(f.) No person shall climb up to or on any partition or roof or any other portion of the Baths buildings.

(g.) No person shall, in the Baths rooms or elsewhere in the Baths premises, wastefully use the water nor leave any taps running.

(h.) No person shall spit or expectorate in the Baths, or on any of the platforms or in any of the dressing rooms, or commit any nuisance on or in any part of the Baths or the Baths premises.

(j.) No person resorting to the Baths shall wilfully damage any part of the Baths premises, furniture, or fittings, nor carelessly or negligently injure or improperly use or interfere with any taps, valves, or other fittings or appliances.

(k.) No person resorting to the Baths shall in any way interfere with any person therein, nor throw or push, nor attempt to throw or push, any person into the Swimming Bath, nor throw any stones or sticks or any other matter or thing to the annoyance of or interference with any other person using the Baths.

(l.) No person shall enter or attempt to enter any bathroom or dressing-room that is already occupied.

(m.) No man, and no boy apparently above the age of seven years, shall enter, remain upon, or use any dressing-room, passage, latrine, platform, gangway, or other portion of the Baths which shall be set apart by the Council from time to time for the exclusive use of women or girls or children under the age of seven years; and no woman or girl shall enter, remain upon, or use any dressing-room, passage, latrine, platform, gangway, or other portion of the Baths which shall be set apart by the Council from time to time for the use of men.

8.—*Lost Articles.*

(a.) Every person resorting to the Baths who shall find any article which may have been left therein shall immediately deliver same to the caretaker, who shall thereupon register a description of such article and all particulars relating thereto in a book which shall by him be kept for that purpose, and on any person claiming such article and who satisfies the caretaker that he is the lawful owner of the same, such person shall have such article returned to him, and on receiving such article he shall sign for the same in the book before mentioned.

(b.) The caretaker shall on every Monday report to the Town Clerk regarding all articles found in the Baths and handed to him, and whether any such have been claimed and returned to the owner thereof; at the same time he shall hand to the Town Clerk any such articles unclaimed, who shall hand over same to the Police.

9.—*Carnivals.*

(a.) The Council may in their discretion grant to any person, club, association, or organisation, permission to hold and conduct swimming carnivals in the Baths, for such periods, and to charge such fees for admission to same, as the Council may determine, and the sums to be paid to the Council for such privileges and conditions under which such carnivals shall be conducted shall be fixed by the Council as it deems fit.

(b.) During the holding of any swimming carnival the persons, club, association, or organisation conducting the same shall be responsible for seeing that good order and conduct are maintained by the competitors and spectators, and that there is no overcrowding, also that no damage is done to the building or fittings or other portions of the Baths premises.

(c.) At all swimming carnivals all competitors shall wear proper and approved swimming costume.



(d.) Any person, club, association, or organisation to whom the Baths are granted for the purpose of holding a swimming carnival shall, at least one week before the date of such carnival, forward to the Town Clerk a copy of the programme of the events to be competed for thereat; any item on such programme that the Mayor and Town Clerk do not approve of shall be struck out, or so altered as they direct.

#### 10.—Enforcement of By-laws.

(a.) Any person offending against any of the provisions of this By-law shall, on conviction, be liable to a penalty not exceeding £20.

(b.) Every person who shall infringe any By-law for the regulation of the Baths may be summarily removed therefrom by the caretaker or any other officer of the Council.

#### MUNICIPALITY OF GERALDTON.

##### By-Law 41.

##### *To prevent danger from Fire.*

IN pursuance of the powers in that behalf contained in "The Municipal Corporations Act, 1906," the Council of the Municipality of Geraldton doth hereby repeal Part 2 of By-law 41, and make the following in lieu thereof:—

2. Any person who, without the consent of the Council, in writing, shall store more than 800 gallons of kerosene oil, or 400 gallons of petrol spirit, naphtha, turpentine, or other inflammable or volatile fluid or fluids at one and the same time, in any one building or place within the Municipality of Geraldton, occupied by the same person or persons, within the area from Forrest Street to Gregory Street, and from the Beach to 100 feet south of the south building line of Eleanor Street and its continuation, shall forfeit and pay, upon conviction, a penalty not exceeding £20, and a further penalty not exceeding £1, for each and every day during which the offence continues.

#### MUNICIPALITY OF GERALDTON.

##### By-Law 51.

##### *Regulations for the Construction of Buildings.*

IN pursuance of the powers in that behalf contained in "The Municipal Corporations Act, 1906," the Council of the Municipality of Geraldton doth hereby repeal the last portion of By-law 51, relating to the conditions for determining the

thickness of walls, and doth substitute the following in lieu thereof:—

##### *Conditions for determining the thickness of walls.*

Every person who shall hereafter erect, alter, or add to any domestic buildings shall construct every external wall and every party wall erected in the course of such work in accordance with the following rules, and in every case the thickness prescribed shall be the minimum thickness of which any such wall may be constructed; provided that the several rules shall apply only to the walls built of bricks or of suitable stone or other blocks of hard and incombustible substance, the beds or courses being horizontal:—

(a.) Where the wall does not exceed twenty-five feet in height, its thickness shall be as follows:—

If the wall does not exceed thirty feet in length and does not comprise more than two storeys, it shall be eight and a-half inches thick for its whole height.

If the wall exceeds thirty feet in length, or comprises more than two storeys, it shall be thirteen inches thick below the topmost storey, and eight and a-half inches thick for the rest of its height.

(b.) Where the wall exceeds twenty-five feet but does not exceed forty feet in height, its thickness shall be as follows:—

If the wall does not exceed thirty-five feet in length, it shall be thirteen inches thick below the topmost storey and eight and a-half inches thick for the rest of its height.

If the wall exceeds thirty-five feet in length, it shall be seventeen and a-half inches thick for the height of one storey, then thirteen inches thick for the rest of its height below the topmost storey, and eight and a-half inches thick for the rest of its height.

(c.) Where the wall exceeds forty feet but does not exceed fifty feet in height, its thickness shall be as follows:—

If the wall does not exceed thirty-five feet in length, it shall be seventeen and a-half inches thick for the height of one storey, then thirteen inches for the rest of its height below the topmost storey, and eight and a-half inches for the rest of its height.

If the wall exceeds thirty-five feet but does not exceed forty-five feet in length, it shall be seventeen and a-half inches thick for the height of two storeys, then thirteen inches thick for the rest of its height.

If the wall exceeds forty-five feet in length, it shall be twenty-one and a-half inches thick for the height of one storey, then seventeen and a-half inches thick for the height of the next storey, and then thirteen inches thick for the rest of its height.

##### *Buildings of the Warehouse Class.*

Every person who shall hereafter erect, alter, or add to any building of the warehouse class shall construct every external wall, party wall, and cross wall, erected in the course of such work, in accordance with the following rules, and in every case the thickness prescribed shall be the minimum thickness of which any such wall may be constructed; provided that the several rules shall apply only to walls built of bricks, or of suitable stone, or other hard and incombustible substance, the beds or course, being horizontal.

(a.) Where the wall does not exceed twenty-five feet in height (whatever is its length), it shall be thirteen inches thick at its base.

(b.) Where the wall exceeds twenty-five feet but does not exceed thirty feet in height, it shall be at its base of the thickness following:—

If the wall does not exceed forty-five feet in length, it shall be thirteen inches thick at its base.

If the wall exceeds forty-five feet in length, it shall be seventeen and a-half inches thick at its base.

(c.) Where the wall exceeds thirty-feet but does not exceed forty-feet in height, it shall be at its base of the thickness following:—

If the wall does not exceed thirty-five feet in length, it shall be thirteen inches thick at its base.

If the wall exceeds thirty-five feet but does not exceed forty-five feet in length, it shall be seventeen and a-half inches thick at its base.



If the wall exceeds forty-five feet in length, it shall be twenty-one and a-half inches thick at its base.

(d.) Where the wall exceeds forty feet but does not exceed fifty feet in height, it shall be at its base of the thickness following:—

If the wall does not exceed thirty feet in length, it shall be seventeen and a-half inches thick at its base.

If the wall exceeds thirty feet but does not exceed forty-five feet in length, it shall be twenty-one and a-half inches thick at its base.

If the wall exceeds forty-five feet in length, it shall be twenty-six inches thick at its base.

"Domestic Buildings" includes dwelling houses, suite of offices, not being a public building, or a building of the ware house class.

"Dwelling House" shall mean a building used and constructed or adapted to be used wholly or principally for human habitation.

"Public building" shall mean and include churches, chapels, or other places of public worship, schools, public halls, hospitals, theatres, concert rooms, or Government buildings.

"Buildings of the warehouse class" shall mean a warehouse, factory, manufactory, brewery, or distillery, or any other building exceeding in cubical contents one hundred and fifty thousand (150,000) cubic feet, which is neither a public building nor a domestic building, nor a Government building.
