APPLICATIONS are invited by the Commonwealth Public Service Commissioner from persons qualified for appointment to the following positions.

Applicants outside the Public Service are eligible for appointment to the Administrative and Professional Divisions, but are not eligible for appointment to Clerical or General Division vacancies, unless they were in the service of a State on 1st January, 1901, or have retired from the service of the Commonwealth or of a State.

Applicants who are officers of the Public Service of a State should state the date of their appointment to the service, present position, and salary.

Applicants from outside the service should state their qualifications for the office they seek. Copies only of diplomas, references, testimonials, or certificates should be forwarded. If the originals are required they will be asked for.

Date and year of birth should be stated, and applications must be in applicants' hand-writing.

Applications should be addressed to the "Commonwealth Public Service Inspector" of the State in which the vacancy exists, and in the case of officers of the Commonwealth Service be forwarded through the chief officer of the department to which the applicant belongs.

Minimum and maximum salaries where shown indicate the limits of the class or grade in which the position is classified. Subject to the provisions of the Public Service Act, appointments may be made at any salary within those limits. Successful appointees must comply with the life assurance provisions of the Public Service Act and Regulations.

Amendments.

Regulation 1 to read:—

These Regulations shall not apply to the Commissioner of Police nor to any person who prior to his appointment as a commissioned officer was paid a gratuity from the Western Australian Police Benefit Fund; but, subject as aforesaid, shall apply to every member of the Police Force.

Add to Regulation 2:—

Clause (b.):

Sub-Inspectors, Inspectors, and Chief Inspector, three per cent. per annum on their respective annual rates of pay.

Regulation 15:—Repealed.

Regulation 19 to read:—

The moneys described in Regulation 2 shall be paid by the Ministerial Accountant to the credit of an account in the Treasury to be called "Western Australian Police Benefit Fund Account," and moneys shall be drawn therefrom only on the approval of the Governor-in-Council.

Regulation 20 to read:—

The Board shall cause a proper record of receipts and disbursements made under these Regulations to be included in the books of the Ministerial Department, and such shall be audited every twelve months by the Auditor General, who shall affix his signature to the yearly statement, and every four years the condition of the fund shall be examined by the Government Actuary, who shall report on such to the Board.

PREVENTIVE DETENTION REGULATIONS, 1914.

Colonial Secretary's Office,
Perth, 10th July, 1914.

1838/14.

HIS Excellency the Governor, acting with the advice of the Executive Council, doth hereby (in exercise of the powers vested in him by Section 748 of the Criminal Code and of all other powers him in this behalf enabling) make the following Regulations, and doth order that such Regulations shall come into operation on the publication thereof in the *Government Gazette*.

1. Persons subject to preventive detention shall be classified as follows:—

(a) *Males*—

- (i.) Unskilled Labourers;
- (ii.) Skilled Labourers;
- (iii.) Artisans, Professional men, Clerks.

The rates of remuneration for males shall, subject to these regulations, be as follows:—

- Unskilled Labourers, 8s. per week.
- Skilled Labourers, 10s. per week.
- Artisans, Professional men, or Clerks, 12s. per week.

(b) *Females*—

- (i.) Unskilled,
- (ii.) Skilled,

(iii.) Proficients, in any of the following trades or callings:—
Dressmaking, Knitting, Laundry, or Domestic Service.
The rates of remuneration for females shall, subject to these regulations, be as follows:—

Unskilled, 4s. per week;
Skilled, 6s. per week;
Proficients, 8s. per week.

Provided that for those confinees who have no dependants, the rates of remuneration shall be one-half the above prescribed amounts.

For the purposes of these rules "dependant" shall mean wife, child, or reputed child of the confinee, or any other relative or reputed relative of such confinee, dependent on him for support.

2. Every person subject to preventive detention shall if he has no trade or calling, be put to work at some trade or calling. Males shall be put to Tailoring, Shoemaking, Carpentry, or Smithing and shall commence as labourers, and may be promoted from class to class as they become proficient, on a certificate by the Trade Instructor approved by the Superintendent. Females shall be put to work at Dressmaking, Knitting, Laundry, or Domestic work. They shall commence as unskilled and may be promoted from class to class on the certificate of the Trade Instructor subject to the approval of the Superintendent.

3. Every person subject to preventive detention who, through old age or physical infirmities, is unable or unfitted for work shall, for the purposes of these rules, be classed as an unskilled labourer, and treated accordingly.

Provided that he or she shall be paid every week the sum following only:—

If a male, 2s. 6d.
If a female, 1s. 3d.

4. Any person subject to preventive detention may be required to teach other persons, subject to such detention, the particular trade or calling in which he or she is proficient, and refusal to do so will be punishable by loss of marks or earnings.

5. Persons subject to preventive detention shall, so far as the accommodation of the place of confinement permits, be treated as a separate class, and may have their cells lit up for one hour longer than is permitted in the case of prisoners under sentence, and may dine together if accommodation permits. They will also be allowed such recreation and games as the Superintendent approves, and shall not be subject to separate treatment. They shall receive the diet prescribed as Number 3 under the Prison Regulations.

6. Persons undergoing preventive detention shall be awarded marks in accordance with the provisions of Number 186 of the Prison Regulations, but such marks shall not have any effect as regards remission of sentence.

7. Persons subject to preventive detention shall be graded as follows:—

(1.) First Grade.

Persons in this grade shall wear ordinary prison clothing; illiterates shall attend school, and perform such work as the Superintendent decides; they may write one letter and receive one visit per month, and purchase such luxuries as the Superintendent approves.

A person shall be placed in this grade on commencing his sentence of preventive detention and shall remain therein until 2,920 marks have been earned, provided that any such person may, on the order of the Superintendent, be detained longer therein if he or she has not progressed sufficiently in his or her studies or trade.

(2.) Second Grade.

Subject as aforesaid, persons who have remained the requisite period in the first grade shall be placed in this grade.

Such persons shall dress and be treated in the same manner as persons in the first grade, but may be supplied with technical books dealing with the respective trades or callings which they are learning; they may also be permitted to purchase one paper weekly.

An habitual criminal shall remain in this class until 2,920 marks have been earned, but he may be required by the Superintendent to remain therein for a longer period if necessary.

(3.) Third Grade.

After he has remained the required time in the second grade the habitual criminal will (except as herein otherwise provided) pass into this grade.

Persons in this grade shall, in addition to privileges of the first and second grades be allowed, at their own expense, to decorate their cells, and may in addition be allowed to write and receive two letters, also two visits per month, and will be required to remain in this grade until 2,920 marks have been earned, but may, on the order of the Superintendent, be detained longer if necessary.

(4.) Fourth Grade.

Subject to these Regulations the habitual criminal will be placed in the fourth grade after he has remained the requisite period in the third.

Persons in this grade shall, in addition to the privileges of the three preceding grades, wear such distinctive dress resembling civil attire, as may be approved by the Comptroller General.

They shall continue to earn marks until released or allowed out on conditional license.

8. (1) In addition to the above-mentioned grades there is also the *Disciplinary Grade*.

(2) Any habitual criminal may be placed in the Disciplinary Grade by order of the Superintendent, by way of punishment for misconduct or because he is known to be exercising a bad influence on others, and may be kept there as long as may be necessary in the interests of himself and others.

(3) Whilst in the Disciplinary Grade he may be employed in association; but he will not be associated with others except at labour.

(4) He may earn remuneration, but such remuneration shall not be at the rate hereinbefore fixed but shall be twopence per day only.

(5) Marks earned by an habitual criminal whilst in the Disciplinary Grade shall not be taken account of for the purpose of determining when he may be removed from one grade to another, but shall be looked to only for the purpose of determining whether he may be allowed any remuneration.

(6) Any person who has been released on conditional license and whose license has been revoked may, on his return to detention be placed, on the order of the Superintendent, in the Disciplinary Grade for such time as the Superintendent may think necessary.

(7) An habitual criminal shall be removed from the Disciplinary Grade by the order of the Superintendent and shall thereupon be placed in the position which he occupied in the grade in which he was prior to his being placed in the Disciplinary Grade or (when he has been placed therein after revocation of his license) prior to his release on license.

9. No habitual criminal shall be allowed any remuneration for any day on which he has not earned full marks.

10. Any remuneration earned under these Regulations shall be disposed of as provided in Section 663 of the Criminal Code.

11. Subject as hereinbefore provided, any habitual criminal who has been released on license and whose license has been revoked shall, on return to detention, be placed in the class grade and position in which he was at the time of his release.

12. Whenever for the purpose of applying these rules it becomes necessary to decide any question, the Superintendent shall decide such question.

13. Any decision or order of the Superintendent may be reversed or varied by the Comptroller General.

14. (1) The Regulations relating to preventive detention published in the *Government Gazette* on the 27th day of September, 1912, are hereby repealed, but without prejudice to the past operation thereof or to any right, status, or obligation acquired or incurred thereunder.

(2) Any habitual criminal who, immediately prior to the coming into operation of these Regulations, was in any class or at any stage or position under such regulations shall be placed in the corresponding class, grade, or position under these Regulations.

15. In these Regulations "Superintendent" means the Superintendent of the prison or place in which the preventive detention is being served.

16. These Regulations may be cited as the *Preventive Detention Regulations, 1914*.

BY-LAW No. 112A.

Obstruction of Pipes, Sewers, Drains, or Fittings.

1. Any person who, without the written consent of the Minister, erects or maintains any building or structure or causes any building or structure to be erected or maintained, or places or keeps any material or thing or causes any material or thing to be placed or kept over any pipe, sewer, drain, or fitting which is the property of the Minister, and thereby—

(a.) Trespasses on or injures such pipe, sewer, drain, or fitting; or

(b.) Prevents or in any way impedes or obstructs the inspection, maintenance, cleansing, repair, management, or use of such pipe, sewer, drain, or fitting,

shall be guilty of an offence and punishable on summary conviction by a penalty not exceeding twenty pounds, and in the case of a continuing breach of this By-law the offender shall be liable to a further penalty not exceeding five pounds for each day the offence continues

after notice thereof has been given by or on behalf of the Minister to the offender.

2. The Minister may cause any building, structure, material, or thing erected, placed, maintained, or kept over any such pipe, sewer, drain, or fitting in contravention of this by-law to be altered, pulled down, removed, or otherwise dealt with as he shall think fit.

3. Any person committing any breach of this by-law shall, in addition to any penalty imposed on him, pay any expense incurred by the Minister in consequence of such breach.

4. This by-law shall extend and apply to buildings, structures, materials, or things maintained or kept as aforesaid, whether they were erected or placed over the pipe, sewer, drain, or fitting before or after the passing of this by-law.

THE STOCK DISEASES ACT, 1895.

The following Regulations, which have been made by His Excellency the Governor with the advice of the Executive Council, for carrying into effect the provisions of the above-named Act, dealing with all local stock, and relating to the introduction and importation of stock by sea and land into the State, are published for general information:—

2. These Regulations may be cited as "The Stock Diseases Regulations, 1914," and shall be divided into the following divisions:—

PART A.—Introductory and General.

PART B.—Pertaining to Stock within the State.

PART C.—Introduction of Commonwealth Stock by sea and land.

PART D.—Penalties and Confiscations.

PART E.—Schedules under the Regulations.

PART A.—INTRODUCTORY AND GENERAL AS TO ALL STOCK.

RESCISSION OF PREVIOUS REGULATIONS.

3. The Regulations heretofore made by the Governor under the powers conferred by the above-named Act shall be, and the same are hereby rescinded from and after the date of these Regulations, except as to the acts, matters, and things done or commenced thereunder, and subject to such and the like savings as apply in the case of a repeal of a Statute.

What are deemed to be infectious and contagious Diseases.

4. The Diseases mentioned in Schedule No. 1 hereto are hereby declared to be infectious or contagious diseases under the said Act, without in any way limiting the generality of the definition of "disease" contained in such Act and "The Stock Diseases Amendment Act, 1906."

5. In these Regulations "The Interpretation Act, 1898," shall apply, and the following words and terms shall, unless the context otherwise indicates, have the meanings set against them respectively, namely:—

Interpretation.

"Foreign."—As regards places, stock, fodder, fittings, effects, or vessels, any place, port, stock, fodder, fittings, effects or vessel within the Commonwealth.

"Holding."—Any land or collection of lands constituting and worked as one property, whether held or occupied under pastoral lease, or in fee simple, or under conditional purchase lease or otherwise, and whether under the same title or different titles, or under titles of different kinds.

"Litter."—Any straw or other bedding or litter or any manure or other excreta with which stock shall have been in direct or indirect contact.

"Prescribed."—Prescribed by these Regulations.

"Ship's stock."—Any stock on board ship for the use of the passengers and crew, and any stock not-intended to be introduced nor to be transhipped.

"Vessel."—Any steamer, ship, lighter, boat, launch, punt, or ferry-boat.

"Cow Shed."—Any building or premises in which milking cows or goats may be kept.

"Cow-keeper."—Any person carrying on the trade of cow-keeper, dairyman, or purveyor of milk.

"Quarantine."—Any quarantine area, infected holding, or quarantine station.

Inspector receiving information of existence of disease to take immediate action.

6. (1.) Any inspector of stock on receiving information of the existence of disease in any stock, or having reasonable grounds to suspect that disease exists, or has within the preceding three months existed in any place within Western Australia, shall proceed to that place with all practicable speed, and shall inquire into the existence of disease in such place or in any other place in the manner hereafter set forth.

(2.) He may call upon all persons concerned in or having the charge, control, or management of any such stock suspected or said to be diseased, to give evidence before him as to the facts within their knowledge relating to such stock.

(3.) Any person who, after having received notice to attend for that purpose, shall refuse or neglect to attend, or to answer any inquiries put to him by the inspector under the authority of the Stock Diseases Act, 1895, or these Regulations, shall be deemed to have committed a breach of these Regulations.

(4.) If it appears to the inspector that disease exists, or has within the preceding thirty days existed among such stock, or on the land inspected or examined by himself or any other inspector, he shall so determine and shall declare such land to be an infected

holding within the boundaries of which such stock shall be kept, and shall forthwith notify the Chief Inspector, who may cause notice of the fact to be published in the *Government Gazette* and in such newspapers circulating in the district or subdivision where the disease has been ascertained to exist.

(5.) Such notice shall particularly describe the place and area intended to be affected by the declaration, and until released such place and area shall be deemed to be an infected holding from which no stock, fodder, or fittings shall be removed, except under the direction of an inspector of stock.

(6.) The provisions of this Regulation shall not be deemed to apply to stock infected or affected by a disease other than of a highly infectious or contagious nature.

The whole expense to be borne by the owner.

7. The owner of the stock shall pay all charges and expenses connected with the inspection, transporting, quarantining, housing, sustenance, disinfecting, dipping, dressing, or veterinary or other treatment of such stock until they are, as the case may be, released from detention or quarantine, transhipped, or destroyed, and the charges and expenses for transit, inspection, and dipping shall be calculated on the whole number of stock, and where there are more owners than one each owner shall pay a proportionate share thereof.

8. When any infected holding has been declared by an inspector of stock, the inspector shall quarantine, within such infected holding, all stock straying or being driven on to that holding, and the owner or owners of such stock shall be liable for all charges and expenses as prescribed in Regulation 7.

All risk and loss to be borne by the owner.

9. All loss sustained with respect to any stock while being conveyed to or from or whilst in quarantine, whether by accident or by sickness arising from natural causes, or contracted from other stock, or by the destruction or detention or quarantine or dressing of such stock to prevent the spread of disease, shall be borne by the owner of such stock, and he shall have no other claim for compensation for any such loss.

No person to enter or leave infected holding without permission.

10. No person shall enter or leave an infected holding without the permission of an inspector, in writing, and every person who shall enter shall, if the inspector so directs, disinfect himself and his clothes in such a manner as the inspector shall order.

Owner to receive notice when stock are ailing.

11. When any stock are ailing or about to be destroyed under the Act or these Regulations, notice thereof shall be given to the owner of such stock to the effect of Schedule No. 3 hereto.

How notices are to be served.

12. Notices under these Regulations may be either served personally on the person to whom such notice is required to be given, or left at his last known residence or place of business, or sent to him under registered envelope through the post.

Inspector's directions to be carried out.

13. Any person receiving a requisition or direction from an inspector under these Regulations shall, with due despatch, give effect to and carry out the same, and if there be any information or document in the possession or power of any person which is required by an inspector under these Regulations and asked for by him, the same shall be given by such person, and the requisition so made, or any directions so given by an inspector may, if not carried out by the owner, be so done by the inspector at the owner's expense, and the expense incurred may be recovered in any competent court by and in the name of an inspector of stock.

The spread of disease—prevention of.

14. (1.) Any inspector of stock may, if he deems it necessary for preventing the spread of disease,—

(a) Prohibit in any district the holding of exhibitions of stock and the sale of stock in public markets and in private sale yards.

(b) Quarantine within an infected holding all stock straying or being driven or brought on to such infected holding.

(2.) Where any stock are suffering from disease and there are no means of efficient isolation, the Chief Inspector may order such stock to be killed.

(3.) It shall be unlawful for any person, except for scientific purposes by authority from the Minister, to wilfully communicate, or cause to be communicated to any stock, any disease mentioned in Schedule No. 1 hereto, or without the written consent of the Chief Inspector, to inoculate or cause any stock to be inoculated with the virus of any disease, whether such virus be in an attenuated form or not.

(4.) Any inspector may, if he discovers the carcase or part of the carcase of any diseased stock unfit for human consumption in any slaughter-house or place used for the slaughter of stock, or exposed for sale in any shop or market or for exhibition, seize and destroy such carcase or part thereof.

(5.) During period of quarantine no person except the attendant shall, without the permission of an inspector, touch, handle, or come in contact with any stock within the quarantine, and if any person touches, handles, or comes in contact with any such stock contrary to this Regulation he shall disinfect himself and his clothes as an inspector shall direct.

Premises, vessels, sheds to be disinfected.

15. Any inspector of stock may require any place, vessel, shed, or yard where any diseased or infected stock, or stock suspected of being diseased or infected, are or have been kept or to which they may have had access, as well as all vehicles or vessels in which stock have been conveyed, or articles with which they have come in contact, to be thoroughly cleansed and disinfected under his supervision or to his satisfaction.

Affected stock impounded, for sale, or exhibition.

16. If any stock affected with any infectious or contagious disease shall be found in any Government or other public pound, or in any yard or in any other place whatsoever at which stock are offered for sale or are exhibited, the owner of such stock so affected

shall be liable to a penalty not exceeding Fifty pounds. Provided that any inspector of stock may order the withdrawal from sale or exhibition of any stock so affected until such stock have been treated and become free from disease. Provided also that every owner who refuses, neglects, or fails to comply with the directions of the inspector shall be liable to a penalty not exceeding Twenty pounds. But if such stock are intended for immediate slaughter the inspector may exercise his discretion and give an order for them to be slaughtered accordingly.

Inspector may employ assistance.

17. The owner of any stock shall, when required by an inspector, forthwith muster his stock in some convenient place, yard, or crush as the inspector may direct, and if he is not satisfied that the whole of the stock have been so mustered, may employ any person or persons to assist him in the thorough examination of the stock of such owner, and the expenses of, and incident to, such examination shall be paid by the owner thereof.

Inspector not liable for loss.

18. No inspector shall be liable for any loss or damage occasioned to any owner of stock by any act of such inspector unless such damage shall be occasioned by his wilful neglect or default

Inspector not to be interested as a dealer in stock.

19. No inspector shall be either directly or indirectly a dealer in stock, or shall act as the agent of an owner or dealer in stock in the district or subdivision in his charge.

PART B.—PERTAINING TO STOCK WITHIN THE STATE.

GENERAL, *re* TICK IN CATTLE (*Ixodes Bovis*).

Boundaries of East Kimberley quarantine area.

20. The East Kimberley Quarantine area includes all that portion of the Kimberleys eastward of the eastern shore of Brunswick Bay and St. George's basin of the right bank of the Prince Regent River, and of a line therefrom *via* Mount Agnes and the eastern side of the Caroline Ranges, in direction of the Gemini Hills to the meridian of 127 degrees of East longitude and East of such meridian.

Such quarantine area shall include all holdings any portion or portions of which are within such area.

Prohibition of stock from crossing tick boundary.

21. No stock whatsoever shall be allowed to cross the tick boundary line from East to West Kimberley, excepting broken in horses, which are certified by the local inspector of stock to be capable of being easily handled for treatment at Hall's Creek, and excepting also groomed horses used by persons travelling overland, and by special permission of the local inspector of stock, to obtain which, fourteen days' notice must be given prior to crossing the tick boundary. Such horses, however, must be thoroughly treated by washing with a solution fatal to tick at the Police Station at Hall's Creek, for which a charge of 2s. 6d. per head is to be made.

Provided that the owner who refuses, neglects, or fails to comply with this regulation shall be liable, on conviction, to a penalty of not less than Fifty nor exceeding Five hundred pounds.

Wyndham the only port of shipment.

22. No cattle shall leave the East Kimberley quarantine area except at the port of Wyndham, and such cattle shall first have been dipped to the satisfaction of an inspector of stock in a specific known to be fatal to cattle tick (*Ixodes Bovis*) prior to leaving that port.

Dipping charges.

23. The charge for dipping cattle at Goose Hill for shipment shall be at the rate of 1s. per head.

Cattle to be quarantined at Owen's Anchorage or North Fremantle.

24. All cattle leaving the East Kimberley quarantine area for any other part of the State of Western Australia shall be shipped to the quarantine station at Owen's Anchorage, near Fremantle, or to the North Fremantle quarantine station, and shall be landed within either of the quarantine enclosures mentioned, where they shall be deemed to be quarantined until slaughtered or otherwise disposed of as directed in writing by an inspector of stock.

Vessels may call at ports en route to Fremantle.

25. All vessels employed in the East Kimberley cattle trade may call at any port *en route* from Wyndham to Fremantle and ship other stock, but no stock or cargo shall be unloaded from such vessels *en route* to Fremantle.

Provided also that all stock on board such vessels shall be considered as quarantined stock.

How vessels are to be treated under the regulations.

26. All vessels which have been employed in carrying cattle from the port of Wyndham to Fremantle shall be considered clean vessels after coming off the trade, provided that they are thoroughly disinfected to the satisfaction of an inspector of stock and a certificate given by such inspector to that effect.

All expenses incidental to the disinfecting of such vessels shall be borne by their owners.

Conditions under which cattle may be removed from the quarantine stations at Owen's Anchorage and North Fremantle.

27. No cattle shall be removed from the quarantine stations at Owen's Anchorage and North Fremantle unless they are free from tick, and a certificate to the effect of Schedule No. 4 hereto has been obtained from an inspector of stock that the animals have been dipped and are entirely free from tick.

Provided that all cattle which have been dipped prior to leaving the port of Wyndham may, on the certificate of an inspector of stock to the effect that they are entirely free from tick on landing, be trucked by rail to any part of the State for immediate slaughter, or as otherwise directed by the Chief Inspector of Stock, provided that in the opinion of the inspector they are free from any infectious or contagious disease.

28. Provided also that for all cattle dipped in accordance with Clause 1 of Regulation 27 a fee of 6d. per head shall be paid.

Vessels carrying tick-infested cattle to be disinfected.

29. In the event of any shipment of cattle being found on arrival at Fremantle to be tick-infested, the vessel bringing same shall be thoroughly disinfected to the satisfaction of an inspector of stock before leaving the port of Fremantle.

All expenses incurred in connection with such disinfecting shall be borne by the owners of the cattle.

Skins and hides to be treated similarly, as prescribed under Regulation No. 45.

30. All skins and hides removed from cattle slaughtered within the East Kimberley quarantine area and Owen's Anchorage and North Fremantle quarantine stations shall be treated as prescribed in Regulation 45, paragraphs (c) and (d) of these Regulations.

Penalty for breach of any of these cattle-tick Regulations.

31. Any person committing a breach of any of these Regulations pertaining to tick in cattle shall be liable to a penalty not exceeding Five hundred pounds.

GENERAL—*re* SHEEP AFFECTED WITH TICK OR LICE.

Boundaries of affected area and period of dipping.

32. (a) Every owner of sheep within the boundaries of the State known as the South-West Division shall, after the shearing of such sheep, and before the thirty-first January in each year, dip or cause to be dipped in a swim-bath prepared with some specific known to be fatal to ticks and lice all sheep running on land whereof he is the owner or occupier.

Provided that for every sheep not so dipped within the period prescribed above and to the satisfaction of an inspector, such owner shall, on conviction, be liable to a fine not exceeding Two shillings.

Notice of Muster to Neighbours.

(b) Every occupier of any land in the South-West Division who shall muster his sheep for either of the purposes of dipping or removal from his farm or runs, shall, before yarding the same, give due notice *in writing* of not more than three days nor less than thirty-six hours to the occupiers of all the adjoining lands of his intention so to yard his stock.

When ewes with lamb are to be dipped.

33. Notwithstanding anything contained in these Regulations, it shall not be necessary to dip ewes affected with ticks or lice during such time previous to or after their lambing as the inspectors may appoint, and for such purpose any inspector may, in respect of such ewes, extend any notice to dip for such time as he shall think fit.

Statutory declaration after dipping required by owner.

34. Within seven days after the dipping of his sheep, the owner shall make a statutory declaration before a Justice of the Peace to the effect of Schedule No. 5 hereto, stating that he has

dipped his sheep in accordance with the provisions of these Regulations, the date of dipping, number of sheep dipped, and the class of dip used; and he shall forward a copy of such declaration to the Chief Inspector of Stock at Perth and retain the original in his possession for production when called upon to do so by an inspector.

Affected stock not allowed to stray.

35. Every person who by himself, his agent or servant, drives, without the permission of an inspector, or suffers to stray across or upon any land, or drives, depastures, or suffers to stray upon or along any highway any sheep which have not been dipped according to these Regulations, or affected with ticks or lice, shall be liable on conviction to a penalty not exceeding Fifty pounds.

Inspector discovering stock to be affected must give notice.

36. (a) If an inspector is satisfied that a flock depasturing in any part of the State is affected with tick or lice, he shall give the owner thereof notice to dip such stock forthwith to the satisfaction of the inspector or his agent.

Provided that the owner who refuses, neglects, or fails to comply with such notice on or before the date specified therein shall be liable on conviction to a penalty not exceeding Fifty pounds for the first offence, and if immediately after conviction for the first offence such sheep shall not be dipped to the entire satisfaction of the inspector, such owner shall upon conviction be liable to a further penalty not exceeding Fifty pounds, and so on for each and every succeeding conviction.

(b) If any sheep affected with tick or lice shall be found in any pound, or in any yard or yards, or on any land or other place at which sheep are offered for sale or exhibited for show purposes, the owner exposing the sheep so affected shall be liable to a penalty not exceeding Fifty pounds: Provided that any inspector, if he deems it necessary, may order the withdrawal from sale of any sheep affected with ticks or lice until such sheep have been dipped or dressed to the satisfaction of such inspector or any other inspector, and shall give notice to the aforesaid owner of such sheep to dip or dress the same forthwith, at such place as the inspector may direct; and every such owner who refuses, neglects, or fails to comply with the aforesaid notice is liable to a further penalty not exceeding Twenty pounds. But if the inspector is satisfied that such sheep are intended for immediate slaughter, he may withhold such notice to dip.

MISCELLANEOUS—RELATING TO SWINE, ETC.

Boundaries of quarantine area for swine.

37. The quarantine area for swine includes all that portion of the State bounded on the North by an easterly line from the sea coast to the 44-mile post on the Eastern Railway Reserve; on the East by a South-Easterly line therefrom to the North-East corner of Avon Location 3444; thence Southerly along its Eastern boundary to its South-East corner; thence South-South-Westerly to a point situate six miles East from the North Dandalup railway station; on the South by a Westerly line therefrom to the sea coast; and on the west by the sea coast aforesaid.

Such quarantine area shall include all holdings any portion or portions of which are within such area.

Diseased swine to be destroyed.

38. When any person shall have in his possession swine which are diseased or infected with an infectious disease, or showing symptoms of any infectious disease, such person shall immediately give notice thereof to an inspector, and if such swine on examination by an inspector or other authorised person show symptoms of disease they shall be destroyed on the premises where such diseased swine are inspected, and such premises shall be thoroughly disinfected by the owner or occupier thereof under the supervision and to the satisfaction of the inspector.

39. If it appears to an inspector that disease exists, or has within the preceding thirty days existed among any swine, or on any land inspected or examined by himself or any other inspector, he shall so determine and shall declare such land to be an infected holding, within the boundaries of which such swine shall be kept, and shall forthwith notify the Chief Inspector, who may cause notice of the fact to be published in the *Government Gazette* and in such newspapers circulating in the district or subdivision where the disease has been ascertained to exist.

Such notice shall particularly describe the place and area intended to be affected by the declaration, and, until released, such place and area shall be deemed to be an infected holding from which no swine, fodder, or fittings shall be removed, except under the direction of an inspector.

Action to be taken with infected swine.

40. The carcase of any swine not affected with disease may be disposed of for the benefit of the owner, notwithstanding that such swine may have come in contact with infected swine, provided that an inspector of stock has first certified in writing to the effect of Schedule No. 6 hereto that such carcase is fit for human consumption and use.

Killing swine within quarantine area or infected holding.

41. No person shall kill any swine whilst impounded in any quarantine area or infected holding without first obtaining the written authority of an inspector to the effect of Schedule No. 7 hereto.

Swine killed under authority of Inspector.

42. (a) An inspector of stock may, but shall not be compelled, to grant a permit to an owner of swine desirous of moving stock within a quarantine area.

(b) Prior to the issuing of any such permit, the owner may be required to sign a declaration to the effect of Schedule No. 8 hereto.

(c) All store swine in a quarantine area not intended for killing, and removed under permit to any place not being a market, shall not be again moved within thirty days from the date of the permit authorising their removal.

Conveyance of swine to markets for sale.

43. Swine moved pursuant to a permit from an inspector to the effect of Schedule No. 9 hereto, and offered for sale at any

market or saleyard within a quarantine area shall be offered on the vehicle by which they have been conveyed, and such swine may be removed to another vehicle and conveyed to the purchaser's land.

Provided that when yards or pens are specially prepared in such saleyards or markets, such swine may be permitted to be placed in such yards for sale.

Provided also that swine purchased at any saleyards or markets shall not be removed from the purchaser's premises within thirty days of the date when such swine were purchased.

Inspection of dairy farm or cow-shed.

44. Every cowkeeper or occupier of a dairy farm, or any person in charge thereof, which an inspector of stock may visit for the purpose of inspecting any cattle or cow-shed thereon, shall afford every reasonable assistance that may for the purpose of such inspection be required of him.

REGULATIONS PERTAINING TO HIDES AND SKINS.

Persons to keep record of stock, hides, and skins received.

45. Every person who receives any stock, hides, and skins for sale, or disposes for or on behalf of any other person, shall,—

- (a) Make in the manner prescribed and during a period of twelve months from the date of such receipt keep a record of the description of the stock, hides, and skins and of the brands and marks thereon, and of the name and address of the person from whom he received the same.
- (b) At all reasonable times within the said period produce any stock, hides, and skins which are in his possession for sale or disposal as aforesaid, or any such record for the inspection of any justice, inspector, or member of police force on demand, and permit any such person to take a copy of or extract from any such record.
- (c) All hides of cattle, horses, or camels shall be fully opened out with the hair or outer side lowermost on a properly prepared floor of concrete or other impervious substance on which a layer of salt has been spread. The inside shall be covered with strong, coarse dry salt to the extent, on an average, of not less than 12lbs. to each hide, and they shall be built up greenside to greenside and salted in this way until a stack is formed, from which the brine is allowed to drain freely off. The hides shall remain in the stack seven days.
- (d) When salted, each of the hides or skins shall be turned in from the head, then from the butt, and then so folded up that the salt shall be retained and every part of the green side of the skin or hide shall come in contact with the salt.
- (e) All skins of sheep, kangaroos, or of any other animals shall be dressed with an arsenical solution and sun or wind dried.

Scale of Fees on Stock and Hides intended for Exportation.

46. All live stock intended for exportation shall, prior to embarkation, be examined by an inspector, and a fee levied for such examination in accordance with the scale of charges hereunder:—

All hides intended for export shall be examined by an inspector prior to embarkation, and a certificate issued on payment of a fee of 2s. 6d. per certificate.

PART C.—INTRODUCTION OF COMMONWEALTH STOCK.

47. (a) Cattle intended to be introduced into this State from the State of Queensland may be permitted to land subject to the provisions prescribed under these Regulations controlling the spread of disease known as Cattle Tick (*Ixodes Bovis*).

(b) Sheep intended to be introduced into this State from Queensland shall be subject to quarantine for a period of fourteen days, and shall not be permitted to land at any port in this State other than the port of Fremantle.

(c) Swine intended to be introduced into the State from any of the States of the Commonwealth shall be subject to quarantine for a period of thirty days, and shall not be permitted to land at any port in this State other than the port of Fremantle.

Introduction of Cattle from the Eastern States.

48. No cattle shall be introduced or imported into Western Australia from any other State or any territory of the Commonwealth; provided that any cattle may be imported at the ports of Fremantle and Albany (but not elsewhere) if the following conditions are complied with, that is to say:—

- (a) On production by the importer of a certificate in writing, signed by a qualified veterinary surgeon attached to the Government Stock Department of the State from which such cattle are imported, to the effect that such cattle have been duly tested and found free from tuberculosis:

Provided, also, that cattle brought overland from the Northern Territory of Australia may be introduced if such cattle have been inoculated with *pleuro virus* within the three months last preceding their introduction into the State of Western Australia, and such cattle are accompanied by a certificate in writing signed by the owner or his agent before a Justice of the Peace to that effect, or if such cattle come from any station which the Chief Inspector of Stock is satisfied is free from the disease of *pleuro-pneumonia contagiosa*:

Provided also that fat cattle may be imported at the ports of Fremantle and Albany (but not elsewhere), for immediate slaughter at the port of entry, if the approval, in writing, of an inspector is first obtained.

What shall be deemed a clean State.

49. Any State shall, as regards any particular kind of stock, be deemed clean if the introduction of that kind of stock, or stock of a different kind but liable to be infected with the same disease, is not prohibited from being introduced from such State in terms of these Regulations.

Ports at which stock may be landed.

50. Any stock from the States which may be lawfully imported by sea shall not be landed at any other port than Fremantle and Albany unless they shall have been first inspected and passed by an inspector of stock at one of the aforesaid ports.

Fees on stock imported.

51. All stock imported shall be examined by an inspector, and a fee levied for such examination in accordance with Schedule No. 2 of these Regulations.

Introduction of stock by land into this State.

52. In the case of stock from any of the States intended to be introduced into this State, it shall be necessary for the owner of such stock to give notice thereof to the inspector of stock in the district into which they are intended to be introduced to the effect of Schedule 10 hereto, such notice to be delivered not less than seven days before the introduction of such stock.

Cattle admitted free from the Northern Territory.

53. No border inspection fees shall be charged on cattle entering this State by land from the Northern Territory, but all other stock shall be charged for as set out in Schedule No. 2 hereto.

Crossing places for the introduction of stock by land.

54. The crossing places for stock intended to be introduced into this State from any of the other States shall be at the Newry Station, Negri River, and Cockatoo Spring for districts in the northern portion of the State, and for districts in the southern portion of the State the only crossing place shall be where the present road crosses the border at a point about eight miles distant in a north-easterly direction from Eucla.

Border inspection.

55. If the inspector for this State at a crossing place on the border receives notice from the owner of any stock that he intends to cross such stock on a date therein mentioned, and the stock are not presented at such crossing place for inspection on the date stated, whereby the inspector is unnecessarily detained at the said crossing place, or if an inspector is called upon to inspect any stock for which the owner has neglected to obtain a certificate required to be produced to the inspector of this State, the owner of such stock shall pay the inspector on demand the expenses incurred by him through such unnecessary detention, or in making such inspection, in addition to the fees prescribed in Schedule No. 2 of these Regulations.

PART D.—PENALTIES AND CONFISCATIONS.

PENALTIES.

Penalties not exceeding £20 for breaches of Regulations.

56. Any person who shall commit or attempt to commit, or be concerned in committing or attempting to commit a breach or violation of, or shall neglect to comply with any of the foregoing regulations for which no special penalty is provided, shall for every such offence, upon conviction thereof, be liable to a penalty not exceeding Twenty pounds.

Penalty for damaging property.

57. Any person who removes, destroys, or damages, or in any way interferes with any marks, notices, gates, or fences made, posted, or erected as being necessary for the better administration of these Regulations, shall be liable on conviction to a penalty not exceeding Twenty pounds.

Legal procedure.

58. (1.) All penalties for any breach of this Act or Regulations thereunder, and all moneys due and payable under this Act may be recovered in a summary way before a resident or police magistrate, or any two or more justices of the peace on information or complaint by any inspector of stock, owner, or occupier, or by any person authorised by the Minister in that behalf.

(2.) Whenever any expenses, fees, costs, or charges have been incurred by an inspector under these Regulations, he may sell the stock, fodder, or fittings in respect of which the same were incurred for the purpose of defraying all or any such expenses, fees, and charges.

Confiscation or destruction of stock, etc.

59. Stock, fodder, fittings, or effects, as the case may be, may under all or any of the following circumstances be destroyed or otherwise disposed of, as the Chief Inspector of Stock shall direct:—

- (a) If stock are infected with any infectious or contagious disease, whether they be on land or on board any vessel within the territorial limits of this State.
- (b) If any foreign stock, fodder, fittings, or effects are landed in contravention of these Regulations.
- (c) If any foreign stock, fodder, fittings, or effects which are prohibited are landed.
