Subject to the provisions of the Public Service Act, appointments may be made at any salary within those limits. Successful appointees must comply with the life assurance provisions of the Public Service Act and Regulations.

Under Secretary.*Cambridge Gulf.*—Channel Rock.—The beacon marking these rocks has disappeared. Chart affected, No. 1388.*King Sound.*—Point Torment, Elbow Shoal.—The two black buoys North of this shoal have been removed. Chart affected, No. 1052.*Port Hedland.*—Outer Bar.—In crossing this bar deeper water has been obtained by keeping the leading beacons open, slightly either East or West.*Middle Ground.*—This has shoaled considerably of late years. The dry portion of the bank has extended as a narrow ridge to the North and Westward of buoy. Vessels should round buoy fifty yards off.

*Penalty.*

Every person offending against any of the foregoing By-laws shall for every such offence, upon conviction, forfeit and pay a sum not exceeding Twenty pounds.
