Finding of the Court.

The Court, having carefully inquired into the circumstances attending above-mentioned negligence, finds that the Master of the s.s. "Bullarra" (Captain W. F. Lewis) was guilty of negligence in the navigation of the ship in approaching Bedout Island, on the night of the 24th August, 1914, and that such negligent naviga-tion caused the ship to strike on a reef close to the

For such negligent navigation he is severely repri-manded, and is ordered to pay the costs of this inquiry, which are allowed at three guineas sterling.

THE following Report and Finding of the Deputy Chief Harbour Master into the circumstances attending the stranding of the s.s. "Kwinana" on Fathom Rock, at the entrance of Cambridge Gulf, in the afternoon of the 25th August, 1914, has been approved by the Hon. the Colonial Secretary.

G. J. SINCLAIR, Secretary Navigation Act.

I beg to report, for the information and approval of the Hon. the Minister, having this day held a Preliminary Inquiry into the circumstances attending the stranding of the s.s. "Kwinana" on the rocks to the Westward of Fathom Rock, Cambridge Gulf, at 12.15 p.m. on the 25th August, 1914.

The s.s. "Kwinana" is a single screw steamer, 3,295 tons gross and 2,130 tons nett register, Official No. 101707, owned by the Western Australian Government, and engaged in the cattle trade from Wyndham to Fre-

After careful consideration of the evidence given by the Master, Frank Dalrymple Lewis, Robert Griffiths, 2nd Officer, watch officer at the time the vessel struck, and the helmsman, at the above Inquiry,

(a.) I find the s.s. "Kwinana" left Wyndham Jetty at 6.30 a.m. on the morning of the 25th August, and steered the usual course to pass to the Westward of Fathom Rock, on the usual track used by all vessels on this trade for reasons supplied by the Master in his evidence.

(b.) That on approaching the passage it was found that the tide had taken charge of the vessel, thereby sweeping her bodily on to the rocks, notwithstanding she had been hauled to the Westward to avoid same.

When it was found the vessel would not clear the rocks the engines were reversed from full speed ahead to full speed astern, but the vessel unfortunately took the bottom on the rocks to the West of the Fathom Rock, and remained fast until the tide again rose.

There is nothing in the evidence to support a charge of misconduct, incompetency, drunkenness, neglect, or carelessness on the part of the Master, Officers, or Crew; on the contrary, everything possible appears to have been done to avoid the stranding, and to save the vessel after she had stranded.

(d.) That the mishap was caused by the exceptionally strong tide taking the vessel and bodily setting her on the rocks.

To prevent danger from inflammable materials.

Any person who shall stack any hay, straw, or other inflammable material within 75 feet of any house or other building, and who shall not remove within two hours after due notice from the Town Clerk, shall forfeit and pay, on conviction, a penalty not exceeding £20 for each such offence.

No. 58.

To prevent danger to passengers.

Any house or building the roof whereof shall overhang or project over any public street, without having a proper gutter or pipe to earry off the rain, or which shall have any cornice, crane, or hoist, or other fixture or projection overhanging or projecting over any public street without the sanction, in writing, of the Council thereof, shall be deemed to be a nuisance, and any owner of any such house or building who shall neglect or refuse to remove or abate such nuisance within seven days after due notice by the Mayor or Town Clerk shall forfeit and pay, upon conviction, a penalty not exceeding £5 for every such offence.

No. 59.

Encroachments or obstructions to be removed.

- 1. On the order of the Council, the Town Clerk, or other appointed officer, may direct the removal within 14 days of any building, fence, or other obstruction or encroachment in or upon any street, lane, or public place under the control of the Council.
- 2. In any case where after service of notice for such removal any such encroachment or obstruction has not been removed within the specified time, it shall be lawful for the officer appointed by the Council to re-move same at the cost and charges of the person so offending, and to proceed against the offender for the breach of this by-law; the penalty for such offence shall Le not more than £20.

Construction of footpath crossing places.

- 1. It shall be lawful for the owner of any land fronting any street or public way requiring access thereto with horses and vehicles from such street to such land across any existing footpath, channel, or gutter, having first had and obtained the consent of the Council, to construct a crossing of such dimensions and materials and in such a form and manner as the regulations of the Council for the time being may require or as may be directed by the Town Surveyor, and shall thereafter keep and maintain in safe repair. person not complying with the provisions of this by-law shall, upon conviction, forfeit and pay a sum not exceeding £5.
- 2. Every person who shall wilfully and without lawful excuse ride or drive or wheel any carriage, cart, or other vehicle, or shall ride any bicycle, velocipede, or tricycle upon, along, or across any footpath or water channel or gutter by the side of any street, road, or public way, save in each such case upon and by or at some properly constructed crossing, shall forfeit and pay, upon conviction, a sum not exceeding £2.

MUNICIPALITY OF BUNBURY.

By-law No. 62.

A By-law of the Municipality of Bunbury made under Section 179 of "The Municipal Corporations Act, 1906," and numbered 62, for regulating the general control and management of the Bunbury Library and Free Reading Room.

In pursuance of the powers conferred by the said Act, the Mayor and Councillors of the Municipality of Bunbury order as follows:-

1. That the name of the Library shall be the "Bun-bury Library and Free Reading Room," hereinafter called the Library.

Objects.

2. The objects of the Library shall be for the diffusion of literature, scientific and useful knowledge which shall be attained by the establishment of a free and circulating library and reading room, or such other means as the Committee of Management may from time to time determine.

Library, etc., when open.

3. The Library shall be open on such days and during such hours as the Committee may from time to time determine.

Library.

4. The public shall have access to the Library at all hours during which such is open, and to all books, periodicals, newspapers, etc., that may be available for their use; but no book shall be taken out of the Library except as hereinafter provided.

Management.

- 5. The Library shall be managed by a Committee of Management, hereinafter called "The Committee," consisting of four members (with the Mayor for the time being as Chairman), such Committee to be elected annually by the Council. At any meeting of the Committee three shall form a quorum.
- 6. The Committee shall have the entire management of the Library and care and control of the buildings set apart for its use, the custody of all books, periodi-

cals, maps, apparatus, and other property to be vested in the Mayor and Councillors for the time being of the Municipality of Bunbury, in trust for the ratepayers thereof.

7. The Committee shall cause minutes to be kept of their proceedings and shall have the power to frame such by-laws as shall seem to them necessary for the proper administration of the affairs of the Library; provided that no such by-law shall be inconsistent with the rules or Municipal Act.

Chairman of Committee.

- 8. The Mayor shall take the Chair at all Committee meetings, but in the event of his absence the meeting shall appoint a Chairman for the time being.
- 9. The Chairman at any meeting shall have a casting vote as well as his vote as a member.
- 10. The Town Clerk shall enter the minutes of every Committee meeting in a book to be provided for that purpose, which minutes shall be read and confirmed at the succeeding meeting, and signed by the Chairman. He shall receive all moneys and give receipts for same and pay over to the Treasurer of the Council all moneys received by him within seven days. He shall by circular summon at least two clear days the members of the Committee before holding any meeting of same. He shall draw up the annual report and shall submit the same to the Committee at their meeting previous to the annual meeting. He shall notify to all officers all orders, directions, or regulations of the Committee, and see the same duly carried out by them, and report all neglect or dereliction of duty on their part.

Books registered before taken out.

11. No person shall on any pretence remove books from the circulating library without having first deposited with the Council the sum of 2s. 6d. (to secure the safe return of the books) and without the books being first entered in the register kept for that purpose by the Librarian. The time for keeping books shall not exceed fourteen days. Not more than two books shall be issued at any time to any one borrower, every borrower undertaking that he will not lend to any other person any books belonging to the Library.

Reference books stamped as such on no account shall be removed from the Library.

All books borrowed must be returned to the Librarian within 14 days, and for every failure to comply with this regulation the borrower shall be liable to a fine of 3d. per day to be paid to the Librarian.

The Librarian or other officer of the Council has power to refuse to lend books to any person who neglects to comply with the above regulations, or who is, in his or her opinion, for other reasons not to be trusted.

Return of Deposit.

12. Any person leaving the district or being desirous of discontinuing the use of the circulating library shall, on application to the Town Clerk, have the amount of their deposit returned subject to these rules.

Damaged Books.

13. If any book be lost, written upon, or otherwise damaged, the person in whose hands the book was at the time shall replace or pay the value thereof at the discretion of the Committee.

Library Register.

14. A proper register shall be kept by the Librarian of all books taken out and returned to the Library, such register to be laid before the Committee at each monthly meeting.

Admission of books.

15. No books shall be admitted into the Library except they are sanctioned by the Committee.

State of Library.

16. For the purpose of enabling the Committee to ascertain the state of the Free and Circulating Library, they may close the same, call in all outstanding books, and cause same to be closed for a period of not more than 10 days, at such time as the Committee may determine.

Sale of damaged books.

17. The Committee shall have the power to sell, exchange, or otherwise dispose of duplicate or damaged works which they consider unnecessary to be retained in the Library, all proceeds of such sale or exchange to be paid over to the Council in aid of the funds thereof.

Suggestion Book.

- 18. A book to be called "The Suggestion Book" shall at all times lie upon the table at the Reading Room, in which any visitor may enter, for the consideration of the Committee, any suggestion which he may consider proper to make relative to the purchase of books, papers, etc., or for the general conduct and management of the Library. Every such entry to be signed by such visitor making the same, and to be laid by the Librarian before the Committee at each monthly meeting.
- 19. There shall be placed in the Library a catalogue of books, and lists of such books as may be added to the Library subsequent to the printing of the last catalogue.

Rules not to be altered without sanction of Council.

20. These rules shall not be added to, altered, or amended unless with concurrence of a majority of the Committee present at the meeting, and of which seven days' notice in writing has been given. Such alterations and additions to these rules to be subject to the approval of the Bunbury Municipal Council.

Regulations.

- 1. The Circulating Library will be open daily from 3 p.m. to 5 p.m. (except Saturday), and from 7 p.m. to 8.30 p.m. (Sundays and public holidays excepted), and the Reading Room from 9 a.m. to 10 p.m. Children under 12 years of age not admitted.
- 2. Books are to be left on the table to be placed on the shelf by the Librarian.
- 3. In writing extracts, the use of ink is prohibited.
- 4. Writing in or upon, marking, folding down a leaf, defacing, mutilating, or otherwise injuring any book is strictly prohibited. Any person so offending will be excluded from the Library.
- 5. No conversation will be allowed, and no person is to partake of food or fruit, expectorate on the floor, or commit any other irregularity, and any person so offending will be excluded from the Library.
- 6. Smoking or loitering about the entrance or in the Library is not permitted.
- 7. Any person mutilating or taking books from the Library will be prosecuted, and any person giving such information as will lead to the conviction of anyone so offending will receive a reward of £2.
- No person shall keep a newspaper or periodical longer than fifteen minutes after it has been asked for by another person.
- The Librarian is directed to enforce the foregoing Regulations, and cause to be removed any person not complying with the same.

MUNICIPALITY OF BUNBURY.

Alteration of By-law 54, Subsection 7.

7. With regard to the component materials of external walls of buildings that front upon or face towards any public street within the North, Central, and South Wards of the Municipality, every such wall, if the premises are to be used for business purposes, must be built of brick or stone or artificial stone together laid in, and with mortar or cement in such manner as to

produce solid work. If the premises are to be used as dwellings only the external walls may be of wood, provided that the premises are erected not less than twenty feet from any street line, and the plans and specifications of the building and its position on the ground have been approved by the Surveyor.

Alteration of By-law 30.

No person shall place or suspend, in any street or lane in the Municipality of Bunbury, any signboards or other sign, show bill, showboard, or overhanging lamp, which shall project more than three feet from the building line, or be at a less height than eight feet in the clear from the ground, and no person shall suspend in any street in the Municipality any street blind or awning at a less height than four feet six inches in the clear from the ground except by permission of the

Alteration of By-law 54, Subsection 17

Awnings, verandahs, or cantilevers, or any other projection to be erected over footpaths are to be in accordance with drawings and specifications approved by the Surveyor and accordingly adopted by the Council. The minimum height to be eight feet, the verandah to be painted and kept in repair to the satisfaction of the Surveyor, who shall have power to order such repair to the verandahs generally as he may deem necessary. In the event of neglect, or of the Surveyor observing the necessity of removal or repair, such must be com-menced within seven days of the receipt of notice from the Surveyor, and must be completed within 14 days from such notice, or otherwise the verandahs will be removed as nuisances, the cost of such removal to be borne by the owner or occupier, and to be recoverable from him in a summary manner before the Justices.
