WHEREAS by "The Prisons Act, 1903," it is provided in Part 2, Section 8, Subsection (a), that the Governor may proclaim any building, enclosure, or place to be a Gaol: And whereas it is expedient to exercise such power in manner hereinafter appearing: Now therefore I, the said Governor, acting with the advice of the Executive Council, do hereby by this Proclamation proclaim all that building situate at Coolgardie, known and described in the Second Schedule to the said Act as "The Police Gaol at Coolgardie," to be a Gaol.

in the Schedules hereto: Now therefore I, the said Governor, by and with the advice and consent of the Executive Council, do hereby, in exercise of the powers enabling me in this behalf, proclaim and declare as follows:—

- (1) That nets which do not exceed in length 30 fathoms (60 yards) and the size of the mesh of any part whereof is not less than 2½ inches measured from knot to knot on the inside of the mesh when wetted and ready for use and stretched so that the opposite knots on the alternate corners are in contact, shall when used or intended to be used for lawful fishing in the waters defined in the First Schedule hereto be lawful nets, and that it shall not be lawful to use in such waters any net not in conformity with these conditions.
- (2) That nets which do not exceed in length one hundred fathoms and the size of mesh of any part whereof is not less than 2¼ inches measured from knot to knot on the inside of the mesh when wetted and ready for use and stretched so that the opposite knots on the alternate corners are in contact, shall when used or intended to be used for lawful fishing in that portion of the waters of the Leschenault Estuary defined (*vide* separate Proclamation) be lawful nets, and that it shall not be lawful to use in such waters any net not in conformity with these conditions.

First Locality Schedule.

The waters of the Swan River extending from the Railway Bridge at Guildford to the Upper Swan Bridge, near Midland.

Second Locality Schedule.

The waters of the Leschenault Estuary North of a line drawn from the South-Eastern corner of Leschenault Location 24 to the North-Western corner of Leschenault Location 31.

WHEREAS by Section 8 of "The Fisheries Act, 1905-13," it is provided that the Governor may, by Proclamation, prohibit all persons from—

- (a.) Taking fish of any specified species, by any specified means of capture;
- (b.) Taking any fish whatsoever, by any specified means of capture;
- (c.) Taking any fish whatsoever, by any means of capture whatsoever

in any specified portion of Western Australian waters during any specified time in any specified year or during a specified portion of any year: Now therefore I, the said Governor, by and with the advice and consent of the Executive Council, do hereby, in exercise of the powers aforesaid and of any other powers enabling me in this behalf, proclaim and declare as follows:—

(1.) That all that portion of Western Australian waters defined in the First Locality Schedule attached hereto shall be closed against the use of fishing nets as from the first day of January, 1917, until the thirtieth day of April, 1917, and as from the first day of August, 1917, until the thirty-first day of December, 1917, inclusive.

(2.) That all those portions of Western Australian waters defined in the Second Locality Schedule attached hereto shall be closed against the use of fishing nets as from the first day of January, 1917, until the thirtieth day of April, 1917, and from the first day of November 1917, until the thirty-first day of December, 1917, inclusive.

(3.) That all those portions of Western Australian waters defined in the Third Locality Schedule attached hereto shall be closed against the use of fishing nets as from the first day of January, 1917, until the thirty-first day of March, 1917, and from the first day of October, 1917, until the thirty-first day of December, 1917, inclusive.

(4.) That all that portion of Western Australian waters defined in the Fourth Locality Schedule attached hereto shall be closed against the use of fishing nets as from the first day of January, 1917, until the twenty-third day of March, 1917, and from the sixteenth day of May, 1917, until the thirty-first day of December, 1917, inclusive.

(5.) That all that portion of Western Australian waters defined in the Fifth Locality Schedule shall be closed against the use of fishing nets as from the first day of January, 1917, until the thirty-first day of December, 1917, inclusive; provided that subject to certain provisions (*vide* separate Proclamation) it shall be lawful to fish within the waters of the Leschenault Estuary North of a line drawn from the South-Eastern corner of Leschenault Location 24 to the North-Western corner of Leschenault Location 31, between the hours of twelve o'clock noon and twelve o'clock midnight on all Mondays and Thursdays.

(6.) That all that portion of Western Australian waters defined in the Sixth Locality Schedule shall be closed against the taking of English Perch by any method of capture as from the first day of July, 1917, until the thirty-first day of October, 1917, inclusive.

First Locality Schedule.

All that portion of the ocean waters of Rottnest Island lying West of the North-Eastern extremity of North Point (on the Northern side of the said island) and West of the South-Western extremity of Salmon Point (on the Southern side of the said island), and within the sea limits of half-a-mile from the foreshore.

Second Locality Schedule.

(a.) That portion of the waters of Geographe Bay extending in an Easterly direction from the Eastern side of the shore end of the Busselton Pier or Jetty to a point on the foreshore one and a-half miles from the said pier or jetty and half-a-mile into the waters of the said bay,

(b.) That portion of the waters of Geographe Bay extending in a Westerly direction from the Western side of the shore end of the Busselton Pier or Jetty to a point on the foreshore half-a-mile from the said pier or jetty and half-a-mile into the waters of the said bay.

Third Locality Schedule.

(a.) That portion of the waters of Geographe Bay extending from the North-Western side of the "Fish Rock" to a point half-a-mile along the foreshore and a quarter of a mile into the waters of the said bay.

(b.) That portion of the waters of Geographe Bay extending from the South-Eastern side of the "Fish Rock" to a point half-a-mile along the foreshore and a quarter of a mile into the waters of the said bay.

Fourth Locality Schedule.

That portion of the ocean waters near the entrance to Peel's Inlet bounded by the following lines:—

On the West by a line drawn in a Northerly direction for a quarter of a mile from the extremity of Robert Point (on the Western side of the Bar); thence by a line running in an Easterly direction until it meets the foreshore of the mainland (on the Eastern side of the entrance to Peel's Inlet); thence in a generally Southerly direction along the line of foreshore to the Bar; thence by a line in a generally Westerly direction to the Western point of entrance to the Bar, and thence in a generally Westerly direction along the line of foreshore to the point of commencement.

Fifth Locality Schedule.

The whole of the waters of Leschenault Estuary (Bunbury).

Sixth Locality Schedule.

The whole of the waters of the Capel River (near Bunbury), including the creeks flowing into it.

WHEREAS by Section 8 of "The Fisheries Act, 1905-13," it is provided that the Governor may, by Proclamation, prohibit (*inter alia*) all persons from—

- (a) taking fish of any specified species by any specified means of capture,

in any specified portion of Western Australian waters during any specified time in any specified year or during a specified portion of any year: And whereas the "Prawn" is a prescribed species of fish within the meaning of this provision: And whereas by Section 17 of the same Act the Governor may, by Proclamation, declare what length and depth of net and size of mesh for the whole or any part of a fishing net shall, when used or intended to be used in any specified water or waters, or for catching any specified kind or kinds of fish, be a lawful net: Now therefore I, the said Governor, by and with the advice and consent of the Executive Council, do hereby, in exercise of the powers aforesaid and of every other power enabling me in this behalf, proclaim and declare as follows:—

That those portions of Western Australian waters defined in the Schedule hereto shall be closed against the taking of "Prawns" by means of any net other than a hand-scoop net (such net not to exceed a total length of nine feet) from the first day of January, 1917, until the thirty-first day of December, 1917, inclusive: And further, that any net which does not exceed 25 fathoms in length and has a mesh throughout the whole of the

net of not less than one-half inch, measured from knot to knot on the inside of the mesh when wetted ready for use and stretched so that the opposite knots on the alternate corners are in contact, shall be a lawful net when used or intended to be used for the capture of "Prawns" in any Western Australian waters, except that portion defined in the said Schedule.

Schedule.

That portion of the Swan River extending in a West-erly and Southerly direction to its entrance from a line drawn from the Point Walter Jetty (at Water Point) to Point Resolution, and the Swan River and its tributaries extending upwards in a Northerly and North-Easterly direction to its head from the Narrows at Mill Point.

That portion of the Canning River and its tributaries extending upwards to its head from a line drawn due South from Salter's Point.

- (b) taking any fish whatsoever, by any specified means of capture;
- (c) taking any fish whatsoever, by any means of capture whatsoever,

in any specified portion of Western Australian waters during any specified time in any specified year or during a specified portion of every year: And whereas the "Crayfish" is a prescribed species of fish within the meaning of the hereinbefore recited provision: Now therefore I, the said Governor, by and with the advice and consent of the Executive Council, do hereby, in exercise of the powers aforesaid and of every other power enabling me in this behalf, proclaim and declare as follows:—

That all those portions of Western Australian waters defined in the Schedule hereto shall be closed against the taking of "Crayfish" by means of pots or "cribs," hoop nets, or meshing nets, from the 1st day of January, 1917, until the 31st day of December, 1917.

Locality Schedule.

- (a) The whole of the waters of Rottnest Island within a radius of half a mile from the line of foreshore.
- (b) The waters of the Swan River and its tributaries.
- (c) The waters of Koombana Bay (Bunbury).

WHEREAS by Section 9 of "The Fisheries Act, 1905-13," it is provided that the Governor may, by Proclama-

tion, prohibit all persons from taking any fish whatsoever, in every or any specified portion of Western Australian waters, by means of fishing nets and fishing lines, or either of such means of capture or by any other specified means of capture, for any specified term: Now therefore I, the said Governor, by and with the advice and consent of the Executive Council, do hereby, in exercise of the powers aforesaid and of every other power enabling me in this behalf, proclaim and declare as follows:—

That all those portions of Western Australian waters defined in the Schedule hereto shall be closed against the use of fishing nets from the first day of January, 1917, until the thirty-first day of December, 1919, inclusive.

Schedule.

(1.) The waters of the Swan River and its tributaries extending in a North, Easterly, and North-Easterly direction from a line drawn from the North-Eastern extremity of the Mill Point Wharf (situated on the Western side of Belches or Mill Point) to the North-Western extremity of the Harbour and Light's Wharf (situated on the Western side of the river between the Swan Brewery and Eliza Point) to the Railway Bridge at Guildford (except for Prawns, *vide* separate Proclamation).

(2.) The waters of the Swan River and its tributaries extending from the Upper Swan Bridge (near Midland) to the head of the Swan River (except for Prawns, *vide* separate Proclamation).

(3.) The waters of the Swan River and its tributaries West, South, and South-West of a line drawn from the South-Western extremity of Point Resolution to the South-Western extremity of the Point Walter Jetty (situated at Walter Point) to a line drawn from the Western extremity of the South Mole to the Western extremity of the North Mole (at Fremantle).

(4.) The waters of the Canning River and its tributaries from the Lower Canning Bridge to the head of the said river (except for Prawns, *vide* separate Proclamation).

(5.) The whole of the waters of the Channel Entrance to Peel's Inlet (Mandurah) bounded on the North by a line drawn in an Easterly direction from the extremity of the Western point of Entrance (at the Bar) to a point on the mainland on the Eastern shore, and on the South by lines drawn in an Easterly direction from the South-Eastern corner of Murray Location No. 5, to the Southern extremity of Channel Island; thence to the South-Western extremity of Creery Island and by its Southern foreshore to the Eastern extremity of that Island; thence by a line drawn in a North-Easterly direction to a point on the foreshore of the mainland.

(6.) The whole of the waters of the Murray River and the Serpentine River (including their estuaries, tributaries, lakes and lagoons, the waters of which during any time of the year have access directly or indirectly to the sea lying North, East, and South-East of a line drawn from a point on the Eastern foreshore of Peel's Inlet situated East of the Southernmost point of Goongoolup Island, and extending in a Westerly direction half a mile; thence in a Northerly direction to the foreshore of Peel's Inlet to a point lying West of the Western side of the entrance to the Serpentine River.

(7.) The whole of the waters of the Harvey River and that portion of the Harvey Estuary South of that part known as the "ford" which extends from Reserve No. 2990 on the Western side of the said Estuary to Reserve No. 2991 on the Eastern side of the said Estuary.

(8.) That portion of the waters of Koombana Bay (Bunbury) situated Southward of a line drawn from the junction of the Stone Causeway with the Bunbury Jetty to a white post situated on the foreshore 27 chains Eastward of the North-Eastern corner of the Quarantine Reserve at North Bunbury.

(9.) The whole of the waters of Toby's Inlet and that portion of the ocean waters within a radius of a quarter of a mile from the entrance on either side to the said Toby's Inlet.

(10.) The whole of the waters of the King River (Albany), including its tributaries, West of a line drawn in a North-Easterly direction from a point on the Western foreshore of Oyster Harbour, 25 chains South from the Southern extremity of the King River Bridge to a point, on the Northern foreshore of Oyster Harbour, 57 chains East of the Northern extremity of the said Bridge.

(11.) The whole of the waters of the Kalgan River (Albany), including its tributaries, North of a line drawn in a South-Easterly direction from a point, on the

Northern foreshore of Oyster Harbour, 57 chains East of the Northern extremity of the King River Bridge to a point of the foreshore at Swan Point (on the Eastern side of Oyster Harbour) 68 chains South from the Eastern extremity of the Kalgan River Bridge,

(12.) The waters of the Channel Entrance between King George's Sound and Oyster Harbour (Albany), the Northern boundary being a line drawn in an Easterly direction from a point on the foreshore 10 chains North of Emu Point (on the Western side of the entrance aforesaid) and the Southern boundary being a line drawn in an Easterly direction from a point on the foreshore 10 chains South of the said Emu Point.

(13.) The whole of the waters of the Denmark River and its tributaries and that portion of the waters of Wilson's Inlet within a radius of half a mile from the mouth of the said Denmark River.

(14.) The whole of the waters of the Hay River and its tributaries and that portion of the waters of Wilson's Inlet within a radius of half a mile from the mouth of the said Hay River.

(15.) The whole of the waters of Taylor's or Nanarup Inlet (near Albany).

(16.) The whole of the waters of the Preston River, the Collie River, and the Capel River, with their tributaries.

(17.) That portion of the waters of Champion Bay (Geraldton) extending from a point on the foreshore 100 yards Eastward of the Geraldton Railway Jetty to a point on the foreshore 100 yards to the Westward of the said Jetty and thence half a mile into the waters of the said Champion Bay.

(18.) That portion of the waters of Champion Bay (Geraldton) extending from a point on the foreshore 100 yards Eastward of the Geraldton Esplanade Jetty to a point on the foreshore 100 yards Westward of the said Jetty and thence half a mile into the waters of the said Champion Bay.

(19.) All that portion of Western Australian waters known as the "Dead" Water, situated in Sussex Location No. 11.

(20.) All that portion of the waters of Cockburn Sound (near Rockingham Beach) lying South of a line drawn from the North-Western extremity of Point John, intersecting the North-Western extremity of the Northernmost pier or jetty at Rockingham Beach and extending to a point on the foreshore at the said Rockingham Beach.

(21.) All that portion of Western Australian waters contained in the Vasse and Wonnerup Estuaries.

(22.) The whole of the waters of Torbay Inlet (near Albany) including the waters of the creeks flowing into it.

(23.) That portion of the waters of the Gascoyne River (Carnarvon) lying between the Jetty Tramway Bridge and a line drawn from the Beacon on the South-Eastern corner of Babbage Island to Mangrove Point on the mainland.

(24.) All that portion of the ocean waters of Rottnest Island lying East of the North-Eastern extremity of North Point (on the Northern side of the said Island) and East of the South-Western extremity of Salmon Point (on the Southern side of the said Island) and within the sea limits of half a mile from the foreshore.

(25.) The waters of the channel entrance to Hardy's Inlet (Augusta) situated between a line drawn in a North-Easterly direction from Duke's Head (on the Western side of the Inlet) to Point Frederick (on the Eastern side of the Inlet) and a line drawn in a West-erly direction from Point Irwin (on the Eastern side of the Inlet) to a point where the Southern boundary of Hurford Street touches the foreshore on the Western side of the River.

(26.) The whole of the waters of Grassmere Lake, also known as Nine-Mile Lake (near Albany) and the waters of the creeks flowing into it.

(27.) The waters of Geographe Bay, near Wonnerup Inlet, bounded on the South by a North-West-erly line drawn from a point on the foreshore fifteen (15) chains South-East from the Southern side of the "Old Jetty" and extending into the waters of the said Bay a distance of 40 chains; thence by a line drawn in a North-Easterly direction a distance of about 120 chains; thence by a line drawn in a South-Easterly direction extending to the foreshore of the said Bay at a point 60 chains North of the Northern point of entrance to Wonnerup Inlet, and

thence in a South-West-erly direction by the foreshore of the said Bay to the point of commencement.

By-law No. 40.

Advertising Hoardings, Posting Bills, Painting Advertisements.

IN pursuance of the powers in that behalf contained in Part VIII. of "The Municipal Corporations Act, 1906," the Municipal Council of the City of Perth doth hereby make the following By-law:—

Repeal.

1. All By-laws hitherto made by the Municipal Council of the City of Perth, with reference to the matters herein contained, are hereby repealed.

Interpretation Clause.

2. In the construction of this By-law:—

- (a) The word "hoarding" shall mean a hoarding erected on private property for advertising purposes.
- (b) The word "occupier" shall mean the person having the use and control of a hoarding.
- (c) The word "owner" shall mean the owner of the land on which a hoarding is erected.
- (d) "Building Surveyor" shall mean the Building Surveyor for the time being of the City of Perth.
- (e) The word "Council" shall mean the Municipal Council of the City of Perth.
- (f) The word "Municipality" shall mean the Municipal District of the City of Perth.
- (g) The word "Advertisement" shall mean and include papers, bills, or posters and all other advertisements of any nature, stencilled, painted, or embossed and affixed or placed in any way on walls, fences, or windows.

3. No person shall erect or cause to be erected a hoarding unless and until a plan and specification, showing clearly the position and size and the method of and the materials to be used in the construction of, and the manner of fixing same, shall have been deposited with and approved by the Building Surveyor, and except in accordance with such plan and specification, and a license in the form of Part 1 of the Schedule attached hereto has been issued by the Building Surveyor.

4. No license shall be granted in respect of any hoarding erected either before or after the passing of this By-law, unless the distance from the face of the hoarding to the alignment of the nearest street or way shall be at least equal to the distance from the level of such street or way to the highest point of such hoarding.

5. Every person erecting a hoarding, or the occupier or owner of a hoarding already erected at the corner of two streets, shall cause such hoarding to be rounded off or splayed off to its full height, as may be required by the Building Surveyor.

6. No person shall make any alteration or addition to any hoarding, unless and until the proposed alteration or addition shall have been approved in writing by the Building Surveyor.

7. If any hoarding is at any time, in the opinion of the Building Surveyor, in a dangerous or neglected condition, and the owner or occupier shall upon receipt of a written notice to that effect fail to forthwith remove or refix the same to the satisfaction of the Building Surveyor, the Council may remove the same and recover the cost of so doing from the owner or occupier.

8. The occupier of a hoarding shall maintain such hoarding to the satisfaction in all things of the Building

Surveyor, and if any paper or other material affixed thereto becomes detached shall forthwith remove and clear away such paper or other material.

9. If in the opinion of the Council any bill, placard, or advertisement attached to or painted on any hoarding be objectionable, and the occupier or owner shall upon receipt of a written notice to that effect fail to at once remove or cause to be removed such bill, placard, or advertisement, the Building Surveyor or other person or persons authorised by the Council may remove the same and recover the cost of such removal from the occupier or owner.

10. All notices required under this By-law to be served on the owner or occupier shall, in the first place, be given by the Council to the occupier, but if he cannot be found then any such notice may be served upon the owner.

11. If the occupier or owner of any hoarding fails to comply with a written order of the Council within the time named in such order, the Building Surveyor or other person or persons authorised by the Council may carry out the requirements of the said order, and any costs incurred may be recovered by the Council from the occupier or from the owner.

12. No person shall attach, paste, or paint any bill or other form of advertisement upon any hoarding in any part of the Municipality without having a valid and subsisting monthly or yearly license therefor from the Building Surveyor in the form of Part 2 of the Schedule hereto attached.

13. Every license issued by the Surveyor under Sections 3 and 12 of this By-law shall terminate on the 31st day of October in each year.

14. The fee for a license under Section 3 shall be sixpence per superficial yard per annum. The fee payable for a monthly license under Section 12 of this By-law shall be seven shillings and sixpence (7s. 6d.), and the fee payable for a yearly license under Section 12 shall be four pounds (£4). Full fees shall be charged for all licenses issued before the thirteenth day of April in each year, but for all licenses, other than monthly licenses, issued between the first day of May and the thirty-first day of October in each year, half fees shall be charged, provided that in no case shall the charge be less than ten shillings (10s.).

15. Every hoarding shall at all times have the name of the occupier clearly shown in a conspicuous place on the front of the hoarding.

16. No person shall post, paint, stencil, place, or affix any advertisement on any fence, wall, footpath, or on any fence or wall, window, or other portion of any building facing or abutting on any street or way or public place within the Municipality.

17. The Council may permit the display of advertisements at theatres or other places of public amusement, and may permit the advertising of meetings or objects of national or general importance, under such terms and conditions as the Council may in each case decide.

18. Applications for such permission shall be made in the form specified in Part 3 of the Schedule hereto attached.

19. Any permission granted by the Council hereunder may be in the form specified in Part 4 of the said Schedule.

20. The provisions of Section 16 of this By-law shall not apply to bills or advertisements posted on or affixed to signboards to the erection or maintenance of which the Council has consented, or to the advertisement by the occupier of any shop or dwelling on the windows thereof in respect of the business carried on by him therein, or to advertisements as allowed for and provided by the standard verandah specifications.

21. The use of any advertisement within the Municipality, otherwise than in accordance with this By-law, is hereby prohibited.

22. The occupier or owner of any premises within the Municipality on the walls, windows, or fences of which any bills or any advertisements are painted, stencilled, placed, or fixed contrary to the provisions of this By-law shall, on receiving written notice from the Council so to do, remove the same, and if the same are not removed within seven days from the giving of such notice then the Council may by its officers remove the same and recover from the owner or occupier in a court of summary jurisdiction the cost of so doing.

Penalties for breaches of By-laws.

23. Where anything in this By-law is directed to be done or forbidden to be done, or where authority is

given to any officer to direct anything to be done or to forbid anything to be done and such act forbidden to be done is done, in every such case the person making default as to such direction and prohibition respectively shall be deemed guilty of a breach of this By-law; and every person guilty of a breach of this By-law shall be liable, for every such offence, besides any costs or expenses which may be incurred in the taking of proceedings against such person guilty of such offence, to a penalty of Ten shillings (10s.) for the first breach of this By-law and to a penalty not exceeding Twenty pounds for every succeeding breach of such By-law, or to a penalty not exceeding Two pounds (£2) for each day during which such breach shall be committed or continued, and in addition to such penalty shall be liable to pay to the Council any expense incurred by the Council in consequence of any breach or non-observance of any By-law, or in the execution of any work directed to be executed and not so executed. Provided that the minimum pecuniary penalty for any offence against this By-law other than the first offence shall be one-tenth of the maximum penalty hereby provided.

The Court of Arbitration of Western Australia doth hereby make the following Award in connection with the industrial dispute between the abovementioned parties :—

AWARD.

1. *Hours.*—The workers covered by this award, excepting those mentioned in Section II., may be required to work the maximum hours prescribed for shop assistants by "The Early Closing Act, 1902," and the amendments thereof.

For the purposes of this award the time during which the worker is on the premises of the employer shall be deemed working time. If a worker has permission to leave the premises for any time not less than one hour, but prefers to remain thereon, such time shall not be included in the working time.

The working hours shall be exclusive of holidays, and of the time allowed for meals and all other time off.

2. *Holidays.*—During each week of seven days the weekly workers covered by this award shall be allowed as a holiday—

- (a.) One whole day, or if it be impracticable to grant the whole day, then,
- (b.) Two half-days commencing immediately after the conclusion of the mid-day meal and terminating at the usual starting time on the next ensuing morning, or,
- (c.) One afternoon and one morning consecutively, commencing immediately after the conclusion of the mid-day meal on the first day and terminating immediately before the mid-day meal on the second day.

Provided that in lieu of two half-days in each of any two consecutive weeks there may be granted the Sunday in one of such weeks and one half-day in each of such weeks.

No deduction shall be made from the wage of any worker in consequence of the granting of any such holiday or half-holiday.

3. *Wages*.—The minimum wages payable to workers employed in the capacities hereinafter mentioned shall be as follows:—

If the juniors are required to wear special uniforms they shall be supplied by and remain the property of the employer.

Work done by workers, not being shop assistants, covered by this section, after the completion of fifty-six hours in a week in the case of males, or fifty-two hours in a week in the case of females, shall be deemed overtime, and shall be paid for at the rate of time and a-half. Provided always that no employer shall employ any worker and no worker shall work for any employer for a longer period of overtime than five hours in any one pay-week except during—

- (i.) The two weeks from the 23rd December to the 6th January;
 - (ii.) The week immediately preceding and the week immediately succeeding Easter Sunday; and
 - (iii.) The week during which the Royal Agricultural Show is held;
- in any one of which weeks the maximum period of overtime permissible shall be ten hours.

(a.) Casual workers, with the exception of those employed in connection with the outside catering jobs hereinafter mentioned, shall be engaged by the day and shall be paid at the rate of time and a-half during the first three consecutive days of employment, and thereafter at the minimum rate hereinbefore prescribed.

(b.) Casual workers engaged in work done in connection with race-courses, show grounds, or sports grounds shall be paid 2s. per hour for males and 1s. 3d. per hour for females, with a minimum of two and a-half hours' pay.

(c.) The time for casual workers at outside jobs shall count from the time appointed for their attendance on the job until they are discharged.

(d.) The wage payable to casual workers on outside jobs shall be handed to the worker immediately on completion of the employment.

GENERAL CONDITIONS.

4. *Employer acting as Chief Cook.*—Where an employer is substantially and continuously acting as chief cook his employment shall, for the purposes of this award, be regarded as the employment of a chief cook for the purpose of ascertaining the minimum wage payable to the other cooks in the same establishment.

5. *Weekly Wage.*—Wages shall be payable weekly. When no agreement in writing is made determining the period of notice, then a notice of not less than forty-eight hours shall be given by either party of intention to terminate the service.

The employer may keep in hand two days' pay until the service has been legally terminated.

This clause shall not be deemed to apply to the casual workers provided for in clause 3, Section III., subdivision (b), of this award.

6. *Board and Lodging.*—If board is not provided by the employer the worker shall be entitled to seventeen shillings per week, and if lodging is not provided he or she shall be entitled to five shillings per week, in addition to the wage hereinbefore prescribed. The employer requiring a worker to sleep in shall provide suitable accommodation. If the worker shall consider the accommodation unsuitable, then the union may request a Health Inspector to inspect and report upon the same, and his decision shall be final on the point. This clause shall not apply to tea-rooms.

7. At least half an hour shall be allowed to each worker for each meal not otherwise provided for under the provisions of "The Early Closing Act, 1902," or its amendments.

8. All workers covered by this award and who are required to work on proclaimed holidays shall be allowed one week's holiday on full pay after the completion of each twelve months' service: Provided that the worker shall, if required, supply to the employer the name of a suitable substitute willing to take his place during such holiday. Provided, also, that any worker who shall have served three months or over, and whose services shall be terminated, for any cause other than misconduct, before a week's holiday has become due under this subclause, shall be entitled to a proportionate allowance in respect of the time actually served.

9. A worker covered by Section I. of this award who does not during the whole or part of his or her annual holiday board and lodge at his or her employer's establishment, shall be entitled to an addition to his or her cash wage of a proportionate part of the board and lodging allowance provided by Clause 6 hereof: Provided that any worker who desires his or her room to remain unused during his or her absence shall not be entitled to any addition to his or her cash wage by way of lodging allowance.

10. A worker covered by Section II. of this award who does not during the whole or part of her annual holiday have her meals at her employer's establishment shall be entitled to an addition to her cash wage of 12s. or a proportionate part thereof as the case may be.

11. No female worker employed in an hotel and who is covered by this award shall be compelled to serve in the bar.

12. *Record.*—The employer shall keep or cause to be kept at his business premises, or at each of them if more than one, a time and wages book wherein shall be entered the name, occupation, and in the case of juniors the age on his or her last birthday, the time he or she commences and finishes work each day, the hours worked on each day, and the weekly wages of such worker.

Such book shall be entered up from day to day and shall be signed weekly, if correct, by each worker.

The employer and worker shall be severally responsible for the proper daily posting up of the book, which shall be open to the inspection by a duly authorised representative of the union, on a portion of the employer's premises convenient to the employer during all working hours.

13. *Scope of Award.*—This award shall be binding upon the above-named parties, and shall have effect over the area comprised within a radius of sixteen miles from the General Post Office, Perth.

14. *Term of Award.*—This award shall continue in force for a period of three years from its date: Provided that, at any time after the expiration of twelve months from its date, the Court may alter or amend the same on the application of any party or person affected by its provisions.
