WHEREAS by Section 8 of "The Fisheries Act, 1905-13," it is provided that the Governor may, by Proclamation, prohibit all persons from—

- (a) Taking fish of any specified species, by any specified means of capture;
- (b) Taking any fish whatsoever, by any specified means of capture;
- (c) Taking any fish whatsoever, by any means of capture whatsoever,

in any specified portion of Western Australian waters, during any specified time in any specified year or during a specified portion of every year: Now therefore I, the said Governor, by and with the advice and consent of the Executive Council, do hereby, in exercise of the powers aforesaid and of every power enabling me in this behalf, proclaim and declare as follows:—

That all that portion of Western Australian waters defined in the Schedule hereto shall be closed against the use of fishing nets as from the 1st day of July, 1917, until the 30th day of September, 1917.

The waters of the Hotham River.

WHEREAS by "The Game Act, 1912-13," it is provided that the Governor may from time to time, by Proclamation, declare any one or more portions of the State or any one or more localities to be respectively defined in such Proclamation a Reserve for Native Game or any particular Native Game: Now therefore I, the said Governor, in exercise of the power aforesaid, do hereby, with the advice of the Executive Council, declare that the portions of the State and localities mentioned and defined in the Schedule hereto shall be a Reserve for Native Game:—

Schedule.

That portion of the Municipality of South Perth known as the Golf Links, bounded on its four sides by Amherst Street, Labouchere Road, South Terrace, and Melville Terrace, respectively.

SWAN RIVER REGULATIONS.

WHEREAS by virtue of the Ordinances 18 Vict., No. 15, and 37 Vict., No. 14, the Governor may by Proclamation from time to time frame rules and regulations not repugnant to any of the provisions of the said Ordinances, to be observed by all masters and commanders of all ships or vessels in any of the ports or harbours of the said Colony, and by all persons duly appointed or licensed to act as Harbour Masters or Pilots in such ports or harbours, and further may alter, amend, or repeal such rules and regulations and substitute others in their stead: And whereas the Governor acting under the aforesaid Ordinances did by Proclamation dated the 14th day of December, 1904, and published in the *Government Gazette* of the 6th day of January, 1905, frame the rules and regulations annexed to the said Proclamation: And whereas it is desirable that the said rules and regulations be repealed and fresh rules and regulations substituted therefor: Now therefore I, the said Governor, acting with the advice and consent of the Executive Council and in pursuance of the powers aforesaid and of all other powers me in this behalf enabling, do hereby repeal the Proclamation dated the 14th day of December, 1904, and the rules and regulations annexed thereto, as from the coming into force of the rules and regulations in the Schedule hereto; and do hereby declare and proclaim that the rules and regulations in the Schedule hereto shall be substituted therefor, and that the rules and regulations hereby proclaimed shall come into force and have effect at the expiration of one month from the publication of this Proclamation in the *Government Gazette*.

The Schedule.

REGULATIONS FOR THE NAVIGATION OF THE SWAN RIVER BETWEEN THE FREMANTLE RAILWAY BRIDGE, PERTH CAUSEWAY, AND CANNING BRIDGE.

1. The following Regulations shall be enforced and observed on the Swan River within the prescribed limits, namely, between the Railway Bridge at Fremantle, the Causeway Bridge at Perth Water, and Canning Bridge.

2. The Chief Harbour Master or his deputy, or other officer acting for such Chief Harbour Master, shall have entire control over the Swan River, within the said limits and over the navigation thereof, and shall have power to remove any boat or vessel from any berth or anchorage, and to alter the berth or anchorage of any boat or vessel whenever he may deem it necessary.

3. In every case where, by these Regulations, any act is forbidden or required to be done in relation to any boat or vessel, the duty of performing such act, or of seeing that such act is not done or committed, shall rest upon the master and the owner of such boat or vessel, unless where otherwise expressly directed to the contrary.

4. No boat or vessel shall be anchored in or near the middle of any fairway or channel: and any boat or vessel detained in the fairway or channel shall lie close on one side of such fairway or channel, nor shall any cable chain, hawser, or rope be placed across any such fairway or channel without permission from the Chief Harbour Master.

5. The master and the owner of any boat or vessel compelled by unavoidable circumstances to let go any anchor in any fairway or channel shall, as soon as possible, lift the same and place it in such a situation as not to interrupt or interfere with the free passage of other boats or vessels.

6. In the following Regulations "Steam vessel" means any vessel propelled otherwise than by sails or oars.

Lights when under way. Masthead lights for steamers.

7. Every vessel when navigating the said waters shall carry lights from sunset to sunrise as follows, that is to say:—On the starboard side, a green light so constructed as to throw an uniform and unbroken light over an arc of the horizon of ten points of the compass, so fixed as to throw the light from ahead to two points abaft the beam on the starboard side, and of such a character as to be visible on a dark night, with a clear atmosphere, at a distance of at least one mile; on the port side, a red light, so constructed as to throw an uniform and unbroken light over an arc of the horizon of ten points of the compass, so fixed as to throw the light from right ahead to two points abaft the beam on the port side, and of such a character as to be visible on a dark night, with a clear atmosphere, at a distance of at least two miles. The said green and red side lights shall be fitted with inboard screens projecting forward from the light, so as to prevent these lights from being seen across the bow, and every steam vessel shall, in addition to the lights above required, carry, from sunset to sunrise, when under way and when navigating the said waters, and at a height above the hull of such steam vessel of not less than 10 feet, a bright white light so constructed as to show an uniform and unbroken light over an arc of the horizon of 20 points of the compass, so fixed as to throw the light 10 points on each side of the vessel, viz.: from right ahead to two points abaft the beam on either side, and of such a character to be visible on a night with a clear atmosphere at a distance of at least two miles. Launches may carry the white light at any convenient height above the hull, and shall not be obliged to carry the side lights above mentioned, but in lieu thereof shall carry a combined lantern showing a green light and a red light from right ahead to two points abaft the beam on their respective sides. Such lantern shall be carried not less than three feet below the white light.

8. A steam vessel when towing another vessel shall, in addition to her side lights, carry two bright white lights in a vertical line one over the other, not less than three feet apart, so as to distinguish her from other steam vessels. Each of these lights shall be of the same construction and character, and shall be carried in the same position as the white light which other steam vessels are required to carry.

Sailing Vessels to carry lights if towed.

9. A sailing vessel under way, or being towed, shall carry the same lights as are provided by Article 7 for a steam vessel under way, with the exception of the white light, which she shall never carry.

Anchor light.

10. A vessel, whether a steam vessel, sailing vessel, or lighter, when at anchor, shall carry, where it can best be seen, but at a height not exceeding 20 feet above the hull, a white light in a globular lantern of not less than eight inches in diameter, and so constructed as to show a clear uniform and unbroken light visible all round the horizon at a distance of at least one mile.

Boat lights.

11. Open boats, sailing boats, and lighters of less than 28 tons net registered tonnage, when under way, shall not be obliged to carry the coloured side lights; but every such boat and vessel shall in lieu thereof have ready at hand a lantern with a green glass on one side, and a red glass on the other side, and on approaching to or being approached by another vessel, such lantern shall be exhibited in sufficient time to prevent collision, so that the green light shall not be seen on the port side nor the red light on the starboard side.

Anchor lights for boats.

12. Every yacht, fishing vessel, launch, and every open boat, when at anchor between sunset and sunrise in an unauthorised anchorage, shall exhibit a white light visible all round the horizon at a distance of at least one mile.

Stern lights.

13. A vessel which is being overtaken by another shall show from her stern to such last-mentioned vessel a white light or a flare-up light.

Steering and sailing rules.

14. When two sailing vessels are approaching one another so as to involve risk of collision, one of them shall keep out of the way of the other, as follows:—

- (a.) A vessel which is running free shall keep out of the way of a vessel which is close-hauled.
- (b.) A vessel which is close-hauled on the port tack shall keep out of the way of a vessel which is close-hauled on the starboard tack.
- (c.) When both are running free with the wind on different sides, the vessel which has the wind on the port side shall keep out of the way of the other.
- (d.) When both are running free with the wind on the same side, the vessel which is to windward shall keep out of the way of the vessel which is to leeward.
- (e.) A vessel which has the wind aft shall keep out of the way of the other vessel.

15. If two vessels under steam are meeting end on, or nearly end on, so as to involve risk of collision, each shall alter her course to starboard, so that each may pass on the port side of the other.

This section only applies to cases where steam vessels are meeting end on, or nearly end on, in such a manner as to involve risk of collision, and does not apply to two vessels, which must, if both keep on their respective courses, pass clear of each other.

The only cases to which it does apply are when each of the two vessels is end on, or nearly end on, to the other; in other words, to cases in which by day each vessel sees the masts of the other in line, or nearly in a line with her own, and by night to cases in which each vessel is in such a position as to see both the side-lights of the other.

It does not apply, by day, to cases in which a vessel sees another ahead crossing her own course; or, by night, to cases where the red light of one vessel is opposed to the red light of the other, or where the green light of one vessel is opposed to the green light of the other, or where a red light without a green light or a green light without a red light is seen ahead, or where both green and red lights are seen anywhere but ahead.

16. If two vessels under steam are crossing, so as to involve risk of collision, the vessel which has the other on her own starboard side shall keep out of the way of the other.

17. If two vessels, one of which is a sailing vessel and the other a steam vessel, are proceeding in such directions as to involve risk of collision, the steam vessel shall keep out of the way of the sailing vessel.

18. Every steam vessel when approaching another vessel so as to involve risk of collision shall slacken her speed and stop and reverse her engines if necessary.

19. In taking any course authorised or required by these Regulations, a steam vessel under way may indicate that course to any other vessel which she has in sight by the following signals on her steam whistle or horn, viz.:—

One short blast to mean "I am directing my course to starboard."

Two short blasts to mean "I am directing my course to port."

Three short blasts to mean "I am going full speed astern."

The use of these signals is optional, but if they are used the course of the vessel must be in accordance with the signal made.

20. Notwithstanding anything contained in any preceding Regulation, every vessel, whether a sailing vessel or a steam vessel, overtaking any other shall keep out of the way of the overtaken vessel.

21. In narrow channels every steam vessel shall, when it is safe and practicable, keep to that side of the fairway or mid-channel which lies on the starboard side of such vessel.

22. Where by the above Rules one of two vessels is to keep out of the way, the other shall keep her course.

23. In obeying and construing these Rules due regard shall be had to all dangers of navigation and to any special circumstances which may render a departure from the above Rules necessary in order to avoid immediate danger.

24. No vessel or any obstruction shall be fastened to or near any public steps or landing place for passengers in such a manner as to impede free access to such public steps or landing places.

25. For the purpose of seeing that all or any of these Regulations are properly carried out, the Water Police, in uniform, shall have access to any vessel at any hour of the day or night, and shall be allowed and authorised to ask any reasonable question of the master of the vessel, or of any officer thereof, and any information required shall in all cases be furnished.

26. No vessel shall be beached or grounded without permission being first had and obtained from the Chief Harbour Master, and any such vessel which shall take the ground or be stranded as aforesaid from accident or stress of weather, or any other cause, shall be removed by the owner when called upon to do so by the Chief Harbour Master.

27. The Chief Harbour Master may, whenever it appears necessary to such Chief Harbour Master, appoint the place of moorage or anchorage of all coasting vessels, cargo and other boats, and from time to time, when necessary, may direct the removal of any such coasting vessel, cargo or other boat, therefrom to such other place of moorage or anchorage. (34 Vict., No. 22.)

28. Any person who shall moor or anchor, or shall wilfully or by culpable negligence ground, sink, or set adrift in any of the fair channels or passages of any navigable river or water within the territory of Western Australia any substance or article liable to obstruct the passage of boats or crafts by coming in contact with them, shall, on conviction thereof, forfeit any sum not exceeding Twenty pounds. (17 Vict., No. 4.)

29. If the owner or some person on behalf of the owner of any vessel sunk, stranded, or run on shore in any harbour, port, roadstead, channel, or navigable river within the said territory, shall not weigh, raise, or otherwise remove such vessel within ten days next after the same shall have been so sunk, stranded, or run on shore, the Chief Harbour Master of such harbour, port, or roadstead in which such vessel shall lie may take and use all necessary ways and means for clearing such harbour, port, roadstead, channel, or river of such vessel. (17 Vict., No. 4.)

30. The Chief Harbour Master may remove any wreck or any other substance which impedes, or tends to impede, the navigation of the Swan River, or access thereto, or which shall be a nuisance or inconvenience in or to any harbour; and the expense of such removal shall be repaid by the owner of such wreck or other substance to such Chief Harbour Master, or, in default of payment thereof on demand, the said Chief Harbour Master may recover the same as a penalty. (37 Vict., No. 14, Section 5.)

31. Every person other than the Chief Harbour Master who shall wilfully let go, cut, break, or destroy the moorings or fastenings of any vessel lying in a harbour or dock at or near a wharf shall, for every such offence, be liable to a penalty not exceeding Five pounds, in addition to any liability he may incur by proceedings at the suit of or for the benefit of any person damaged thereby. (37 Vict., No. 14.)

32. Any person who shall wilfully injure or remove any buoy, beacon, or sea-mark used for the convenience of navigation or security of shipping shall be liable to a penalty of Fifty pounds. (18 Vict., No. 15, Section 15.)

33. Any person who shall, without permission from the Chief Harbour Master, make fast any vessel or any other article to any such buoy, beacon, or sea-mark as aforesaid shall be liable to a penalty of Ten pounds. (18 Vict., No. 15, Section 16.)

34. No person shall improperly interfere with any life-saving gear, life-buoy, or other apparatus placed within the port for the purpose of saving life from drowning.

35. If any person throw, or cause to be thrown out of any vessel into the navigable part of any river, creek, or water, below high-water mark, any sand ballast, stone, or rubbish, or who shall remove or take away from any bank of the same above-high-water mark, not being private property, any sand ballast or stone without having first obtained the consent of the Chief Harbour Master of the port, shall, on conviction for every such offence, forfeit any sum not less than Ten shillings nor more than Five pounds. (17 Vict., No. 4.)

36. On the occasion of any boat race or regatta, or on any occasion when crowds assemble, no vessel shall pass on the river so as to obstruct, impede, or interfere with the boat race or regatta, or to endanger the safety of persons assembling on the river, or to prevent the maintenance of order thereon.

37. No steam vessel shall be permitted to pass through any bridge with more than one laden lighter or barge in tow at a time.

38. If any master of any vessel shall fail to observe the Port Rules and Regulations, he shall, for every such offence, forfeit any sum not exceeding Twenty pounds (£20): Provided that no master of any vessel shall be liable to a fine for any breach of such Rules and Regulations unless a copy thereof shall have been previously delivered to him or left on board his vessel. (18 Vict., No. 15.)

39. Whenever applicable in these Regulations, a vessel holding a license issued by the Fremantle Harbour Trust Commissioners, acting as the Fremantle Boat Licensing Board, under "The Boat Licensing Act, 1878," and the Regulations of the Commissioners thereunder, shall be amenable to these Regulations, as well as those under which the license is issued.

40. The Port Regulations as proclaimed on the 2nd November, 1904, shall apply to the Swan River within the said territory in so far as they are applicable.

41. The speed of passenger steamers on the Swan River shall not exceed five knots when passing to and fro between the notice "Slow" in Rocky Bay and North Fremantle Road Bridge, also when navigating the Narrows Channel and the channel leading to Barrack Street Jetties.

42. A charge in accordance with the following scale shall be paid by the owner of every vessel or boat for a permit to moor, fasten, or take such vessel or boat alongside any public bridge, jetty, pier, wharf, landing place, or buoy in the Swan River. Such charge shall be paid before a permit is issued:—

Vessels or boats licensed to carry passengers—2s. per head per annum for the first 25 passengers; 1s. per annum for each additional passenger.

Unlicensed vessels or boats:—

17 feet in length and under—5s. per annum.
Over 17 feet and under 28 feet—10s. per annum.
28 feet and over—£1 per annum.

(Note.—The above measurements shall be taken from the fore part of the stem under the bowsprit to the aft side of the head of the stern post.)

43. The owner of any vessel or boat licensed to carry passengers may be permitted to use a Government wharf or jetty as a permanent berth for such boat or vessel where accommodation is available, on payment of a charge in accordance with the following scale, in addition to the charge payable under the preceding regulation; provided that it shall at all times be in the discretion of the Chief Harbour Master or his officers to decide if any and what accommodation is to be allowed:—

Vessels licensed to carry over 200 passengers—10s. per week.

Vessels licensed to carry 200 passengers or under—5s. per week.

44. The owners of all vessels shall pay as wharfage dues the sum of 9d. (ninepence) per ton, except where special licenses have been issued, on all cargo landed and shipped on any of the wharves and jetties of the Swan River; provided that any cargo landed or shipped from one part of the Swan River to any other shall pay wharfage dues one way only.

45. No person shall moor, fasten, or take any vessel or boat alongside any public bridge, jetty, pier, wharf,

landing-place or buoy in the Swan River, or cause or permit any vessel or boat to be so moored, fastened or taken, unless the owner of such vessel or boat shall have first obtained from the Chief Harbour Master permission in writing to make use of such public bridge, jetty, pier, wharf, landing-place, or buoy.

46. Any person guilty of a breach of the foregoing Regulation shall be liable, on conviction, to a penalty not exceeding £20.

WHEREAS by a Crown Lease under "The Land Act, 1898," registered in the books of the Office of Land Titles as Crown Lease No. 550/1912, Avon Location 11773 was granted to George Murray Wansbrough as Grazing Lease numbered 3340/68w, subject to the reservation to His Majesty the King, his heirs and successors, of the right to resume and enter upon possession of any part of the said lands which it might at any time be deemed necessary to resume for roads, tramways, railway stations, bridges, canals, towing paths, harbour or river improvement works, drainage or irrigation works, or quarries, and generally for any other works or purposes of public use, utility, or convenience, and such lands so resumed to hold to His Majesty, his heirs and successors, as of his or their former estate, without making to the said grantee any compensation in respect thereof, so that the lands so resumed should not exceed one-twentieth part in the whole of the land aforesaid, and that no such resumption should be made of any land upon which any buildings should be erected, or should be in use as gardens or otherwise for the more convenient occupation of any such building, without compensation: And whereas it is desirable to resume the land hereinafter described (being a portion of the land granted as aforesaid not exceeding one-twentieth thereof) for the purpose of "Public Convenience": Now know ye that I, the Governor of this State, by and with the advice and consent of the Executive Council, do hereby proclaim that, in exercise of the power contained in the said Crown Lease as aforesaid, the land described in the Schedule hereto, being a portion not exceeding one-twentieth of the whole of the land comprised in the said Crown Lease, was on the 13th day of June, 1917, resumed on behalf of His Majesty, for the purpose of Public Convenience.

WHEREAS by "The Transfer of Land Act, 1893, Amendment Act, 1896" (60 Vic., No. 22), the Governor is empowered, by Proclamation in the *Government Gazette*, to revest in His Majesty, as of his former estate, all or any lands whereof His Majesty may become the registered proprietor: And whereas His Majesty is now the registered proprietor of portions of Perth Sub. Lot 111 and Sub. Lot 18, Sub. Lot 61 and Sub. CECIL ANDREWS,
Director of Education.

Reg. 21 to read as follows:—

21. The efficiency of teachers will be judged on the basis of the reports of the Inspectors. The Inspectors will take into consideration ability and effectiveness in teaching, skill in the management of a school or a class, interest in work, and diligence and tact in the discharge of duties. Each grade of teachers will be divided into three groups by the Board of Classifiers, according to efficiency. The second and third groups will each have two subdivisions. A teacher who is placed in the second subdivision of the third group in two consecutive years will have his classification reduced.

The attainments of teachers will be judged on the basis of examinations, as prescribed in Regulations 15-19.

Reg. 22 to read as follows:—

22. A teacher may be promoted from one class to another when he has—

- (a) passed the prescribed examination;
- (b) been placed in the first group in the first grade of his class;
- (c) completed the period of service as prescribed in Regulation 24.

A teacher may be promoted to a higher grade in his class when he has—

- (a) been placed in the first group or in the first subdivision of the second group of his grade.

Teachers who have held the C1 Certificate for ten years with good reports, and have been placed in the first group of their grade, may be granted the B2 Classification without examination. They will not be able to rise to the B1 Grade until the examination has been completed.

Head Teachers who have held the B1 Certificate for fifteen years, and have consistently obtained exceptionally good reports, shall be eligible for two additional increments of £10 each.

Head Teachers who were Head Teachers with the B1 Certificate before the year 1902, and who sat for the A Certificate Examination before the year 1915 may, if they have consistently obtained exceptionally good reports, and have satisfied the Department of their ability to conduct efficiently a school containing Classes VII. and VIII., be granted the A3 Certificate without examination. They will not be eligible to rise to any higher grade until the examination has been completed.

Reg. 23 to read as follows:—

23. Teachers who have fulfilled the examination conditions prescribed in Regulation 19 (c) may be granted the C1 Certificate, provided that they have already served as teachers for at least two years and have been placed in the first group of their grade.

Except as provided above, no candidates who have passed the C Examination shall be granted a higher certificate than C2. Those who have fulfilled the examination conditions prescribed in Regulation 19 (c) and have been placed in the first group of their grade, may be raised to C1 after one year.

Reg. 28 to read as follows:—

28. Relative claims for promotion to vacant positions shall be determined by the Board of Classifiers. A promotion list shall be formed for each grade from the names included in the first group (*vide* Reg. 21). The Board will take into consideration in each case the efficiency marks recommended by the Inspectors, the teacher's literary or scientific qualifications, the length and nature of the teacher's service, and any other information that may be available. Such promotion lists shall be compiled in each year before 30th June, and shall govern the promotions for the next succeeding twelve months.

Reg. 29 to read as follows:—

29. No teacher shall have any claim to be placed on the list for promotion to the head-mastership of a large school until he has been in the service of the Department for six years.

WHEREAS by virtue of the powers conferred by the provisions of "The Roads Act, 1911," the Governor may, by Order in Council, divide any District into Wards and define the boundaries of and assign names to such Wards, increase the number of members for any Board, and determine the number of members for each Ward: And whereas it is desirable to divide the Perenjori-Morowa Road District into Wards with the boundaries, names, and the number of members to represent each Ward, and to increase the number of members of the Road Board as hereinafter set forth: Now, therefore, His Excellency the Governor, with the advice of the Executive Council doth hereby divide the Perenjori-Morowa Road District into Wards with the names and boundaries set forth and described in the schedule hereto, and doth increase the number of members of the said Perenjori-Morowa Road Board from seven to nine and determine that the number of members to represent each Ward shall be as set forth in the said Schedule.

Schedule.

North Ward.—Bounded on the North and East by part of the Northern boundary of the District from its North-West corner to its intersection with a South boundary of P.L. 273/97 at the 95m. 42ch. 77 links post. On the South by the South boundaries of said P.Ls. 273/97 and 1842/93 to the production South of the East boundary of Victoria Location 6298, and along said prolongation and East boundary to the centre of a surveyed road along its North boundary; thence along the centre of said surveyed road along the North boundaries of Locations 6298, 6297, 6296, and part of the North boundary of Location 6295, the South boundaries of Locations 6434, 6435, 6217, a West and a North boundary of Location 6225 and the North boundaries of Locations 6779, 6224, and 6223 to the West boundary of the District. On the West by part of the West boundary of the District from its intersection with the North boundary of Location 6223 to its North-West corner. (Three Members.)

Central Ward.—Bounded on the North by the South boundary of the North Ward. On the East by part of the District boundary from its intersection with the South boundary of the North Ward to its intersection with the South boundary of P.L. 2531/93. On the South by part of the South boundary of P.L. 2531/93 to its intersection with a rabbit-proof fence (abandoned) survey and along said fence to the 119 M.P.; thence to the North-East corner of Location 5696 and along its North and part of its West boundaries to its intersection with the prolongation East of the centre of a surveyed road along the South boundary of Location 5693; thence along said prolongation and road centre to opposite the South-West corner of said Location 5693 and along part of its West boundary and a North boundary of Location 6461; thence along the centre of a surveyed road along its West boundary and along the South-East, a South, a West, and again a South boundary of Location 6119 and the South boundary of Location 6762, a South, an East, and again a South and part of the West boundaries of Location 6240 to opposite the South-East corner of Location 6244; thence along the South boundary of said Location 6244, along the centre of a surveyed road, along part of East boundary of Location 6242, and along the latter's South boundary to the District boundary. On the West by the District boundary from its intersection with the South boundary of said Location 6242 to its intersection with the South boundary of the North Ward. (Three Members.)

South Ward.—Bounded on the North by the South boundary of the Central Ward and the North boundary of the District from its intersection with the said South

boundary of the Central Ward to the North-East corner of the District. On the East, South, and West by the East, South, and part of the West boundaries of the District. (Three Members.)

WHEREAS by an Order in Council in the *Government Gazette* of the 2nd day of June, 1916, page 1033, certain portions of the Williams Road District therein described were as from 1st day of July, 1916, transferred to the Wandering Road District in accordance with the provisions of "The Roads Act, 1911": And whereas it is desirable that an adjustment and settlement of the accounts of the said respective Boards of the said Districts be made and that the vesting order rendered necessary by reason of such transfer be issued as and in manner hereinafter appearing: Now, therefore, His Excellency the Governor by and with the advice and consent of the Executive Council doth hereby order that all arrears of General Rates and interest levied and charged by the Williams Road Board on the lands so transferred to the Wandering Road District as aforesaid at any time prior to the date of such transfer and due and unpaid on the 30th day of June, 1916, shall vest in and are hereby transferred to the Wandering Road Board and shall be recoverable by such Road Board accordingly (provided, however, that the Wandering Road Board shall refund to the Williams Road Board the sum of £3 1s. 6d. as recommended by Road Board Inspector Hawtin in his report on the adjustment of accounts between the said Boards dated the 22nd day of May, 1917, and the statements of accounts accompanying same and in accordance with the terms thereof).
