WHEREAS by "The Game Act, 1912-13," it is provided that the Governor may from time to time, by Proclamation, declare any one or more portions of the State, or any one or more localities to be respectively defined in such Proclamation, a Reserve for Native Game or any particular Native Game: Now therefore I, the said Governor, in exercise of the power aforesaid, do hereby, with the advice of the Executive Council, declare that the portion of the State and localities mentioned and

defined in the Schedule hereto shall be a Reserve for Native Game.

Alteration of Boundaries of Mt. Magnet Health District under the provisions of "The Health Act, 1911."

WHEREAS it is enacted by Section 19 of "The Health Act, 1911," that the Governor may alter the boundaries of any Health District constituted by the Governor under the said Act: And whereas it is desired to alter the boundaries of the Mt. Magnet Health District which was so constituted: Now, therefore, His Excellency the Governor of Western Australia, by and with the advice of the Executive Council, does hereby alter the boundaries of the said Health District in manner following, that is to say:—

Bounded on the North by the Northern boundary of Reserve 12876 (Lennonville Common) and its extension Eastward and Westward; on the West by a North and South line running parallel to the Western boundary of Reserve 12876 at a distance of two and a-half miles to the Westward thereof; on the South by an East and West line running parallel to the Southern boundary of Reserve 11342 (Mt. Magnet Common), and at a distance of two miles to the Southward thereof; and on the East by a North and South line running parallel to the Eastern boundary of Reserve 12876 and at a distance of two and a-half miles to the Eastward thereof.

HIS Excellency the Governor in Executive Council has approved of the following Regulations governing the admission of Cadet Draftsmen and Computers to the Office of Titles, Crown Law Department:—

REGULATIONS GOVERNING THE ADMISSION OF CADET DRAFTSMEN AND COMPUTERS, OFFICE OF TITLES, CROWN LAW DEPARTMENT.

Conditions.

1. An applicant for appointment must not be more than twenty nor less than sixteen years of age. He will be required to produce a medical certificate to the effect that he is of sound constitution, and not affected with any physical infirmity which would interfere with the proper exercise of his profession. He shall also produce satisfactory evidence as to character.

Qualifications.

2. An applicant shall produce evidence of having passed—

- (a) The Junior Certificate Examination of the University of Western Australia in English, Mathematics, and any other three subjects;
- (b) Such other examinations as shall in the opinion of the Inspector of Plans and Surveys be equivalent thereto.
- (c) He shall also submit a specimen of his plan drawing.

Competitive Examination.

3. Applications will be invited by the Public Service Commissioner by advertisement, and in the event of more applications being received than the number of vacancies, a competitive examination may be held by the Department in plotting, plan drawing, and trigonometrical computations, as a guide towards the selection of the most suitable candidates.

Probation.

4. Every Cadet shall, in the first instance, be appointed on probation for a period of six months. Before the expiration of the period of probation, the Permanent Head shall report to the Commissioner on the manner in which the probationer has performed his duties and upon his general conduct. Upon receipt of such report the Commissioner will confirm or annul the cadetship, or extend the period of probation for a further period not exceeding six months.

Remuneration.

5. The remuneration will be as follows:—

First year—£48.

Second year—£72.

Third year—£96.

Fourth year—£120.

Term of Service and Qualifying Examinations.

6. A Cadet who has passed the examination prescribed in Section 2 will be required to serve for a term of four years. During the first two years he will be instructed in drafting, plotting from field notes, and elementary computations.

7. When he has completed one-half of the prescribed term of service, if in the opinion of the Permanent Head of the Department his progress and general conduct have not been satisfactory, his services may be dispensed with, on the approval of the Public Service Commissioner.

8. On the completion of his term of service he will be required to present himself at a qualifying examination, which shall embrace the following subjects:—

- (a) *Drawing*: Plan drawing; enlarging and reducing; use of scales and protractors; plotting by co-ordinates; plotting from surveyor's field books; stump writing and printing; colouring; drawing for reproduction.
- (b) *Computing*: Examination of surveyor's diagrams and original plans and adjustment of discrepancies in surveys; computation of co-ordinates and areas of rectilinear figures and of figures bounded by circular arcs; computations of observations for azimuth, latitude, and time.
- (c) Use of planimeter and calculating machine.

9. All Cadets will be examined in their knowledge of the Land Act, Land Transfer Act, Roads Act, Public Works Act, and Regulations thereunder, so far as they affect the work of the Professional Branch of the Office of Titles, in addition to the General Regulations for the guidance of Surveyors, under "The Licensed Surveyors Act, 1909," and the Departmental Rules and Directions. Examinations prescribed in Section 8 shall be conducted by a Board appointed by the Public Service Commissioner.

10. When Cadets cannot obtain the necessary instruction at the evening classes of the University of Western Australia, the Technical School, or other approved institution, they will be allowed such leave of absence as may be necessary to attend the day lectures in approved subjects, but such leave of absence during working hours shall be without pay, unless the Department can conveniently arrange for the Cadet to make up the time.

11. Should a Cadet fail to pass in the qualifying examination his term of service may, on the recommendation of the Commissioner, be extended for a further period not exceeding two years, at the same remuneration as that received for his fourth year of service.

Permanent Appointment.

12. A Cadet who has satisfactorily completed his cadetship and obtained his certificate of qualification shall (should he be so required) serve in the Public Service of the State for a period of three years, at a salary in accordance with the Public Service Commissioner's classification of the work upon which he is engaged, but at not less than at the rate of £204 per annum.

13. If the Cadet is under 21 years of age when he obtains his certificate of qualification, the Commissioner may extend his cadetship, and fix the salary to be paid until he reaches that age.

Public Service Act and Regulations.

14. During the whole term of his cadetship and any extension thereto, a Cadet shall be subject to the Public Service Act and Regulations relating to the permanent staff, as far as applicable. His service qualifying him for long service leave, however, will not count until after the completion of his cadetship.

Bond.

15. An agreement and bond, with approved sureties, in a form to be prescribed, to be executed for the due performance of all the terms herein specified.
