The Game Act, 1912-13. Reserves for Native Game. PROCLAMATION

WHEREAS by Section 6 of "The Game Act, 1912-13," it is provided that the Governor may from time to time, It is provided that the Governor may from time to time, by Proclamation, declare any one or more portions of the State or any one or more localities to be respectively defined in such Proclamation a reserve for native game or any particular native game: And whereas by a Pro-clamation dated the 19th day of July, 1916, *inter alia*, certain portions of the State and localities mentioned and defined in programs 2 and 3 of the Schedule to such defined in paragraphs 2 and 3 of the Schedule to such Proclamation were declared Reserves for Native Game: And whereas it is desirable that paragraphs 2 and 3 of the said Schedule be revoked: Now therefore I, the said Governor, by and with the advice and consent of the Executive Council, do hereby, in exercise of the powers aforesaid and of every power enabling me in this behalf, revoke paragraphs 2 and 3 of the Schedule to the said Proclamation, and proclaim and declare as follows:-

That those portions of the State and localities mentioned and defined in the Schedule hereto shall be a Reserve for Native Game.

Schedule.

The whole of the waters of the Channel Entrance to Peel's Inlet and all that portion of the said Inlet North of lines extending respectively in a South-Easterly direc-tion from the South-Eastern corner of Murray Location No. 5 to a beacon known as the "Big Stick," and in an East-South-Easterly direction from the "Big Stick" to the Southernmost point of Goongoolup, and including the whole of Channel and Greery Islands.

WHEREAS by the provisions of "The Cemeteries Act, 1897," and amendments, it is made lawful (in case it should appear to the Governor that burials in any Cemetery under any law relating to public connections or other burial ground or place of burial whatsoever should be wholly discontinued or should be discontinued subject to any exception or qualification) for the Governor, by Order to be published in the Government Gazette, direct that after a time to be mentioned in such Order (not being less than three months from the date thereof), burials in any cemetery or burial place, ground, or place of burial shall be discontinued wholly or subject to any exception or qualifications mentioned in the same or in any subsequent Order: And whereas by an Order in Council dated the 16th day of February, 1916, and published in the *Government Gazette* on the 18th day of February, 1916, His Excellency the Governor directed vithin the limits of the Public Cemeteries and Burial Grounds, East Perth, should be wholly discontinued: And whereas by Section 7 of "The Cemeteries Act, 1897," it is further provided that the Governor may from time to time vary any such Order: And whereas it is desirable to vary the Order above-mentioned, as hereinafter provided: Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Conneil, doth hereby direct that the said Order be varied by inserting the following words after the word "Perth," in the 15th line of the said Order and at the end of the said Order:

WHEREAS by Section 267 of "The Health Act, 1911-15," it is provided that the Governor may cause to be prepared Model By-laws for all or any of the purposes for which By-laws may be made by a Local Authority under the provisions of the said Act, and that a Local Authority may of its own motion by resolution adopt the whole or any portion of such By-laws; and whereas Model By-laws have been prepared in accordance with the provisions of the said section and published in the foverment Gazette on the 20th day of November, 1914: Now, therefore, it is resolved and determined by the Broome Road Board, being a Local Health Authority within the meaning of the said Act, that with the ex-ceptions specified thereunder such Model By-laws be adopted for the Broome Health District.

Interpretation Clauses.—Part I., By-laws 16, 22, 26 (d), 34, 39 (d), 42, 52 (a); Schedule "A," By-law 25 (a); Part III., Schedules "A" and "C"; Part

Interpretation.

In these By-laws the terms specified hereunder shak bear the meaning defined, unless the context indicates otherwise:

"Act" means "The Health Act, 1911-15."

"Approved" shall mean approved by the Medical Officer of Health, or by an Inspector.

"District" shall mean the Health District under the jurisdiction of the Local Health Authority.

PART I.

By-law 16.--The emptying and removal of such recep-tacles shall be conducted by the Local Authority only.

By-law 25 (a).—The occupier of any premises from which any sanitary service is effected shall pay to the Local Authority the charges specified in Schedule "A" hereto.

By-law 26 (d) .- The provisions of this By-law shall not apply to persons engaged in the removal of refuse as provided by By-law 16, nor to the collection, removal, and disposal of nightsoil, urine, and refuse and other offensive material by the Local Authority.

By-law 34.-No person shall keep swine within the Broome Ward of the Road District.

By-law 35 (j).—Subsections (e) and (f) shall be compulsory only in cases where required by the Local Authority.

By-law 39 (d).—The underside of any part of the lowest wooden floor of any such building shall be not less than thirty inches above the surface of the land.

Certain space to be allowed in sleeping rooms. By-law 42.---No sleeping room in any dwelling-house shall be occupied by such a number of inmates that for every inmate over the age of ten years there is less than three hundred cubic feet of air space, and for every inmate under the age of ten years there is less than three hundred cubic feet of air space, and the occupier of every such dwelling-house shall be responsible for any breach of this By-law.

By-law 52 (a).—The occupier of any premises, the water supply of which is drawn or partly drawn from tanks, shall maintain the roof forming the catchment for such tanks, together with the spouting and down pipes appurtenant to such roof in a clean condition, and shall at least once in each year, during the months of October, November, December, or January, thoroughly clean any tank the water from which is used for human consumption.
