FLOUR.

Perth, 14th December, 1921.

IT is hereby notified, for public information, that His Excellency the Governor in Executive Council has this day been pleased to revoke, as from the 15th day of December, 1921, the Order in Council dated the 3rd day of August, 1921, published in the *Government Gazette* of the 5th August, 1921, relating to flour; and to approve of the following Order in Council reducing the maximum wholesale and retail prices of this foodstuff.

The Prices Regulation Act, 1919/20.

Determination of Prices.

ORDER IN COUNCIL.

WHEREAS under the provisions of "The Prices Regulation Act, 1919," as amended by "The Prices Regulation Act Amendment and Continuance Act, 1920," the Governor may, on the recommendation of the Commissioners, by Order in Council, determine the maximum prices, whether retail or wholesale, which may be charged for foodstuffs and necessary commodities in any proclaimed area; and without affecting the generality of the powers conferred may determine such prices on the basis of producing, manufacturing, landed delivery, or other cost, and may declare what items may or may not be included in such cost: Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council and on the recommendation of the Commissioners, doth hereby determine that the prices of the foodstuff mentioned in the Schedule hereto shall be the maximum prices that may be charged for such foodstuff in the areas set out in paragraphs 1 and 2 of the Schedule, and as provided in paragraph 3 of the said Schedule in all other proclaimed areas.

The Schedule.

The maximum prices at which flour may be sold or supplied, and which said prices shall include the containers in which the said flour is sold or supplied, shall be as follows:—

1. Within the Metropolitan and Bunbury Areas:
 - (a.) Wholesale—delivery at mill door or on rail at mill siding—
 - In sacks of 150 lbs.—£11 15s. per ton of 2,000 lbs.
 - In bags of 50 lbs.—£13 2s. 6d. per ton of 2,000 lbs.
 - In bags of 25 lbs.—£14 5s. per ton of 2,000 lbs.
 - (5s. per ton may be added to these prices when booked for more than seven days.)
 - (b.) Wholesale—except as above—
 - In sacks of 150 lbs.—at the rate of £12 6s. 9d. per ton of 2,000 lbs., or 18s. 9d. per sack.
 - In bags of 50 lbs.—at the rate of £13 15s. 9d. per ton of 2,000 lbs., or 7s. per bag.
 - In bags of 25 lbs.—at the rate of £15 per ton of 2,000 lbs., or 3s. 9d. per bag.
 - (c.) Retail—
 - In sacks of 150 lbs.—£1 1s. 9d.
 - In bags of 50 lbs.—8s. 3d.
 - In bags of 25 lbs.—4s. 4d.
 - Loose, per dozen pounds, 2s. 3s. Less than one dozen pounds, at the rate of 2½d. per lb.
 - (If booked for more than seven days, the following charges may be added:—
 - 10d. per sack of 150 lbs.
 - 5d. per bag of 50 lbs.
 - 3d. per bag of 25 lbs.)
2. Within the Kellerberrin, Northam, York, Brookton, Pingelly, Narrogin, Wagin, and Katanning Areas:
 - (a.) Wholesale—delivery at mill door or on rail at mill siding—
 - In sacks of 150 lbs.—£11 7s. 6d. per ton of 2,000 lbs.
 - In bags of 50 lbs.—£12 15s. per ton of 2,000 lbs.
 - In bags of 25 lbs.—£13 17s. 6d. per ton of 2,000 lbs.
 - (5s. per ton may be added to these prices when booked for more than seven days.)
 - (b.) Wholesale—except as above—
 - In sacks of 150 lbs.—at the rate of £11 19s. per ton of 2,000 lbs., or 18s. per sack.
 - In bags of 50 lbs.—at the rate of £13 7s. 9d. per ton of 2,000 lbs., or 6s. 9d. per bag.
 - In bags of 25 lbs.—at the rate of £14 11s. 6d. per ton of 2,000 lbs., or 3s. 8d. per bag.

(c.) Retail—

In sacks of 150 lbs.—£1 0s. 9d.

In bags of 50 lbs.—7s. 10d.

In bags of 25 lbs.—4s. 3d.

Loose, per dozen pounds, 2s. 3d. Less than one dozen pounds, at the rate of 2½d. per lb.

(If booked for more than seven days, the following charges may be added:—

10d. per sack of 150 lbs.

5d. per bag of 50 lbs.

3d. per bag of 25 lbs.)

3. The above-mentioned wholesale and retail prices for flour have been fixed with due regard to the cost of transport within the areas set out in paragraphs 1 and 2; within other proclaimed areas, the equivalent of any additional cost actually incurred in transportation beyond the areas set out in paragraphs 1 and 2 above may be added to the above-mentioned prices.

This Order in Council shall take effect as from the 15th day of December, 1921.

First Schedule.

The maximum prices at which Bran and Pollard, the produce of mills in Western Australia, may be sold or supplied shall be as follows:—

1. (a) Wholesale—delivery at mill door or on rail at mill siding—

(1.) In lots of half-a-ton or over—£7 per ton of 2,000lbs. (2s. 6d. per ton may be added to this price when booked for more than seven days.)

(2.) In lots of less than half-a-ton, direct to consumers, not being wholesalers or retailers for the purpose of resale—1s. 7d. per bushel.

(b) Wholesale—except as above—

(1.) In lots of half-a-ton or over shall be £7 17s. 6d. per ton of 2,000lbs., delivery free at wholesaler's store. (2s. 6d. per ton may be added to this price when booked for more than seven days.)

(2.) In lots of less than half-a-ton, 1s. 8d. per bushel.

(c) By retailers, if in lots of one bag or more, 2s. per bushel; lesser quantities, 2s. 2d. per bushel (delivery free at retailer's shop).

(d) Within all proclaimed areas other than those mentioned in the Second Schedule hereto, the equivalent of any additional cost actually incurred in transportation of bran and pollard beyond the said areas specified in the Second Schedule may be added to the above-mentioned prices.

The maximum prices at which Flour, Bran, and Pollard may be sold or supplied within the Geraldton Area, and which said prices shall include the containers in which the said Flour, Bran and Pollard are sold or supplied, shall be as follows:—

1. Flour:

(a) Wholesale—delivery at mill door or on rail at mill siding—

In sacks of 150 lbs.—£11 15s. per ton of 2,000 lbs.

In bags of 50 lbs.—£13 2s. 6d. per ton of 2,000 lbs.

In bags of 25 lbs.—£14 5s. per ton of 2,000 lbs.

(5s. per ton may be added to these prices when booked for more than seven days.)

- (b) Wholesale, except as above—
 In sacks of 150 lbs.—at the rate of £12 6s. 9d. per ton of 2,000 lbs., or 18s. 9d. per sack.
 In bags of 50 lbs.—at the rate of £13 15s. 9d. per ton of 2,000 lbs., or 7s. per bag.
 In bags of 25 lbs.—at the rate of £15 per ton of 2,000 lbs., or 3s. 9d. per bag.
- (c) Retail—
 In sacks of 150 lbs.—£1 1s. 9d.
 In bags of 50 lbs.—8s. 3d.
 In bags of 25 lbs.—4s. 4d.
 Loose, per dozen pounds—2s. 3d. Less than one dozen pounds—at the rate of 2½d. per lb.
 (If booked for more than seven days, the following charges may be added:—
 10d. per sack of 150 lbs.
 5d. per bag of 50 lbs.
 3d. per bag of 25 lbs.)
2. Bran and Pollard:
- (a) Wholesale—delivery at mill door or on rail at mill siding—
1. At the rate of £8 per ton of 2,000 lbs. (2s. 6d. per ton may be added to this price when booked for more than seven days.)
 2. In lots of less than half a ton, direct to consumers not being wholesalers or retailers, for the purpose of re-sale—1s. 9d. per bushel.
- (b) Wholesale, except as above—
 At the rate of £8 15s. per ton of 2,000 lbs., delivery free in Geraldton. (2s. 6d. per ton may be added to this price when booked for more than seven days.)
- (c) By retailers, if in lots of one bag or more—2s. 1d. per bushel; or quantities of less than one bag—2s. 3d. per bushel (delivery free in Geraldton).
