HIS Excellency the Administrator has been pleased to approve, under Section 43 of "The Land Act, 1898," of the By-laws of the Laverton and Beria Commons (Reserves 6882 and 6884) being amended as set out hereunder:—

By-law No. 4 amended to read as follows:—The scale of charges to be as follows:—

Horses, cattle, mules, and asses—7s. 6d. per head per annum; Dairy cows—5s. per head per annum; Camels—30s. per head per annum; Sheep and goats—1s. 6d. per head per annum;

each ratepayer to the Board being allowed the following exemptions: 3 head of great stock or 6 goats free of charge, but such stock shall be duly registered at the office of the Board. No license granted to any butcher shall allow of the depasturing of more than 150 sheep or 15 head of cattle, and any license granted to dairymen shall not allow of the depasturing of more than 15 head for dairying purposes.

By-law No. 5 amended to read as follows:—No license shall be granted to any person except *bona fide* butchers and dairymen to depasture on the commons at any one time more than 6 head of horses, cattle, mules, asses, goats, or camels, except by special permission of the Road Board.

By-law No. 16 to read as follows:—Every licensee under these By-laws shall produce his license upon being requested to do so by any member or officer of the Road Board or any policeman.

And to approve of the following additional By-law:—

No. 5a. Stock under the age of one year shall be exempt from tax if running with the mother.

No. 5b. No stock on which commonage fees are due shall be removed from the common unless with the written sanction of the Secretary, until such fees have been paid in full.

No. 6a. No stock shall be mustered on the commons without the written permission of the Secretary of the Road Board or Commonage Ranger, and no person or persons shall brand stock running or depasturing on the Commons, unless in the presence of the Secretary or Ranger.

No. 4114.
