*The Metropolitan Water Supply, Sewerage, and Drainage Act, 1909.*

### ORDER IN COUNCIL.

M.W.S. 596/22.

WHEREAS by "The Metropolitan Water Supply, Sewerage, and Drainage Act, 1909," it is provided that, subject to the provisions of the Act, the Minister of Water Supply, Sewerage, and Drainage shall, with the approval of the Governor, have power to construct and extend Water Works, Sewerage Works, and Storm-water Drainage Works; and whereas the preliminary requirements of the said Act have been complied with, and plans, sections, and estimates in respect of the works hereinafter mentioned have been submitted to and approved by the Governor in Council: Now, therefore, His Excellency the Governor, with the advice and consent of the Executive Council, does hereby empower the Minister of Water Supply, Sewerage, and Drainage to undertake the construction of the following works under the said Act, namely:—

*Leederville Stormwater Drainage and Sewerage.*

Proposed Stormwater Drain from McCourt Street to Monger's Lake, conjointly with proposed Sewer from

McCourt Street to Location 118, as shown on Plan M.W.S., S., & D.D., W.A., No. 4125.

This Order in Council shall take effect from the sixteenth day of March, 1923.

ORDER IN COUNCIL.

M.W.S. 148/23.

WHEREAS by "The Metropolitan Water Supply, Sewerage, and Drainage Act, 1909," it is provided that, subject to the provisions of the Act, the Minister of Water Supply, Sewerage, and Drainage shall, with the approval of the Governor, have power to construct and extend Water Works, Sewerage Works, and Storm-water Drainage Works; and whereas it is further provided that the Governor may exempt reticulation works from certain sections of this Act: Now, therefore, His Excellency the Governor, with the advice of the Executive Council, hereby approves of the construction and extension by the Minister of Water Supply, Sewerage, and Drainage of the following works under the said Act, and does hereby exempt such works from the operations of Sections 20, 21, 22, and 23 of the said Act:—

*Description and Location of Reticulation Works  
Approved and Exempted.*

*Perth Road Board.  
Maylands Ward.*

*Water Supply Improvements.*

(a) 6-inch diameter cast-iron water main along North Street from Lawley Crescent North-Easterly to Second Avenue (length about 20½ chains).

(b) 3-inch diameter cast-iron water main along First Avenue from North Street South-Easterly to the existing main at Lot 247 (length about 2 chains).

(c) 4-inch diameter cast-iron water main along Second Avenue from North Street South-Easterly to Robinson Street (length about 12 chains); including lifting the existing 1-inch diameter galvanised iron water main.

Mains to be provided with valves, hydrants, and all necessary apparatus.

The whole of the above works is as indicated in red on Plan M.W.S., S., & D.D., W.A., No. 4144.

WHEREAS it is provided by "The Road Districts Act, 1919," that a Road Board shall consist of such number of members not less than five nor more than thirteen as the Governor from time to time declare by Order in Council, and that if a district is divided into wards the Governor shall from time to time determine the number of members for each ward, and further that on a change being made in the number of members of a board the Governor may declare and direct whether a new election

of members shall be held for the district or any ward thereof, and when such election shall be held, and may order, settle, adjust, and finally determine any questions and matters regarding the representation of electors on the board and the constitution of the board which he may consider necessary to be ordered, settled, adjusted, or determined: And whereas it is desirable to increase the number of the members of the Ashburton Road Board to nine, by adding one to the number of members for the East Ward and also for the West Ward: Now, therefore, His Excellency the Governor, acting with the advice and consent of the Executive Council, doth hereby, in exercise of the hereinbefore recited powers and of all other powers him in this behalf enabling, order, direct, and declare as follows:—

1. The number of members of the Ashburton Road Board is hereby increased to nine.
2. The number of members for the East Ward and also for the West Ward of the Ashburton Road District is increased to three.
3. An election of an additional member for each of the wards aforesaid shall be held on the fourteenth day of April, 1923.
4. Such election shall be conducted as a separate election, the nominations therefor shall be distinct from those for any ordinary periodical election to be held on that day, and separate ballot papers shall be provided therefor.

## FREMANTLE HARBOUR TRUST.

HIS Excellency the Governor in Council has been pleased to approve of the following amendment to Regulations 52 and 56 of the Fremantle Harbour Trust Regulations, dealing with signals to be made ashore and on vessels in port, as made by the Fremantle Harbour Trust Commissioners on the 9th March, 1923.

*Amendment of Regulations.*

The Regulations made by the Fremantle Harbour Trust Commissioners are hereby amended as follows, viz.:—

1. By adding to Regulation No. 52 the following clause:—

3. International Code flag "A" will be the signal for a vessel to come into the Inner Harbour.

2. By repealing Regulation No. 56 and enacting the following new regulation in lieu thereof, viz.:—

*Signals on Vessels.*

No. 56.

The following signals are to be used on vessels in the port when requisite, viz.:—

*Sea Pilot.*—The following signals used or displayed together or separately—

*In daylight:*

1. To be hoisted at the fore masthead, the Union Jack or other National Colour having round it a white border one-fifth of the breadth of the flag;
2. The International Code Pilotage Signal indicated by "P.T.;"
3. The International Code Flag "S" with or without the code pennant over it;
4. The distant signal, consisting of a cone point upwards, having above it two balls or shapes resembling balls.

*At Night:*

1. The pyrotechnic light commonly known as a blue light shown every fifteen minutes;
2. A bright white light flashed or shown at short or frequent intervals just above the bulwarks for about a minute at a time.

*Note.*—Pilots at the Port of Fremantle leave the Inner Harbour when vessels are sighted by Rottnest Island Signal Station and proceed at once to the Pilots' Boarding Ground six miles East of Bathurst Point Light, and all vessels subject to pilotage must make for the Boarding Ground, and there wait till picked up by pilot, taking care to keep well clear of the shoals off the Island.

*Quarantine.*—The sea Quarantine Regulations are made by the Commonwealth Government of Australia under the Quarantine Act, 1908-15. The signals are:—

(1) In daylight:

- (a) By oversea vessels requiring pratique, Commercial Code Flag "Q" (being a yellow flag of six breadths of bunting) hoisted at the mainmast head.
- (b) By vessels having or suspected of having a quarantinable disease on board or actually performing quarantine, Commercial Code Flag "L" (being a large flag of yellow and black borne quarterly) hoisted at the mainmast head.

(2) At night:

Three lights (two red and one white, each being not less than eight inches in diameter) of such a character as to be visible on a clear night all round the horizon for a distance of two miles and placed as nearly as practicable amidships at distances of six feet apart in the form of an equilateral triangle with the apex (the white light) above.

*Note.*—The Quarantine Act prescribes heavy penalties against the shipmaster who fails to display these signals within three miles of a port or while entering or within a port, and keeping them displayed until authorised by a quarantine officer to take them in. No boats other than those containing port officials or quarantine officers may be allowed in close vicinity of a ship awaiting pratique or performing quarantine, under heavy penalties.

*Harbour Pilot.*—International Code Flag "S" at foremast head.

*Customs Officer Wanted.*—International Code Flags "K.G.W." at peak or other prominent place.

*Medical Assistance Wanted Immediately.*—International Code Flags "YL" at peak or other prominent place.

*Police (Water, River, or Harbour) Wanted—*

- (a) In daylight:  
International Code Flags "Y.V.X." at mainmast head.
- (b) At night:

Two white lights shown vertically five feet apart from peak or other prominent place.

*Tug Boat Wanted.*—(1) In daylight—(a) International Code Flags "Y.P." (if more than one wanted indicate number by International Code Flags); or (b) Two blasts on whistle, one prolonged and one short.

(2) At night—Two blasts on whistle, one prolonged and one short.

*Water Boat or Waterman Wanted.*—International Code Flags "G.U.J." at mainmast head or other prominent position.

*Ash Boat Wanted.*—International Code Flag "M" at mainmast head or other prominent position.

*Lighter Wanted.*—International Code Flags "Y.M." at mainmast head or other prominent position. (If more than one wanted indicate number by International Code.)

*Mails on Board.*—International Code Flags "R.E.W." at mainmast head or other prominent position.

*Explosives or Inflammable Cargo on Board.*—(a) In daylight—International Code Flag "B" at foremast head or other prominent position.

(b) At night—A red light of such a character as to be visible all round the horizon for a distance of one mile, shown from a prominent position clear of all other lights on the vessel.

*Boarding Officer Wanted.*—International Code Flags "S.P.I." at mainmast head or other prominent position.

*Sound Signals.*

Steamers or other vessels fitted with sound whistles, sirens or horns are not permitted to use these in the Inner Harbour except for navigational or manœuvring purposes, as set out in these regulations.

*Steering Sound Signals Day or Night.*—When vessels are in sight of one another, a steam vessel under way, in taking any course authorised by the steering and sailing rules for preventing collisions embodied in regulations made under "The Merchant Shipping Act, 1894," shall indicate that course by the following signals on her whistle, siren, or horn, viz.:—

- (a) One short blast to mean, "I am directing my course to starboard."
- (b) Two short blasts to mean, "I am directing my course to port."
- (c) Three short blasts to mean, "My engines are going full speed astern."
- (d) Four short blasts to mean, "My ship is out of control, keep clear."

## SIGNALS ON VESSELS.

No. 6.

The following signals are to be used, when requisite, at the Ports of Western Australia:—

*Pilot Required.*—The following signals used or displayed together or separately:—

In daylight:

1. To be hoisted at the foremast head the Union Jack or other National colour having round it a white border one-fifth of the breadth of the flag.
2. The International Code Pilotage Signal indicated by "P.T."
3. The International Code Flag "S," with or without the code pennant over it.
4. The distant signal, consisting of a cone point upwards, having above it two balls or shapes resembling balls.

At night:

1. The pyrotechnic light commonly known as a blue light shown every fifteen minutes.
2. A bright white light flashed or shown at short or frequent intervals just above the bulwarks, for about a minute at a time.

*Quarantine.*—The sea quarantine regulations are made by the Commonwealth Government of Australia under the Quarantine Act, 1908-15. The signals are:—

1. In daylight:
  - (a) By oversea vessels requiring pratique, Commercial Code Flag "Q" (being a yellow flag of six breadths of bunting) hoisted at the mainmast head.
  - (b) By vessels having or suspected of having a quarantinable disease on board, or actually performing quarantine, Commercial Code Flag "L," being a large flag of yellow and black borne quarterly hoisted at the mainmast head.

2. At night:

Three lights (two red and one white, each being not less than eight inches in diameter) of such a character as to be visible on a clear night all round the horizon for a distance of two miles, and placed as nearly as practicable amidships at distances of six feet apart in the form of an equilateral triangle with the apex (the white light) above.

Note.—The Quarantine Act prescribes heavy penalties against the shipmaster who fails to display these signals within three miles of a port, or while entering or within a port, and keeping them displayed until authorised by a Quarantine Officer to take them in. No boats other than those containing port officials, or Quarantine Officers, may be allowed in close vicinity of a ship awaiting pratique, or performing quarantine, under heavy penalties.

*Customs Officer Wanted.*—International Code Flags "K.G.W." at peak, or other prominent place.

*Medical Assistance Wanted Immediately.*—International Code Flags "Y.L." at peak, or other prominent place.

*Police (Water, River, or Harbour) Wanted:*

- (a) In daylight.—International Code Flags "Y.V.X." at mainmast head.
- (b) At night.—Two white lights shown vertically five feet apart from peak, or other prominent place.

*Mails on Board.*—International Code Flags "R.E.W." at mainmast head, or other prominent position.

*Explosives or Inflammable Cargo on Board:*

- (a) In daylight.—International Code Flag "B" at foremast head, or other prominent position.
- (b) At night.—A red light of such a character as to be visible all round the horizon for a distance of one mile, shown from a prominent position clear of all other lights on the vessel.

*Sound Signals.*

Steamers or other vessels fitted with sound whistles or horns are not permitted to use those in the Inner Harbour except for navigational or manœuvring purposes, as set out in these regulations.

*Steering Sound Signals, Day or Night.*

When vessels are in sight of one another, a steam vessel under way, in taking any course authorised by the steering and sailing rules for preventing collisions, embodied in regulations made under "The Merchant Shipping Act, 1894," shall indicate that course by the following signals on her whistle or siren, viz.:—

- (a) One short blast to mean "I am directing my course to starboard."
- (b) Two short blasts to mean "I am directing my course to port."
- (c) Three short blasts to mean "My engines are going full speed astern."
- (d) Four short blasts to mean "My ship is out of control; keep clear."

HIS Excellency the Governor in Executive Council has been pleased, under the provisions of "The Forests Act, 1918," and on the recommendation of the Conservator of Forests, to approve of the following amendments to the "Forest Regulations, 1920":—

Regulation 48 is amended by the addition of the following words after the word "regulation," in the reading of the last line: "provided, however, that this regulation shall not apply to that portion of the State North of the twenty-sixth parallel of South latitude."

Regulation 50 is amended by the addition of the following words after the word "man," in the reading of the last line: "provided that the issue of licenses for obtaining sandalwood on Crown lands within that portion of the State North of the twenty-sixth parallel of South latitude shall be dealt with in accordance with the provisions of Regulations 51b and 52a."

Regulation 52 is amended by inserting after the word "sandalwood" in the first line, the words "from Crown Lands within the State South of the twenty-sixth parallel of South latitude."

Regulation 53 is amended by the addition of the following words after the word "license," in the reading of the last line: "This regulation shall not apply to that portion of the State North of the twenty-sixth parallel of South latitude."

Regulations are inserted after Regulation 51, and shall have effect, as follows:—

51a. The cutting, pulling, or removal of sandalwood from Crown Lands within the State North of the twenty-sixth parallel of South latitude, except for oil distillation purposes within the State, is hereby prohibited.

51b. Licenses for obtaining sandalwood from Crown Lands North of the twenty-sixth parallel of South latitude shall be in the Form 9a in the First Schedule. No fee shall be payable for such license, but the license shall be issued subject to the payment by the licensee of a royalty of five shillings per ton cleaned, for all sandalwood obtained thereunder.

A regulation is inserted after Regulation 52, and shall have effect as follows:—

52a. Licenses under Regulation 51b shall be issued only on the production by the applicant of a genuine order for sandalwood for oil distillation purposes within the State, and the applicant shall, before receiving such license, be required to deposit with the Department the sum equal to twenty-five per centum of the royalty which would be payable upon the whole of the sandalwood ordered.

The minimum deposit shall be five shillings. The balance of the royalty payable shall be paid to the Department before the sandalwood is loaded into railway or tramway wagons or on board ship.

Upon issue of a license, the issuer shall endorse, across the face of the order produced, particulars of the license issued and his signature. Each license shall be limited to the quantity of sandalwood specified in the order produced at the time of issue and shall be current for six months, but may be extended by endorsement by an authorised issuer of licenses in that portion of the State referred to in Regulation 51b, provided the order referred to therein has not been fully supplied.

*Concessions.*

68a.—No person, being the holder of a timber concession granted and held subject to the regulations in force for the time being, whereby the powers thereby conferred may be regulated, shall cut any tree that is not a mature tree: Provided that a forester may mark and allow to be felled defective and crooked trees although not mature, and such other immature trees as in the opinion of the forester may be properly felled with due regard to the conservation of the forest.

68b. No jarrah tree of less than 90 inches in circumference, measured at 4 feet 3 inches from the ground, and no karri tree of less than 108 inches in circumference, measured at 4 feet 3 inches from the ground, shall be deemed a mature tree.

68c. Poles and piles and forest produce other than timber shall not be cut or removed by the holder of a timber concession except by the authority of a permit issued under and subject to these regulations.

I find on the evidence, on the advice of the Assessors, that the s.s. "Eucla," owned by the Western Australian Government, while on a voyage from Fremantle to Flinders Bay on February 10, 1923, struck a submerged rock in the vicinity of the South-West Breaker, doing serious damage to the hull.

I am of opinion that the master should have exercised more care to ascertain the error of his compass, and that the vessel was further to the North than the position given by him.

I suggest that better charts and appliances should be supplied for the use of this steamer.
