The Metropolitan Water Supply, Sewerage, and Drainage Act, 1909.

ORDER IN COUNCIL.

M.W.S. 80/23.

WHEREAS by "The Metropolitan Water Supply, Sewerage, and Drainage Act, 1909," it is provided that, subject to the provisions of the Act, the Minister of Water Supply, Sewerage, and Drainage shall, with the approval of the Governor, have power to construct and extend water works, sewerage works, and stormwater drainage works: And whereas the preliminary requirements of the said Act have been complied with, and plans, sections, and estimates in respect of the work hereinafter mentioned have been submitted to and approved by the Governor in Council: Now, therefore, His Excellency the Governor, with the advice and consent of the Executive Council, does hereby empower the Minister of Water Supply, Sewerage, and Drainage to undertake the construction of the following works under the said Act, namely:—

Metropolitan Sewerage.

Area 33—Perth District.

Main sewer construction of 12-inch reinforced concrete pipes, and reticulation sewers constructed of 6-inch and 4-inch stoneware pipes, with all manholes, inspection shafts, and other apparatus connected therewith, as shown on Plan M.W.S., S., & D.D. No. 4201.

ORDER IN COUNCIL.

WHEREAS there is reason to believe that the introduction or importation of cattle into Western Australia from the States of New South Wales, Victoria, South Australia, and Queensland would cause the disease of pleuro-pneumonia to extend to the State of Western Australia, and it is desirable that steps should be taken for its prevention: Now, therefore, His Excellency the Governor, by and with the consent of the Executive Council, doth hereby prohibit, for a period of twelve months from the date of this Order, the introduction or importation into Western Australia from the States of New South Wales, Victoria, South Australia, and Queensland of any cattle except stud stock accompanied by a certificate from the Chief Veterinary Officer of the State that such stud stock are from clean herds and have not been in contact with diseased stock for a period of at least six months.

All lifts over 3 tons weight occurring during the course of ordinary continuous work in discharging or loading a vessel will be charged as "special lifts," and the time occupied in dealing with same will be deducted from the time of continuous work.
