3. Who was responsible for the publication in the newspapers of frequent reports of the discovery of high values in the leases held by the Empire Syndicate, which values it was afterwards shown never existed.

*Balingup Road Board.*

*Compilation of Fresh Rolls.*

P.W. 1436/23.

WHEREAS it is provided by Section 56 of "The Road Districts Act, 1919," that whenever it is proved to the satisfaction of the Minister that any roll has not been duly and regularly prepared, revised, or completed in accordance with Division 6 of Part III. of the said Act, he may, by order in writing published in the *Gazette*, direct the compilation of a fresh roll, and may order that such fresh list and roll be prepared, revised, and completed in such manner and according to such rules as he shall prescribe: And whereas I, the Minister administering the said Act, am satisfied that the rolls of the wards of the Balingup Road District have not been prepared, revised, or completed in accordance with the relative provisions of the said Act: Now, therefore, I do hereby direct the compilation of a fresh roll for each ward of the said district; and I do order that each such roll and the list on which the same shall be based shall be prepared, revised, and completed in manner set out in Sections 38 to 50 (both inclusive) of the said Act, subject to such modifications as are contained in the rules following, that is to say:—

*Rules applicable to Compilation of Lists and Roll.*

- The powers and functions of the Board and of the Chairman thereof, under the said sections, shall be exercised and discharged by the Commissioner of the said District (Albert Ernest Sanderson).
- The list of owners shall be made out on the first day of December, 1923.
- Applications under Section 39 shall be delivered on or before the 8th day of December, 1923.
- Objections shall be delivered on or before the 11th day of December, 1923.
- The Commissioner shall hold an open Court for the revision of the list on such day not earlier than the 16th day of December, 1923, nor later than the 18th day of December, 1923, as he shall appoint.
- The Court shall be constituted of the Commissioner alone, and his certificate shall be sufficient for the purposes of Section 49 of the said Act.
- The Commissioner shall, on or before the 18th day of December, 1923, sign any copy or print made under Section 50 of the said Act of any list previously certified by him.

## TRAFFIC ACT, 1919, AS AMENDED BY AMENDING ACT OF 1922.

*Traffic Regulations.*

*Repeals, Additions, and Amendments.*

PURSUANT to Section 41 of "The Traffic Act, 1919," His Excellency the Governor, with the advice and consent of the Executive Council, hereby makes the following repeals, amendments, and additions to the Traffic Regulations and the Second and Sixth Schedules thereto:—

Regulation No. 30 is amended by adding further clauses, as follows:—

(m) To apply to all passenger vehicles plying for hire. No sidecar is permitted to be attached to motor cycles on the right hand of the cycle, except—

- When such sidecar is used by a person who became permanently maimed whilst on Active Military Service, and who satisfies the Authorities that he is only able to control a motor cycle from within a sidecar so affixed.
- When such sidecar is used by any person who proves to the satisfaction of the Licensing Authority that he is unable, through physical disability, to control a motor cycle except from within such sidecar.

(iii) A lamp is affixed on the extreme right hand or off side of the machine to enable its width and position to be ascertained by any approaching driver. Such lamp to be submitted and approved of by the Licensing Authority, and to exhibit a white light in the direction in which the sidecar is proceeding or is intending to proceed, and a red light from the rear—also to be subject to the general conditions laid down in Regulation No. 28.

(n) All motor vehicles shall have the steering controls on the right side thereof, so as to be manipulated by the Driver from that side only: Provided that this restriction shall not apply to—

- Any existing motor vehicles licensed in the State prior to the issue of the Regulations.
- Motor vehicles owned and used by persons visiting the State subject to the provisions of Section 30 of "The Traffic Act, 1919."
- Motor bicycles.

Regulation No. 66 is amended by adding after the word "may," in the eighth line, the words "himself remove or."

Regulation No. 73 is amended by adding the following paragraph:—

(b) No vehicle is permitted to stand on any portion of the streets in Perth and Fremantle set forth hereunder, except on authorised stands, for a longer period than fifteen minutes:—

- Wellington Street—From Pier Street to William Street;  
 William Street—From Wellington Street to St. George's Terrace;  
 Murray Street—From William Street to Irwin Street;  
 St. George's Terrace—From William Street to Irwin Street;  
 Pier Street—From St. George's Terrace to Wellington Street;  
 Hay Street—From Havelock Street to Irwin Street, in the City of Perth, and  
 High Street in the town of Fremantle.

Regulation 130 is hereby revoked, and the following Regulation is inserted in lieu thereof:—

(a) No person shall, without the written consent of the Commissioner of Police, in the Metropolitan Area, or the Town Clerk or Secretary of any other District, drive or cause to be driven in or along any road any cart, carriage, van, or other vehicle with signs or advertisements printed or painted on calico, paper, or other material posted thereon, or carry and exhibit on a road any board or other thing having an advertisement posted thereon as aforesaid, or solely or mainly for advertising purposes.

(b) No picture, print, board, placard, or notice shall be carried in any road, street, or public place by any person, unless the approval of the form and manner shall have been first obtained in writing from the Commissioner of Police for within the Metropolitan Area or from the Traffic Inspector for any other District.

(c) This Regulation shall not apply to the sale of newspapers.

(d) The following Regulations are as to form and manner in which boards and placards may, by way of advertisement, be carried in any street within the specified limits:—

As to form:

The advertisements are to be written or printed on wood or pasteboard of not more than 32 inches in length nor more than 20 inches in width.

As to manner:

(i) The boards and placards shall be suspended from the shoulders over the chest and back of the person carrying them, or carried overhead in the manner approved by the Commissioner of Police for the Metropolitan Area or the Traffic Inspector of the Local Authority outside that area.

(ii) Every board and placard shall be carried at a distance of not more than 30 yards from any other board or placard carried in the streets by way of advertisement.

(iii) Every board and placard shall be carried in the carriage way, close to the kerb of the footpath, but not on the footpath. Also with due regard to the rule of the road as prescribed in Regulations Nos. 40 and 45.

Regulation No. 144 is hereby revoked and the following regulation is inserted in lieu thereof:—

(a) No person shall hold or address any public meeting upon any road, way, or public place, or address any public meeting assembled on any road, way, or public place, from any public or private place adjacent thereto, unless he shall have first obtained the written permission in that behalf of the police in regard to the metropolitan area or the Town Clerk or Secretary of a Local Authority for any other district, or except from the date, time, and place specified in such written permission.

Provided that any refusal or order under Regulation 144 may be appealed against to the Minister for Works, whose decision shall be final.

(b) Any person desirous of holding or addressing any public meeting upon any road, way, or public place shall, at least three days before the date upon which he desires to hold or address such meeting, apply for permission to hold the same.

(c) Any person purporting to hold or address such meeting as aforesaid pursuant to such written permission shall, upon demand, produce the same to any police constable or officer of the Local Authority.

(d) No person shall, by speaking, shouting, singing, playing upon or sounding any musical or noisy instrument, or doing anything whatsoever, attract together a number of persons in any road, street, or public place to the inconvenience, annoyance, or obstruction of the public.

Regulation No. 146 (paragraph 1) is amended by the addition of the following proviso:—

Provided that the rates and fares as set forth in the Sixth Schedule shall be the maximum amounts to be charged for the several services, and no other charges or toll shall be levied in addition thereto.

Regulation published in *Gazette* dated 17th March, 1922, is re-numbered and amended as follows:—

151. (i) No vehicle shall pass over or along any road, which has been set apart for traffic in a specified direction, except in the direction so specified.

(ii) The following roads or parts of roads are hereby set apart for the particular traffic, as follows:—

(a) All vehicular traffic using that part of King Street, Perth, between Hay and Wellington Streets, must pass only in a south to north direction.

(b) All vehicular traffic using Queen Street, Perth, must pass only in a north to south direction.

#### Additions.

Further Regulations are hereby added, to be numbered 152 and 153:—

Regulation No. 152:

Motor Cycle Taxi Cars shall be a vehicle on three wheels, designed and constructed for the conveyance of one or two passengers, and shall be liable to all Traffic Regulations issued previously for the general conduct of motor vehicles, the identification discs and the licensing thereof, so far as they apply, with the additional conditions set out hereunder:—

(a) Motor cycle taxi cars shall, so far as possible, be of a permanent character in preference to the combination of motor cycle and sidecar.

(b) Motor cycle taxi cars must be submitted for inspection in thoroughly good condition, and no vehicle will be licensed unless it is certified by the manufacturer or agent to be safe and fit for public use as a motor cycle taxi car.

(c) The motor cycle car must be geared for three speeds and of not less than four horse-power, also capable of carrying the number of people for which it is licensed, and a width of seat of not less than 15 inches for each passenger.

(d) There must be at least three connections of approved design connecting the sidecar to the cycle, and so placed as to avoid the car striking the bars when car is loaded.

(e) Each car must be of the type known as the Coupe body and be provided and fitted with approved wind screen and hood for use at passengers' discretion and directions.

(f) The wind screen and door lights are to be of triplex safety glass or other glass that will not splinter, or some non-inflammable material to be first submitted to and approved of by the Licensing Authority.

(g) The windows, etc., must be so fitted as not to rattle.

(h) All brakes and other machinery must be kept in proper order, and the taxi car shall be submitted for inspection and test when required by the Traffic Inspector or Licensing Authority.

(i) The brakes must be capable of easy adjustment.  
 (j) Each wheel of bicycle shall have a stand fitted thereto.

(k) Each motor cycle and side car must be kept in such a condition and all parts so adjusted as to prevent undue noise or vibration.

(l) All driving chains and sprockets must be protected by a suitable guard.

(m) Accommodation for the carrying of a reasonable quantity of luggage must be provided.

Regulation 153.—Special Speed Limit under the provisions of Section 41 of "The Traffic Act, 1919":—

No person shall ride or drive any animal or vehicle on, over, or along any bridge within the Metropolitan Area, as defined by the Traffic Regulations, except under the following restrictions:—

(i) All vehicles, which with load exceed two tons in weight, are restricted to a speed not exceeding six miles per hour.

(ii) All vehicles, which with load do not exceed two tons in weight, are restricted to a speed of not exceeding 10 miles per hour.

(iii) All animals ridden or driven, except when attached to vehicles or in mobs, are restricted to a speed not exceeding 10 miles per hour.

- (iv) All animals driven in mobs, droves, or other numbers are restricted to a speed of not exceeding six miles per hour.

## Resolution.

M.P.H. 383/18; Ex. Co. 3472.

WHEREAS by Section 294 of "The Health Act, 1911-19," it is provided that the Governor may cause to be prepared Model By-laws for all or any of the purposes for which By-laws may be made by a Local Authority under any of the provisions of the said Act, and that a Local Authority may, of its own motion, by resolution, adopt the whole or any portion of such By-laws: And whereas Model By-laws have been prepared in accordance with the provisions of the said section and published in the *Government Gazette* on the 9th day of July, 1915: Now, therefore, it is resolved and determined by the Gnowangerup Road Board, being a Local Health Authority within the meaning of the said Act, that Series "B" of such Model By-laws be adopted (a) for the town ward of the Gnowangerup Road District, (b) dairies within the Road District of Gnowangerup from which milk is sold, with the following exceptions:—

## Part I.—By-laws 24 and 25.

And whereas under the provisions of "The Health Act, 1911-19," a Local Authority may make By-laws: Now, therefore, the Gnowangerup Road Board, being the Local Health Authority within the meaning of the said Act, doth hereby make the following By-laws, to stand as By-laws 24 and 25:—

24. The occupier of any premises shall not permit any liquid refuse to be discharged or deposited upon the surface of any street or other land under the control of the local authority or upon the surface of any part of his premises, except as hereinafter specified.

25. The occupier of any premises shall dispose of the liquid refuse produced upon the premises by such one of the following methods as may be required by the Local Authority:—

- (1) By discharging it on the surface of two prepared beds complying with the following conditions:
  - (a) Each bed shall be of an area of not less than 20 square yards, or such larger area as shall be required by the inspector.
  - (b) Each bed shall be used for receiving liquid wastes for one week at a time, and shall then be allowed to rest for one week. During the resting week, the bed shall be dug up to full spade depth.
  - (c) Where the inspector considers the soil too stiff for the purpose required, the occupier shall cart in sufficient sand to bring the soil to an approved texture.

(d) The liquid wastes shall be discharged evenly on the surface of the bed, and not allowed to saturate any one portion.

(2) By discharging into an approved ventilated impervious receptacle fitted with a gas-tight cover, which shall comply with the following conditions:

- (a) The contents of such receptacle shall be removed at such times and in such frequency and in such manner as is directed by an inspector.
- (b) The occupier shall not permit any such receptacle to overflow or become offensive.
- (c) The receptacle shall be situated where directed by an inspector.
