THE LAND ACT, 1898.*Amendment of Forms of Conditional Purchase Leases, etc.*

1456/21.

HIS Excellency the Governor in Executive Council has been pleased to amend, under Section 160 of "The Land Act, 1898," the Forms of Conditional Purchase Lease, Conditional Purchase License, Grazing Lease, Occupation Certificate, Homestead Farm, and Special Lease prescribed in the Ninth, Eleventh, Fourteenth, Eighteenth, and Twenty-ninth Schedules respectively to "The Land Act, 1898," by adding the following Clauses (to be

applied to localities where the land carries Sandalwood), viz.:—

This Lease (or Occupation Certificate) is issued subject to the following conditions:—

1. All sandalwood growing on the demised land is reserved to the Crown, and shall not be cut, pulled, or destroyed by the lessee or his assigns.

2. Any license heretofore or hereafter granted under "The Forests Act, 1918," or the Regulations thereunder, shall apply to the demised land as if such land were Crown lands.

3. Any registered sandalwood getter holding an order from a person licensed under any license so applicable to the demised land as aforesaid may enter upon such demised land and remove any sandalwood therefrom.

4. If the lessee or any assignee of the lessee desires to clear the whole or any portion of the demised land upon which sandalwood is growing, he shall send notice of such desire, together with an estimate of the sandalwood to be obtained from the land to be cleared, and the Conservator of Forests may thereupon grant permission to the lessee or his assignee to remove the sandalwood from such land, subject to such conditions as the Conservator may think fit to impose.

5. Any sandalwood so removed by the lessee or his assignee shall not be disposed of to any person other than the holder of a license which is applicable to the demised land, and every disposition of such sandalwood to such a licensee shall be on such terms and conditions as the Conservator shall from time to time prescribe: Provided that the lessee or his assignee shall not be compelled to accept, in payment for any sandalwood from any such licensee, less than the licensee would be called upon to pay to a registered sandalwood getter for a similar quantity and quality of sandalwood obtained from Crown lands.

BY-LAWS OF THE GREENMOUNT ROAD BOARD.

Whereas by "The Road Districts Act, 1919," the Road Board of any District is empowered to make By-laws for all or any purposes in the said Act mentioned, the Greenmount Road Board, in pursuance of the powers vested in the said Board under and by virtue of the said Act and of every other authority enabling it in that behalf, doth hereby make and publish the following By-laws:—

Interpretation.

1. In these By-laws the following terms shall, unless the context otherwise indicates, bear the meanings set against them respectively, that is to say:—

"The Act."—The Road Districts Act, 1919, and all other amendments thereto, or which hereafter come into force.

"District."—The Greenmount Road District.

"Chairman."—The member acting for the time being as Chairman of the Board.

"Board."—The Greenmount Road Board.

"Member."—A Member of the Board.

"Secretary."—Secretary of the Board.

"Person."—Shall include the plural and also a body corporate.

"Masculine"—Shall include the feminine.

"Permission of the Board."—The consent of the Board given in writing.

Other terms shall have the same meaning as in "The Road Districts Act, 1919," or other Regulations thereunder.

Appointments.

2. The appointment of all officers shall be by show of hands, unless a ballot be demanded, in which case the election thereto shall be conducted by ballot, so as to obtain an absolute majority of the members present. The salary attached to any office and the terms of the engagement thereto shall in all cases be fixed before any appointment is decided.

Duties of Secretary.

3. It shall be the duty of the secretary:—

To attend all Board meetings.

To attend all Committee meetings.

To take notes of minutes and prepare reports of committees.

To conduct all correspondence, and to give the other officers instructions as directed by the Minutes.

To answer all questions on the Board's business.

To carry out all duties as specified in the Act.

To supervise the preparation of the Board's Electoral Lists; examine proofs of latter, and arrange for distribution of copies prior to elections; to attend all courts of revision or appeal, and make the necessary arrangements for the elections.

To summon the members to Board and Committee meetings.

To keep all books entered up to date in accordance with instructions issued by the Minister, and any additional instructions of the Board.

To check all accounts sent into the Board, check all the returns made by the collectors or other of the Board's officers, and see that with all returns made the duplicate of the receipt books accompany the returns; to supervise and attend to the due payment of all money coming through the hands of the Board's officers, and payable to the credit of the Board.

To report to the Board, at its next meeting, any officer neglecting to make his returns as provided, with the necessary vouchers attached thereto.

To pay into the Bank, within seven days after receipt, to the credit of the Board, any sum or sums of money that may be received by him on behalf of the Board.

No money shall be paid into the Bank to the credit of the Board, except by or through the secretary. The secretary shall give all receipts on printed forms.

To have the cash-book and Bank pass-book statement made up in readiness for the meetings of the Board, and produce them at each meeting thereof.

To see that all bonds and other forms of security to be taken from the contractors are prepared, and that the security required of servants is taken within due time, and report as to such matters to the Board.

He shall be responsible for the safe custody of all books, deeds, records, and papers; shall readily and cheerfully obey all lawful commands and orders of the Board, and attend to all matters affecting the finances and welfare of the Board and not herein specified.

Report to the Chairman any servant of the Board who has been guilty of any neglect of duty or who is incapable of performing the duties allotted to him.

Exercise, subject to any directions given by the Board or Chairman, control over all servants of the Board.

At each ordinary meeting of the Board an approximate balance sheet shall be produced, showing as nearly as possible the financial position of the Board as regards payments already made, its present assets and liabilities, which latter shall specify and include moneys voted for special purposes which have not yet been undertaken or contracted for, and no further expenditure of any nature shall be incurred unless this balance sheet shall be then produced.

All current books and legal documents when not in actual use shall be kept in the safe.

One key of the safe shall be kept in the personal custody of the secretary, and the duplicate lodged at the Bank, in the names of the Chairman and one member of the Board.

Duties of the Supervisor.

4. The duties of the supervisor shall be to promptly attend to all instructions received through the secretary with respect to the following matters:—

To prepare proper plans and specifications for all works in connection with roads and culverts under the control of the Board; examine all material for such work; set out the height, lines, levels, and dimensions of any work, watch the progress and formation thereof, and see the same faithfully executed and performed.

To report to the Board any road in need of repairs, or other matters requiring attention, and to make the necessary arrangements for carrying out the work in a proper manner when so directed.

To see that no labourers are engaged but those who are able-bodied and sober, and to immediately discharge any labourer guilty of disobedience or insubordination or found incapable of performing the duties allotted to him.

To see that all drains, culverts, and bridges are maintained in a state of efficiency.

To attend Board or committee meetings as required.

To specially examine all roads throughout the district, at least twice a year, or as directed by the Board.

To keep the secretary informed of all matters under his (the supervisor's) control, and to submit each month to the Board a full report of all works carried out or in progress, with recommendations regarding works to be put in hand.

Building Surveyor.

5. The Building Surveyor shall examine all plans and specifications for buildings submitted to the Board, and see that they are in proper form and comply with the Regulations and By-laws. He shall at once report to the Board or the secretary any building operations in the specified area for which no permit has been granted. He shall from time to time inspect buildings in progress, and see that the work is carried out in accordance with the plans and specifications as approved by the Board, and generally shall see that all the requirements of the Building Regulations and of by-laws made thereunder are duly observed.

Meetings.

6. Meetings of the Board shall be of two kinds, ordinary and special. It shall rest with the Chairman and any three members of the Board to exclude the public when in their opinion it is expedient to do so.

Notice shall be given by the Chairman or secretary of ordinary or special meetings at least seven days before such meeting, and "notice in writing" of every meeting adjourned for a term exceeding two days.

Ordinary meetings of the Board shall be held at the office of the Board during the first week in the month, unless otherwise resolved at the preceding ordinary meeting of the Board.

Order of Business.

7. The business of all ordinary meetings shall be as follows, that is to say:—

- (a.) Reading and confirmation of Minutes of last ordinary and of special meetings if any.
- (b.) Consideration of business arising out of Minutes.
- (c.) Reading of correspondence, and taking such immediate action as may be deemed expedient in regard thereto.
- (d.) Passing accounts for payment.
- (e.) Presentations of petitions or memorials and committee reports, and consideration thereof.
- (f.) Opening and consideration of tenders and ratification of contracts.
- (g.) Motions of which previous notice has been given.
- (h.) Ordinary business of the Board.

No discussion shall take place upon the Minutes except as to their accuracy, or for the rectification of any clerical error.

Immediately after confirmation of the Minutes the Chairman may make any communication to the Board which he may deem advisable, or bring under consideration any business he may think necessary, and it shall be competent for any member of the Board to ask a question or questions, but he shall confine himself to the question simply, and no debate shall ensue thereon at the time.

In the event of any member having urgent business to place before the meeting, he may move the suspension of the Standing Orders, and if agreed to by the Board, such business shall take precedence of all other.

Order of Debate.

8. A member having audience shall not digress from the subject of debate and speak for not more than ten minutes, unless by permission of the Board.

A motion once moved at a meeting cannot be withdrawn unless by the consent of the Board.

One or more amendments may be proposed on a motion before the Board, but no second or subsequent one can be accepted by the Chairman until the previous amendment has been dealt with.

A motion or amendment not seconded cannot be discussed by any member except the mover, nor be put by the Chairman.

In submitting a motion or amendment, the Chairman must put the question first in the affirmative, then in the negative.

When an amendment is carried, the motion as amended thereby becomes a substantive motion, upon which further amendment may be moved, before it is finally dealt with.

All notices of motion shall be in writing and shall be lodged with the secretary ten days before the regular meeting of the Board.

No motion shall be brought forward for discussion unless given notice of or permission being granted by the Board.

No member shall speak twice on the same subject except by way of explanation or to an amendment, or in reply upon any original motion of which he may have been the mover, but any member who may have been misunderstood, or misrepresented, shall be allowed to explain before the mover replies, but not after; and after the reply, the original or amended motion, as the case may be, shall at once be put to the vote.

Committees.

9. The Board may at any meeting appoint three or more members as a committee to inquire into any matter and make a report or recommendation thereon, but no committee shall incur any financial liability or in any way commit the Board to any responsibility whatever without express and specific authority conferred by the By-laws, or by a resolution of the Board.

Finance—Accounts.

10. All accounts, bills, and vouchers shall be submitted to the ordinary meeting, and after being certified as correct and passed for payment shall be paid by cheque.

An account shall be opened with such Bank as the Board may direct, and all money received from whatever source (with the exception of money granted by the Government) shall be paid into such Bank to the credit of the Board, and no account shall be paid except by cheque signed by the Chairman and countersigned by another member of the Board and by the secretary.

All moneys belonging to the Board shall within 24 hours after they come into the hands of any officer, servant, or clerk be paid to the secretary or other responsible officer if directed by the Board.

Money granted by the Government and paid to the Board's credit at the Treasury shall only be operated upon to pay actual creditors for work executed on the specific object for which the money was granted.

Tenders.

11. Tenders for work shall be opened and dealt with when the subject-matters of the tenders come to be considered at the meeting of the Board, or by a committee appointed for the purpose. Deposit, 5 per cent.

Petitions.

12. Every petition or memorial shall be respectful and temperate in its language, and shall be presented to the Board by a member only, and any member presenting a petition or memorial to the Board shall affix his name to the beginning thereof with the number of signatures; and every member presenting a petition or memorial shall acquaint himself with the contents thereof, and ascertain that it does not contain language disrespectful to the Board. The nature and prayer of every petition or memorial shall be stated to the Board by the member presenting the same.

Urgent Work.

13. The Chairman with one member may, in case of urgency, authorise the expenditure of a sum not exceeding £10; one member £3, Chairman only £5, two members £3; but shall in every case report the same at the next meeting of the Board.

Unauthorised Expenditure.

14. Every item of expenditure and every liability incurred by any committee or member of the Board, otherwise than under the authority of the Act or of these By-laws, shall be deemed unlawful expenditure.

Offences, Omissions, and Neglects.

15. Any person found guilty of the following offences shall, on conviction thereof, pay a penalty not exceeding £10:—

- (a.) Damaging or destroying any building, dam, well, tank, pump, windmill, windlass, bucket, rope, piping, troughing, fence, gate, or other property under the control of the Board.
- (b.) Placing any placard or other document, writing, printing, or otherwise defacing any house or building abutting on or contiguous to a public road, or on any wall, fence, gate, or lamp-post without the consent of the occupier thereof.
- (c.) Erecting or fixing, or permitting to be erected or fixed, any sign, notice board, placard or advertisement of any description on any road or reserve or upon any fixture or trees thereon without having first obtained the permission of the Board.
- (d.) Neglecting to clean all private yards, ways, passages, or avenues, by which neglect a nuisance by offensive smell or otherwise is caused.
- (e.) Blasting any rock, stone, or timber in or near any road, or to the danger of the public, without the permission of the Board, or not attending to such directions in regard thereto as may be given by such Board.
- (f.) Placing, stacking or storing, within the limits of the townsite, in the open air, any cases, paper, shavings, crates packed with straw, or dangerous or inflammable substances so as to be or likely to become a source of danger through fire.
- (g.) Having a pit or other excavation on unfenced land abutting on to any road or street, and failing to fence such land so as to prevent danger to the travelling public within seven days after receiving notice from the Board so to do. If the owner of the land is not known or cannot be found, notice may be served by posting it on the land. Should the notice not be complied with, the Board may cause the work to be done and recover the costs from the owner of the land.

Removal of Verandahs, Encroachments, etc.

16. Any verandah, balcony, or hoarding which obstructs the footpath or is dangerous, or any building, fence, tree, or other obstruction or encroachment upon or overhanging any road, footpath, street, lane, or public place, shall be removed when so ordered by the Board. Should any such order not be carried out within the time specified the Board may cause the work to be done, and all expenses incurred thereby shall be borne by the owner or occupier of such verandah, balcony, hoarding, or other obstruction or encroachment.

Any person failing to comply with such order for removal, or obstructing any officer or person employed by the Board in carrying out this By-law, shall be liable to a penalty not exceeding £10.

Lighting.

17. Any unauthorised person who shall light, put out when lighted, or in any other way interfere with any lamp

belonging to or under the control of the Board, or any person who shall damage or destroy such lamp shall pay, in addition to the value of such damage (if any), on conviction, a sum not exceeding £5.

Water Supply.

18. Any person who shall injure or destroy any well, bore, pipe, tank, or place of storage for water, or any machinery, appliances, or property used in connection therewith, shall be liable to a penalty not exceeding £5, and also shall pay to the Board the sum of such damages.

19. Any person who shall waste or allow water to escape, foul, pollute, or taint any water contained in any bore, pipe, tank, or place of storage shall be guilty of an offence against this By-law, and shall be liable to a penalty not exceeding £20.

20. No person shall pollute or cause to be polluted any watercourse, pool, well, tank, reservoir, or other water within the district.

21. Any person who shall remove any water from any well, bore, tank, or other place of storage under the control of the Board, except in the direct watering of stock thereat, or for *bona-fide* camping use, or except with the written consent of the Board and payment thereon of such reasonable fee as may be demanded, shall forfeit and pay, on conviction, a penalty not exceeding £5.

Sand and Timber.

22. Any person who shall remove any sand, stone, timber, or other materials from any lands under the control of the Board without a license shall forfeit and pay, on conviction, a sum not exceeding £5, together with the value of the materials so removed.

Barbed Wire.

23. Barbed wire shall not be allowed on the outer or road side of any fence along any road. Any person offending against this By-law shall be liable to a penalty not exceeding £5.

Fencing.

24. The owner of any land abutting on any road in any townsite shall fence all such boundaries so abutting with such description of fence as may be directed by the Board, and shall maintain every such boundary fence erected, or to be erected, in good order. Penalty for non-compliance £5. In the event of such fence not being erected, or repaired after due notice has been given to do so, the Board may fence or repair such fences and recover the cost of so doing from the owner or owners of the land.

Bathing.

25. No person shall bathe in any river or open public water within the limits or abutting on the boundary of the Road District within the jurisdiction of the Board, without suitable bathing costume or clothing. Every person offending against this By-law shall, for every such offence, be liable to a penalty not exceeding £20.

Depasturing of Cattle, etc.

26. Any person who shall turn loose, or suffer any horse, cow, sheep, goat, or other animal belonging to him or under his control to stray or go about, or to be tethered or depastured in or upon any road, recreation ground or reserve shall, upon conviction, be liable to a penalty not exceeding £5, and the Board may cause such animal to be impounded, and straying goats to be destroyed.

27. No animal shall be allowed to stray on any roads or places, and no animal suffering from an infectious or contagious disease shall be ridden or driven on any road or be allowed to drink at any public watering place within the district. The Board may order any animal so suffering to be slaughtered at the owner's expense. The owner or driver of such animal shall be liable to a penalty not exceeding £10 for a breach of this By-law.

28. The owner of any bull or stallion straying on any road within the district shall be liable to a penalty of not less than £3 and not exceeding £5.

Copulation of Stock.

29. Any person who, as owner or otherwise, while in charge of an entire horse, bull, or ass shall cause, allow, permit, or suffer any such entire horse, bull, or ass to try to cover any mare or cow within any township within the district, or shall cause, allow, permit, or suffer any such entire horse, bull, or ass to be turned loose in any yard or other place with any mare or cow for the purpose of allowing such mare or cow to be tried or covered except in some yard, building or other premises as shall be entirely and sufficiently screened from public view, shall forfeit and pay, on conviction, a sum not exceeding £10.

The keeping of Bees.

30. Where the Board is satisfied that the keeping of bees in any locality in the district is a nuisance to the general public, it may prohibit bees being kept in such locality or any portion thereof. The owner or person in charge of any bees who fails to remove or dispose of such within seven days after notification by the Board that the keeping of same is prohibited, shall be liable to a penalty not exceeding £5.

Public Pounds.

31. Any person who shall break, damage, or destroy any pound, fence, gate, lock, shed, trough, or other premises, the property of the Board, shall be liable to a penalty not exceeding £5.

32. Any person who shall obliterate, deface, or damage any table of fees, placard, or other notice required by "The Cattle Trespass, Fencing, and Impounding Act, 1882," shall be guilty of an offence against this By-law, and shall be liable to a penalty not exceeding £5.

33. Any person who shall release, or attempt to release any cattle which shall be lawfully seized for the purpose of being impounded, whether such cattle shall be in the pound or on the way to or from any such pound, shall be guilty of an offence against this By-law and shall, on conviction, be liable to a penalty not exceeding £5.

Pound Fees.

34. The fees to be charged for impounded cattle shall be as under:—

Sustenance Fees.

35. The charges for sustenance of impounded cattle shall be as follows:—

For each horse, mare, gelding, mule, ass, pony, or head of horned cattle above 12 months old	3	0
For each colt, foal, camel, or head of horned cattle under 12 months old, excepting sucking foals or calves	2	0
For each sheep or goat	2	0

Such sustenance fees to be charged for each day of twenty-four hours, half rates only to be charged for less than twelve hours, and no charge to be made for less than three hours.

Crossing Places.

36. It shall be lawful for the owner of any land fronting or adjoining any road or public way requiring access thereto with horse and vehicle, from such street to such land across any existing made footpath, kerbing, channel, or gutter, having first had and obtained the consent of the Board, to construct a crossing of such dimensions and materials, and in such form and manner as the regulations of the Board for the time being require, or as may be directed by the secretary, and shall thereafter keep and maintain the same in good repair. Any person not complying with this By-law shall be liable to a penalty not exceeding £5.

Lamps, Posts, etc.

37. No person shall erect, or cause to be erected, any lamp-post, bridle-post, telegraph, telephone or electric lighting pole, or flag-staff in any road or public place without the permission of the Board. Any such post or pole shall be placed in such position as directed by the Board, and shall be painted at least once in every three years. The Board may order to remove all bent, dangerous, or unsightly posts or poles. Any person erecting any such pole or flag-staff without having first obtained the permission of the Board, or failing to paint or remove any such pole or post when so directed by the Board, shall be liable to a penalty not exceeding £5 for each offence.

Clearing.

38. The owner of any vacant lots or lot in any townsite shall clear such land of trees, scrub, and undergrowth when so required by the Board. Any person failing to comply with such notice within the time allowed shall be liable to a penalty not exceeding £10.

Damaging Roads.

39. No person shall wilfully or negligently damage or destroy by means of horse, team, or any other means, any

oad under construction or repair, and any person found guilty of such damage or destruction shall be liable to a penalty not exceeding £20.

40. Any person who—

(a.) draws upon any road timber, stone, or other material otherwise than on a wheeled vehicle or suffers such material when carried principally or in part upon a wheeled vehicle, to drag or trail upon a road; or

(b.) uses any jinker or whim on any road in the Board's district without permission of the Board—the Board may grant permission to any applicant to use jinkers or whims on any road, the person applying to deposit the sum and sign conditions as the Board may deem necessary for regulating the use of jinkers on roads; or

(c.) draws, without the consent aforesaid, across the waterside of a road, or across a drain, except over a properly constructed approach or culvert, a dray or other wheeled vehicle, or damages the kerbing of any footpath or road, shall be deemed guilty of an offence against these By-laws, and shall be liable to a penalty not exceeding £20 for every such offence.

Heavy Traffic.

41. The Board may, by notice affixed to any bridge or culvert, declare the maximum weight of any engine, agricultural or other machine, or vehicle of any kind, and of any load or material which shall be permitted to cross such bridge or culvert, and also the pace or speed at which such engine, machine, vehicle, or load shall be driven, led or taken over such bridge or culvert, and any person who shall cross such bridge or culvert in contravention of this By-law shall, in addition to liability for any damage he may have caused, be liable to a penalty not exceeding £20.

42. Any person taking any plough, cultivator, or other implement over or along any road and thereby damaging or marking such road in such a manner which in the opinion of the Board may indirectly cause ultimate damage to the road, shall be liable to a penalty not exceeding £10.

43. No person shall use upon any road any vehicle, the wheel or wheels of which are locked, unless there is placed at the bottom of such vehicle some sufficient protection to prevent damage to such road; any person so offending shall be liable to a penalty not exceeding £10.

To prevent Obstruction of Streets and Reserves.

44. No person shall place, lay, deposit, or shoot or discharge any rubbish or materials whatsoever on the surface of any street, road, footpath, or public reserve within the District, without having first obtained the permission of the Board.

Every person shall, after having received from the Board, as in the last preceding section provided, a permit to deposit rubbish or materials on the surface of any street, road, footpath, or jetty, or public reserve, have and keep sufficient light burning thereon from sunset until the following sunrise, during the time such rubbish or materials shall remain and continue so deposited.

No person, without having first obtained the permission of the Board, shall break up, cut down, damage, destroy, or injure any footpath, drain, culvert, gutter, bridge, road, public-way, kerbing, gate, fence, post, lantern, lamp-post, implements, materials, buildings, or other properties of the said Board, or under the control of the Board.

Depositing Rubbish on Roads, etc.

45. No person shall deposit any bottles, broken glass, crockery, tins, rubbish or offensive matter, solid or liquid, on the roads or reserves within the boundaries of the district.

To Protect Bridges from Fire.

46. Any person who shall light a fire (except by the order of the Board) or shall place any rushes, bushes, or other inflammable substance under, near, or against any bridge in the district, for the purpose of making a camp or sleeping place, or for any other purpose, shall be liable to a penalty of not less than £1 and not exceeding £20.

Prevention of Trees falling across Roads.

47. No person shall make or leave a fire near any road or track or reserve without taking proper precautions against such fire spreading.

No person shall ringbark or set fire to any standing tree near to any road or track.

Park Lands, Recreation Grounds, and Reserves.

48. All park lands, recreation grounds and reserves under the control of the Board shall be open to the public daily for recreation purposes, except as otherwise provided in these By-laws.

49. The Board shall have the power to grant to any responsible person or persons, on such occasions as it thinks fit, the exclusive right to use and occupy any park lands,

recreation grounds or reserves under its control, for the purpose of holding public sports or amusements. Any person or persons to whom this right is granted shall:—

(a.) Pay the Board such fee as may be fixed.

(b.) Be responsible for the proper care of all fences, buildings, trees, or other improvements upon or enclosing such park lands, recreation grounds, or reserves, during the period of occupancy.

(c.) Immediately remove rubbish of any description brought thereon, and leave the grounds clean and in proper order.

(d.) If so required, pay the Board a deposit not exceeding £5 as a guarantee for the due observance of this By-law. The amount so deposited shall be returned if the grounds are left in order to the satisfaction of the Board, but otherwise shall be forfeited.

50. The Board, or any person it has duly authorised, may make charges for admission to any recreation ground or reserve when public sports or amusements of any description are being held. Such charges shall not exceed two shillings for each adult and one shilling for each child under 15 years, with free entry for children under five years if accompanied; and for horses and vehicles one shilling each. On such occasions no person shall be entitled to admittance until the sum charged has been paid.

51. No horses, cattle, or vehicles shall be allowed on any park lands, recreation grounds or reserves, without the permission of the Board.

52. No person shall offer for sale on any recreation ground or reserve any provisions, refreshments, or goods of any kind; nor carry on racing, boxing, or other shows; nor carry or use any firearms; except with the express sanction of the Board and payment of such fee as may be demanded.

53. Persons using or being upon any park lands, recreation grounds or reserves, shall at all times conduct themselves in a becoming manner; and any person creating a disturbance, or being an annoyance to the public, or otherwise failing to observe the provisions of these By-laws, may be expelled from such grounds by any police constable, officer of the Board, or other duly authorised person.

54. The Board may, in its discretion, prohibit any games or gymnastics from being played or carried on by any person or persons upon any park lands, recreation grounds or reserves, on any Sunday, Christmas Day, or Good Friday.

55. No person shall damage or injure any tree, shrub, or plant, in any park lands, recreation grounds or reserves.

Stall Licenses.

56. No person shall keep, manage, or conduct any movable or temporarily fixed stall in or near any street for the sale of any meat, fruit, vegetables, drinks, eatables or articles of merchandise, unless such person be licensed by the Board. Licenses for stalls shall be in the form of Schedule C.

57. No licensed stall shall be placed or allowed to stand in any street or position other than that mentioned in the license, or between the hours of 8 p.m. and 8 a.m.

58. The following fee shall be paid for licenses for stalls, and shall be paid in advance on the first Monday in every month, and if payment be not made when due the license shall be void. For every stall, 20s. per month.

59. Every licensed stallholder shall at all times obey the lawful directions of the Traffic Inspector or other authorised officer of the Board.

60. If any person to whom a stallholder's license is granted shall lend, transfer, or assign his license or fail to carry out the Board's directions, such license shall be null and void, and no person shall borrow or make use of any such license granted to a person other than himself; any person offending against this By-law shall be liable to a penalty not exceeding £5.

Penalties.

61. Where any person by these By-laws, or any of them, is required to do or perform any act, and such act is not done and remains undone or unperformed, it shall be lawful for the Board to perform the same and charge the cost and expenses against such person, and the amount thereof may be recovered summarily.

62. Every person who does, permits, or suffers any act, matter, or thing contrary to any of these By-laws, or commits or permits any breach or neglect thereof, shall be deemed guilty of an offence against these By-laws, and, where not otherwise provided, shall be liable to a penalty not exceeding £20 for every such offence.

63. All penalties or other sums recovered under provisions of these By-laws shall, unless otherwise provided, be paid to the Board, and shall become the property of and form part of the ordinary income of the district, except so much as may be paid to any informer.

By-laws Repealed.

64. The By-laws made and published in the *Government Gazette* of September 20th, 1907, numbered one to forty-five inclusive, together with Schedule "A," are hereby repealed.

A By-law of the Municipality of the City of Perth, made under Section 179 of "The Municipal Corporations Act, 1906," and numbered 29, for the regulating of the standing of Motor Cars in Streets.

In pursuance of the powers conferred by the said Act, the Mayor and Councillors of the City of Perth order that By-law No. 29 be repealed, and the following substituted in lieu thereof:—

The following stands are hereby appointed as stands for Motor Cars licensed under "The Traffic Act, 1919":—

(1) For Private Motor Cars—

- (a) A stand in the centre of St. George's Terrace, beginning at a point 113 yards west of the western side of Barrack Street and extending westwards 37 yards.
- (b) A stand in the centre of St. George's Terrace, beginning at a point 113 yards west eastern side of Pier Street and extending eastwards for six chains.
- (c) A stand in the centre of St. George's Terrace, beginning at the western side of William Street west of the underground lavatory and extending to the western side of Foy & Gibson's buildings.
- (d) A stand on the western side of Pier Street, beginning at a point two chains south of the southern side of Hay Street and extending southwards six chains.
- (e) A stand on the northern side of Murray Street, beginning at a point twenty feet east of the eastern side of Pier Street and extending eastwards two and a-half chains.
- (f) A stand, with the width of one chain, on the western side of the Esplanade, beginning at the southern side of Bazaar Terrace and extending southwards five chains.
