1. Regulation 28 is amended as follows:—

Paragraph (c) of Regulation 28 is hereby repealed, and the following paragraph inserted in lieu thereof:

(c) The total number of plates to be issued to any manufacturer or dealer shall be decided by the Local Authority.

2. Regulation No. 151 is hereby amended, by the addition of the following paragraph:—

(c) All motor cycles using that part of St. George's Terrace between Milligan Street and George Street, also the whole of Malcolm Street and Mount Street, must pass only in an Easterly direction.

154. The Regulations made under "The Traffic Act, 1919," and published in the *Government Gazette* on the 13th February, 1920, and the amendments thereof, shall be deemed to supersede all Regulations previously made, and such prior Regulations shall stand repealed.

155. The said Regulations published in the *Government Gazette* on the 13th February, 1920, and all amendments thereof heretofore enacted or hereafter to be enacted, shall be read and construed together and may be cited as the "Traffic Act Regulations."

Regulation 22.—Paragraph 6 is amended by revoking subparagraphs (d) and (e), and the following inserted in lieu thereof:—

(d) For any cart or carriage for private use, red numbers or letters and numbers on green ground.
