# The Road Districts Act, 1919. Meckering Road District. PROCLAMATION

WESTERN AUSTRALIA, By His Excellency Sir Robert Furse
TO WIT.

WHEREAS it is provided by Section 233 of "The Road Districts Act, 1919," that rates throughout a district shall be uniform, except in so far as a Board may fix the rates for any townsite or any area defined for that purpose by proclamation at a higher figure within the limits in the said section set forth: And whereas it is desirable to approve of and define the area hereinafter described as an area within which the Meckering Road Board may rate at such higher figure: Now therefore I, the said Administrator, by and with the advice and consent of the Executive Council, do hereby approve of and define the following area, viz.:

All that territory comprised in that portion of the Meckering Townsite bounded by lines starting from the South corner of Meckering Town Lot 361 and extending North-Westerly to its West corner; thence North-Easterly, passing along the South-Eastern side of a public road, to its intersection with the North-Eastern side of Moore Road; thence North-Westerly passing along the said side of Moore Road to its intersection with the South-Eastern side of Watts Street; thence North-Easterly, passing along the said side of Watts Street to its intersection with the North-Easterly side of Hackett Street; thence North-Westerly, passing along said side of Hackett Street to its intersection with the South-Eastern side of Backett Street to its intersection with the South-Eastern side of Bath Street; thence North-Easterly, passing along said side of Bath Street, to a point situated South-Easterly from the East corner of Town Lot 244; thence North-Westerly, passing through said corner and onwards to the South-Eastern side of Stewart Road; thence North-Easterly, Easterly to the West corner of Town Lot 1, and again North-Easterly, passing along South-Eastern, Southern, and again South-Eastern sides of Stewart Road to its intersection with the South-Western side of Leeming Road; thence South-Easterly, passing along said side of Leeming Road to the South-Eastern side of Vanzetti Street; thence South-Westerly, passing along said side of Vanzetti Street along the South-Eastern sides of Meckering Suburban Lots 40 and 41, and onwards to the South-Western side of Moore Road aforesaid; thence South-Easterly, passing along said side of Moore Road to a point situate North-Easterly from the starting point; thence South-Westerly to the said starting point, as an area in which the Meckering Road Board may fix their rate at such higher figure as aforesaid, within the limits mentioned in Section 233 of "The Road Districts Act, 1919."

When passing accounts for payment under this paragraph, departments must quote thereon, as their authority for the expenditure, the Tender Board number, which will be given on the approved application. The Controller of Stores may, at his discretion, purchase supplies in anticipation of Tender Board approval, provided that in all such cases quotations have been obtained in accordance with these regulations, and the lowest quotation for quality required accepted.
