ORDER IN COUNCIL.

*Water Boards Act, 1904.**Bruce Rock Water Area.*

ORDER IN COUNCIL.

WHEREAS by "The Water Boards Act, 1904," the Governor is empowered by Order in Council to constitute the district of a Local Authority or two or more Local Authorities or any part or parts of such District or Districts a Water Area, under such name as may be directed; and whereas, under the provisions of the said Act, the Governor may authorise the Minister of Water Supply, Sewerage, and Drainage to exercise within a Water Area all the functions of a Water Board: Now, therefore, His Excellency the Administrator, by and with the advice and consent of the Executive Council, doth hereby constitute an area, having the boundaries described in the Schedule hereunder a Water Area for the purpose of the said Act, under the name of the Bruce Rock Water Area, and does hereby appoint the Minister of Water Supply, Sewerage, and Drainage to exercise all the functions of a Water Board under the said Act in such area.

Schedule.

The townsite of Bruce Rock gazetted 27th June, 1913, and the catchment area commencing at a point about 5½ chains West of the intersection of the northern boundary of Avon Location 1161 with the western boundary of Location 7793; thence north-easterly in Location 13697 about 7 chains; thence north-westerly about 10 chains; thence south-westerly about 16 chains; thence southerly about 7½ chains into Location 1161; thence south-easterly about 12 chains; thence generally north-easterly about 26 chains; thence north-westerly about 3½ chains to the point of commencement; and a pipe track, 33 feet wide, commencing at the said catchment area and running thence in a generally south-easterly direction for about 1 mile 1 chain to the said townsite; and a reservoir site, about 8½ chains long by about 5 chains wide, on the said pipe line, situated about 27 chains from the townsite, as shown outlined in red on Plan P.W.D., W.A., 23079.

This Order in Council shall take effect from the 10th day of September, 1924.

*The Road Districts Act, 1919.**Yilgarn Road Board.**Appointment of a Commissioner.*

MEDICAL AND HOSPITAL REGULATIONS.

HIS Excellency the Administrator in Council has been pleased to make the following Medical and Hospital Regulations, to be the regulations governing the medical and hospital services of the State, and to repeal all previously existing regulations relating thereto.

MEDICAL AND HOSPITAL REGULATIONS.

INTERPRETATION.

1. Throughout these Regulations the word "Department" shall be deemed to mean the Department of the Public Service of the State for the time being charged with control of and management of the hospital and medical services.

2. The "Principal Medical Officer" is the officer for the time being charged with the professional control of the Department, and shall include any officer constitutionally appointed to fill the office temporarily during the absence of the Principal Medical Officer.

3. The "Secretary" is the officer who shall be responsible to the Permanent Head for the business and financial management of the Department.

PRINCIPAL MEDICAL OFFICER.

4. The Principal Medical Officer shall exercise a general supervision over all hospitals, and for this purpose he shall have power to visit and inspect all or any such hospitals, whether wholly or in part maintained by the Government.

5. The Department may from time to time require hospitals to make such returns relating to patients treated, to finance, and other matters, as it may deem necessary.

6. The Secretary shall have power to visit any hospital, and he may also require the production of any hospital records and books of account.

DISTRICT MEDICAL OFFICERS.

7. A District Medical Officer is required to perform the following duties:—

- (a) He shall provide, free of cost to the patient, medical attendance and treatment, together with medicine, to all indigent sick and unindentured aboriginals.
- (b) He shall, when necessary in such cases, issue certificates in lunacy.
- (c) He shall be responsible for the proper medical care of patients in hospital.
- (d) He shall attend, when required, upon any cases in custody and upon any State children.
- (e) He shall provide, free of cost to the patient, medical attendance and treatment and also medicine for any members of the Police Force and officers under the Regulations made under the Prisons Act.
- (f) He shall similarly provide for such public servants of the State as entered the Service prior to 8th July, 1886, and for the families of such public servants. For the purpose of this paragraph, the term "family" shall include all persons constituting an officer's ordinary household, having no means of their own, but the term does not include children over 18 years of age or grown-up persons who reside with any such public servant for the sake of convenience, or servants.

(g) At hospitals in his district at which probationers are in training, he shall deliver, or arrange for the delivery of such courses of instruction as are specified by the Nurses' Registration Board.

(h) Where no other medical practitioner is available, a District Medical Officer shall, if requested so to do, accept the position of Medical Officer of Health to a Local Authority under the provisions of "The Health Act"; should any dispute arise in connection with the payment of emoluments by any such local authority, the Principal Medical Officer shall decide the amount to be paid, and his decision shall be final.

(i) When required by the Principal Medical Officer, a District Medical Officer shall carry out any professional duty in his district, whether under these Regulations or under the provisions of the Health Act or otherwise, and shall accept in connection therewith such remuneration, if any, as the Principal Medical Officer may decide as equitable.

(j) In districts situated in the North and North-West of the State, except Broome and Carnarvon, the District Medical Officer shall be generally responsible for the management of the hospital in his district, and for the expenditure and revenue in connection therewith.

8. The district of any Medical Officer appointed under these Regulations shall be deemed to extend half-way towards the place of residence of any other medical practitioner (other than those residing in the same town, if any). Such district shall include all points, having regard to means of access by road or rail, to which the Medical Officer of the district is more readily accessible than any other medical practitioner (other than any such residing in the same town, as aforesaid).

9. A District Medical Officer shall be appointed by the Governor, on the recommendation of the Principal Medical Officer. On appointment a District Medical Officer shall sign an agreement in the form provided.

10. In the case only of a District Medical Officer whose appointment dates from prior to 1895, and who is entitled to annual leave, the Department shall pay to a *locum tenens*, during the absence of any such District Medical Officer on leave, subsidy at a rate not exceeding that ordinarily received by such District Medical Officer.

11. If at any time there is no District Medical Officer in any district, or if, from any other cause, the services of the District Medical Officer are not available, the Medical Officer of an adjacent district shall, when called upon by the Principal Medical Officer, or the Resident Magistrate of such vacant district, or by the Commissioner of Police, or by a police officer in cases of emergency, so to do, perform all the duties of District Medical Officer in such district.

12. District Medical Officers shall provide their own means of transport, if transport by rail is unsuitable. Where a District Medical Officer provides his own transport, the Department shall pay to officers stationed in Division 1 mileage at the rate of 2s. per mile one way, and to District Medical Officers stationed in Division 2 mileage at the rate of 3s. per mile one way. The divisions referred to are such as prescribed by Public Service Regulations.

13. District Medical Officers giving their services under Rule 11 shall, in addition to mileage rates, be entitled to subsistence as follows:—Division 1, 15s. per diem; Division 2, 18s. 4d. per diem. One day to mean three meals, and one night away from the usual place of residence: Provided that if return to such usual place of residence be made within nine hours, only one fourth of the daily rate

shall be allowed. The time for meals shall be 8 a.m., 1 p.m., and 6.30 p.m. The time of departure from and return to headquarters shall be shown on the voucher submitted to the Department. When called out of their districts under the provisions of Regulation 11, District Medical Officers shall, in addition to the usual subsistence rates, be entitled to charge at the rate of one guinea for the whole or portion of a day's absence.

14. A District Medical Officer desirous of absenting himself from his district shall first obtain leave from the Principal Medical Officer, and shall make proper arrangements for the performance of his duties during absence: Provided, however, that in cases of emergency the District Medical Officer shall be entitled to temporarily absent himself for the purpose of affording professional service in a neighbouring district, as provided in Regulation 11.

15. District Medical Officers shall not contract any liability, or involve the Department in any expenditure, unless such liability or expenditure, as the case may be, has first been approved by the Department.

HOSPITAL ADMINISTRATION.

16. Except at the Wooroloo Sanatorium and hospitals in the North and North-West of the State, other than at Broome and Carnarvon (see Regulation 7 (j)), the Matron shall be responsible to the Department for the general management of the institution and for the observance of the regulations in connection therewith.

17. *Staff.*—No appointment to the nursing, clerical, or domestic staffs of any hospital shall be made without the authority of the Department, and every change in the staff shall be reported to the Department on the form provided for that purpose.

18. The Matron shall not grant leave to any member of her hospital staff for a longer period than 48 hours without first obtaining the approval of the Department.

19. The Matron shall have power to suspend any officer of the nursing or domestic staff of a hospital for any dereliction of duty, or for misconduct, and a full report of the circumstances attending such suspension shall be forthwith forwarded, in writing, or by telegraph, to the Department.

20. Any officer so temporarily suspended shall be supplied with a copy of the charge, signed by the Matron, and be required to give such reply, in writing, as may be deemed to be his or her defence.

21. Upon receipt of a report of any suspension, the Principal Medical Officer shall, either personally or by deputy, investigate the circumstances. If, upon inquiry, he is of opinion that no offence has been committed, he shall remove the suspension; if the charge be admitted by the accused officer or sustained upon inquiry, the Principal Medical Officer may—

- (a) impose a penalty not exceeding one month's remuneration;
- (b) dismiss; or
- (c) require an officer to resign his or her appointment:

Provided that any officer may (except where the penalty imposed has been less than one pound) appeal to the Minister through the Permanent Head.

22. A suspended officer who voluntarily leaves the district to which he or she is attached, during the period of suspension, shall not be entitled to claim subsistence allowance during such absence, whether the charge be proved or not. A suspended officer shall not be entitled to draw salary during the period of suspension; but in the event of the suspension being removed, the officer shall be paid salary in full.

23. *Cleaning of Wards.*—(a) The wards of the hospital shall be well ventilated, and windows opened according to the state of the weather.

(b) The floors shall be dry-rubbed and cleansed every day; but washed only when ordered by the Matron. The bedding, so far as circumstances permit, shall be shaken and freely exposed to the air every day.

24. *Admission into Hospital.*—Admission into hospitals shall be obtainable only on the order of the Medical Officer in charge, who shall make no charge for an order of admission. In cases of emergency, admission may be secured on the authority of the Matron or other officer in charge of the hospital, or of the Resident Magistrate of the district in which the hospital is situated. The following cases are not to be admitted, except in emergency:—

- (1) Pregnant females for the purpose of confinement (except to a maternity ward when provided).
- (2) Persons suffering from an incurable disease (except temporarily to await completion of arrangements for transport to an institution provided for the reception of such cases), or persons suffering from a disease for which a special institution is provided for their treatment, shall only be detained in hospital sufficiently long to establish diagnosis.
- (3) Persons whom it is possible to treat as out-patients.
- (4) Persons whose admission might endanger other patients (except where wards are provided for the reception of such).

25. (a) On admission every patient, unless too ill to be subjected to the treatment, shall be perfectly cleansed with soap and water, the hair combed or cut, if necessary, the patient supplied with hospital clothing and removed to bed.

(b) In respect also of every patient all necessary particulars shall be obtained and entered in the admission and discharge book. Particulars shall at the same time be obtained, in the form provided for that purpose, regarding the financial position of the patient or those legally responsible for him.

(c) A card showing the name, age, status and religious belief of the patient, the nature of the illness, date of admission and treatment ordered, shall be placed above the bed-head of each patient.

(d) Patients' property and valuables shall be dealt with as prescribed in Regulation 151.

26. Patients suffering from infectious or contagious diseases shall be kept apart from those suffering from other complaints; and bedding used by such infectious or contagious patients shall be thoroughly cleansed, disinfected, and aired before being used again or stored away.

27. Patients shall (unless themselves provided with these necessities) wear the night clothing and linen provided by the Department. The latter shall be changed at least twice, and the sheets of all beds once, in each week, or oftener if necessary.

28. As absolute quiet is indispensable in hospitals, every duty shall be performed with the least possible noise. Patients shall retire for the night by 7 o'clock p.m. in winter and 8 p.m. in summer, and conversation shall not be permitted after the retiring hour, nor any fires or lights left burning except by direction of the Matron.

29. If it is desired to remove a patient from one hospital to any other hospital, the approval of the Medical Officer of such other hospital must be first obtained.

30. *Out-patients.*—Persons treated as out-patients shall be entitled to advice and medicines at hospitals at such fixed hours, daily, as may be determined by the Medical Officer. Those persons able to pay something toward the cost of medicines and dressings shall be liable to do so. (See Regulation 150.)

31. *In-patients.*—In-patients shall obey the directions of the professional staff.

32. Patients may receive visits from friends on Wednesday and Sunday, between the hours of two and four o'clock in the afternoon; but not more than two friends shall be permitted to visit a patient on one day. Visitors on other than visiting days shall be admitted only with the permission of the Matron.

33. No in-patient shall leave his bed or ward without permission.

34. No male patient shall enter the female wards, and no female patient shall enter the male wards without the permission of the Matron.

35. No patient shall smoke in any of the wards or corridors of the hospital, or gamble or swear or use abusive language, or in any way behave improperly, on any part of the hospital premises. If any visitor be guilty of any of the aforesaid offences, or of supplying liquor or provisions to patients, the offender shall be prohibited from visiting the hospital except by the special permission of the Matron or Medical Officer.

36. Any person having cause for complaint shall, within one week after such cause arising, but not later, complain in writing to the Matron, who shall forward such complaint with reasonable despatch to the Principal Medical Officer.

37. Patients or their friends shall not bestow any gratuity whatsoever on any officer or employee of a hospital.

38. The introduction to the hospital of articles of food or drink (without the sanction of the Matron) is positively forbidden.

39. A patient contravening these Regulations may be expelled by the Matron or a Medical Officer, who shall forthwith report such expulsion to the Principal Medical Officer.

40. Patients obtaining passes for leave of absence must return to the hospital by 6 o'clock p.m. Passes are available only for the day of issue.

GENERAL RULES.

41. No officer, servant, or other person attached to a hospital shall on any pretence, directly or indirectly, accept any fee, reward, or gratuity from a patient, nor from a tradesman or other person supplying or desirous of supplying the institution; and any officer, servant, or other person infringing this regulation shall be liable to immediate dismissal.

42. The matron of any of the smaller hospitals connected with the Department shall have authority to vary the hours of duty in all cases in which it shall appear to her that the hours hereinafter defined operate against the smooth or economical working of the institution. Nurses' two hours daily leave shall be fixed by the Matron, as also the afternoon and Sunday leave. Night duty for nurses and an orderly should not be continuous for a longer period than two months.

43. (a) Any member of the nursing staff, or any other employee, who, through sickness or accident, in the opinion of the Medical Officer, needs hospital treatment, shall receive all such treatment as can be afforded at the hospital at which the nurse or other employee is employed.

(b) Application shall be made for any sick leave needed, and such application shall be supported by an adequate medical certificate.

(c) Sick leave with pay may be granted on the following scale:—

Under three years' service—one month on full pay and one month on half-pay.

Over three years' service—two months on full pay: Provided that all sick leave, within the periods named herein, granted to probationer nurses, shall be on full pay.

(d) Sick leave may be granted in one or more periods, but the aggregate amount of leave on pay shall not (except as hereinafter provided) in any one triennial period exceed the time provided for in the foregoing scale.

(e) A triennial period shall be the three years preceding the date of application.

(f) Periods of leave within the foregoing scale may be granted by the Principal Medical Officer, or, if not exceeding two weeks at any time, by an officer to whom such authority is delegated by the Principal Medical Officer.

(g) Where the maximum leave permitted under the foregoing scale is inadequate to meet the circumstances of any case, and where the Principal Medical Officer considers that there are sufficient grounds for so doing, he may make a recommendation, through the Permanent Head, to the Minister, for such extension of sick leave as he deems necessary.

44. Matrons and nurses, domestic workers, and orderlies shall be allowed off duty for one clear day each week.

45. Matrons and nurses shall be entitled to four weeks' holiday after one year's service, and all other employees to a fortnight's holiday, on full pay. All such leave shall be first approved by the Department.

46. Out-of-pocket expenses incurred for meals by officers whilst travelling to a hospital shall be refunded by the Department on receipt of a voucher duly certified by the Secretary of the hospital or the Matron.

47. Laundry work for the nursing staff and resident officers of a hospital shall be done by the hospital staff at the expense of the Department, but nurses and other female employees shall not be entitled to send to the laundry articles of apparel worn while off duty, such as dresses, blouses, etc.

48. A leave of absence book shall be kept, which every officer obtaining leave shall sign, stating the hour of going off duty and the hour of return to the hospital.

49. All communications from the members of the staff of a hospital to the Department shall be forwarded through the Matron.

RESIDENT PHYSICIAN OR SURGEON.

50. Except in regard to appointments made under the Public Service Act, every junior Resident Physician or Surgeon shall be appointed by the Governor on the recommendation of the Principal Medical Officer, made through the Permanent Head to the Minister. Every such junior Resident Officer shall perform such duties at the hospital to which he is attached as may from time to time be prescribed by the Principal Medical Officer or the District Medical Officer.

51. No Resident Physician or Surgeon shall leave the hospital during his hours of duty without having first obtained leave from the District Medical Officer.

52. Except by leave of the District Medical Officer no Resident Physician or Surgeon shall be absent on any night later than 12 o'clock.

53. The Resident Physician or Surgeon shall be responsible for prompt attention on all cases of emergency, and for the proper application of necessary splints, bandages, and dressings to patients suffering from accidents, or who may have been operated upon.

54. In infectious cases, and also in cases considered by him to be serious, the Resident Physician or Surgeon shall immediately report to the District Medical Officer, and in the absence of the Medical Officer he shall take such action as he may deem necessary.

55. The Resident Physician or Surgeon, or the Medical Officer, shall not give a testimonial of conduct or qualification to a member of the nursing staff of a hospital without first obtaining the sanction thereto of the Principal Medical Officer.

56. Misconduct on the part of a Resident Physician or Surgeon shall render him liable to suspension by the District Medical Officer, who shall immediately report thereon by telegraph to the Principal Medical Officer.

THE MATRON.

57. The Matron, who shall be the head of the nursing and domestic staff, shall hold office during the pleasure of the Department, and reside in the quarters provided for her. She shall devote the whole of her time and attention to the duties of the hospital (see also Regulation 16).

58. She shall take entire charge of the domestic arrangements of the nurses and employees, and have full control over the nursing staff attached to the institution.

59. She shall report, in writing, all resignations, vacancies, leave of absence, promotions, and defects in the nursing staff to the Department, and shall furnish half-yearly to the Department a report as to the efficiency or otherwise of the nursing staff.

60. She shall see that all articles of bedding, clothing, etc., are kept in thorough repair, and that all articles of bedding (including mattresses) in use in the wards are frequently changed and regularly aired, and that no bedding which has been in use is stored away without previous airing.

61. She shall exercise strict economy in the use of provisions, medical comforts, fuel and light, and see that order and cleanliness prevail throughout the establishment.

62. She shall visit each ward at least twice every day, carefully supervising all that appertains to the nursing and home departments, or that contributes to the comfort and welfare of the patients, and to the general efficiency of the hospital.

63. She shall see to the daily delivery to the cook of the proper quantities of provisions for the day's consumption, in accordance with the diet scale.

64. She shall issue all clothing, bedding, linen, glassware, crockery, utensils, and appliances for the use of the hospital; and for the care and custody of these she shall be responsible.

65. She shall be responsible for the internal economy and general management of the nurses' quarters, the quality, quantity, and preparation of food, the state of their rooms and the comfort generally of the nurses; and she shall guard, as far as possible, against irregularities in conduct on the part of nurses and employees, such as late hours, absence without leave, objectionable familiarities, and, by the maintenance of a wholesome discipline on her part, inculcate among her subordinates a sense of the responsibilities devolving upon them.

66. She shall be responsible that no ward is left without a nurse, and shall see that all nurses carry out the directions of the Medical Officer relative to the treatment of patients.

67. She shall give such practical and theoretical instruction as may be necessary for the training of nurses, and in addition to the ordinary instruction, shall see that pupil nurses are practically instructed in all branches of cookery for invalids, such as the preparation of beef tea, arrowroot, gruel, mutton broth, puddings, etc.

68. She shall see that the nurses under her charge attend the lectures and other forms of instruction given.

69. She shall during the last year of training of nurses instruct them in the method of keeping the various books and returns provided for in these Regulations.

70. She shall visit the laundry and issue the necessary directions concerning the washing and getting up of the linen, blankets, and other articles, and see that such articles are fit for use before being again used.

71. She shall also issue necessary directions for the making and mending of linen and clothing, and for the proper number and marking of all articles with the name of the hospital. Where no Secretary is employed, the Matron shall also carry out the duties specified herein, as those pertaining to the position of Secretary.

72. At any hospital at which no Secretary is employed, the Matron shall, *mutatis mutandis*, perform the duties of Secretary as prescribed in these Regulations (see Regulations 73 to 96).

SECRETARY.

73. The Secretary of a hospital shall be directly under the control of and responsible to the Department, and shall not engage directly or indirectly in any business or profession, unless by special permission of the Public Service Commissioner in writing.

74. On his appointment he shall provide a fidelity bond in such amount as may be decided by the Colonial Treasurer, that he will account in proper manner for all public moneys received by him.

75. He shall see that all the regulations relating to the admission of patients, and having relation to the collection of fees from patients, are duly observed, and he shall be responsible for supervising the work of the collector, and for seeing that reasonably good results are achieved.

76. He shall conduct the correspondence, and shall have charge of all documents relating to the hospital; and shall keep in the form laid down by the Department the books, forms, and accounts of the hospital correctly and in such manner as will permit of ready reference; and shall submit his accounts to an officer from the Department when required to do so.

77. He shall keep copies of all letters written, and shall file all letters received on the business of the institution, and shall execute all orders he may receive from the District Medical Officer or the Principal Medical Officer.

78. He shall receive all moneys paid as fees at the hospital and, after entering particulars of same in the cash-book, shall dispose of such money in the manner provided in the Regulations.

79. (a.) He shall record in the Admissions and Discharges Register full particulars of each patient.

(b.) He shall receive all property and moneys from patients on admission and enter particulars thereof in a book to be kept for the purpose, giving the patient a receipt therefor; on the discharge of the owner he shall return the same, taking a proper receipt.

80. He shall upon admission of a patient, or as soon as possible afterwards, ascertain whether or not the patient is in a position to pay hospital fees.

81. He shall obtain accounts in duplicate, covering a calendar month, from contractors and tradesmen supplying the hospital.

82. He shall stamp the back of all accounts so received with the hospital stamp and the date of receipt from the contractor.

83. He shall carefully examine all tradesmen's vouchers, and shall certify to their correctness, in the terms of Section 33 of the Audit Act.

84. He shall note all accounts received in a book kept for that purpose, and shall forward the original accounts to the Department as soon as possible after receipt, retaining the duplicate copy in his own office.

85. He shall be responsible for the furniture, clothing, bedding, linen, glassware, crockery, cutlery, cooking and kitchen utensils while in store.

86. He shall quarterly (in the first week in March, June, September, and December), and on the form provided, requisition to the Department for such articles as may be required at his hospital for the ensuing quarter.

87. He shall order in writing on requisitions provided for the purpose, and receive the daily supply of stores from contractors and tradesmen; shall see that these correspond in description, quality, and quantity with the tenders and orders; he shall be responsible for the due issue of same.

88. He shall not obtain stores from any person other than those under contract to supply, except by direction in writing of the Department.

89. He shall prepare daily a diet roll showing the number of patients on each diet for the day under review.

90. He shall not lend any official books or papers belonging to the hospital, nor permit their removal or inspection without the express permission of the Department.

91. He shall obtain authority from the Department for necessary urgent repairs, and shall supervise the progress of any works; he shall also see that all fittings and appliances are efficient.

92. He shall be responsible to the Department for the cleanliness and order of all parts of the hospital grounds.

93. He shall, when practicable, instruct the male employees in hose practice and the use of fire extinguishing appliances, and in the event of fire shall assume command until the arrival of the fire brigade.

94. He shall be responsible for the due observance of these Regulations, and shall report to the Department, in writing, any misconduct or breach of these Regulations by any member of the hospital staff under his control.

95. He shall keep the following books, etc.:—

Admissions and Discharges Register.

Cash Book.

Fees Ledger (Card system).

Patients' Property Book.

Visitors' Book.

Records of Accounts passed to Head Office.

Stimulants Book.

96. He shall furnish the following to the Department:—

Monthly Return of Patients, etc.

Change of Staff (immediately it occurs).

DISPENSER.

97. The Dispenser shall be in attendance at the hospital from 8.30 a.m. until 5 p.m., and at any other hour at which his services are required by the Medical Officer.

98. He shall have charge of the dispensing utensils, medicines, sera, dressings, etc.; shall examine all drugs and chemicals brought into the hospital, both as to quality and quantity, and shall report any defect in either respect to the Medical Officer; he shall be responsible for all medicines and other articles entrusted to his care.

99. He shall prepare and sign quarterly (March, June, September, and December), on the form provided, a requisition for all drugs and sundries required for the ensuing three months in his hospital.

NURSING SISTERS.

100. Sisters shall be appointed by the Department, on the recommendation of the Matron, and shall be held responsible to her for the efficient nursing of the patients and the good order and cleanliness of the wards.

101. A sister shall reside in the quarters allotted to her, and when on duty shall wear such distinguishing dress as the Department may direct.

102. She shall not be absent from the hospital after 10.30 p.m., nor leave the wards during her hours of duty, except by permission of the Matron.

103. She shall at no time leave the wards without placing a qualified nurse in charge.

104. She shall be careful before going off duty to give the nurse in charge all necessary instructions, in writing, concerning any patient requiring special care and attention.

105. She shall have the control, when on duty, of the nurses and servants in her wards, and shall report to the Matron if the duties are not performed punctually and efficiently.

106. She shall be responsible to the Matron for the efficient training of probationers in all practical details of their work, both medical and surgical, and shall report to her thereon from time to time, as required.

107. A sister shall perform such duties in the wards, and about the hospital, as the Matron may require; she shall obey all orders and instructions issued by the Matron, and shall obey every specific direction, relating to any patient, issued by a Medical Officer.

THE NURSES.

108. Every nurse shall perform such duties as are allotted to her by the Matron. She shall obey all instructions and directions of the Matron, and in all respects shall be under the authority of that officer.

109. Their hours of duty shall be such as may from time to time be arranged by the Matron. All nurses are required to keep their sleeping apartments neat and clean, and make their own beds.

NIGHT NURSES.

110. (a.) The hours of duty of a night nurse shall be such as may from time to time be arranged by the Matron.

(b.) She shall preserve order in the wards during the night. She is not permitted to sleep, lie down, or leave the wards during the night, except for urgent reasons.

(c.) She shall, on entering on duty for the night, receive from the day nurse, verbal or written instructions concerning the patients. In case of emergency, she shall inform the Matron. The subdivision of duties assigned to nurses shall be arranged by the Matron.

(d.) She shall pay particular attention to the state and symptoms of the patients, visiting them frequently, and administering medicines and stimulants at regular intervals, and in the manner prescribed.

(e.) She shall see that the lights are kept low, and turned off at daylight.

(f.) Before leaving the wards she must report to the Charge Nurse as to the state of the patients, especially as regards cases of a serious nature, and everything in the wards must be left in perfect order.

NURSE PROBATIONERS.

111. Probationers shall be engaged by the Department and discharged on the recommendation of the Matron. A probationer shall not be under eighteen years of age, and shall continue on trial for one month without pay, at the expiration of which, if found satisfactory, she shall be required to sign an agreement to remain in the employment of the Department for a period of four complete years of training, unless in the matter of ability or conduct she is found to be unsatisfactory, in which event, on the recommendation of the Matron, her agreement may be cancelled by the Department.

112. (a.) Probationers shall be respectful and obedient to those in authority, and, without hesitation or comment, carry out the duty assigned to them by the Matron or Sister under whom they are placed.

(b.) They shall wear, when on duty, such distinguishing dress as the Department may direct.

113. They shall, when on duty, be under the more immediate control of the Sister or Nurse in charge of the ward in which they are placed, and during their second year may be required to take night duty, or at any time, if in the opinion of the Matron they are competent to do so.

114. Their hours of duty shall be arranged from time to time by the Matron, and, when on duty, they are not to leave their wards except by permission of the Sister or Nurse, or to engage in any private work whatever. *No Nurse or probationer shall be permitted to see friends when on duty.*

115. They shall make the beds of the patients in their respective wards, and be ready to assist, wash, and feed infirm and helpless patients, and see that those able to assist themselves are supplied with washing materials before leaving the wards. They shall see that everything is in readiness for the Night Nurse in accordance with the instructions of the Sister or Nurse, and they must relieve each other punctually at the hour appointed.

116. They shall act under the Sister or Nurses, and assist them, when required, in all departments of their work. They shall assist in keeping the wards and ward furniture clean, and in its proper place, and, when necessary, assist

in fetching patients' food from the kitchen. They shall, during the afternoon, take messages and fetch articles from the dispensary. All other matters relating to details of their work shall be arranged by the Matron.

117. They shall be subject in all matters of discipline to the same regulations as the nurses. When off duty, they are not to enter the wards without permission, and they are not to loiter about the lobbies or corridors.

118. They shall be required to attend courses of lectures and instruction, during their probation, in accordance with the regulations prescribed under the Nurses' Registration Act.

119. On completing her engagement, and provided she has successfully passed the necessary examinations, a probationer shall be entitled to receive a certificate of training issued by the Department.

120. The names of probationers shall be entered in a register, in which also shall be kept a record of their conduct and qualifications, and such record shall be treated as a confidential document and retained by the Matron. On completion of the period of training, probationers who have passed satisfactorily through the course of instruction and examination shall apply for registration under the Nurses' Registration Act.

121. At the expiration of one month from the date of entry, every probationer shall be required to write a letter to the following effect:—

"To the Principal Medical Officer, Perth.

"Having been a month at.....Hospital, I have a general idea of the duties of a Hospital Nurse. I am able and desire to continue training as a probationer Nurse at any Hospital under the control of the Medical Department, where directed from time to time, for a period of four years."

ORDERLIES AND OTHER MALE EMPLOYEES WHOSE DUTIES ARE NOT OTHERWISE ENUMERATED HEREIN.

122. Orderlies and other male employees shall carry out the instructions of and perform such duties as may be given by the Medical Officer, Matron, Secretary, Sister or Nurse, as the case may be. They shall be liable to immediate dismissal by the Matron or Secretary for insobriety, wilful disobedience of orders, incapacity, or other gross misconduct.

WARDSMAIDS, HOUSEMAIDS, COOKS, LAUNDRESSES, AND OTHER FEMALE EMPLOYEES WHOSE DUTIES ARE NOT OTHERWISE ENUMERATED HEREIN.

123. The above-named employees shall be directly under the authority of the Matron, and shall carry out such orders as they may from time to time receive. They shall be appointed subject to the condition of liability to immediate dismissal by the Matron for insobriety, misconduct, or wilful disobedience of orders. Wardsmaids shall carry out the orders of the Nurse in charge of a ward.

MINISTERS OF RELIGION.

124. Every Minister of Religion who visits a hospital shall confine his visits to patients of his own denomination, unless his services are specially requested by any patient of another denomination, and shall, except in cases of emergency, make such visits between the hours of 2 and 4 p.m.

125. Every such minister shall perform the duties of his office at the bedside of the patients in such a way as to be as little overheard as possible by the surrounding patients.

126. No person shall read aloud, or conduct religious service in the sick wards of the hospital.

127. Clergymen and other visitors must retire from the bedside if requested to do so by a Medical Officer, Matron, or Nurse.

COLLECTION OF HOSPITAL FEES.

Introductory.

128. The following Regulations are to be observed by District Medical Officers, Secretaries, Matrons, Collectors, and other officers in the service of the Department who, by virtue of their appointments, become subject to the operation of "The Audit Act, 1904," and the Regulations thereunder.

In the following Regulations the word "Officer" means and includes District Medical Officer, Secretary, Matron, or Sister in charge.

District Medical Officers at places in the North and North-West of the State, except Carnarvon and Broome, are hereby charged with the duty of seeing that the Regulations are carried out at hospitals under their control; at Kalgoorlie, the Secretary is so charged, and at all other places the duty shall devolve upon the Matron.

ADMISSION.

129. (a.) Every patient admitted into hospital shall have his or her name entered in the Admission and Discharge Book, which shall be numbered consecutively. A similar entry shall then be made on the Monthly Return, which shall be drawn up in duplicate by using carbon paper.

(b.) A Ledger Card, in the form provided, shall also be drawn up, showing the number given in the Admission and Discharge Book.

(c.) If the physical condition of a patient permits, and he is in a position to pay any sum of money in advance, on account of the cost of treatment, he should be urged to do so.

(d.) All available information respecting the financial position of the person responsible for the maintenance fees shall be obtained on the form provided for the purpose, and then entered on the Ledger Card. If necessary, further information shall be obtained during the patient's period of hospital treatment, so that upon discharge the officer shall be possessed of correct knowledge of the patient's financial position.

SCALE OF CHARGES.

130. The scale of fees for patients shall be as set out in Schedule A.

A copy of the scale of charges shall be conspicuously posted at the entrance to the hospital and in each ward.

In each hospital printed cards are to be placed in conspicuous positions directing patients that fees are only payable at the hospital or to the authorised collector, and that in every instance a receipt must be given on the printed form of the Department.

ADMISSION OF PRIVATE CASES TO HOSPITALS.

131. Where private wards are provided, patients may be accommodated therein and shall sign an agreement to pay private ward rates, the fact being indicated against the entry in the Admission Register.

DISCHARGE FROM HOSPITAL.

132. (a.) While hospitals are established for the care and treatment of the sick, regardless of financial position, and while there is no question of the best possible treatment being given gratis to a patient who can pay nothing, nevertheless the settled policy of the Department is that any patient who can reasonably pay the whole or a portion of his hospital debt is expected to do so. Even if payment can only be made by small instalments, then such payment is expected.

(b.) When a patient does not pay in full upon discharge, the officer shall make full inquiry respecting the person responsible, and shall decide the terms of payment to be agreed upon; the form known as Form H shall then be filled in, in triplicate, and signed by the responsible person (or some other person authorised by him), who shall receive the duplicate copy, which shall show all payments made on account.

(c.) If, in the opinion of the officer, an account owing by a patient is a debt which should be handed to the collector for collection *at once*, the original shall be so handed to him; otherwise, if payment by a patient appears to be probable, then the account should be handed to the collector after a period of grace, to be determined by the officer, *but not exceeding 28 days*. When any account is handed to the collector full particulars of the debtor's circumstances should be given him, and those facts and the date of passing the account to the collector must be recorded on the Ledger Card.

(d.) The fact should be impressed on patients that any failure to comply with the terms of their agreements will be followed by legal action.

(e.) If, subsequent to the signing of the agreement, a patient finds himself unable to comply with its terms, he must at once communicate with the officer of the hospital, who may re-arrange the terms as he thinks fit.

(f.) If the officer of the hospital is satisfied when discussing the terms of payment to be inserted in Form H (paragraph (b)), or when later discussing terms of payment (paragraph (e)), that the whole or a portion of the debit of any patient should be written off, then he should make a recommendation to the Department accordingly, at the same time giving full reasons for such recommendation.

(g.) Patients must notify the hospital of any change of address.

REFUSAL TO SIGN FORM "H."

133. Should a patient refuse to sign Form "H," then Form "I" shall be used. If the officer is satisfied that recovery of the cost of treatment cannot otherwise be promptly effected, the Form "I," together with all available information that will assist in the collection shall be sent to the Department and the fact noted on the Ledger Card.

EMPLOYMENT OF COLLECTORS.

134. Collectors may be employed by the Department, the remuneration to be by commission on moneys collected, at a rate mutually agreed upon, employment being determinable by either party at will. Appointments of collectors shall be made by or approved at the Head Office of the Department.

DUTIES OF COLLECTORS.

135. The Collector shall keep a suitable record of the accounts in his hands and shall show thereon the action taken by him to collect. The Collector shall use every means in his power to as promptly as possible recover every debt placed in his hands for collection. Form "D" shall be used by him in every case where a considerable period occurs between the patient's discharge from hospital and the due date of the first instalment. Should an instalment not be paid on its due date, the Collector shall send to the patient Form "D1."

The Collector may use his own business note-paper or any forms approved by the Department.

136. When accounts are transferred to Head Office for action, a record shall be left at the hospital on the form provided for that purpose, and shall be available to the Collector for his information.

137. The Collector shall report to Head Office on any account lying dormant, or any account in respect of which action other than by the Collector is needed.

138. The Collector's records shall be open for inspection by the Secretary of the Department or any officer appointed

to inspect hospital records, as well as the local officer (*e.g.*, the Matron). Should any such officer consider the position to be unsatisfactory, he shall report to the Department.

139. For all moneys received, the Collector shall give a receipt on the form supplied for that purpose.

DISPOSAL OF MONEYS BY COLLECTOR.

140. All moneys received by the Collector shall be paid directly to the hospital in cash.

The Collector shall, *at least weekly*, hand to the officer of the hospital his receipt book, together with all sums he has collected. The officer shall then furnish a receipt for the total amount thereof and initial the last butt of the Collector's receipt book; at the same time noting the numbers and dates of the receipts issued by the Collector in order to show such numbers subsequently on Treasury Form 2 (Cash Book).

IF NO MONEYS COLLECTED—PROCEDURE.

141. When no moneys are received by the Collector during a period of one month, he shall produce his receipt book to the officer, who shall initial it, noting the date.

COMMISSION ON SUMS COLLECTED.

142. Commission may be claimed, according to the terms of a Collector's appointment, upon all amounts collected by him, and on payments on account of debts placed in his hands for collection, whether made to himself or to the hospital or the Department.

Collectors shall claim commission monthly, on Treasury Form 10. The claim shall be submitted to the officer of the hospital, supported by Form "E," detailing payments in respect of which commission is claimed; the whole to be checked, certified by the officer, and forwarded to Head Office. A collector shall not deduct his commission from any amounts collected.

The Collector shall not have access to the hospital books, but may obtain necessary information from the officer.

MONEYS PAID AT HOSPITAL.

143. For all moneys received at the hospital a receipt is to be given on the proper form provided for that purpose.

When moneys are paid at the hospital on accounts which are in the Collector's hands, he shall be so informed when claiming his commission, provided the Collector shall have satisfied the officer that he has taken steps to secure the payment of the same.

DISPOSAL OF MONEY BY HOSPITAL AUTHORITIES.

144. All moneys received at the hospital, whether from the Collector, or from patients direct, shall be disposed of as prescribed from time to time by Treasury Regulations. (The procedure below is authorised until further notice.)

(a.) Details of payments shall be entered from the Receipt Book into the Cash Book. The books being in duplicate form, a carbon sheet is to be used so that an exact copy may be obtained.

(b.) In places where a bank exists, the receipts, as shown by the Cash Book, are to be paid into the bank at least weekly to the credit of the "Colonial Treasurer, Commonwealth Bank, Perth." In places where no banking facilities exist, the amount shall be paid to the Local Treasury Cashier.

(c.) In either case the duplicate of the Cash Book, together with the bank or Treasury Cashier's receipt, is to be immediately forwarded to the "Under Treasurer, Perth."

CASH BOOK.

145. The Cash Book is to be totalled at each banking day, and the amount carried forward to the 25th of each month (June excepted, for which read 30th). The total amount will represent the collections for the month.

All moneys received, from whatever source, at the hospital, except patients' private cash (see Regulation 151), shall be entered in the Cash Book, together with the date of payment, number of receipt, name of patient, and the number in the Admission Book.

FEES LEDGER (CARD SYSTEM).

(To be kept by Secretary or Matron.)

146. (a.) On the admission of a patient, the procedure specified in Regulation 129 shall be followed.

(b.) Upon the discharge of a patient, the date shall be entered in the Admission and Discharge Book, and on the Monthly Return, on which shall also be entered the rate and the amount of the debit (see Schedule A). The discharge date, rate, and amount of debit shall be entered on the Ledger Card, on which shall also be entered from time to time the date, the cash sheet number, and the amount of every payment on account of the fees debited thereon.

(c.) Overpayments of fees shall not be brought to account in the Fees Ledger, but only in the Cash Book, as "Donations."

BAD DEBTS TO BE WRITTEN OFF FROM TIME TO TIME.

147. (a.) In respect of hospitals in the North and North-West, the officer shall from time to time make recommendation to Head Office for the writing off of any debt which, after all local inquiry, he considers to be hopeless of collection, Form "F" being used.

(b.) When authority has been received through the Department for writing off a debt, the date of the advice, and the words "written off," are to be written in, and the amount entered in the credit column of the Fees Ledger Cards. The advice is to be filed securely.

PAYMENTS DIRECT TO DEPARTMENT.

148. When payments are made direct to Head Office on behalf of a hospital, advice will be sent to the officer of the hospital monthly on Form "K." On receipt of the advice the amount is to be entered in the credit column of the Fees Ledger with the date of payment, and the word "Head Office." The advices shall then be filed in consecutive order.

SURGICAL OPERATIONS.

149. A Register shall be kept of all surgical operations performed at the hospital. When it is the opinion of the officer that the patient can reasonably afford to pay the Theatre Fee (vide Schedule A), such fee shall be included when the debit for maintenance is being raised on the Monthly Return, and shall be shown on the debtor's card and on the "H" Form.

A Theatre fee for a minor operation on an out-patient may be charged, and when so charged an entry shall be made on the Monthly Return—similar to the entry made for an in-patient—and a general "Out-patient's Ledger Card for Theatre Fees" shall be drawn up instead of a separate Form for each.

OUT-PATIENTS' FEES.

150. (a.) Out-patients shall be liable to pay such fees as the Matron considers justified in each case, having in view the extent of treatment given and the patient's financial position.

(b.) Payment under the foregoing paragraph shall be made in cash by the patient, and for every such payment the Matron shall issue receipts of an equivalent amount in the form of "out-patients' chits" as provided.

(c.) All moneys received under this regulation shall be brought to account in the Cash Book (Regulation 145) and disposed of as provided for in Regulation 144.

PATIENTS' PRIVATE CASH AND VALUABLES.

151. (a.) When the Secretary or Matron receives from a patient private cash or valuables for safe keeping, a receipt in the form provided shall be given to the patient. When these articles are returned, or when any cash is re-issued to a patient, a receipt shall be obtained on the duplicate of the above-mentioned form.

(b.) The receipt for any valuables or cash handed over by the officer must be signed (a) by the patient, (b) by some person authorised in writing by the patient, such authority being retained in the Patients' Property Book, or (c) in the event of death, by the Curator of Intestates' Estates (or his agent), or by the executor (or his agent).

(c.) For the purpose of holding patients' private cash, an account shall be opened by the Secretary or Matron in his or her own name with the State Savings Bank (or Commonwealth Savings Bank, if no branch of the State bank is available).

(d.) Patients' private cash shall, from time to time, be paid into the Savings Bank account before-named, except in the case of small sums held on behalf of patients liable to remain in hospital for a few days only.

(e.) At hospitals in the North and North-West, any cheques or orders forming part of a patient's cash should not be paid into the Savings Bank account, but held and returned in due course to the patient concerned.

(f.) Before refunding to any patient his private cash, a portion of which has been made up by a cheque, duly paid into the bank (paragraph (d)), the officer must satisfy herself that the value of the cheque has been duly honoured and placed to credit of the account.

(g.) Any interest credited on the Savings Bank account shall from time to time be withdrawn and credited to Revenue (Regulation 144).

A By-law of the Municipality of the City of Perth, made under Section 179 of "The Municipal Corporations Act, 1906," and numbered 2, for the regulating of the standing of licensed vehicles.

In pursuance of the powers conferred by the said Act, the Mayor and Councillors of the City of Perth order that Parts 1 and 2 of Schedule "B" be repealed, and the following substituted in lieu thereof:—

Schedule "B."

The owners and occupiers of all holdings within the district of the Board, except Townsites, shall commence the work of destroying rabbits on such holdings and upon the roads bounding or intersecting the same, on or before 1st November, 1924, and shall continue and systematically carry out the said work until 1st May, 1925.

The means to be adopted for carrying out the said work shall be as follows:—

Not less than two (2) miles of furrow, with poison baits not more than four yards apart, must be done weekly for each 1,000 acres or part thereof, owned or occupied.
