WHEREAS by "The Transfer of Land Act, 1893, Amendment Act, 1896" (60 Vict., No. 22), the Governor is empowered, by proclamation in the *Government Gazette*, to vest in His Majesty, as of his former estate, all or any lands whereof His Majesty may become the registered proprietor: And whereas His Majesty is now the registered proprietor of portion of Williams Location 2587, registered in the Office of Titles in Volume 477, Folio 85: Now therefore I, the said Governor's Deputy, with the advice and consent of the Executive Council do by this Proclamation vest in His Majesty, his heirs and successors, portion of Williams Location 2587 aforesaid, as of his former estate.

*Water Boards Act, 1904.**Narrogin Water Area.*

ORDER IN COUNCIL.

P.W.W.S. 732/24.

WHEREAS by "The Water Boards Act, 1904," it is provided that before undertaking the construction of water works, the Minister shall submit plans, descriptions, books of reference, and estimates of the proposed works to the Governor for approval; and if they are

approved the Governor may forthwith, by Order in Council, empower the Minister to undertake the construction of the proposed works: Now, therefore, His Excellency the Governor, with the advice of the Executive Council, hereby approves of the plans, descriptions, books of reference, and estimates marked P.W.D., W.A., 23568, for the construction of water works within the Narrogin Water Area, which were duly submitted for approval, and hereby empowers the Minister for Water Supply, Sewerage, and Drainage to undertake the construction of the said works.

Stock Diseases Act, 1895.

ORDER IN COUNCIL.

WHEREAS His Excellency the Governor, by Orders in Council dated the 27th day of August, 1924, and the 18th day of September, 1924, did, in exercise of powers conferred by "The Stock Diseases Act, 1895," prohibit the introduction or importation of cattle into Western Australia from the States of New South Wales, Victoria, South Australia, and Queensland subject to the conditions therein specified: And whereas it is considered that the qualified prohibition hereinafter set forth regarding the importation of stock from South Australia is necessary and will be sufficient to prevent the disease of pleuro-pneumonia extending to the State of Western Australia, and it is accordingly deemed expedient to re-

voke the before-mentioned Orders in Council in so far as they apply to the State of South Australia and to substitute in lieu thereof, so far as regards that State, the provisions hereinafter set out: Now, therefore, His Excellency the Governor, acting by and with the advice and consent of the Executive Council and in pursuance and exercise of the powers and authorities contained in the said Act and any other powers him in this behalf enabling, doth hereby order and declare the said Orders in Council dated the 27th day of August, 1924, and the 18th day of September, 1924, shall cease to apply to the State of South Australia, and in lieu thereof doth prohibit (for a period of twelve calendar months from the date of the publication of this Order in Council in the *Government Gazette*) the introduction or importation into Western Australia from the State of South Australia of any cattle excepting:

- (1) Stud stock accompanied by a certificate from the Chief Veterinary Officer of the State of South Australia that such stud stock are from clean herds and have not been in contact with diseased stock for a period of at least six months.
- (2) Cattle transported by railway direct to the Kalgoorlie Abattoirs for immediate slaughter and under such conditions that the hooves of such cattle do not touch ground outside of such abattoirs, and provided that the cattle to which this exception applies shall be accompanied by a certificate issued by an Inspector of Stock in South Australia that such cattle are free from disease.

The Metropolitan Water Supply, Sewerage, and Drainage Act, 1909.

ORDER IN COUNCIL.

M.W.S. 47/25.

WHEREAS by "The Metropolitan Water Supply, Sewerage, and Drainage Act, 1909," it is provided that, subject to the provisions of the Act, the Minister of Water Supply, Sewerage, and Drainage shall, with the approval of the Governor, have power to construct and extend Waterworks, Sewerage Works, and Stormwater Drainage Works; and whereas it is further provided that the Governor may exempt reticulation works from certain sections of this Act: Now, therefore, His Excellency the Governor, with the advice of the Executive Council, hereby approves of the construction and extension by the Minister of Water Supply, Sewerage, and Drainage of the following works under the said Act, and does hereby exempt such works from the operations of Sections 20, 21, 22, and 23 of the said Act:—

Description and Location of Reticulation Works approved and exempted.

CITY OF PERTH.

Victoria Park Ward.

Metropolitan Reticulation Main Extension.

Proposed 4in. diameter cast-iron water main, commencing from end of existing main at Lot 268, Salehan Street, and proceeding South-Easterly to Goddard Street; thence North-Easterly along Goddard Street to Howick Street; thence proceeding North-Westerly along Howick Street to Lot 291 (total length 29½ chains), together with valves, hydrants, and all necessary connections and apparatus, as indicated in red on Plan M.W.S., S. & D.D., W.A., No. 4361.

This Order in Council shall take effect from the seventeenth day of February, 1925.

Reciprocal Enforcement of Judgments Act, 1921.

ORDER IN COUNCIL.

WHEREAS by Section 8 of "The Reciprocal Enforcement of Judgments Act, 1921," it is enacted, among other things, that where the Governor in satisfied that reciprocal provisions have been made or are about to be made by the Legislature or other competent authority of any part of His Majesty's Dominions outside the Commonwealth and outside the United Kingdom, for the enforcement within that part of His Majesty's dominions of judgments obtained in the Supreme Court of this State, the Governor may, by Order in Council, declare that the said Act shall extend to that part of His Majesty's Dominions: And whereas the Governor

is satisfied that the Legislature of the Straits Settlements Colony is about to make such reciprocal provisions: Now, therefore, His Excellency the Governor, acting by and with the advice and consent of the Executive Council, and in pursuance and exercise of the powers and authorities conferred on him by Section 8 of "The Reciprocal Enforcement of Judgments Act, 1921," doth hereby declare that the said Act shall extend to the Straits Settlements Colony.

By-laws to provide Restrictions as to Hawkers.

1. No person shall hawk any fruit, fish, vegetables, or any article of merchandise within any part of the district without having first obtained a license from the Board.

2. Any person who travels and trades on foot or with any vehicle or animal, or otherwise carrying to sell, or expose, or offer for sale, within the district aforesaid any of the articles or things aforesaid, shall be deemed to hawk the same.

3. No person shall keep, manage, or conduct a movable or temporarily fixed stall in or near any street for the sale of any meat, fruit, vegetables, drink, eatables, or articles of merchandise, unless such person be licensed.

4. Licenses for hawkers shall be in the Form "X" of the Schedule, and for stalls in the Form "Z" in the Schedule.

5. Every hawker while employed in hawking shall produce his license upon being required by any constable, or officer of the Board, and shall at all times have affixed to some conspicuous part of his coat, barrow, basket, or vehicle, a board or plate bearing his name and the words "Licensed Hawker" legibly printed thereon in letters not less than one inch in length.

6. No licensed stall shall be placed or allowed to stand in any street or position other than that mentioned in the license, or between the hours of 8 p.m. and 4 a.m.

7. The following fees shall be paid for licenses to hawkers, or stalls, and shall be paid in advance on the first Monday in every month, and if any fees be not paid when due the license shall be void.

Fees for Hawkers' Licenses.

For every hawker with hand basket, or tray, 1s. per month.

For every hawker with barrow, or handcart, 1s. 6d. per month.

For every hawker with vehicle drawn by a horse or other animal, 2s. per month.

For every hawker with motor vehicle, 5s. per month.

Stall Licenses.

For every stall, 5s. per month.

8. Every licensed hawker and stall-holder shall at all times obey the lawful directions of the Secretary, or any authorised officer of the Board.

9. No person to whom hawkers' or stall-holder licenses is granted shall lend, transfer, or assign his license, and no person shall borrow or make use of any such license granted to a person other than himself, unless by written consent of the Secretary.

WHEREAS by Section 295 of "The Health Act, 1911-1919," it is provided that the Governor may cause to be prepared Model By-laws for all or any of the purposes for which By-laws may be made by a Local Authority under any of the provisions of the said Act, and that a Local Authority may of its own motion by resolution adopt the whole or any part of such By-laws: And whereas Model By-laws have been prepared in accordance with the provisions of the said section and published in the *Government Gazette* on the 20th November, 1914: Now, therefore, it is resolved and determined by the Mayor and Councillors of Collie, being a Local Health Authority within the meaning of the said Act, that subject to the following amendment, the whole of such Model By-laws be adopted for the District of Collie.

Amendment: That Clause 29 of Part VIII. of such Model By-laws is repealed, and the following be substituted in lieu thereof:—

Meat.

29. (1.) Every occupier of premises where meat shall be kept for sale shall cause such meat to be protected from contamination from flies or dust by one of the following methods: (a) By causing all such meat to be kept in enclosures covered by glass or fine wire mesh gauze, or (b) by covering all doors and window openings and other apertures on the premises with screens or fine mesh wire gauze and by fitting all doors so that they are self-closing. Every such occupier shall at all time maintain the fittings provided under this subclause in good repair and order.

(2.) No person shall transport or carry meat in any vehicle unless such meat is completely covered with clean canvas or other approved wrappings, in such manner as to completely protect such meat from flies and dust. (a) No meat shall be transported or carried in any vehicle unless such vehicle is covered and is provided with efficient ventilation. (b) No vehicle used in the transport of meat shall be at any time used in the transport of any offensive matter. (c) No meat shall be carried on any railway except in trucks provided for that purpose, or unless such meat is hung on hooks and is clear of the floor. (d) Any person engaged or employed in the transport or delivery of carcase meat within the district shall, at all times when so engaged, wear a cap which shall be constantly covered with detachable cover made of washable material, and he shall wear overalls of washable material which shall completely cover his clothes. He shall cause such covering and overalls to be kept thoroughly clean.
