Alteration of Boundaries of Maylands Health District under the provisions of "The Health Act, 1911-19."

ORDER IN COUNCIL.

WHEREAS it is enacted by Section 19 of "The Health Act, 1911-19," that the Governor may alter the boundaries of any Health District constituted by the Governor under the said Act: And whereas it is desired to alter the boundaries of the Maylands Health District which was so constituted: Now, therefore, His Excellency the Governor of Western Australia, by and with the advice of the Executive Council, does hereby alter the boundaries of the said Health District in manner following, that is so say:—

Pearling Act, 1912-1924.

ORDER IN COUNCIL.

1550/25.

WHEREAS by Subsection 5 of Section 33 of "The Pearling Act, 1912-1924," it is provided that when the remuneration to which a diver or other pearl-fisher employed in pearling in connection with any ship consists wholly or in part of an allowance or lay calculated with reference to the quantity of pearl-shell or pearls fished by him or with his assistance, then the right to such allowance or lay shall be deemed to be a right to share in the results or proceeds of pearling within the meaning of the said section, unless the allowance or lay is calculated on such basis as shall be prescribed and at a percentage not exceeding the prescribed percentage: And whereas it is desirable to prescribe the basis and maximum percentage on or at which such allowances or lay as aforesaid shall be calculated with reference to the pearls fished or found: And whereas power is given to the Governor by the said Act to make regulations with regard to various matters: Now, therefore, His Excellency the Governor, acting with the advice and consent of the Executive Council, doth hereby in exercise of all powers him in this behalf enabling, make the following regulations, that is to say:

1. Such allowances or lays as are referred to in Section 33 of "The Pearling Act, 1912-1924," shall be calculated with reference to pearls fished or found on the basis of the actual values of such pearls at a maximum percentage of ten per centum on such values and that when such allowance or lay as aforesaid is paid to more than one pearl-fisher on any pearling ship the aggregate of such allowances or lays shall not exceed the amount which would be payable to one person in accordance with the foregoing provision.

2. After the termination of the engagement of a pearl-fisher, the owner of the pearling ship on which such pearl-fisher was engaged shall at or before the time of the discharge of the pearl-fisher, produce and show, or cause to be produced and shown to the Superintendent, any wages accounts in the possession, custody, or power of himself or any agent of his, relating to or connected with the employment of the pearl-fisher during the said engagement. Any contravention by act or omission of the provisions of this regulation shall be an offence punishable on summary conviction by a penalty not exceeding £20.

By-laws.

HIS Excellency the Governor in Executive Council has been pleased to approve of the following By-laws under Section 14 of “The Cemeteries Act, 1897” (61 Vict., No. 23), for the management of the Chowerup Cemetery (Reserve 18904).

Under Secretary for Lands.

By virtue of the powers vested in them the Board of Trustees make the following By-laws and Regulations:—

1. All fees and charges payable to the Trustees, as set forth in Schedule “A,” are to be paid at the time when the applications are made or orders given.

2. Any person desiring ground in the Cemetery for any grave, private grave, vault, or tombstone, monument or enclosure, or for any other purpose, shall make application therefor on prescribed form. Upon such application being approved of the Trustees shall cause to be issued to such person so applying a Certificate of Right of Burial in the form specified in the Act (*see* Schedule “B”).

3. All applications for interment shall be made at the office of the Trustees in time to allow of at least five (5) working hours, notice being given to the Secretary at the Cemetery prior to the time fixed for burial, otherwise an extra charge shall be made. No free interment shall be allowed unless the application and order therefor be handed in at the office in time to allow of at least six (6) working hours' notice being given as above.

4. The name, age, late place of residence, probable cause of death of deceased, and any other particulars mentioned in Schedule “D,” shall be furnished at the time of giving the order.

5. The Trustees shall cause all ordinary graves to be dug, but any person requiring a brick grave or vault shall be permitted to construct the same under the supervision of the Secretary, after submitting a plan of same and obtaining a written approval of the Trustees thereto, and on payment of the necessary fees; and every coffin placed therein shall be bricked in, cemented, and covered by a slab of stone, slate, or iron, unless special exemption be obtained from the Trustees in writing.

6. Every coffin shall have upon the lid an approved metal plate, bearing the name of the deceased stamped or otherwise indelibly inscribed in legible characters thereon.

7. Every grave shall be at least 7ft. deep, and no interment shall be allowed in any grave with less depth than 3ft. from the top of coffin to the original surface of the surrounding ground after such interment.

8. No interment shall be allowed in any private grave or vault without the production of the Certificate of Right of Burial, as in Schedule “B,” or other satisfactory evidence that the person desiring to bury therein is entitled to do so, except in such cases as are provided for in the following By-law.

9. In the case of an application for interment in any private grave or vault to which the deceased had no claim during life, the written consent of the owner shall be handed in with the application.

10. No burial shall be allowed to take place in the Cemetery without a certificate from the District Registrar of Deaths that the death has been registered, or a Coroner's order for burial. Such certificate or order shall at the latest be handed to the Secretary upon the funeral entering the Cemetery.

11. The hours fixed for burials shall be as follows:— Week days, from 8 a.m. to 5 p.m.; Sundays, 2 p.m. to 5 p.m.

12. No burial shall be allowed to take place at any other hour, except by written permission of the Trustees.

13. The time fixed for any burial shall be the time at which the funeral is to arrive at the Cemetery.

14. At funerals no vehicles other than hearses shall be allowed to enter the Cemetery gates.

15. All hearses shall proceed by such roads as directed, and the drivers shall at all times observe such directions as may be issued to the Secretary by the Trustees from time to time for the regulation of the traffic.

16. No headstones, footstone, kerbing, monument or any other erection of any kind shall be permitted, nor shall any inscription be allowed until the plans and particulars of the same have been approved by the Trustees.

17. Every erection shall be placed on proper and substantial foundations, and if required by the Trustees or their officers, such foundations shall extend to the bottom of the grave.

18. The materials used in every erection shall be subject to the approval of the Secretary or other officer appointed by the Trustees, and any material rejected shall be immediately removed from the Cemetery by the contractor or person responsible for the erection.

19. All material, refuse, and other rubbish remaining after any work is completed shall be immediately removed from the Cemetery by the person responsible therefor.

20. In the event of the refuse, rubbish, or material referred to in previous By-law not being so removed, the Trustees shall have power to cause the same to be removed, and to recover the costs of such removal from the person or persons responsible therefor.

21. All materials required in the erection and completion of any stone or other work shall, as far as possible, be prepared before being taken to the Cemetery, and all materials required by tradesmen shall be admitted at such entrance to the Cemetery and conveyed along such roads or tracks as the Secretary shall direct, and no vehicle conveying any such material with wheels less than 4in. broad shall be permitted to enter the Cemetery.

22. The Trustees will not (unless in very exceptional cases) permit the removal of any corpse from any grave for re-interment in this or any other Cemetery.

23. Before any such exceptional case, as referred to in the last By-law, be dealt with by the Trustees, a written application, setting forth the reason for the proposed removal, and verified by a statutory declaration, shall be produced by the nearest available representative of the deceased, and in the event of such application being granted, the permission of the Chief Secretary, in addition to the permission of the Trustees, shall be obtained. If in the opinion of the Trustees it is necessary, the coffin shall be enclosed in a second and air-tight coffin prior to removal.

24. No wooden fences, railings, crosses, etc., shall be allowed.

25. The shape and height of all graves, etc., shall be subject to the approval and supervision of the Secretary.

26. No trees or shrubs shall be planted in any enclosure, except such as are approved by the Secretary.

27. All workmen, whether employed by the Trustees or by any other person, shall at all times, whilst within the boundaries of the Cemetery, be subject to the supervision of the Secretary, and shall obey such directions as that officer may find necessary to give, and any workman committing any breach of these Regulations and By-laws, or refusing or neglecting to comply with any directions of the said Secretary, shall be removed from the Cemetery.

28. Any person taking part in dressing or attending to any grave shall comply with the following rules:—

(a) No rubbish, soil, sand, or any other materials removed in dressing a grave shall be placed on any other graves, and if placed on any other adjoining ground shall be removed immediately the work is completed.

(b) No sand, soil, or loam shall be taken from any portion of the Cemetery for the purpose of dressing graves, except with the permission of the Secretary.

(c) The dressing of all graves, and the wheeling and carting of any material shall be subject to the supervision of the Secretary.

(d) Work in all classes to be carried on with due despatch, and only during regulation hours.

29. Children under the age of ten years shall not be admitted to the Cemetery unless in charge of some responsible person.

30. No dogs shall be admitted into the Cemetery and any found there shall be liable to be destroyed.

31. Any person violating the rules of propriety and decorum, or committing any nuisance or trespass, or injuring any trees, shrub, flower, border, or any erection, or in any way infringing "The Cemeteries Act, 1897," or any rule, regulation, or by-law made for protecting the Cemetery, shall be prosecuted as the law directs.

32. No person shall promote or advertise, or carry on within the Cemetery or its approaches, any trade, business, or calling, either by solicitation, distribution of circulars or cards, or otherwise, or by any other system of advertisement whatsoever.

33. No person employed by or under the Trustees shall be permitted to accept any gratuity whatever whilst in discharge of his duty, nor shall he be pecuniarily interested in any work in the Cemetery other than that for which he receives payment from the Trustees, any any person so employed accepting any gratuity, or being pecuniarily interested in any such work shall be liable to summary dismissal.

34. Licenses for grave dressing or decorating may be issued by the Trustees in the form set out in Schedule "B"; such licenses to be renewed annually.

35. Subject to the directions of the Trustees, the Secretary shall exercise a general supervision and control over all matters pertaining to the Cemetery.

HIS Excellency the Governor in Executive Council has approved of the following amendments to the Regulations of the Education Department:—

Add to Regulation 25:

A teacher who completes the thesis requirements for the "A" Certificate will, if the conditions relating to service and efficiency have been fulfilled, receive his new classification on that one of the following dates which occurs next after the writing of his final thesis—1st February, 1st May, 1st August, 1st November.

Delete the last four paragraphs of Regulation 22 and the whole of Regulations 27, 28, 29, and 30, and substitute:

27. (1) A head teacher with the "C" Classification will not be regarded as eligible for the headship of a school higher than Class VI.

(2) A head teacher with the "B2" Classification will not be regarded as eligible for a school above Class V., nor a teacher with a "B1" Classification for a school above Class IV.

(3) A head teacher with the "A3" Classification will not be regarded as eligible for a school above Class III., nor a teacher with the "A2" Classification for a school above Class II.

(4) Assistant teachers with the "A2" Certificate will not be regarded as eligible for the headship of a school above Class IV; those with the "A3" Certificate will not be eligible for a school higher than Class V.; or those with the "B" Certificate for a school higher than Class VI.

(5) Head teachers will be eligible only for the promotion list to the next class of school above that in which they are placed.

28. Relative claims for promotion to vacant positions shall be determined by the Board of Classifiers. A promotion list shall be formed for the headmastership of each class of school above Class VII. The board will take into consideration in each case the record of the teacher, the teacher's literary or scientific qualifications, and the length and nature of the teacher's service. Such promotion lists shall be compiled in each year before 31st July, or at such other times as is appointed by the Minister, and shall govern the promotions until the completion of the next annual list.

29. (1) The Board of Classifiers shall consist of the Chief Inspector, a Senior Inspector nominated by the Minister, and a Head Teacher who is a member of the Teachers' Union, elected by the teachers in the following manner:—

(2) Every head teacher and assistant on the permanent staff of the Department, and every head or assistant teacher on supply who has been continuously employed as a teacher for not less than twelve months immediately preceding the month in which the election is held shall be entitled to vote. Notice shall be given in the *Circular*, and votes must be received at the Department before the end of the month following that in which the *Circular* is issued.

(3) No head teacher is eligible for election unless he or she holds the "A1" Classification and is drawing a salary equal to that provided for such a teacher in Class 1A school. The elected teacher shall hold his position for two years, and shall be eligible for re-election. A returning officer shall be appointed by agreement between the Department and the Teachers' Union to conduct the election.

(4) The board shall meet from time to time to consider matters affecting the promotion and classification of teachers, and to consider any appeal from teachers against their classification or position on the promotion list. No appeals against Inspector's report will be referred to the Board.

(5) A teacher who wishes to appeal against a decision of the Board of Classifiers may appeal to the Minister. His appeal must be made in writing, setting out fully the grounds upon which he claims that an alteration should be made. The Minister will call for a statement in writing from the Board of Classifiers showing the grounds on which their decision was based. Unless there are very special circumstances which appear to the Minister to make an interview desirable, the appellant will not be called upon to appear in person. The Minister's decision will be final, unless the provisions of the Public Service Appeal Board Act apply.

(6) Efficiency as a teacher shall be determined by the nature of the Inspector's report, as indicated in the teacher's record. In these reports Inspectors shall estimate the teacher's worth under various headings by using any of the terms: Excellent; Very good; Good; Very fair; Fair; and Weak. Such an estimate will be made, so far as possible, for every teacher every year.

(7) The Board shall award efficiency marks, the possible maximum being 90.

(8) The following table shows the numerical value assigned by the Board to the various terms employed by the Inspectors:—

(9) In assessing Certificate marks the Board shall assign the following values:—

"A" Teachers. "B" Teachers. "C" Teachers.
A1—10 B1—5 C1—1
A2—9 B2—4
A3—8

Where a teacher holds the University Degree, one additional mark will be added to his Certificate value.

(10) In calculating seniority the whole of the teacher's service under the West Australian Department shall be taken into consideration. Marks for service shall be awarded as under:—

Each year as a Monitor 1/4.
Each year as a student in College .. 1/8.
Each year as head teacher or assistant .. 1/2

For teachers who have served in localities where a district allowance is payable an additional 50 per cent. on the above marks will be allowed for the period served in such localities.

(11) When an assessment of marks from the teacher's staff reports has been made, the Board will arrange teachers into groups, according to their marks. Teachers who obtain a mark of 81 or over for efficiency will be placed in Group 1, and teachers whose mark lies between 70 and 81 for efficiency, in Group 2. The efficiency mark will be calculated on the average of the marks gained by the reports for the four years immediately preceding the year in which the promotion list is being compiled.

(12) Having been arranged into groups according to marks, teachers in Group 1 will then be placed in promotion order by Board. The promotion order within the Group will be determined by seniority and certificate marks combined. Should the names in Group 1 be exhausted, promotion shall be made from Group 2, the order being determined by efficiency, seniority, and certificate marks combined. No teacher shall be considered for further promotion until he has served for two years in his new position.

(13) Should the available promotions for the year not exhaust the list of Group 1 teachers, those who remain without receiving promotion for the current year will be placed at the head of Group 1 for the following year, provided that their efficiency warrants their retention in Group 1.

(14) All vacancies for First Assistants and Head Mistresses of Infants' Schools, and all special positions, shall be advertised, and appointments or recommendations shall be made in accordance with the Regulations.

30. For positions needing special qualifications the Director will ask the Board to make recommendations, after taking the particular circumstances into consideration, and departing, if necessary, from the ordinary rules of priority.
