WHEREAS by Section 13 of "The Main Roads Act, 1925," the Governor may, on the recommendation of the Board, declare by Proclamation that any road shall be a main road: And whereas the Main Roads Board has recommended that the road specified in the Schedule hereto be so declared: Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, hereby declares that the road specified in the Schedule hereto shall be a main road within the meaning of "The Main Roads Act, 1925," and that the footpaths, if any, of such road be excluded from the main road.

The Schedule.

Moora-Geraldton Road (Mingenew Road District).

A strip of land, one chain wide, commencing at the North-Western corner of Location 3763 at the Western boundary of the Carnamah Road Board District; thence continuing in a North-Westerly direction along the South-Western boundaries of Locations 5177, 3471, and 3433; thence continuing in a North-Westerly direction through Location 2899 and along the North-Eastern boundary of Location 2894; thence continuing along the North-Eastern boundary of Location 2759 to the North-Eastern corner of Location 6850; thence continuing in a Northerly direction along Durack Street, crossing the Midland Railway to its Northern side and continuing in a Northerly direction to the North-Eastern corner of Location 1489 at the junction of Road No. 2131; thence continuing along Road No. 2131 in a Westerly and North-Westerly direction, crossing the Midland Railway to its Western side at the South-Eastern corner of Location 6745; thence continuing in a North-Westerly direction along Midland Street; thence

following the Midland Railway past Reserve No. 2326 to the North-Eastern corner of Location 2758, as shown on Plan M.R.B., W.A., No. 236.

Traffic Act (viz., from the Western side of Coppin Road at Mahogany Creek in the Greenmount Road District); thence continuing in an Easterly direction through Mundaring Townsite, crossing the Eastern Goldfields Railway to its Eastern side at the North-Eastern corner of Lot 15; thence continuing in an Easterly and North-Easterly direction through the Townsite of Sawyers' Valley to the Townsite of Chidlow's Well; thence crossing the Eastern Goldfields Railway to its Northern side, in the said Townsite; thence continuing in a North-Easterly direction, again crossing the Eastern Goldfields Railway to its Eastern side at the North-Eastern corner of Location 3042; thence continuing in a North-Easterly direction past Beechina Hill to the North-Western corner of Location 6684, as shown in blue on Plan M.R.B., W.A., 242.

WHEREAS by Section 3 of "The Electric Lighting Act, 1892," it is provided that any Municipal Council may, subject to the provisions of the Act, supply electricity for all or any of the purposes mentioned in the Act within the limits of the Municipality, or within such other limits as the Governor may by Proclamation approve and allow: And whereas it is desirable that the Council of the Collie Municipality should be authorised to supply electricity to consumers in Ewington and West Collie areas, outside the Municipal boundaries: Now, therefore I, the Governor as aforesaid, with the advice and consent of the Executive Council, do hereby declare that the supply of electricity by the Council of the Collie Municipality within the Ewington and West Collie areas, outside the Municipal boundaries as aforesaid, is approved and allowed subject to the following conditions:—

(a) The above extension and supply shall be subject to any By-laws which may from time to time be approved under "The Electric Lighting Act, 1892," and the Amendment Acts, and shall be maintained in an efficient state, to the satisfaction of the Minister for Works;

(b) That in the event of the Government requiring the removal of the poles and cables, or any portion of the installation, the undertakers shall remove the same at their own expense, upon receiving three months' notice in writing to that effect;

(c) The Government shall not be held responsible in any way for claims which may arise from any cause, either during the construction or working of the line.

ORDER IN COUNCIL.

WHEREAS by Section 202 of "The Road Districts Act, 1919," it is enacted that the Governor may in his discretion extend the provisions set out in the Second Schedule of the said Act to any district or portion thereof: And whereas it is desirable to extend such provisions to the Townsites of Allanson, Shotts, Collie Burn, Cardiff, and part of Collie within the Collie Road District: Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, doth by this Order in Council, made under Section 202 of "The Road Districts Act, 1919," extend the provisions set out in the Second Schedule of the said Act to the Townsites of Allanson, Shotts, Collie Burn, Cardiff, and part of Collie within the Collie Road District.

Cranbrook Road District—Redivision into Wards.

ORDER IN COUNCIL.

WHEREAS, under the provisions of "The Road Districts Act, 1919," the Governor may by Order in Council redivide a Road District into Wards: And whereas it is desirable to redivide the Cranbrook Road District into Wards: Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, under the provisions of the said Act and all other powers enabling him in this behalf, doth hereby redivide the Cranbrook Road District into six Wards, with the names, boundaries, and number of members allotted to each Ward as described in the Schedule hereto.

CRANBROOK ROAD DISTRICT.

Description of Ward Boundaries.

Central Ward.—Bounded on the North-Eastward by lines commencing at the Western corner of Reserve 14302 and extending South-Eastward along the South-West boundary of the said Reserve and part of the South-West boundary of Plantagenet Location 2770 to the Northern corner of Reserve 5349.

On the South-Eastward by lines commencing at the said Northern corner and extending South-Westward along the North-West boundaries of Reserve 5349, Location 4494, and part of the North-West boundary of Location 3267 to the Southern corner of Location 4426.

On the South-Westward by lines commencing at the said Southern corner and extending North-Westward along North-Eastern boundaries of Locations 3826, 3856, and 1528 to the Western corner of Cranbrook Lot 147.

On the North-Westward by lines commencing at the said Western corner and extending North-Eastward along South-Eastern boundaries of Locations 3087, 1016, and Reserve 12724 to the starting point. (One member.)

Tunney Ward.—Bounded on the Northward and Eastward by part of the district boundary from the North-West corner of Kojonup Location 7214 to the South-West corner of Plantagenet Location 604.

On the Southward by lines commencing at the said South-West corner and extending along the South-Eastern side of the Great Southern Railway Reserve to the North-Eastern boundary of the Central Ward; thence by parts of the North-Eastern and North-Western boundaries of the Central Ward to the South-East corner of Location 1016; thence along the Southern boundaries of Locations 1016 and 3867 and the Western boundary of the latter, part of the Western boundary of Location 3306, the South boundaries of Location 3165 and Hay Locations 839, 838, 194, and a West

and a South boundary of the last-mentioned location, continuing to the right bank of the Gordon River; thence along the said bank of the river to the South-Western corner of Location 7214; on the Westward by the West boundary of Location 7214 to the starting point. (Two members.)

Gordon Ward.—Bounded on the Northward by part of the district boundary and by part of the Southern boundary of the Tunney Ward from the North-West corner of Nelson Location 4180 to the South-Western corner of Plantagenet Location 3867.

On the Southward by lines commencing at the said South-West corner and extending along the Northern boundaries of Locations 3327, 3043, Hay Locations 897, 648, Reserve 5090, Locations 527, 174, 173, 172, 171, 455, 858, 860, 543, 837, 625, 1099, 140, 363, 362, and part of the Northern boundary of Location 885, the East, North, and part of the West boundary of Location 645, a Northernmost, West, and North boundary of Location 1162, a North, East, and Northernmost boundary of Location 1040, part of the East and a South boundary of Location 713, a South boundary of Location 693 and a South and part of the West boundary of Location 713, South boundaries of Locations 340 and 209, a West boundary of Location 980, part of the Northern boundary of Location 765, the Northernmost boundary of Location 875, the East and South boundaries of Location 1058, the South and part of the West boundary of Location 1017, the Southernmost boundary of Location 1033, the East boundary of Location 841, part of the South, East, and the North boundary of Location 760, the East and Northernmost boundary of Location 884, part of the East and the North boundary of Location 620, the North, an East and the Northernmost boundary of Location 1174, parts of the East and South boundaries of Location 57, the East and Southernmost boundary of Location 123, and the South boundary of Location 63 to intersect the right bank of the Frankland River.

On the Westward by lines commencing at the said intersection and extending Northward along the said bank of the river to the South-East corner of Hay Location 7; thence along the South boundary of Location 7 and South boundary of Nelson Locations 2770 and 349 and the West boundary of the latter, South and West boundaries of Location 3908, and the West boundary of Location 4180 to the starting point. (Two members.)

Frankland Ward.—Bounded on the Southward, Westward, and Northward by part of the district boundary and by part of the boundaries of the Gordon Ward from the West boundary of Hay Location 768 to the North-Western boundary of the Central Ward.

On the Eastward by part of the North-West and part of the South-Western boundaries of the Central Ward and by the Eastern side of the Great Southern Railway Reserve to the production East of the South boundary of Plantagenet Location 957; thence along the said production and South boundary and the South boundaries of Locations 642, 735, 606, 607, and again 735 and part of the West boundary of Location 735 aforesaid, the North boundaries of Tenterden A.A. Lots 46, 45, 44, 43, 41, and 42, part of the East boundary of Hay Location 957, the Easternmost and Northern boundaries of Location 408, the East boundary of Location 721, the North and West boundaries of Location 861, part of the North and West boundaries of Location 868, part of the Northernmost, West, and North boundary of Location 869, the North and Westernmost boundary of Location 878, a South and East boundary of Location 899, part of the Northern and the West boundary of Location 663, part of the North and West boundary of Location 482, the West and South boundary of Location 1181, part of the South boundary of Location 938 and part of the West boundary of Location 768 to the starting point. (Two members.)

Tenterden Ward.—Bounded on the Westward and Northward by the boundaries of the Frankland Ward, on the Eastward by the Eastern side of the Great Southern Railway Reserve, and on the Southward by part of the district boundaries. (One Member.)

Stirling Ward.—Bounded on the Northward, Eastward, and Southward by part of the district boundaries, on the Westward by the Eastern boundaries of the Tenterden Ward, part of the Eastern boundary of the Frankland Ward, part of the South-Western, the South-Eastern, and part of the North-Eastern boundary of the Central Ward and part of the Southern boundary of the Tunney Ward to the starting point. (One member.)

The Traffic Act, 1919-26.
Darling Range Road Board.
ORDER IN COUNCIL.

P.W. 1523/26.
WHEREAS under the provisions of "The Traffic Act, 1919-26," the Governor may by Order in Council empower a Local Authority to exercise within its district any power of making Regulations which the Governor can exercise under Division 4 of Part IV. of the said Act: And whereas it is advisable to empower the Darling Range Road Board to prohibit the passage of heavy traffic over specified roads within its district, and to define what shall be deemed heavy traffic for such purpose: Now, therefore, His Excellency the Governor, with the advice and consent of the Executive Council, under the provisions of the said Act and all other powers enabling him in this behalf, doth hereby empower the Darling Range Road Board, by the By-law in Schedule hereto, to prohibit the passage of heavy traffic over specified roads during such period or periods as the Board may deem necessary within its district, and to define what shall be deemed heavy traffic for that purpose and to impose a penalty not exceeding £20 for the breach thereof.

THE TRAFFIC ACT, 1919-26.
Darling Range Road Board.

The Darling Range Road Board, pursuant to an Order in Council under Section 43 of "The Traffic Act, 1919-26," and in exercise of the power thereby conferred, doth hereby make the following By-law, to have effect within the Darling Range Road District:—

The passage of any vehicle engaged in heavy traffic over Welshpool Road and Belmont-Kalamunda Road within the Darling Range Road District is prohibited.

For the purpose of this By-law "Heavy Traffic" means the traffic of all vehicles engaged in the carriage or conveyance of sleepers (sawn or hewn), split and other timber, firewood, bricks, stone, gravel, salt, lime, cement, farm produce, or other material in bulk, and the traffic of any vehicle the weight thereof including load exceeds 10 cwt. per wheel.

This By-law shall not apply to vehicles engaged in carrying passengers at a separate fare.

Any person who commits a breach of this By-law shall be liable on conviction to a fine not exceeding £20.



- in consequence of the relieving man not coming on duty at the proper time, in which cases (a), (b), and (c) ordinary rates shall be paid for the time so worked; provided that, where in case (c) the relieving man fails for more than two hours to come on duty, any such time worked after the said period of two hours shall be deemed to be overtime.

3.—Sunday Rates.

For all work done on Sundays shift workers shall be paid at the rate of time and a half and non-shift workers at the rate of double time.

4.—Holidays.

All employees shall be entitled to the three holidays hereinafter mentioned, without pay, viz.:—Christmas Day, Easter Monday, and Labour Day. All work performed on those days shall be paid for at the rate of double time.

5.—Annual Leave.

All employees shall be granted, once in each year, fourteen consecutive days' holiday, which shall include twelve working days, for which the employee shall be paid two weeks' wages. If the employment is determined before the holiday is due, the employee shall be entitled to one day's pay in lieu of holidays for every complete month of his service or portion of a month.

6.—Hours of Duty.

Eight hours shall constitute a day's work and forty-eight hours a week's work. The provision that eight hours shall constitute a day's work shall be deemed to

be satisfied if the time of duty be either eight and three-quarter hours on five days and four and a quarter hours on one day in each week, or eight and one-half hours on five days and five and one-half hours on one day in each week.

7.—Probationary Period.

The first fourteen days of employment shall be on daily basis at one-sixth of the weekly rate fixed.

8.—Adjustment of Wages.

The parties hereto agree that, if and when any higher rates of wages are payable under any Award or Industrial Agreement made pursuant to the Industrial Arbitration Act of the State of Western Australia, and operating within a radius of five miles from the General Post Office, Kalgoorlie, to employees engaged in any of the classes of work hereinbefore specified, the higher rates of wages so payable shall be deemed to be substituted for the respective rate of wages payable for the time being under this Agreement.

9.—Maintenance of Existing Conditions.

Save, so far as they may be altered or varied by this Agreement, all now existing conditions and customs shall be maintained during the period of this Agreement.

10.—Term.

This Agreement shall operate as from the day of the date hereof, and shall continue in force for a period of three years, subject to the right of either party to apply to the Court of Arbitration at any time after the expiration of twelve months from such date and/or at the end of any succeeding twelve months from the date of any such application to amend this Agreement.

11.—Breakdowns, etc.

For the purpose of setting out plainly the exact method of procedure under this clause it shall be mutually understood that, where it becomes necessary for the Company to deduct payment when any member or members of the organisation cannot be usefully employed, it is hereby mutually agreed that:—

- No deduction will be made where the breakdown or stoppage of work for any cause the Company cannot reasonably be held responsible for only affects one employee member for not more than two consecutive days; or
- alternately, affects only two employees for not more than one day; thus making a total of six shifts in either alternative as a maximum to be paid for by the Company;
- should the breakdown or stoppage affect the Company to a greater extent than as above specified in (1) and (2), then the Company agrees to stand down the employee-members of the organisation in reasonable rotation so as to give, as far as possible, equal work for all employees, always excepting leading firemen, whose services the Company reserves the right to retain, at its discretion.

12.—No Reduction.

Nothing in this Agreement shall in itself operate to reduce the wage of any worker below the rate actually received by him at the date hereof.

INDUSTRIAL ARBITRATION ACT, 1912-1925.

In the Court of Arbitration, Western Australia, between The Western Australian Lime and Stone Merchants Employees' Industrial Union of Workers, Fremantle, and North Fremantle Lime and Stone Company and others.

Award of Industrial Board.

1.—Area.

This Award shall apply over the area comprised within a radius of fifty miles from the General Post Office, Perth.

2.—Term.

The currency of this Award shall be three years from the 2nd day of March, 1928, provided that either party may, after the expiration of one year from its date, apply to alter, amend, or revise the same.

3.—Definitions.

(a) In this Award, if not inconsistent with the context, "worker" shall include any person engaged as a horse-driver or motor-driver working in or about a lime kiln, or on any necessary work in connection with the quarrying of limestone and sandstone and the production and distribution of lime or stone.

(b) "Horse-driver's or Motor-driver's Assistant" shall mean any worker employed to accompany a driver to assist in loading, unloading or delivering.

(c) "Loaders and Helpers" shall mean any worker who is engaged in assisting to load or unload any vehicle.

4.—Hours.

(a) Forty-four (44) hours shall constitute a week's work, to be worked on five and a-half days in each week. The starting time on every working day shall be 7.45 a.m. and the finishing time shall be 4.45 p.m. on each working day, except Saturday. On Saturday the finishing time shall be 11.45 a.m. Provided that the starting and finishing times may be varied by agreement in writing between any employer and the Union as long as the daily working hours do not exceed eight in any one day.

(b) Night Firing shall be worked in one shift between the hours of 6 p.m. and 6 a.m., when required. One hour shall be allowed for meals, which shall be taken at times suitable for the proper working of the kilns. Half shifts may be worked between the hours of 6 p.m. and 7 a.m. by mutual agreement between the employer and worker.

(c) Horse-drivers:—Horse-drivers shall have their horses harnessed and hooked up to drays ready to commence work at the time appointed for other workers to commence, and unharnessed and in the stable at the usual finishing time of other workers.

(d) Motor-drivers:—Motor-drivers shall have their vehicles ready to commence work at the time appointed for other workers to commence and shall have them garaged at the usual finishing time.

5.—Overtime.

(a) For all work done beyond forty-four (44) hours in one week payment shall be at the rate of time and a-quarter for the first four hours and time and a-half thereafter.

(b) Except for night burners and horse feeders all work done on Sundays shall be paid for at double time rates.

For night burners double time shall be paid between the hours of 6 p.m. on Saturday and 6 a.m. on Sunday. Burners employed between 6 p.m. Sunday and 6 a.m. on Monday shall be paid at ordinary time rate.

(c) If a worker who has been employed in the day-time is requested to continue and fire a kiln at night time, during the time he is employed at night time he shall be paid at the rate of time and a-quarter on night burner's rate.

6.—Holidays.

Each worker shall be entitled to eight fully paid holidays per annum. Such holidays shall be taken at Christmas time. Should the period of continuous employment be less than one year the worker shall be paid holiday pay in proportion as his length of service is to the full year's employment.

All work performed on Christmas Day, Good Friday, Labour Day or Union Picnic Day shall be paid for at double time rates.

7.—Hours of Cooling.

No kiln shall be broken into until eighteen hours after the last fire in winter and twenty-four hours after the last fire in summer. The winter months shall be from the fifteenth day of March to the fifteenth day of October (both inclusive). The summer months shall be from the sixteenth day of October to the fourteenth day of March (both inclusive).

8.—Finishing off Kilns.

Day workers engaged in finishing off kilns shall be paid an allowance of one shilling per kiln in addition to their ordinary rate of wages.

9.—Pay Day.

Wages shall be paid in cash on Friday of each week between the hours of 3 p.m. and 5 p.m., except when Friday shall be a holiday, in which case the pay shall be distributed between the hours above-mentioned on the next preceding working day; the wages shall be paid up to and inclusive of the day preceding pay day.

10.—Foreign Subjects.

The number of foreign subjects employed by any employer in the industry to which this Award relates shall not exceed one foreign subject to every two British subjects.

11.—Contract of Service.

All workers shall be engaged and paid by the day, and one day's notice of determination shall be given by either party.

12.—Wages.

The minimum rate of wages to be paid shall be as follows:—

Feeding Horses:—Any worker employed outside his ordinary working hours in feeding horses, shall be paid an allowance of ten shillings a week in addition to his ordinary wages.

Piecework quarrying:—If a piece-work quarryman be not satisfied with the measurement of his stone by measurement of dray or lorry, he shall have the option of stacking the stone he quarries, and the measurement of his stone shall be ascertained on the ground.

Kiln repairing:—Kiln repairing shall mean and include re-inserting bricks or stone in a kiln with mortar.

13.—Hurricane Lamps and Kerosene.

Hurricane lamps shall be provided once in six months if required for the use of night burners. Sufficient kerosene oil to keep such lamp burning during the hours of darkness during his shift shall also be provided by the employer.

14.—First Aid Equipment.

Adequate First Aid equipment shall be provided at all kilns and works.

15.—Explosives.

Where explosives are provided by the employer they shall be provided at the usual retail rates charged in Fremantle or Perth. Should a dispute arise as to the retail price in Fremantle or Perth it shall be referred to a committee consisting of a representative of the employer concerned, a representative of the Union, and a Chairman selected by these two delegates.

16.—Time and Wages Book.

The employer shall keep and enter up, or cause to be kept and entered up, a book containing the name of each of his workers to whom this Award applies, the class of work performed by and the wages paid to each such worker, and the time during which each such worker has been employed. Such book shall be signed by the worker and shall be open for inspection by any authorised representative of the Union during the daytime working hours.

17.—Aged and Infirm Workers.

A worker who is unable to earn the minimum rate of wages hereby prescribed may be employed at a lesser rate of wage, which shall be agreed upon between the employer and the Secretary of the Union. If within seven days after being notified in writing of the worker's desire to work at a lower rate of wages than that specified in the award the secretary of the Union and the worker are unable to agree upon a lower rate, then the worker may apply in writing to the nearest Industrial Magistrate to fix such lower rate of wage. The worker shall give such secretary two days' notice in writing of his intention to apply to the Court, and the secretary or his agent may attend and oppose the application. The Industrial Magistrate may fix the rate of wage and his decision shall be final: provided always, that the employer shall not employ more than one such lower paid worker to every four fully paid workers or fraction of the first four.

18.—Preference to Unionists.

Should any worker be employed who at the time of his engagement is not a member of the W.A. Lime and Stone Merchants Employees' Industrial Union of Workers, Fremantle, and who shall refuse within fourteen days of his engagement to become a member of such Union, then the employer shall dispense with the services of such worker, and shall not re-engage him until notified by the secretary of the Union that such worker has become a member of the Union. Provided that the Union shall not refuse to accept as member any worker who is eligible under the Rules of the Union to be a member of the Union, and who applies in the prescribed form to become a member.

19.—Junior Workers.

(a) "Junior Worker" shall mean any person under the age of 20 years in receipt of less than the adult wage.

(b) "Proportion of Junior Workers": Junior workers may be employed in the proportion of one junior to every five adult workers engaged.

Junior workers shall not be employed at night firing, quarrying, or powder monkey's work.

20.—Posting Award.

A copy of this Award shall be posted at every lime kiln, or works, and kept in a legible condition during the currency of this Award. If foreign subjects who cannot read the English language are employed at the kiln, or works, a copy of the Award in a language that the foreign subject can understand shall be posted up.

THIS Agreement, made in pursuance of "The Industrial Arbitration Act, 1912-1925," this 20th day of December, One thousand nine hundred and twenty-seven, between the Mayor and Councillors of the Municipality of Boulder, hereinafter termed "the Employer," of the one part, and the Eastern Goldfields Municipal and Roads Board Labourers' Union of Workers, being a Union of workers registered under the provisions of "The Industrial Conciliation and Arbitration Act, 1912-1925," hereinafter termed "the Employees," of the other part, whereby the said parties are mutually agreed as follows:—

1.—Wages.

The basic wage at the rate of £4 5s. 0d. per week.

The minimum rate of wage which shall be paid by the employer to the employees shall be:—

2.—Hours of Labour.

(a) Generally.—The hours of labour for all employees shall not exceed 44 hours per week, divided as follows:—Mondays, Tuesdays, Wednesdays, Thursdays, and Fridays, work shall commence at 8 a.m. and continue with one hour intermission for dinner until 5 p.m. Saturday's work shall commence at 8 a.m. and continue until 12 noon. Provided always, and it is agreed, that such division may be re-arranged by mutual consent of both parties.

(b) Sanitary Employees.—The hours of labour for sanitary employees shall not exceed 44 hours per week, divided as follows: Provided always, and it is agreed, that such division may be re-arranged by mutual consent of both parties.

Vanmen shall start work on Mondays, Tuesdays, Wednesdays, Thursdays, and Fridays at 5 a.m. at the stables and finish at 2 p.m. Saturdays—Work shall start at the stables at 5 a.m. and finish at 9 a.m.

Stagemen shall start work at the cleansing stage every day except Sundays at 8 a.m. and continue with one hour intermission for dinner until 5 p.m., except on Saturdays, when they shall finish at 12 noon.

Slopmen shall start at the stables on Mondays, Tuesdays, Wednesdays, Thursdays and Fridays at 5 a.m. and continue with one hour intermission for dinner until 2 p.m. Saturday's work shall start at 5 a.m. and finish at 9 a.m.

Trenchmen shall start work at the trenches, or where otherwise directed, every day except Sundays at 8 a.m. and continue with one hour intermission for dinner and finish at the trenches at 5 p.m., except on Saturdays, when they shall finish at 12 noon.

Tipmen shall start work at the tip (when working on same), or where directed, every day except Sundays at 8 a.m., and continue with one hour intermission for dinner and finish at the tip (when working on same) or where directed, at 5 p.m., except on Saturdays, when they shall finish at 12 noon.

Rubbish Carters shall start work every day at the stables, except Sundays, at 8 a.m., work with one hour intermission for dinner, and finish at the stables at 5 p.m., except on Saturdays, when they shall finish at 12 noon.

General Hand shall start work, where directed, at 8 a.m. each day except Sundays, work with one hour intermission for dinner, and finish, where directed, at 5 p.m.; on Saturdays he shall finish at 12 noon.

3.—Overtime.

All time worked in excess of the hours stated herein, each day's work to stand by itself, shall be considered as overtime, and shall be paid for at the following rates:—For the first two (2) hours after the ordinary time for ceasing work, time and a quarter; after the first two (2) hours and up to four (4) hours, time and a half; after the first four (4) hours, and until the ordinary time for recommencing work, double time. All work performed on Sundays shall be paid for at double time rates. Sunday, for the purpose of this clause, shall be from midnight Saturday to midnight Sunday. Overtime rates shall not apply to foremen or watchmen. Stablemen of both stables shall be paid time and a half for Sunday work only.

4.—Holidays, Public.

Every employee shall be allowed the following holidays on full pay:—Christmas Day, New Year's Day, and Labour Day. Employees compelled to work on such days shall be paid at double time rates. When any of these holidays falls on a Sunday, the following Monday to be observed as a holiday.

5.—Annual Holidays.

A fortnight's holiday, including twelve working days on full pay, shall be granted once in each year to every worker, provided he has worked 298 shifts at ordinary rates of pay, and should he have worked less than 298 such shifts when the said holiday is taken, or at the termination of his employment, he shall be paid for a proportionate number of holidays.

6.—Annual Holidays' Notice.

Notification of annual leave shall be given to employees entitled thereto at least one week before the commencement of such leave.

7.—Annual Leave, Mixed Functions.

Any employee who has been engaged on mixed functions during the year, when their annual leave falls due, shall be paid for such leave at a rate computed on the average weekly earnings of such employee for the twelve months preceding such leave.

8.—Sick Pay.

Twelve days' sick pay on half pay on account of sickness shall be allowed to men employed in the Sanitary Department only. A doctor's certificate to be produced on each occasion a man is off sick; sick pay shall not be granted for more than twelve days in the aggregate in each year.

9.—Aprons.

Two aprons each per year to be provided for use of the drivers and stagemen in the Sanitary Department, if required.

10.—Oilers.

Men having to work in the rain, oilers to be provided, the style of oiler optional.

11.—Mixed Functions.

Any employee using tradesmen's tools and doing the work of tradesmen shall be paid the ruling rate in the district for the class of work upon which he is employed; likewise an employee taking the place of a higher paid employee, or doing work classed at a higher rate, such employee shall be paid the higher rate of wage. If employed at the higher rate for two or more hours, he shall be paid at the higher rate for the whole of that shift.

12.

Any employee turning up to work at the usual starting time, if his services are not required, he shall be paid for two hours at his usual rate, unless previously notified that his services would not be required.

13.

In the event of the full complement of men not being required, men shall be employed in rotation.

14.

In the engagement of its employees the employers shall give preference to unionists, and men engaged by the Council shall become members of the Eastern Goldfields Municipal and Roads Board Labourers' Union of Workers within three weeks of date of engagement, and this Union guarantees to accept the employees of the Council as members of the said Union.

15.—First Aid Outfit.

The Council shall, at depots and stables, provide full and complete first aid boxes for the use of employees, and shall from time to time keep same renewed and in proper order.

16.—Full Payment for Shift.

After beginning a shift workers shall not be paid for less than a full shift, unless they leave of their own accord, or are dismissed for misconduct.

17.—Inspection of Time and Pay Sheets.

A duly accredited official of the Union shall be allowed to collect Union fees at the pay office, and shall be allowed to inspect time and pay sheets relating to any worker affected by this Agreement, and make extracts therefrom.

18.—Rights and Privileges.

Any employee who may be at the date of the signing of this Agreement in receipt of a higher rate of pay for his particular class of work than is herein prescribed, or in respect of any privilege or allowance other than herein provided, shall not suffer by reason of this Agreement any reduction in the amount which such employee was receiving above the rate prescribed in this Agreement, or loss of any privilege or allowance.

19.

In all contracts let by the Council for work to be performed, the rates of pay and conditions of work set out in this Agreement shall be embodied in the conditions of contract.

20.—Interpretation Clauses.

For the purpose of this Agreement the terms used shall be interpreted or defined as follows:—

"Vanmen" means one who is engaged in collecting nightsoil from house to house, or engaged in driving the waggons conveying pans containing nightsoil.

"Stagemen" means one who is engaged cleaning pans at the cleansing stage, and loading nightsoil in tank carts to be carted to the trenches.

"Trenchmen" means one who is engaged at the trenches, and, after the trenches have been ploughed, covers with earth nightsoil deposited in same.

"Slopmen" means one who collects in the slop cart the liquid waste from hotels, laundries, and other premises, also urine from pans and tanks in the Municipality, and conveys and empties same at the rubbish tip.

"Ploughmen" means one who ploughs trenches for the reception of nightsoil and any other land required.

"Spreaders"—A spreader is one who is engaged spreading metal or other material from two or more drays, or motors, or new works or works being reconstructed, or men engaged forming, levelling, or spreading after the scarifier, but shall not include horse-drivers spreading his own load, or doing patching work.

"Rubbish Carters" means one who is engaged collecting rubbish which has been deposited by householders in boxes and other utensils, also rubbish thrown in the streets and in any right-of-way.

"Tipmen" means one who works on the rubbish tip, spreads the rubbish when tipped and burns same.

"Men tarring pans" means one who tars pans in use after being cleansed, or new pans before being used.

"Stablemen" means one who works in the stables grooming horses, cleaning harness, cleaning out the stables and mixing horse feed.

"Handling nightsoil" means:—

- (a) The work defined as vanmen.
- (b) Daymen taking nightsoil trucks to stage.
- (c) Emptying pans into trenches or tank carts, carting same and tipping into trenches or otherwise.

"Cleaning silt pits" means men engaged in emptying and cleaning the silt pits at corner of Burt and Lane Streets, Piesse and Lane Streets, and Burt and Brookman Streets.

"Foremen" means one who directs the workmen, and takes his instructions from the Town Clerk.

"Concreter" means one who under the instructions of the Town Clerk or Foreman, carries out or supervises the doing of any concrete work.

"Labourer assisting concreter" means one who is engaged on concrete work under direct instructions from the concreter in charge.

"Tarpaver" means one who under instructions from the Town Clerk or Foreman, carries out or supervises the doing of any tarpaving work.

"Labourer assisting tarpaver" means one who is engaged on tarpaving work under the direct instructions of the tarpaver in charge, also those carting tar and tar-bearing material such as asphalt, etc.

"Block boys" means the boys employed cleaning the streets.

"Municipal Labourer" means one who is engaged on any class of work as a labourer not otherwise specified in this Agreement.

"Casual hand" means one who is occasionally employed by the Council.

21.—Minimum Wage.

The minimum wage shall be ninety-three shillings per week of forty-four hours.

Notwithstanding that the rate is expressed in a weekly amount, it is hereby declared that the contract of service is a daily contract.

22.—Term of Agreement.

This Agreement shall come into force on the day of the date hereon and shall remain in force for the period of three (3) years thence next ensuing, and thereafter subject to the provisions of "The Industrial Arbitration Act, 1912-1925," and shall apply to all works and undertakings carried out by the said employer in the Eastern Industrial District.

DRIED FRUITS ACT, 1926.

Department of Agriculture,
Perth, 1st March, 1928.

IT is hereby notified that His Excellency the Governor in Executive Council has been pleased to approve of the following Regulations under "The Dried Fruits Act, 1926."

DRIED FRUITS ACT, 1926.

Regulations.

1. No currants shall be received into or dealt with in a registered Packing Shed unless all large currants, commonly called buck currants, have been separated from the average sized currants by sieving during the process of drying, and are delivered at the Packing Shed in separate boxes or containers.

2. No dried fruits shall be packed for export or for sale within the State otherwise than in clean new cases made of well seasoned softwood smoothly sawn.

3. Every dealer who imports dried fruits into this State shall, before taking delivery of such dried fruits in this State, notify the Secretary to the Board in writing of the quantity and grades of each consignment.
