M.R.B. 496/27.

WHEREAS by Section 13 of "The Main Roads Act, 1925," the Governor may on the recommendation of the Board declare by Proclamation that any road shall be a main road; and whereas the Main Roads Board has recommended that the road specified in the Schedule hereto be so declared: Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, hereby declares that the road specified in the Schedule hereto shall be a main road within the meaning of "The Main Roads Act, 1925," and that the footpaths, if any, of such road be excluded from the main road.

## The Schedule.

*Bunbury-Busselton-Yallingup-Augusta Road. (Augusta Margaret River Road Board District.)*

A strip of land, one chain wide, commencing at the North-Western corner of Location No. 1545 on Road No. 331 and continuing in a South-Easterly direction along the South-Western boundaries of Locations numbered 1545, 1544, 1522, 1521, 1519, and 1518 to the intersection with a public road (one chain wide), crossing the said public road and continuing along said Road No. 331 in a South-Easterly direction, along the South-Western boundaries of locations numbered 1524 and 1493 to the Northern boundary of Location No. 1237; thence along the said Road No. 331, passing through Locations 1237 and 1492 in a South-Easterly, Southerly, and South-Westerly direction to the bridge in Location No. 1492, crossing the said bridge to its Southern end and proceeding through Location No. 1492, along said Road No. 331 in a South-Westerly direction to the North-Western corner of Location No. 588; thence along said Road No. 331, following the South-Western

boundary of the said Location No. 588 in a South-Easterly direction to its South-Western corner; thence proceeding along the said Road No. 381 in a South-Easterly direction through Location No. 934 to the North-West boundary of the Townsite of Augusta, as shown on Plan marked M.R.B., W.A., No. 410.

WHEREAS by Section 3 of "The Electric Lighting Act, 1892," it is provided that any Municipal Council may, subject to the provisions of the Act, supply electricity for all or any of the purposes mentioned in the Act within the limits of the Municipality or within such other limits as the Governor may by Proclamation approve and allow: And whereas it is desirable that the Council of the Collie Municipality should be authorised to supply electricity to consumers in the Collie Road District: Now, therefore I, the Governor as aforesaid, by and with the advice and consent of the Executive Council, do hereby declare that the supply of electricity by the Council of the Collie Municipality within the Collie Road District as aforesaid is approved and allowed subject to the following conditions:—

- (a) the above extension and supply shall be subject to any By-laws which may from time to time be approved under "The Electric Lighting Act, 1892," and the Amendment Acts, and shall be maintained in an efficient state to the satisfaction of the Minister for Works;
- (b) that in the event of the Government requiring the removal of the poles and cables or any portion of the installation the undertakers shall remove the same at their own expense upon receiving three months' notice in writing to that effect;
- (c) the Government shall not be held responsible in any way for claims which may arise from any cause either during the construction or working of the line.

of competent jurisdiction: And whereas it is desirable to specify an area in the Claremont Road District as an area for the purpose of the said Section 161: Now, therefore I, the said Governor, by and with the advice and consent of the Executive Council, do hereby specify the area situated within the Claremont Road District and set forth hereunder as an area with the meaning and for the purpose of Section 161 of "The Road Districts Act, 1919."

ORDER IN COUNCIL.

M.W.S. 170/28.

WHEREAS by "The Metropolitan Water Supply, Sewerage, and Drainage Act, 1909," it is provided that, subject to the provisions of the Act, the Minister for Water Supply, Sewerage, and Drainage shall, with the approval of the Governor, have power to construct and extend water works, sewerage works, and storm-water drainage works: And whereas the preliminary requirements of the said Act have been complied with, and plans, sections, and estimates in respect of the works hereinafter mentioned have been submitted to and approved by the Governor in Council: Now, therefore, His Excellency the Governor, with the advice and consent of the Executive Council, does hereby empower the Minister for Water Supply, Sewerage, and Drainage to undertake the construction of the following works under the said Act, namely, Metropolitan Sewerage—Area 37 Perth District—6in. and 4in. reticulation sewers, with all manholes, inspection shafts, and all other apparatus connected therewith, as shown in blue on the Plan M.W.S., S., & D.D., W.A., No. 4822, deposited at the office of the Minister.

*The Metropolitan Water Supply, Sewerage, and Drainage Act, 1909.*

ORDER IN COUNCIL.

M.W.S. 1316/28.

WHEREAS by "The Metropolitan Water Supply, Sewerage, and Drainage Act, 1909," it is provided that, subject to the provisions of the Act, the Minister for Water Supply, Sewerage, and Drainage shall, with the approval of the Governor, have power to construct and extend water works, sewerage works, and storm-water drainage works: And whereas it is further provided that the Governor may exempt reticulation works from certain sections of this Act: Now, therefore, His Excellency the Governor, with the advice of the Executive Council, hereby approves of the construction and extension by the Minister for Water Supply, Sewerage, and Drainage of the following works under the said Act, and does hereby exempt such works from the operations of Sections 20, 21, 22 and 23 of the said Act. Description and Location of Reticulation Works Approved and Exempted.—Metropolitan Reticulation Main Extension.—Canning Road District.—Proposed four-inch diameter cast-iron water main, commencing at the existing thirty-six-inch steel main in Railway Promenade at the junction of the said Railway Promenade and John Street, and proceeding thence in a South-Westerly direction along John Street to a point opposite Lot 175 (length about sixteen chains).

The above main to be complete with valve, hydrant, and all necessary apparatus as shown in red on plan M.W.S.S., and D.D., W.A., No. 4855.

This Order in Council shall take effect from the 19th day of October, 1928.

WHEREAS by "The Road Districts Act, 1919," the Road Board of any District is empowered to make By-laws for all or any purposes under the above-mentioned Act, the Wongan-Ballidu Road Board, in pursuance of powers vested under the said Act, and of every other authority enabling it in that behalf, doth hereby make the following, which shall be known and cited as the Building By-laws:—

1. Interpretation.—Unless the context otherwise indicates, the following terms shall bear the meanings set against them:—

"Board"—The Wongan-Ballidu Road Board.

"District"—The Wongan-Ballidu Road District.

"Building"—Any house, store, shop, stable, shed, verandah, lean-to, bough shed, or tent.

"Owner"—The owner of any land, as interpreted under the provisions of "The Road Districts Act, 1919."

"Builder"—Any builder, contractor, painter, or persons engaged in the erection of any building within the meaning of these By-laws.

"Townsite"—The townsite of Wongan Hills.

"Footpath"—Shall include any part of a street set apart for the sole use of pedestrians, and whether the footpath be made or kerbed or otherwise.

“Chairman”—The Chairman of the Wongan-Ballidu Road Board.

“Secretary”—The Secretary of the Wongan-Ballidu Road Board.

2. No owner or builder within the meaning of these By-laws shall erect any building upon any land in the townsite unless he first submits to the Board a copy of the plans and specifications of the building to be erected, and setting out clearly the number of buildings proposed to be built on each particular lot or parcel of land, the measurements, material of construction, and use for which the building is intended.

3. No building shall be commenced unless a copy of the plans and specifications shall have been laid before and approved by the Board, and such copy of the plans and specifications shall receive approval by endorsement set thereto by the hands of the Chairman and Secretary.

4. The Board may reject any plans or specifications which have not, by reason of inflammable material proposed to be used, or other reason, proper regard for the safety of persons or other buildings in the event of fire.

5. The Board may reject any plans or specifications which, in the opinion of the Board, do not bear proper consideration of size or design of construction or architecture to the adjacent buildings.

6. No builder or owner shall open up any road or footpath which by reason of building operations is found necessary unless he first obtains a permit from the Board, and such openings shall be covered or railed and provided with lights to ensure safety to the general public using the road or footpath.

7. Every builder or owner shall, within reasonable time from the completion of any building, fill in and repair to the satisfaction of the Board's authorised inspection officer, all openings on any road or footpath which by reason of building operations it has been found necessary to open.

8. The Board shall have the right to declare any street or streets, or parts of a street, an area wherein no owner or builder may erect buildings of any kind other than of brick, stone, or concrete, with the exception that the Board may permit outhouses to be erected of any material, providing that special application is made.

9. The footpath in all made roads in the townsite shall be 12 feet wide from the building line.

10. The Board shall withhold its permission to build premises to be used for living purposes only unless such premises are specified as follow:—

- (a) to be built not less than 15 feet from the building line;
  - (b) to have a picket or other suitable fence enclosing the block on which the building is to be erected;
  - (c) to be equipped in the case of a one-roomed building with a tank having at least a capacity of 1,000 gallons; in the case of a building having from two to four rooms, with a tank or tanks having a minimum capacity of 2,000 gallons; in the case of a building having more than four rooms, with a tank or tanks having a minimum capacity of 3,000 gallons;
  - (d) to have the E.C.'s erected on the rear boundary abutting on the right-of-way;
  - (e) to have the rear doors to E.C.'s hung with two self-closing hinges, which must be screwed on to the side of the door and not on to the top.
11. No builder or owner shall allow any steps leading to his premises to be erected on a footpath or shall place any other obstruction of any kind on a footpath.
12. Any persons who do any act contrary to, or neglect or omit to do any act required to be done within the meaning of these By-laws, shall incur a penalty of not exceeding Fifteen pounds and a further penalty of not more than Twenty shillings for each day the offence continues.

2. Notwithstanding anything contained in the preceding paragraph, no such discount shall be allowed to any person who at the time of tendering payment of such rates shall be indebted to the Municipality of Kalgoorlie for any arrears of rates of any description whatsoever.

## UNIVERSITY OF WESTERN AUSTRALIA.

*Statute.*

THE following new Statute, which has received the approval of the Governor, is published in the *Government Gazette* in accordance with Section 33 (i) of "The University of Western Australia Act, 1911":—

*Statute No. 20—Conditions of Awarding Hackett Bursaries and Research Studentships.*

1. Under the terms of the Will of Sir John Winthrop Hackett, first Chancellor of the University, the Senate shall offer each year Bursaries and Research Studentships "for the assistance and maintenance of deserving students of the University whose means make it difficult for them to take a University course."

Under the terms of the Will as interpreted by the Order of the Court, No. 20 of 22nd December, 1926, no amendment of this Statute "shall depart from the fundamental object of granting assistance and/or maintenance to those students only who are deserving and of limited means."

2. The Bursaries shall be given under the following conditions:—

(a) The Chancellor shall have received satisfactory assurance that the applicant's own means, and those of his parents or guardians are such as to make it difficult for him to bear the cost of attending the University as a full-time student without the assistance of a Bursary.

(b) The bursar shall attend the University as a full-time student.

(c) Applications for Bursaries should reach the Vice-Chancellor not later than January 15th in each year from persons who have qualified or who expect to qualify for matriculation before the commencement of next session of the University.

(d) The applicant shall at the time of his selection be domiciled in Western Australia or have received a considerable part of his education in the State.

(e) The Bursar shall hold his Bursary only for so long as he shows himself to be diligent and of good conduct and satisfies the Board of Examiners at each annual examination and while his means and those of his parents or guardians are such as to make it difficult for him to bear the cost of attending the University as a full-time student without the assistance of a Bursary.

(f) Subject to the above conditions, the Bursary may be held from the date of the student's entry on the course as a matriculated student for the duration of the course for a pass or Honours degree.

(g) Bursaries may also be granted to—

(i) Undergraduates who have already gone through part of the course, and have then become unable to finish their course without help.

(ii) Unmatriculated students pursuing a full-time course for a Diploma.

3. The Research Studentship shall be given under the following conditions:—

(a) Post Graduate Studentships of a value not exceeding £150 per annum are open to graduates of the University. An additional sum not exceeding £100 per annum may be spent under the direction of the Supervisor of the research for the provision of books, apparatus, and other expenses incidental to the student's work. These books and other materials shall remain the property of the University.

(b) The Chancellor shall have received satisfactory assurance that the applicant's means are such as to make it difficult for him to continue as a full-time research student, without the assistance of a Studentship.

(c) That the Studentship shall be tenable for one year in the University of Western Australia but may be continued for a period to be determined by the Professorial Board, and may then be made tenable elsewhere. When a studentship is held outside the State, a certain proportion of the sum set apart for books, apparatus, etc., may be spent on travelling expenses. This proportion shall be fixed by the Vice-Chancellor and shall not in any case exceed two-thirds of the sum so set apart.

(d) Applications should reach the Vice-Chancellor not later than the third Tuesday in August in each year.

(e) Applicants must submit a scheme of work for the approval of the University.

(f) The awards will be made by the Professorial Board after reports have been received from the Faculties. The Faculty concerned shall, in each case, appoint a supervisor of the student's research. No awards shall be made in any year unless applicants of sufficient merit present themselves, but additional Studentships may be awarded in a subsequent year.

(g) Payment of the grant under the Studentship may be made in instalments, at such times as may be decided, each instalment, with the exception of the first, which will be paid in advance, being payable only on receipt by the University of sufficient evidence that the holder of the Studentship is satisfactorily pursuing his studies.

(h) At the close of the year of tenure the Research student shall be required to supply a full report to the University on the progress he has made with the work originally undertaken, including copies of any theses or publications resulting from his work.

(i) Whenever publication is made of any work carried out under a Hackett Research Studentship, the published work shall include a statement to this effect.

(j) Notwithstanding anything contained in Section 3, Subsection (c), any holder of a Research Studentship may, irrespective of the date of his or her graduation in the University of Western Australia, be permitted under special circumstances to commence or continue such Research Studentship at another University or at a Research Institution outside the State, the grant of such permission and the duration of the period that may be so spent outside the State to be in the discretion of the Professorial Board.

(k) Temporary provision.—Notwithstanding Section (c) above, students who graduated at least one year prior to the institution of the Research Studentships may be allowed, in special circumstances, to hold a Research Studentship from the outset at another University or at a Research Institution outside the State.
