AT a meeting of the Executive Council held in the Executive Council Chambers, at Perth, this 16th day of July, 1929, the following Orders in Council were authorised to be issued:—

The Metropolitan Water Supply, Sewerage, and Drainage Act, 1909.

ORDER IN COUNCIL.

M.W.S. 625/29.

WHEREAS by "The Metropolitan Water Supply, Sewerage, and Drainage Act, 1909," it is provided that, subject to the provisions of the Act, the Minister for Water Supply, Sewerage, and Drainage shall, with the approval of the Governor, have power to construct and extend water works, sewerage works, and stormwater drainage works: And whereas it is further provided that the Governor may exempt reticulation works from certain sections of this Act: Now, therefore, His Excellency the Lieut.-Governor, with the advice of the Executive Council, hereby approves of the construction and extension by the Minister for Water Supply, Sewerage, and Drainage of the following works under the said Act, and does hereby exempt such works from the operations of Sections 20, 21, 22, and 23 of the said Act:—

Description and Location of Reticulation Works approved and exempted—City of Perth—Leederville Ward.—Proposed 12-inch diameter cast-iron and Hume pipe water main commencing at the 12-inch main near the Redan Street Bore, in Lot 12, Vincent Street; thence into and along Vincent Street in a South-Easterly and Easterly direction to a point in line with the Drain Reserve; thence across Vincent Street and South-Easterly along Drain Reserve to the junction with 18-inch main from the Regent Street Bore (length about 19 chains).

The above-mentioned main to be complete with all necessary apparatus as shown in red on Plan M.W.S., S., & D.D., W.A., No. 4942.

This Order in Council shall take effect from the 19th day of July, 1929.

Reciprocal Enforcement of Maintenance Orders Act, 1921.

ORDER IN COUNCIL.

WHEREAS by Subsection 3 of Section 14 of "The Reciprocal Enforcement of Maintenance Orders Act, 1921," the Governor may, upon being satisfied that reciprocal provisions are about to be made by the Legislature or other competent authority of any part of His Majesty's Dominions outside the Commonwealth, for the enforcement within that part, of maintenance orders made by Courts within this State, extend the provisions of the said Act to that part of His Majesty's Dominions to which the said Act extends: And whereas the Governor is satisfied that the competent authority of Nyasaland Protectorate is about to make reciprocal provisions for the enforcement within the Nyasaland Protectorate of maintenance orders made by Courts within this State: Now, therefore, His Excellency the Lieut.-Governor, acting with the advice and consent of the Executive Council, doth hereby extend the said Act to the Nyasaland Protectorate.

Pinjarra School Quarters.

ORDER IN COUNCIL.

P.W. 1036/29; Ex. Co. No. 1893.

ADDITIONAL PORT REGULATIONS.

Shipping Signals.

1. The signal for "Port closed" for navigation purposes and the dredge signal for "Channel blocked" shall be a cone shape between two balls by day and a green light between two red lights by night. The colour of the day marks will correspond with the colours of the lights.

Naked Lights in Ships' holds.

2. The use of flare-up lamps or naked lights of any kind or design whatever in the holds of vessels lying at any of the wharves or jetties of the ports controlled by the Harbour and Light Department, whether for the purpose of working cargo or for any other purpose, is prohibited.

Any person committing a breach of this regulation shall be liable on conviction to a penalty not exceeding Twenty pounds.

The Board shall be entitled to apply the whole or so much of the said sum of £3 as may be necessary in payment or part payment of the amount of any such damage, but nothing in this By-law shall limit or affect any right of action of the Board for any damage done to its footpaths or other property in excess of the said sum of three pounds.

Such sum of three pounds will be returned to the applicant on the certificate of the Building Surveyor that the footpaths or other property of the Board have not been damaged or have been properly reinstated by the applicant.

No. 4. Licenses for hawkers shall be in the form "X" of the Schedule and for stalls in the form "Z" in the Schedule.

No. 5. Every hawker whilst employed in hawking shall produce his license upon being required by any constable or officer of the Board, and shall at all times have affixed to some conspicuous part of his coat, barrow, basket, vehicle or dray a board or plate bearing his name and the words "Licensed Hawker" legibly printed thereon in letters not less than one inch in length.

No. 6. No licensed stall shall be placed or allowed to stand in any street or position other than that mentioned in the license, or between the hours of 9 p.m. and 4 a.m.

No. 7. The following fee shall be paid for licenses to hawkers or stalls, and shall be paid in advance, and if any payment be not paid when due the license shall be void:—

Hawkers' Licenses.

For every hawker with hand basket or tray—20s. per annum.

For every hawker with wheelbarrow or handcart—30s. per annum.

For every other hawker with motor or vehicle drawn by horse or other animal—three pounds three shillings per annum.

Stall Licenses.

For every stall—10s. per month.

No. 8. Every licensed hawker and stall holder shall at all times obey the lawful directions of the secretary or other authorised officer of the Board.

No. 9. No person to whom a Hawker's or Stallholder's License is granted shall lend, transfer, or assign his license granted, and no person shall borrow or make use of any such license granted to a person other than himself, unless by written consent of the secretary.
