ORDER IN COUNCIL.

P.W. 5819/21.

WHEREAS the enactment contained in Section 74 of "The Constitution Act, 1899," whereby the appointment of all public officers under the Government of the State is vested in the Governor in Council does not apply to minor appointments, which by Order in Council are vested in heads of Departments or other officers or persons within the State; and whereas it is desirable that the appointment of foreman and all other persons employed at a daily rate of wage on works under the control of the Public Works and Labour Department should be vested in George Hammond: Now, therefore, His Excellency the Governor, by and with the advice of the Executive Council, hereby vests in George Hammond and any person or persons appointed to temporarily act in his place, the appointment of foreman and all persons employed on such works at a daily rate of wages.

The Land Drainage Act, 1925.
South Belmont Drainage District.

ORDER IN COUNCIL.

P.W.W.S. 739/26.

THIS Agreement, made in pursuance of "The Industrial Arbitration Act, 1912-1925," this 7th day of August, 1929, between the Federated Clerks' Union of Australia Industrial Union of Workers, W.A. Branch, of the one part, and the Perth Hospital Board of Management, of the other part; whereby it is mutually agreed as follows:—

Area and Scope.

This Agreement shall apply to all members of the clerical staff, including telephonists, of the Perth Hospital Board of Management, with the exception of the secretary and assistant secretary.

Definitions.

- "Officer," "worker," shall mean any member of the clerical staff of the Perth Hospital, male or female, covered by this Agreement.
 "Board" shall mean the Board of Management of the Perth Hospital in office.
 "Union" shall mean the W.A. Branch of the Federated Clerks' Union of Australia Industrial Union of Workers.
 "Secretary" shall mean the secretary for the time being of the Union.
 "Temporary clerk" shall mean a clerk who is engaged for a lesser period than three calendar months.
 "Casual clerk" shall mean a clerk who is engaged for a lesser period than four weeks.

Hours of Duty.

The ordinary hours of duty shall be thirty-eight per week, and shall be worked from 9 a.m. to 5 p.m., on Mondays to Fridays inclusive, with one hour off for lunch, and from 9 a.m. to 12 noon on Saturdays.

Overtime.

Overtime shall mean all time worked outside the ordinary hours of duty and shall be paid for as follows:—All time worked on the first five days of the week, at the rate of time and half for the first two hours and double time thereafter. All time worked on Saturdays, and all time worked on Sundays and holidays, at the rate of double time: Provided that, when an officer is required to work on a holiday, he shall receive at least four hours' pay at the penalty rate: Provided that overtime will not be paid for unless same is authorised by the secretary of the Perth Hospital Board.

Meal Money.

If an officer is required to resume duty after the ordinary hours of duty, he or she shall, in addition to the overtime above referred to, be paid 2s. as the price of one meal on each such occasion, or shall be provided with a suitable meal by the Board.

Rates of Pay.

The rates of pay from January 1st, 1929, to June 30th, 1929, are based on a basic wage of £4 5s. per week for males and £2 5s. 11d. per week for females.

Holidays.

(a) The following days shall be observed as holidays and paid for:—New Year's Day, Anniversary Day, Good Friday, Easter Saturday, Easter Monday, Labour Day, Foundation Day, Christmas Day, Boxing Day, Anzac Day, and all gazetted holidays.

(b) Annual Holidays.—All officers shall receive a fortnight's holiday per annum, in accordance with the Rules and Regulations of the Perth Hospital Board, dated June 16th, 1926.

(c) Sick leave.—Sick leave shall be granted to all officers in accordance with the Regulations of the Perth Hospital Board dated June 16th, 1926.

Engagement—Officers.

The employment of any officer shall be terminated by one month's notice on either side. Such notice to expire on the usual pay day.

Temporary Clerks.

The employment of temporary clerks shall be terminated by one week's notice on either side, such notice to expire on the usual pay day.

Preservation of Accrued Rights.

Nothing herein contained shall affect any rights or privileges accrued prior to this Agreement.

Recognition of Union.

All officers shall be members of the Federated Clerks' Union of Australia: Provided that any officer appointed who at the time of engagement is not a member of the Union shall become a member of the Union within fourteen days.

Record Book.

A Record Book shall be kept showing the name of each worker under this Agreement, showing the nature of the work performed, the hours worked each day, and the amount of wages received each pay, the said Record to be open to the inspection of an accredited representative of the Union during working hours.

Reference.

A reference shall be given to any officer of not less than three months' service, containing all necessary information in regard to service and duties performed.

Term.

The term of this Agreement shall be for a period of three years from 1st January, 1929, provided that, at any time after the expiration of twelve months from the commencement of this Agreement, any term or terms thereof may be reviewed by either party giving one month's notice of their desire so to do.

WALLACE CLUBB,

REGULATIONS MADE UNDER SUBSECTION (E) OF
SECTION 37 OF THE EDUCATION ACT, 1928.

(1) The Director may appoint a member of the Clerical Staff of his Department to act in the capacity of Clerk to the Appeal Board, and such Clerk shall have the custody of the records and proceedings of the Board.

(2) Notice of appeal to the Board shall be given by an appellant to the Director within one month after the receipt by the appellant of the notification of the decision appealed against.

(3) The notice shall be in writing signed by the appellant, and shall contain a short statement of the grounds of appeal. Provided that the Board may at any stage of the proceedings allow an appellant to amend the statement of the grounds of appeal on such terms (if any) as the Board may deem just.

(4) The appellant shall deposit with the Director with his notice of appeal the sum of two pounds as security for costs.

(5) The Director, as soon as practicable after the receipt by him of the notice of appeal, shall notify the Clerk to the Board, who shall forthwith arrange for a sitting of the Board to deal with the appeal.

(6) The Chairman of the Board shall appoint a time and place for hearing the appeal.

(7) The Clerk to the Board shall give notice in writing by post or otherwise to the appellant, and to all other persons interested in the appeal of the time and place appointed for the hearing of the appeal. Where the party to be notified resides at a place within a radius of 300 miles from the place of sitting of the Board, seven days' notice at least shall be given; if he resides outside such a radius, 21 days' notice at least must be given.

(8) The Clerk of the Board, if requested so to do by the Director or an appellant, shall send notice to any person whose attendance as a witness is desired at the hearing of the appeal. Should the witness be required to produce any document or other thing at the hearing, the Clerk shall notify the witness accordingly and specify in his notice the particular document or thing required to be produced.

(9) The party requiring the attendance of a witness at the hearing of an appeal shall, if the witness resides or carries on a business at a place more than two miles from the place of sitting of the Board, pay or tender the witness a reasonable sum of money for travelling expenses.

(10) Any person who, having been notified by the Clerk to the Board to attend as a witness, and/or to produce any document or other thing at the hearing of the appeal, and having been paid or tendered reasonable conduct money, if resident more than two miles from the place of sitting of the Board, fails without reasonable cause to attend before the Board and give evidence, or produce any such document or other thing, shall be liable to a penalty not exceeding ten pounds.

(11) The evidence of witnesses who reside more than 20 miles from the place of sitting of the Board may be taken on affidavit sworn before a Justice of the Peace; but the Board may require the attendance of any such witness if it deems it desirable so to do.

(12) The appellant may at any time before the date appointed for the hearing of the appeal, give notice to the Clerk to the Board of his intention to abandon his appeal. In such event the Board may, on the application of the Director, order the appellant to pay the costs (if any) reasonably incurred by the Department in connection with the appeal.

(13) The order of procedure at the hearing of the appeal before the Board shall be as follows:—

- (a) The appellant may attend in person or by his agent;
- (b) The appellant or his agent shall open his case to the Board and may adduce evidence in support of his appeal;
- (c) At the close of the case for the appellant, the Director's representative may adduce evidence in support of the decision appealed against;
- (d) When all the evidence for both parties has been adduced, each party shall be entitled to address the Board on the whole of the evidence. If evidence is called by both parties, the Director's representative may address the Board immediately at the conclusion of the evidence called by him, and the appellant or his agent may then address the Board. If evidence is called by the appellant, and the Director's representative before the conclusion of the appellant's case intimates to the Board that he does not intend to adduce any evidence, the appellant or his agent shall address the Board immediately on the conclusion of the evidence, and the Director's representative shall have the right to reply. If no evidence is called by either party to the appeal, the appellant may address the Board first and will be entitled to a further address in reply to the Director's representative, if he addresses the Board; and the same procedure will be followed where the only evidence adduced is on behalf of the Director.

(14) The Board shall conduct the inquiry without regard to legal forms and precedents, and shall direct itself by the best evidence it can procure, and may regulate its own procedure.

(15) The Clerk shall keep a record of the proceedings of the Board. Any member of the Board, the Director or his representative, shall have access to such record. An appellant shall be entitled to apply for and obtain from the Clerk a copy of the proceedings relating to his appeal. No other person shall be entitled to inspect or obtain copies of proceedings in custody of the Clerk.
