### PROCLAMATION

(Addition to Schedule)

WHEREAS by Section 4 of "The Native Flora Protection Act, 1912," the Governor may at any time by Proclamation add the name of any tree, plant, or shrub to the Schedule of the said Act: And whereas it is deemed expedient that the names of the trees, plants, or shrubs set out hereunder should be added to such Schedule: Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, declares by this Proclamation that the following names shall be added to the Schedule of the said Act:—Pitcher Plant (*Cephalotus follicularis*); Red Banksia (*Banksia coccinea*); "Crowea" (*Crowea denticulata* and *C. angustifolia*); Red Flowering Gum (*Eucalyptus ficifolia*); Palms (*Livistona spp.*) (Kimberley district); Cycads (*Cycas spp.*) (Kimberley district); Black Kangaroo Paw (*Macropidia fuliginosa*); Baobab (*Adansonia Gregorii*); Sturt Pea (*Chianthus speciosus*); Albany Bottlebrush (*Callistemon speciosus*); Kurrajong (*Sterculia Gregorii*); Blanket Plants (species of *Lachnostachys* and *Newcastilia*); Hibiscus (species of *Hibiscus* and *Cienfugosia*); Wild Pomegranate (*Balaustion pulcherrimum*); Cork Tree (*Sesbania grandiflora*) (Kimberley); Orange Creeper (*Marianthus ringens*); Byblis gigantea.

ORDER IN COUNCIL.

P.W.W.S. 815/28.

WHEREAS by "The Water Boards Act, 1904," it is provided that, before undertaking the construction of water works the Minister shall submit plans, descriptions, books of reference, and estimates of the proposed works to the Governor for approval; and that if they are approved, the Governor may forthwith by Order in

Council empower the Minister to undertake the construction of the proposed works: Now, therefore, His Excellency the Governor, with the advice of the Executive Council, hereby approves of the plans, descriptions, books of reference, and estimates marked P.W.D., W.A., 26238, for the construction of water works within the Narrogin Water Area, which were duly submitted for approval, and hereby empowers the Minister for Water Supply, Sewerage, and Drainage to undertake the construction of the said works.

The Metropolitan Water Supply, Sewerage, and  
Drainage Act, 1909.

ORDER IN COUNCIL.

M.W.S. 882/29.

WHEREAS by "The Metropolitan Water Supply, Sewerage, and Drainage Act, 1909," it is provided that, subject to the provisions of the Act, the Minister for Water Supply, Sewerage, and Drainage shall, with the approval of the Governor, have power to construct and extend water works, sewerage works, and stormwater drainage works: And whereas the preliminary requirements of the said Act have been complied with and plans, sections, and estimates in respect of the works hereinafter mentioned have been submitted to and approved by the Governor in Council: Now, therefore, His Excellency the Governor, with the advice and consent of the Executive Council, does hereby empower the Minister for Water Supply, Sewerage, and Drainage to undertake the construction of the following works under the said Act, namely:—Metropolitan Water Supply Improvements.—Claremont Municipality and Claremont Road District.—Proposed 12-inch water main from Goldsworthy Road to Walter Road, along Aggett Road, Bay Road, and Victoria Avenue (length approximately 46 chains), with valves and all necessary apparatus, including the lifting of approximately 34 chains of 3-inch water main, as indicated in red on Plan M.W.S., S., & D.D., W.A., No. 4953.

This Order in Council shall take effect from the 18th day of October, 1929.

Land Drainage Act, 1925.

North Coolup Drainage Area.

ORDER IN COUNCIL.

WHEREAS by "The Land Drainage Act, 1925," the Governor is empowered by Order in Council to constitute the District of a Local Authority, or the Districts of two or more Local Authorities, or any part or parts of such a District or Districts, a Drainage Area, under such name as may be directed: Now, therefore, His Excellency the Governor, by and with the advice of the Executive Council, does hereby constitute an Area having the boundaries described in the Schedule hereunder, a Drainage Area for the purpose of the said Act, under the name of the North Coolup Drainage Area.

The Schedule.

Commencing at a point on the South-West corner of Pinjarra Townsite boundary; thence East along the Southern boundary of the said Townsite to its intersection with the Western boundary of the Main Perth-Bunbury Road; thence Southerly along the Western boundary of the said road to its intersection with the Western boundary of the South-Western Railway Reserve; thence South-Westerly across Murray Location 3 to the South corner of Lot 90 of Coolup Agricultural Area; thence North-Westerly along the South-Western boundary of said Lot 90, and across the Old Bunbury Road to the South-Eastern boundary of Lot 110; thence South-Westerly along the South-Eastern boundaries of Lots 110 and 111 to the South corner of Lot 111; thence North-Westerly along the South-Western boundaries of Lots 111, 112, 132, and 150 to the West corner of Lot 150; thence North-Easterly along the North-Western boundary of Lot 150 to its North corner; thence North-Westerly across the road and along the South-Western boundary of Lot 171 to its West corner, and North-Easterly along its North-Western boundary to the South corner of Lot 179; thence North-Westerly along the South-Western boundary of Lot 179, and across the road to the South-Eastern boundary of Lot 196; thence Westerly across Lot 196 to the South-West corner of Lot 197; thence North along the Western boundaries of Lots 197 and 204 and their prolongation to the shore of Peel Inlet; thence generally Northward along the said shore to a point on the prolongation Westward of the Northern boundary of Murray Location 625; thence Easterly along the said prolongation and the Northern boundaries of Locations 625 and 1017 to the North-East corner of Location 1017; thence South-East and South along the Eastern boundary of said location to its intersection with the Northern boundary of Location 333; thence East along the Northern boundaries of Locations 333 and 335 to the North-East corner of Location 197; thence South along the Western boundary of said location to its South-West corner; thence East along the Southern boundary of Location 197 and the prolongation thereof, across Locations 1178, 1180, 1168, and Reserve No. 525 to its intersection with the Western boundary of Pinjarra townsite; thence South along the said boundary to the point of commencement, as shown in red on Plan.

This Order in Council shall take effect from the 18th day of October, 1929.

In the matter of an Application for a Publican's General License for the Township of Miling, within the Licensing District of Irwin, in Western Australia, and in the matter of "The Licensing Act, 1911," Section 47.

To His Excellency Colonel Sir William Robert Campion, Knight Commander of the Most Distinguished Order of St. Michael and St. George, D.S.O., Governor in and over the State of Western Australia and its Dependencies in the Commonwealth of Australia.

THE humble Petition of the undersigned, being a majority of the Electors living in the area hereinafter defined, sheweth as follows:—

1. It is for the local and public advantage and convenience of the residents of Miling, and of the District of Miling aforesaid, and of the travelling public, that a

## THE INDUSTRIAL ARBITRATION ACT, 1912-1925.

No. 1 of 1929.

The West Australian Cleaners, Caretakers, Lift-attendants, Window Cleaners, Attendants, Watchmen, and Domestic's Industrial Union of Workers, Perth, and The Minister for Works and Labour and other Ministers of the Crown in Western Australia; Australian Mutual Provident Society; Millars' Timber and Trading Company, Limited, and others.

*Award of Industrial Board.*

## 1.—Scope.

This Award shall apply to persons employed as caretakers and/or cleaners, watchmen, window cleaners, lift-attendants and other attendants; but shall not apply to workers in an industry covered by any Award or Industrial Agreement existing at the date of this Award.

The term "Caretaker" shall mean a person required to reside on or in the vicinity of the premises of his employer.

## 2.—Area.

This Award shall operate over that portion of Western Australia comprised in the South-West Land Division and in the area within a radius of five miles from the Kalgoorlie Post Office.

## 3.—Term.

The term of this Award shall be three years from the date hereof: Provided that, after the expiration of one year from such date, either party may make application to the Court of Arbitration for leave to apply to the Court or to this Industrial Board to alter, amend, or revise the same.

## 4.—Time Book.

The employer shall keep a time book or time sheets properly posted each week, showing the times worked by each employee and the wages paid to each employee covered by this Award. Such time book or time sheets, with all entries therein shall, on demand, be produced at any reasonable time during the day by the employer, for inspection by the Secretary of the Union, or by a duly authorised official of the Union.

## 5.—No Discrimination against Unionists.

In the employment of persons under this Award no discrimination shall be exercised against the members of the West Australian Cleaners, Caretakers, Lift-attendants, Window Cleaners, Attendants, Watchmen, and Domestic's Industrial Union of Workers, Perth: Provided, that where a worker other than a member of the Union is engaged, such worker (not being a casual hand) shall within fourteen days of engagement make application for membership of the Union; and, if accepted, shall complete such application.

## 6.—Hours of Labour.

The hours of caretakers shall be 48 (forty-eight) per week. The hours of male cleaners (including window cleaners and lift-attendants) shall be forty-four (44) hours per week, which shall be worked within the hours of six o'clock a.m. and seven o'clock p.m. The hours of attendants in the Public Library shall be forty-four (44) hours per week, which shall be worked between the hours of seven a.m. and 10 p.m. The hours of other attendants shall be forty-eight (48) hours per week and shall be worked between the hours of 8 a.m. and 5 p.m. The hours of watchmen shall be fifty-six (56) hours per week.

The hours of full-time female cleaners shall be not less than twenty-five per week, and shall be worked between 6 a.m. and 7 p.m. on Monday, Tuesday, Wednesday, Thursday, and Friday and before 1 p.m. on Saturday.

## 7.—Overtime.

All time worked in excess of or outside the usual hours shall be paid for at the rate of time and a half for the first four hours after the usual time for ceasing work, and double time thereafter: Provided, that workers called upon to start within an hour and a half of the usual starting time shall be paid at the rate of time and a half until the usual starting time.

Employees required to work on Sundays or on the public holidays specified herein shall be paid double time, with the exception of watchmen, who shall work such days, if required, at ordinary rates of pay.

Provided, that attendants employed at the Public Library, Museum and Art Gallery shall, if required, be on duty on all public holidays and Sundays, and shall be allowed the equivalent time off duty at the convenience of the employer: Provided also, that in respect of employees of the Minister for Education, who are granted holidays in excess of those prescribed herein, any time worked by them on the prescribed holidays may be set off against the holidays allowed to them during school vacations.

#### 8.—Posting Award.

A copy of this Award shall be posted in a suitable place on the premises of every employer.

#### 9.—Notices.

The Secretary may post notices relating to Union business at the place where the copy of the Award is posted.

#### 10.—Holidays.

Except for watchmen, New Year's Day, Anniversary Day, Good Friday, Easter Saturday, Easter Monday, Anzac Day, Labour Day, Foundation Day, Christmas Day, and Boxing Day shall be holidays and paid for at ordinary rates. If workers are called upon to work on such days they shall be paid in accordance with Clause

#### 11.—Annual Leave.

(a) After the completion of twelve months' service all employees, other than watchmen and casuals, shall be granted two weeks' holiday on full pay.

(b) Watchmen shall be granted three weeks' holiday on full pay.

(c) If the service be terminated before the completion of twelve months' service one day's holiday pay shall be granted for each month's service: Provided, that a worker dismissed for gross misconduct shall not be entitled to the benefit of Subclause (c) hereof.

#### 12.—Materials.

All workers under this Award shall be provided with the necessary tools and materials free of charge.

Where an employee is called upon to wash articles the following amounts shall be paid, namely:—

Towels—One shilling and sixpence per dozen.

Dusters—One shilling per dozen.

#### 13.—Outside Cleaning.

No female cleaner shall be permitted to do outside cleaning of windows except when standing on the ground or on a balcony or verandah. No female worker shall be required to use a step-ladder.

#### 14.—Casual Hands.

"Casual Hand" shall mean a worker engaged for six days or less, who may be discharged or leave the employer's service at any time without notice.

#### 15.—Sickness.

No worker shall be entitled to be paid for absence from employment on the ground of personal ill-health for more than six days in any year of service. Before becoming entitled to payment, the worker shall, if required, furnish the employer with satisfactory proof that his absence from employment was the result of ill-health.

#### 16.—Long Service Leave.

In accordance with the conditions adopted by the Western Australian Government, all full-time employees of that Government, whether male or female, shall be granted long service leave.

#### 17.—Wages.

The wages payable under this Award shall be on the following scale:—

#### Conditions.

A maximum amount of seventeen shillings per week may be deducted from the amount of wages of a caretaker for the value of rent, light, and firewood supplied by the employer. In assessing the value of rent, special consideration shall be given to those caretakers who are required to occupy rooms within the building of which they are caretakers.

The value of the accommodation supplied by the employer shall be as agreed upon by the Union and the employer. In the event of their being unable to agree upon such value, the matter shall be referred to this Board for determination.

If a part-time female cleaner is required, in the performance of her work, to travel from her residence to an employer's premises more than once per day, she shall be deemed to be a full-time cleaner and paid accordingly.

Casual male workers shall be paid ten per cent. in addition to the ordinary rate of wage prescribed for their particular work. The amount shall be calculated on an hourly basis with a minimum engagement of two hours.

#### 18.—Junior Workers.

(1) Where an employer has three or more fully-paid window cleaners he may employ one junior worker, who shall not be less than fifteen years of age.

(2) The rates of pay for such junior worker shall be:—

and thereafter the rate for an adult window cleaner.

(3) A junior worker between 15 and 16 years of age shall not be required to do work which necessitates his ascending more than eight feet from the ground.

#### 19.—High or Dangerous Cleaning.

Where it is necessary to go wholly outside of a building to do window cleaning, the worker shall, if such cleaning be twenty-five feet or over from the ground floor or balcony be entitled to be paid threepence extra for each such window.

#### 20.—Higher Duties.

A worker called upon to perform work carrying a higher minimum than his regular rate of pay shall be paid such higher minimum for the particular day whilst so employed upon such higher work. Provided, that acting time less than twenty minutes in any one shift shall not be counted.

#### 21.—No Reduction.

Nothing contained in this Award shall entitle an employer to reduce the wage of any worker who at the date of this Award is being paid a higher rate of wage than the minimum prescribed for his or her class of work.

#### 22.—Piece Work.

In accordance with the provisions of Regulation 115, made under "The Education Act, 1928," workers may be employed by the Minister for Education or by a Head Teacher in the cleaning of schools at the following rates, namely:—Three shillings (3s.) per week for every five hundred and fifty (550) square feet of floor space of rooms.

In the calculation of floor space of rooms corridors, passages, and cloak-rooms shall be included.

In addition to the above verandahs and shelter-sheds will, if floored, be counted at half the rate, and, if not floored, at one-quarter the rate for rooms.

Provided that, if desks are used in such verandahs or shelter sheds, they shall be counted as rooms.

Eight closets will be counted at the same rate as one room of five hundred and fifty (550) square feet. Smaller numbers shall be paid for at proportionate rates.

Where a school is held in a public hall or other hired building, special rates for school cleaning, not less than those prescribed by this Award, may be fixed.

Nothing contained in any other clauses in this Award shall apply to teachers engaged under this clause in cleaning their schools.

## TRAMWAY (OFFICERS).

(Registered 10/10/1929.)

No. 19 of 1929.

THIS Agreement, made in pursuance of "The Industrial Arbitration Act, 1912-1925," this seventh day of October, One thousand nine hundred and twenty-nine, between the Commissioner of Railways for the State of Western Australia (hereinafter referred to as the "Commissioner"), of the one part, and the Western Australian Government Tramways and Electricity Supply Officers' Industrial Union of Workers (hereinafter referred to as the "Union"), of the other part, whereby it is mutually agreed by and between the parties hereto as follows:—

## 1.—Term of Agreement.

The currency of this Agreement shall be three years from the 1st October, 1929, with right of review in accordance with the provisions of "The Industrial Arbitration Amendment Act, 1925."

## 2.—Area and Scope of Agreement.

This Agreement shall apply to all officers engaged in the W.A. Government Tramways and Electricity Supply, except Head of Branch, Subheads of Branch, Shift Engineers, and Control Room Operators.

## 3.—Hours of Duty.

(a) The hours of duty of officers shall be 38 hours per week, exclusive of Sunday time, with the following exceptions:—(1) District Engineer, Cottesloe; (2) Electric Mains Subforeman; (3) Receiving Clerks; (4) Rolling Stock Foreman; (5) Traffic Running Staff.

It has been agreed that, as regards Receiving Clerks, although they are included under those officers whose hours of duty are 44 per week, a trial will be made to see whether it is possible for these officers to work 38 hours per week without the employment of additional staff, as per suggestion made by the Union, under date of 27th August, 1929. If it is found after trial that it is impossible for these officers' hours of duty to be confined to 38 hours per week without employment of additional staff, then they will revert to 44 hours per week.

(b) The hours of officers specified above shall be 44 per week, exclusive of Sunday time: provided that, where the present custom is to work a lesser number of hours, such custom shall continue.

(c) Outdoor Traffic Officers shall not be booked up for duty until they have 12 hours off duty, except to facilitate rotation of shift from Saturday to Sunday.

(d) All shifts shall be completed within ten hours; half-day shifts to be completed within five hours as from time of first signing on duty to final time of signing off duty.

(e) Signing on and off depots for officers shall be Head Office, 514 Hay Street; Power Station, East Perth; Car Barn; East Perth; Cottesloe District Office; Cook Street Substation; or any similar depot as may be established during the currency of this Agreement.

(f) Inspectors shall not be required to work more than five hours fifteen minutes without a meal relief. The minimum time of booking off for a meal shall be forty-five minutes.

## 4.—Overtime.

(a) Overtime shall mean all time worked in excess of the recognised working hours in any one week, and can only be claimed under the following conditions:—

Less than 30 minutes—not to be paid for.

30 minutes and up to 37 minutes—half an hour.

38 minutes and up to 52 minutes—three-quarters of an hour.

53 minutes and up to 67 minutes—one hour.

68 minutes and up to 82 minutes—one hour and a-quarter.

83 minutes and up to 97 minutes—one hour and a-half;

and thereafter on a similar basis.

(b) Overtime shall be paid for at the ordinary rate of pay for all time worked in excess of the recognised working hours up to two hours per day; over that period, time and a-quarter. All time worked in excess of a spread of twelve hours shall stand alone and be paid for at the rate of time and a-quarter.

(c) All officers engaged on work which may be defined by the Commissioner as special, in excess of the recognised working hours, shall be paid overtime at the rate of time and a-quarter for the whole of such overtime.

(d) The recognised hours of duty shall be as laid down in Clause 3 (a) and (b).

(e) In computing the number of hours worked per week, time absent on sick leave and holidays, when paid for, shall be treated as time worked.

(f) Any periods up to five minutes on any days are not to count in the week's total. The first two hours' overtime or any portion thereof in any one day may be adjusted in the week's total. Such adjustment shall take place by being brought on later or booked off earlier, but any overtime beyond the two hours will stand alone and be paid for at the rate of time and a-quarter.

(g) Any officer in receipt of a salary over £433 per annum shall not be entitled to overtime pay.

## 5.—Sunday Time.

(a) Sunday time will stand alone and be paid for at time and a-half rates.

(b) Where less than a full shift is worked on a Sunday, the time worked will be calculated as follows:—

(i) Any officer called upon for Sunday duty shall be paid a minimum of four hours' ordinary pay, except when such time is worked in continuance of a shift beginning on a Saturday or in commencement of a shift terminating on Monday.

(ii) Over half a day and up to and including three-quarters of a day to be counted as three-quarters of a day.

(iii) Over three-quarters and up to one day to be counted as one day.

(iv) An officer who on a Sunday works more than his ordinary week-day rostered shift shall be paid for the actual time worked. A rostered shift shall mean seven hours twenty minutes for those working a forty-four hour week and six hours twenty minutes for those working a thirty-eight hour week.

(c) For the purpose of calculating the hourly rates, the year shall be deemed to consist of 313 days and the day in each case of the usual hours of the officer concerned.

(d) Christmas Day and Good Friday shall be treated as Sunday.

(e) Sunday time shall be paid fortnightly within fourteen days of the last Sunday worked.

#### 6.—Leave of Absence—Annual.

(a) After twelve months' continuous service all officers shall be entitled to annual paid leave of twelve days and public holidays, or days in lieu thereof.

(b) Leave of absence shall be calculated to the close of each financial year, and shall be paid for at the salary the officer is in receipt of at the time such annual leave is taken.

(c) The leave shall be applied for and taken out at a time convenient to the Department before the 30th June following the year for which it fell due. At the expiration of that time the leave shall lapse, unless such leave shall have been deferred by the Department or the permission of the Commissioner obtained for its accumulation.

(d) In urgent cases leave in addition to the foregoing may be granted without pay for a period not exceeding six months. Any public holidays falling due during the period in which an officer is on leave without pay shall not be paid for.

(e) Subject to the proviso hereto, any officer with more than six months' service who may resign or be dismissed from the service, shall be entitled to receive payment for any holidays pro rata up to the time of leaving the service: Provided that, if an officer be dismissed for being under the influence of liquor or for drunkenness, he shall be entitled to be paid for such leave, if any, as was due up to the 30th June previous, and if dismissed for speculation, tampering with ticket issues, or manipulation of the books of the Department, he shall not be entitled to payment of any holidays.

(f) The next of kin of a deceased officer shall be granted payment of pro rata annual leave to the date of the decease of the officer.

#### 7.—Absence without Pay.

Any term in excess of three months an officer is absent from duty from any cause without pay shall not for any purpose be included as part of such officer's period of service.

#### 8.—Long Service Leave.

(a) The Commissioner shall grant to any officer who has continued on the salaried staff for ten years long service leave for three calendar months on full pay or six calendar months on half pay. For the subsequent period of ten years the same conditions shall apply, and thereafter for every seven years similar leave shall be granted.

(b) Service prior to attaining the age of eighteen years shall not count in computing long service leave.

(c) Any public holidays occurring during the period in which an officer is on long service leave will be calculated as portion of the long service leave, and extra days in lieu thereof shall not be granted.

(d) If a deceased officer leaves a widow, dependant children, mother or invalid sister, payment pro rata of long service leave up to the date of such officer's death shall be granted to such dependant or dependants.

(e) (i) Officers regressed to the Wages Staff and reappointed to the Salaried Staff, or appointees from Wages to Salaried Staff shall, for the purpose of this clause, be treated as if the whole of their service had been served on the Salaried Staff; subject to the proviso, that officers who had less than ten years' Salaried service but more than ten years' Wages and Salaried service combined as at the 1st January, 1927, shall be entitled to the first period of leave as from that date.

(ii) For the next period of leave the qualifying service shall be ten years from the 1st January, 1927, and for subsequent leave the qualifying service shall be seven years from the 1st January, 1937.

(f) Any officer who resigns or is retired from the service, except as provided for in subclause (g), shall be paid for long service leave due at the time of resignation or retirement.

(g) Any officer who retires or is retired upon reaching the retiring age, or through ill-health, shall be paid for long service leave pro rata to date of retirement.

(h) An officer dismissed from the service shall not be entitled to payment in respect of long service leave other than for leave that had accrued due to him prior to the date of the offence for which he was dismissed.

(i) A female officer resigning from the service for the purpose of getting married, and who has been continuously employed for three years and over, shall be granted payment pro rata of her long service leave at the date of retirement, subject to the proviso in Subclause (b).

#### 9.—Sick Leave.

(a) Any officer who is incapacitated for duty in consequence of illness or injury shall, as soon as possible, advise his superior officer in sufficient time to admit of arrangements being made for the performance of his duties. Any such officer who fails to do so shall be treated as absent without leave.

(b) Any officer so incapacitated for duty shall also notify his superior officer in sufficient time of the date on which he will be able to resume duty to enable any necessary arrangements to be made.

(c) Should the absence be prolonged beyond one day, the officer shall forward to his superior officer on the second day thereof a certificate from any legally qualified medical practitioner, showing the nature of the illness and the probable duration.

(d) Any officer who finds that he is unable to resume duty on the expiration of the period shown in the first certificate shall thereupon furnish a further certificate, and shall continue to do so upon the expiration of the periods respectively covered by such certificates: Provided, however, that the maximum period between the dates of furnishing any two medical certificates shall be fourteen days.

(e) In cases where incapacity for duty is obvious to the Head of the Branch, he may relieve the officer of the necessity for providing medical certificates.

(f) Any officer shall, if so directed, present himself for examination by a medical officer at such time and place as may be fixed.

(g) Any officer who has been absent for three days (not continuous) in one financial year shall, if instructed by his superior officer, furnish a medical certificate for absences of one day only.

(h) Officers who have conformed to the foregoing may be granted sick leave (exclusive of annual and long service leave) as follows:—Officers with six or less than six months' service—nil; officers with more than six months but less than three years' service—two weeks on full pay for each completed six months' service; officers with three years' service and over—three months on full pay and three months on half pay.

(i) Such leave may be granted in one or more periods, but the aggregate amount of leave on pay provided for must not be exceeded.

(j) In no case shall an officer be granted more than three months on full pay and three months on half pay in any one triennial period, unless otherwise determined by the Commissioner. The triennial period to be the three years preceding the date of illness for which payment is claimed.

(k) No payment shall be made for any absence due to an officer's own fault, neglect, or misconduct.

(l) Indisposition not necessitating confinement to the house will not be regarded as illness in respect of which leave of absence will be granted under this section, excepting under special circumstances, to be approved by the Commissioner.

#### 10.—Meal Allowance.

When an officer is instructed to work during or over meal hour he shall be paid a maximum allowance of 2s. per meal, providing he could not conveniently have his meal in the usual way. Outside a radius of twelve miles from Perth, 2s. 6d. per meal shall be paid.

#### 11.—Resignations and Retirements.

(a) No officer shall leave the department until the expiration of one month's written notice of his intention so to do without the approval of the Commissioner.

(b) One calendar month's notice in writing shall be given by the Commissioner to any such officer whose services are no longer required. Provided that this subclause shall not apply to cases of summary dismissal for misconduct, or to officers for whom the Commissioner is unable to find work, or whom he may deem it unnecessary to employ by reason of any action on the part of any section of his employees, or for any cause beyond his control.

#### 12.—Reductions in Staff.

If at any time the staff may be reduced the following shall be the course adopted with regard to the re-employment of retrenched officers, viz.:—

(a) As vacancies occur the officers retrenched shall, in order of seniority of service, have the offer of re-employment in any position in the Department for which they are qualified.

(b) Any officer having left the Department on account of retrenchment and being re-employed within twelve months shall be credited with the period of former service.

#### 13.—Promotions.

(a) Promotion and the selection of any officer to act in a higher position shall be governed by relative ability, suitability, record, and experience. If everything else is deemed equal, the senior officer shall be selected for promotion.

(b) As a general rule officers and employees of the section in which the vacancy occurs will be promoted to the higher position, but the Commissioner may, when he considers it advisable for the good of the service, select an officer from one section for position in another, either in the same or in a higher range.

(c) When considered necessary, a person from outside the service may be appointed to any position in the service, provided there is not an officer in the service capable of filling the position.

(d) No officer shall refuse compliance with any order directing his transfer from one position to another, but if on appeal the Commissioner is satisfied that the objection is sound, then such officer shall not be penalised.

(e) An officer desiring to be passed over in the event of promotion being offered shall, if his request be acceded to, forfeit all claim to promotion for two years, but if good and sufficient reason be given the Commissioner, he may restore such claim.

(f) All officers promoted to a higher position shall be subject to a probationary period of six months and paid the minimum rate of salary assigned to the range to which they are promoted. At the end of such period the head of the branch shall report to the Commissioner as to the fitness of the officer for the higher position; if the report is satisfactory the appointment will be confirmed as from the date of taking up the duty; if unsatisfactory, the officer will be provided for at the same salary as he was in receipt of prior to the period of probation in the higher position. Provided that, where an officer has been in receipt of a salary equivalent to such minimum for twelve months or over, he shall be paid the intermediate rate; if receiving such salary for a period of less than twelve months, the advance to the intermediate rate shall be made twelve months from the date he receives the salary equal to the minimum.

(g) When a vacancy occurs in the service, if the senior officer is not selected for promotion, applications shall be called for the vacancy.

(h) Should a vacancy occur while an officer is on leave he shall be deemed to have made application for such vacancy, and shall be considered for such position.

(i) All vacancies shall be notified to the staff by a notice exhibited on the Salaried Staff Notice Board in the Head Office for at least seven days prior to filling of such vacancy.

#### 14.—Temporary Clerks.

(a) Temporary clerks shall not be engaged without the approval of the Commissioner in any position classified above the range £228-£293.

(b) The provisions of Clauses 3, 4, 5, 6, 9, 10, and 17 will apply to temporary clerks.

(c) The provisions of Clause 11, provided that the notice to leave received and given shall be one week in lieu of one calendar month, shall apply to temporary clerks.

(d) The daily rate of pay shall be:—

First six months—basic wage plus 18s. per week.

After six months—basic wage plus 21s. per week.

After twelve months—basic wage plus 24s. per week.

#### 15.—Acting in Higher Capacities.

(a) When an officer other than a relief officer performs the duties of a position higher than that in which he is classified, for a term exceeding one lunar month continuous or broken, within any one financial year, he shall be paid from the end of that month while performing any such duties at the minimum salary attached to such higher position.

(b) An officer called upon to occupy a higher position temporarily shall be entitled to increments as though he had been permanently promoted to such position, provided that, in the case of the first increment, the officer shall have performed the higher duties for twelve months continuously; provided further, that the officer shall be entitled to receive the second increment if he shall have performed the higher duties for two years continuously.

(c) Absence on annual leave, long service leave, or sick leave on pay shall be counted as service, provided the officer resumes in the same or another higher position.

#### 16.—General.

(a) The word “officer,” where used in this Agreement, shall, unless inconsistent with the text, mean male or female.

(b) Officers may, on obtaining approval from their superior officer, exchange shifts.

(c) Where it is necessary to work day and night shifts, officers concerned shall work alternate shifts weekly.

(d) Inspectors shall be allowed to wear glasses on duty and when passing the eyesight test.

#### 17.—Passes.

(a) Pass available over the Tramway System shall be issued to all officers.

(b) When an officer is on leave a pass available for the period of such leave over the Tramway System shall be issued in favour of his wife and members of his family under eighteen years of age unmarried, unmarried daughters over eighteen years of age, and the mother of an officer, provided that they are resident with and dependant upon him for support.

#### 18.—Payment of Salaries.

(a) Salaries shall be paid fortnightly on each alternate Friday, except where the usual pay-day falls on a public holiday, when payment shall be made on the previous Thursday.

(b) A day's salary shall be calculated as one three hundred and thirteenth of the yearly rate of salary.

(c) The salary for a fortnight shall be computed by dividing the yearly rate by three hundred and thirteen and multiplying the result by twelve.

#### 19.—Rates of Pay.
