WHEREAS it is provided by Section 233 of "The Road Districts Act, 1919," that Rates throughout a District shall be uniform, except in so far as a Board may fix the rates for any Townsite or any area defined for that purpose by Proclamation at a higher figure within the limits in the said section set forth: And whereas it is desirable to approve of and define the areas hereinafter described as areas within which the Rockingham Road Board may rate at such higher figure: Now, therefore I, the said Governor, by and with the advice and consent of the Executive Council, do hereby approve of and define the following areas, as described in Schedules hereunder, of the Rockingham Road District as areas in which the Rockingham Road Board may fix the Rate at such higher figure as aforesaid, within the limits mentioned in Section 233 of "The Road Districts Act, 1919."

All that portion of the Rockingham Road District bounded by lines commencing on the shores of the Indian Ocean (Cockburn Sound) at their intersection with an East and West line passing through the junction of

RESERVE No. 13322.—BY-LAWS.

1.—Hours.

The Reserve shall be open to the public at all hours free of charge, but subject to the restrictions herein-after contained.

2.—Injury to Things.

No person shall pluck any of the wild or cultivated flowers, or walk on the beds, borders, or putting greens, nor pull up or dig or otherwise disturb any grass, or climb upon or get through or over the fences, or remove or injure any of the gates, turnstiles, fences, buildings or flags; nor disturb, damage or destroy any property or things within the bounds of the Reserve.

3.—Shooting.

No person shall carry or discharge firearms through or on the Reserve, or shoot, snare, or destroy any birds or animals, except as in the next paragraph mentioned.

4.—Dogs, Goats, etc.

All dogs, goats, and poultry found within the Reserve may be destroyed by any of the persons hereinafter referred to as being authorised to prosecute for breaches of this By-law, and the owner shall make compensation, to be recovered before any Justice of the Peace, for any damage done by such dogs, goats, or poultry.

5.—Works.

During the constructing, building, making, repairing or maintaining of any beds, borders, or greens, links, buildings, or other improvements, no person shall interfere with the workmen, gardeners, caretakers, or rangers, or do or cause to be done any act which will or may be likely to interfere with or prevent such constructing, building, making, repairing or maintaining.

6.—Misconduct.

Any person in a state of intoxication or misconducting himself or herself shall be liable to be removed from the Reserve.

7.—Rubbish.

No person shall deposit rubbish or any offensive matter on any part of the Reserve.

8.—Fires.

No person other than the workmen, gardeners, caretakers, or rangers referred to in paragraph 5 hereof shall light any fires on the Reserve.

9.—Games.

In the event of the lease or permit of the Reserve being granted to any person or persons or club for the purpose of enabling any particular game or games to be established on the Reserve, then so long as such lease or permit remains in force no game shall be played on the Reserve which may prevent, hamper, interfere, or compete with such person or persons or club in the use of the Reserve for the purposes set forth in such lease or permit, and no person shall do or cause to be done anything which will or may be likely to interfere or compete with such person or persons or club in any manner in commencing, playing, or carrying on such game or games.

10.—Enforcement.

Any member of the Goomalling Road Board, or the Secretary or Acting Secretary, or Supervisor to the Goomalling Road Board, or any person authorised under the seal of the Goomalling Road Board, or in the event of the Reserve being leased to any person or persons or club, such lessee or permit holder shall have power to enforce these By-laws and take any proceedings hereunder at any time.

11.—Penalties.

Any person offending against any part of these By-laws shall be liable to a penalty not exceeding £10 for each offence.

South Perth Road Board.

By-laws for the Control and Management of Halls.

P.W. 376/23.

WHEREAS by "The Road Districts Act, 1919," the Road Board of any district is empowered to make By-laws for all or any of the purposes mentioned in the said Act; and whereas the South Perth District Road Board, in pursuance of the powers vested in the said Board, under and by virtue of the said Act, and of every authority enabling it in that behalf, doth hereby make and publish the following By-laws:—

1. Interpretation.—In these By-laws, subject to the context—

"Board" means the South Perth Road Board;

"Caretaker" means the caretaker of the hall, or the person acting for the time being in that capacity;

"Hall" means any hall owned or controlled by the South Perth Road Board;

"Hirer" means any person, persons, company, organisation, or club by, or on whose behalf, any hall, room, furniture, or crockeryware is hired from the Board, or used with the permission of the Board;

2. Application for the hire or use of a hall or any room or furniture, or appurtenances of a hall, shall be made to the Secretary of the Board in writing, in the form of Schedule A hereto, not less than 24 hours before such hall, room, or furniture is required.

3. The Board, when granting the use of any furniture or crockery-ware, may fix the date and hour when such furniture or crockery-ware shall be returned to the hall; and when it has not been so returned, the Board may have it returned, or replaced, at the hirer's expense.

4. The Board may demand that, prior to any term of hiring, the hirer shall deposit with the Board a sum of money estimated by the Board as being sufficient to cover the cost of making good any damage that might occur to the hall or appurtenances thereof during such hiring. The Board's determination of the cost of making good any such damage shall be final and conclusive, and such cost or expense incurred under the last preceding By-law (No. 3) shall be retained by the Board out of the deposit lodged by the hirer. Should such cost or expense exceed the amount of the deposit lodged by the hirer, then the amount of such excess shall be a debt due by the hirer to the Board.

5. No person or persons shall be allowed the use of a hall, room, furniture, etc., until after the full rent in accordance with Schedule B hereto has been paid and a written permit for the use of the said hall, room, or furniture, etc., issued by the Board. Such permit may be by way of an endorsement on the receipt for rent paid or otherwise, and must be produced to the caretaker before the hiring will be allowed to commence.

6. The hirer shall give up possession of the premises or furniture, etc., hired, promptly at the time agreed upon, and shall leave the same clean and in good condition, with any furniture hired with a hall or room in its normal position.

7. The Board reserves the right to refuse to hire a hall or any room or furniture to any applicant for the hire of same without assigning any reason for such refusal.

8. The Board may at any time cancel any agreement made for the hiring of a hall or any room or furniture.

9. In the event of two or more applications being made for the hire of the hall or room or furniture for the same date and hour, the Board may, without considering priority of application, determine to which applicant the hire of a hall or any room or furniture shall be granted.

10. The hirer of the hall or any room shall comply with the provisions of the Health Act, Entertainments Tax Act, Copyright law, and any other Act in force for the time being applicable to such hiring and use of hall or any room. If in the opinion of the Board all the necessary actions have not been taken to comply with the provisions of the aforementioned Acts, the Board may at any time prior to or during the term of an engagement forbid and prevent the use of a hall or any room.

11. In the event of the use of the hall or any room being forbidden or prevented under the last preceding By-law, the hirer shall forfeit the full amount payable for the hire of the hall or any room, as if the hire had been duly fulfilled, and the Board shall not be responsible for any loss or damage incurred by the hirer.

12. No fermented or spirituous liquors shall be brought into or consumed in a hall or any room, except when permitted by the Board in writing.

13. When so required by the Board or the Caretaker, no person shall smoke any tobacco, nor strike or otherwise ignite any light in a hall or any room during any ball or public entertainment, or at any gathering of persons in the said hall, or in any room, whether such persons have been admitted by the payment of money or otherwise.

14. No person shall in any part of a hall or any room—

- (a) use profane or improper language;
- (b) enter or be allowed to enter whilst intoxicated;
- (c) be guilty of any misbehaviour whatsoever;
- (d) damage, mark, or deface any wall or any part of a hall or any room; any person who does, permits, or suffers such damage shall be liable to pay the cost of all such damage in addition to any penalty imposed by these By-laws;
- (e) stand, loiter, or cause any obstruction whatsoever: any person so doing shall immediately disperse on being requested to do so by the hirer, the Secretary, the Caretaker, or other duly authorised officer of the Board or Police Constable, whether in uniform or otherwise.

15. No offensive impersonations or representations of living persons, or anything calculated to produce a disturbance, riot, or breach of the peace shall be permitted in the hall or any room.

16. No encouragement shall be given to improper characters to assemble in a hall or any room.

17. Children under 10 years of age must be under responsible supervision when in a hall or a room.

18. The hirer of a hall or any room shall maintain and keep good order and decent behaviour in such hall or room, and shall be responsible for the carrying out of these By-laws, and for any damage done to buildings, fixtures, fittings, furniture, or crockery-ware during his or her term of hiring, and shall pay such damages as shall be assessed by the Board. Any article of crockery-ware or furniture not accounted for, or in a cracked or broken condition, shall be paid for at current rates or prices.

19. No confetti or similar material shall be used in any hall or room in connection with any entertainment or otherwise, unless an amount of 2s. 6d. over and above the rent is first paid to the Board.

20. The Secretary, Caretaker, or other duly authorised officer of the Board, or Police Constable when dressed in uniform or otherwise, shall be permitted to have free ingress to a hall or any room at all times during the term of engagement, and every facility shall be given them for enforcing these By-laws.

21. Every person who does, permits, or suffers any act, matter, or thing contrary to any of these By-laws, or commits or permits any breach or neglect thereof, shall be liable on conviction to a penalty not exceeding £20 for every such conviction.

THE MUNICIPAL CORPORATIONS ACT, 1906.

Municipality of Cottesloe.

P.W. 1352/21.

A By-law of the Municipality of Cottesloe, made under Section 179 of "The Municipal Corporations Act, 1906," and numbered 23, for the General Control and Management of Reserves 16189, 13719, 16188, 6896, 13718, and 16187 (Cottesloe), and the Cottesloe Jetty.

IN pursuance of the powers conferred by the said Act, the Mayor and Councillors of the Municipality of Cottesloe order as follows:—

Repeal—By-law of the Municipality of Cottesloe No. 23, passed on the 25th day of May, 1915, is hereby repealed.

Interpretation—In the construction of this By-law, unless the context otherwise requires—

"Beach" means the sea beach on and/or adjacent to Reserves 16189, 13719, 16188, 6896, 13718, and 16187, Cottesloe;
"Council" means the Council of the Municipality of Cottesloe;
"Jetty" means the Jetty at Cottesloe on and extending into the sea from Reserve No. 13718, and shall include the Shelter Shed erected thereon;

"Proper Bathing Costume" means a costume covering the body from the shoulders to the thighs, with an overpiece or skirt extending from the hips to a point half way between the hips and the knees, and which shall be composed of wool or wool and cotton mixture;

"Reserve" means any portion of the Reserves above-mentioned, including all buildings, erections, and structures thereon.

1. No person shall create or commit any nuisance, or behave in a disorderly manner, or use indecent or improper language on the reserve, or upon the beach or the jetty.

2. No person shall climb on or over any building, shelter shed, or lavatory, or climb on or over any fence or fixture erected on the reserve or the beach, or upon or over the shelter shed erected on the jetty.

3. No person shall pry into or over or enter any lavatory, bathing shed, or building, or portion of a building erected upon the reserve or the beach expressly reserved for the use of the opposite sex.

4. No person shall enter any portion of the reserve or the beach which has been fenced off or otherwise closed to the public.

5. No person shall break, injure, pull up or destroy any tree, shrub, or grass growing on the reserve or the beach.

6. No person shall cut, mutilate, deface or disfigure the jetty, or any buildings, erections, fixtures, or structures upon the beach or the reserve, or without the written consent of the Council write, paste, or affix any notice or advertisement thereon.

7. No person shall expectorate or throw lighted matches upon any portion of the jetty, or upon any building, erection, or structure on the reserve or the beach.

8. No person shall place or break, or permit to be placed or broken, any glass, metal, bottle, or utensils on the reserve or the beach, and no person shall deposit or leave any rubbish, refuse, paper, broken glass, china, or litter of any kind thereon except in receptacles provided for that purpose.

9. No person shall, without the written consent of the Council, remove any sand, soil, or stone from the reserve or the beach.

10. No person shall, without the permission of the Council, allow any horse, cattle, sheep, donkey, mule, pig, or other animal, or any fowl or other bird, to enter or stray upon the reserve or the beach.

11. No person shall, either on the reserve or the beach, or upon the jetty, without the written consent of the Council—

- (a) in any way damage, alter, or interfere with the electric light fittings or electrical equipment;
- (b) sell or offer or expose for sale any goods or merchandise;
- (c) engage in any public speaking or in any musical, dramatic, or athletic performance;
- (d) alter, deface, or remove from its position any notice board or other sign erected by the Council;
- (e) take any intoxicating liquor into any bathing pavilion, dressing shed, or other building;
- (f) carry or discharge any firearm, or throw or discharge any stone or other missile.

12. No person shall cause, or permit any dog of which he is the owner, or of which for the time being he has control, to be on that portion of the beach situated between the Moodoorup rocks on the South and the

projection of the Northern side of Eric Street on the North, between the hours of 9 a.m. and 9 p.m. daily. Any dog found on the beach in contravention of this By-law may be destroyed.

13. Every person on the beach shall, when not attired in ordinary apparel, wear a proper bathing costume, and every person on any portion of the reserve (other than the beach), when not attired in ordinary apparel, shall wear, in addition to a proper bathing costume, a dressing gown or other garment of a similar nature, which shall completely cover the body.

14. No person shall use any surf board on the following portions of the beach, that is to say:—

- (a) between the Moodoorup rocks on the South and the Northern boundary of John Street on the North;
- (b) between the point opposite the Southern boundary of Eric Street and a point opposite the Southern boundary of Reserve No. 1203.

15. No person, without the written consent of the Council first had and obtained, shall camp or lodge at night in or occupy as sleeping quarters any stall, building, or structure of any kind erected on the reserve or the beach.

16. No person shall—

- (a) enter upon or remain on the jetty in bathing costume;
- (b) enter or remain upon the reserve or the beach or upon the jetty whilst visibly under the influence of liquor;
- (c) fish from the jetty on the Eastern side of the shelter shed thereon;
- (d) fish from any portion of the jetty on any day when a notice is affixed thereon by order of the Council prohibiting fishing therefrom;
- (e) clean fish or cut bait on the rails or seats or deposit fish refuse on any portion of the jetty;
- (f) bring any bicycle or other vehicle upon the jetty or the promenade or ramps leading thereto.

17. The Council may at any time, and from time to time, charge a fee of not more than 6d. per head for admission to the jetty. At such times as such fee is payable notice thereof shall be exhibited at the shore end of the jetty, and no person shall enter thereon unless in possession of a ticket, which must be produced on demand by any member or official of the Council or by any person authorised by the Council.

18. Any person attempting to do any of the things expressly or impliedly forbidden in this By-law, shall be liable to a punishment as if he had committed the offence.

19. Every person offending against any provision of this By-law shall be liable for every such offence to a penalty not exceeding £10.
