WHEREAS it is provided by "The Vermin Act, 1918," that "Vermin" means and includes any animal or bird mentioned in the Third Schedule to the said Act, and such other animals or birds, the names of which the Governor may by Proclamation add to the said Schedule, and it is further provided by such Act that any such Proclamation may be restricted in its operation to any portion of the State to be defined by the Proclamation; and whereas it is desirable to declare Kangaroos to be vermin within the portions of the State hereinafter mentioned: Now, therefore I, the said Governor, by and with the advice and consent of the Executive Council, do by this Proclamation add "Kangaroos" to the Third Schedule of the said Act: Provided, however, that this Proclamation shall be restricted in its operation to the Black Range Vermin District.

The Metropolitan Water Supply, Sewerage, and  
Drainage Act, 1909.

ORDER IN COUNCIL.

M.W.S. 548/29.

WHEREAS by "The Metropolitan Water Supply, Sewerage, and Drainage Act, 1909," it is provided that, subject to the provisions of the Act, the Minister for Water Supply, Sewerage, and Drainage shall, with the approval of the Governor, have power to construct and extend water works, sewerage works, and stormwater drainage works: And whereas it is further provided that the Governor may exempt reticulation works from certain sections of this Act: Now, therefore, His Excellency the Governor, with the advice of the Executive Council, hereby approves of the construction and extension by the Minister for Water Supply, Sewerage, and Drainage of the following works under the said Act, and does hereby exempt such works from the operations of Sections 20, 21, 22, and 23 of the said Act:—

Description and Location of Reticulation Works approved and exempted.—The construction, as a reticulation work, of a 6-inch diameter stoneware pipe sewer with manholes and all other apparatus connected therewith:—Commencing at Manhole No. 4060 and proceeding West for a distance of 218 feet to Manhole No. 4055 situated in Matlock Street; thence North along Matlock Street for a distance of 72 feet to Manhole No. 4056; thence West for a distance of 132 feet to Manhole No. 4057, situated in Lot No. 6, North Beach Road, in lieu of the 6-inch diameter sewer, between Manhole No. 4049 and a point about 70 feet up stream from Manhole No. 4056, which were portions of the works as advertised in the *Government Gazette* of Western Australia on the 28th day of February, 1930, and as detailed in the plans and specifications therein referred to.

This Order in Council shall take effect from the 12th day of September, 1930.

Brookton Road and Vermin Board.

By-laws for the Regulation and Licensing of Hawkers.

P.W. 1841/22.

WHEREAS by "The Road Districts Act, 1919," the Road Board of any District is empowered to make By-laws for all or any of the purposes mentioned in the said Act: And whereas the Brookton District Road and Vermin Board, in pursuance of the powers vested in the said Board, under and by virtue of the said Act, and of every authority enabling it in that behalf, doth hereby make and publish the following By-laws:—

1. In the construction of these By-laws, subject to the context, "Board" shall mean the Brookton Road and Vermin Board.

2. No person shall hawk any fruit, fish, vegetables, or any article of merchandise within any part of the Board's District without first obtaining a license from the Board.

3. Any person who trades or travels on foot or with any vehicle or animal, or carries to sell, or expose or offer for sale within the Board's district any of the articles or things above mentioned shall be deemed to hawk the same:

Provided that nothing contained in this section shall apply to any person or persons paying rates, or liable to pay rates, for any shop or store carrying on the usual business, trade, and delivery trade, or delivery of goods therefrom.

4. A Hawker's License shall be in the Form No. 3 in Schedule A attached hereto.

5. The fees to be paid for licenses issued to hawkers shall be as set forth in Schedule B attached hereto.

6. Every application for a Hawker's License shall be made during the currency of the financial year in which the license is to have effect; and every such license shall have effect for and during that year, or the unexpired portion thereof, and no longer.

7. Every hawker, while employed in hawking, must produce his license, upon being required to do so by any police officer or officer of the Board.

8. Every hawker shall rigidly affix to some conspicuous part of his cart, barrow, or other vehicle or basket, and at all times maintain thereon, a board or plate bearing his name and the words "Licensed Hawker," legibly written thereon, in letters not less than one inch in height and of corresponding breadth.

9. No person to whom a Hawker's License shall have been granted shall lend, transfer, or assign his license, and no person shall borrow or make use of such license granted to a person other than himself.

10. Every person who does, permits, or suffers any act, matter, or thing contrary to these By-laws, or

commits or permits any breach or neglect thereof, shall be liable on a conviction to a penalty not exceeding £10 for every such conviction.

## TRAFFIC ACT, 1919-26.

## Traffic Regulations—Additions and Amendments.

P.W. 966/30.

REGULATION No. 60 is hereby amended by the addition of the following paragraphs:—

(a) Within the City Block, Perth, and the Town Block, Fremantle, the driver of any vehicle shall not turn such vehicle so as to proceed in the opposite direction, unless such turning can be made in safety and without backing or otherwise interfering with traffic.

Provided that, between the hours of 4.30 p.m. and 6.30 p.m. on a week day, and between the hours of 11 a.m. and 1.30 p.m. on a Saturday, no vehicle shall be turned so as to proceed in the opposite direction.

(b) (1) The driver of a vehicle intending to turn to the left at an intersection shall approach the point of turning by driving as near as possible to the left-hand edge or kerb of the street.

(2) The driver of a vehicle intending to turn to the right at an intersection shall approach the point of turning by driving such vehicle with the outside wheels within at least two feet of the centre of the road.

Provided that, in a street set apart for traffic to proceed in a specified direction, the driver of a vehicle intending to turn to the right at an intersection shall drive such vehicle as near as possible to the right-hand edge or kerb of the street.

Regulation No. 239 is hereby deleted and the following inserted in lieu thereof:—

No person in charge of any vehicle shall cause or permit such vehicle to stand on any portion of the streets of Perth or Fremantle set forth hereunder, except on authorised stands, for a longer period than 15 minutes:—

In the City of Perth:—Wellington st.—from Pier st. to Milligan st.; William st.—from Wellington st. to St. George's ter.; Murray st.—from Milligan st. to Irwin st.; St. George's ter.—from Milligan st. to Irwin st.; Pier st.—from St. George's ter. to Wellington st.; Barrack st.—from Wellington st. to St. George's ter.; Hay st.—from Havelock st. to Irwin st.

In the City of Fremantle:—Market st.—from Elder Place to South ter.; South ter.—from Market st. to Norfolk st.; Adelaide st.—from High st. to Point st.; William st.—from High st. to Henderson st.; High st.

Provided that between the hours of 4.30 p.m. to 6.30 p.m. on a week day, and between the hours of 11 a.m. and 1.30 p.m. on a Saturday, no vehicle shall stand on any portion of the streets herein

mentioned for a longer period than five minutes:—Barrack st.—Eastern side, from Wellington st. to St. George's ter.; Murray st.—North side, from William st. to Barrack st.; William st.—Eastern side, from Wellington st. to St. George's ter.; William st.—Western side, from St. George's ter. to Wellington st.

Provided also, that no person in charge of any vehicle shall cause or permit such vehicle to stand on any portion of King Street or Queen Street, Perth, for a longer period than 5 minutes.

Regulation 240 is hereby deleted and the following inserted in lieu thereof:—

Between the hours of 4.30 p.m. and 6.30 p.m., on any week day, and between the hours of 11 a.m. and 1.30 p.m., on any Saturday, no person in charge of any vehicle shall cause or permit such vehicle to stand on the Western side of Barrack Street, from St. George's Terrace to Wellington Street; on the North side of Hay Street, from Pier Street to Milligan Street; on the South side of Murray Street from King Street to Pier Street, in the City of Perth, and, in the City of Fremantle, in High Street, on the North side, from Henry Street to Queen Street, and on the Eastern side of Market Street from Elder Place to South Terrace; and in Adelaide Street on the North side from High Street to Queen Street.

Provided that this regulation shall not render it unlawful for a vehicle to be stopped for a sufficient time to enable a person to enter or alight from the vehicle.

The following Regulation is added:—

240A. Between the hours of 4.30 p.m. and 6.30 p.m., on any week day, and between the hours of 11 a.m. and 1.30 p.m., on any Saturday, no driver of any vehicle shall, within the City Block, Perth, turn such vehicle to the right at any intersection where traffic is regulated by a police constable.

Provided that this regulation shall not prohibit drivers of vehicles turning to the right from a road set apart for traffic in any specified direction.

Provided also, that this regulation shall not apply to omnibuses making the necessary turns at the terminal points of their routes.

Regulation 241 is hereby amended by the addition of the two paragraphs hereunder:—

(v) All vehicular traffic using that part of Pier Street between Murray Street and Hay Street shall pass only in a Southerly direction.

(vi) All vehicular traffic using Howard Street shall pass only in a Southerly direction.
