The Forests Act, 1918.

ORDER IN COUNCIL.

Forests File 2056/25.

WHEREAS by "The Forests Act, 1918," it is provided that the Governor may by an Order in Council declare any Crown lands as Timber Reserves, within the meaning and for the purpose of that Act, or may revoke in whole or in part such reservation: Now, therefore, His Excellency the Administrator, with the advice and consent of the Executive Council, do hereby revoke in part Timber Reserve 68/25 by exercising therefrom the area described in the schedule hereunder.

An area of about 345 acres bounded by lines commencing at a point on the Northern side of a deviation of Road No. 114 situate about 1,100 links North and about 500 links West of Angle Peg No. A92, on old road survey, and extending Northward about 8,000 links; thence Eastward about 4,500 links; thence Southward about 6,000 links; thence Westward about 1,500 links; thence Southward about 3,000 links to and thence generally Westerly and North-Westerly along said Northern side of Road deviation to the starting point, subject to survey. Forests Act, 1918.

ORDER IN COUNCIL.

F.D. 1781/30.

WHEREAS by "The Forests Act, 1918," it is provided that a dedication under the said Act of Crown land as a State Forest may be revoked in whole or in part in the following manner:—(a) the Governor shall cause to be laid on the Table of each House of Parliament a proposal for such revocation; (b) after such proposal has been laid before Parliament, the Governor, on a resolution being passed by both Houses that such proposal be carried out, shall by Order in Council revoke such dedication: And whereas His Excellency the Governor did cause to be laid on the Table of each House of Parliament his proposal dated the Twenty-first day of October, 1930, for the revocation in part of the dedication of Crown lands as State Forest: And whereas after such proposal had been laid before Parliament a resolution was passed by both Houses that such proposal should be carried out: Now, therefore, His Excellency the Administrator, with the advice and consent of the Executive Council, doth hereby revoke in part the dedication of Crown lands as State Forest No. 20, by excising that portion of such State Forest as is described in the Schedule hereto:—

The Pearling Act, 1912-29.

ORDER IN COUNCIL.

2856/21.

WHEREAS by Section 45 of "The Pearling Act, 1912-29," it is made lawful for the Governor to close any portion of a pearl-shell area, and to prohibit the gathering, collection, or removal of any pearls or pearl-shell within or from the portion so closed for a specific period: And whereas it is deemed expedient that the whole of that portion of the Shark Bay Pearl-Shell Area known as South Passage Section, other than those portions held under Exclusive License, shall be closed and that the gathering, collection, or removal of pearls or pearl-shells within or from that portion so closed shall be prohibited: Now, therefore, His Excellency the Administrator, by and with the advice and consent of the Executive Council, hereby directs that the above-mentioned portion of the said Pearl-Shell Area shall be closed, and that the gathering, collection, or removal of pearls or pearl-shells within or from the portion so closed shall be prohibited for a period of twelve (12) months from the 14th day of December, 1931.

THE TRAFFIC ACT, 1919-30.

Koorda Road Board.

ORDER IN COUNCIL.

P.W. 919/28.

WHEREAS under the provisions of "The Traffic Act, 1919-30," the Governor may by Order in Council empower a Local Authority to exercise within its District any power of making Regulations which the Governor can exercise under Division 4 of Part IV. of the said Act: And whereas it is advisable to empower the Koorda Road Board to make By-laws to regulate the use of roads within its District with a view to prevention of undue damage thereto, and for that purpose to prohibit the passage of heavy traffic over any specified road within its District, and define what shall be deemed heavy traffic for such purpose, and impose a penalty of not exceeding £20 for the breach thereof: Now, therefore, His Excellency the Administrator, with the advice and consent of the Executive Council, under the provisions of the said Act and all other powers enabling him in this behalf, doth hereby empower the Koorda Road Board to make By-laws to regulate the use of roads within its District with a view to the prevention of undue damage thereto, and for that purpose to prohibit the passage of heavy traffic over any specified road, either generally or during certain months of the year, and define what shall be deemed heavy traffic for that purpose and impose a penalty not exceeding £20 for the breach thereof.

The Metropolitan Water Supply, Sewerage, and Drainage Act, 1909.

ORDER IN COUNCIL.

M.W.S. 778/31.

WHEREAS by "The Metropolitan Water Supply, Sewerage, and Drainage Act, 1909," it is provided that, subject to the provisions of the Act, the Minister for Water Supply, Sewerage, and Drainage shall, with the approval of the Governor, have power to construct and extend water works, sewerage works, and stormwater drainage works: And whereas the preliminary requirements of the said Act have been complied with, and plans, sections, and estimates in respect of the works hereinafter mentioned have been submitted to and approved by the Governor in Council: Now, therefore, His Excellency the Administrator, with the advice and consent of the Executive Council, does hereby empower the Minister for Water Supply, Sewerage, and Drainage to undertake the construction of the following works under the said Act, namely:—

Metropolitan Sewerage.—Fremantle District—Reticulation Area No. 18:—9-inch, 6-inch, and 4-inch reticulation sewers, with all manholes, inspection shafts, and all other apparatus connected therewith.—Portion of East Fremantle and Melville Road Boards between Canning Road and View Terrace and Birdwood Circus West and Alexandra Road, within the boundaries as shown in blue on Plan M.W.S., S., & D.D., W.A., No. 5130.

This Order in Council shall take effect from the 27th day of November, 1931.

HIS Excellency the Administrator in Executive Council has been pleased to approve of the Regulations relating to the payment of survey fees being amended as set out hereunder.

REGULATIONS—SURVEY FEES.

1. Subject to the proviso hereto the cost of survey of land shall be in accordance with the scale set out in the First Schedule hereto. Provided that, in special cases approved by the Minister, the cost of survey of land shall be the actual cost incurred in the survey of the land as certified in writing by the Surveyor General.

2. Except as hereafter provided, where land is selected under Parts V. and VI. of "The Land Act, 1898," the cost of survey, with interest, is included in the price of the land, and shall be payable by instalments as set out in the Second Schedule hereto, where such cost of survey is ascertained in accordance with the scale set out in the First Schedule hereto, but, where the cost of survey is the actual cost of survey, as certified in writing by the Surveyor General, as provided for in the proviso to Regulation 1, the same shall be payable by instalments over the respective periods mentioned in the said Second Schedule, but in such amounts as shall be determined by the Minister.

3. The cost of survey of land purchased by direct payment under Section 57 of "The Land Act, 1898," with interest, is included in the price of the land, and shall be payable by instalments as set out in the Third Schedule hereto, where such cost of survey is ascertained in accordance with the scale set out in the First Schedule hereto, but, where the cost of survey is the actual cost of survey, as certified in writing by the Surveyor General, as provided for in the proviso to Regulation 1, the same shall be payable by instalments over the period mentioned in the said Third Schedule in such amounts as shall be determined by the Minister.

4. The cost of survey of land purchased under Section 60 of the said Act, with interest, is included in the price of the land, and shall be payable by instalments as set out in the Fourth Schedule hereto, where such cost of survey is ascertained in accordance with the scale set out in the First Schedule hereto, but, where the cost of survey is the actual cost of survey, as certified in writing by the Surveyor General, as provided for in the proviso to Regulation 1, the same shall be payable by instalments over the period mentioned in the said Fourth Schedule, but in such amounts as shall be determined by the Minister.

5. The cost of survey of land selected under Part VIII. of "The Land Act, 1898" (Homestead Farm), with interest, shall be payable by instalments as set out in the Fifth and Sixth Schedules hereto, where such cost of survey is ascertained in accordance with the scale set out in the First Schedule hereto, but, where the cost of survey is the actual cost of survey, as certified in writing by the Surveyor General, as provided for in the proviso to Regulation 1, the same shall be payable by instalments over the respective periods mentioned in the said Fifth and Sixth Schedules respectively, but in such amounts as shall be determined by the Minister.

6. (a) Except as hereafter provided no application for land under Parts V., VI., or VIII. of "The Land Act, 1898," shall be approved, if such land is not surveyed before selection, until the land applied for has been surveyed, classified, and valued.

(b) After such survey and classification the application will be approved and the applicant duly notified, but in no case shall he be entitled to a return of any portion of the deposit paid in connection with his application.

(c) The Minister may, in his discretion, approve of applications before survey in special cases where the delay in survey and classification in view of the isolation of the land applied for, or other sufficient reason, would cause hardship or inconvenience to the applicant.

(d) Whether the land is surveyed or unsurveyed at the time of selection, no applicant shall be entitled to a refund of any portion of the money he has paid with his application, should the approval notice have been issued, or the land have been surveyed as a result of his application prior to issue of the approval notice.

7. Notwithstanding anything in these Regulations to the contrary, the Minister may in his discretion in any particular case refuse to effect the survey of any land for an applicant or lessee unless the applicant or lessee shall pay, or agree to pay, as the case may require, the full cost of the survey in such amounts, in such manner, and at such times as the Minister shall in writing direct.

8. Where a lease is surrendered or forfeited, the Minister may direct that the cost of the survey, or the unpaid balance thereof, shall be paid to the Minister forthwith by the person in whom the lease was vested at the date of the surrender or forfeiture.

These Regulations shall come into operation as from the 27th day of November, 1931 (inclusive).

By-laws.

IT is hereby notified, for general information, that His Excellency the Administrator in Council has been pleased to approve of the following By-laws of the Collie Recreation and Park Lands Board, under Section 8 (1) of "The Parks and Reserves Act, 1895."

By-law No. 1—Interpretation.

1. In these By-laws, except where otherwise provided, or unless the context otherwise indicates:—

The use of the word "Reserves" shall mean those portions of Reserves A7927 and B7945 more particularly defined in the First and Second Schedules of "The Collie Recreation and Park Lands Act, 1931," or any other reserves or portions of a reserve which may from time to time be vested under the control of the Collie Recreation and Park Lands Board.

"The Board" shall mean the body corporate, under the name of the "Collie Recreation and Park Lands Board," created under the provisions of "The Collie Recreation and Park Lands Act, 1931."

"Permission" shall mean the permission of the Board first obtained and expressed in writing.

2. (a) The Board may appoint a secretary, at such remuneration or salary (if any) as it thinks fit.

(b) The secretary shall keep a register of the members of the Board, and shall record any change of membership as may take place from time to time, together with a record of attendances at meetings.

Meetings.

3. (a) There shall be one annual general meeting, held in the month of July in each and every year, at a time and place to be decided upon by the Board. The business at such annual general meeting shall be for the purpose of preparing and adopting the annual financial statement, to be certified by an auditor approved of by the Minister and to be presented to the Minister; secondly, for the purpose of preparing and adopting a report of the Board's proceedings and operations during the preceding year. For the purpose of this By-law "Year" shall be deemed to be the year ending on the 30th June.

(b) There shall be held an ordinary meeting of the Board, at such frequency, date, time, and place as shall be decided upon and requested—(a) by any three or more members of the Board; or (b) by the Board sitting as such at any preceding ordinary meeting: Provided that, should any ordinary meeting be decided upon and requested by any three or more members as aforesaid, then the secretary shall be notified accordingly of the date, time, and place requested, and the substance of the matter to be raised and discussed, and the secretary shall then send to each member of the Board at least three days' notice in writing of the date, time, and place so fixed, and the substance of the matter to be raised and discussed, but non-receipt of such notice by any member shall not invalidate the proceedings of any such ordinary meeting.

(c) The Board shall act by a majority of votes, and if at any meeting there is an equality of votes, the president, chairman, or member actually presiding shall have a second or casting vote.

(d) The Board shall commence business so soon after the hour fixed for the holding of a meeting as aforesaid as there is a sufficient number of members in attendance to constitute a quorum; but if at the expiration of ten minutes after the time fixed for the holding of the said meeting there is not a quorum present, the business shall be transacted at that meeting, but such meeting shall be adjourned to such time, date, and place as a majority of the members then present shall decide, and the secretary shall thereupon give at least three days' notice in writing to the members of the Board of the time, date, and place of such adjournment.

(e) Minutes of the proceedings of all meetings, whether "annual," "general," or "ordinary," shall be recorded by the secretary, who will, as soon after the said meeting as convenient and practicable, make duplicate copies thereof, and shall send one of such duplicate copies to each member of the Board, together with a notice of the next ordinary Board meeting (if arranged); and when such further ordinary Board meet-

ing is held, a copy of such minutes of the last preceding ordinary Board meeting shall be placed before each member of the Board present at such meeting for confirmation and adoption, and no discussion shall be permitted thereupon, except as to their accuracy as a record of the proceedings.

After the confirmation and adoption of the said minutes in the manner aforesaid, a copy thereof shall be signed by the chairman and shall be filed subsequently by the secretary in chronological order on a file or files kept for that purpose.

The Seal.

4. The Board shall provide a Common Seal which shall always be deposited with the secretary and shall never be used except by the authority of the Board previously given and then only in the presence and accompanied by the signatures of the chairman and secretary of the Board. No person dealing with the Board shall be bound or concerned to see or inquire as to the authority under which any instrument is sealed or in whose presence.

Accounts.

5. (a) The banking account shall be kept in the name of the Board, at such bank as the Board shall from time to time appoint. Every sum exceeding one pound to be paid by the Board shall be paid by cheque on the bankers.

(b) Cheques shall be drawn, signed, and endorsed in such manner and by such person or persons as the Board shall from time to time direct.

(c) No payments shall be made without the order of the Board, except payments on petty cash account, for which the Board may place at the disposal of the Secretary such sum as it thinks fit, not exceeding at any one time ten pounds, and the secretary shall make, at such times as the Board directs, a return of all receipts, payments, and liabilities on petty cash account.

(d) All subscriptions, donations, rents, tolls, fines, and other moneys payable to the Board, shall be received by the secretary or such other officer of the Board as the Board shall appoint to receive the same, who shall forthwith pay the same into the bank account. The receipt of the secretary or such other officer shall be a sufficient discharge.

(e) The Board shall cause true accounts to be kept, in such manner as it thinks fit, of all the receipts, credits, payments, and liabilities of the Board, and of each object or purpose in the management or administration whereof the Board shall for the time being act, and of all other matters necessary for showing the true state and condition of the Board. Such books, and all vouchers relating thereto, and all the documents belonging to the Board, shall be kept by the secretary, or at such place or places and under the control of such person as the Board may from time to time appoint, and (subject to any reasonable restrictions as to the time and manner of inspecting the same that may be imposed by the Board) shall be open to the inspection of any member of the Board.

(f) The secretary shall submit a balance sheet to the annual general meeting of the Board, together with a statement made up to the 30th day of June next preceding the date of the annual general meeting or such other day as the Board shall from time to time determine, of the income and expenditure of the Board since the last preceding statement, and a report on the state and progress of the Board. The balance sheet, statement, and report shall be signed by the chairman and the secretary, or in such other manner as the Board shall from time to time direct, and a printed copy thereof shall, three days previously to the said annual general meeting, be sent to each member of the Board.

Audit.

6. (a) The Board shall propose the appointment of an auditor or auditors for the approval of the Minister of the Crown charged with the administration of the Department of Lands and Surveys, and, after obtaining such approval by the said Minister, the salary or remuneration, if any, of such auditor or auditors shall be fixed by the Board and paid out of moneys applicable to the general purposes of the Board.

(b) Not less than one month before the annual general meeting of the Board there shall be delivered by the secretary to the auditors the accounts and vouchers relative thereto, and the balance sheet as on the 30th June, together with a statement of income and expen-

diture for the year, and the auditors shall examine the same, and within ten days after the receipt thereof shall report thereon.

(c) The auditors shall have access to all the books of account and documents of the Board, and shall receive such information and assistance from the secretary and other officers of the Board as they may reasonably require.

Control of Vehicles.

7. No person shall drive, ride, convey, or impel any motor car, motor cycle, bicycle, carriage, cart, aeroplane, or other vehicle within the Reserves, except upon a declared public highway or road, or place specially set apart for that purpose.

Class of Vehicles.

8. No passenger vehicle plying as an omnibus, or which plies for hire, nor any vehicle, team, cart, or waggon used for carrying any goods, bricks, stone, wood, iron, or merchandise of any kind (whether laden or not), nor any hearse, mourning coach, camel, pack-horse, or other beast of burden shall enter or pass through the Reserves.

Timber and Firewood.

9. No person shall cut or remove any tree or sapling, or any part thereof, either living or dead, for any purpose whatever without permission.

Damaging Growth.

10. No person shall injure, cut, break, deface, pull up, pick, remove, or destroy any tree, shrub, plant, flower, or grass growing on the Reserves, or remove or damage stakes or labels therein, nor hang, nor attach clothing or other articles thereto.

Soil, Fences, and Grass.

11. No person shall cut up, damage, disfigure or interfere with the soil, turf, or surface of any part of the Reserves, or the roads or footways across, around, or over the same, or with any part of the fences, buildings, electrical equipment, rock work, water cocks, or seats around or upon the same, or pollute or interfere with any ornamental water therein, or interfere with or destroy any birds, animals, or fish therein in any manner whatsoever.

Stone.

12. No person shall remove stone, gravel, or earth from any part of the Reserves.

Animals, Birds, and Fish.

13. No person shall disturb, interfere with, catch or destroy any bird, animal, or fish, nor their nests, spawning grounds, or other habitat within the Reserves, nor enter any portion set apart or enclosed for their sole use for breeding or otherwise.

Rubbish.

14. No person shall deposit or leave any rubbish, refuse, paper, broken glass, china, or litter of any kind whatsoever, within the Reserves, except in the receptacles provided, nor break bottles, china, or other similar substance therein.

Behaviour.

15. No person shall misconduct himself, or indulge in any riotous or indecent conduct, or use any indecent or improper language, or offend against decency as regards dress on the Reserves.

Intoxicating Liquor.

16. No person shall bring into or consume within the Reserves any intoxicating liquor, nor enter thereon when visibly under the influence of liquor.

Expectoration.

17. No person shall spit or expectorate upon any path, grass, structure, or erection within the Reserves.

Camping.

18. Subject to the provisions of By-law No. 33 no person shall camp, lodge, or tarry overnight, or frequent the Reserves for the purpose of camping, lodging, or tarrying overnight.

Seats for Ladies.

19. No man shall occupy a seat which is set apart for the use of ladies.

Bill Sticking.

20. No person shall post, stick, stamp, stencil, paint, or otherwise affix, distribute, or give out any placard, hand bill notice, advertisement, or any document whatsoever, upon any tree, fence, post, gate, wall, flagging, road, path, or any place whatever on the Reserves, and no person shall cause to be done any of the acts herein prohibited.

Fires and Shooting.

21. No person or persons shall carry or discharge any firearms, or throw or discharge any stone or other missile, or set off any fire balloons, or throw or set fire to any fireworks, or kindle or make any fire on any portion of the Reserves without the permission of the Board.

Games and Animals.

22. No person shall play, practice, or indulge in any games, sport, or gymnastic exercise, or exercise horses, dogs, or other animals for racing upon the Reserves without the permission of the Board.

Trading.

23. No person shall, without permission of the Board, sell or expose for sale any goods, wares, or merchandise or purchase, solicit or offer to purchase any bottles on any portion of the Reserves.

Straying Stock.

24. No person shall cause or suffer any horse, cattle, sheep, dog, goat, camel, donkey, mule, pig, or other animal, or fowl or other bird, to enter, stray, or feed upon the Reserves without permission of the Board.

Meetings.

25. No person shall organise, arrange, advertise, or take part in any fete, picnic, or concert, or engage in public worship, preaching, or public speaking of any kind, or in any meeting of like character on the Reserves without the permission of the Board.

Betting.

26. No person shall bet or offer to bet publicly on any part of the Reserves.

Trespass.

27. No person, except workmen employed in the Reserves, shall enter any place enclosed for trees, flowers, or shrubs, or plantations of young trees, nor step, nor walk upon, or jump across any plot therein which may be set apart for shrubs, plants, or flowers.

Obstructing Employees.

28. No person shall in any part of the Reserves wilfully obstruct, disturb, interrupt, or annoy any other person in the proper use or enjoyment of the gardens, or wilfully obstruct in the execution of his duties, or insult, or neglect to obey the lawful directions of, or refuse, or neglect to give his name and address, or give a wrong name or address, to any officer, gardener, keeper, labourer, workman, or other person employed in any connection therewith.

Sails.

29. No person shall spread or dry sails or other similar material upon the Reserves.

Traffic.

30. The laws relating to the regulation of traffic in force for the time being under "The Traffic Act, 1919," and its amendments and the regulations made thereunder, shall be observed upon the Reserves, but always with the limitation that no person shall at any time drive, ride, or impel any carriage, motor car, motor cycle, bicycle, tricycle, or other vehicle at a speed exceeding 12 miles an hour.

Fees.

The Board may from time to time at its discretion, levy and collect an admission fee, not exceeding one shilling, for each and every vehicle or person entering these Reserves or any portion or enclosure thereof. The Board may also levy and collect, by itself or its agents, such charges as it may determine for the use of tennis courts, swimming pools, buildings, and/or other conveniences in the Reserves, or for any other improvement under control of the Board.

Mooring Boats.

31. No boat shall be moored or anchored, or kept or left moored, or anchored, or unattended, opposite or near any part of the river which may be set aside from time to time unless such boat is and remains at least one chain below low-water mark, except as hereinafter provided.

Swimming Area.

32. Notwithstanding the provisions of any other By-law, areas may be set apart for bathing and swimming, and no boat of any description shall be permitted to enter or remain in such area. Such areas may be defined from time to time by the placing of posts at intervals along the said side of such area, and the posting of a notice indicating the purpose of the area thus set apart.

Permits for Camping.

33. Notwithstanding the provisions of any other By-law, camping may be permitted in areas set apart for the purpose, but not elsewhere, on the Reserves, upon the issue of a permit from the Camp Controller, and subject to the following conditions:—

- (a) For the purposes of this By-law the term "Camp Controller" shall mean the person appointed by the Board from time to time to control and supervise the camping areas, and shall particularly apply to the Caretaker of these Reserves.
- (b) The permit will indicate the site to be occupied, and the Controller's decision in any dispute shall be final. Fees are payable prior to the issue of permits, on the scale of five shillings per week or part thereof. Extensions of the permit may be secured upon the payment of a further fee upon the above scale.
- (c) No person shall sublet any camp, or sell, give, or otherwise dispose of any permit to any person.
- (d) Except by permission of the Camp Controller, no person shall bring into or keep within the camping area any animal or birds whatever.
- (e) No person shall misconduct himself or indulge in any riotous or indecent conduct, or use any indecent or improper language, or offend against decency as regards dress in the camping area.
- (f) No person shall bring into or keep or consume in the camping area any intoxicating liquor, nor enter, nor remain thereon when visibly under the influence of liquor.
- (g) Campers must keep the area covered by their permit in a clean sanitary condition at all times. All rubbish capable of destruction by fire shall be burned by the occupier in the approved fireplace.
- (h) All campers must use the sanitary conveniences provided, and in no circumstances will improvised conveniences or individual camping sites be permitted.
- (i) No person shall cause or permit any damage to trees, shrubs, or grass, whether naturally or artificially planted, within or surrounding the camping area. The presence of green timber or foliage on the area covered by any camping permit shall be prima facie evidence that the holder of the permit has caused or permitted damage, unless the permit holder has pointed out the damage before taking over camping site.
- (j) Camping permits may at any time be withdrawn by the Camp Controller, if in his opinion a breach of these By-laws has been committed, or if, in his opinion, it is desirable that the permit shall be terminated. In the event of termination hereunder, the rental paid shall be forfeited to the Board, and no compensation shall be claimed or paid for loss, damage, or inconvenience suffered through the withdrawal of the permit.
- (k) Subject to the right of the Camp Controller, and the officers and employees of the Board, or any person acting under their instructions, or any police constable, to enter any camping site at any time, no person shall enter into or remain within such camping site, except with the permission of the holder of the permit.
- (l) No fires shall be lighted on any camping area, except in places approved by the Camp Controller.

Penalty.

34. Any person offending against any of the provisions of these By-laws shall be liable on conviction to a penalty not exceeding Twenty pounds, in addition to, being immediately removed from these Reserves.

TOWN PLANNING AND DEVELOPMENT ACT, 1928.

Section 30 (1), Second Schedule, Paragraph 6.

By-laws for Control of Hoardings.

Part I.—Interpretation.

1. In these By-laws, unless the context otherwise indicates—

"Advertising device" shall mean and include any advertisement, signboard, poster, or other sign, painted notice, electrical advertising device, or other illuminated sign.

"Land" includes land, hereditaments, tenements, and also houses, buildings, and other works and structures.

"Local sign" shall mean any advertising device, or other device or figure, carving, or design put up or affixed upon or to any land which shows, consists of, or indicates the name of or the trade, business or calling of the person in actual occupation of the said land, and which shows, consists of, or indicates nothing else whatever.

The term explicitly includes signs erected upon land indicating that the said land is to let or for sale and giving the names and addresses of the agents or vendors.

"Near to"—Any advertisement or sign so situated with relation to any road or any land as to be plainly visible to ordinary eyesight, when viewed from such road or such land, shall be deemed to be "near to" such road or such land.

"Person" shall mean and include any person or association of persons, firm, or body corporate.

"Put up" shall mean and include make, erect, put up, or operate, or suffer or cause to be or to remain made, erected, put up, or operated.

"Responsible officers" shall mean the Town Planning Commissioner or his Deputy and/or the officer of the Local Authority charged for the time being with the administration of these By-laws.

"Town Planning Commissioner"—Commissioner appointed under "The Town Planning and Development Act, 1928," or any person temporarily acting as the Commissioner.

"Town Planning Board"—The Board appointed under "The Town Planning and Development Act, 1928."

"Trade, business, and calling" shall mean and include any trade, business, industry, calling, occupation, pursuit, pastime, operation, engagement, or activity of whatsoever sort carried on, undertaken, or engaged in by any person, whether the same be or be not carried on, undertaken, or engaged in for the purpose of profit.

Part II.—General Provisions.

2. Every existing advertising device, upon, over, or near to any road or footway or land under the control of any Local Authority which does not conform in all respects with the requirements and provisions of these By-laws shall be removed, obliterated, or taken down within the period of twelve months next after the date of the publication of these By-laws in the *Gazette*, or shall, within that period, be altered in construction or situation or by repainting or relettering or otherwise, so as to conform with the requirements of these By-laws,

Provided that advertising hoardings licensed on the 24th day of September, 1930, which require to be altered or removed by such By-laws, shall be so altered or removed within a period of five years from the aforesaid date, the 24th day of September, 1930.

3. Every advertising device and every advertising hoarding shall be securely constructed and maintained to the satisfaction of the responsible officer.

4. (1) No person shall put up or maintain any sign or advertisement in such a position which, in the opinion of the responsible officer, would create a danger to traffic by obstructing the view of persons in charge of vehicles or animals upon any road, or otherwise.

(2) No person shall put up any signboard or advertisement so as to obstruct access to or from any window, door, or fire escape; provided that this shall not include a window used for the display of goods or merchandise.

5. The owner of or other person using any advertising device shall—

- (1) maintain the same, and all things appertaining thereto, in a clean, tidy, and slightly condition;
- (2) whenever required by the responsible officer by written notice, repaint or renovate the same;
- (3) forthwith, upon notice from the responsible officer that the same is against public decency, or morality, remove or obliterate the same;
- (4) if the advertising device is put up over any road or footway, keep the same free from any accumulation of dust or other unsightly matter.

6. (1) No person shall put up any swinging signboard or sign, or advertising device, or any advertising device constructed wholly or partly of calico, canvas, paper, or other flimsy material, so as to overhang or to be over any road or footway or land under the control of a Local Authority or the Main Roads Board.

(2) The responsible officer may cause any such sign or signboard or advertising device to be removed, without notice, at the expense of the owner thereof.

7. (1) No person shall put up or permit, or suffer to be put up on land under his control, any advertising device (not being a temporary local sign) near to the Swan River, or its tributaries from source to mouth, or any water front or lakeside within the boundary of any Local Authority; provided that this By-law shall not be deemed to prohibit the putting up of any advertising device which is so remote from the said Swan River and tributaries or other waters as to be inconspicuous when viewed therefrom; or put up, or permit, or suffer to be put up, any advertising device fronting any improved park or improved reserve; provided that, where there is a predominance of industrial or commercial buildings, this clause shall not apply.

(2) No person shall put up or permit, or suffer to be put up, any advertising device on any land in a residential street, except to exhibit his name and trade or calling.

A residential street is one in which the greater part of the frontage to such street between two cross streets is occupied by residences; provided that this clause shall not apply to a gazetted shopping area, or to any section of any street which the responsible officer certifies to be a future shopping area.

8. No person shall put up, or permit to be put up, near to any road, railroad, or land under control of a Local Authority, any advertising device upon any advertising hoarding that shall obstruct any view from any public highway which, in the opinion of the responsible officer, should not be obstructed; or put up, write, or make any advertising device, notice, intimation, or quotation upon any road or footway under control of a Local Authority or Main Roads Board, or on any tree or other surface thereon, except as herein provided.

9. (1) No person shall, near to any road, footway, or land under the control of the Local Authority, put up any advertising device upon any advertising hoarding—

- (a) unless such advertising hoarding is at least its own height from the building line of any street, thoroughfare, or footpath;
- (b) unless such advertising hoarding is constructed in accordance with a design and specification approved by the Local Authority, consisting of an advertising panel or panels painted to the approval of the said Local Authority, and supported or surrounded by, or contained within, structural features of an ornamental or decorative character.

10. Subject as in this By-law herein provided, if any advertising device shall be put up on any land or upon any advertising hoarding or other hoarding, wall, fence or other structure, or rock, stone, tree, or other thing near to any road, footway, or land under the control of a Local Authority, in contravention of these By-laws, and the person putting up such advertising device is not known, then any person interested or benefited or capable of being interested in or benefited by the putting up of such advertising device shall be deemed to have committed and be held liable for the breach whereby these By-laws have been so contravened: Provided always, that these By-laws shall not apply in the case of any advertising device put up as aforesaid which the Local Authority in whose district the same is put up by resolution declares to be for a national, charitable, or religious purpose, but such advertising device shall be removed forthwith after the purpose for which it was put up shall have ceased to exist.

11. If any person shall, either by act or omission, contravene any of these By-laws, he shall be guilty of an offence under these By-laws, and on conviction for such offence shall be liable to a penalty not exceeding Ten pounds, and also, if such offence is in its nature a continuing offence, to a daily penalty not exceeding Ten pounds during the continuance of the offence.

12. These By-laws shall not apply to and shall not in any manner whatsoever bind the Crown, or any Government department, or Government instrumentality, or any State trading concern.

13. These By-laws shall have the force of law in the district of every Local Authority in the State as defined in the said Act, excepting only the Municipalities of Perth and Fremantle.
