The Road Districts Act, 1919.

Armada-Kelmscott Road District.—Alteration to Ward Boundaries.

ORDER IN COUNCIL.

P.W. 1805/23.

WHEREAS under the provisions of "The Road Districts Act, 1919," the Governor may by Order in Council sever any portion of a Ward of a Road District and annex it to another Ward: And whereas it is desirable to—(1) sever portion of the West Ward of the Armada-Kelmscott Road District and annex it to the Kelmscott Ward of the said District; (2) sever portion of the Roleystone Ward of the Armada-Kelmscott Road District and annex it to the Kelmscott Ward of the said District; (3) sever portion of the Roleystone Ward of the Armada-Kelmscott Road District and annex it to the Armadale Ward of the said District; (4) sever portion of the Roleystone Ward of the Armada-Kelmscott Road District and annex it to the Bedforddale Ward of the said District; (5) abolish the Forrestdale Ward of the Armada-Kelmscott Road District and include such territory within the West Ward of the said District: Now, therefore, His Excellency the Administrator, by and with the advice and consent of the Executive Council, under the provisions of the said Act and all other powers enabling him in this behalf, doth hereby—(1) sever that portion of the West Ward of the Armada-Kelmscott Road District described in Schedule A hereto and annex it to the Kelmscott Ward of the said District; (2) sever that portion of the Roleystone Ward of the Armada-Kelmscott Road District described in Schedule B hereto and annex it to the Kelmscott Ward of the said District; (3) sever that portion of the Roleystone Ward of the Armada-Kelmscott Road District described in Schedule C hereto and annex it to the Armadale Ward of the said District; (4) sever that portion of the Roleystone Ward of the Armada-Kelmscott Road District described in Schedule D hereto and annex it to the Bedforddale Ward of the said District; (5) abolish the Forrestdale Ward of the Armada-Kelmscott Road District and include such territory within the West Ward of the said District.

#### Schedule A.

All that piece of land bounded by lines commencing on the District boundary at the Northern corner of Jandakot A.A. Lot 90 and extending North-Eastward and South-Eastward along said District boundary to the present Ward boundary; thence Southward along part of the present boundaries of the Roleystone and Kelmscott Wards to the production North-Eastward of the North-Western boundary of Lot 23 of Location 31; thence along said production and part of the said North-West boundary and the North-Eastern boundaries of Lots 24 and 27 of the said location, part of the South-East and the North-East boundary of Jandakot A.A. Lot 37; thence Southward along part of the Eastern boundary of said Sub. Lot 37 and the Eastern boundaries of Sub. Lots 43 and 44 and part of the Eastern boundary of Lot 86, the Northern and the East boundary of Lot 82, and the East boundary of Lot 83 to the South-East corner of the last-mentioned lot; thence Westward along the South boundaries of Lots 83 and 84 and of Sub. Lots 49, 51, 52, 53, and the South side of Roads Nos. 1346 and 2971 to the East side of Road No. 122; thence South along said side of Road 122 to the South side of Lilian Avenue (Road No. 3846) and West along said side of Lilian Avenue to the Eastern side of the South-Western Railway Reserve; thence Northward along part of the present boundary of the Roleystone Ward and part of the present boundaries of the Kelmscott Ward and again along part of the present boundary of the Roleystone Ward to the starting point.

#### Schedule C.

All that piece of land bounded by lines commencing on the present Ward boundary at the intersection of the production West of the South side of Lilian Avenue (Road No. 3846) with the Eastern side of the South-Western Railway Reserve and extending Eastward along said side of Lilian Avenue to the Eastern side of Road No. 122; thence North along said side of Road No. 122 to the South side of Road No. 2971 and East along said side of Road No. 2971 to the North-West corner of Lot 122 (Location 31); thence South along the West boundary of said Lot 122 to the present Ward boundary at its South-West corner and West and North along the present Ward boundaries to the starting point.

The Road Districts Act, 1919.

Augusta-Margaret River Road District.—Alteration of Boundaries with the Sussex Road District and Redivision into Wards.

ORDER IN COUNCIL.

P.W. 189/21.

WHEREAS under the provisions of "The Road Districts Act, 1919," the Governor may by Order in Council sever any portion of a Road District and annex it to an existing Road District and may redivide a District into Wards: And whereas it is desirable to—(1) sever portion of the Augusta-Margaret River Road District and annex it to the Sussex Road District; (2) sever portion of the Sussex Road District and annex it to the Augusta-Margaret River Road District; (3) redivide the Augusta-Margaret River Road District into seven Wards: Now, therefore, His Excellency the Administrator, by and with the advice and consent of the Executive Council, under the provisions of the said Act and all other powers enabling him in this behalf, doth hereby—(1) sever parts of Locations 2593, 3001, and 3000, also certain vacant lands from the Augusta-Margaret River Road District and annex same to the Sussex Road District; (2) sever parts of Locations 2947, 1692, 2228, 2239, 2240, 3005, 3006, and 3036, also certain vacant lands from the Sussex Road District and annex same to the Augusta-Margaret River Road District, in order that the South boundary of the Sussex Road District and the North boundary of the Augusta-Margaret

River Road District shall be as described in Schedule A hereto; (3) redivide the Augusta-Margaret River Road District into seven Wards, with the names, boundaries, and number of members allotted to each Ward as shown in Schedule B hereto.

#### SUSSEX AND AUGUSTA-MARGARET RIVER ROAD DISTRICTS.

##### Redescription of Portion of Common Boundary.

Commencing at the junction of the shores of the Indian Ocean with the production West of the South boundary of Sussex Location 540 and extending Eastward along said production and South boundary and the Southern boundaries of Locations 1052, 1053, and 1081, part of the Western, the South, and the Easternmost boundary of Location 1668, the North and the East boundary of Location 1669 (Reserve 1465), the North-West and North-East boundaries of Location 2947, the North-Eastern boundary of Location 1686, and part of the North-Eastern boundary of Location 2949, the West and North boundaries of Location 1683, the North and North-Eastern boundaries of Location 3175, the North-Eastern boundary of Location 1689, and part of the North-Eastern boundary of Location 1690, the North-Western boundary of Location 1692, the South-Western boundary of Location 2730; thence along the Western side of the Busselton-Augusta Railway Reserve to the production West of the South boundary of Location 2594 and along said production and South boundary, the South boundaries of Locations 3193 and 2537, part of the North boundary of Location 2202 and the North boundaries of Locations 2203 and 2204; thence along the Southern side of a surveyed road to and along the Northern boundary of Location 2228 and the Northern boundaries of Locations 2239, 2240, 2241, 3002, 3005, and 3006, the South-Western and South-Eastern boundaries of Location 969 (Reserve 18521), the South-Western boundaries of Locations 3032 and 3033, a North, a West, the Northernmost and part of the East boundary of Location 3036, the Northern boundaries of Locations 3037, 3038, and 3039 to the North-Eastern corner of the last-mentioned location; thence North to the production West of the South boundary of Location 696 (the present boundary).

#### Schedule B.

#### AUGUSTA-MARGARET RIVER ROAD DISTRICT.

##### Description of Ward Boundaries.

##### Cowaramup Ward.

Bounded on the Westward and Northward by part of the district boundaries from the right bank of the Margaret River to the intersection of the production South-Eastward of the North-Eastern boundary of Sussex Location 2194 with the Western side of the Busselton-Augusta railway reserve; on the Eastward by lines commencing at the said intersection, and extending Southward along said side of the railway reserve to an East and West line passing through the 26-Mile Post on the Busselton-Karridale Road; thence East to the Eastern side of said road and South along same to intersect the Northern boundary of Margaret River townsite; on the Southward by lines commencing at the last-mentioned intersection, and extending Westward along parts of the North and West boundaries of the said townsite to the right bank of the Margaret River, and along said bank of the river to the starting point. ##### Margaret Ward.

Bounded on the Northward by the Southern boundary of the Cowaramup Ward and by part of the North boundary of Margaret River Townsite to the North-East corner of the said Townsite; on the Eastward by lines commencing at the said North-East corner and extending Southward along the East and part of the South boundaries of the said Townsite to the Eastern side of the Busselton-Karridale Road; thence South along said side of the road passing along the Western boundaries of Locations 2151, 2152, 859, 1066, 2154, 2155, 2173, 2812, 2807, and 1627; the North and West boundaries of Location 1617, the Westernmost, a Southern and a Western boundary of Location 1616, the West-

ernmost boundary of Location 1615, part of the North and Western boundaries of Location 1554, the Western boundaries of Locations 1635, 1636, and the South boundary of the last-mentioned location; thence along the Western side of the Busselton-Karridale Road to the North boundary of Location 1564 and along part of the North, the West, and part of the South boundary of the last-mentioned location; the West boundaries of Locations 1649 and 1650 and continuing along the Eastern side of the road to and along the North-Western and Western boundaries of Location 1965, the Western boundaries of Locations 1964 and 3186, and continuing to and along part of the West boundary of Location 2601 to intersect the production East of the North boundary of Location 968; on the Southward by lines commencing at the last-mentioned intersection, and extending Westward to and along the North boundaries of Location 968, Reserve 1942, and Location 1386 and to and along the South boundary of Location 1358 to the shores of the Indian Ocean; on the Westward by the shores of the Indian Ocean to the starting point. (Two members.)

##### The Rapids Ward.

Bounded on the Northward and Eastward by part of the district boundary from the North-Eastern corner of the Cowaramup Ward to intersect an East and West line passing through the Southernmost corner of Location 2891; on the Southward by the said East and West line to the Southernmost corner of Location 2891 and continuing along the right bank of the Margaret River to the East boundary of Margaret River Townsite; on the Westward by part of the East and North boundaries of the said Townsite, and the East boundary of the Cowaramup Ward to the starting point. (One member.)

##### East Ward.

Bounded on the Northward by the South boundary of the Rapids Ward; on the Eastward by part of the district boundary to the right bank of the Blackwood River; on the Southward by the right bank of the Blackwood River to the North-Western corner of Location i; thence along part of the West boundary of said Location i to the South-East corner of Location 2402; on the Southward by lines commencing at the said South-East corner and extending Westward along the South and part of the Western boundary of said Location 2402, the North-Western boundary of Location 2404, the South and part of the West boundary of Location 2403, the North boundary of Location 2659, the South boundaries of Locations 2262, 1274, and 232, part of the East, the South, and part of the West boundary of Location 1357, the North boundary of Location 3143, part of the East, the North, and part of the Western boundary of Location 1968, the South boundary of Location 1955, part of the East and South boundaries of Location 1954, the East and part of the North boundaries of Location 2601 to the East boundary of the Margaret Ward; on the Westward by the East boundary of Margaret River to the starting point. (One member.)

##### Karridale Ward.

Bounded on the Northward by the South boundary of the Margaret Ward and part of the boundaries of the East Ward to the right bank of the Blackwood River; on the Eastward by the said bank of the Blackwood River to Point Dalton (Hardy Inlet); thence South to the Northern boundary of Location e, and again Westward along the Southern shore of Hardy Inlet to the North-Eastern corner of Location 934, along the East and South boundaries of the said location, and part of the South boundary of Location 946, the Eastern boundaries of Locations 1242, 1435, and 1152, part of the North, and the East boundary of Location 1380 (Reserve 13984), and the Northern boundary of Location h to the shores of the Indian Ocean; and Westward by the shores of the Indian Ocean to the starting point. (Two members.)

##### Augusta Ward.

Bounded on the Northward and Westward, and again Northward by the boundaries of the Karridale Ward and the North boundary of Location e; thence South along its Eastern boundary to the shores of Flinders Bay; thence Southward along said shores of Flinders Bay, Westward and Northward along the shores of the Indian Ocean to the starting point. (One member.)

## Blackwood Ward.

Bounded on the Westward by part of the boundaries of the Augusta, Karridale, and East Wards, and on the Northward by part of the South boundary of the East Ward; on the East and South by part of the District boundary to the starting point. (One member.)

## The Road Districts Act, 1919.

Serpentine-Jarrahdale Road District.—Alteration of Boundaries with the Rockingham Road District.

## ORDER IN COUNCIL.

P.W. 792/31.

WHEREAS under the provisions of "The Road Districts Act, 1919," the Governor may by Order in Council sever any portion of a Road District and annex it to an existing Road District: And whereas it is desirable to—(1) sever portion of the Rockingham Road District and annex it to the Serpentine-Jarrahdale Road District; (2) sever portion of the Serpentine-Jarrahdale Road District and annex it to the Rockingham Road District: Now, therefore, His Excellency the Administrator, by and with the advice and consent of the Executive Council, under the provisions of the said Act and all other powers enabling him in this behalf, doth hereby—(1) sever that portion of the Rockingham Road District described in Schedule A hereto and annex it to the Serpentine-Jarrahdale Road District; (2) sever that portion of the Serpentine-Jarrahdale Road District described in Schedule B hereto and annex it to the Rockingham Road District.

## Forests Act, 1918.

## ORDER IN COUNCIL.

P.D. 1781/30; 1217/31.

WHEREAS by "The Forests Act, 1918," it is provided that a dedication under the said Act of Crown land as a State Forest may be revoked in whole or in part in the following manner:—(a) the Governor shall cause to be laid on the Table of each House of Parliament a proposal for such revocation; (b) after such proposal has been laid before Parliament, the Governor, on a resolution being passed by both Houses that such proposal be carried out, shall by Order in Council revoke such dedication: And whereas proposals dated the Twenty-first day of October, 1930, and Fourth day of August, 1931, for the revocation in part of the dedication of Crown lands as State Forest were laid on the Table of each House of Parliament: And whereas after such proposals had been laid before Parliament resolutions were passed by both Houses that such proposals should be carried out: Now, therefore, His Excellency the Administrator, with the advice and consent of the Executive Council, doth hereby revoke in part the dedication of Crown lands as State Forests Nos. 14 and 30 by excising those portions of such State Forests as are described in the Schedule hereto:—

The Constitution Act, 1889.

ORDER IN COUNCIL.

1419/21.

WHEREAS the enactment contained in Section 74 of "The Constitution Act, 1889," by which the appointment of all public officers under the Government of the State is vested in the Governor in Council does not apply to minor appointments which by Order in Council are vested in Heads of Departments or other officers or persons within the State: And whereas it is desirable that the minor appointments of all persons who are exempt from the provisions of "The Public Service Act, 1904," employed in the Chief Secretary's Department should be vested in the several officers whose names or offices are set out in the Schedule hereto. Now, therefore, His Excellency the Administrator in Council, by and with the advice of the Executive Council, hereby cancels the Order in Council of 18th May, 1921, and amending Orders in Council of 1st June, 1921; 23rd August, 1922; 21st February, 1923; 12th March, 1924; and 16th December, 1930, vesting such appointments in the several officers whose names or whose offices are set out in the Schedule to the Order, and ordains and declares that the power of making minor appointments of all persons which are exempt from "The Public Service Act, 1904," in each of the Sub-departments mentioned in the first column of the Schedule hereto shall be vested, and the same is hereby vested in the officer or each of the officers mentioned opposite thereto in the second column of the said Schedule, and in the person for the time being acting in the place of any such officer, with effect from the 1st January, 1932:—

The Workers' Compensation Act, 1912-1924.

#### ORDER IN COUNCIL.

WHEREAS under the provisions of "The Workers' Compensation Act, 1912-1924," the Governor may make such Regulations as may be necessary or convenient for carrying out or giving effect to the provisions of the said Act: And whereas the Governor duly made Regulations under the said Act which were published in the *Government Gazette* on the 26th day of June, 1925: And whereas it is now deemed expedient to amend the said Regulations in the manner hereinafter mentioned: Now, therefore, His Excellency the Administrator, acting with the advice and consent of the Executive Council and in exercise of the powers conferred by the said Act, doth hereby amend the said Regulations as follows:—

1. Regulation 5 is repealed and a regulation is inserted in lieu thereof as follows:—

5. (1.) Every application by an employer for exemption from the provisions of Section 10 of "The Workers' Compensation Act, 1912-1924," shall be in accordance with Form E, and shall state the following particulars:—

- (a) The amount of the fund established.
- (b) The number of employees.
- (c) The annual amount of wages or salaries of the employees coming within the provisions of "The Workers' Compensation Act, 1912-1924."
- (d) The general nature of the business carried on by the employer.
- (e) The number of accidents sustained within the previous five years by workers employed by the employer and entitled to compensation, and the amount paid in respect of such accidents.
- (f) The annual amount of premium to be paid to the fund in respect of the workers coming within the provisions of the Act.
- (g) The period for which the exemption is desired.
- (h) Whether the employer proposes to deposit with the Treasury cash or securities; and, if securities, the nature thereof.

(2.) Where an employer proposes to deposit cash with the Treasury, the amount to be deposited shall be such sum, being not less than £5,000, as the Registrar shall determine.

(3.) Where an employer proposes to deposit securities with the Treasury, such securities shall be subject to the approval of the Registrar. Such securities may consist of a bond or guarantee of an insurance company or bank in Form F to the value of such amount, being not less than the sum of £5,000, as the Registrar shall determine, and having a currency of at least one year and renewable at the option of the employer.

(4.) Where an employer deposits cash, the Treasurer may invest the same in any security in which trustees are by law permitted to invest trust moneys, and in such case the security obtained and the income accruing therefrom shall be the property of the employer, who shall not be entitled to delivery of such security, but shall be entitled to the income accruing therefrom, during such time as he continues to be exempted as aforesaid.

(5.) Where an employer deposits cash and the Treasurer does not invest the same, such deposit shall bear interest at such rate, not exceeding four pounds per centum per annum, as the Treasurer shall from time to time determine, and payable by the Treasurer to the employer half-yearly until such deposit is returned to the employer.

(6.) Every application for exemption shall be submitted for the approval of the Minister, who shall decide whether the applicant shall be permitted to deposit cash instead of securities, and subject to the recommendation of the Registrar, the amount or value thereof. The decision of the Minister shall be communicated to the employer, who may thereupon deposit with the Treasury cash or securities as decided by the Minister charged as provided for in Section 10 of the said Act.

(7.) When the deposit has been made the employer shall be entitled to receive from the Minister an order granting him exemption as aforesaid. Such order shall state the period for which it is granted, and shall not have any force or effect beyond that period.

(8.) In so far as any employer who is now exempted as aforesaid shall have deposited with the Treasury cash as provided for in Regulation 5 as it existed prior to the commencement of this regulation, then, notwithstanding anything to the contrary contained in the said regulation, the interest payable in respect of such cash deposit as from and including the date of the commencement of this regulation shall be at such rate, not exceeding four pounds per centum per annum, as the Minister shall from time to time determine.

2. Form E is amended by striking out the words "With this application is forwarded," and inserting in lieu thereof the words "The applicant proposes to deposit."

6e. (1) If any person seeking employment in, on, or about a mine situated within the East Coolgardie Goldfield cannot enter upon any such employment because he has not obtained the requisite Medical Certificate under Regulation 6a or 6b, as the case may be, and proves to the satisfaction of the Medical Officer in charge of the Commonwealth Laboratory aforesaid that he is without sufficient means to pay the cost of obtaining such certificate, then, notwithstanding anything to the contrary contained in any of those Regulations, the Commonwealth Laboratory aforesaid may issue to such person a Medical Certificate in the Form "F" in the Appendix hereto, and upon such person obtaining such certificate it shall be lawful for any owner or manager or other person authorised to employ persons to work in a mine to employ such person, and it shall be lawful for such person to work in, on, or about any mine within the said East Coolgardie Goldfield for a period which shall not in any event exceed thirty days from the date of the issue of such certificate.
