ORDER IN COUNCIL.

F.D. 1217/31.

WHEREAS by "The Forests Act, 1918," it is provided that a dedication under the said Act of Crown land as a State Forest may be revoked in whole or in part in the following manner:—

- (a) The Governor shall cause to be laid on the Table of each House of Parliament a proposal for such revocation:
- (b) After such proposal has been laid before Parliament, the Governor, on a resolution being passed by both Houses that such proposal be carried out, shall by Order in Council revoke such dedication:

And whereas His Excellency the Administrator did cause to be laid on the Table of each House of Parliament his proposal dated the 4th day of August, 1931, for the revocation in part of the dedication of Crown lands as State Forest: And whereas after such proposal had been laid before Parliament a resolution was passed by both Houses that such proposal should be carried out: Now, therefore, His Excellency the Administrator, with the advice and consent of the Executive Council, doth hereby revoke in part the dedication of Crown lands as State Forest No. 26 by existing that portion of such State Forest as is described in the Schedule hereto.

Fruit Cases Act, 1919.

ORDER IN COUNCIL.

WHEREAS under the provisions of "The Fruit Cases Act, 1919," the Governor may make regulations prescribing all such matters and things as the Act requires or permits to be prescribed or which it may be necessary or convenient to prescribe for giving effect to the provisions or objects of the said Act: And whereas by an Order in Council published in the *Government Gazette* on the 6th day of January, 1922, the Governor made a regulation under the said Act prescribing standards for fruit cases: And whereas it is now deemed expedient to amend the said regulation in the manner hereinafter mentioned: Now, therefore, His Excellency the Administrator, acting with the advice and consent of the Executive Council, and in exercise of the power in that behalf conferred by the said Act and all other powers enabling him in this behalf, doth hereby amend the regulation prescribing standards for fruit cases as published in the *Government Gazette* on the 6th day of January, 1922, as follows:—

AMENDMENT OF REGULATION.

The regulation is amended by substituting the words "ten per cent." for the words "six per cent.," and by substituting the words "five per cent." for the words "three per cent." wherever the same appear respectively in the first paragraph of the said regulation.
