WHEREAS by "The Transfer of Land Act, 1893, Amendment Act, 1896" (60 Vict., No. 22), the Governor is empowered by Proclamation in the *Government Gazette* to revest in His Majesty as of his former estate all or any lands whereof His Majesty may become the registered proprietor: And whereas His Majesty is now the registered proprietor of those portions of Canning Location 31, registered in the Office of Titles in Volume 1030, Folio 472: Now, therefore I, the said Administrator, with the advice and consent of the Executive Council, do by this Proclamation revest in His Majesty, His heirs and successors those portions of Canning Location 31 aforesaid as of His former estate.

Forests Act, 1918.

### ORDER IN COUNCIL.

F.D. 1732/31.

WHEREAS by "The Forests Act, 1918," it is provided that a dedication under the said Act of Crown land as a State Forest may be revoked in whole or in part in the following manner: (a) the Governor shall

cause to be laid on the Table of each House of Parliament a proposal for such revocation; (b) after such proposal has been laid before Parliament the Governor, on a resolution being passed by both Houses that such proposal be carried out, shall by Order in Council revoke such dedication: And whereas His Excellency the Administrator did cause to be laid on the Table of each House of Parliament his proposals dated the fourth day of August, 1931, and seventeenth day of November, 1931, for the revocation in part of the dedication of Crown lands as State Forest: And whereas, after such proposals had been laid before Parliament, resolutions were passed by both Houses that such proposals should be carried out: Now, therefore, His Excellency the Administrator, with the advice and consent of the Executive Council, doth hereby revoke in part the dedication of Crown lands as State Forests Nos. 20 and 34, excising those portions of such State Forests as are described in the Schedule hereto:—

FINANCIAL EMERGENCY ACT, 1931.

(b) Where it suits the convenience of the employer's business, any worker may be employed for the full number of hours per week as laid down in Clause 4 and then stood down for one week at a time;

(c) When the services of a worker are not required owing to the operation of Subclauses (a) and (b) hereof, the employer shall give the worker one day's notice thereof;

(d) When the provisions of Subclauses (a) and (b) hereof are availed of, holidays, as prescribed in Clause 6 of the Agreement, or pay in lieu, shall be reduced pro rata;

(e) The provisions as to overtime in Clause 5 of the Agreement shall not be affected hereby, nor shall the worker's rights under Clause 11 of the Agreement be annulled, in the event of a worker being dismissed permanently from his employment. Where a worker is engaged as a casual worker the provisions of Clause 7, Sub-clause (c), shall still apply.

(2.) The foregoing provisions may be continued from month to month after the said 7th October, 1932, by agreement between the parties, a memorandum of which, signed by or on behalf of the parties, shall be filed in the Court. In the event of the parties failing to agree the matter may be referred to the Court.

(3.) The term "worker" herein shall, where the context so permits, include junior workers.

(4.) Save as is herein expressly provided, and for the term or terms herein expressed or provided for, the said Industrial Agreement shall remain in full force and effect.
