BUNBURY HARBOUR BOARD.

Amendment of Regulations.

Chief Secretary's Department,

HIS Excellency the Lieut.-Governor and Administrator in Council has been pleased to approve the enactment of the following new Regulation, No. 175b, of the Bunbury Harbour Board Regulations, in connection with Dredger Signals, as adopted by the Bunbury Harbour Board on the 6th January, 1933.

The Regulations made by the Bunbury Harbour Board on the first day of October, 1909, are hereby amended by enacting the following new Regulation, viz.:—

No. 175b—Dredger Signals.

The master of a dredger moored within any part of the Harbour, whether such dredger is working or not, shall, in the undermentioned circumstances, exhibit or make, as the case may be, the following signals:—

(a) When requiring any vessel approaching from seaward to keep the dredger on the starboard hand of such vessel and any vessel proceeding seaward to keep the dredger on the port hand of such vessel in passing—

- (1) By day, a red cone on the yardarm on the side to be passed;
- (2) By night, a red light over a green light on the yardarm on the side to be passed;
- (3) In fog, mist, or heavy rain, the Morse sound signal letter "A" at intervals of not more than two minutes on the dredger's bell.

(b) When requiring any vessel approaching from seaward to keep the dredger on the port hand of such vessel and any vessel proceeding seaward to keep the dredger on the starboard hand of such vessel in passing—

- (1) By day, a black cylinder on the yardarm on the side to be passed;
 - (2) By night, a green light over a red light on the yardarm on the side to be passed;
 - (3) In fog, mist, or heavy rain, the Morse sound signal letter "N" at intervals of not more than two minutes on the dredger's bell.
- (c) When the dredger is blocking the channel—
- (1) By day, a green cone between two red balls, vertical at the masthead;
 - (2) By night, a green light between two red lights, vertical at the masthead;
 - (3) In fog, mist, or heavy rain, the Morse sound signal letter "S" at intervals of not more than two minutes on the dredger's bell.
- (d) When a vessel may pass on either side of the dredger—

- (1) By day, a white flag on the masthead;
 - (2) By night, a green light on both yardarms.
- (e) When the dredger is unable to move, or is out of control—
- (1) By day, a red flag on the masthead;
 - (2) By night, a red light on both yardarms.

Self-propelling Dredgers—Not anchored.

Suction-dredgers under way when dredging and unable to manoeuvre as required by Regulations in order to keep out of the way of other vessels, shall show lights and shapes required by the International Regulations, Article (4) (a) for vessels not under command, viz.:—

Two (2) black balls by day or two (2) red lights by night from where best seen.

Morse Sound Signals.

The Morse sound signals hereinbefore referred to shall be made by the dredger's bell for the respective signals, viz.:—

- (1) Short ring—1½ seconds duration;
- (2) Long ring—4 seconds duration;
- (3) Interval between rings—1½ seconds duration.

Anchor Lights on Dredgers.

In addition to the coloured lights shown above, moored dredgers may carry the anchor light or lights required to be carried by other vessels, according to their lengths.

A white light shall be shown on the outer rail of the silt barge, if moored to the dredger, on the passing side. No light need be shown on the barge if moored to the side of the dredger that is not clear.

Size of Shapes.

The diameter of the shapes shall not be less than two feet nine inches. The vertical height of the cone and cylinder shapes shall be one and a-half times the diameter of their own base. The vertical distance between shapes or lights shall be between four and six feet.

Vessels to observe Dredger Signals.

(1) Any vessel approaching a dredger from whatsoever direction shall pass such dredger on the side upon which the signal is exhibited, as hereinbefore mentioned.

(2) Any vessel approaching from whatsoever direction shall not pass any dredger exhibiting the "Channel Blocked" signals as mentioned in paragraph (c), but must wait until one of the passing signals mentioned in paragraph (a), (b), or (d) is exhibited or made.

(3) Every vessel approaching a dredger from whatsoever direction, when such dredger is exhibiting the signal mentioned in paragraph (d) may pass on either side of the dredger.

(4) Every vessel approaching a dredger from whatsoever direction when such dredger is exhibiting the signal mentioned in paragraph (e) must be navigated with all due precaution when passing such dredger.

THE HEALTH ACT, 1911-26.

Amendment of By-laws.

M.P.H. 4452/21; Ex. Co. No. 197.

IN pursuance of the powers vested in me by Section 16 of "The Health Act, 1911-26," I, Everitt Atkinson, Commissioner of Public Health, do hereby make the following amendment to the Model By-laws as made by the Governor on the 8th day of April, 1927, under Section 295 of the said Act and adopted by me with modifications on the 9th day of May, 1927, and published in the *Government Gazette* of the 3rd day of June, 1927, to the intent that such amendment shall be read as one with the By-laws so adopted by me, and shall take effect on publication in the *Government Gazette*:—

Part VII. is amended by the addition of a new By-law, to stand as By-law No. 16A, as follows:—

No person shall apply arsenic or lead, either as a spray or powder, or in any other form whatsoever, to cabbage, cauliflower, or any other plant of the Brassica family, within four weeks of cutting for sale.

No person shall sell or attempt to sell or receive for sale, or have in possession for sale, expose, send, forward, or deliver for sale any cabbage, cauliflower, or any other plant of the Brassica family which has adhering to it or upon any part of it any arsenic or lead or any other poisonous or deleterious substance of any kind whatsoever.

No person shall sell or attempt to sell, or receive for sale, or have in possession for sale, expose, send, forward, or deliver for sale any fruit of any kind whatsoever which has adhering to it or upon it any arsenic or lead.

No person shall send any fruit or any vegetable to market for sale unless and until it is clean and free from any spray residue or any other foreign substance which is deleterious, objectionable, or injurious to health.

FARMERS' DEBTS ADJUSTMENT ACT, 1930.

NOTICE is hereby given that the following Stay Orders have been issued in accordance with Section 7, Subsection 1, of "The Farmers' Debts Adjustment Act, 1930," and Amendment Act, 1931, which reads as follows:—

A Stay Order shall direct that no action, execution, distress for rent, proceedings on default or breach of covenant under any mortgage or other security for money, or under an agreement of sale and purchase of land, or other process or proceeding, shall be commenced or proceeded with or put in force against the farmer or his estate or effects during the operation of such Stay Order. BALINGUP ROAD BOARD.

BY-LAWS for the Management and Use of Public Halls under the Control of the Balingup Road Board.

P.W. 1809/25.

1. Interpretation.—In these By-laws the following terms shall, unless the context otherwise indicates, bear the meaning set against them:—

"The Board"—The Balingup Road Board.

"Management Committee"—A Committee of persons appointed by the Board to manage and control any specified public hall within the Balingup Road District.

"Secretary"—The secretary of the Board.

"Caretaker"—The person appointed by the Board to control any public hall under the directions issued by the Management Committee or secretary of the Board.

"Hall"—The word "hall" shall mean and include any hall, room, lounge, corridor, stairway, stage, entrance, yard, or land situated within the boundaries of the Townsite lot upon which any public hall shall be erected.

"Permit"—The consent of the Board or Management Committee given in writing.

2. Application for the hire of any hall or any room or furniture shall be made on the specified application form to the secretary or caretaker not less than twenty-four hours before the time that such hall, room, or furniture is required.

3. The name and place of abode of the actual and responsible person or persons hiring any hall, room, or furniture shall be given in the application for the use of any hall, room, or furniture.

4. The rent of any hall, room, or furniture (inclusive of the use of any crockeryware owned by the Board) shall be paid with each application, and such payments shall be in accordance with the scale of charges that the Board may from time to time decide.

5. The hours for which any hall, room, or furniture shall be hired shall be: Day—9 o'clock a.m. to 6 o'clock p.m.; Night—from 7 o'clock p.m. to 12 o'clock midnight, after which the prescribed fee shall be paid in addition to the ordinary payment.

6. Skating will not be permitted under any consideration.

7. Decorations shall not be allowed unless a special permit be obtained, and the hirer shall only use fixtures provided for this purpose. No person shall drive a nail into any part of the wall, windows, doors, floors, partitions, etc., or otherwise deface the building. The hirer shall remove all decorations used in connection with any entertainment from the premises within 24 hours from the commencement of the hiring period.

8. No advertising matter shall be pasted or attached to any wall or fitting, and advertisements shall only be displayed on bill-boards provided for that purpose.

9. The Board or Management Committee may at any time demand that the hirer shall, prior to the term of engagement, deposit an amount estimated to cover any damage that might occur during the term of such engagement.

10. The Board or Management Committee reserves the right to let any hall, room, or furniture to any applicant for the hiring of same without assigning any reason for such refusal.

11. The hirer of any hall, room, or furniture shall comply with the provisions of the Health Act, the Entertainment Tax Act, and any other Act in force for the time being applicable to such hiring or using of any hall or room. If, in the opinion of the Board or Management Committee, all the necessary actions have not been taken to comply with the provisions of the Acts mentioned above, the Board or Management Committee may at any time prior to or during the term of engagement forbid and prevent the use of such hall or room.

12. In the event of the use of any hall or room being stopped under the last preceding By-law, the hirer shall forfeit the full amount payable for the hire of such hall or room as if the hire had been duly fulfilled, and the Board shall not be responsible to the hirer by reason of such stoppage.

13. No spirituous liquors, wine, ale, beer, porter, cider, or any other intoxicating liquor shall be brought into or consumed in any hall or room except by permit from the Board or Management Committee.

14. The Board or Management Committee reserves the right to allow any person or persons to smoke any tobacco, cigars, cigarettes, or strike or otherwise ignite any light in any hall or room during any ball or public entertainment, or at any gathering of persons in the said hall or rooms, whether such persons shall have been admitted by payment of money or otherwise.

15. No person shall in any part of any hall—

- (a) enter or be allowed to enter whilst intoxicated;
- (b) use profane or improper language;
- (c) be guilty of any misbehaviour whatsoever;
- (d) damage, mark, or deface any wall or fitting, furniture or crockeryware.

Any person who does, permits, or suffers any such damage shall be liable to pay the cost of all such damage in addition to any penalty imposed by these By-laws.

16. No person or persons shall stand, loiter, or cause any obstruction whatsoever in the passageway or any part of any hall. Any person or persons so doing shall immediately disperse on being requested to do so by the secretary, caretaker, or person duly authorised by the Board or Management Committee, or police constable, whether in uniform or otherwise.

17. No offensive personalities or representations of living persons, nor anything calculated to produce riot or a breach of the peace shall be permitted in any hall or any part thereof, or in any room.

18. No encouragement shall be given to improper characters to assemble in any hall or room.

19. The secretary, caretaker, or other person duly authorised by the Board or Management Committee, or police constable when dressed in uniform or otherwise, if known as such to the hirer or his servant, shall be permitted to have free ingress to any hall or any part

thereof at all times during the term of engagement, and shall be given every facility for seeing that these By-laws are duly carried out.

20. Children under 10 years of age must be under responsible supervision when in any hall or part thereof.

21. The hirer of any hall or room shall maintain and keep good order and decent behaviour in any such hall or room, and shall be solely and entirely responsible for the carrying out of these By-laws, and for any damage done to the hall, fixtures, fittings, furniture or crockeryware, and shall pay such damages as shall be assessed by the Board or Management Committee. Any article of crockeryware not accounted for or in a cracked or broken condition shall be paid for at current rates or prices.

22. Every person who does, permits, or suffers any act, matter or thing contrary to any of these By-laws, or commits or permits any breach or neglect thereof, shall be deemed guilty of an offence against these By-laws, and shall be liable to a penalty not exceeding £20 for every such offence.

10. The farmer shall, unless prevented by sickness or other sufficient cause, attend the meeting and any adjournment thereof, and shall submit a statement of his assets and liabilities, signed by him and verified by his statutory declaration in the Form 5 in the said Schedule.

11. Any form may be varied so far as necessary to suit the circumstances of any particular case.

12. (1) The following fees shall be payable out of the assets of a farmer who is made subject to the said Act, that is to say:—

Application Fee (which shall include the cost of publishing and advertising the Stay Order and the notice calling meeting of creditors)—£1.

Deputy Director's fee for calling and attending first meeting and performing other services incidental thereto—£4 4s.

Deputy Director's fee for attending each adjournment of any meeting, such amount as may be fixed by the Director in each case not exceeding, where the adjourned meeting is held for the purpose of passing in review the accounts and operations of a previous year, £3 3s., and in other cases, £2 2s.

Receiver's Fee—£3 3s.

(2) The Receiver shall have authority to deduct such fees from any assets of the farmer coming to his hands, whether the application shall have been made by the farmer or by a creditor, out of the fees so deducted by him, the Receiver may retain the fee to which he is entitled as Receiver and thereafter shall pay the application fee to the Director, and the Deputy Director's fees to the Deputy Director entitled thereto.

(3) Where an application is made by a creditor, the application fee of £1 shall be paid, in the first instance, by the creditor making the application.
