### ROYAL COMMISSION

WESTERN AUSTRALIA, } By His Excellency Sir James Mitchell,  
TO WIT. } K.C.M.G., Lieutenant-Governor in and  
JAMES MITCHELL, } over the State of Western Australia  
Lieutenant-Governor. } and its Dependencies in the Common-

To Henry Doyle Moseley, Stipendiary Magistrate,  
Perth, Western Australia.

I, THE said Lieutenant-Governor, acting with the advice and consent of the Executive Council, do hereby appoint you Henry Doyle Moseley to be a Commissioner to investigate, report, and advise upon the following matters:—

(1) The social and economic conditions of aborigines and persons of aboriginal origin, with special reference to—

- (a) the inclusion or exclusion of different classes of persons of aboriginal origin in or from native camps;
- (b) proximity of native camps to towns;
- (c) physical well-being of aborigines, and any suggested measures for amelioration;
- (d) disease amongst aborigines and measures for their treatment;
- (e) native settlements;
- (f) employment of aborigines and persons of aboriginal origin;
- (g) missions;
- (h) trial of aboriginal offenders;

(2) Laws relating to aborigines and persons of aboriginal origin and suggested amendments.

(3) The administration of the Aborigines Department generally.

(4) Allegations which have appeared in the Press since the 1st day of July, 1930, relative to the ill-treatment of aborigines in Western Australia.

And I declare that you shall, by virtue of this Commission, be a Royal Commission within the Royal Commissioners' Powers Act, 1902, as reprinted in the Ap-

pendix to the Sessional Volume of Statutes for the year 1928, and that you shall have the powers of a Royal Commission or the Chairman thereof under that Act.

And I hereby request you, as soon as reasonably may be, to report to me in writing the result of this your Commission.

ORDER IN COUNCIL.

P.W. 73/30; Ex. Co. No. 399.

WHEREAS by Section 11 of "The Public Works Act, 1902," it is made lawful for the Governor, by Order in Council, to authorise the Minister to undertake, construct, or provide any public work (subject as to Railways to Section 96), and such authorisation shall be deemed an authority to such Minister by and under that Act: Now, therefore, His Excellency the Lieutenant-Governor, acting by and with the advice and consent of the Executive Council, and in exercise of the power conferred by the recited section of "The Public Works Act, 1902," doth hereby authorise the Honourable Minister for Works to provide and construct School Quarters at Jindong, on the land shown coloured green on Plan P.W.D., W.A., 27471, which may be inspected at the office of the Minister for Works, Perth.

The Traffic Act, 1919-32.

Denmark Road Board.

ORDER IN COUNCIL.

P.W. 3449/22.

WHEREAS under the provisions of "The Traffic Act, 1919-32," the Governor may by Order in Council empower a Local Authority to exercise within its District any power of making Regulations which the Governor can exercise under Division 4 of Part IV. of the said Act: And whereas it is desired to empower the Denmark Road Board to regulate the standing of vehicles in the Townsite of Denmark, within its District: Now, therefore, His Excellency the Lieutenant-Governor, by and with the advice and consent of the Executive Council, under the provisions of the said Act and of every other authority enabling him in this behalf, doth hereby empower the Denmark Road Board to make By-laws to regulate the standing of vehicles in the Townsite of Denmark, within the Denmark Road District, and to impose a penalty of not exceeding £20 for the breach thereof.

The Metropolitan Water Supply, Sewerage, and Drainage Act, 1909.

ORDER IN COUNCIL.

M.W.S. 135/34.

WHEREAS by "The Metropolitan Water Supply, Sewerage, and Drainage Act, 1909," it is provided that, subject to the provisions of the Act, the Minister for Water Supply, Sewerage, and Drainage shall, with the approval of the Governor, have power to construct and extend water works, sewerage works, and stormwater drainage works: And whereas the preliminary requirements of the said Act have been complied with, and plans, sections, and estimates in respect of the works hereinafter mentioned have been submitted to and approved by the Governor in Council: Now, therefore, His Excellency the Lieutenant-Governor, with the advice and consent of the Executive Council, does hereby empower the Minister for Water Supply, Sewerage, and Drainage to undertake the construction of the following works under the said Act, namely:—

Metropolitan Sewerage—Claremont-Cottesloe System—3rd Section, Claremont Main Sewer, 24in. and 21in. diameter reinforced concrete pipe sewer, with all manholes and other apparatus connected therewith, as shown on Plan M.W.S.S. & D.D., W.A. No. 5334.

This Order in Council shall take effect from the Twenty-second day of February, 1934.

HIS Excellency the Lieutenant-Governor in Executive Council has approved of the repeal of the following Public Service Regulations:—6, 7, 8, 51, 91, 105, 112, 117, 125, 127, 133, 134, 135, 136, 154, 196, and of the repeal of the following and the substitution of new regulations in lieu thereof, as listed hereunder:—

## 2

For the purposes of promotion under Section 38 of the Act, the term "Department" shall mean the group of Departments included in the portfolios of any one Minister.

Where the work of an officer includes duties for two Departments in fairly equal proportions, he may be considered an officer of either Department.

## 3

The term "Permanent Head," used throughout these Regulations, refers to the officers directly responsible to the Minister for the administration of any one of the Departments included in the group of portfolios of a Minister.

## 4

The term "Head of Sub-department," used throughout these Regulations, refers to the officers in charge of Branches or Sub-departments who are directly responsible to the Permanent Head. (Such title is conferred merely for the purpose of working these Regulations, particularly those relating to suspensions and inquiries.)

## 35

One month's notice of termination of engagement shall be given by either side.

## 46

(1.) Increments of salary within the limits of a range shall be annual; but no increment shall accrue to any salary until the officer in receipt thereof has received such salary for a period of twelve months:

Provided that the right to receive an increment in any year shall depend upon the good conduct, diligence, and efficiency of the officer.

(2.) The permanent head of each department shall furnish to the Commissioner a report upon the conduct, diligence, and general efficiency of the officers of his department before any increase of salary is paid to such officers.

Such report shall, in the first instance, be made by the immediate superior of the officer reported upon, and then forwarded by the permanent head, with such amendments as he may think fit.

Upon receipt of such report, and after obtaining any further information which the Commissioner may deem necessary, he shall determine whether such officer is entitled to the full amount or any portion of the increment claimed.

When an officer is relieving another, or is on special work away from his usual headquarters, and in consequence has in addition to his own maintenance to maintain an establishment elsewhere, or is put to expense which otherwise it would not be necessary for him to incur, an allowance at the rate of 6s. per diem if married or 2s. 6d. per diem if single, may be granted by the Permanent Head, provided that if the period exceeds six weeks, the approval of the Commissioner shall be obtained to the continuance of such allowance.

This allowance to commence from the expiration of the period during which it is considered by the Permanent Head to be reasonable to pay travelling allowance (Regulation 60), but which in no case shall exceed 10 days.

Regulation 70 to be read and included as part of this Regulation; provided that where it is considered advisable to do so an officer's headquarters may be changed to a new locality, in which case the allowance under Regulation 60 may be granted up to 10 days. In cases where the officer is put to expense on return to his former headquarters the allowance may also be paid up to 10 days.

In the event of an officer being accused of any of the offences mentioned in the preceding Regulation the Head of Sub-Department shall charge and suspend the officer, and shall forthwith refer the matter to the Permanent Head: Provided that if the accused is in any office or branch not under the immediate control of the Head of Sub-department, the Officer-in-Charge shall charge and suspend, but shall immediately report such action to the Head of Sub-department, who shall refer the matter to the Permanent Head. An officer charged shall—

- (a) be furnished with a copy of the charge, signed and dated;
- (b) be required to forthwith state in writing whether he admits or denies the truth of such charge;
- (c) be allowed to give any written explanation with regard to the alleged offence.

Witnesses, other than Government officers or persons in the employ of the Government, may be paid allow-

ances for their travelling expenses and maintenance during their absence from their usual place of residence, based on the scale of allowances payable to witnesses in force for the time being, and the amount shall be settled by the officer of the Crown Law Department whose duty it is to pay witnesses.

All claims made by witnesses must, in the first instance, be submitted to the Public Service Commissioner.

Regulation 67:—The deletion of the last paragraph of Regulation 67.

Regulation 71:—The deletion of Regulation 71 and the substitution of the following in lieu thereof:—

Regulation 71. University graduates who have served one year as monitors may be accepted as candidates for a special course of one year's duration. They will be required to sign an agreement that they will teach in the schools of the Department for three years after the completion of their training. They will receive the same allowances as full course students and will be eligible for appointment on the same conditions as full course students.

Regulation 71A:—The insertion of a new regulation after Regulation 71, as follows:—

71A. University graduates who hold the diploma of education, and who have completed one year's satisfactory service as monitors, may be appointed as assistants or head teachers, with a provisional salary and classification of C1 (2nd Year); provided they have first fulfilled the requirements of the Departmental "C" examination in music, drawing, drill, and, in the case of women, needlework. A person so appointed will not have the provisional classification awarded him confirmed until after the confirmation of his certificate has been recommended by the district inspector.

Notwithstanding anything to the contrary elsewhere in these Regulations, University graduates who have not fulfilled the requirements of the Departmental "C" examination in music, drawing, drill, and, in the case of women, needlework, but who qualified for the Diploma of Education before the 1st January, 1934, and entered the service before that date, may be appointed as assistants or head teachers, with a provisional salary and classification of "C1" (2nd Year); provided they have completed one year's satisfactory service as monitors. A person so appointed will not have the provisional classification awarded him confirmed until he has fulfilled the requirements of the Departmental "C" examination in the aforementioned subjects; and, should a person so appointed not fulfil the requirements in the aforementioned subjects within two years from the date of such appointment, then his provisional classification and salary will be liable to reduction. For the purpose of Regulation 15 no person so appointed shall be deemed to have completed the "C" examination until after he has fulfilled the requirements in the aforementioned subjects.

1932-1933.

## Regulations.

1. The following new Regulations shall be added to "The Metropolitan Whole Milk Act, 1932-1933," Regulations after Regulation 41:—

## PART XI.

## Election of Members of the Board.

42. The first election of elective members of the Board shall be held on the 21st day of March, 1934, and subsequent elections shall be held on the third Tuesday in March in each year, at the office of the Board in Perth.

43. Nominations for the positions of two members of the Board as representatives of the dairymen shall be called for during the month of February, by advertisement in three consecutive issues of a daily newspaper published in Perth and in one issue of a weekly newspaper published in Perth and which circulates in the districts mentioned in Section 6, Subsection 2 (b), of "The Metropolitan Whole Milk Act, 1932-1933:—

44. Candidates for one of the positions shall be nominated by dairymen—

- (a) who are duly licensed under "The Metropolitan Whole Milk Act, 1932-1933," to carry on business in the Number 1 Dairy Area, being the area described in the First Schedule of a notice published by the Minister for Agriculture in the *Government Gazette* of the 10th March, 1933, namely, the area which is within a line extending due East from the West coast to and passing through the Wanneroo 12-mile Road Post; thence continuing directly to one-and-one-half miles East of the Midland Railway to the 116deg. 3min. East meridian of longitude; thence due South, crossing the Eastern Railway one-half mile West of Swan View Railway Station to the Canning River; thence due West one mile South of Kelmscott Railway Station, continuing in a line due West to meet the coast one mile North of Woodman's Point; and
- (b) who are dairymen of the first class mentioned in Section 6, Subsection 2 (b), of "The Metropolitan Whole Milk Act, 1932-33," being—
  - (i) owners or occupiers of dairies within the district defined by Order in Council made

under "The Dairy Cattle Compensation Act, 1926," and published in the *Government Gazette* on the 11th day of November, 1927, which is identical with the area described in subparagraph (a) of this Regulation; and

- (ii) owners of dairy cattle registered under "The Dairy Cattle Compensation Act, 1926."

45. Candidates for the other position shall be nominated by dairymen—

- (a) who are duly licensed under "The Metropolitan Whole Milk Act, 1932-33," to carry on business in any area outside the Number 1 Dairy Area; and
- (b) who are dairymen of the second class mentioned in Section 6, Subsection 2 (b), of "The Metropolitan Whole Milk Act, 1932-1933," being owners or occupiers of dairies outside the area described in Regulation 44 (a) whose names appear on the Register of Dairymen kept by the Board.

46. Nominations shall be in writing, on forms similar to the appropriate form in the Fourth Schedule to these Regulations, and must be signed by two dairymen who will, if they still hold their respective licenses, be qualified under the provisions of Section 6, Subsection 2 (b), and Section 10, Subsection 2, of "The Metropolitan Whole Milk Act, 1932-1933," to vote at the election in respect of which the nomination is made. The form must also be signed by the candidate himself as evidence of his consent to stand for election.

47. Nominations shall be in the hands of the Secretary of the Board not later than noon on the first Tuesday in March in the year in which the election is to be held.

48. If only one candidate is nominated by dairymen of the first-class he shall be declared elected by the Returning Officer, hereinafter mentioned, on the date appointed for the holding of the election.

49. If only one candidate is nominated by dairymen of the second class, he shall be declared elected by the Returning Officer, hereinafter mentioned, on the date appointed for the holding of the election.

50. If more candidates than one are nominated by dairymen of the first class, the Secretary of the Board shall prepare ballot papers, on which shall be printed in alphabetical order the names of all candidates nominated by such dairymen.

51. If more candidates than one are nominated by dairymen of the second class, the Secretary of the Board shall prepare ballot papers, on which shall be printed in alphabetical order the names of all candidates nominated by such dairymen.

52. The ballot papers so prepared shall be posted or delivered by the Secretary of the Board, at least seven days before the date appointed for the holding of the election, to every elector of the first class or the second class, as the case may be, who is qualified to vote for candidates nominated by dairymen of that class.

53. Every elector shall vote on and by the ballot paper so forwarded to him by writing the numeral 1 opposite the name of the candidate for whom he votes, and, if there are more than two candidates, he shall place the numeral 1 opposite the name of the candidate for whom he votes as his first preference, and he shall give contingent votes for all the remaining candidates by placing the numerals 2, 3, and so on (as the case requires) opposite their names, so as to indicate by such numerical sequence the order of his preference.

54. After recording his votes, every elector shall place his ballot paper in a plain envelope, which shall be sealed by the elector and enclosed unmarked in another envelope, addressed to the Secretary of the Board. The signature and license number of the elector shall be written inside the last-mentioned envelope, in spaces which shall be provided for the purpose. The envelopes shall be supplied by the Board.

55. All envelopes containing ballot papers shall be delivered or posted to the Board at its address in Perth, and shall be in the hands of the Secretary not later than

noon on the date appointed for the holding of the election. Every envelope posted as aforesaid shall be properly stamped, and if it is not so stamped, the Board may refuse to accept the ballot paper therein contained.

56. The Board shall, on or before the date appointed for the holding of the election, appoint a Returning Officer and two scrutineers, who shall not be members of the Board or employees thereof in any other capacity.

57. As soon as possible after noon on the date of the election the Secretary of the Board shall open all envelopes (except the sealed envelopes containing ballot papers) in the presence of the Returning Officer and scrutineers, and shall check the signatures and license numbers of the electors.

58. If the Secretary is satisfied that an elector is duly qualified to vote, and that his signature is genuine, he shall hand the sealed envelope, containing the ballot paper, to the scrutineers, who shall place it, unopened, with all other similar envelopes containing ballot papers submitted by dairymen of the same class in a ballot box provided for the purpose. Separate ballot boxes shall be used for the ballot papers submitted by the dairymen of each class.

59. When all the signatures and numbers have been checked as aforesaid, the scrutineers shall remove all the sealed envelopes from each ballot box, and count the votes appearing on the ballot papers therein contained, using the preferential system of counting in the same manner as it is for the time being adopted and used in connection with the election of members of the Legislative Assembly of Western Australia.

60. If it appears to the scrutineers or either of them that any ballot paper is informal, they shall submit the ballot paper to the Returning Officer, who may accept or reject it, and whose decision shall be final.

61. A ballot paper shall be informal:—

- (a) If the elector has not in casting his votes complied in every respect with the preceding Regulations; or
- (b) if the ballot paper has upon it any mark or writing which in the opinion of the Returning Officer will enable any person to identify the elector; or
- (c) if it does not indicate the elector's vote.

62. The Returning Officer shall keep a record of the number of informal votes.

63. As soon as the counting is complete, the Returning Officer shall declare the candidate in each class who obtained the greatest number of votes (counted as aforesaid) to be elected, and shall report the result in writing to the Chairman of the Board, and shall, as soon as possible after the making of the aforesaid declaration, cause the names of the successful candidates to be advertised in the *Government Gazette*.

## PART XII.

64. All milk supplied or sold by dairymen to milk vendors shall be supplied and/or sold under and by virtue of the provisions of a contract in writing between the parties concerned, which contract shall (subject to paragraph 7 of Section 30 of "The Metropolitan Whole Milk Act, 1932-1933") be approved in writing by the Board before any milk is supplied or sold thereunder.

65. No dairyman shall supply or sell any milk to any milk vendor, and no milk vendor shall accept delivery of or purchase any milk from any dairyman, except in pursuance of a contract in writing approved by the Board as aforesaid, or with the consent in writing of the Board.

66. Regulations 64 and 65 shall not apply to a transaction if the dairyman or milk vendor concerned proves to the satisfaction of the Board or of any Court that the milk sold or purchased by him was neither intended for resale nor resold for consumption in the Metropolitan area.

67. No dairyman who sells any milk retail to consumers shall, on any day during the months of June to February inclusive in any year of supply as defined in Regulation 29, without the consent in writing of the Board first had and obtained, supply, sell, or distribute to consumers in the Metropolitan Area any quantity of milk produced at his own dairy from his own cows in excess of the average daily quantity of milk so produced which was supplied, sold, and/or distributed by him to consumers in the Metropolitan Area during the months of March to May inclusive in that year of supply.

68. Any consent issued by the Board under Regulation 67 in any year of supply shall specify the maximum daily quantity of milk produced at his own dairy from his own cows, which the holder thereof may supply, sell, and/or distribute, and no dairyman holding such a consent shall supply, sell, or distribute any quantity of milk so produced to consumers in the Metropolitan Area during the months of June to February inclusive in that year of supply under the authority thereby conferred upon him in excess of such maximum daily quantity.

69. Every dairyman shall keep complete records indicating the quantity of milk supplied, sold, and distributed on every day by him to milk vendors carrying on business in the Metropolitan Area, and to consumers in the Metropolitan Area. Such records shall also indicate whether the milk so supplied, sold, or distributed was produced at his own dairy from his own cows or, if not, from whom it was acquired.

70. Every milk vendor shall keep complete records indicating the quantity of milk purchased and received by him on every day from dairymen, and the quantity of milk supplied, sold, and distributed by him on every day to consumers in the Metropolitan Area. Such records shall also indicate the name of the person from whom he acquired the milk so supplied or distributed.

(2) Upon a conviction for any offence under this By-law, the person, Local Authority, or other body convicted shall be liable to a penalty not exceeding Twenty pounds.
