J. Craig, Esquire, Stipendiary Magistrate sitting as a Court of Petty Sessions at Fremantle and fined in the sum of £20 on the complaint of Thomas John Hughes for that he the said Edmund Harry Gray did on the 11th day of May 1934 at Fremantle contrary to the provisions of Section 181 Subsection 5 of 7 Edward VII No. 27 (the Electoral Act 1907) publish a printed document or writing containing untrue statements defamatory of Thomas John Hughes a candidate for the West Province Seat at the Legislative Council Election 1934 and calculated to influence the votes of electors such document being headed "T. J. Hughes wants to Govern the Country": Now Know Ye that We in consideration of some circumstances humbly represented unto us and for divers good considerations are graciously pleased to extend our Grace and Mercy unto him the said Edmund Harry Gray, and by these presents for us our heirs and successors do grant him the said Edmund Harry Gray

our Free Pardon for the offence of which he stands convicted as aforesaid and all and singular the executions corporal imprisonments pains penalties forfeitures disabilities demands and other punishments whatsoever which he the said Edmund Harry Gray has incurred or is subject to for or by reason of such offence and in particular the disability or incapacity of being chosen or of sitting as a Member of the Legislative Council of the Parliament of the State of Western Australia caused or created by Section 184 of the said Electoral Act 1907 on the conviction of the said Edmund Harry Gray as aforesaid: And we do by these presents give and grant unto him the said Edmund Harry Gray our firm peace thereupon and, further, we strictly command all and singular Judges, Justices and all others whatsoever that this our present free and gracious pardon shall be construed expounded and adjudged in all our Courts and elsewhere by the general words clauses and sentences aforesaid in the largest and most beneficial sense for the most full and firm discharge of him the said Edmund Harry Gray according to our true intention expressed in these letters patent without any ambiguity question or delay whatsoever.

Our Will and Pleasure, therefore, is that you do take due notice hereof.

And for so doing this shall be your warrant.

In Testimony whereof we have caused these Presents to be made and the Seal of Our said State to be hereunto affixed.

WHEREAS by Sections 222 and 227 of "The Municipal Corporations Act, 1906" (6 Edward, No. 32), it shall be lawful for the Governor, on request of the Council, by notice in the *Government Gazette*, to declare any land reserved, used, or by purchase or exchange acquired for a street or way, or any place, bridge or thoroughfare, to be a public highway, and such land shall thereupon and thenceforth, from the date of such Proclamation, become and be absolutely dedicated to the public as a public highway, within the meaning of any law now or hereafter in force: And whereas the Bunbury Municipal Council has requested that certain land, named and described in the Schedule hereunder, which has been used for a street or way within the Municipality of Bunbury, be declared a public highway: Now, therefore I, the said Lieutenant-Governor, by and with the advice and consent of the Executive Council, do by this my Proclamation declare the said land to be a public highway, and such land shall, from the date of this Proclamation, be absolutely dedicated to the public as a highway, within the meaning of any law now or hereafter in force.

The Road Districts Act, 1919-33.

Buckland Hill Road District: Division into Wards.

#### ORDER IN COUNCIL.

P.W. 650/34.

WHEREAS under the provisions of "The Road Districts Act, 1919-33," the Governor may by Order in Council divide a Road District into Wards: And whereas it is desirable to divide the Buckland Hill Road District into three Wards: Now, therefore, His Excellency the Lieutenant-Governor, by and with the advice and consent of the Executive Council, under the provisions of the said Act and all other powers enabling him in this behalf, doth hereby divide the Buckland Hill District into three Wards, with the names, boundaries, and number of members allotted to each Ward as described in the Schedule hereto:—

#### SCHEDULE.

##### North Ward.

Bounded on the Westward, the Northward, and the Eastward by the District Boundaries; on the Southward by a line commencing on the Western boundary of the District in prolongation of the centre of Glyde Street, and extending Eastward along said centre of Glyde Street to the centre of Palmerston Street; thence South along the centre of the latter to the production West of the North boundary of Class "A" Reserve 1634; thence East to and along the North boundary of the said reserve to the District boundary (2 members).

##### Central Ward.

Bounded on the Westward by part of the District boundary; on the Northward by the Southern boundary of the North Ward above-described, and on the Eastward by part of the District boundary. Bounded on the Southward by a line commencing at the centre of Caporn Street, on the Eastern boundary of the District, and extending North-Westward along said centre to the centre of Bateman Street; thence along the centre of Bateman Street to the production of the centre of Duffield Street; and thence along the centre of Duffield Street to the centre of Wellington Street, and along the centre of Wellington Street to the centre of Palmerston Street; thence along the centre of Palmerston Street to the centre of Victoria Street; thence along centre of Victoria Street to the Eastern side of Waldeck Street and continuing from the latter point to and along the centre of a level crossing to the Western boundary of the District (3 members).

##### South Ward.

Bounded on the Northward by the Southern boundary of the Central Ward described above; and on the Eastward, Southward, and Westward by the District boundaries (2 members).

The Traffic Act, 1919-31.  
Rockingham Road Board.

ORDER IN COUNCIL.

P.W. 2065/26.

WHEREAS under the provisions of "The Traffic Act, 1919-31," the Governor may by Order in Council empower a Local Authority to exercise within its District any power of making Regulations which the Governor can exercise under Division 4 of Part IV. of the said Act: And whereas it is advisable to empower the Rockingham Road Board to make By-laws to prohibit the carriage by any vehicle on the roads, or any specified roads in a prescribed area, of a load (including the weight of the vehicle) exceeding the weight prescribed as the maximum load that may be lawfully carried on such roads, or specified roads within its District, and impose a penalty not exceeding £20 for the breach thereof: Now, therefore, His Excellency the Lieutenant-Governor, with the advice and consent of the Executive Council, under the provisions of the said Act and all

other powers enabling him in this behalf, doth hereby empower the Rockingham Road Board to make By-laws to prohibit the carriage by any vehicle on the roads, or any specified roads in a prescribed area, of a load (including the weight of the vehicle) exceeding the weight prescribed as the maximum load that may be lawfully carried on such roads, or specified roads within its District, either generally or during certain months of the year, and impose a penalty not exceeding £20 for the breach thereof.

## 6.—Lighting.

The charge made to workers for electric light supplied to the quarters at Canning Dam by the Minister shall not exceed the cost to the Minister for so supplying the light.

## 7.—Wet Boring.

The claim on this item having been withdrawn by the Union, no decision by this Board is required.

## 8.—Firewood.

The Minister shall transport to the nearest accessible part of the workers' quarters such stacks of firewood as the workers employed at the Canning Dam may cut: Provided that such stacks are situated adjacent to an accessible road or track and within a reasonable distance of the Canning Dam.

## 9.—Tarring Pipes.

Men employed at the work of tarring the inside of pipes of a diameter of twelve (12) inches or over shall be entitled, under the Award, to two shillings (2s.) a day extra.

## 10.—Shovellers Working in Trenches.

Shovellers, when working by stages in trenches, shall receive sixpence (6d.) per day extra, in accordance with the provisions of Clause 2, Subclause (8) of the Award.
