

WHEREAS it is enacted by Section 30 of "The Explosives Act, 1895," that the Minister may from time to time make, alter, and repeal by-laws for regulating the conveyance, loading, and unloading of gunpowder in any case to which by-laws made under any other provision of the said Act do not apply, and in particular Vision of the said Act do not apply, and in particular for declaring or regulating all or any of the matters specifically mentioned in the said section: And whereas it is also enacted by Section 31 of the said Act that all by-laws proposed to be made by the Minister under the said Section 30 shall, before receiving the authority of the Minister he subliched in such meanure as the of the Minister, be published in such manuer as the Minister may direct as being in his opinion sufficient for giving information thereof to all corporations, officers and persons interested: And whereas it is also enacted by Section 32 of the said Act that, subject to the provisions of the said Act, the said Sections 30 and 31 re-Visions of the said Act, the said Sections 50 and 51 Fe-lating to gunpowder shall apply to every other kind of explosive (as defined in Section 4 of the said Act) in like manner as if those provisions were in Part II. of the said Act re-enacted with the substitution of that kind of explosive for gunpowder: And whereas the Honourable Selby Walter Munsie, M.L.A., the Minister for the time being charged with the administration of the said Act, proposes to make by-laws, as set out in the Schedule hereto, for the conveyance of gunpowder and all other explosives under and in accordance with Section 30 of the said Act, and in pursuance of Section 31 of that Act, has directed that notice of his proposal to make such by-laws and the proposed by-laws them-selves shall be published once in the *Government Gazette*: Now, therefore, notice is hereby given that the said Honourable Minister proposes on the First day of March, 1936, to make by-laws under Section 30 of ''The Explosives Act, 1895,'' for the conveyance of gunpowder and all other explosives as set out in the Schedule hereto.

EXPLOSIVES ACT, 1895.

(Section 30.)

BY-LAWS.

Conveyance of Gunpowder and other Explosives. 1. (1) No gunpowder or any other explosive, in quantities greater than 100 lbs., shall be conveyed in any carriage other than a carriage which has been approved by an Inspector of Explosives and unless and until a permit authorising the conveyance of such gunpowder or other explosive has been issued by an Inspector of Explosives. (2) Such permit shall specify the maximum quantity of gunpowder or other explosive to be conveyed in any one carriage, and the route to be traversed by such carriage, and shall contain such other special conditions as the Inspector of Explosives issuing the same may consider necessary.

2. No gunpowder or other explosive shall be conveyed in any carriage, while such carriage is being used for the conveyance of passengers.

3. Carriages being used for the conveyance of gunpowder or other explosive shall not traverse any route used by tramways.

4. Save and except under a special permit issued by an Inspector of Explosives authorising the same, no other article or chattel shall be conveyed in a carriage whilst the same is being used for the conveyance of gunpowder or other explosives.

5. In addition to gunpowder, only those explosives which by regulations made and in force under "The Explosives Act, 1895," are permitted to be stored together shall be conveyed in the same carriage at the same time.

6. Gunpowder and other explosives shall not be conveyed in a carriage within the boundaries of any Municipality or Townsite except during the day between sunrise and sunset.

7. No person in charge of a carriage in which gunpowder or other explosive is being conveyed shall smoke or commit any other act liable to cause fire or explosion, and every such person shall take every reasonable precaution to prevent other persons upon or near the carriage in which gunpowder or other explosive is being conveyed from smoking or committing acts liable to cause fire or explosion.

S. Every person who commits or attempts to commit any breach of the foregoing by-laws shall be guilty of an offence against these by-laws, and shall be liable, on a conviction summarily by Justices sitting in Petty Sessions, to a penalty not exceeding Twenty pounds, and to an additional penalty of Ten pounds for each day or part of a day during which such offence continues, and shall be liable also to forfeiture of all or any part of the gunpowder or other explosive in respect of which the breach of these by-laws has been committed.

9. In the foregoing by-laws the term "explosive" shall have the same meaning as that given to the said term in Section 4 of "The Explosives Act, 1895," and the term "carriage" shall have the same meaning as that given to the said term in Section 6 of the said Act.

10. The foregoing by-laws shall apply in all cases where rules, regulations, or by-laws relating to conveyance of gunpowder or other explosives and made under Sections 26, 27, 28, or 29 of "The Explosives Act, 1895," do not apply.
