Regulation 1: Insert the words "or have" after the word "impel" in the first line. Strike out the words "upon a declared public highway or road" and insert in lieu thereof the words "upon a place provided for the purpose."

Regulation 2: Delete the regulation and substitute in lieu thereof the following regulation:—

No vehicle, team, cart, or wagon used for carrying any goods, bricks, stone, wood, iron, or merchandise of any kind (whether laden or not), nor any charabanc or other mechanically propelled vehicle capable of carrying more than seven passengers, hearse, mourning coach, camel, pack-horse, or other beast of burden shall enter or pass through the Reserves without permission.

Regulation 4: Delete the regulation and substitute in lieu thereof the following regulation:—

No person shall cut up, damage, disfigure, or interfere with the soil, rocks, turf, or surface of the gardens, coves, pleasure grounds, and appurtenance or of any part of the Reserves, or the roads or footways across, around or over the same or with any part of the fences, buildings, electrical equipment, machinery, rockwork, watercocks, or seats around or upon the same, or pollute or interfere with any water upon the same.

Regulation 6: Insert the words "or herself" after the word "himself" in the first line.

Regulation 12: Add the following words at the end of the existing Regulation "and no person using a lighted match in any portion of the Reserves shall throw away the same without first making sure that it is effectively extinguished."

Regulation 13: Delete the words "without permission" in the first line and add the following words at the end of the existing regulation "unless permission is first obtained and upon payment of such fees as the Board may direct in each case."

Regulation 15: Delete the words "without permission nor" in the fourth line and insert after the word "Reserves" in the fourth line the words "unless permission is first obtained and such fees paid as the Board may direct, and no person shall."

Regulation 18: Delete all the words following the word "sunset" and add in lieu thereof the words "except upon such occasions as the Board may determine otherwise."

Regulation 20: Delete.

Regulation 23: Delete the word "gardens" in the fourth line and substitute the word "Reserves."

Regulation 25: Delete the figure "6" in the last line and substitute the figure "15."

Regulation 26: Delete and substitute in lieu thereof—"No boat shall be moored or anchored, or kept or left moored or anchored or unattended opposite or near any part of any beaches which may be set aside from time to time, unless such boat is and remains at least one chain below low-water mark, except as hereinafter provided."

Regulation 27: Substitute the word "beaches" for the word "beach" in the second line.

Regulation 30: Delete—substitute the following regulation in lieu thereof:—

Notwithstanding the provisions of any other By-law, areas may be set apart for bathing and swimming, and no boat of any description shall be permitted to enter or remain in such area. Such areas may be defined from time to time by the placing of posts at intervals along the river side of such area and the posting of a notice indicating the purpose of the area thus set apart.

Regulation 31: Delete.

Regulation 32: Delete the following words starting in the third line at the words "at Reserve"—"at Reserve A17375 (Crawley) and Reserve No. 17391 (South Nedlands)".

Delete the following words in Clause (a) starting in the second line at the word "person"—"Person appointed by the Board from time to time to control and supervise the camping areas and shall particularly apply to the Master of the Old Men's Home for Reserve No. 17391, the Caretaker, Crawley Recreation Reserve for Reserve A17375," and substitute in lieu thereof the words "Superintendent, caretaker, or person in charge of the Reserve for the time being."

Insert the following words in Clause (b) after the eleventh line:—"Notwithstanding the above scale of charges, the scale of charges at Reserve A4813, Point Walter, shall be as follows:—For a period of one week or part thereof—5s."

Regulation 33: Insert after the word "being" in the tenth line the words "or, in his absence, to the Board," and insert after the word "him" in the same line the words "or the Board."

#### Additional By-laws.

The term "employee" shall mean and include any officer, caretaker, guide, gardener, keeper, labourer, workman or other person employed in any connection therewith, and shall include the members of the Board.

The Board may from time to time at its discretion levy and collect an admission fee, not exceeding 1s. for each and every vehicle or person entering the Reserves or any portion or enclosure thereof. The Board may also levy and collect by itself or its agents such charges as it may determine for the use of tennis courts, swimming pools, buildings and/or other conveniences in the Reserves.

#### Boundaries.

In any prosecution under these By-laws it shall not be necessary for the Board or its officers to prove the boundaries of the Reserve, but at the hearing of the complaint the averment contained in the complaint that the offence was committed within the boundaries of the Reserve shall be deemed to be proved in the absence of proof to the contrary.

#### Timber and Firewood.

No person shall cut or remove any tree or sapling, or any part thereof, either living or dead, for any purpose whatever, from any part of the Reserves, without permission.

#### Stone.

No person shall remove stone, gravel, or earth from any part of the Reserves.

#### Animals, Birds, and Fish.

No person shall disturb, interfere with, catch or destroy any bird, animal or fish, nor their nests, spawning grounds or other habitat within the Reserves, nor enter any portion set apart or enclosed for their sole use for breeding or otherwise.

#### Visitors to Caves.

No person or persons shall enter any cave unless accompanied by the authorised guide or caretaker.

#### Admission Fees.

Every person entering a cave shall pay to the caretaker or authorised guide, before entering, such admission fees as may be approved by the State Gardens Board from time to time.

#### Injuring or Disfiguring Caves.

No person shall break, remove, injure or deface, by writing, or by marking, or in any way damage any rock, stalactite, or stalagmite, or remove any rock, stalactite, or stalagmite, or in any way injure, damage, or disfigure the stairways, ladders, cave gates, railings, seats, fences, buildings, machinery, lighting appliances, or other structures or improvements, or gardens, or pleasure grounds and appurtenances within any cave or upon the Reserves.

#### Lights to be Used.

No person shall use in any cave any artificial light or lights, except those provided by the Board or its servants.

#### Smoking in Caves.

No person shall smoke within any cave.

#### Photographs.

No person shall take photographs in any cave without permission and after payment of any or such fees as the Board may direct in each case.

### FARMERS' DEBTS ADJUSTMENT ACT, 1930-1934.

NOTICE is hereby given that the following Stay Orders have been issued in accordance with Section 7, Subsection 1, of "The Farmers' Debts Adjustment Act, 1930-1934," which reads as follows:—

A Stay Order shall direct that no action, execution, distress for rent, proceedings on default for breach of covenant under any mortgage or other security for money, or under an agreement for sale and purchase of land, or other process or proceeding, shall be commenced or proceeded with or put in force against the farmer or any of the farmer's assets, whether utilised in connection with or forming portion of the assets comprised in his farming business or not, during the operation of such Stay Order: Provided that, by leave of a Judge, any action may, notwithstanding the Stay Order, be instituted and/or carried on against the farmer, but not beyond judgment.

## Amendment of By-laws.

P.H. 697/28; Ex. Co. No. 1421.  
WHEREAS Model By-laws have been prepared in accordance with the provisions of Section 295 of "The Health Act, 1911-35," and published in the *Government Gazette* on the 8th day of April, 1927: And whereas the Geraldton Municipal Council, being a Local Health Authority under the provisions of the said Act, did by resolution published in the *Government Gazette* on the 28th day of September, 1928, adopt either wholly or in part such Model By-laws to be its By-laws: And whereas

by the provisions of the said Act, a Local Authority may alter or amend By-laws so made: Now, therefore, the Geraldton Municipal Council, being the Local Health Authority, doth hereby amend the By-laws so adopted by the insertion of the following new By-law after By-law 23 of Part 1—

23A. Notwithstanding anything contained in the preceding By-laws, the Local Authority may approve of plans and specifications of proposed works or installations for the disposal of liquid waste produced upon any premises or of proposed work in connection with the construction or laying of any drains, or of any plumbing work in connection with the disposal of liquid refuse on any premises, although such plans and specifications shall contemplate works or installations which shall not be in accordance with the provisions of the preceding By-laws. Application for special approval under this By-law shall be made through the Town Clerk to the Local Authority and must be accompanied by a report from the Health Inspector upon the plans and specifications lodged and the situation of the premises to which they relate. No such approval shall be given if the Local Authority considers that the premises are situated in a closely populated area but, subject to this, approval may be given or refused, in the absolute discretion of the Local Authority. No such approval shall be deemed to exempt any person from complying with any part of the preceding By-laws, except in so far as the same shall necessarily be impliedly waived by such approval.

HIS Excellency the Lieutenant-Governor in Council has been pleased to approve of the following Rules and Regulations made by the Jarrahdale Hospital Board under the provisions of "The Hospitals Act, 1927."

#### RULES AND REGULATIONS OF THE JARRAHDALE DISTRICT HOSPITAL.

1. The Institution shall be known as the Jarrahdale District Hospital.

2. The Board of Management shall consist of seven members appointed by the Governor. Three of these members shall be nominated at a general public meeting to be held at Jarrahdale in July of each year, and one member to be nominated in July of each year from the following centres:—Serpentine, Mundijong, and Byford. In addition to these six members, the Serpentine-Jarrahdale Road Board shall be entitled to nominate one member of the Board of Management, so long as they continue to pay a subsidy towards the maintenance of the Hospital.

3. Any person who subscribes six shillings per calendar month shall be termed a subscriber: provided that any subscriber earning less than the basic wage shall only pay a subscription *pro rata*, but the minimum subscription shall be two shillings per calendar month.

4. In these Rules and Regulations the term "subscriber" shall mean any subscriber (male or female) who has paid his or her subscription and is financial, and shall include, so far as medical and hospital treatment is concerned, the wife or husband, parents, grandparents, sons or brothers up to the age of 16 years, daughters up to the age of 18 years, or female relative occupying the position of head of the household, provided they are residing with the subscriber, and wholly dependent on him or her.

5. Subscribers shall be entitled to medical and hospital treatment and medicines at the Jarrahdale District Hospital only, free of charge, for a period of three months in any one year, but the Board may extend the period at their own discretion.

Provided that, in serious cases, the Medical Officer may recommend the removal of a subscriber to another Hospital, should he deem the appliances at hand inadequate for proper treatment at the Jarrahdale District Hospital; in such case, the Board will pay maintenance at a rate not exceeding Two pounds two shillings per week for a period not exceeding Two months in any one year.

6. Subscribers shall not be entitled to benefits in cases of:—

1. Accouchements, abortive or otherwise.
2. Alcoholism.
3. Venereal disease.
4. Insanity.
5. Workers' compensation cases.
6. Surgical operations of choice.

7. Theatre Charge:—Major operations—one guinea; Minor operations—half guinea; Subscribers—free.

X-Ray Charge—One guinea, with 50% reduction for subscribers. Workers' compensation cases at schedule rates. Of these fees, the Medical Officer to be entitled to one half, the Board retaining the other half.

Hospital Charge.—In-patients, non-subscribers' cases, and workers' compensation cases—three guineas; maternity cases—awaiting confinement, 5s. per day, during confinement £3 10s. per week; Millars' T. & T. Coy., Ltd., workers' compensation cases—6s. daily.

8. Notice of Annual Meeting:—The secretary shall give at least fourteen days' notice before the day of meeting, and such notice shall be advertised in such manner and at such places as the Board for the time being shall direct.

9. Business at Annual Meeting:—The order of business at the annual meeting shall be:—Report of the Board and the financial statement for the previous year; selection of members; notice of motion; general business.

10. Special Meeting of Subscribers:—It shall be competent for the Board of Management, or any twenty (20) or more subscribers, by writing under



their hands, to require the secretary to summon a special meeting of subscribers, the occasion for calling such a meeting being specified in the requisition, and no business shall be transacted at such special meeting, except that for which it is called; notice in writing to be given to the secretary at least one month prior to the date of such meeting.

11. If any member of the Board of Management is absent from three consecutive meetings without leave of absence, the Board may recommend to the Governor that his seat be declared vacant; also, the Board may recommend the appointment of another person to the vacant seat, such appointment to take effect until the next annual selection.

12. The matron shall be appointed by the Board of Management and shall hold office upon such terms as they may direct. She shall reside in the quarters provided for her and devote her time and attention to the superintendence and general management of the Hospital. She shall also take charge of the domestic affairs of the Nurse Quarters, and of the Hospital generally, and have under the Medical Officer control of all nurses and employees attached to the Hospital; and, in case of disobedience of the orders, misconduct or neglect of duty on the part of any employee, she shall fully report thereon forthwith to the Medical Officer and Board of Management through the Secretary. The Matron shall also do the ordinary nursing duties of the Hospital, as the Medical Officer may direct. She will report monthly to the Board of Management.

13. She shall employ all assistance in doing such work as she may direct for the benefits of the Hospital, subject to the approval of the Board of Management.

14. She shall strictly attend to the direction of the Medical Officer and use her utmost endeavours to prevent the introduction of liquors and improper provisions for the patients. She shall see that all patients receive proper attention, and are treated with kindness.

15. Prior to the admission of any patients to the wards, she shall take care that their persons and clothing are in a proper state, and she shall take charge of any property which they may have and on the discharge or death of patients. She shall replace the whole of the bed linen with clean articles.

16. In the event of any patient requiring the presence of any minister of religion, she shall take measures that the request is complied with without delay.

17. She shall at once report any observed irregularities to the Medical Officer or Board of Management.

18. She shall not be absent from the Hospital at any time without leaving competent persons in charge.

19. She shall, in company with the Medical Officer and secretary, see that proper inventories are made in the month of June of all stores, furniture, clothing, etc., etc., belonging to the Hospital.

20. She shall order and receive the stores and supplies and see that they correspond in description, quality, and quantity with the orders and in case they do not, she shall report discrepancies to the Board of Management.

21. She shall not suffer any provisions, stores, or utensils to be carried away from the Hospital.

22. She shall take down from patients on admission all particulars necessary to keep the books of admissions. She will also state the nature of the case, medicine prescribed, diets, with extras, and dates of admission and discharge.

23. Visitors and Ministers of Religion:—Visitors shall be admitted to see patients on Wednesdays and Sundays, between the hours of two and four p.m. or at other times by special permission of the Medical Officer or matron or Board of Management.

24. Visitors must not interfere with the matron, nurse, or orderly, nor distract the patients by loud talking or unnecessary noise, on pain of instant dismissal.

25. Visitors supplying liquor or provisions directly to the patients shall be prohibited from visiting the Hospital without special leave from the Medical Officer.

26. Visitors under the influence of drink not allowed to enter,

27. No visitors shall supply anything whatsoever to a patient without the consent of the Medical Officer or matron.

28. On no account shall male visitors be admitted to a female ward without the consent of the Medical Officer or matron.

29. All visitors to retire when requested to do so.

30. Ministers of religion shall have free access to patients of their respective denominations, at such times as shall be appointed by the Board of Management. Any Minister may attend patients when requested by such patients. He shall perform the duties of his office at the bedside of the patient, in such a manner as to be as little as possible overheard by other patients.

Secretary—Appointment and Duties:—The secretary shall be appointed by the Board of Management and his salary shall be fixed by them. He shall correctly keep the books and accounts pertaining to the finances of the institution, and shall afford the Board of Management every information on all matters that come within his duties, as may seem to them necessary. He shall keep an up-to-date list, showing the names of all subscribers, the amounts paid by them into the general fund of the Hospital. He shall prepare a balance sheet showing the Institution's financial operations for twelve months ending 30th June of each year, and shall make up the books and have all vouchers and documents correct, when required to be examined by the Auditors. Any moneys received by him on account of the Institution must be paid into the Institution's bank account. He shall at all times be under the control of the Board of Management, and bring all matter within his knowledge under their notice and shall be in attendance at all Board meetings. The period of his employment shall be determined by one month's notice on either side.

32. All complaints against the Medical Officer or nursing staff must be sent in writing to the Board of Management within fourteen days of the cause for complaint. The Board shall investigate same and shall notify the Medical Officer and nursing staff of same. No verbal complaints will be admitted.

##### Cancellation of Dedication.

HIS Excellency the Lieutenant-Governor in Executive Council has been pleased to approve, under the provisions of "The Cemeteries Act, 1897," and amendments, of the following By-laws for the control and management of the Dalwallinu Public Cemetery, in lieu of the By-laws previously gazetted, which are hereby cancelled.

#### THE CEMETERIES ACT, 1897.

##### By-laws Dalwallinu Public Cemetery.

By virtue of all powers in that behalf vested in the Dalwallinu Cemetery Board the said Board make the following By-laws:—

1. All fees and charges payable to the Board as set forth in Schedule A shall be paid at the times and manner therein mentioned, unless otherwise ordered.

2. Any person desiring to inter any dead body in the Cemetery shall make an application in the form contained in Schedule E.

3. All applications for interment shall be made at the office of the Board, in such time as to allow at least eight working hours' notice being given to the secretary prior to the time fixed for burial, otherwise an extra charge shall be made.

4. The Board shall cause all graves to be dug, and vaults, brick graves, or graves to be reopened as and when required.

5. Every grave shall be at least 6 ft. deep at the first interment, and no interment shall be allowed in any grave with a less depth than 3 ft from the top of the coffin to the original surface of the surrounding ground.

6. In the case of an application for interment in any grave or vault to which the deceased had no claim during life, the written and verified consent of the grantee shall be handed in with the application.

7. No burial shall be allowed to take place in the Cemetery, nor shall any coffin be allowed to enter the

Cemetery, unless a certificate from a District Registrar of Deaths that the death has been registered, or a Coroner's order for burial is handed to the secretary, at the latest upon the funeral entering the Cemetery. Should the undertaker or his representatives be unable to produce the said certificate from the Registrar, he shall give a written guarantee to produce same within three days, and satisfactory reasons must be given for the non-production of such certificate in the first instance. In default of the production of the said certificate within three days, the undertaker's license may be suspended until such certificate is produced. The certificate will be retained, but the Coroner's order shall be returned to the person delivering same.

8. No interment shall be allowed on Sunday, except when it is certified in writing by a Medical Officer of Health, or by a Police Magistrate, or by two Justices of the Peace, that for sanitary or special religious reasons it is necessary or advisable that the burial take place on that day.

9. Subject to good behaviour the Cemetery shall be open to visitors during the hours of daylight.

The office of the Board will be open for business from 9 a.m. to 5 p.m. on week days and 9 a.m. to 12 a.m. on Saturdays. The hours for burial shall be between sunrise and sunset; and no burial shall be allowed to take place nor any coffin allowed to enter the Cemetery at any other hour, except by written permission of the Board.

10. The time fixed for any burial shall be the time at which the funeral is to arrive at the Cemetery gates, and if not punctually observed the undertaker responsible shall be liable to a fine of 10s. 6d.

11. If for any reason the funeral shall on arrival at the entrance gates to the Cemetery remain there for more than 15 minutes prior to proceeding to the graveside, undertakers responsible shall be liable to a fine of ten shillings and sixpence.

12. Every funeral shall enter by the principal entrance, and no vehicle, except the hearse and mourning coaches, shall be permitted to enter the Cemetery.

The funeral cortege shall proceed at walking pace, and no vehicle shall exceed the speed of fifteen miles an hour within the Cemetery, and shall proceed by such roads as directed by the secretary or other officer of the Board from time to time. Any driver or other person failing or neglecting to observe such directions may be forthwith expelled from the Cemetery.

13. If application be made to the Board to exhumate any corpse for the purpose of examination or identification, or for the purpose of its being buried elsewhere than in the Cemetery in accordance with the wishes of the deceased, or of his family, an order from the Governor authorising the Board to permit of the exhumation must be attached to the application form.

14. Children under the age of ten years entering the Cemetery must be in charge of some responsible person.

15. Fireworks or firearms shall not be discharged upon ground vested in the Board.

16. No dogs shall be admitted to the Cemetery, and any found there shall be liable to be destroyed.

17. Any person violating the rules of propriety and decorum, or committing any nuisance or trespass, or injuring any tree, shrub, flower, border, or grave, or any erection, or in any way infringing these By-laws, shall be expelled from the Cemetery.

18. No person shall remove any plant, tree, shrub, flower (other than withered flowers), which are to be laid in the places provided for same, or any article from any grave without first obtaining a permit from the Board.

19. No person shall pluck any tree, plant, shrub, or flower growing in any portion of the Cemetery.

20. No person shall remove or carry out of or attempt to carry out of the Cemetery any tree, plant, shrub, or flower without the written authority of the Board.

21. No person shall promote or advertise or carry on within the Cemetery any trade, business, or calling, either by solicitations, distribution of circulars, by cards or otherwise, or by any other system of advertisement whatsoever, without the written consent of the Board, and any person infringing this By-law shall be expelled from the Cemetery.

22. No person employed by or under the Board shall be permitted to accept any gratuity whatever, nor shall he be pecuniarily interested in any work in the Cemetery, other than the remuneration he received from the

Board, and any such person proved guilty of accepting any gratuity or being pecuniarily interested in any such work shall be liable to summary dismissal.

23. Subject to the By-laws and to the direction of the Board, the secretary shall exercise a general supervision and control over all matters pertaining to the Cemetery, including the conduct of all funerals and interments within the Cemetery.

24. Any person requiring an "Exclusive Right of Burial" shall make application to the Board, specifying the location of the grave, and, where it is proposed to erect a brick grave or vault, submitting plans and specifications of the proposed work. Such application shall also state the names of any already deceased persons whose remains it is proposed to inter therein.

25. Upon being satisfied of the matters aforesaid and of the suitability of the said work, plans, and specifications, the Board may authorise the construction and erection thereof, or, if no work is to be done, may issue a Grant in the Form B in the Schedule.

26. Upon the completion of the work aforesaid, the Board may, if and when the work is done to their complete satisfaction, issue a Grant in the Form B in the Schedule.

27. Every such Grant shall be subject to the By-laws for the time being, and no interment in any such grave or vault shall be allowed unless upon production of the Grant aforesaid, unless with the consent of the Board.

28. Every coffin placed in any such brick grave or vault shall be bricked in, cemented, and any space surrounding such coffin to be filled in with charcoal, dry earth, or other suitable material and covered with a slab of stone, slate or iron, unless special written exemption be obtained from the Board.

29. In the event of such exemption being obtained from the Board, each coffin placed in any brick grave or vault shall be properly leadlined and hermetically sealed.

30. If application be made for an interment in any grave or vault of the remains of any person other than the person to whom the Grant was issued, or his registered assign, the written and verified consent of such grantee or assignee shall be produced, together with the "Grant of Right of Burial."

31. Should the grantee be unable to produce the "Grant of Right of Burial" on making application for a grave to be reopened for the purpose of interment, through having lost same, the said grantee shall make a sworn declaration to this effect, and shall pay the fee for a copy of such "Grant of Right of Burial," as prescribed in Schedule B, before the interment takes place.

32. Any person desiring to place or erect, or to alter or add to any monument, tombstone, or enclosure in any part of the Cemetery, must first obtain the written consent and approval of the Board and otherwise comply with Section 23 of the principal Act (61 Vict., No. 23).

33. Every tombstone, monument, or enclosure shall be placed on proper and substantial foundations, which, if required by the Board or their officers, shall extend to the bottom of the grave.

34. The materials used in every such erection shall be subject to the approval of the secretary or other officer appointed by the Board, and any material rejected shall be immediately removed from the Cemetery by the contractor for the erection. All refuse and other rubbish remaining after any work is completed shall be immediately removed from the Cemetery by the person causing the same.

35. Should any work by masons or others be not completed before a Sunday, they shall be required to leave the work in a neat and safe condition, to the satisfaction of the secretary.

36. Monumental masons and other tradesmen shall, before commencing any work within the Cemetery, deposit with the secretary to the Board the sum of 10s., which shall be forfeited if the provisions of either of the preceding two By-laws be not complied with to the satisfaction of the Secretary.

37. All material required in the erection and completion of any work shall as far as possible be prepared before being taken to the Cemetery, and all materials required by tradesmen shall be admitted at such entrance as the secretary shall direct, and no load exceeding two tons weight shall be permitted to enter the Cemetery.

38. No catacomb shall be allowed.

39. Monumental masons shall not be permitted to carry on work within the Cemetery during other than ordinary working hours of 8 a.m. to 5 p.m. on week days and 8 a.m. to noon on Saturdays, except where employed to remove monumental work for burials, without the written permission of the Board.

40. No wooden fence, railing, cross, or other wooden erection shall be allowed on or around any grave or vault.

41. No trees, shrubs, plants, or grasses shall be grown within the Cemetery, except such as are approved of by the Board. The Board reserve the right to remove any such trees, shrubs, or grasses as they may think proper.

42. All workmen, whether employed by the Board or by any other person, shall at all times, whilst within the boundaries of the Cemetery, be subjected to the supervision of the secretary, and shall obey such directions as that officer may find it necessary to give, and any workman permitting any breach of these Regulations and By-laws, or refusing or neglecting to comply with any directions of the said secretary, shall be removable from the Cemetery.

43. Licenses for grave dressing or decorating may be issued by the Board in the form contained in Schedule F, such licenses to be renewed annually in the month of July.

44. Any person taking part in the dressing or attending to any grave shall comply with the following Rules:—

(a) No rubbish, soil, sand, or other material removed in dressing a grave shall be placed on any other grave, and, if placed on any adjoining ground shall be removed immediately the work is completed;

(b) No sand, soil, or loam shall be taken from any portion of the Cemetery for the purpose of dressing any grave, except with the permission of the secretary;

(c) The dressing of all graves and the wheeling and carting of all material shall be subject to the supervision of the secretary;

(d) Work in all cases to be carried on with due despatch and only during regulation hours.

45. Prior to conducting any interment within any Cemeteries controlled by the Board, or making use of the Cemeteries for any purposes connected with interments or exhumations, every undertaker shall pay to the Board an annual fee of £1 1s., and shall at the time of making such payment give his assent in writing to such conditions as the Board may deem fit to impose. Upon such assent being given and payment of the fee made, he shall receive a permit, to hold good during good behaviour and until the first day of July following, and unless in the possession of such a permit no undertaker shall be allowed to engage in or carry out any duty or work within the Cemeteries.

46. The Board may decorate graves from time to time, when desired by the grantees so to do. If the grantees do not desire the Board to carry out this work, the grantees may either do it themselves or employ any person licensed by the Board for that purpose.

47. No person, except the relatives of the deceased, the Board, or those licensed by the Board, shall be permitted to decorate any grave.

48. If for the purpose of reopening a grave, the Board find it necessary to remove edging tiles, plants, shrubs, etc., from off the grave, the person so ordering the reopening shall pay to the Board the charges laid down in Schedule A.

49. No interment or monumental work shall be permitted by the secretary, unless an iron number plate shall be on the grave, or unless an iron number plate be paid for.

50. Any person committing any breach of any of these By-laws and Regulations, or of any other Rules, Regulations, or By-laws lawfully made under the authority of any Act relating to Cemeteries, shall for every such offence be liable to a penalty not exceeding £5, and, in case of a continuing breach, a further sum not exceeding £1 for every day during which such breach continues, and shall be forthwith removable from the Cemetery by the Board, the secretary, or any other officer of the Board, and shall be treated as a trespasser, and may be proceeded against accordingly.

51. A plan of the Cemetery, showing the distribution of the land, sections, and situation and number of grave, and a register of all Certificates of "Rights of Burial" shall be kept at the Board's Office.

The foregoing By-laws, with the accompanying Schedules, were duly framed and presented to a meeting of the Board held at their Office at Dalwallinu on the 14th day of September, one thousand nine hundred and thirty-five.

THE ELECTRIC LIGHTING ACT, 1892.

Cue Road Board.

P.W. 451/36.

BY LAWS of the Cue Road Board made under "The Electric Lighting Act, 1892," and its amendments: in pursuance of the powers conferred by the said Act, the Cue Road Board orders as follows:—

ELECTRICITY SUPPLY DEPARTMENT.

Service Rules and Regulations for the Supply of Electricity in the Townsite of Cue.

1. Applications for connections:—Application for service connections must be made on the Board's application form and filed at the office of the Board at least three clear days before the connection is required. (The making of application or paying of deposit will not bind the Board to give the supply until the application is approved on behalf of the Board.) The Board will make every effort to make the connection at the time desired by the applicant, but will not be bound to any particular date in case of shortage of labour, material, or electric current.

2. Security:—The Board shall require a security deposit with each application, or may do so at any time after the service is connected, in such an amount as the Board may consider sufficient security, with a minimum of fifteen shillings (15s.).

3. Accounts:—Accounts will be rendered weekly, monthly, bi-monthly, or quarterly at the option of the Board, and at the Board's ruling rates for the district in which the service is rendered, and must be paid on or before the prescribed date. If not paid at the Board's office on or before that date, the right is reserved to cut off and discontinue the supply without further notice.

4. System:—Electric current will be supplied, except where special arrangements may be made, from the Board's Direct Current System, subject, however, to Clause 35 hereunder. All lighting will be, and motors up to two horsepower may be, supplied at nominally 220 volts.

5. Wiring of Installations:—All wiring of installations to be connected shall be in accordance with the standard wiring rules of the Standards Association of Australia, and the requirements of the Department of Public Health and the Public Works Department, for the time being in force, and no connection will be made without a certificate that the installation is in order and on such form as may be from time to time prescribed by the Public Works Department.

6. Position of Service Leads, Fuses, etc.:—The Board will decide as to the most suitable position for its fuses, circuit breakers, indicators, meters, and terminations of service leads. The position of service fuses will be as near as possible to the point where the mains touch the building but one in which they may be reached by a short ladder for replacing fuses. Fuses may be fixed in any suitable position, and, unless of weather-proof type, shall be sheltered from the weather. Where fuses are within a building they will be placed within ten feet of the point of entrance of the supply leads.

7. Consumer's Main Switch and Fuses:—The Board will provide and fix the meter board and meter, to which the consumer must bring his mains and provide on his side of the meter a double pole link switch.

8. Capacity of Main Switches:—The foregoing switches shall be of ample capacity and of approved design. Sufficient length of wire shall be left by the consumer to connect to the Board's meter. In all cases the line wires are at the left and consumer's wires at the right of the meter.

9. Consumer's Terminals and Leads:—The point of termination of the Board's service leads shall be deemed to be the position of the consumer's terminals, which position in the case of an overhead supply shall be on the outside of the building, and is hereinafter designated "the point of entry," and shall be as high as convenient on the building, but not higher than two storeys, unless especially approved. The consumer's leads shall be of sufficient length to allow of their ends being properly



connected to the service conductors at the consumer's terminals. Loops shall be left in the leads for the insertion by the Board of its meter, cut-outs or other apparatus. At the point of entry to buildings the consumer's leads shall be provided with a suitable bell-mouthed bend or other approved terminals fitting of the watershed type. Porcelain bushings through roofs, etc., will not be permitted.

10. Meters and meter boards:

(a) The consumer or contractor shall consult the Board as to the position of the meter board, which must be fixed in a position approved by the Board, protected from the weather, out of doors, or elsewhere accessible to the Board at all reasonable times.

(b) In large buildings all circuits must be brought to one or more central points, as may be arranged with the Board, where the Board's circuits will enter and the necessary meter or meters be placed. The Board will not supply meters promiscuously throughout buildings.

(c) In cases where a building is let in single rooms or groups of offices or flats, the Board will only instal one set of meters and supply current to the building as a whole with the landlord or chief tenant as consumer.

(d) The Board may, if requested in such cases, supply to the landlord, at a rental, meters required by the landlord for metering the supply to various tenants, and may, without extra charge, read such meters at the same time as the master meters are read, and supply the readings to the landlord so that he can collect the value of the current consumed from his various tenants. In all such cases the landlord must charge the tenants the same meter rental and tariff for the electricity used as the tenants should pay if supplied direct by the Board.

(e) Should the Board from any cause whatsoever be short in its stock of meters, meter boards, and fittings, or any or either of them, then it shall not be incumbent upon the Board to supply and/or affix a meter, meter-board and fittings, or any or either of them on any consumer's premises; but the Board may, in its absolute discretion and with the consent of the consumer, for the purpose of assessing the amount of current consumed, take into consideration the number and kind of lamps in use, the heating points in use, and the time same are used, and may render accounts for the amount of current estimated on this basis.

11. Fixing of Leads in Fuses, Meters, etc.:—Only an employee of the Board may insert the ends of the consumer's leads into any service fuse, meter, indicator, current limiter, or other device the property of the Board.

12. Board's Property:—The service mains and fuses, meters, and other apparatus fixed by the Board on the consumer's premises shall remain the property of the Board, and the consumer will be held responsible for any interference whatsoever with any such property.

13. Nature and Protection of Consumer's Leads:—The consumer's main switchboard may be placed in any convenient position on his premises. Conductors between the point of entry and the consumer's main switch shall be of best quality V.I.R. insulation, without joints, installed in conduit, and, where exposed to the weather conduit, shall be screwed. The conductors shall be stranded wire and of not less than 7/036 sectional area.

14. The Board's Service Fuses:—The service fuses fixed by the Board on the main side of the meter may or may not be sealed by the Board, but they shall not in any case be interfered with by the consumer, who must provide suitable fuses on the load side of the consumer's main switch.

15. Testing Insulation:—Before any installation is connected to the supply mains, and before alterations or additions to an installation are connected, they shall be tested by the Board once free of charge. If defective, connection will not be made until the defect is remedied, and a minimum charge of 5s. will be made for the second test and 10s. each for subsequent tests, to be paid by the consumer before connection is made.

16. Service Connection:—The Board will run the overhead service wire to insulators attached to the outside of the consumer's premises at the point of entry, when the distance from the street in which the mains are located does not exceed 66 feet. Above that distance, or if special or underground cables are required, the cost may be charged to the consumer.

17. Conductors not to be Earthed:—No conductor in any consumer's premises shall be connected to the earth, and all conductors shall be equally insulated as provided in the wiring rules of the Standards Association of Australia. No supply will be given to premises wired on the concentric system using an uninsulated "outer" conductor.

18. Wall Plugs for Lighting and Power:—When it is required to provide for separate metering of current supplied at different rates, the installation shall be divided into separate and distinct circuits, which must not be bunched, and all wall plugs, connectors, and the like shall be of different types, so that it shall not be possible to connect apparatus chargeable at a certain rate to any part of the installation conveying current chargeable at a lower rate. No lampholder shall be connected to any circuit the supply to which is given at the power of heating rates, except as provided in S.A.A. 442, in the case of pilot lamps, which, however, shall be so installed as to render it impossible to use them for general illuminating purposes.

19. Switches to be on Non-earthed Conductors:—The ends of the non-earthed conductors to which all single pole switches must be connected in accordance with Rule 162 of the S.A.A. shall be labelled "Switchwire," in order that the Council may correctly connect the consumer's leads to the service leads.

20. All applicants must state clearly the nature and number of the consuming devices and the current taken by each, such as—

1. Number of lamps and candle power of each.
2. Number of motors and horse power of each.
3. Number of other current-consuming devices, radiators, toasters, kettles, ovens, cooking ranges, vacuum cleaners, etc., and current rate of each.

21. Interference with the Supply to other Consumers, Welders, Furnaces, etc.:—Before a consumer purchases any special apparatus with a view to having it connected to the Board's mains, such as welding apparatus, furnaces, X-ray outfits, rapidly fluctuating motors or other loads, he is strongly recommended to submit full particulars to and ascertain from the Board whether such apparatus will be connected and under what conditions, otherwise the Board may refuse to connect. Such apparatus will only be connected where the mains are large enough to carry the current required, without adversely affecting the supply to other consumers, and provided such apparatus has been approved by the Board. In the event of a consumer operating any such apparatus aforesaid, or any lift or motor in such a manner as shall in the opinion of the Board interfere with the supply to other consumers, the Board may call upon him to make such necessary adjustments or alterations and to so operate the apparatus as shall in the opinion of the Board insure that the supply to other consumers be not interfered with, and in the event of his failing to do so the Board may cut off the supply of electricity to him. The fact that the Board shall have connected and approved of the apparatus aforesaid shall not be taken to exempt the consumer from the operation of this clause.

22. Special Lighting and Power for Temporary or Special Services:—Special lighting or power such as ovens, wet premises, out-door displays, illuminations, lighting or power of a temporary nature, or where the conditions are unusual, must be discussed with the Board or representative before the installation is made and approval obtained before the work will be connected.

23. Addition to Installations:—When first connected the consumer will supply the Board with full details of all apparatus connected to the circuits. No addition of lamps, motors, cookers, or other apparatus shall be made until the Board has been notified of such intended addition and the consent of the Board has been obtained, and the consumer shall be fully responsible for any damage to meters or other apparatus which may occur through failure to comply with this regulation, in addition to being liable to disconnection.

24. Meter Deposit:—A deposit of 15s. will be required by the Board, to be paid by the consumer for each meter installed.

25. Minimum Charge:—A minimum charge of 6s. 3d. per month for business premises and 3s. 9d. per month for private dwellings in addition to meter rental will be made, whether electricity to that amount is used or not.

26. Meter Readings:—The reading of the meter or other measuring device provided by the Board shall be taken as *prima facie* evidence of the quantity of electricity consumed. If the meter or other measuring device fails to register, or is found to be inaccurate, the account for the period since the last account was rendered shall be adjusted, at the option of the Board, upon the basis of—

- (a) the account rendered to the consumer for the corresponding period of the last year; or
- (b) the account for the last preceding period; a reasonable allowance being made for any known variations in the demand subject to the provisions contained in the agreement signed by the consumer, the conditions of which are also contained on the back thereof.

27. Testing of Meters:—The Board shall have the right to test meters at any time and adjust the consumption for the current period on such test. The cost of testing such meter shall be borne by the Board, unless the meter is tested on the complaint or at the request of the consumer, in which case a testing fee of 5s. shall be paid before the meter is tested. If it is found on testing that the meter is more than two (2) per cent. fast, a refund of the testing fee will be made to the consumer. Meters will be considered to be correct if on testing they are found to register within two per cent. of the Board's standard certified meters, and no adjustment of accounts will be made. All outstanding accounts must be paid before the test is made.

28. Board's Apparatus, Interruptions, Responsibility:—The Board—

- (a) shall have the right at all reasonable times to enter the premises of the consumer to inspect and test the Board meter, fittings, etc., and to remove any of the Board's property;
- (b) may at any time interrupt the supply to make tests, alterations, or repairs to the Board's system, or for any other purposes;
- (c) shall not be responsible or liable for any injury, damage, or loss of any kind to the person, property, or business of the consumer, or to the consumer's lamps or apparatus, resulting from fire or otherwise through the supply of electricity, or through interruptions or defects of supply due to storm, accident, or breakdown of plant, or mains, or *force majeure*.

29. Right to Disconnect:—The Board shall have the right to disconnect the consumer without notice if—

- (a) the consumer is in arrears in payment of account; or
- (b) the consumer's installations are faulty; or
- (c) the consumer uses the service in any way that interferes with the general supply to other consumers; or
- (d) the consumer uses apparatus not authorised by the Board; or
- (e) the consumer connects increased load without first obtaining the consent of the Board; or
- (f) the consumer interferes with the seals, fuses, meters, or other apparatus the property of the Board; or
- (g) the consumer fails to conform to the Board's regulations in any way.

30. Charge for Reconnection:—If the supply is disconnected for any of the above reasons a charge of 5s. will be made, and must be paid before reconnection.

31. Termination of Connection:—The consumer shall give the Board at least three clear days' notice in writ-

ing of desire to terminate and shall be responsible for all current used until the expiration of such notice.

32. Consumer's Liability for Loss:—The consumer will be held responsible for loss by fire, damage, or theft of the meters or other apparatus hired from or loaned by the Board, on the consumer's premises, in connection with the supply of current to the consumer. The consumer shall insure the Board's property on the consumer's premises against fire.

33. Complaints:—All complaints as to defective service or account must be made to the Board's office, and every effort will be made to rectify same as promptly as possible, but the Board will not be held responsible for any delay. Complaints should be made in writing.

34. Lighting:—Any unauthorised person who shall light, put out when lighted, or in any way interfere with any lamp belonging to the Board, or any person who shall damage or destroy such lamp, shall pay, in addition to the value of such damage, if any, on conviction a sum not exceeding Five pounds.

35. Penalties, etc.:—Any person or persons offending against any of the provisions of these By-laws shall for every such offence be liable to a penalty not exceeding Twenty pounds (£20).

In mining operations where more than one charge is to be exploded, the cartridge method of firing, or some method approved by the Minister which reduces the number of fuses to be lit at any one time to a minimum shall be used—

- (1) In shaft sinking, winzing and rising not more than three fuses are to be lit at any one time; the master fuse shall not be less than six feet in length.
- (2) In driving, crosscutting, and work carried on in all other development places, not more than four fuses shall be lit at any one time; the master fuse shall not be less than six feet in length.
- (3) In stoping, no charge shall be fired without the use of a cartridge and master fuse; the master fuse shall not be less than six feet in length.

This regulation shall not apply when popping rocks and cutting hitches.

## IN THE COURT OF ARBITRATION OF WESTERN AUSTRALIA.

No. 13 of 1931.

Between Metropolitan Brick Company, Limited; L. Whiteman, J. Hesketh, Cardup Brick Company, Applicants, and Westralian Brickyard, Pottery, Porcelain, and Roof Tile Fixers Employees' Union of Workers, Perth, Respondents.

WHEREAS an industrial dispute existed between the abovenamed parties: And whereas the Court of Arbitration, pursuant to Section 63 of "The Industrial Arbitration Act, 1912-1935," made certain suggestions and recommendations to the said parties, and acting thereon the said parties have arrived at an agreement as to all matters in dispute between them, a memorandum whereof, certified by me and filed in the Court as provided in the said Section 63, is hereby appended:—

*Memorandum of Agreement.*

(Note.—Wherever the word "Award" occurs herein it shall be taken to mean and include "Agreement.")

## 1.—Area.

This Award shall apply over the area comprised within a radius of eighty (80) miles from the General Post Office, Perth.

## 2.—Term.

This Award shall operate for a period of three (3) years from the 1st day of July, 1936: Provided that at any time after the expiration of twelve (12) months from its date, application may be made to the Court for alteration, revision, or amendment.

## 3.—Hours.

Except as otherwise provided in this Award, the following shall apply:—

(a) Forty-four (44) hours shall constitute the ordinary week's work.

(b) The ordinary day's work shall not exceed eight (8) hours, Monday to Friday inclusive, and four (4) hours on Saturday.

(c) The hours of work, except where shifts are worked, shall be performed as follows:—Monday to Friday, inclusive—between 7 a.m. and 5.30 p.m.; Saturday—between 7 a.m. and 12.15 p.m.

Provided that, at the option of the employer, the ordinary week's work of forty-four (44) hours may be worked in five (5) days (from Monday to Friday, inclusive) within hours mutually agreed upon between the employer and the Union.

## 4.—Shift Work.

Where two (2) or more shifts in any one day are worked, the hours of shift workers shall be such as are mutually agreed upon between the employer and the Union. Failing agreement, the hours of shift workers shall be fixed by the Board of Reference.

## 5.—Overtime.

Subject to the proviso in Clause 3 (c) hereof, work performed beyond eight (8) hours on Monday to Friday, inclusive, or beyond four (4) hours on Saturday, or beyond forty-four (44) hours in any one week, or, except in the case of shift work, before the prescribed starting or after the prescribed finishing time, shall be deemed to be overtime.

(a) Overtime shall be paid for at the rate of time and a quarter for the first two (2) hours and time and a half thereafter.

(b) Work performed on Sunday, Christmas Day, Labour Day, Boxing Day, Good Friday, and Anzac Day shall be paid for at the rate of double time: Provided that this shall not apply to burners who shall only be paid double time for work performed on Christmas Day and Boxing Day and time and a half for work performed on Labour Day, Good Friday, and Anzac Day.

(c) Workers under the age of eighteen (18) years shall not, as far as practicable, be called upon to work between the hours of midnight and 6 a.m.

(d) As far as practicable when overtime is worked, any worker who is called upon to work such overtime shall be selected from amongst those workers performing the class of work that is required to be done during the time that such overtime is worked.

## 6.—Minimum Engagement.

Except as provided in Clause 17, any worker engaged under the terms of this Award shall be paid a minimum of three (3) hours' pay.

## 7.—Holidays.

(a) Subject as hereinafter provided, twelve (12) days' holiday on full pay shall be granted to each worker per annum.

(b) Good Friday, Easter Monday, Anzac Day, Labour Day, or the days observed in lieu, and Union Picnic Day (on a date to be agreed upon between the parties, about the middle of February in each year) shall constitute five (5) of such twelve (12) holidays. The remaining seven (7) days' holiday shall be taken between the 23rd day of December and the 2nd day of January, inclusive: Provided that burners on Hoffman or Osborne kilns may be granted the holidays prescribed in Subclause (a) of this clause at some other time mutually agreed upon between the employer and the Union. When this proviso is availed of the holidays due shall be taken within three (3) months of the completion of each year that the worker is in the service of the employer.

Provided further, that where a burner on Hoffman or Osborne kilns is granted holidays in the manner laid down in the foregoing proviso, he shall not be entitled to claim payment for any of the other holidays prescribed for other workers, and if work be performed by him on such other holidays, ordinary rates shall be paid for such work, except on Christmas Day and Boxing Day, when double time shall be paid.

Holiday pay for all workers shall be limited to twelve (12) days per annum.

(c) A worker employed for more than one (1) week and for less than twelve (12) months shall be paid holiday pay in proportion as his length of service is to the full year's employment.

(d) Where a worker is dismissed for wilful misconduct or dereliction of duty, he will not be entitled to the benefit of the provisions of this clause.

(e) Holiday pay shall not accrue during a worker's absence from duty for any cause whatsoever.

## (iv) Piecework:

- (a) An employer may make a contract with a drawer for payment by results by piecework.
- (b) The rate of payment shall be fixed on the basis that it shall be sufficient to yield to a drawer of average capacity for a full week's work of the ordinary hours at least the minimum time rate of pay recognised by custom for such week's work: Provided that, where a drawer works part of a full week at piecework rates and part at time rates, he shall be paid so much as he is entitled to receive under such piecework rates, plus the proportionate amount which he is entitled to receive at time rates of pay recognised by custom.
- (c) A drawer working under any system of payment by results shall receive at least the time rate of pay recognised by custom for drawers.
- (d) In the event of any dispute regarding piecework rates occurring and remaining unsettled between the employer and a drawer, the employer or the Union may refer such dispute to the Board of Reference.

## 9.—Open Kiln Burners.

(a) Ten (10) hours shall constitute a night's work, starting at 7 p.m. and finishing at 6 a.m., one hour during that period being allowed for meals. Any time so worked shall not count in the week's work.

(b) All burners employed on full night shift shall be kept on until after the last complete feed on that night. Burners working on broken shifts shall be paid one (1) hour in addition to the actual time worked at the conclusion of the last feed.

(c) Not less than two (2) men shall be employed on kilns containing up to fifty-five thousand (55,000) bricks, when in full fire.

(d) On kilns containing over fifty-five thousand (55,000) and up to seventy-five thousand (75,000) bricks when in full fire, not less than three (3) men shall be employed.

(e) On kilns containing over seventy-five thousand (75,000) when in full fire, not less than four (4) men shall be employed.

(f) An ordinary burner shall not be allowed to work on one kiln for more than two (2) nights in one (1) week, such two (2) nights not to be consecutive.

(g) No burner shall be called upon to attend to more than one (1) full kiln per night, when steaming.

(h) Work performed on a Sunday shall be paid for at the rate of time and a half. Such work shall be confined to work connected with burning only. Firewood shall only be unloaded when it is required for a kiln then burning.

(i) All firewood, stopping and daub required at night shall be provided in proximity to the kilns.

(j) When more than three (3) burners are employed at night, one shall be placed in charge and paid as head burner.

(k) It shall be optional for a worker to refuse to wheel up a checker after having been employed as a burner on the previous night.

## 10.—Hoffman Kilns.

(a) Coal landings shall not be less than three (3) feet wide and shall be railed.

(b) The hours of burners shall be forty-eight (48) per week at an hourly rate calculated on the rate prescribed in Clause 8 (ii) (a).

(c) Burners performing work on Sunday shall be paid time and a half for such work and have one clear day off in each week.

(d) Where a head burner is employed he shall, when necessary, supervise the work of the other burners on other shifts. He shall be paid five shillings (5s.) per week extra, and this extra payment shall be regarded as payment for the extra work involved by such supervision.

(e) All workers employed oiling machinery in pressed brickyards shall be paid an additional half hour's pay per day at ordinary rates for performing such work.

(f) All waste and other material required for cleaning shall be supplied by the employer.

(g) Piecework rates for drawers shall be on trucks or at stack.

## 11.—Lower Duties.

A worker called upon to do work carrying a lower rate than his usual rate of pay, for less than one half of a day, shall be paid for such work at his usual rate of pay.

## 12.—Aged and Infirm Workers.

Any worker who by reason of old age or infirmity is unable to earn the minimum rate of wage herein prescribed may be employed at a lesser rate of wage, to be agreed upon in writing between the worker and the Secretary of the Union, or in default of such agreement within twenty-four (24) hours after such worker shall have applied in writing to such secretary, stating his desire that such wage should be agreed upon, such wage shall be fixed by the most convenient Resident or Police Magistrate, upon the application of such worker after twenty-four (24) hours' notice in writing shall have been given by him to the said secretary, who shall, if he so desires, be heard by the Magistrate upon such application.

After having made application to the secretary, and after lodging the application to the Magistrate, and pending the decision thereon, in either case, the worker shall be entitled to work and be employed by the employer at the proposed reduced wage.

The determination of the Magistrate shall have effect for six (6) calendar months from the date thereof, and after the expiration of the said period until the wage shall be again fixed in the manner prescribed at the instance of the said secretary.

The secretary may by writing under his hand appoint an agent or substitute to represent the Union at the hearing of any such application before a Magistrate.

## 13.—Payment of Wages.

All wages shall be paid on the job within twenty (20) minutes of the close of the day's work at least once a fortnight.

## 14.—Engagement.

One day's notice on either side shall (with the exception of waste sand and bag boys, in whose case one week's notice shall be required) be necessary to terminate the engagement of all workers: Provided that an employer may at any time dismiss a worker for refusal or neglect to obey orders, or for misconduct, or if after receiving the prescribed notice he does not carry out his duties in the same manner as he did prior to such notice.

## 15.—Notices.

Notices relating to meetings in connection with the Union shall be allowed to be exhibited in each yard. A printed copy of the conditions of this Award shall be kept posted by the employer in a conspicuous position in each yard.

## 16.—Time and Wages Book.

The employer shall keep and enter up, or cause to be kept and entered up, a book containing:—

- (a) the name of each worker to whom this Award applies;
- (b) the class of work performed by him;
- (c) the hours worked each day by him;
- (d) the wages (and overtime, if any) paid to him;
- (e) the ages of junior workers.

Such book shall be open to inspection by a representative of the Union not more than once weekly, between the working hours of 10 a.m. and 4 p.m.

## 17.—Breakdowns, etc.

The employer shall be entitled to deduct payment for any day or portion of a day upon which the worker cannot be usefully employed because of any strike by the Union or any other Union or Association, or through the breakdown of the employer's machinery or any stoppage of work by any cause which the employer cannot reasonably prevent.

## 18.—First-Aid Outfit.

Every yard shall be equipped with a First-Aid outfit, and such outfit shall be kept in a suitable place not more than three hundred (300) yards from the place of employment.

## 19.—General.

(a) Plates or planks shall be provided for all wheelers wheeling into the kiln in all places except where the ground to be wheeled on is hard.

(b) A powder monkey shall be paid one shilling (1s.) per day extra. Where a powder monkey is not employed a leading hand shall be appointed and he shall be paid one shilling per day extra.

(c) Where a powder monkey has to break material for six (6) or more workers in a pressed yard, he shall have an assistant, who shall be paid at the labourer's rate of pay.

(d) Where the average length of wheel from the face to the truck shall exceed seventy-five (75) feet, the clay-hole men shall be paid one penny (1d.) per hour extra.

(e) It shall be optional on the part of the employer to provide oilskins.

#### 20.—Board of Reference.

The Court may appoint, for the purpose of this Award, a Board of Reference.

The Board shall consist of a Chairman and two (2) other representatives, one to be nominated by each of the parties.

There are assigned to the Board, in the event of no agreement being arrived at between the parties to this Award, the functions of:—

- (a) adjusting any matters of difference which may arise between the parties from time to time, except such as involve interpretations of the provisions of this Award, or any of them;
- (b) deciding any other matter that the Court may refer to the Board from time to time.
