To Henry Doyle Moseley, Stipendiary Magistrate, Perth,
Western Australia:

I, THE said Lieutenant-Governor, acting with the advice and consent of the Executive Council, do hereby appoint you Henry Doyle Moseley to be a Commissioner to investigate, report, and advise upon the following matters:—

1. The methods observed in connection with the custody of criminally insane persons at the Claremont Mental Hospital and the precautions observed to prevent their escape;
2. The circumstances of the escape of Edward Nicholas Kelly and John Edward Rowe on the 7th day of November, 1936, from the said Hospital;

And to make such recommendations as you may think fit for improving the methods of preventing escape of criminally insane patients from the said Hospital.

And I declare that you shall, by virtue of this Commission, be a Royal Commission within "The Royal Commissioners' Powers Act, 1902," as reprinted in the Appendix to the Sessional Volume of Statutes for the year 1928, and that you shall have the powers of a Royal Commission or the Chairman thereof under that Act.

And I hereby request you, as soon as reasonably may be, to report to me in writing the result of this your Commission.

WHEREAS by "The Factories and Shops Act, 1920," it is enacted that the Governor may by Proclamation temporarily suspend the operations of the said Act, in so far as it applies to the closing time fixed or appointed for any shop or shops: And whereas it is expedient to exercise such power in manner hereinafter appearing: Now, therefore I, the said Lieutenant-Governor, by and with the advice and consent of the Executive Council, do hereby by this Proclamation suspend the operations of the said Act between the hours of six o'clock and nine o'clock in the evening of Monday, Tuesday, Wednesday, Thursday and Friday in every week during the period commencing on the first day of January, 1937, and ending on the thirty-first day of December, 1937, in so far as it applies to the closing time of shops conducted in open markets which are kept open for the conduct of business therein between the times aforesaid and on the days aforesaid, and in which shops home-made jams and preserves, honey, butter (other than factory butter), and eggs, hams and bacon (not being factory hams or bacon), are sold or offered for sale, provided that only the said goods shall be sold or offered for sale between the said times by virtue of this Proclamation, and the said shops shall not be kept open for the sale or offering for sale of any other goods which cannot otherwise be lawfully sold or offered for sale between the times aforesaid.

WHEREAS by Regulation 2 of the Building Regulations contained in the Second Schedule to "The Road Districts Act, 1919-1934," it is provided, in reference to dwelling-houses on any block of land laid out for such purpose, that the area allotted to any dwelling-house and the open space used in connection with such dwelling-house shall together be not less than the area for the time being fixed by Proclamation as the proper area to be allotted to such dwelling-house. And whereas it is desirable that such area should be fixed for the Perth Road District, as hereinafter provided: Now, therefore I, the said Lieutenant-Governor, acting by and with the advice and consent of the Executive Council, do hereby declare that the proper area to be allotted to every dwelling-house and the open space to be used therewith shall in the Perth Road District be:—

An area of ground having a frontage of not less than 50 feet with a minimum depth of 120 feet, except in the following cases:

1. Subdivisions already approved by the Board;
2. Where it can be shown—
 - (a) That contracts to purchase have been entered into prior to the 12th September, 1919, comprising land having a frontage of not less than 44 feet with a minimum depth of 132 feet.
 - (b) That the title to the land was held prior to the 12th September, 1919, and that such land being the whole of the land comprised in such title, has a frontage of not less than 33 feet with a minimum depth of 132 feet.

Proclamations published in the *Government Gazette* on the 22nd November, 1918, pages 1762-3; 12th September, 1919, page 1582, and 3rd November, 1933, page 1678, are hereby repealed without prejudice to any rights and liabilities accrued thereunder.

Commencing at a point at the intersection of Elma street and Walcott street, and proceeding in a general north-easterly direction along the centre of Elma street to Carnarvon crescent; thence northerly to the west corner of Lot 673, Carnarvon crescent; thence in a general north-easterly direction along the north-west boundaries of Lots 673 to 684 inclusive and Lot 686, Carnarvon crescent, to and across road, and along the north-west boundaries Lot 691 and Lots 693 to 704 inclusive, Carnarvon crescent, to and across Bradford street to its north-east side; thence south-easterly along the north-east side of Bradford street for a distance of approximately three chains; thence in a south-westerly direction on a bearing of 243deg. to the point of commencement, as shown in brown on Plan M.W.S.S. & D.D., W.A., No. 3449.

Melville Road Board Town Planning Scheme and Regulations.

Melville Road Board—Town Planning Scheme.

IN pursuance of the resolution of the Melville Road Board of the 5th November, 1935, and notices advertised in accordance with "The Town Planning Regulations, 1930," the undermentioned works are planned and projected.

Work No. 1.

Development and Construction, Melville Highway.

1. To construct a highway from Canning bridge along the waterfront of the Canning and Swan rivers to the Board's western boundary, namely, the junction of the south bank of the Swan river and the western boundary of Swan Location 70.

Work No. 2.

2. Zoning or districting the Road Board District for industrial, business, and residential purposes, as shown on Plan and described in the Schedule hereunder.

Work No. 3.

3. Make provision for the survey and extension of Foss street, Bieton, from its present terminus to View terrace.

Work No. 4.

4. The replanning of that portion of Swan Location 73 north of Canning highway, shown on D.Ps. 1745 and 1746, under the provisions of Clause 6 of the First Schedule of the Town Planning Act, as set out in Plans submitted by Messrs. Industrial and Agricultural Areas Regulations.

1. The land is drained to the satisfaction of the Road Board, and/or
2. The land is built up to the level of the crown of the road (whether existing or to be built) on which the lot fronts.

WHEREAS by "The Road Districts Act, 1919-1934," the Board of any Road District is empowered to make By-laws for all or any of the purposes mentioned in the said Act; and whereas the Armadale-Kelmscott Road Board doth, in exercise of the powers aforesaid and of every power enabling it in this behalf, hereby make the following By-laws:—

1. Interpretation Clause:—In the construction of these By-laws:—

(a) the word "Board" shall mean the Armadale-Kelmscott Road Board.

(b) "Secretary" means the secretary for the time being of the Armadale-Kelmscott Road Board.

(c) "Hall" means and includes any building, hall, room, annex, corridor, stairway, stage, entrance, yard, or land situated within the boundaries of the Reserve Nos. 21514 and 14682.

(d) "Main Hall" means the whole building excluding the supper room, annex, and kitchen, and biograph room.

(e) "Lesser Hall" means the supper room, excluding the kitchen at rear.

(f) "Annex" means those two rooms attached and adjoining the northern end of the supper room.

(g) "Caretaker" means the caretaker of the hall duly appointed by the Board.

(h) The words "Local entertainments" and "Local public meetings," where used in the Schedule A of Charges hereto, mean entertainments, meetings, or functions conducted by residents or ratepayers of the Armadale-Kelmscott Road Board District.

2. Application for the hire of the hall or any room shall be made in writing to the secretary or duly authorised agent not less than twenty-four hours before the time that such hall or room is required, and shall state the time and purpose for which the hall is required, but six weeks' notice in writing shall be given to the secretary by any person desiring to rent the hall on any public holiday or special occasions (holiday seasons); also one month's notice in writing, if it is desired to engage the hall on any of the Saturday nights not granted to the picture proprietor under his agreement.

3. The name and place of abode of the actual and responsible person or persons hiring the hall or room shall be given in the application for the use of any hall or room.

4. The rent of the hall or any room or crockeryware shall be paid with each application, and shall be as set out in Schedule A annexed.

5. Hirers shall make their own arrangements for the safety of anything left in the cloak rooms or any part of the hall, and the Board will accept no liability.

6. No furniture or crockeryware shall be allowed to be taken from the hall by any person.

7. The hall is available on Good Friday for religious services only.

8. The Board may at any time demand that the hirer shall prior to the term of engagement deposit an amount estimated to cover any damage that might occur during the term of such engagement.

9. The Board reserves the right to accept or refuse to hire the hall or any room or crockeryware to any applicant for the hire of same, without assigning a reason for such refusal.

10. The Board may at any time cancel an agreement made for the hiring of the hall or room or crockeryware by giving twenty-four hours' notice, other than a contract made for the hire of the main hall for motion pictures, or a contract made for the hire of the annex. The days granted to the picture proprietor under any contract shall not be available to the public for renting the main hall.

11. In the event of two or more applications being made for the hire of any hall or room for the same date and hour, the Board may, without considering priority of application, determine to which applicant the hire of such hall or room shall be granted.

12. The hirer of the hall or room shall comply with the provisions of the Health Act, the Entertainment Tax Act, and any other Act in force for the time being applicable to such hiring and using of any hall or room. If in the opinion of the Board all the necessary actions have not been taken to comply with the provisions of the Acts mentioned above, the Board may at any time prior to or during the term of engagement forbid and prevent the use of such hall or room.

13. In the event of the use of any hall or room being forbidden or prevented under the last preceding By-law, the hirer shall forfeit the full amount payable for the hire of such hall or room, as if the hire had been duly fulfilled, and the Board shall not be responsible for any loss or damage incurred by the hirer.

14. No fermented or spirituous liquors shall be brought into or consumed in the hall or any room, except when permitted by the Board in writing.

15. No person shall smoke any tobacco, cigar, cigarette, or objectionable substance, nor strike or otherwise ignite any light in any hall or room during any ball or public entertainment, or at any gathering of persons in the said hall, except at a banquet or smoke social.

16. No person shall in any part of the hall:—

- (a) enter or be allowed to enter whilst intoxicated;
- (b) use profane or improper language;
- (c) be guilty of any misbehaviour whatsoever;
- (d) damage, mark, deface any wall or other part of the hall. (Any person who does, permits, or suffers any such damage shall be liable to pay the cost of all such damage in addition to any penalty imposed by these By-laws);
- (e) stand, loiter, or cause any obstruction whatsoever in the passageways or other part of the hall. (Any person so doing shall immediately disperse on being requested to do so by the secretary, caretaker or other duly authorised officer of the Board, or police constable, whether in uniform or otherwise);
- (f) perform any games or athletics whilst wearing boots or shoes, unless such boots or shoes are rubber soled.

17. No offensive impersonations or representations of living persons, or anything calculated to produce a disturbance, riot, or breach of the peace, shall be permitted in the hall or any room.

The hirer of the hall or any room shall maintain and keep good order and decent behaviour in such hall or room, and shall be solely and entirely responsible for the carrying out of these By-laws and for any damage done to the building, fixtures, fittings, electric light globes, electric light fittings, furniture, or crockeryware, and shall pay such damages as shall be assessed by the Board. Any article of crockeryware not accounted for or in a cracked or broken condition shall be paid for at current rates or prices.

22. The secretary, caretaker, or other duly authorised officer of the Board, or police constable when dressed in uniform or otherwise, if known as such to

the hirer or servant, shall be permitted to have free ingress to the hall or any part thereof at all times during the term of engagement, and shall be given every facility for seeing that these By-laws are duly carried out.

23. Hirers may decorate the buildings, using only those fixtures that are specially provided for the purpose, and no person shall drive a nail into any part of the walls, windows, floors, doors, etc., or otherwise deface the building. All decorations used in connection with any entertainment must be removed from the premises and disposed of to the satisfaction of the secretary within twenty-four hours from the commencement of the hiring periods; provided that, with the consent of the secretary first had and obtained, such decorations may be permitted to remain.

24. Hirers wishing to decorate the hall to the exclusion of another tenant shall pay such rental as provided here in Schedule A.

25. All decorations shall be erected under the supervision of the caretaker.

26. The hours for which any hall or room shall be hired shall be:—Day—from 9 o'clock a.m. to 6 o'clock p.m.; night—from 7 o'clock p.m. to 12 o'clock midnight.

28. Refreshments in the nature of supper or food-stuffs shall not be served in the main hall.

29. No electric current will be provided by the Board; the hirer must obtain current through prepayment meters in the hall.

30. Every person who does, permits, or suffers any act, matter, or thing contrary to any of these By-laws, or commits or permits any breach or neglect thereof, shall be liable on conviction to a penalty not exceeding £20 for every such conviction.

Hawkers.

1. (a) No person shall hawk any fruit, fish, vegetables, drapery, softgoods, hardware, or any other articles of merchandise within any part of the Board's District without first obtaining a license from the Board.

(b) No license shall be granted to any person, or persons, or company to hawk any drapery, wearing apparel, hardware or uncooked meats within the Townsites of Gnowangerup, Borden, and Ongerup.

(c) Provided that nothing contained in these By-laws shall apply to:—

- (i) any person or persons or company carrying on a business or trade, whose premises are registered under the Shops and Factories Act and have been established and situated within the Gnowangerup Road District for a period of at least six months;
- (ii) a registered milk vendor;
- (iii) any farmer, so far as these By-laws may or would affect the sale of the produce of a farm;
- (iv) any church, association, club, or charitable organisation established in the District for the benefit of the public.

(d) Any person who trades or travels on foot, or with any vehicle or animal, or carries to sell or expose or offer for sale within the Board's District any of the articles or things above named, shall be deemed to hawk same.

A Hawker's License shall be in the Form No. 1 in the Schedule A attached hereto.

(e) The fees to be paid for a license issued to a hawker shall be as set forth in Schedule B attached hereto.

Stall Keepers.

2. (a) No person shall keep or conduct any movable or temporarily fixed stall in or near any street or way, recreation ground, or reserve within the Board's District for the sale of any fruit, fish, vegetables, meat, or any other articles of merchandise, unless he shall be the holder of a current license from the Board entitling him so to do.

(b) A Stall-Keeper's License shall be in the Form No. 2 in Schedule C attached hereto.

(c) The fees to be paid for the license issued to a stall-keeper shall be as set forth in the Schedule D attached hereto.

3. Every person who wishes to obtain a Hawker's or Stall-keeper's License shall apply in writing to the secretary of the Board therefor, stating the term and kind of merchandise for which he desires to be licensed.

The granting or refusing of a Hawker's or Stall-keeper's License shall be in the absolute discretion of the Board, and, when granted, shall not be transferable. The Board may refuse to grant a license for any reason it may see fit, and every license granted under these By-laws shall remain in force for the period stated therein only.

4. Every hawker whilst hawking and every stall-keeper whilst using or occupying his stall shall carry his license with him, and shall at all times produce the same on demand to any officer of the Board, or to a police officer.

5. The secretary of the Board or other officer appointed by the Board, or any officer of the police force, may demand from and require of any individual committing or suspected of committing any offence against or breach of these By-laws, his name and address, and every person who shall refuse or neglect to give his name and address when required so to do shall be liable to a penalty not exceeding £5.

6. Every person offending against any provision of these By-laws shall be liable on conviction to a penalty not exceeding £20.
