IN pursuance of the powers in that behalf contained in "The City of Perth Superannuation Fund Act, 1934," and of all other powers thereto them enabling, the Lord Mayor and Councillors of the City of Perth do order as follows:

- 1. In this By-law "The Scheme" means the Scheme for the establishment of a Superannuation Fund for the purpose of providing superannuation benefit for officers and wages employees of the City of Perth which was adopted by the City of Perth on the First day of March, 1937, pursuant to Section 8 of "The City of Perth Superannuation Fund Act, 1934."
- 2. The amounts payable to the Superamuation Fund by contributors shall be regulated by the following scale and such amounts shall be deducted from the salaries and/or wages of the respective contributors in accordance with the provisions of the Scheme.

### Scale of Contributions.

Officers.—£4½ per centum of the average yearly salary of every officer who is a contributor: Provided that no contribution shall be paid on that portion of an officer's salary which exceeds £832 per annum.

A proportionate part of the contribution of every shall be deducted from his salary at the times when his salary is paid.

Before a contributor shall become entitled to a superannuation allowance under paragraph 7 (1) (a) of the Scheme he shall submit to the Board the Certificates of two Medical Practitioners to be nominated by the Board and in addition any other evidence which the Board may deem necessary to show that he is incapable of discharging the duties of his office or employment by reason of permanent ill-health or infirmity of mind or body.

6. If it shall at any time appear that a contributor has, on making his application under Clause 3 of this By-law, mis-stated his age the following provisions shall

have effect:-

(1) The Board may if it thinks proper (unless he satisfied it that the mistake was due to inadvertence) decline to allow him to continue as a contributor and also or alternatively at its discretion forfeit all or any part of his contributions or of any superannuation allowance accrued or to accrue to him.

(2) If he continues as a contributor after his correct age has been discovered then:-

(a) All future contributions made by him and by the Council on his account shall be based on

by the Council on his account shall be based on his correct age.

(b) Where his age has been overstated and the contributions of himself and of the Council on his account have accordingly been too high the excess of those contributions over the correct contributions shall be returned to him and the

Council respectively without interest.

IN pursuance of the powers in that behalf contained in "The Municipal Corporations Act, 1906," and all other powers thereto them enabling, the Claremont Municipal Council do make the following By-law:—

1. The areas prescribed in the Schedule hereto and situated within the Municipality of Claremont are hereby classified as districts for residences, and no lot or parcel of land in the said district shall be used for any purpose other than that for which it is classified.

2. No part of either residential district shall be used for the erection of any buildings other than buildings

of the following nature, namely:

(a) Dwelling houses, not including semi-detached houses and flats or tenements and hospitals.

- (b) Private motor garages, out-houses, and similar buildings used solely in connection with a dwelling-house, and not otherwise for the purpose of trade or business.
- (c) Churches.
- (d) Schools.

Any person who shall erect or commence to erect any building in contravention of this By-law, or who shall use any building which shall have been erected in contravention of this By-law shall on conviction be liable to a penalty not exceeding £20.

Claims for compensation by reason of the operation of this By-law shall be made not later than six months from the date on which this By-law is first published in the Government Gazette.

#### INDUSTRIAL AGREEMENT.

#### No. 10 of 1937.

#### (Registered 18/6/1937.)

THIS Agreement, made in pursuance of "The Industrial Arbitration Act, 1912-1935," this Fifteenth day of June, 1937, between the Federated Clerks' Union of Australia, Industrial Union of Workers, W.A. Branch (hereinafter referred to as the "Union") of the one part, and the Minister for Water Supply, Sewerage and Drainage, the Minister for Works, the Minister for Lands, and the Commissioner of Main Roads (hereinafter referred to as the "Departments") of the other part. The parties hereto mutually covenant and agree as follows:—

#### 1.—Area and Scope.

This Agreement shall apply throughout the State to the workers designated in Clause 16 and who are employed in the field on the jobs or elsewhere away from Head Office, and who are not covered by Industrial Awards, or other registered Industrial Agreements.

#### 2.—Hours.

Existing conditions regarding hours of work shall continue. The ordinary hours of work shall not exceed 88 per fortnight in the case of a job with a fortnightly pay, and 44 hours per week in the case of a job with a weekly pay.

#### 3.—Overtime.

Overtime shall be approved by the Permanent Head of the Department concerned before being worked.

All time worked in excess of 88 hours per fortnight in the case of a job with fortnightly pay, and 44 hours in the case of a job with weekly pay, shall be paid for at the rate of time and a half.

#### 4.—Holidays and Leave.

- (a) Two weeks' leave per annum shall be granted to each worker on full pay. Where the period of service is less than one year the worker shall be entitled to holiday pay in proportion as the period of service is to the full period of twelve mouths.
- (b) In addition to the leave prescribed in (a) the following public holidays shall be granted to each worker, provided the job or depot in which he is employed is closed on such days:—Christmas Day, Boxing Day, New Year's Day, Good Friday, Easter Saturday, Easter Monday, and Labour Day.
- (c) No worker shall be entitled to payment of wages for any absence from his employment on the ground of personal ill-health for more than one day per month during each year of service. Payment for absence through such ill-health shall, except as hereinafter provided, be limited to twelve days in each calendar year. Provided that a worker with at least two years of service who produces to his employer a medical certificate that absence from his employment on the ground of personal ill-health necessitates a longer absence than the period allowed of one day per month of service shall be entitled to payment for sickness up to twenty-four days in each calendar year.

Payment hereunder may be adjusted at the end of each calendar year, or at the time the worker leaves the service of the employer, in the event of the worker being entitled by service subsequent to the sickness to a greater allowance than that made at the time the sickness occurred.

(d) Long Service Leave shall be granted in accordance with the conditions applying to Government full time wages employees generally.

#### 5.-Travelling Allowances.

Except in regard to workers in the Lands Department, where it is or has been arranged between the Department and the worker that the wage specifically includes travelling expenses, an amount representing the reasonable out of pocket expenditure necessarily incurred in purchase of meals (excluding lunch on the first day where the worker has received reasonable notice in which to have a lunch prepared) or beds shall be recouped the worker in connection with travelling undertaken on instructions of the officer in charge of the job.

#### 6.—District Allowances.

District allowances as to the general wages employees on the respective jobs shall be paid.

## 7.—Tent Allowance.

Except in regard to workers of the Lands Department where it is or has been arranged at time of engagement between the Department and the worker that the wage shall include this allowance, a tent allowance at the rate of 5s. 3d. per week shall be paid in cases where the workers are required to live in tents on the job and where no cook is provided.

#### 8.—Accommodation.

Workers in camp shall be supplied with accommodation, including stretcher, mattress, crockery, and cooking utensils, rent free.

## 9.--Engagement.

The engagement of a worker shall be terminated by one week's notice by either party, such notice to take effect only at the place of appointment. A worker may, however, be summarily dismissed for misconduct or dereliction of duty.

#### 10.—Reference.

The Department shall give to each worker on termination of services a reference containing full information in regard to period of service and the nature of the duties performed.

#### I1.—Preference.

Preference of employment shall be given to members of the Federated Clerks' Union of Australia Industrial Union of Workers, W.A. Branch, provided that any worker or applicant for employment who is a member of another recognised industrial union, and who produces proof of such membership, shall be entitled to equal preference, provided that such worker or applicant shall, within fourteen days of the expiry of his currenticket with the other union, make and complete an application for membership with the Federated Clerks' Union.

#### 12.—Office Accommodation.

That suitable office accommodation and furniture be provided having due regard to longevity of the job, health regulations, hygienic and climatic conditions.

## 13.—Higher Duties.

Where a worker is called upon to perform the duties of a position carrying a wage higher than his ordinary wage for a period exceeding one week, he shall be paid the difference whilst carrying out such higher duties.

## 14.—Distant Job Allowance.

Workers employed within the Metropolitan Area on jobs in which the general wages employees receive an extra payment because of the long distance of their working place from the nearest transport facilities shall receive such extra payment under the same conditions as the general wages employees.

## 15.—Preparatory and Completion Work.

In cases where preparatory work has to be performed before proceeding to the job, the rates of pay shall operate from the time of the commencement of the work and continue until such time as the Permanent Head considers the work to be done warrants an alteration in the status of the worker. In the event of a dispute arising on an alteration in status the matter may be referred to the Board of Reference.

1.—Area.

This Agreement shall apply to workers employed in the Saw Milling Industry carried on in the South-West Land Division, except such portion of the said Division as is occupied within a radius of twenty-five (25) miles of the G.P.O., Perth.

#### 2.—Term.

The term of this Agreement shall be six (6) months from the date hereof.

#### 3.-Hours.

(a) Forty-four (44) hours shall constitute a week's

work, to be worked in five and one half days.

(b) The ordinary hours of work shall not (without payment of overtime) exceed eight (8) hours, Monday to Friday inclusive, and four (4) hours on Saturday.

(c) Lunch interval shall not exceed one (1) hour. (d) Work shall finish not later than at noon on Saturdays.

4.—Overtime.

(a) For all work done beyond the hours of duty on any week day other than a holiday, payment shall be at the rate of time and a half for the first four hours and double time thereafter.

.(b) For all time of duty on Sundays, Christmas Day, Good Friday, and Labour Day, the worker shall be paid at double rates except in the case of workers effecting repairs to or renewals to plant and/or machinery necessary to enable work to be safely resumed on Monday or the earliest working day, in which case payment shall be made at the rate of time and a half. This exception

shall not apply to the installing of new machinery.

(c) When a worker is recalled to work after leaving the job he shall be paid for at least two hours at over-

time rates.

(d) When a worker is required to hold himself in readiness for a call to work after ordinary hours he shall be paid at ordinary rates for the time he so holds himself in readiness.

(e) When a worker is required for duty during any meal time whereby his meal time is postponed for more than one hour, he shall be paid at overtime rates until he gets his meal.

5.-Holidays.

(a) All workers, after twelve (12) months' continuous service, shall be entitled to a fortnight's holiday per annum on full pay as prescribed herein. Such holi-days may be taken all at one time or partly at Christdays may be taken all at one time or partly at Christmas time and partly at Easter time, as may be mutually arranged between the Union, or the local branch of the Union, and the employer; provided that where any day has been kept as a holiday outside the said holidays during the year and paid for, such day shall be deducted from the days herein specified as holidays, or if included chall not be prid for. included shall not be paid for.

(b) Where employment of a worker entitled to holidays under Subclause (a) is terminated during the course of a calendar year, his employer shall pay to him a day's wages for each calendar month of his services in lieu of the holidays to which he would have been entitled under this clause and has not received. Such worker shall only be entitled when the holidays are taken to such holidays on full pay as are proportionate to his length of service during that period with such employer, and if such holidays are not equal to the holidays given to the other workers, he shall not be entitled to work or pay whilst the other workers of such employer

are on holiday on full pay.

(c) A worker who is dismissed for misconduct or who illegally severs his contract of service shall lose all rights under the holiday clause.

6.-Weekly Hiring.

(a) Except as to casual workers, the employment is terminable on either side by one week's notice given on any day, or, if the employer terminate it by payment of one week's pay, but for the first two weeks of employment the hiring shall be from day to day, and during this period a day's notice or a day's pay shall be sufficient.

- (b) But if a weekly worker absents himself from duty without reasonable cause a sum proportionate to his time of absence may be deducted from his pay, that is to say, one-sixth of the week's pay for each day of absence and a proportionate part of one-sixth for a shorter absence.
- (c) This does not affect the employer's right to dismiss for misconduct, incompetence, or negligence, and in such case wages shall be paid up to the time of dismissal only.
- (d) The employer may deduct payment for any day or portion of a day the worker cannot be usefully employed because of any strike by or participation in any ployed because of any strike by or participation in any strike by the Union, by any branch of the Union or by any members or member of the Union, employed by the employer, or because of any strike by or participation in any strike by any other Union, branch of any other Union, or members or member of any other Union employed by the employer, or because of any breakdown of machinery, or because of any other stoppage of work for any other cause for which the employer cannot be for any other cause for which the employer cannot be held responsible; provided that no deduction shall be made unless such stoppage exceeds two (2) hours.
- (e) A worker (except a casual worker) shall be entitled to payment for non-attendance on the ground of personal ill-health for one half day for each completed month of service during any year; provided that payment for absence through such ill-health shall be limited to six (6) days in each calendar year. Payment hereunder may be adjusted at the end of each calendar year or at the time the worker leaves the service by service subsequent to the sickness to a greater amount than that made at the time the sickness occurred. This clause shall not apply where a worker is entitled to compensation under the Workers' Compensation Act. Personal ill-health does not include ill-health which is the result of an accident sustained away from the place of employment or ill-health the result of the worker's own misconduct, but the onus of proof in such cases shall rest upon the employer.
- (f) Holiday pay shall not accrue during a worker's absence from duty except on account of sickness in accordance with Subclause (e) hereof.
- (g) The onus of proof of sickness entitling the worker to the leave mentioned in Subclause (e) hereof shall be on the worker, and if necessary may require to be supported by a certificate from a qualified medical practitioner.

8.—Travelling Time.

(a) All time reasonably occupied by a worker in travelling to or from work outside the shop or mill stations and outside ordinary hours, shall be treated as

maximum of duty and paid for at ordinary rate up to a maximum of twelve (12) hours for the journey.

(b) All fares and reasonable travelling expenses incurred by a worker in such travelling, together with reasonable cost of board and lodging if the worker has to be away from his house for a night shall be raid to be away from his home for a night, shall be paid to the worker.

#### 9.—Casual Worker.

A casual worker shall be paid ten per centum increase on the prescribed rates for the particular class of work he is required to perform, provided however, that if a man be dismissed for incompetence or misconduct within the first twelve days of his employment he shall not be entitled to the ten per cent. increase for casual work.

Any worker who by reason of old age or infirmity is unable to earn the minimum rate prescribed by this Award may be paid such lesser rate as may from time to time be agreed upon in writing between the employer and the secretary of the Association, or, failing such agreement within twenty-four hours after such worker shall have applied in writing to the secretary of the Association stating his desire that such wage should be agreed upon, such wage as shall be fixed by the most convenient Resident or Police Magistrate, upon the ap-plication of such worker after twenty-four hours' notice pheation of such worker after twenty-four hours' notice in writing shall have been given by him to the said secretary, who shall if he so desires be heard by the Magistrate upon such application. After having given notice to the secretary and after lodging the application mentioned and pending the Magistrate's decision thereon, the worker shall be entitled to work for and be applicated to the secretary and after logging the special transfer of the secretary and the secretary be employed at the proposed lesser rate. The determination of the Magistrate shall have effect for the period of six calendar months from the date thereof and after the expiration of the said period until the wage shall have again been fixed at the instance of the said secretary in the manner prescribed. The secretary of the Association may by writing under his hand appoint an agent or substitute to represent the Association at the hearing of the application before the Magistrata

11.—Record Book.

A record or time book shall be kept by each employer in which record or time book shall be entered the name of each worker, the nature of the work he is doing, the hours worked each day, and the amount of wages received by him each week; the said record or time book shall be open to the inspection of the accredited representative of the Association at any time during the working hours, and he shall be allowed to take necessary extracts therefrom.

12.—Representative Interviewing Workers.

In the case of a disagreement existing or anticipated concerning any of the provisions of this Agreement, an accredited representative of the Association shall be permitted to interview the workers during the recognised meal hour on the business premises of the employer, but this permission shall not be exercised without the consent of the employer more than once in any one week.

13.—Tools.

The employer shall provide for the worker, excepting patternmaker, all necessary tools including micrometer (where used) but excluding other measuring or precision tools of less than thirteen inches, but the worker shall replace or pay for any tools so provided if lost through his negligence. This clause does not apply to pattern-

makers, who are to provide their own tools.

Each patternmaker at the end of his employment shall be allowed an hour at ordinary rate for the purpose of grinding his tools.

## 14.-Mixed Functions.

When an employee performs on any day functions of a mixed character, he shall be paid for that day at the rate appropriate for the functions for which the highest rate is payable.

## 15.—Extra Rates.

Extra rates in this Agreement prescribed are not cumulative so as to exceed the maximum of double the ordinary rates.

16.—Board of Reference.

(a) The Court hereby appoints for the purpose of

the Agreement a Board of Reference.
(b) The Board shall consist of a Chairman and two other representatives, one to be nominated by each of the parties.

(c) In the event of a disagreement between the parties bound by the Agreement, in any of the matters hereinafter mentioned, the Board is hereby assigned the following functions:

- (i) classifying and fixing wages, rates and conditions for any machine, occupation, or calling not specifically mentioned in the Agreement, but so as not to contravene any of the provisions herein;
- (ii) adjusting any matters of difference which may arise between the parties from time to time, except such as involve interpretations of the provisions of the Agreement or any of them;

(iii) deciding any other matter that the Court may refer to the Board from time to time.

(d) The provisious of Regulation 92 of the Industrial Arbitration Act shall be deemed to apply to any Board of Reference appointed hereunder.

17.—Definitions.
(a) "Casual Worker" means a worker employed for less than twelve consecutive days.

(b) "Leading Hand" means any tradesman placed in charge of three or more other tradesmen or six other workers, and shall be paid two shillings and sixpence (2s. 6d.) per day above the minimum rate hereinbefore prescribed for his trade.

(c) "Blacksmith" means a man working as a blacksmith who is amployed making or repairing governibling.

smith who is employed making or repairing sawmilling or loghauling plant, locomotive railway rolling stock or whims, or is employed in or upon any engineering work, but shall not mean making or repairing road vehicles, nor farriers, nor bush black-

smiths.
(d) "Striker" or "Blacksmith's Striker" means the striker associated with the blacksmith described in

the preceding definition.
(e) "Electrical fitter" means a worker employed in making, repairing, altering, assembling, testing, winding or wiring electrical machines, instruments, meters, or other apparatus other than wires leading thereto. The work of an electrical fitter shall not be tested by a worker of a lower grade.

(f) "Electrical Linesman" means a worker engaged (with or without labourers assisting) in erecting poles for electric wires or erecting wire or cables on poles or over buildings or tying it or them to insulators or joining or insulating it or them or doing any work on

electric poles off the ground, but no linesman shall be allowed to work on live wires without any assistant.

(g) "Electrical Wireman" means a worker engaged in installing electric light meters, bells, or telephones or running or repairing the wires used for power or heating purposes.

18.—Apprentices.

(a) The provisions of the Schedule hereto marked "Apprenticeship Regulations" are hereby embodied in and form part of this Agreement.

(b) Apprentices shall be allowed to the following

trades:-

- (1) Patternmaking.
- (2) Motor Mechanics. (3) Coppersmithing.
- (4) (5)Blacksmithing.
- Brassfinishing.
- Turning. Fitting. (6) (7)

(8) Electrical Fitting.
(9) Universal Milling Machining.
(10) Machining (including Milling Machining other than Universal Milling Machining

ing).

(c) If there shall be no technical or other approved school situate within a reasonable distance of an employer's establishment, the employer shall provide a course of technical training for apprentices with a correspondence school approved by the Association.

(d) The proportion of apprentices to journeymen shall not exceed the proportion of one apprentice to every three or fraction of three journeymen.

## SCHEDULE.

## Apprenticeship. Definitions.

- 1. (1) "Act'" means "The Industrial Arbitration Act, 1912-1925," and any alteration or amendment thereof for the time being in force.

  (2) "Apprentice" means any person of either sex of any age who is apprenticed to learn or to be taught any industry, trade, craft, or calling to which these Regulations apply, and includes an apprentice on pro-
- (3) "Award" includes Industrial Agreement.
  (4) "Court" means the Court of Arbitration.
  (5) "Employer" includes any firm, company or cor-

years of age and not more than eighteen years of age who customarily works under the direction of or in association with an employer, master, or journeyman upon the material and with the tools or implements used in the industry.
(7) "Registrar" means the Registrar of the Court.

Employment—Probation.

2. No minor shall (except where provision is otherwise made in this Award) be employed or engaged in the industry, except subject to the conditions of apprenticeship or probationership herein contained.

3. (1) Every apprentice shall be employed on probation for a period of three months to determine his threes or otherwise far apprenticables and shall have

fitness or otherwise for apprenticeship, and shall work only for such hours per day and for such remuneration as may be prescribed by the Award. In the event of his becoming an apprentice such probationary period shall be counted as part of the term of apprenticeship.

(2) The Court may in any case where it seems expedient to do so, order that the probationary period of employment be extended for a further period not exceeding three months.

4. (a) Any employer taking an apprentice on probation shall within 14 days thereafter register such probationer by giving notice thereof to the Registrar in the prescribed form. If at the date of the coming into operation of these Regulations an employer is fitness or otherwise for apprenticeship, and shall work

employing any apprentice or probationer who has not been duly registered as such, he shall forthwith apply for the due registration of such apprentice or probationer.

(b) At the end of the period of probation of each

(b) At the end of the period of probation of each apprentice, if mutually agreed upon by the employer and the legal guardian of the boy, but not otherwise, he may become an apprentice under an agreement.

5. The employer of every apprentice shall keep him constantly at work and teach such apprentice or cause him to be taught the industry, craft, occupation, or calling in relation to which he is bound apprentice, by competent instruction in a gradual and complete mancompetent instruction in a gradual and complete mancompetent instruction in a gradual and complete manner, and shall give such apprentice a reasonable opportunity to learn the same, and receive, during the period of his apprenticeship, such technical, trade, and general instruction and training as may be necessary. And every apprentice shall, during the period of his apprenticeship, faithfully serve his employer for the purpose of being taught the industry, craft, occupation, or calling in relation to which he is bound, and shall also conscientiously and regularly accept, such technical conscientiously and regularly accept such technical, trade, and general instruction and training as aforesaid, in addition to the teaching that may be provided by his employer.

6. An employer shall be deemed to undertake the duty which he agrees to perform as a duty enforceable under an Award of the Court.

Advisory Committee.
7. A Board to be called "The Advisory Committee" may be appointed by the Court to advise in regard to any apprenticeship matter. Such committee shall consist of the following:—

(a) Some person appointed by the Court who shall

act as Chairman.

(b) Two representatives appointed by the employers.

(c) Two representatives appointed by the industrial union or unions of workers in the trade.

The Advisory Committee shall have such powers and duties as the Court in each case may determine.

8. (i.) No employer shall refuse employment to any person, or dismiss any worker from his employment, or injure him in his employment or alter his position to

injure him in his employment or alter his position to his prejudice, by reason merely of the fact that the worker is a member of any Advisory Committee, or by reason merely of anything said or done or omitted to be done by any such person or worker in the course of his duty as such member.

(ii.) In any proceeding for any contravention of this Regulation it shall lie upon the employer to show that any person proved to have been refused employment, or any worker proved to have been dismissed or injured in his employment or prejudiced whilst acting as such member, was refused employment or dismissed or injured in his employment or prejudiced for some or injured in his employment or prejudiced for some reason other than that mentioned in this Regulation.

Agreement of Apprenticeship.

9. (a) All agreements of apprenticeship shall be drawn up on a form approved by the Court, and signed by the employer, the legal guardian of the apprentice, the apprentice, and the Registrar. No employer, guardian, or apprentice shall enter into any agreement or undertaking purposting to add to very alter or amend.

dian, or apprentice shall enter into any agreement of undertaking purporting to add to, vary, alter or amend any such agreement without the approval of the Court.

(b) There shall be three copies of each agreement, of which one copy shall be held by the employer, one shall be held by the legal guardian of the apprentice, and one copy shall be retained by the Registrar.

(c) The apprenticeship agreement shall be completed within one month of the termination of the probationary period

period.

(d) Every agreement of apprenticeship shall be subject to the provisions of the Award in force for the time being applicable to apprenticeship in the industry.

10. Every agreement entered into by the employer and the legal guardian of the apprentice shall be for a period of five years, but this period may be reduced in special circumstances with the approval of the Court.

11. Every agreement of apprenticeship entered into shall contain-

(a) The names and addresses of the parties to the agreement.

The date of birth of the apprentice.

(c) A description of the industry, craft, occupation or calling or combination thereof to which the apprentice is to be bound.
(d) The date at which the apprenticeship is to commence and the period of apprenticeship.

(e) A condition requiring the apprentice to obey all reasonable directions of the employer and requiring the employer and apprentice to comply with the terms of the industrial Award so far as they concern the apprentice.

(f) A condition that technical instruction of the apprentice, when available, shall be at the employer's expense, and shall be in the employer's time, except in places where such instruction is given after the ordinary work-

(g) A condition that in the event of any apprentice, in the opinion of the examiners, not progressing satisfactorily, increased time for technical instruction shall be allowed at the employer's expense to enable such apprentice to reach the necessary standard.

(h) The general conditions of apprenticeship.

Transfer of Apprentices.
12. (a) The Court shall have power to transfer an apprentice from one employer to another either temporarily or permanently-

(i) if the employer does not provide the necessary facilities for the apprentice to become proficient in his trade; or

(ii) upon the application of the employer or the

apprentice for good cause shown.

(b) The transfer of every agreement shall be on a form approved by the Court, and shall be made out in quadruplicate and shall, unless the Court otherwise directs, be signed by the late employer or his assigns, the legal guardian of the apprentice, the apprentice, the Registrar, and the new employer. The transfer form shall be completed within two months of the date on, which the transfer is effected.

(c) One copy of the transfer agreement shall be held by the late employer, one shall be held by the new employer, one shall be held by the legal guardian of the apprentice, and one shall be retained by the Registrar.

- 13. Should an employer at any time before the determination of the period of apprenticeship desire to dis-pense with the service of the apprentice he may with the consent of the apprentice and guardian transfer him to another employer carrying on business within a reasonable distance of the original employer's place of business, willing to continue to teach the apprentice and pay the rate of wages prescribed by the Court in its Award or otherwise according to the total length of time served, and generally to perform the obligations of the original employer.
- 14. On the transfer or termination of any apprenticeship, from whatever cause, the employer shall give the apprentice a certificate stating what time he has served, full particulars of the branches of the trade or industry in which he has received instruction, the proficiency attained, and shall also notify the Clerk of the Court, and the cause thereof.
- In the event of an employer being unable to provide work for the apprentice or to mutually agree with the legal guardian of the apprentice to cancel the agreement or to arrange a transfer, application may be made to the Court to arrange for such transfer or to have such agreement cancelled.
- 16. Where a person is apprenticed to partners his agreement of apprenticeship shall upon the retirement or death of any partner be deemed to be assigned to the continuing partner or partners.

Cancellation of Agreement.

17. Every agreement shall include a provision that it may be cancelled, by mutual consent, by the employer and the legal guardian of the apprentice giving one mouth's notice in writing to the Court and to the parties concerned that such apprenticeship shall be terminated.

- 18. If the apprentice shall at any time be wilfully disobedient to the lawful orders of the employer, his managers, foremen or other servants having authority over the apprentice, or be slothful, or negligent, or disshould do, or shall not faithfully observe and keep his part of his agreement, then it shall be lawful for the employer, with the consent of the Court, to discharge the apprentice from his service.
- 19. The Court may in its discretion for any cause which it may deem sufficient on the application of any party to an apprenticeship agreement vary or cancel the agreement, either unconditionally or subject to such terms and conditions as it may deem advisable.

No apprentice employed under a registered agreement shall be discharged by the employer for alleged misconduct until the registration of the agreement of apprenticeship has been cancelled by order of the Court

apprenticeship has been cancelled by order of the Court on the application of the employer.

Provided, however, that an apprentice may be suspended for misconduct by the employer, but in any such case the employer shall forthwith make an application for cancellation of the agreement of apprenticeship, and in the event of the Court refusing same the wages of the apprentice or such portion thereof, if any, as the Court may order shall be paid as from the date of such suspension, and, in the event of the application for canthe date when the apprentice was suspended.

21. Subject to the provisions of the Acts relating to Bankruptey and Insolvency and the Winding-up of Com-

panies, the following provisions shall apply:

(a) The Trustee or Liquidator, as the case may be,
may give written notice to the apprentice and his parent or guardian of his intention to dis-continue the employment of the apprentice from a date to be named in such notice, and there-upon the agreement shall be deemed to be terminated from the said date; subject, however, and without prejudice to the right of the apprentice, his parent or guardian, to compound, compromise, or agree upon or to sue for and recover such damages (if any) as he may have sustained through such rescission of the agreement as aforesaid.

(b) Any proceedings for damages hereunder must be commenced within six weeks after the service on the apprentice of the notice referred to in subclause (a) hereof, otherwise any claim for damages shall be deemed to be waived and

forfeited.

#### Extension of Term.

Subject to Regulation 37, time lost by the apprentice through sickness or any other cause whatsoever may, with the consent of the Court on the application of any party, be added to the original term in the apprenticeship agreement at the end of the year of service in which the time has been lost or at the termination of the

apprenticeship period.

The term of apprenticeship may be extended by the Court on the failure of an apprentice to pass any of the examinations, and for such purpose it shall be the duty of the examiners to make any necessary recommendation to the Court. Any extension of the term of apprenticeship shall be subject to all the conditions and stipulations in the original agreement, except as to rates of wages, which shall be such amount as the Court may determine.

## Technical Education Classes.

(a) Every apprentice shall attend regularly and punctually a Government or other approved technical school vocational classes or classes of instruction, for instruction in such subjects as are provided for his trade. This clause shall be deemed to have been complied with if the apprentice takes a course in an approved correspondence school: Provided, however, that attendances shall not be compulsory when the apprentice is resident outside a radius of 12 miles from the place where instruc-tion is given, or in the case of illness of the apprentice the proof whereof lies on him. Provided also that if technical instruction is not available in the locality in which the apprentice is employed and is available by correspondence, at reasonable cost to be approved by the Court, the Court may prescribe such correspondence course as the technical instruction to be taken by the apprentice and paid for by the employer.

(b) The fees for the classes attended by the apprentice shall be paid by the employer.

(c) The period during which apprentices are to attend such technical school or classes if any shall be four hours

- per week.

  25. Where in any case it is shown to the satisfaction of the Court that any apprentice, by reason of his engagement on country work or other good cause, cannot conveniently attend a technical school or other prescribed classes, such of these Regulations as relate to attendance at a technical school or other prescribed classes, and to examinations, shall not apply to such apprentice, but he shall be subject to such conditions as the Court may
- 26. If the examiners or the industrial union or employer concerned, make representations to the Court that the facilities provided by the Technical School, or other place of vocational training for the teaching of appren-

tices, are inadequate, the Court may make such investigations and such report to the Minister controlling such Technical School, or such other place, as it deems

27. When an apprentice attends a technical school, vocational classes, or other class or classes of instruction during his ordinary working hours, where such is prescribed, the time so occupied shall be regarded as part of the term of his apprenticeship, and the employer shall not be entitled to make any deduction from the wages of the apprentice for such time.

#### Examinations.

28 (a) Every apprentice shall be bound to submit himself to examination at the places and times appointed by the Registrar after consultation with the examiners.

(b) Every apprentice shall, prior to submitting himself to examination, produce to the examiners a certificate that he has made at least 70 per centum of attendances at the technical school or other place of instruction unless he is exempted from such attendance for good cause.

(c) The clerk of the Court shall notify the examiners

of the names and addresses of the apprentices required

- to submit themselves to examination.

  (d) The employer shall place at the disposal of the examiners such material and machinery on his premises as may be required by them, and shall in all ways facilitate the conduct of the examination.
- 29. (a) The examiners shall be persons skilled in the industry and appointed as prescribed by the Award Failing provision or appointment as aforesaid the Court may appoint such person or persons as it may deem fit. In the event of a disagreement between the examiners, the matter in dispute shall be referred to a third person agreed to by them or nominated by the Court or the President at the request of any of the examiners, and the decision of such person shall be final and conclusive.
- (b) It shall be the duty of the examiners to examine the work, require the production of the certificate of attendance, inquire into the diligence of each apprentice, and as to the opportunities provided by the employer for each apprentice to learn, and to submit a report to the Court in writing as to the result of the examination within one month from the date of holding the examination, but this period may be extended by the
- (c) Such examination shall, where possible, include theory and practice as applied to the trade, maustry, eraft, occupation, or calling to which the apprentice is indentured.
- 30. The Registrar shall, after each examination, issue a certificate to each apprentice indicating his degree of proficiency, taking into consideration the term of apprenticeship served. A duplicate of such certificate shall be lodged by each apprentice with his employer and the secretary of the Union each of whom held here. and the secretary of the Union, each of whom shall keep the same in safe custody, and produce the same for in-spection by the Industrial Inspector whenever demanded by the latter to do so. When the final examination has been passed the certificate shall also be signed by the examiners.
- 31. Whenever it is possible so to do, the examiners, before entering upon the examination, shall draw up a syllabus showing what, in their opinion, is the stage of proficiency which an apprentice should attain at each of the examinations prescribed. The syllabus shall be subject to review by the Court at any time, and shall be kept as a record by the clerk of the Court and a copy handed to the examiners before each examination. The said syllabus may be subject to alteration from time to time by the examiners, who shall forthwith notify the clerk of the Court thereof.

32. In lieu of, or in addition to, examiners above referred to the Court may appoint, wholly or partly, examiners to be appointed by the Director of Technical Education for the whole or any portion of the subjects of instruction, and at such remuneration as the Court

may determine.

33. In the event of an apprentice failing to pass any of his examinations the employer may apply to the Court to disallow the increase in wages prescribed by the award, and the Court, on any such application, may make such order as the circumstances of the case may seem to require.

34. Upon the failure of an apprentice to pass two consecutive examinations, it shall be the duty of the examiners to report same to the Court with a recommendation as to the cancellation of the apprenticeship

agreement, or such other remedial measures deem advisable. The Court, after notice to all parties concerned, may cancel the agreement or make such other order in the circumstances as it may deem necessary.

35. Upon the completion of the period of training prescribed for apprenticeship, each apprentice shall be required to pass the final examination test to the satisfaction of the examiners, and upon passing this test shall be provided with a certificate to that effect by the Registrar.

#### Lost Time.

36. The employer shall pay the apprentice for all time lost through sickness or the holidays prescribed by this award: Provided-

(a) payment for such sickness shall not exceed a total of one month in each year;

(b) where the time lost through sickness exceeds four consecutive working days, the employer may demand from the apprentice the production of a medical certificate, and a further certificate or certificates may be required if any time is lost through sickness within seven days from the date of resumption of duty, the cost if any of such certificate or certificates not exceeding 5s. to be borne by the employer;

(c) an apprentice shall not be entitled to receive any wages from his employer for any time lost through the result of an accident not arising out of or in the course of his employment, or for any accident or sickness arising out of his

own wilful default.

37. The employer shall pay the apprentice, in respect of time lost through compulsory military or naval training, the amount by which the wages prescribed by the industrial award for the trade, calling, craft, occupation, or industry exceeds the amount received by the apprentice from the Department of Defence: Provided, however, that this clause shall not apply to military or naval training imposed through failure to attend compulsory parades.

All time lost by reason of compulsory military or naval training other than the additional training mentioned in the above proviso shall count as part of the

apprenticeship.

When an apprentice is absent from work for any cause other than sickness or in pursuance of the provisions of these Regulations, the employer shall be entitled to deduct from the wages of the apprentice an

amount proportionate to the time so lost.

39. When an apprentice cannot be usefully employed because of a strike the employer shall be relieved of his obligations under the apprenticeship agreement dur-

ing the period of the strike.

Part-time Employment.

40. Where in any case an employer is temporarily unable to provide work to employ an apprentice for his full time, application may be made by the employer to the Court for permission to employ the apprentice for such lesser time per week or per month, and at such remuneration as the Court may determine, being not less than the proportionate amount of the rate of wages prescribed by the industrial award for the trade, calling, or industry. If the Court grants the application holidays will be reduced pro rata. 40. Where in any case an employer is temporarily

#### Miscellaneous.

41. (1) The Registrar shall prepare and keep a roll of apprentices containing-

(a) a record of all apprentices and probationers placed with employers;

(b) a record of all employers with whom apprentices are placed;

- (c) a record of the progress of each apprentice, recording the result of the examiners' reports; (d) any other particulars the Court may direct.
- (2) These records shall be open to inspection by employers and the Union of workers interested upon request.
- 42. For the purpose of ascertaining the number of apprentices allowed to be taken at any time, the average number of journeymen employed on all working days of the twelve months immediately preceding such time shall be deemed to be the number of journeymen em-ployed. Where the employer is himself a journeyman regularly and usually working at the trade he shall be

counted as a journeyman for the purpose of computing the number of apprentices allowed. Where a business is in operation for less than twelve months the method of ascertaining the number shall be as agreed by the parties to the Award, or, if no agreement arrived at, as determined by the Court.

43. Every industrial inspector appointed in pursuance of the provisions of "The Industrial Arbitration Act, 1912-1925," shall have the power to enter any premises, make such inspection of the premises, plant, machinery, or work upon which any apprentice is employed or could be employed, interview any apprentice or employee, examine any books or documents of the business relating to the wages and conditions of apprentices, interrogate the employer in regard to any of the abovementioned matters.

44. With a view to determining whether the number of apprentices being trained is sufficient to meet the future requirements of the industry in the matter of skilled artisans, the Registrar may require any employer to furnish him with any specified information relating to the said industry, or relating to the workers engaged therein.

45. In every application under Clauses 15, 18, 19, 20, 22, 23, 33, and 40 of this Schedule, the Union of Workers registered may intervene and make such representations at the hearing as it may deem necessary. The representative shall be appointed in the manner prescribed by Section 65 of the Act.
